DESCRIPTION

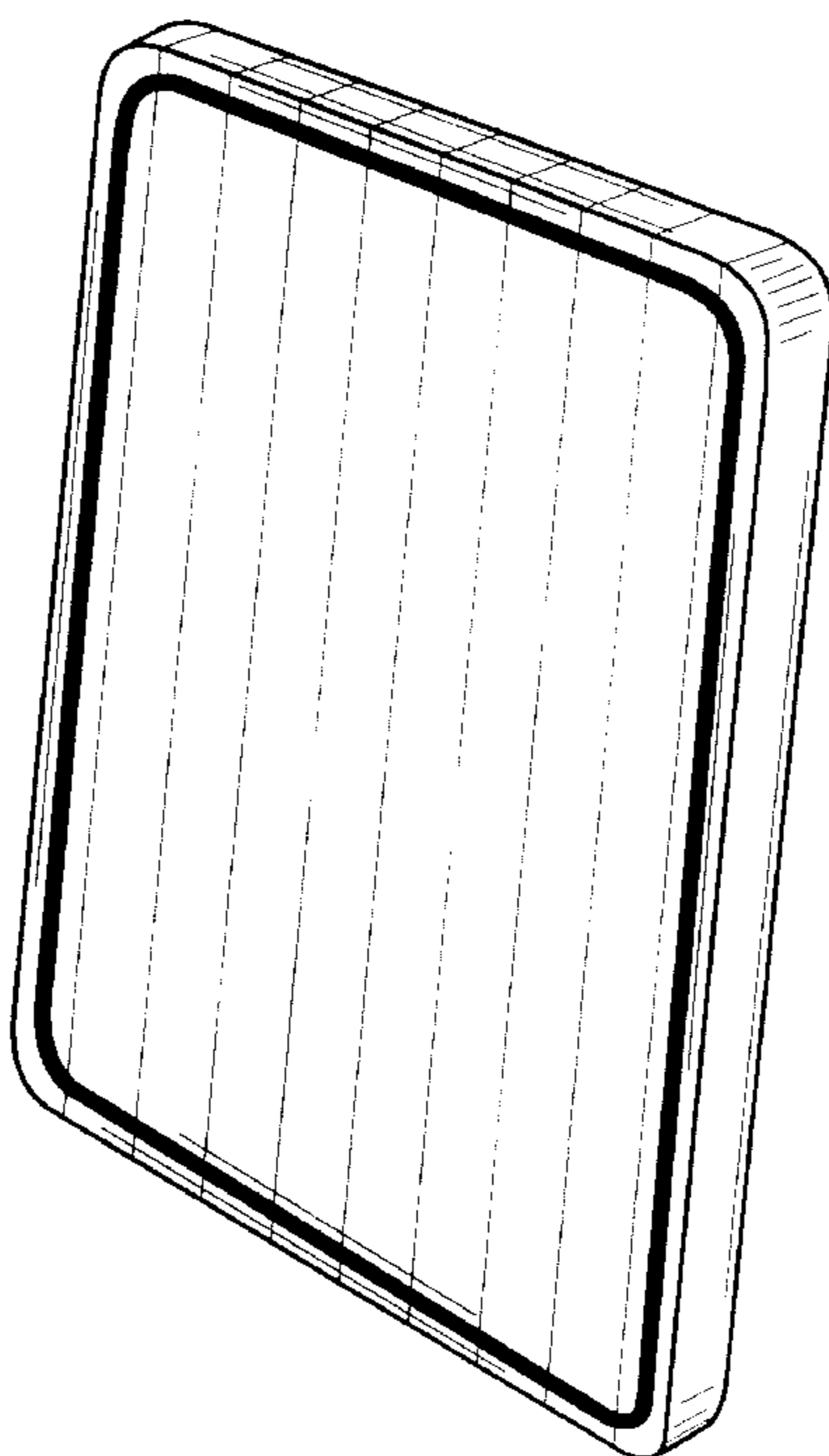
FIG. 1 is a perspective view of a combined soccer hand warning card and seat cushion showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a side elevational view thereof, the opposite side being a mirror image thereof; and FIG. 5 is a bottom view thereof. FIG. 6 is a perspective view of another embodiment of a combined soccer hand warning card and seat cushion showing our new design; FIG. 7 is a front elevational view thereof; FIG. 8 is a rear elevational view thereof; FIG. 9 is a side elevational view thereof, the opposite side being a mirror image thereof; and, FIG. 10 is a bottom view thereof. The drawing is lined for color. The FIGS. 1–5 are lined to indicate the color red. FIGS. 6–10 are lined to indicate the color yellow.

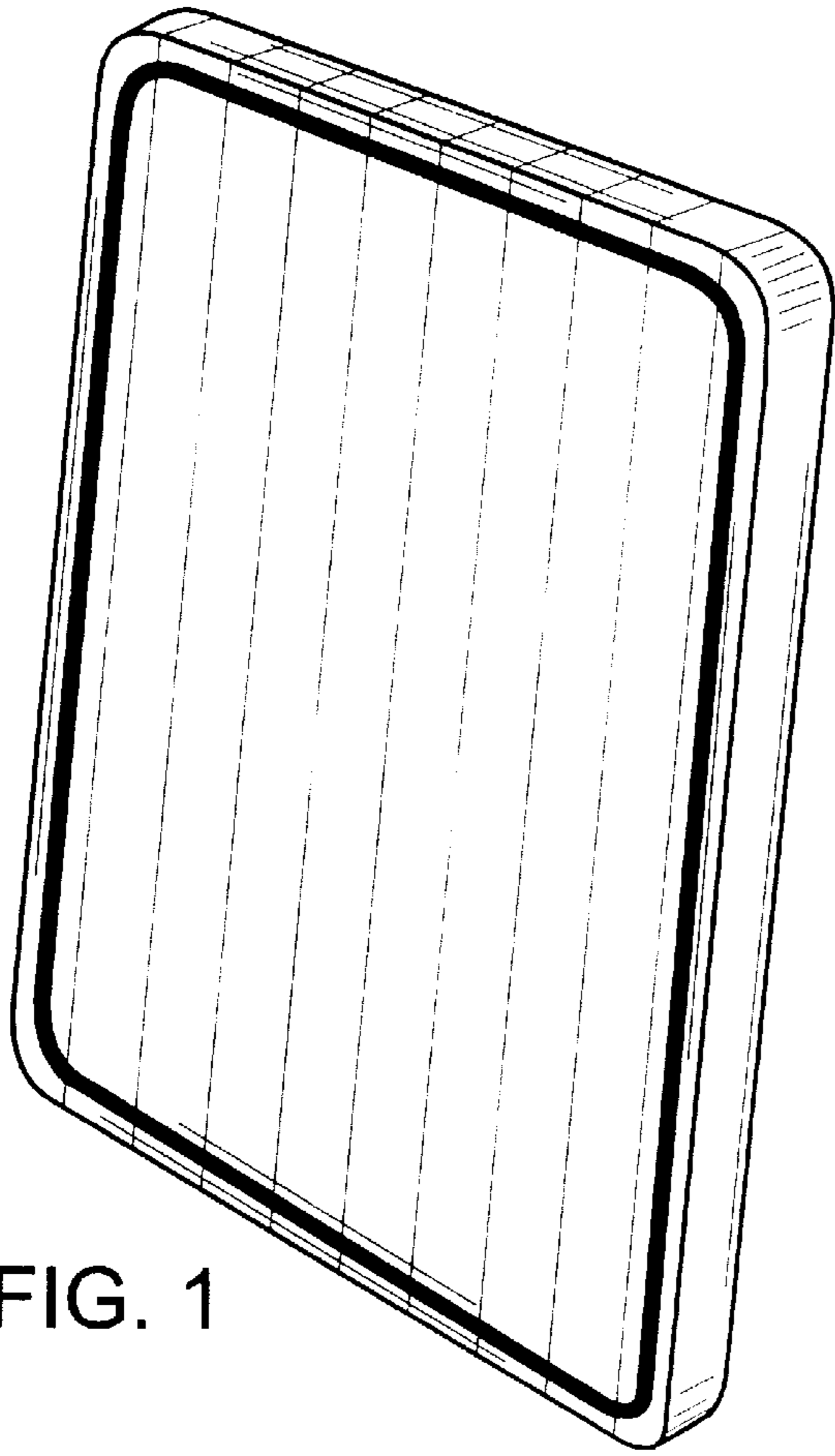

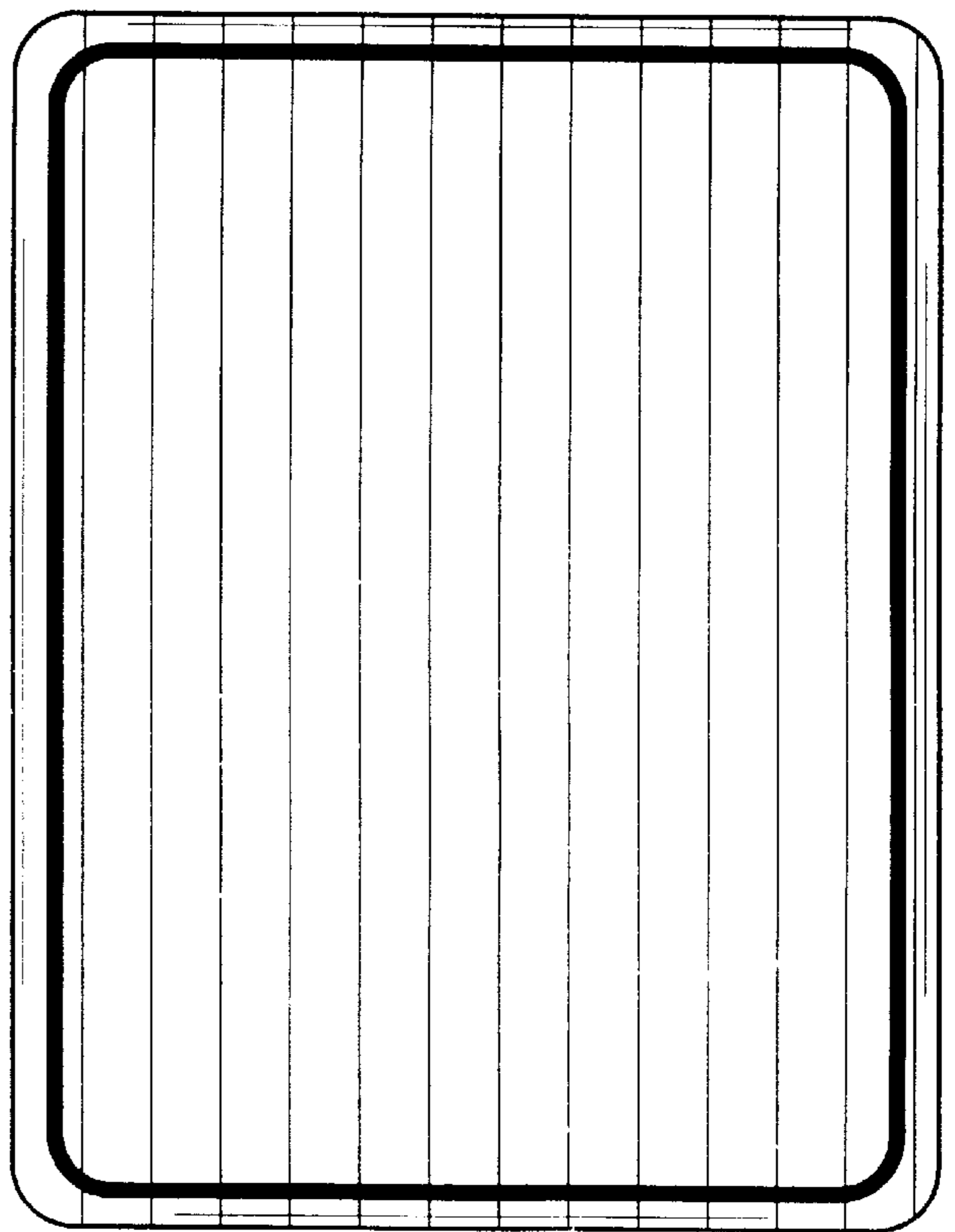

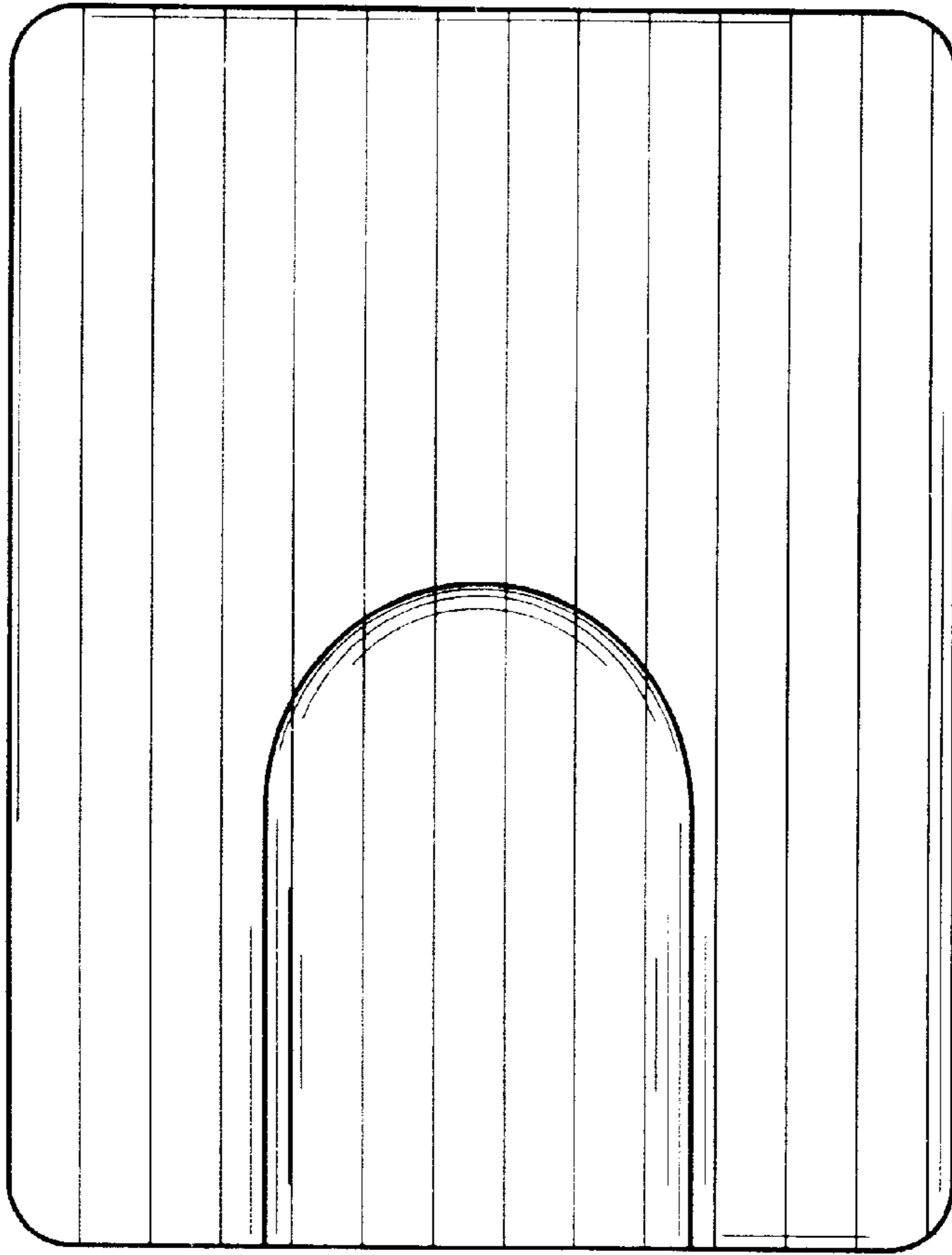

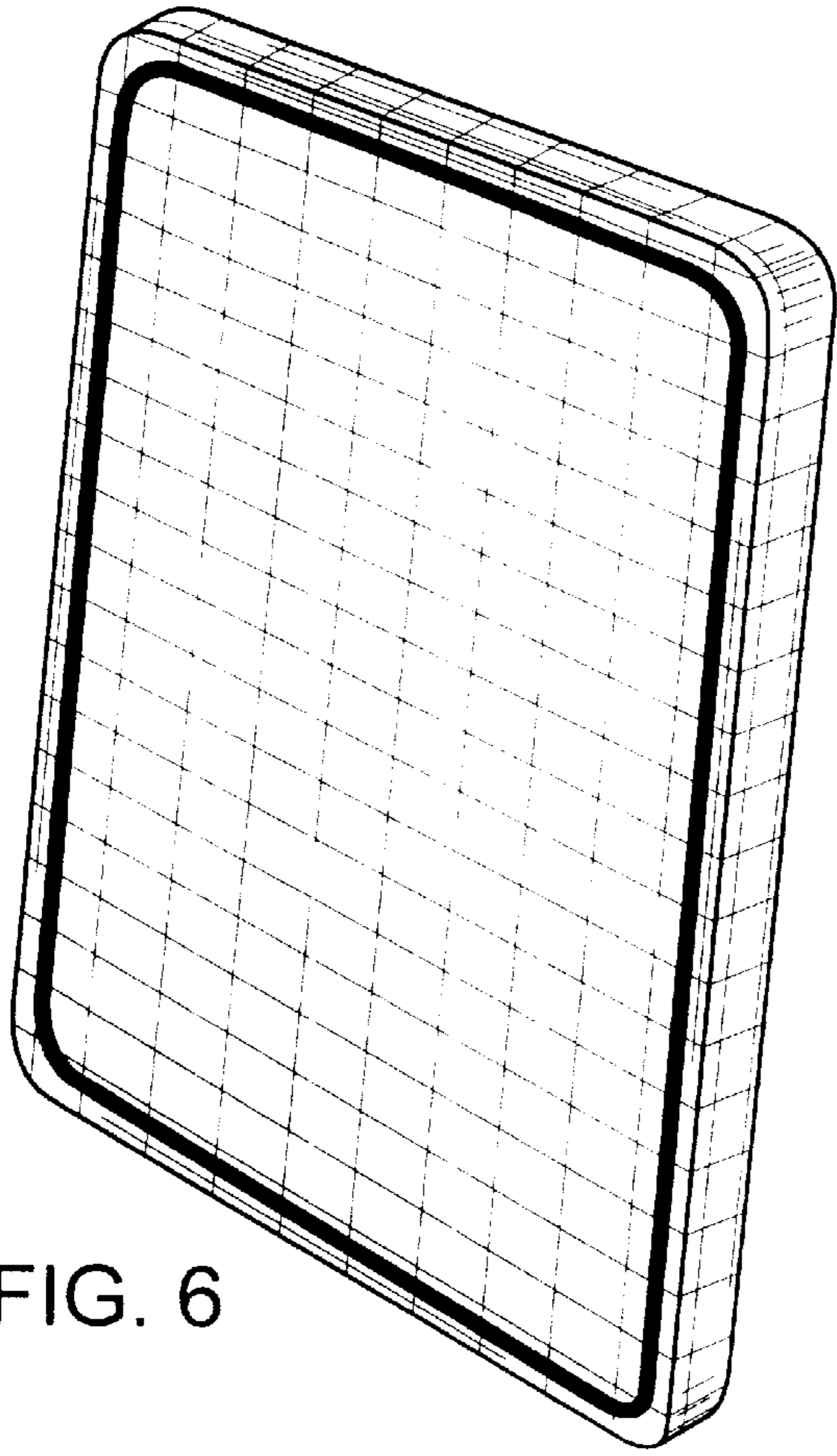

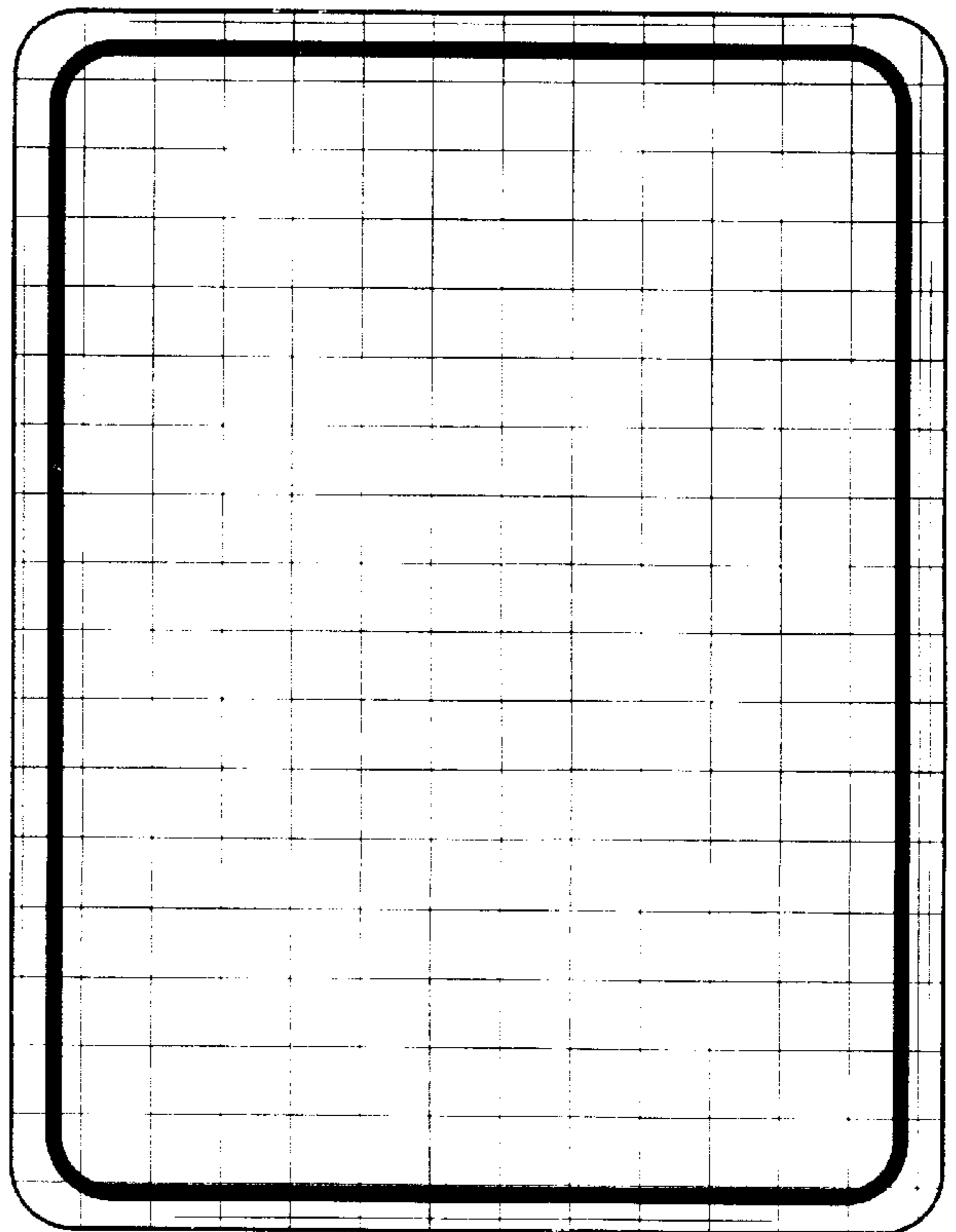

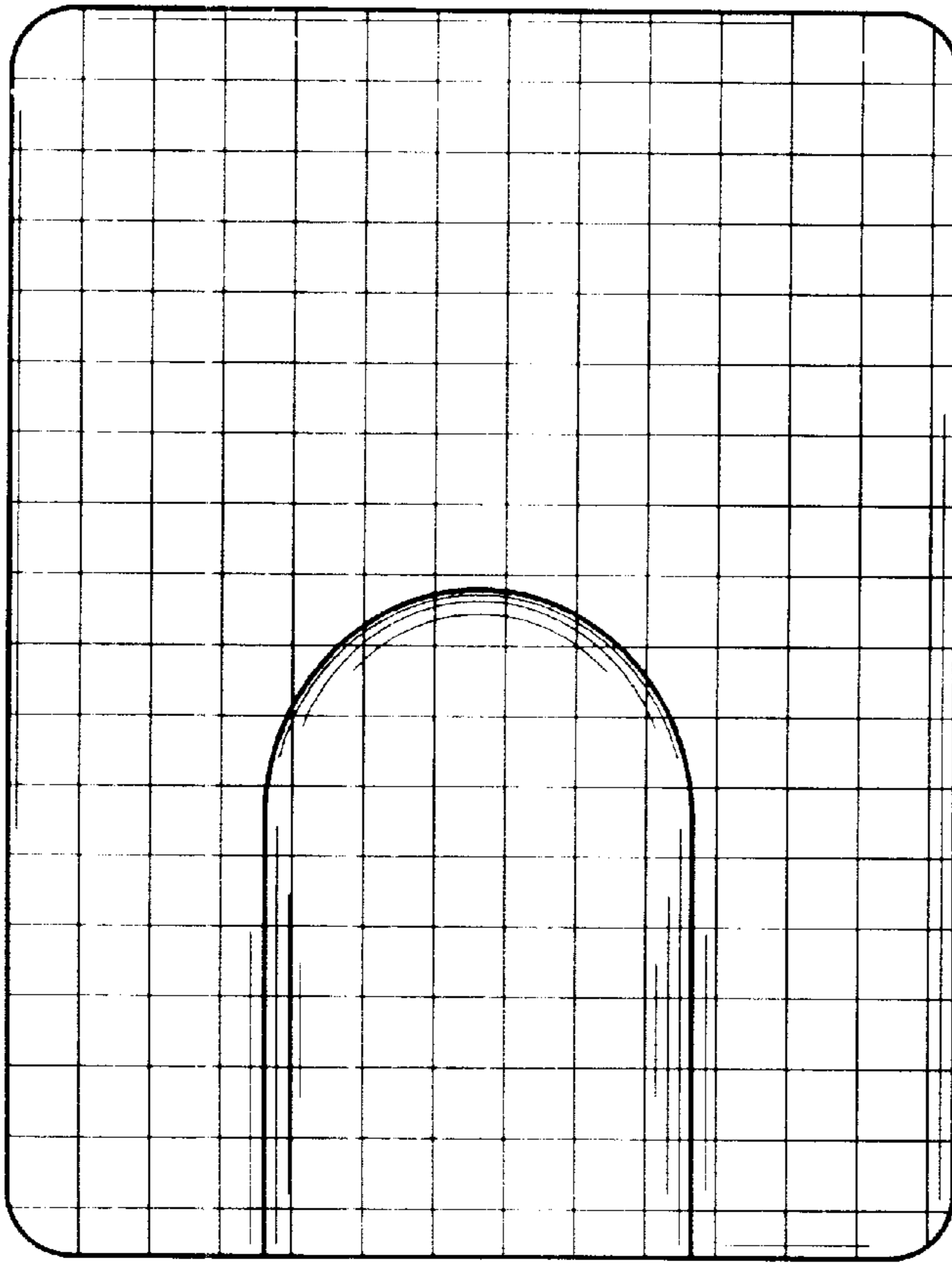

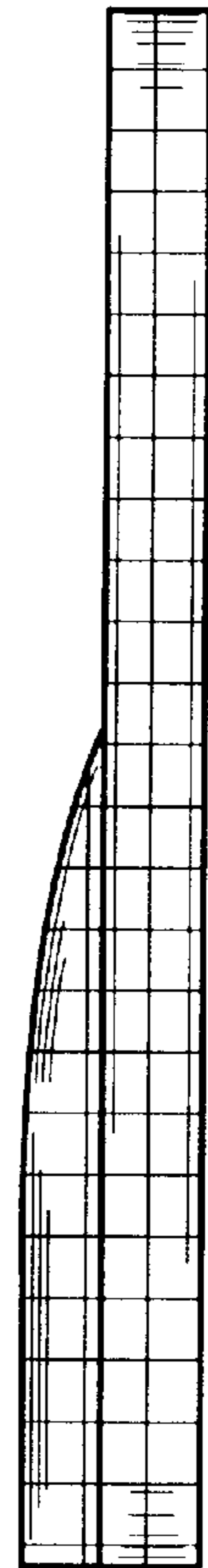
