(57) **CLAIM**

The new original design for “plastic tumbler with transparent shell”, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tumbler embodying the invention;

FIG. 2 is a top view of the tumbler depicted in FIG. 1;

FIG. 3 is a front view of the tumbler of FIG. 1;

FIG. 4 is a rear view of the tumbler of FIG. 1;

FIG. 5 is a bottom view of the tumbler of FIG. 1;

FIG. 6 is a perspective view of a modified tumbler embodying the invention;

FIG. 7 is a top view of the tumbler depicted in FIG. 6;

FIG. 8 is a front view of the tumbler of FIG. 6;

FIG. 9 is a rear view of the tumbler of FIG. 6; and,

FIG. 10 is a bottom view of the tumbler of FIG. 6.

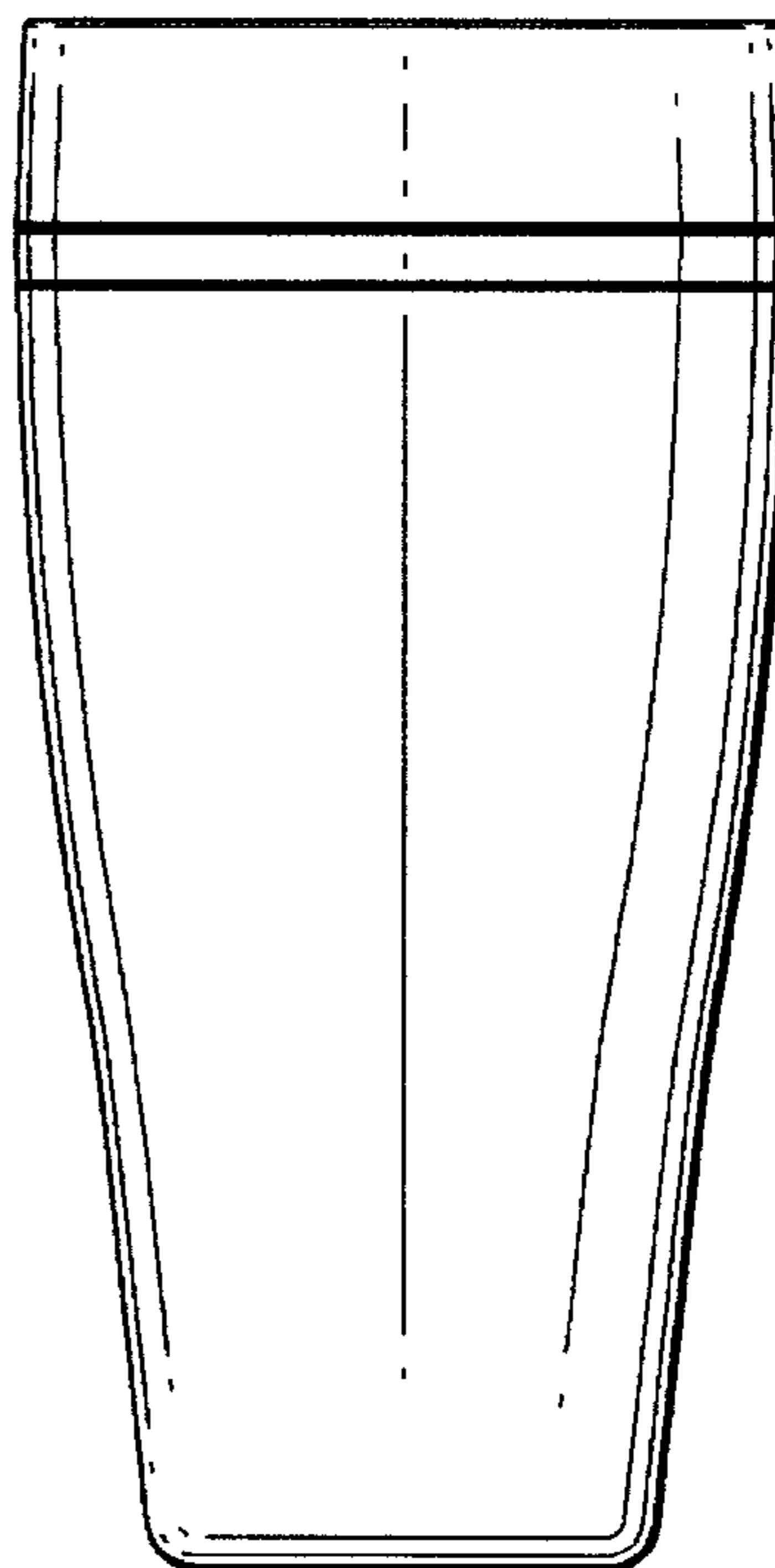
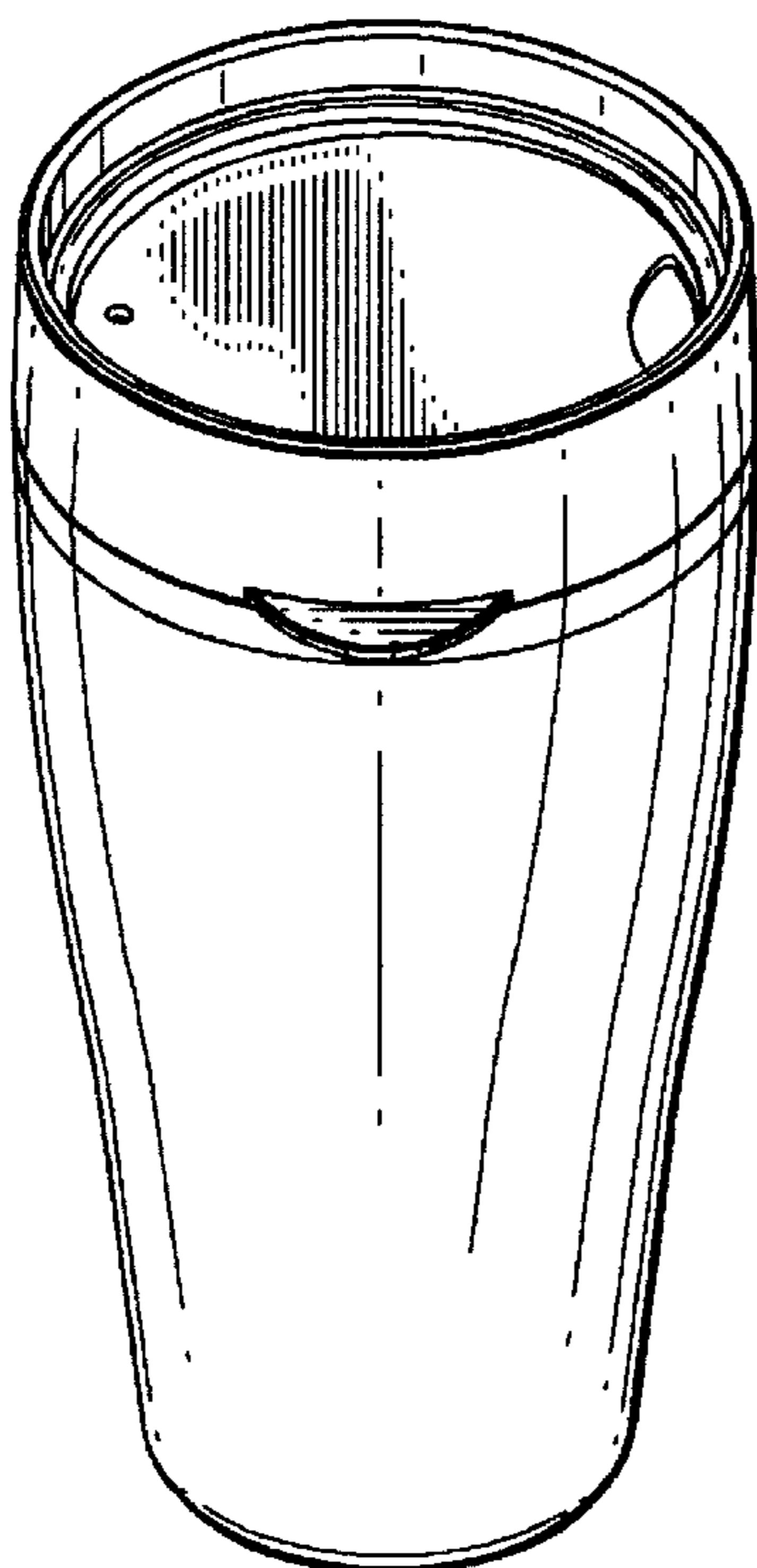

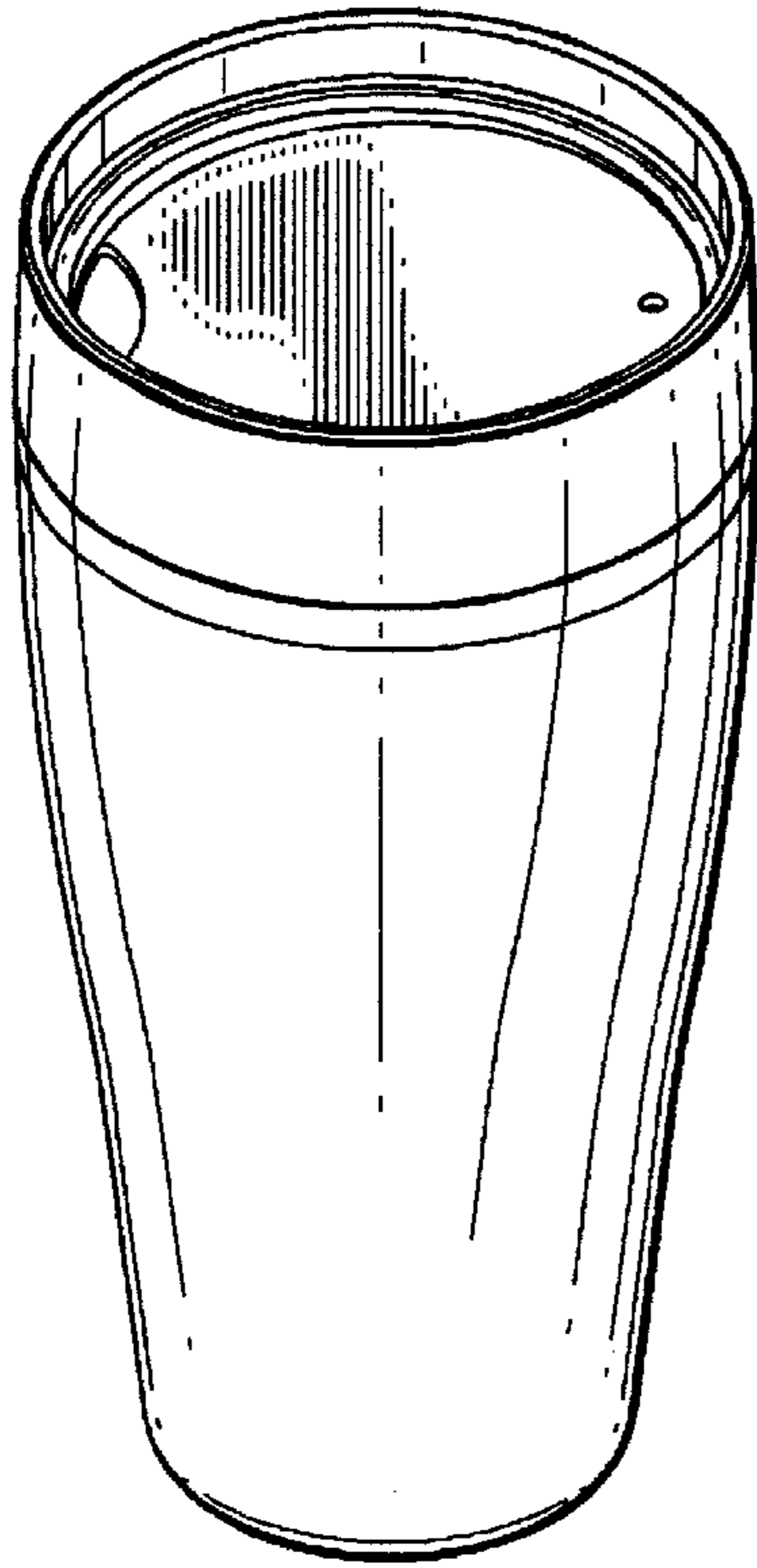

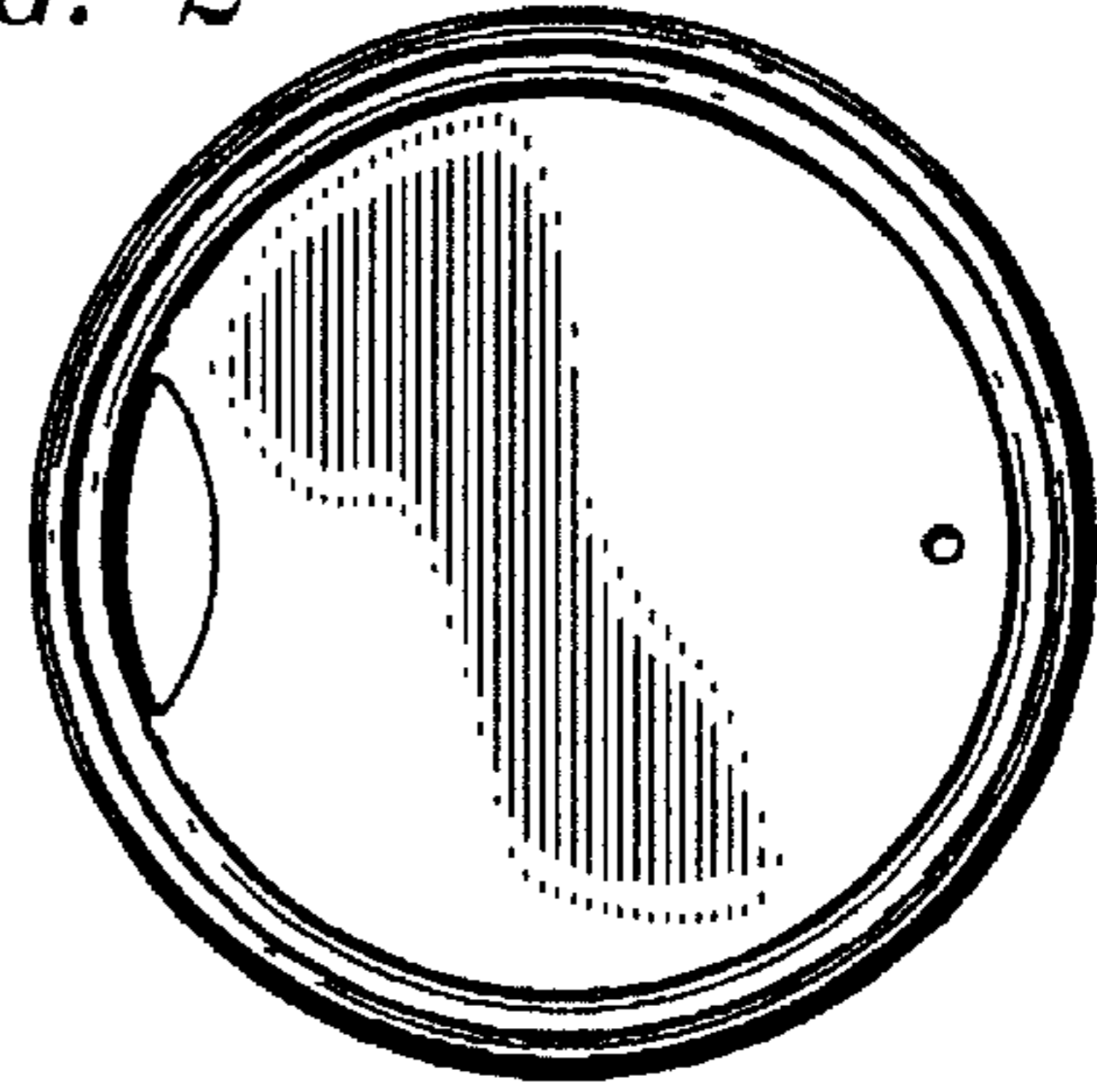

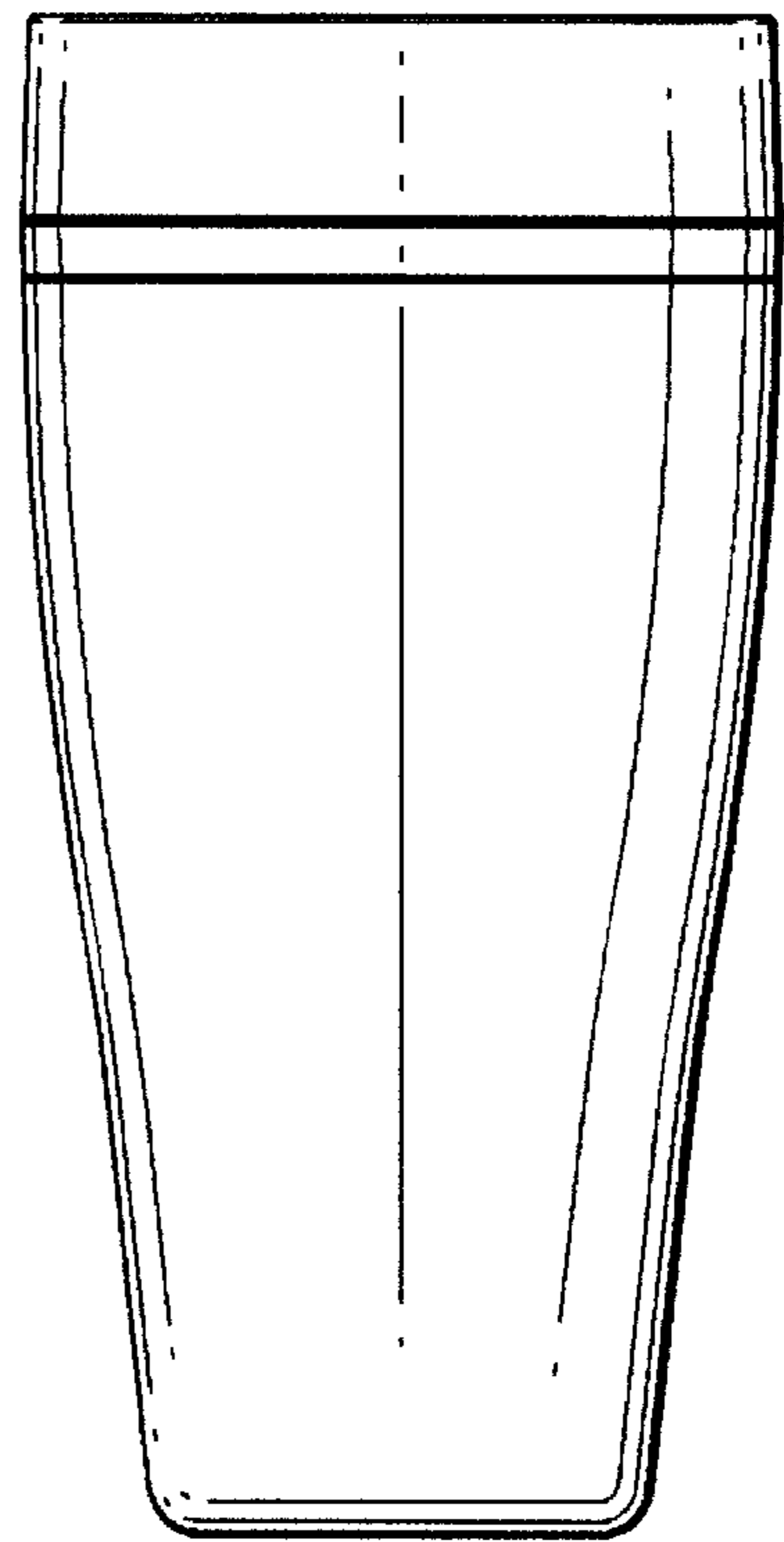

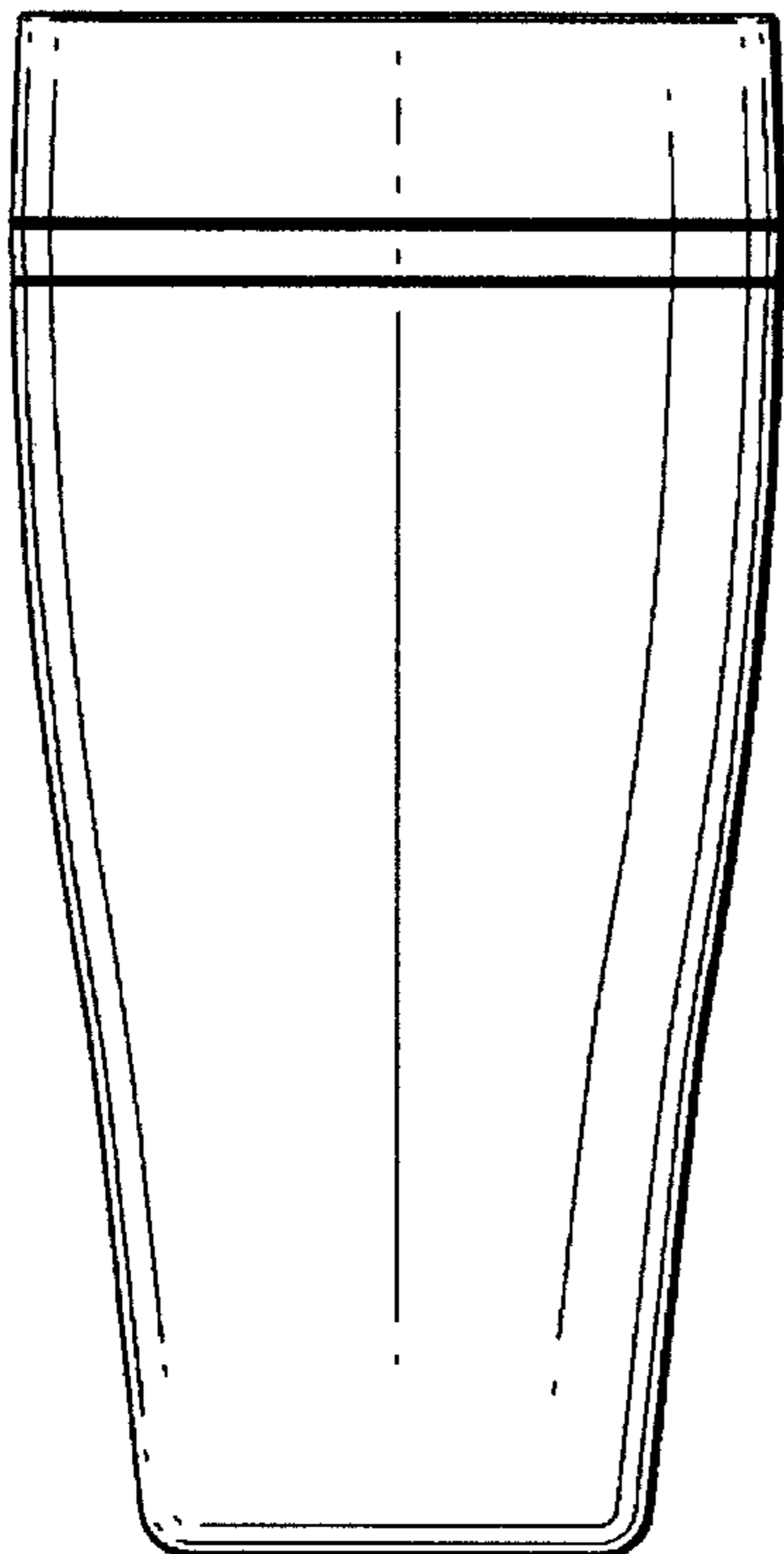

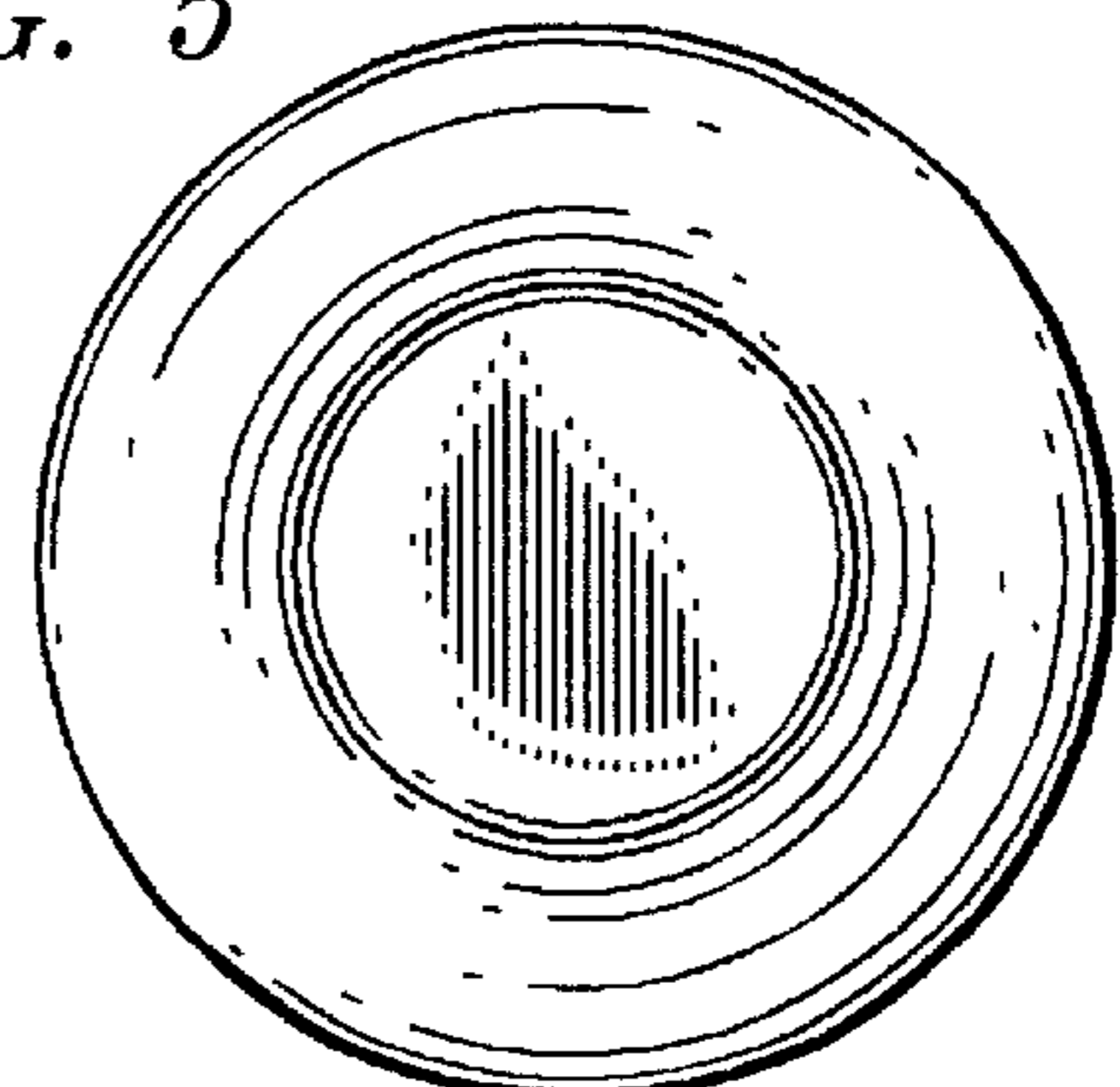

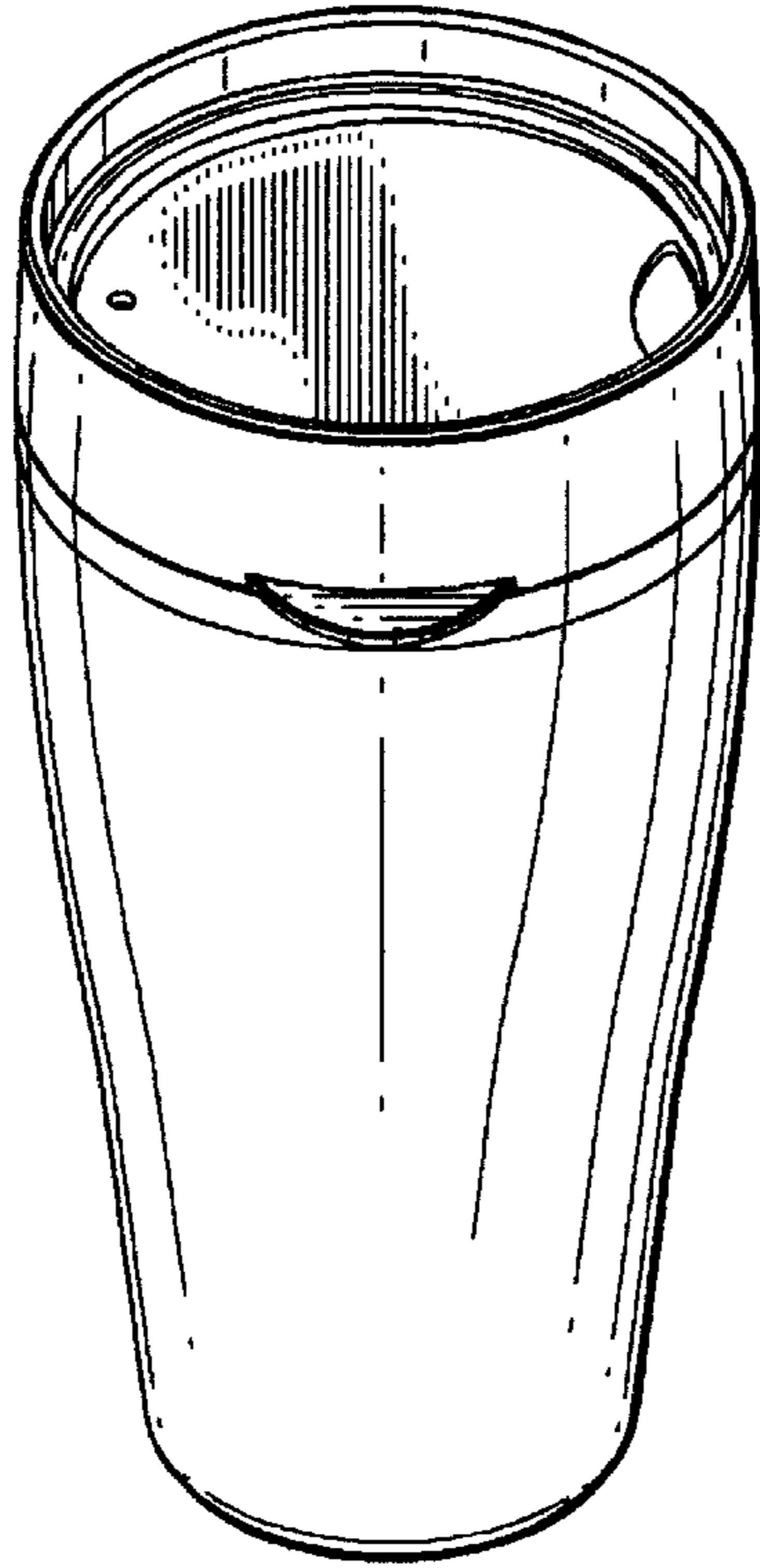

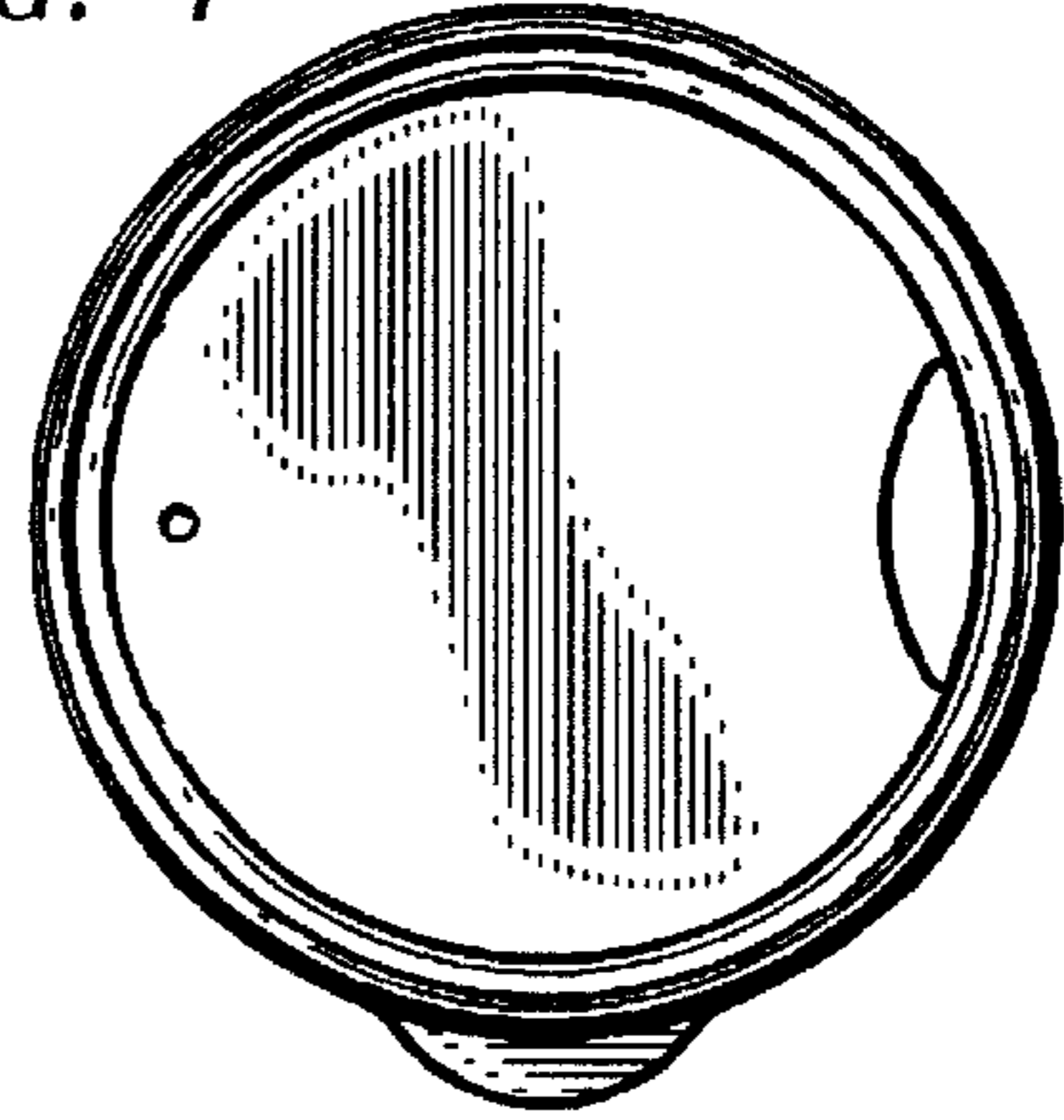

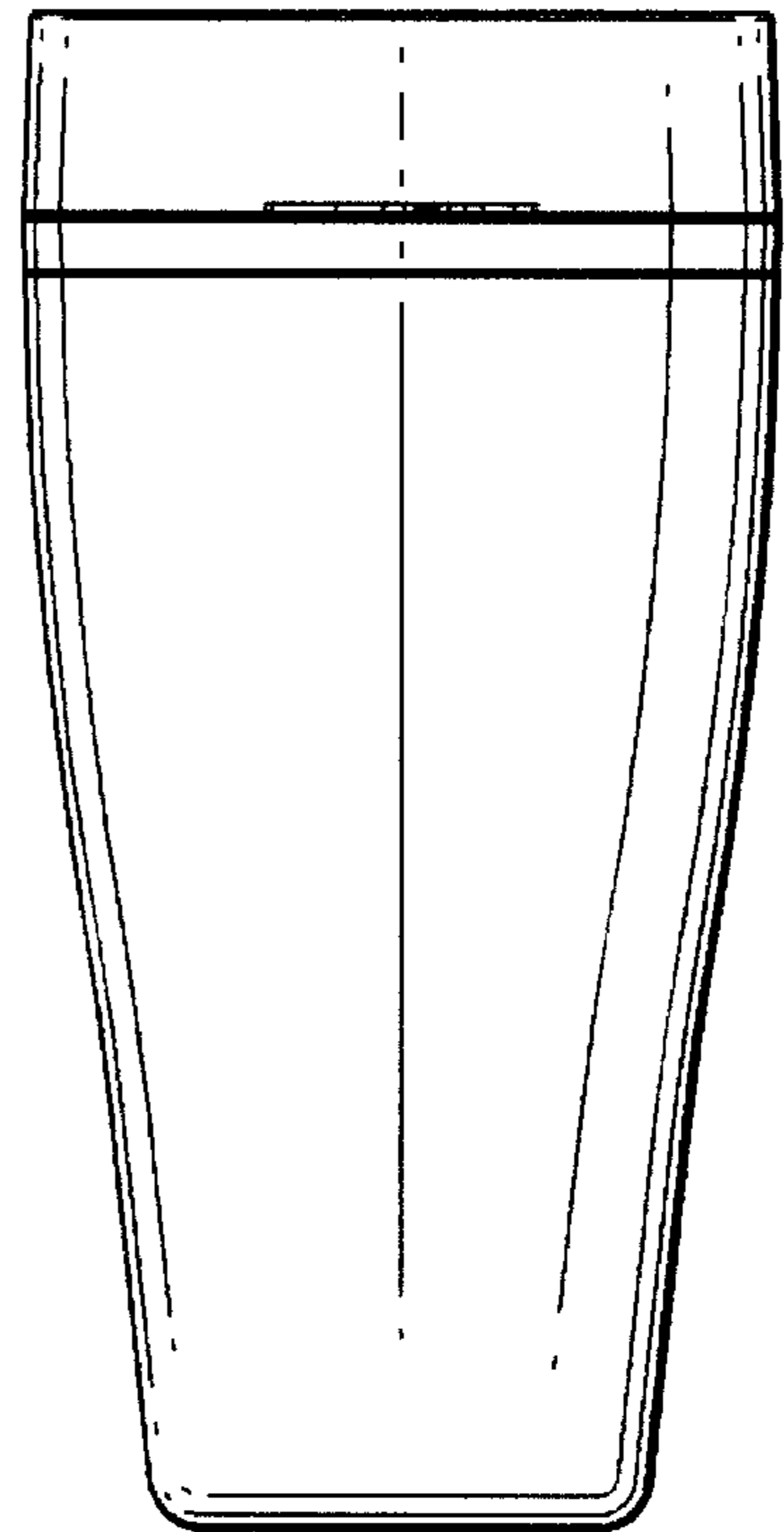

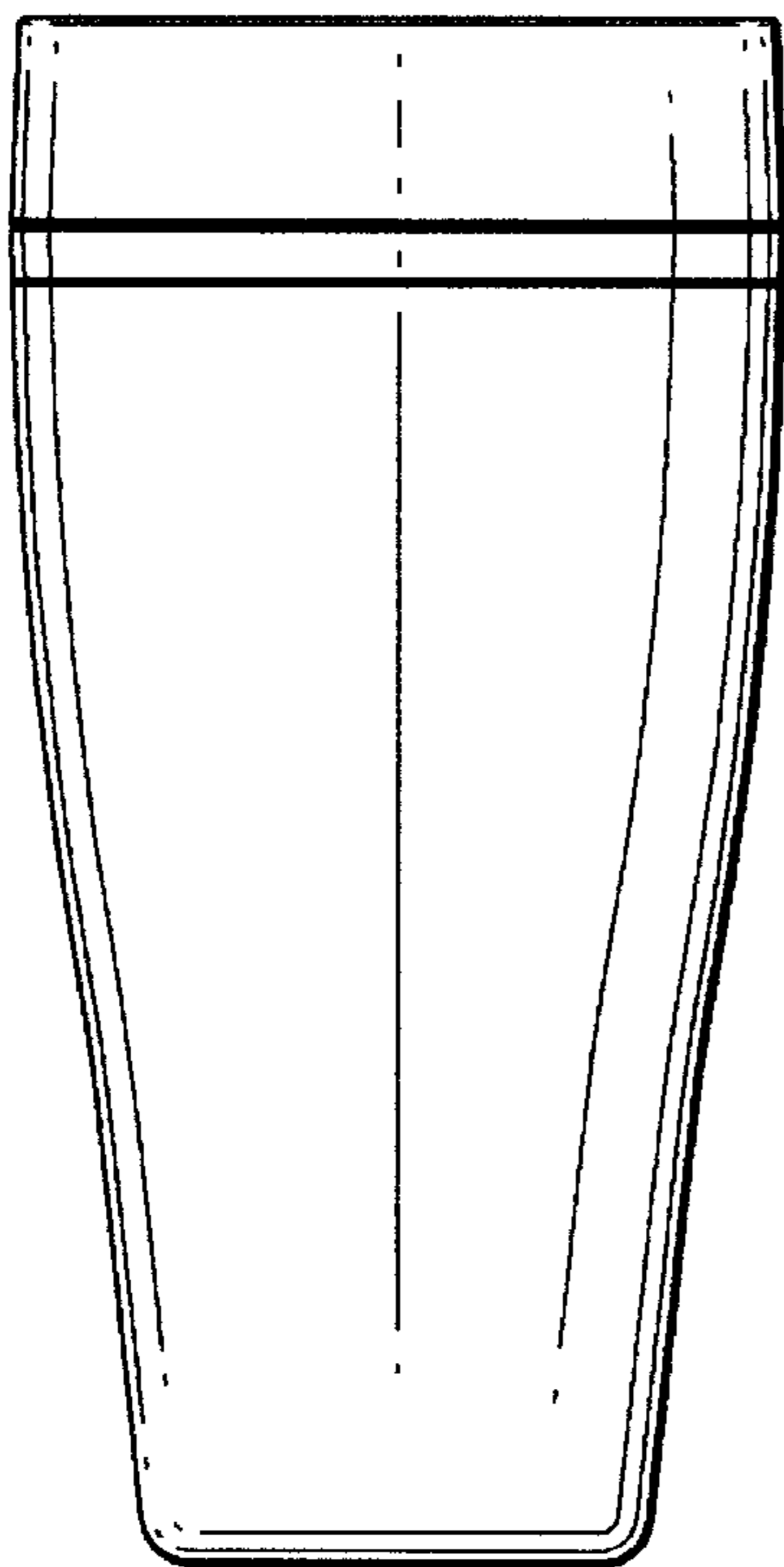
