(57) **CLAIM**

The ornamental design for a transparent plant stake with transparent tie member, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a transparent plant stake with transparent tie member showing our new design;

FIG. 2 is a top plan view of the embodiment shown in FIG. 1;

FIG. 3 is a side elevational view of the embodiment shown in FIG. 1;

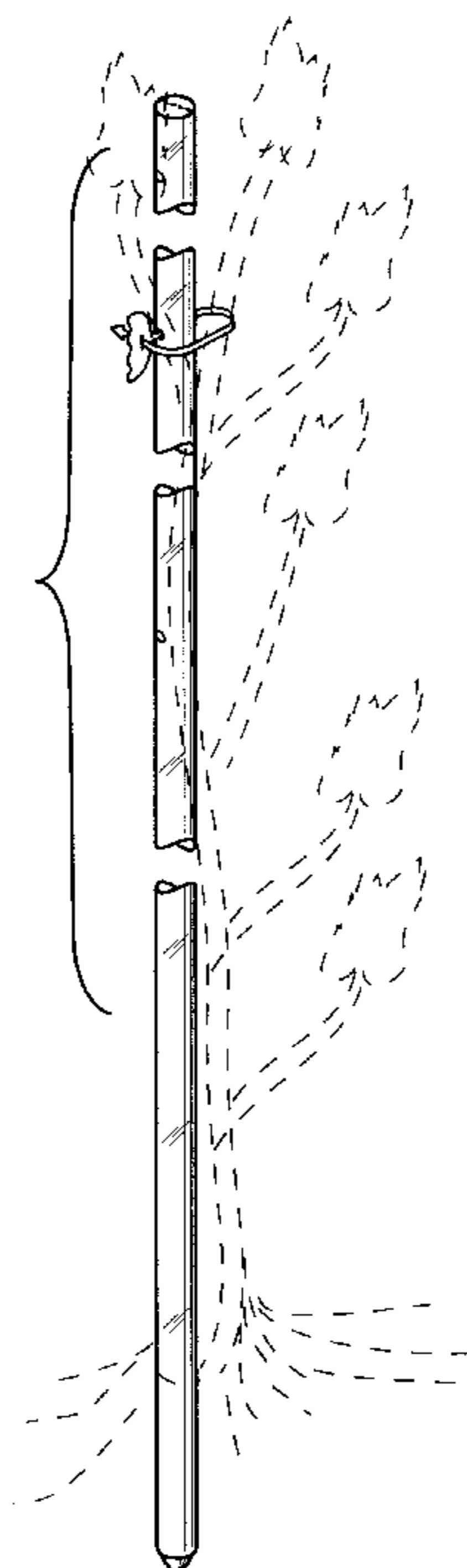
FIG. 4 is an end elevational view of the embodiment shown in FIG. 1;

FIG. 5 is a bottom plan view of the embodiment shown in FIG. 1; and,

FIG. 6 is a perspective illustration of the tie member shown in the unsecured position.

The broken line showing of the plant in FIGS. 1 through 5 is for illustrative purposes only and forms no part of the claimed design. The breaks are shown in FIGS. 1, 3, and 4 to indicate of indeterminate length.

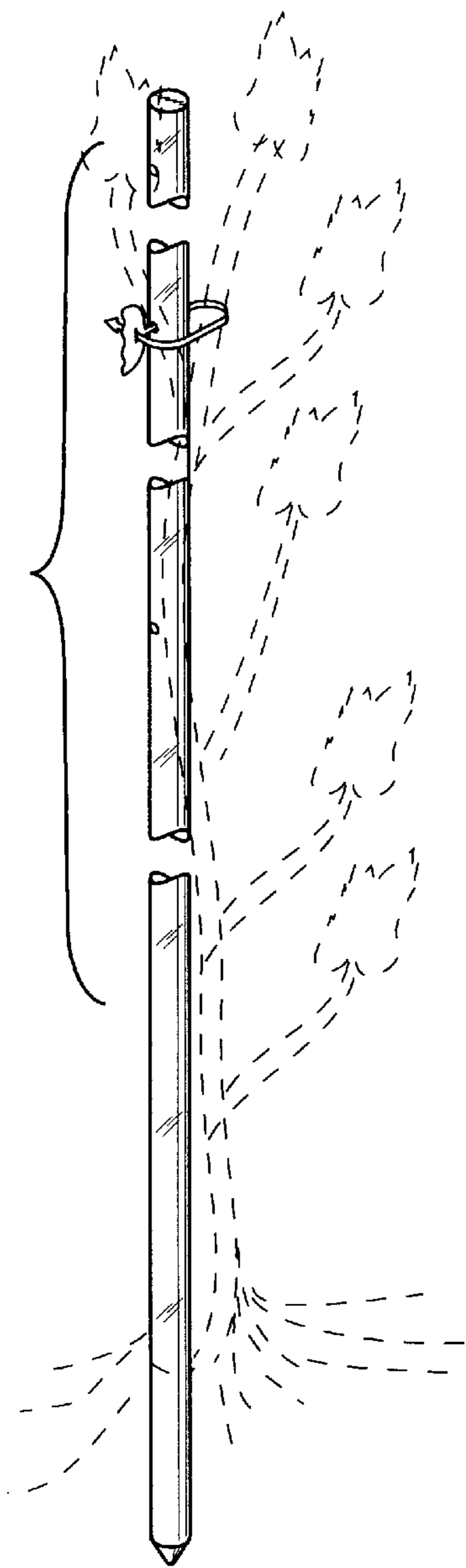

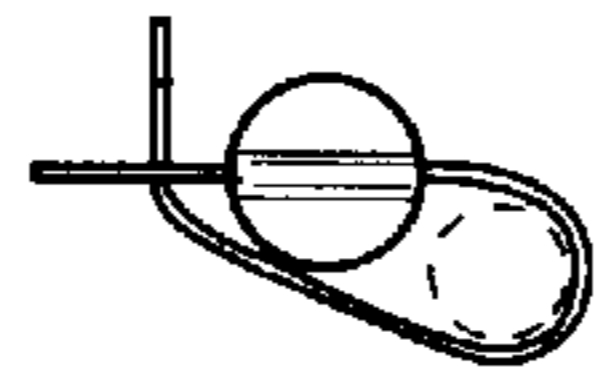

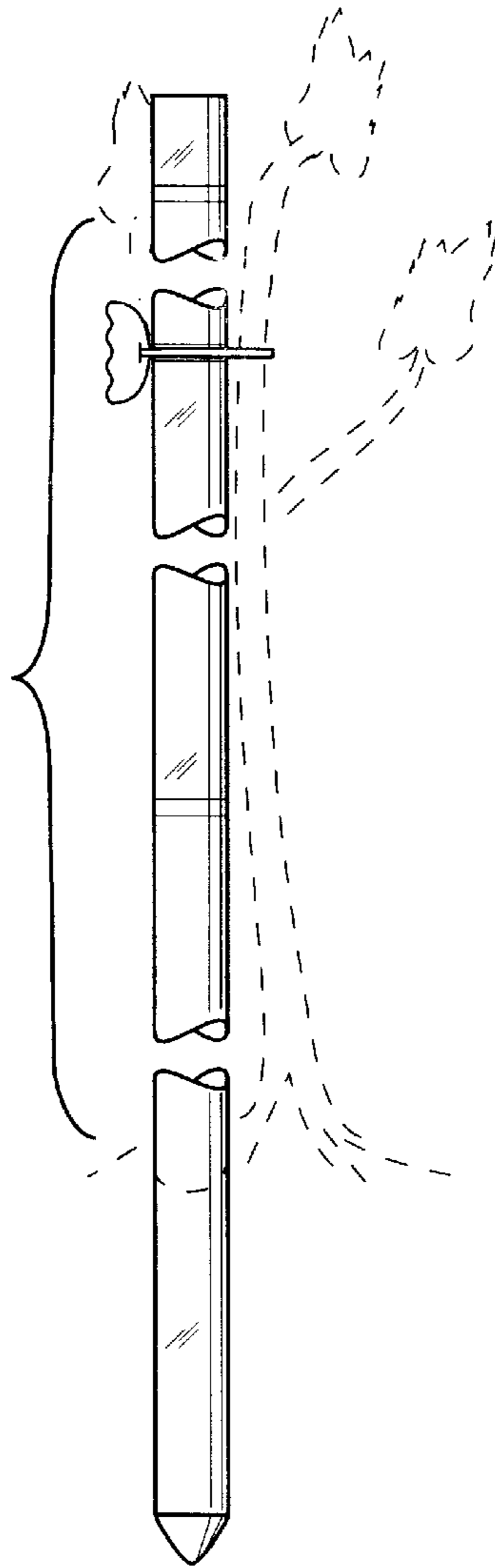

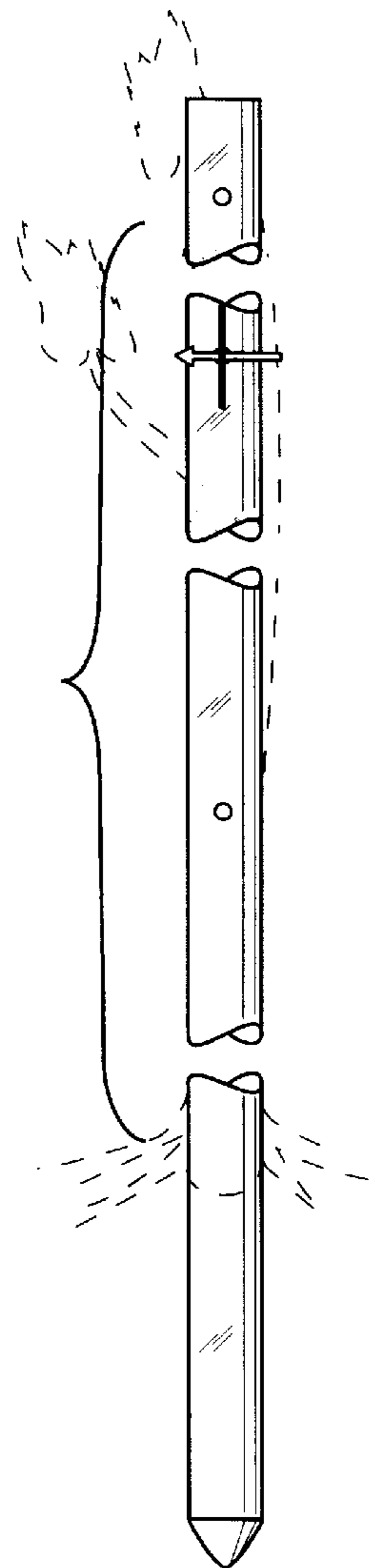

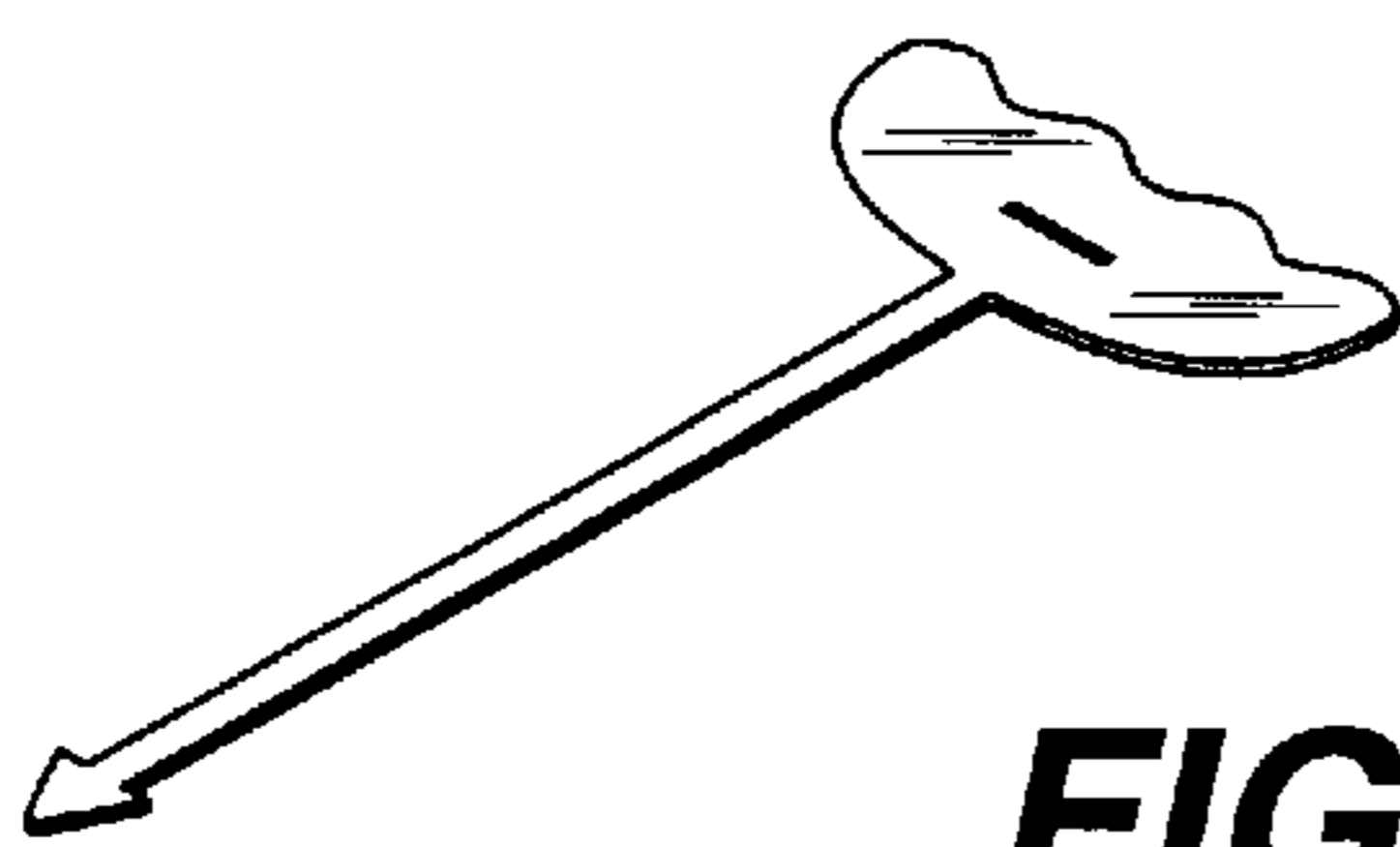

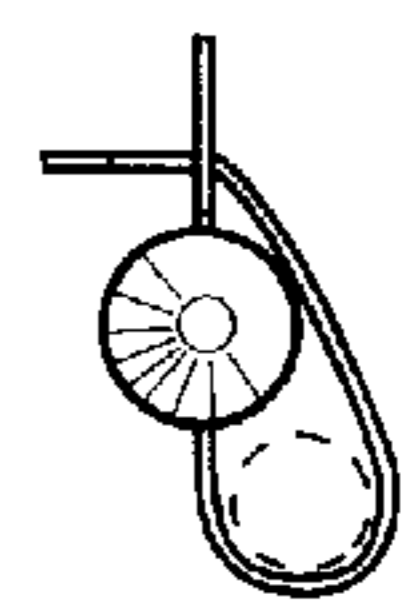
