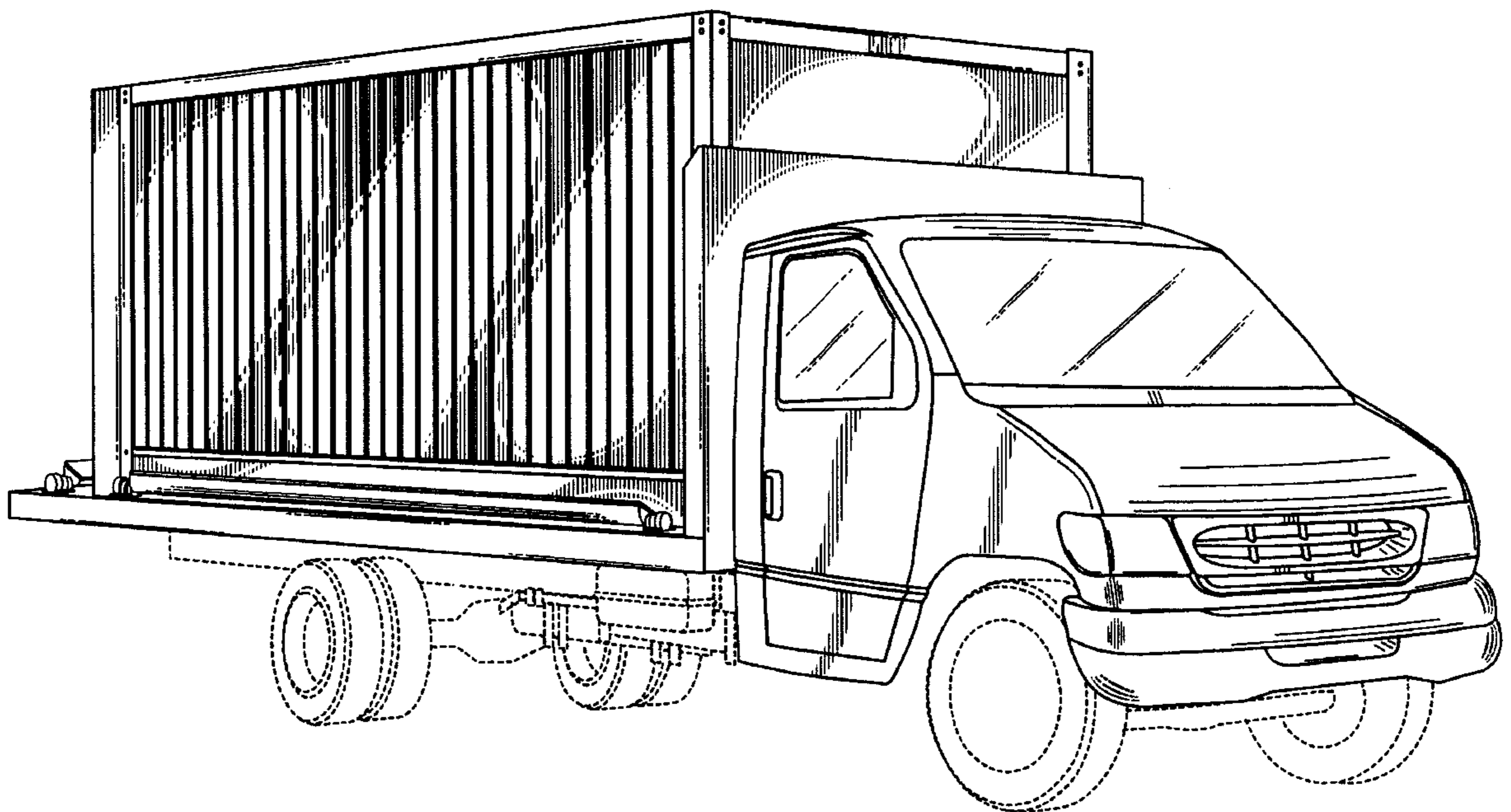

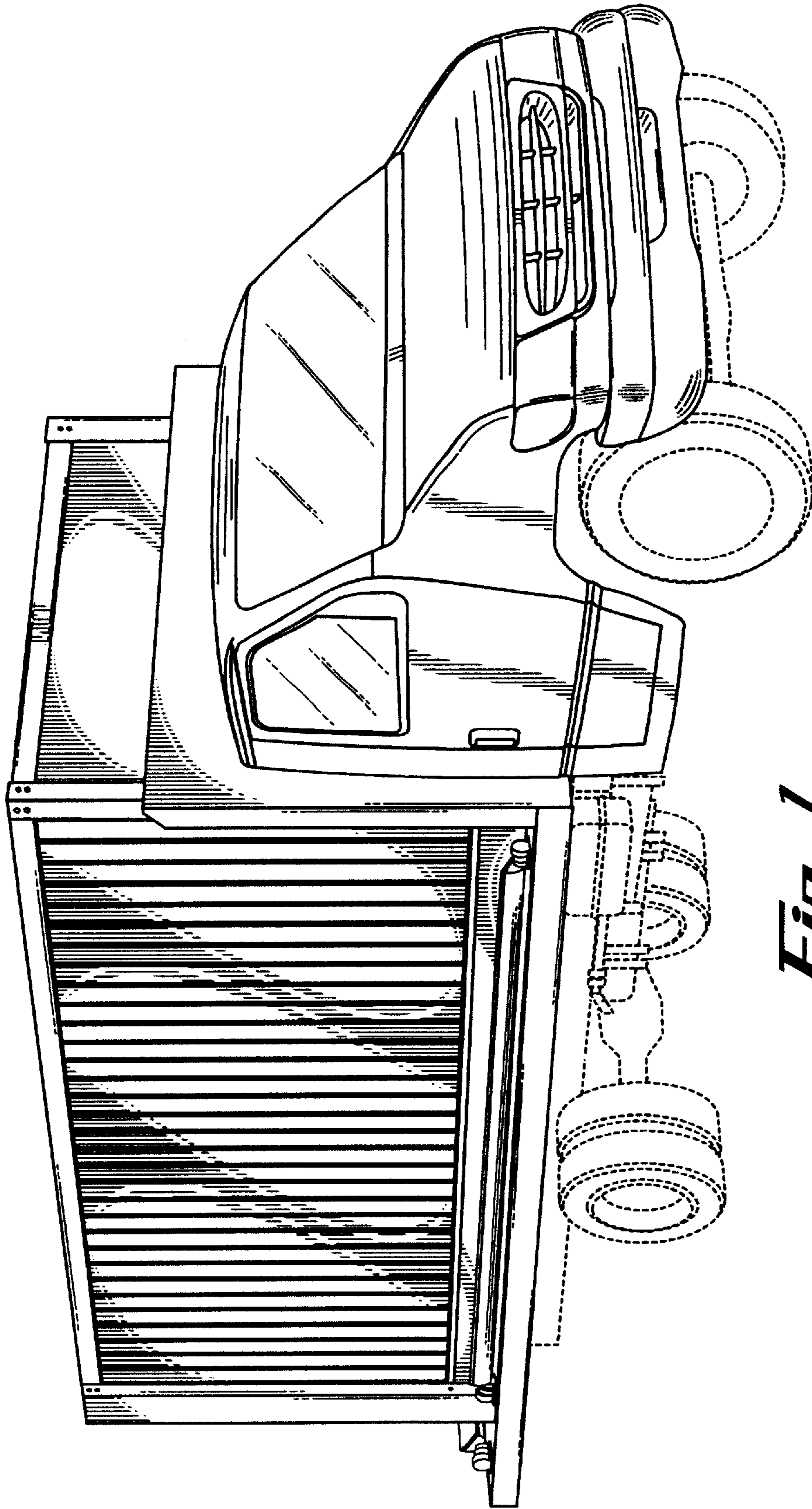
The ornamental design of a mobile multi-display billboard vehicle, as shown and described.

**DESCRIPTION**

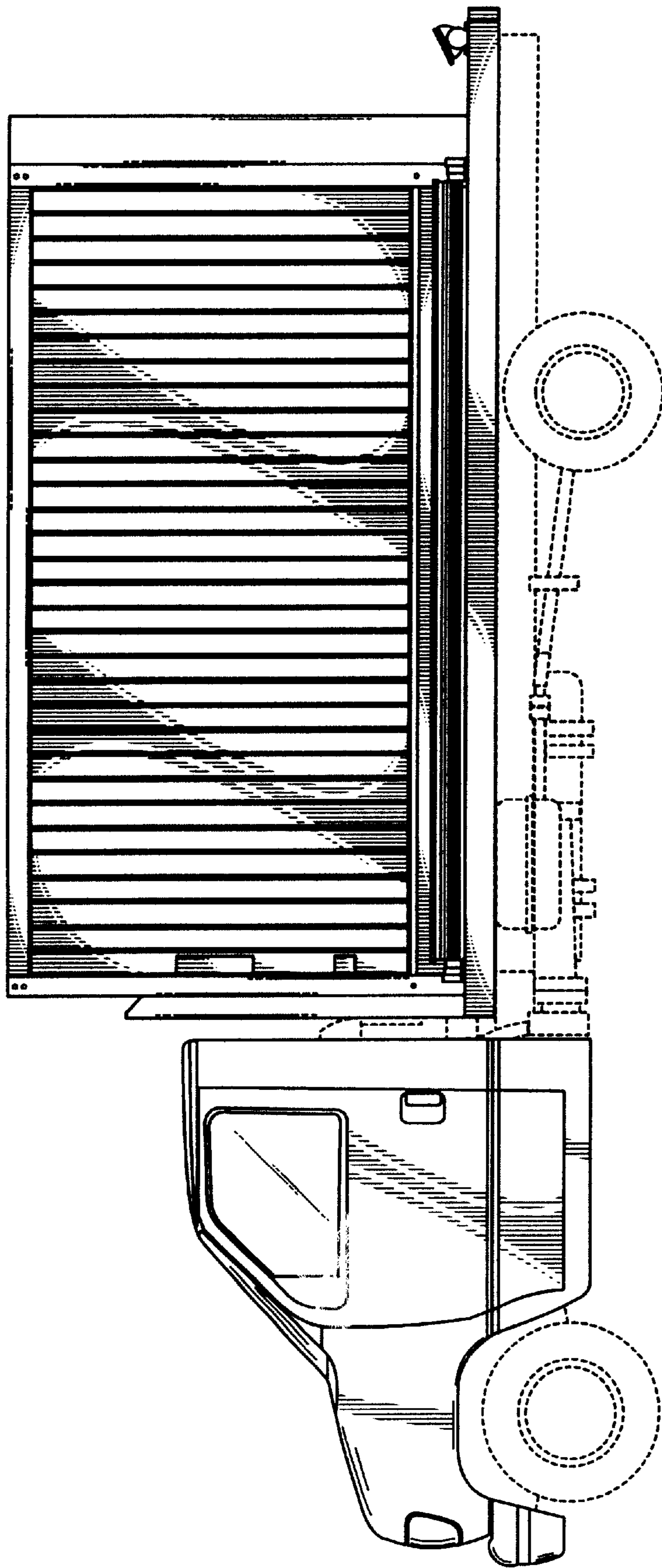
FIG. 1 is a perspective view showing our new mobile multi-display billboard vehicle;

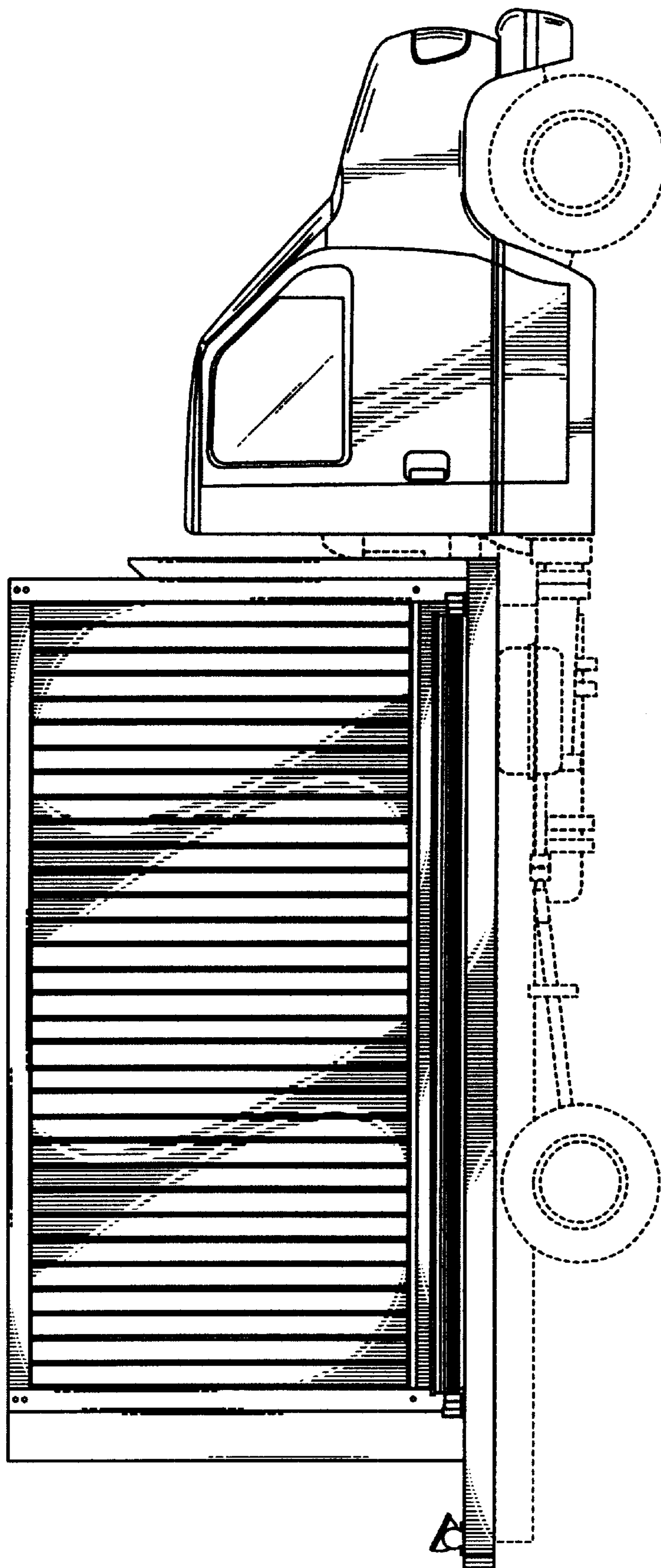

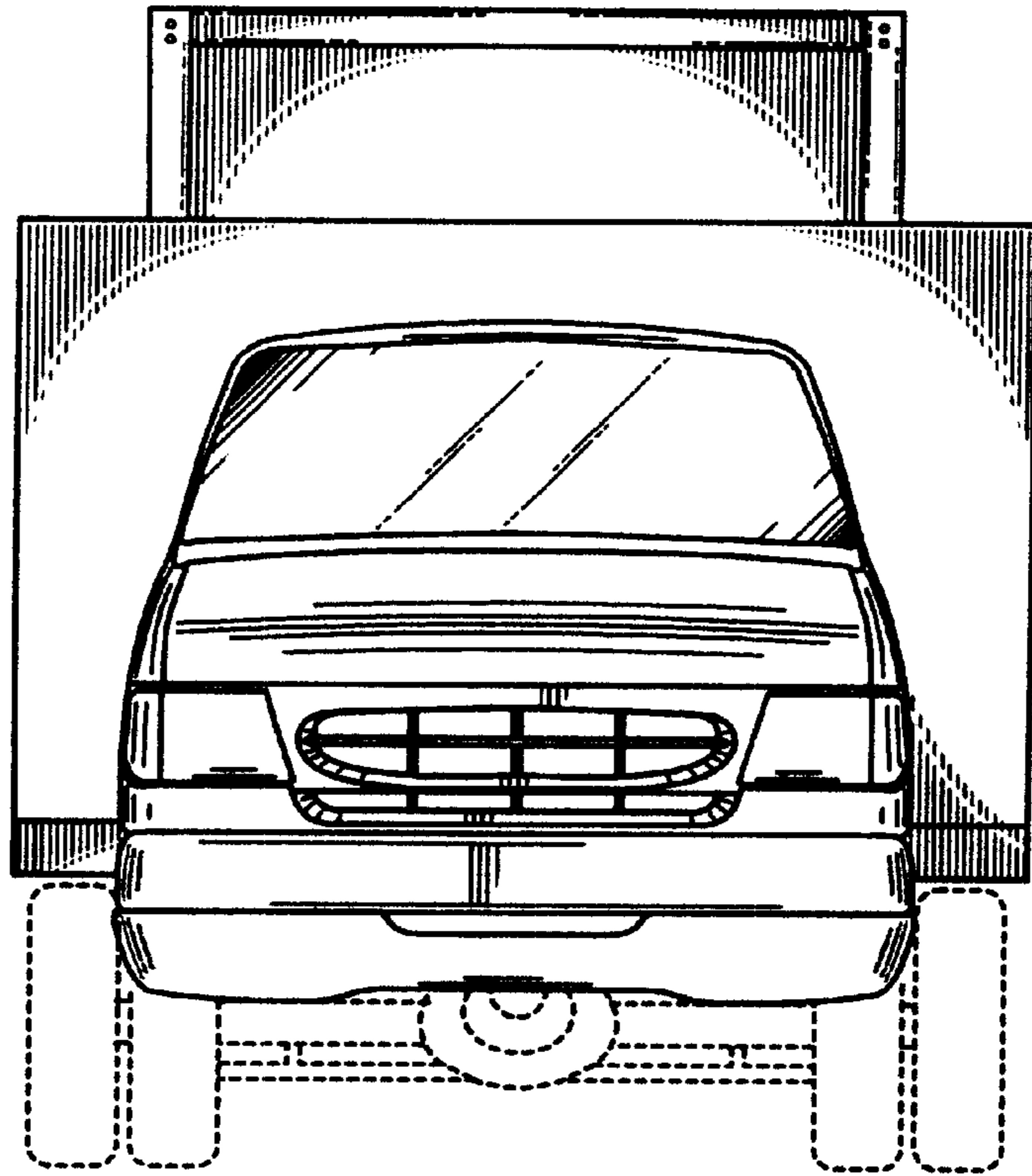

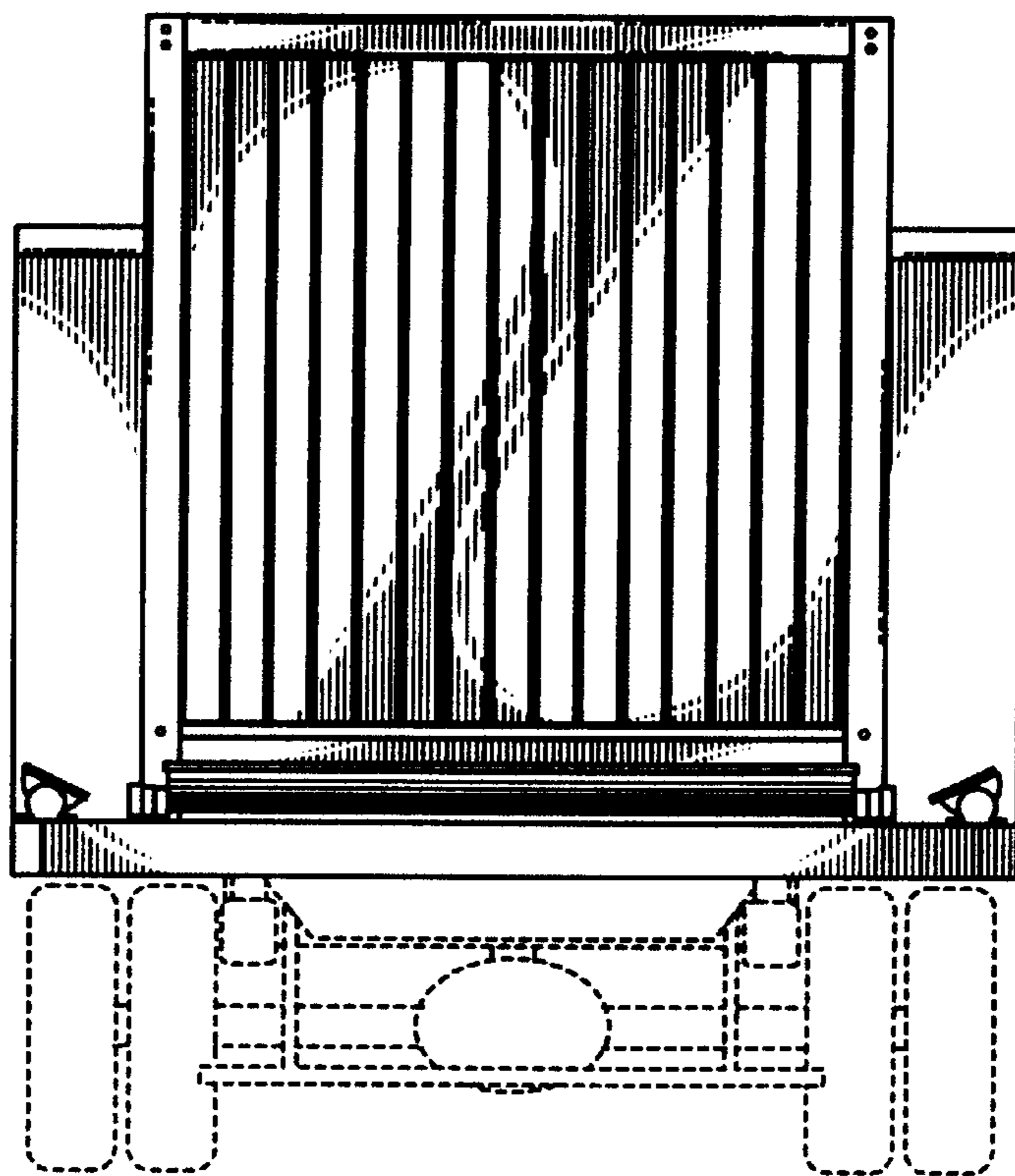


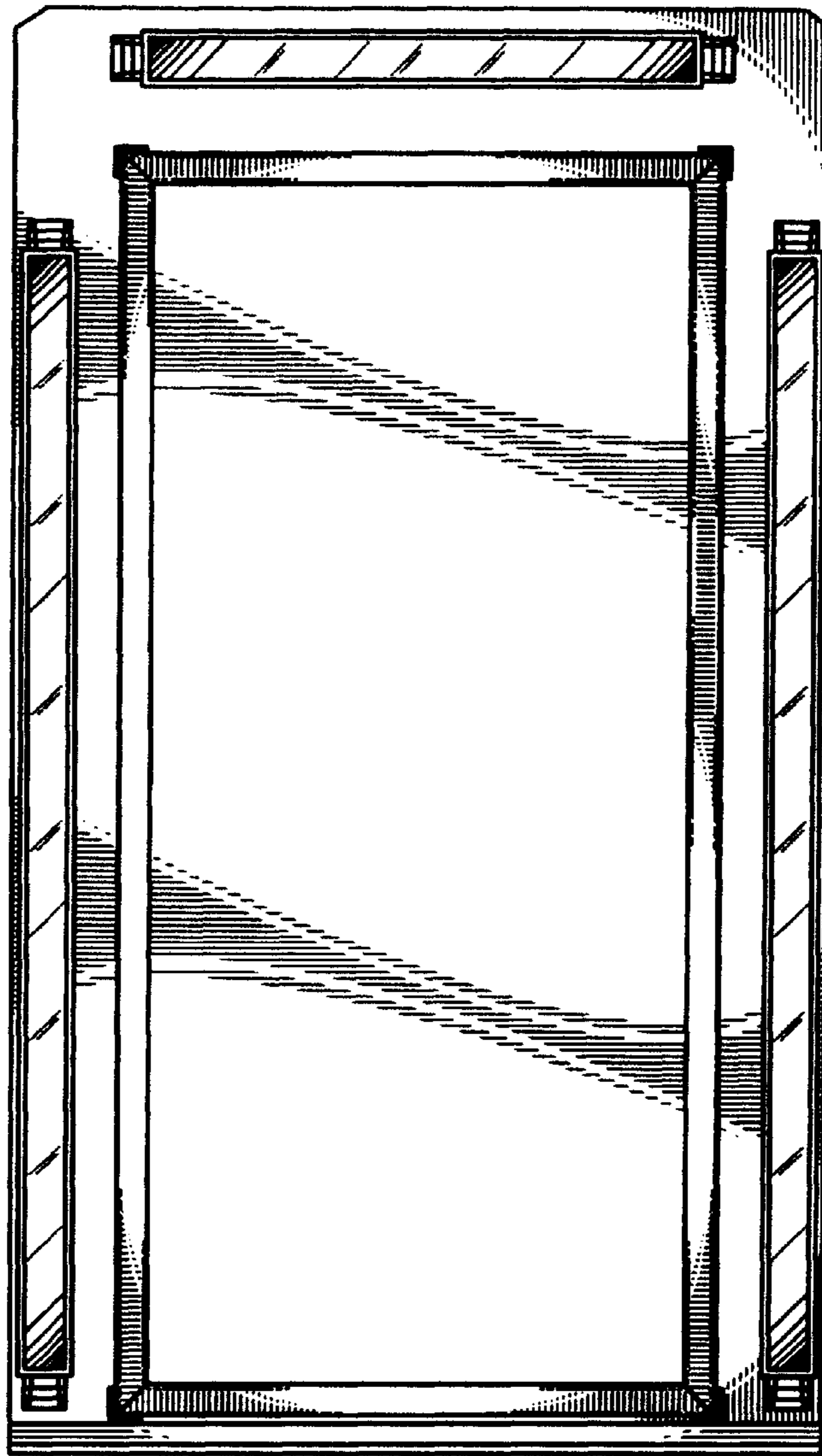
