The ornamental design of front fenders of an all terrain vehicle, as shown and described.

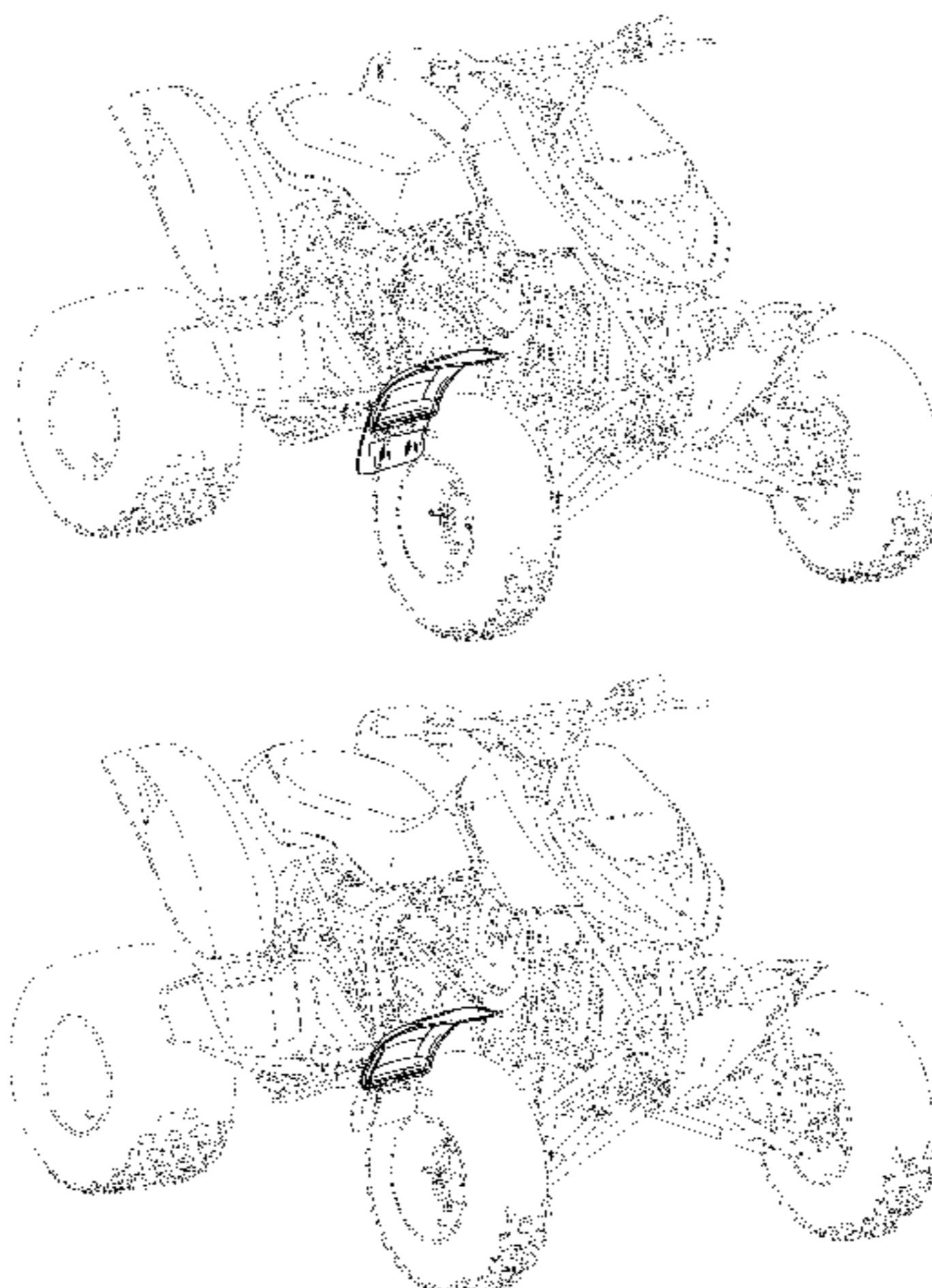
DESCRIPTION

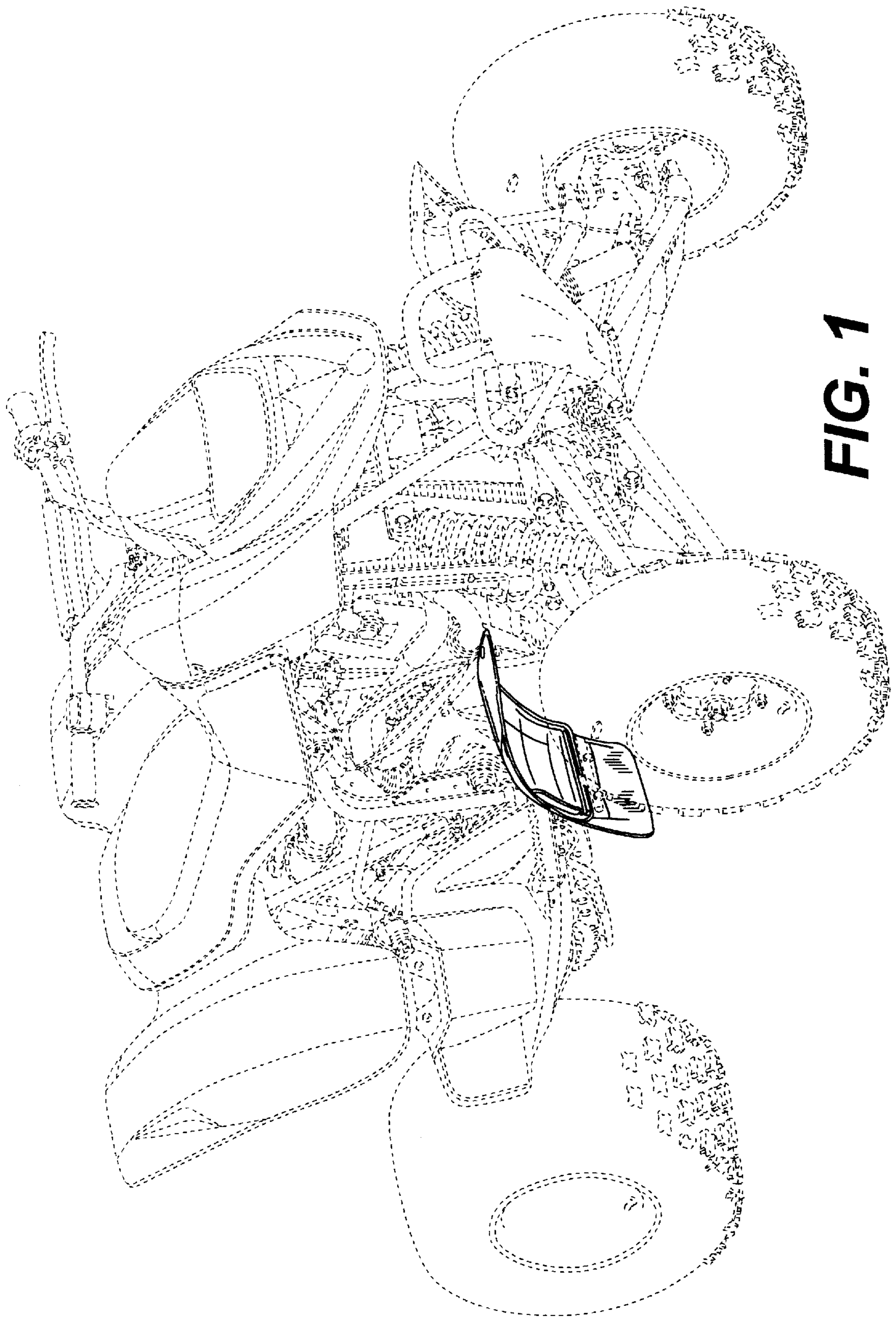

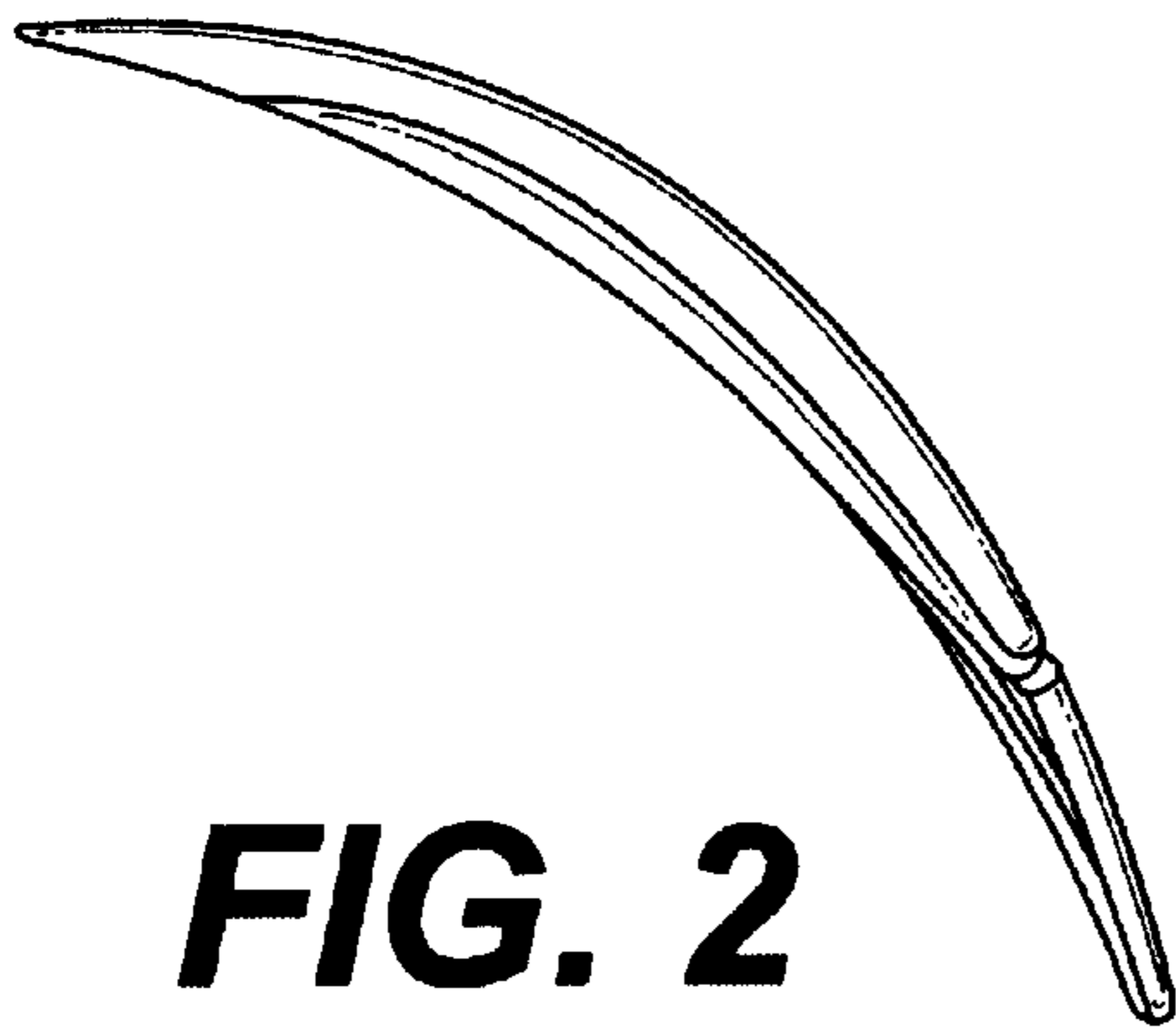

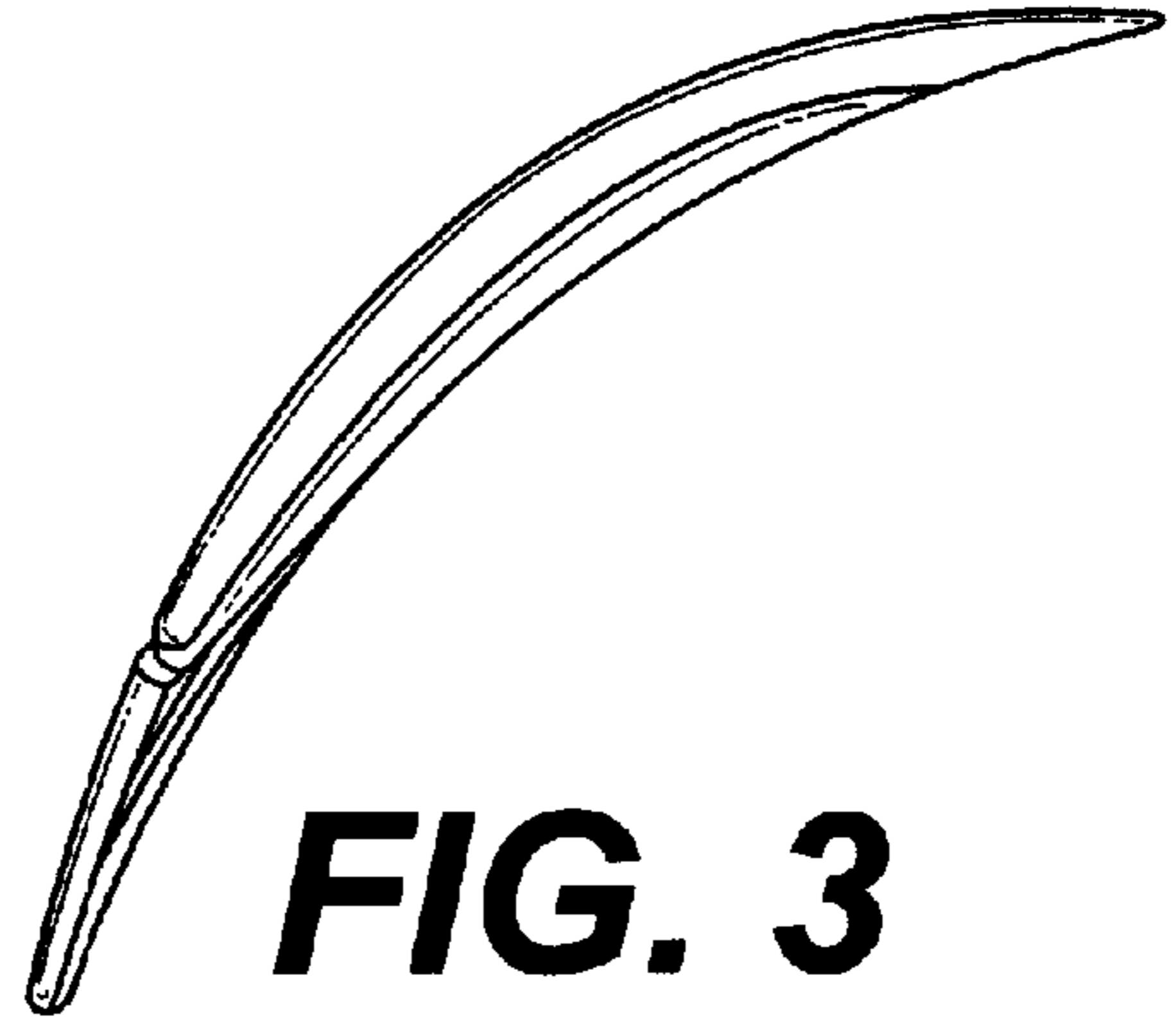

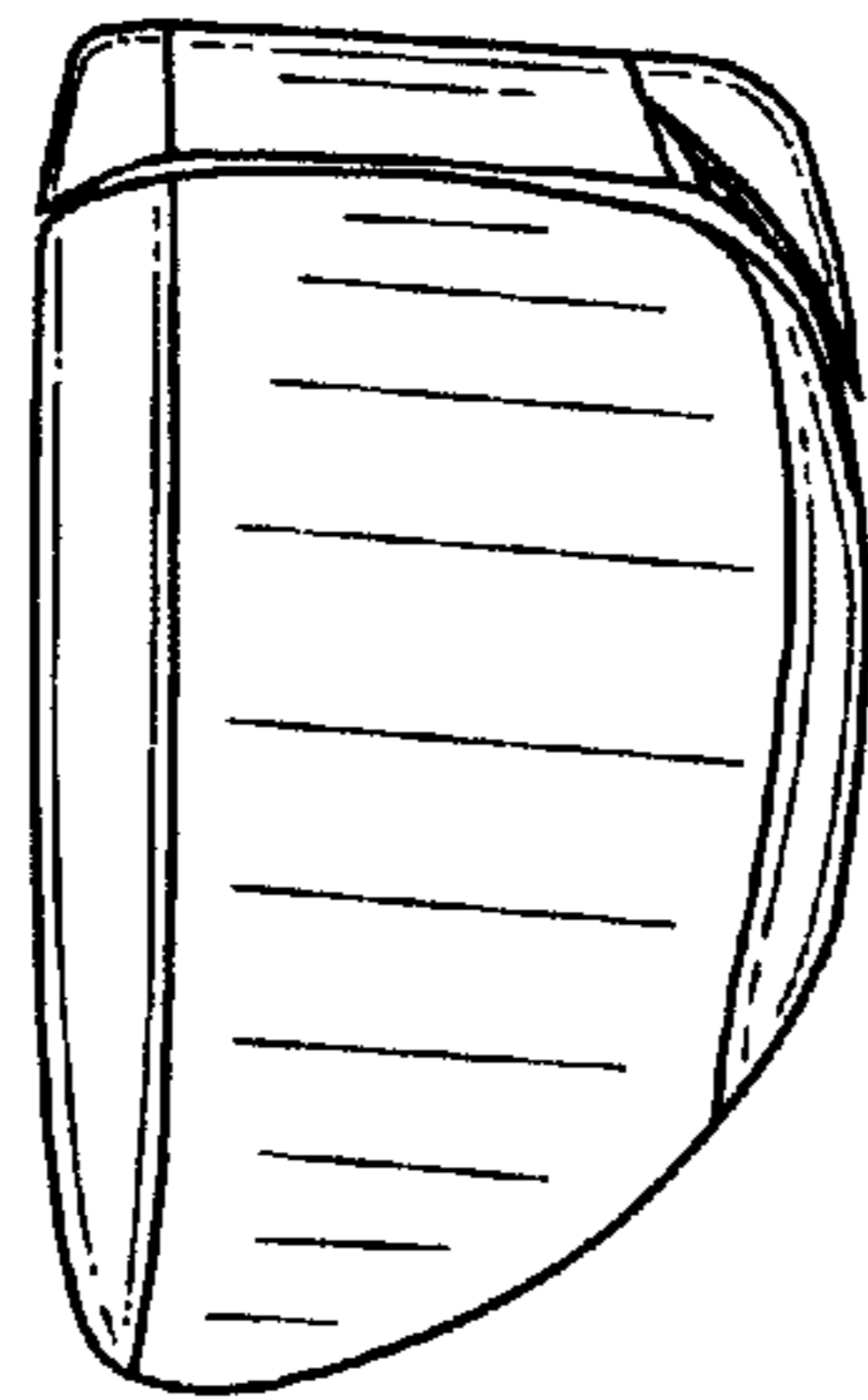

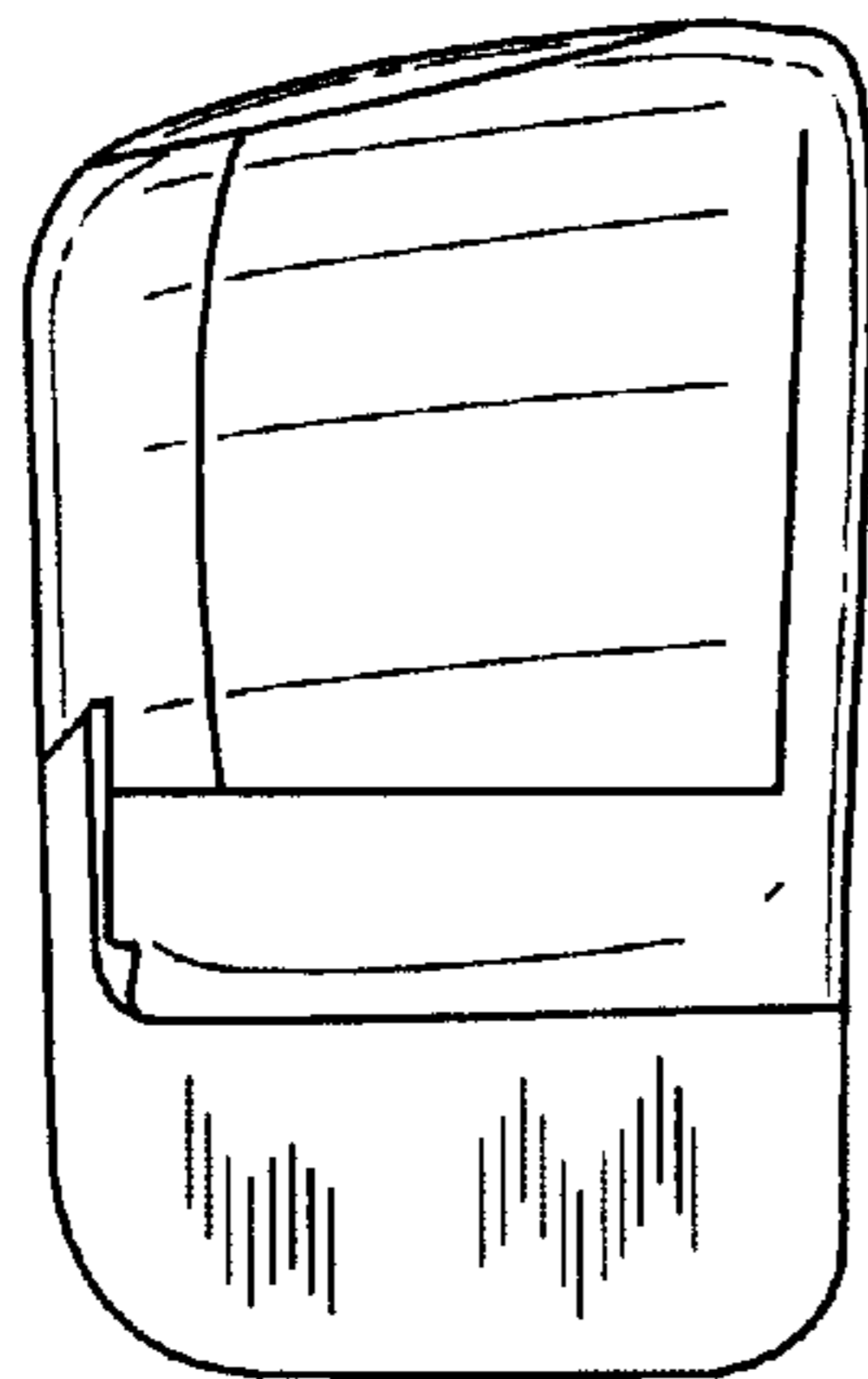

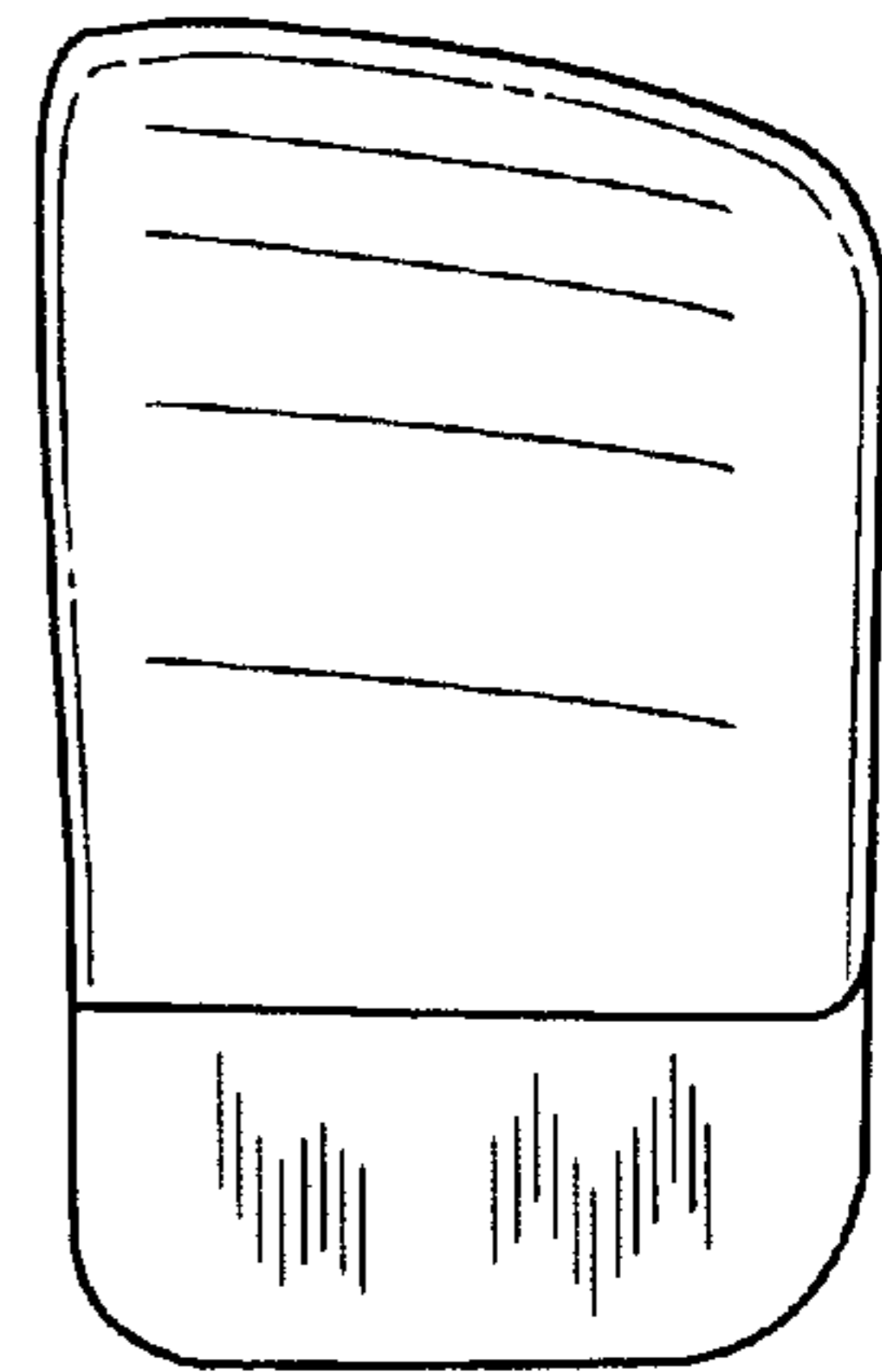

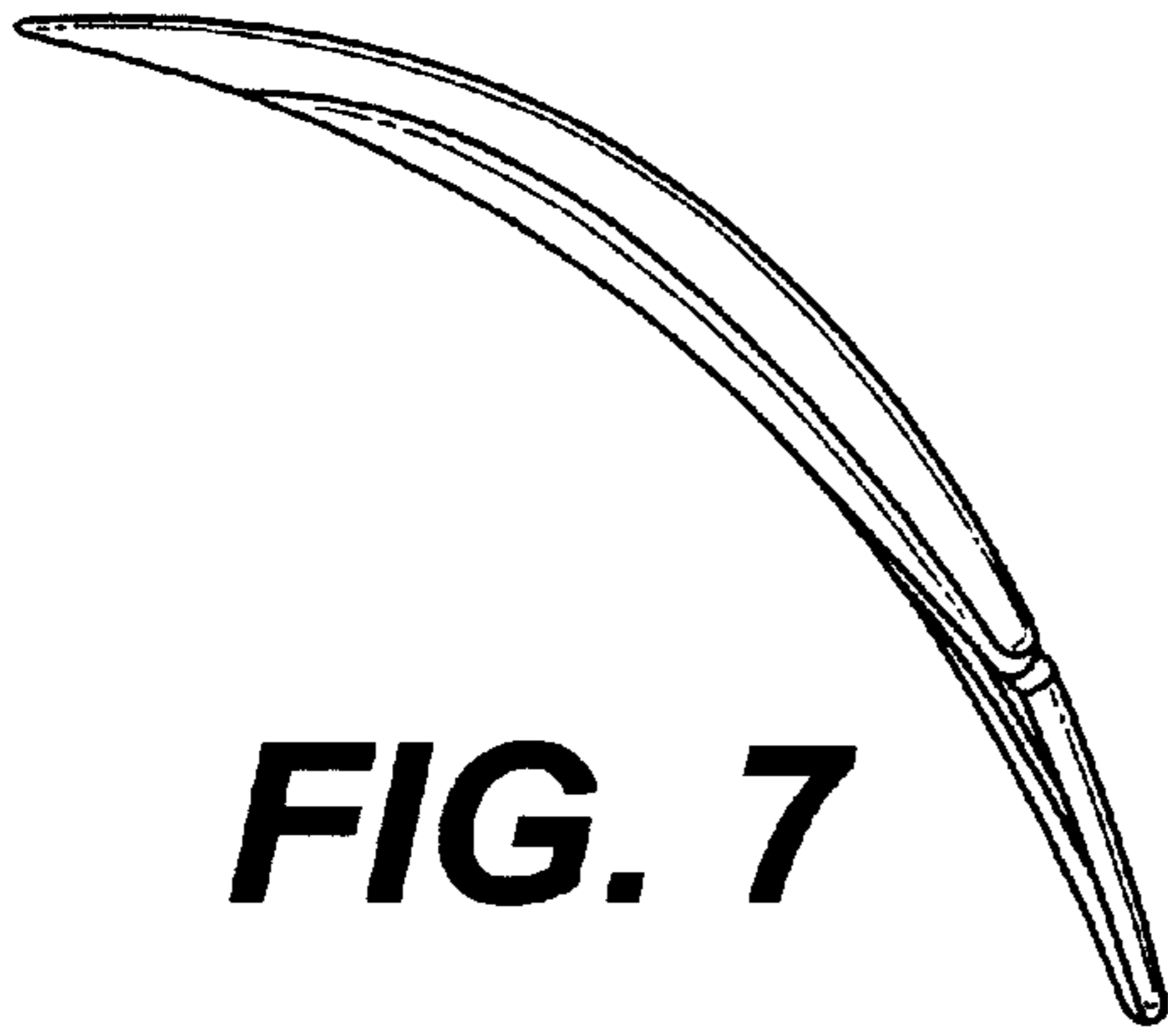

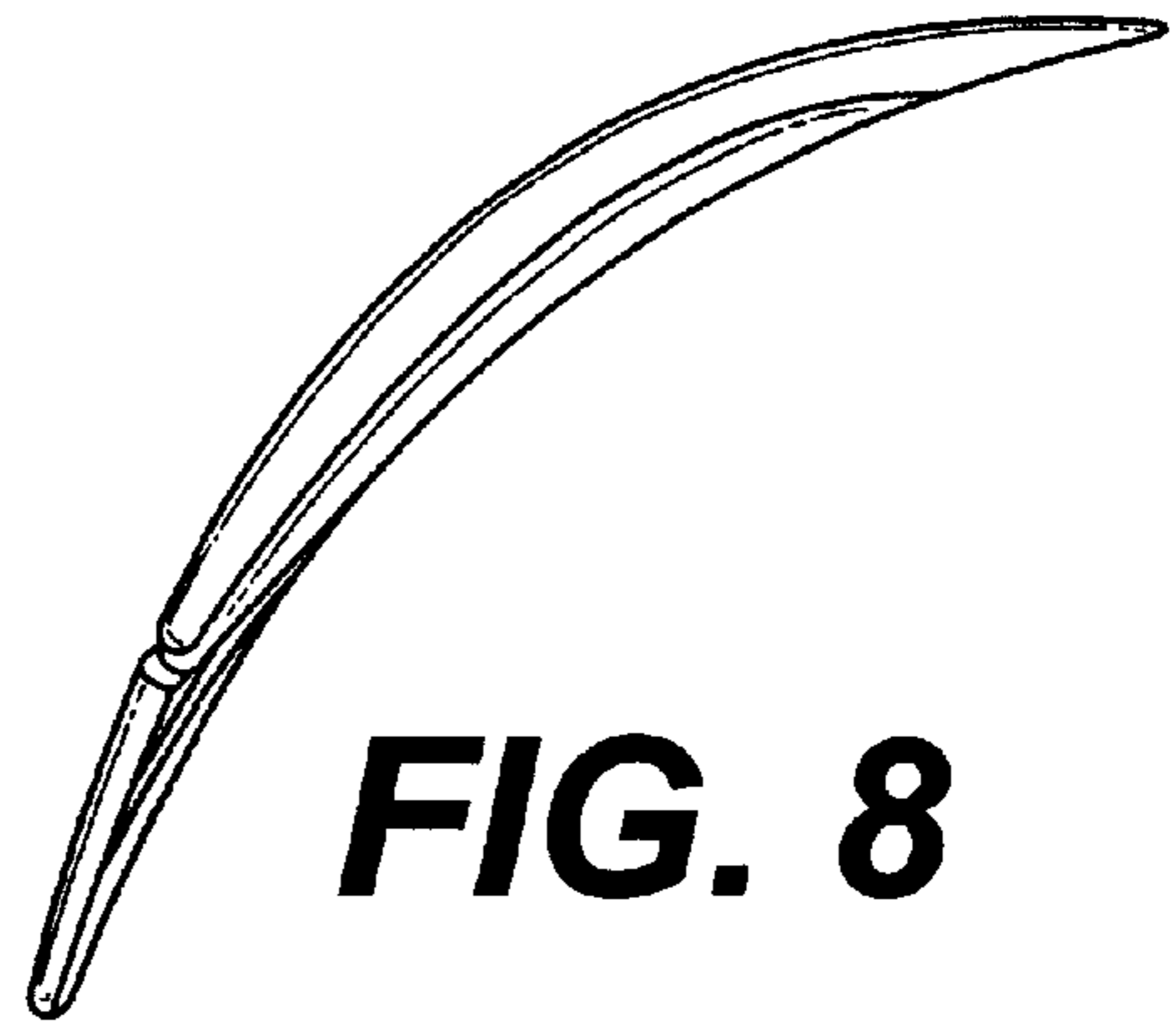

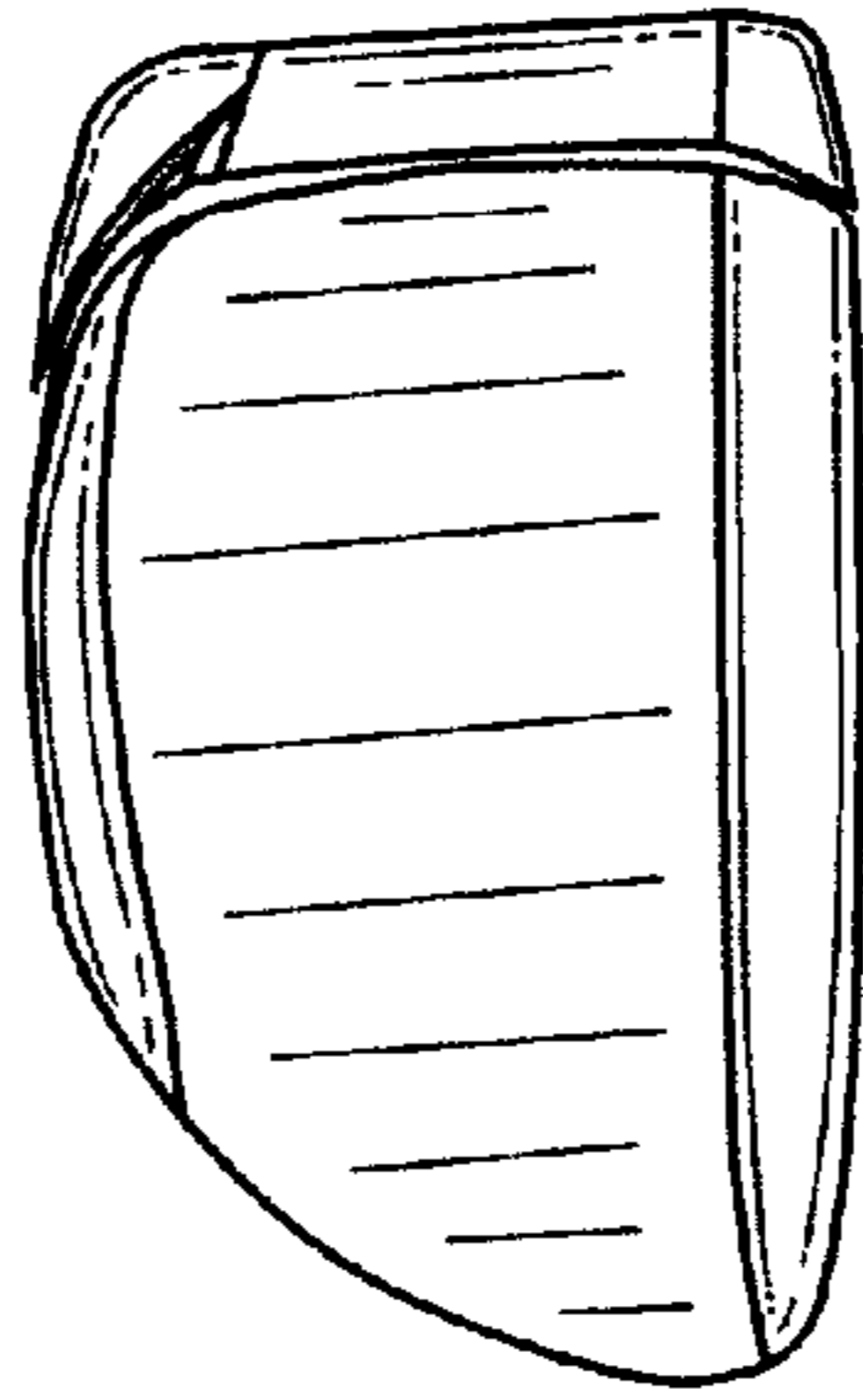

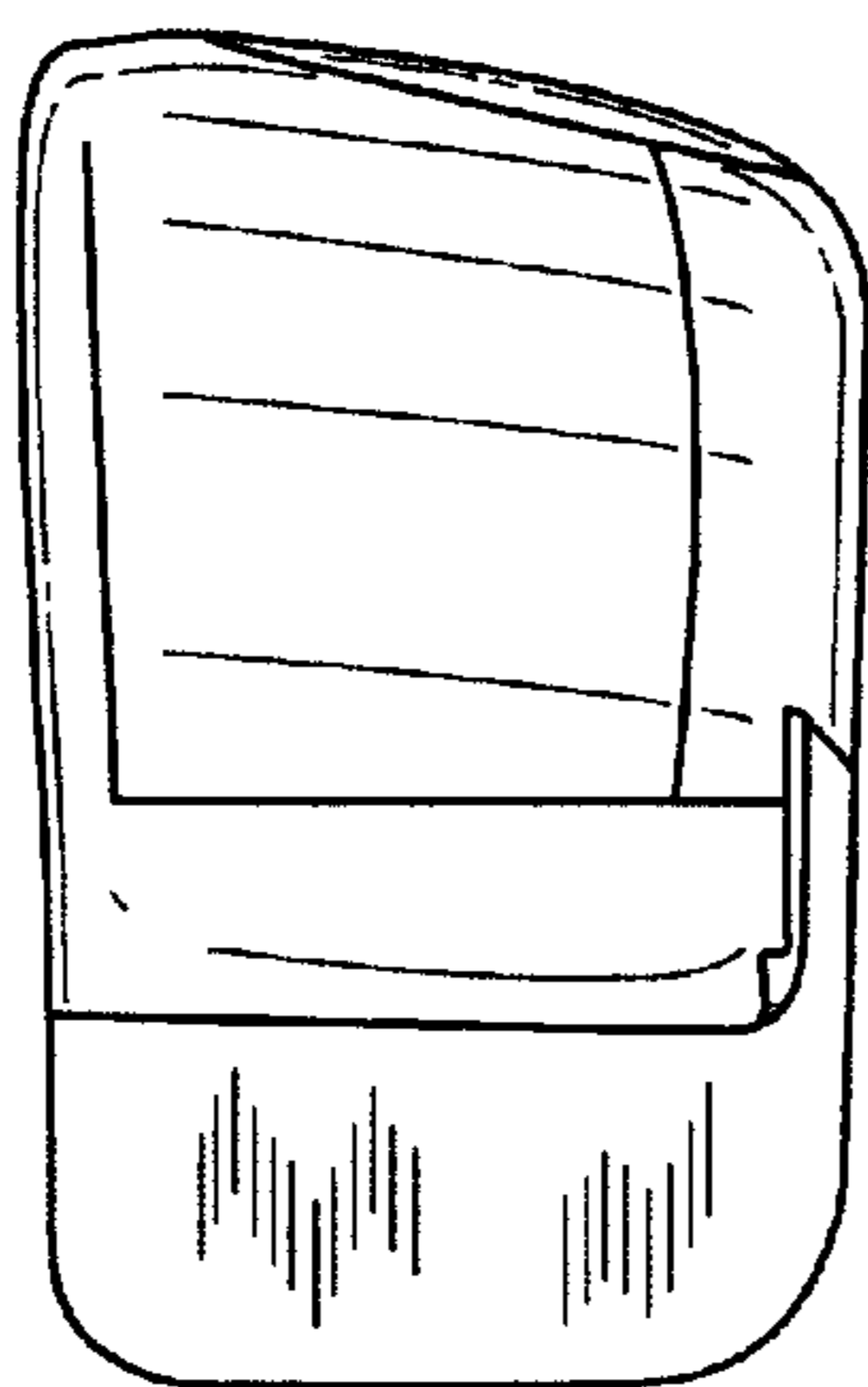

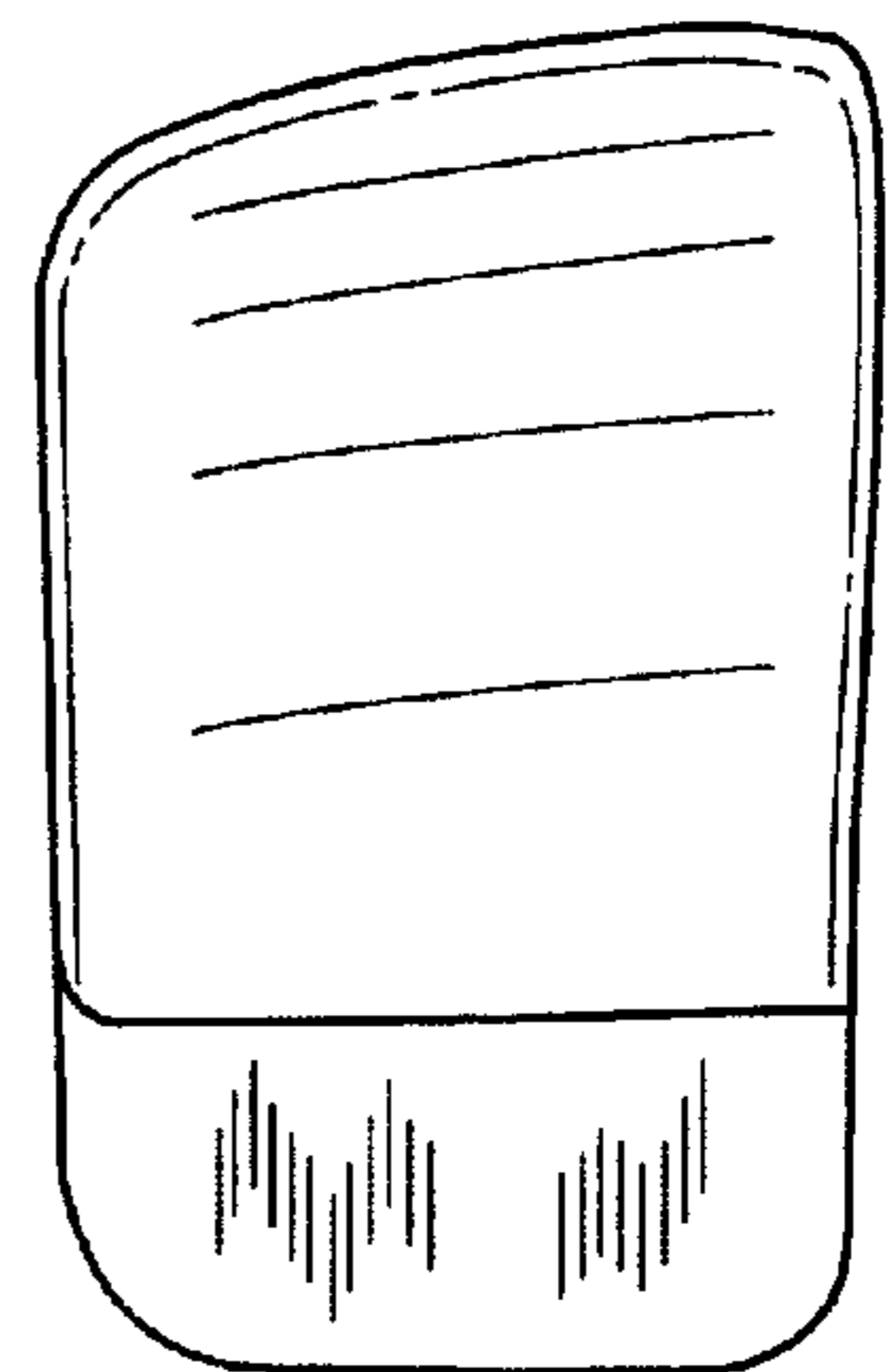

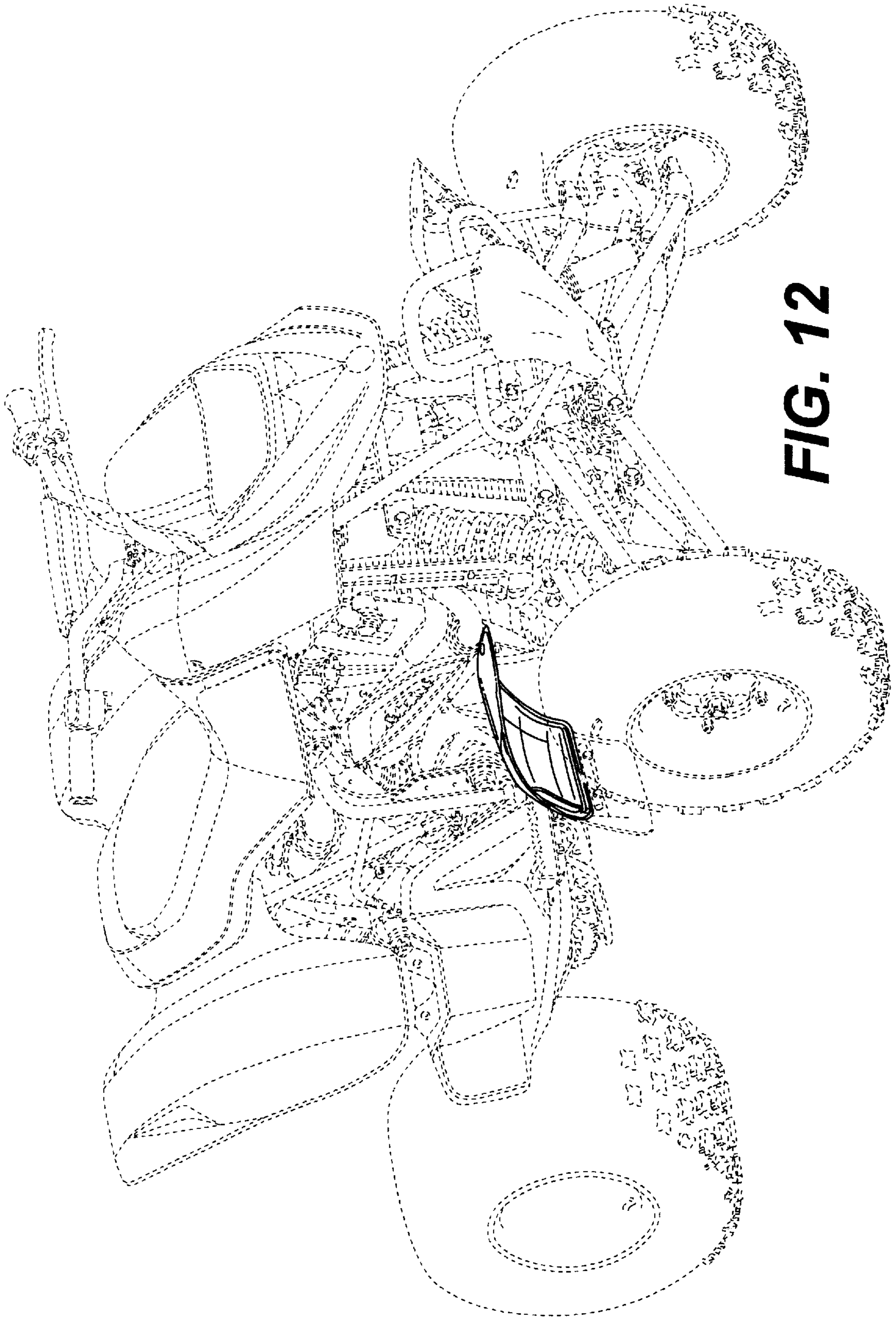

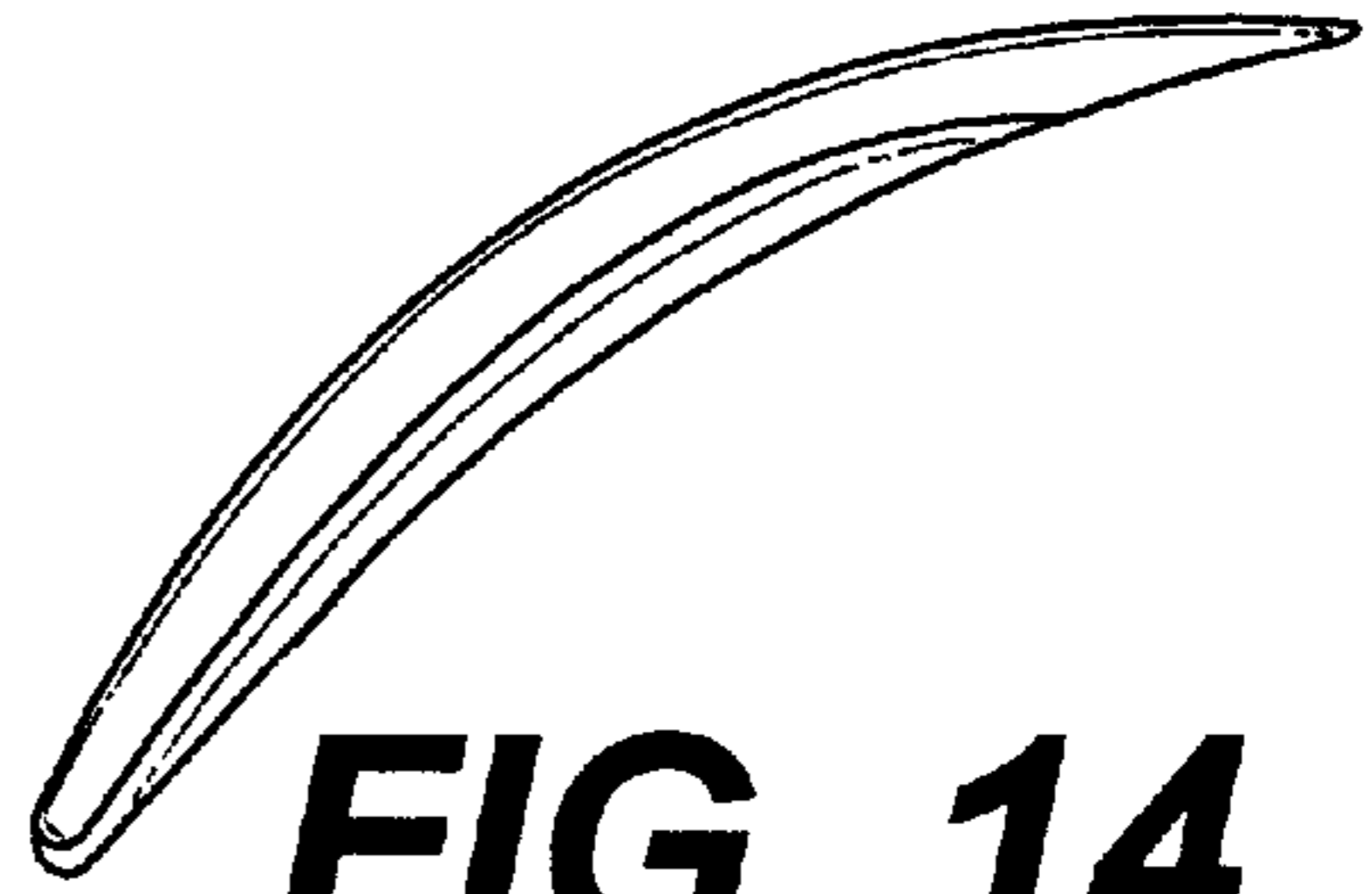

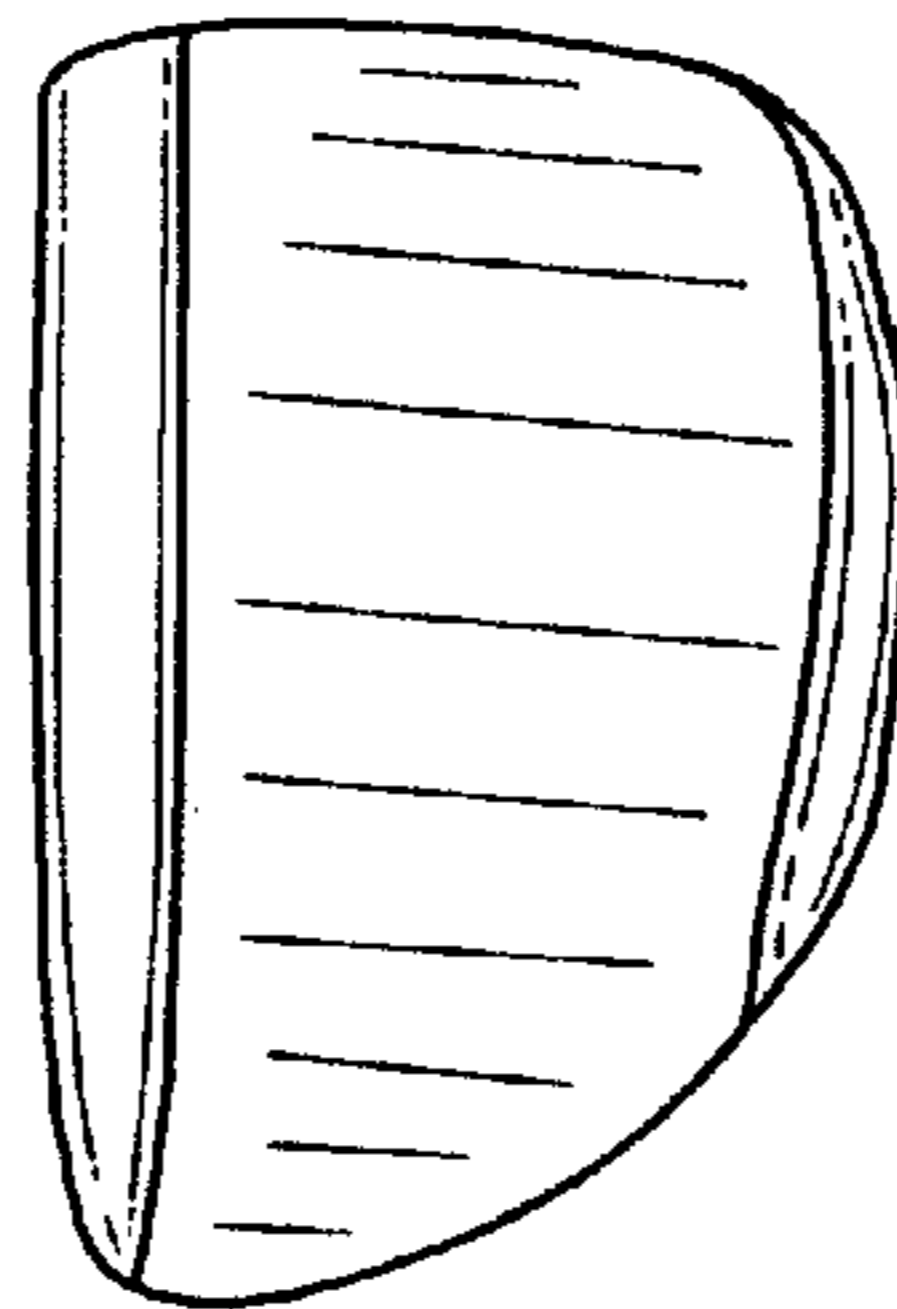

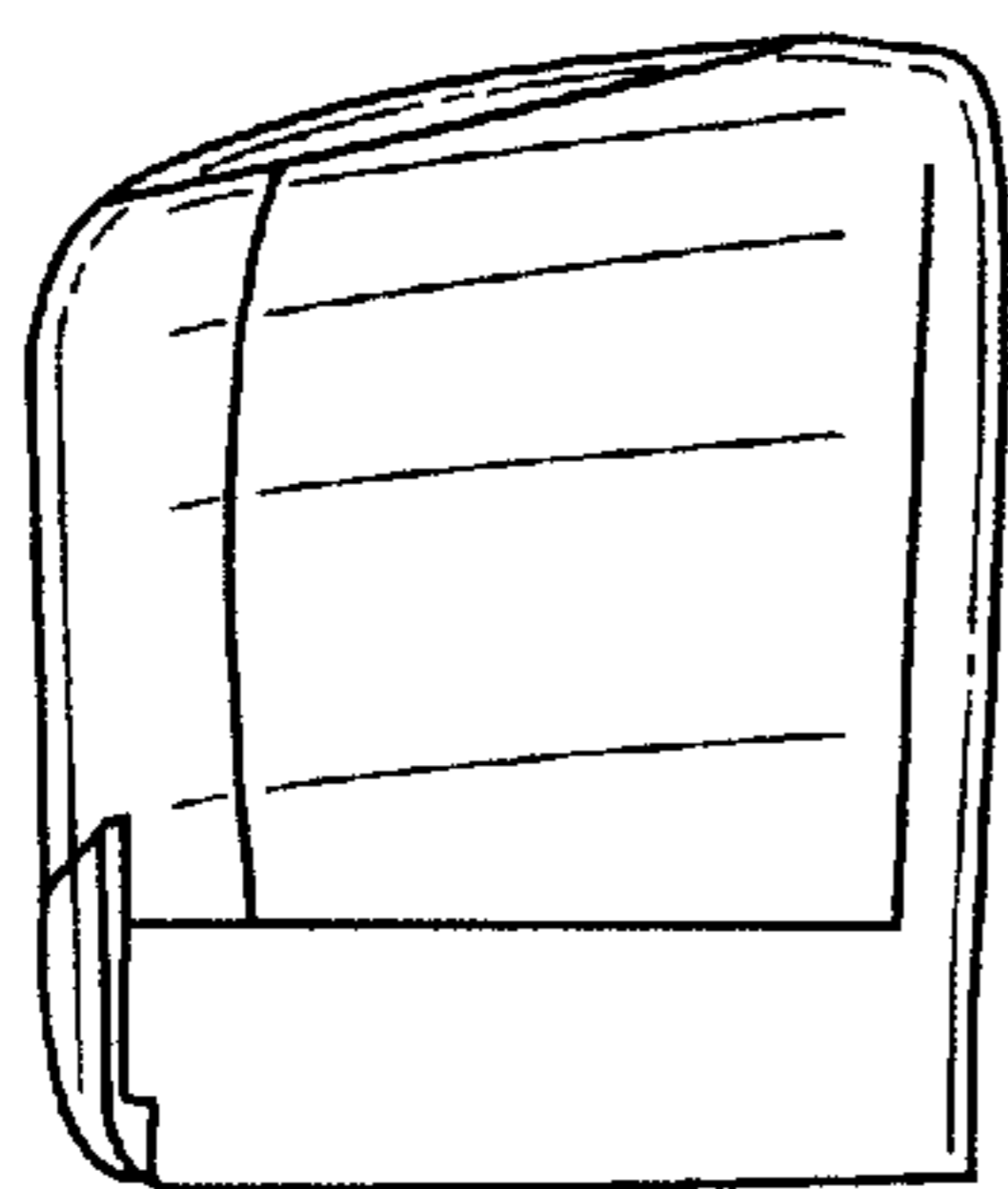

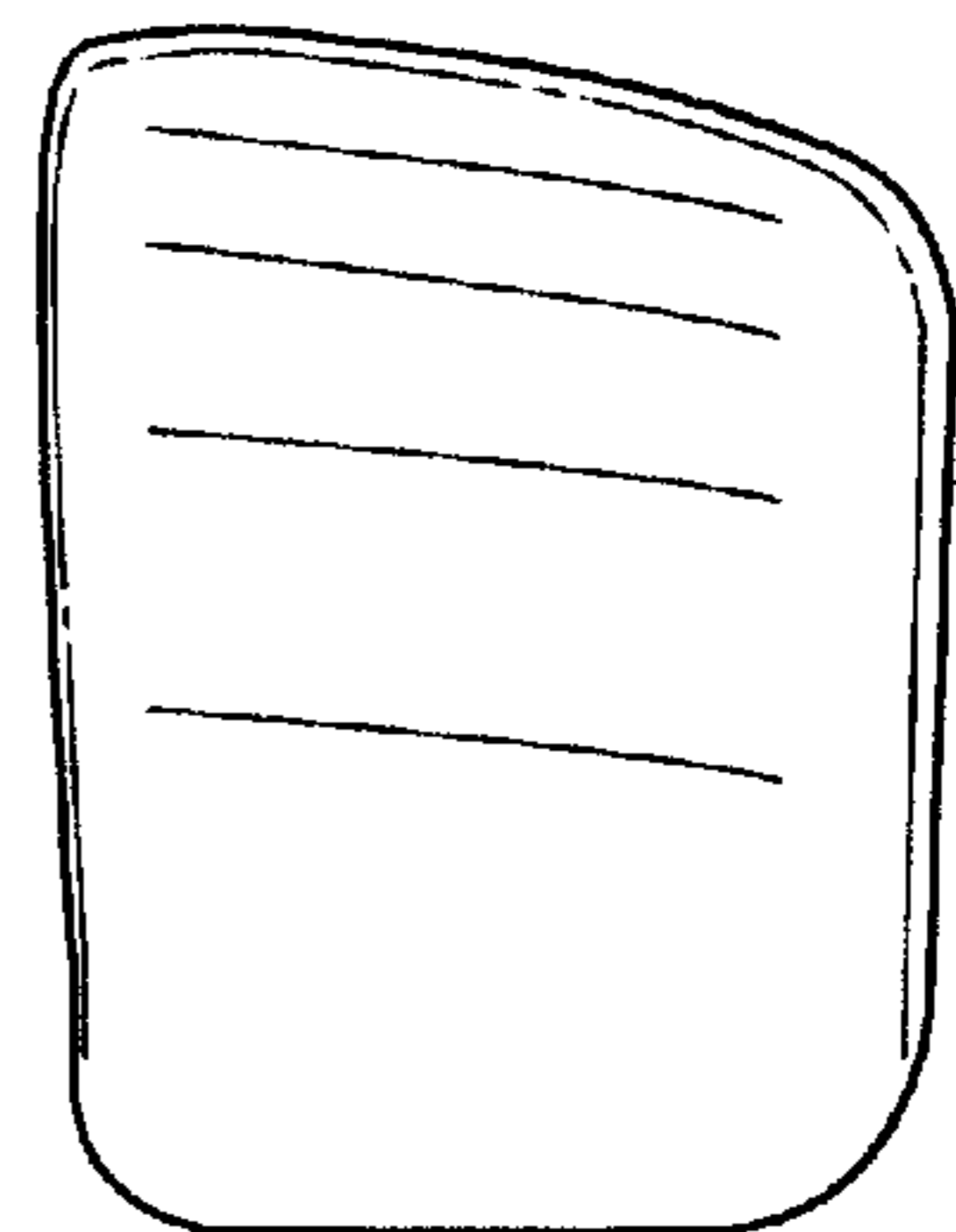

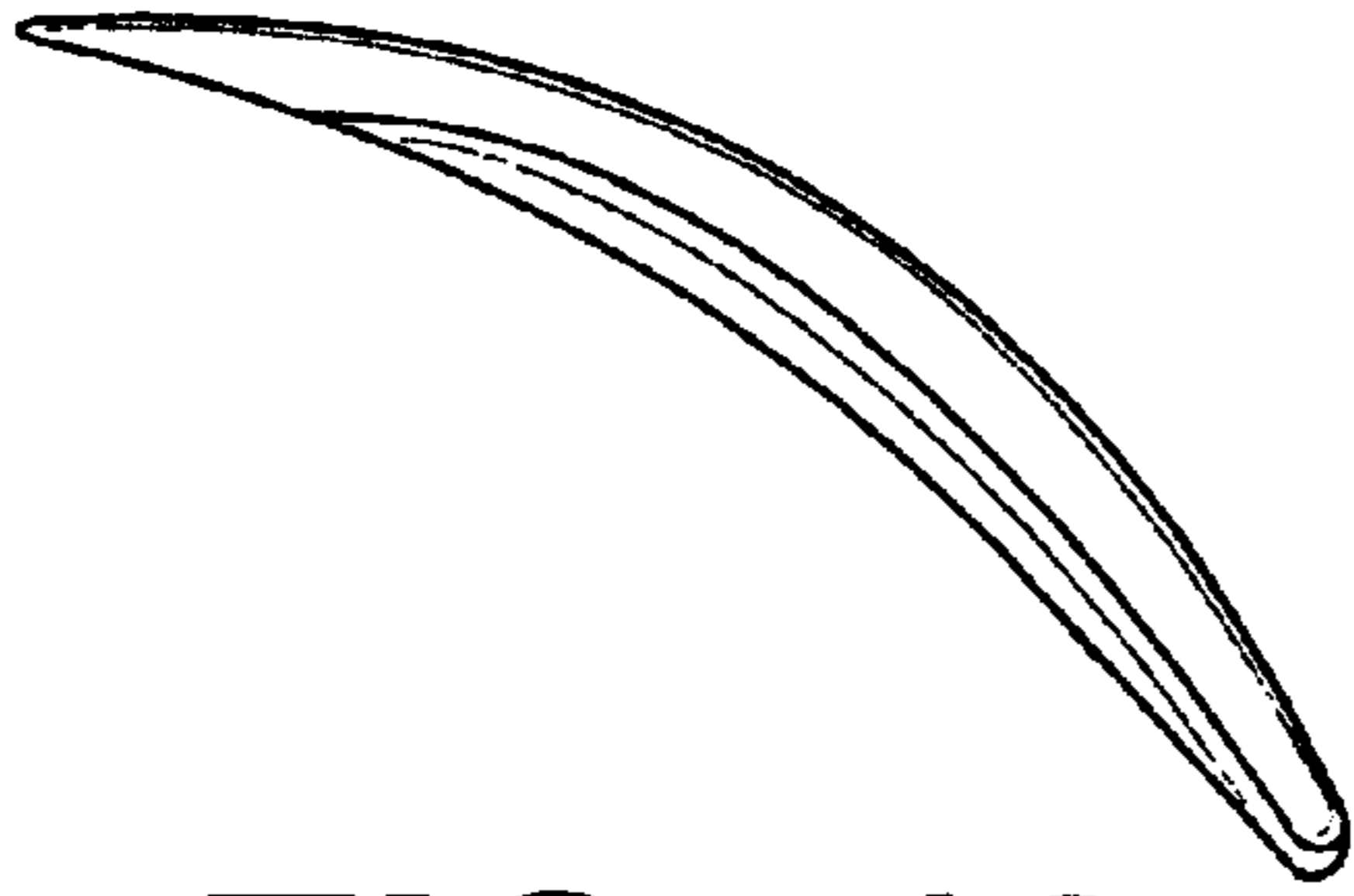

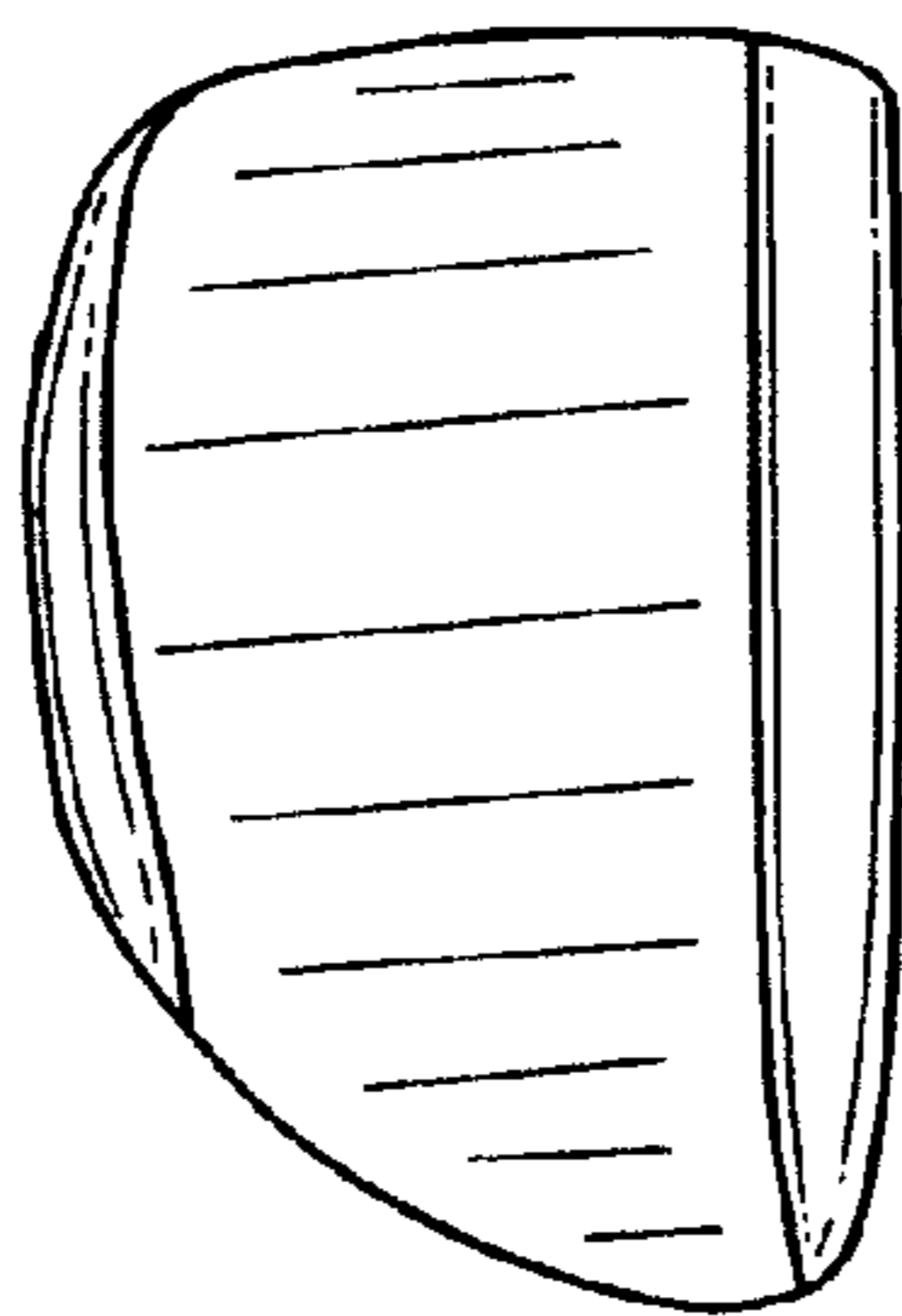

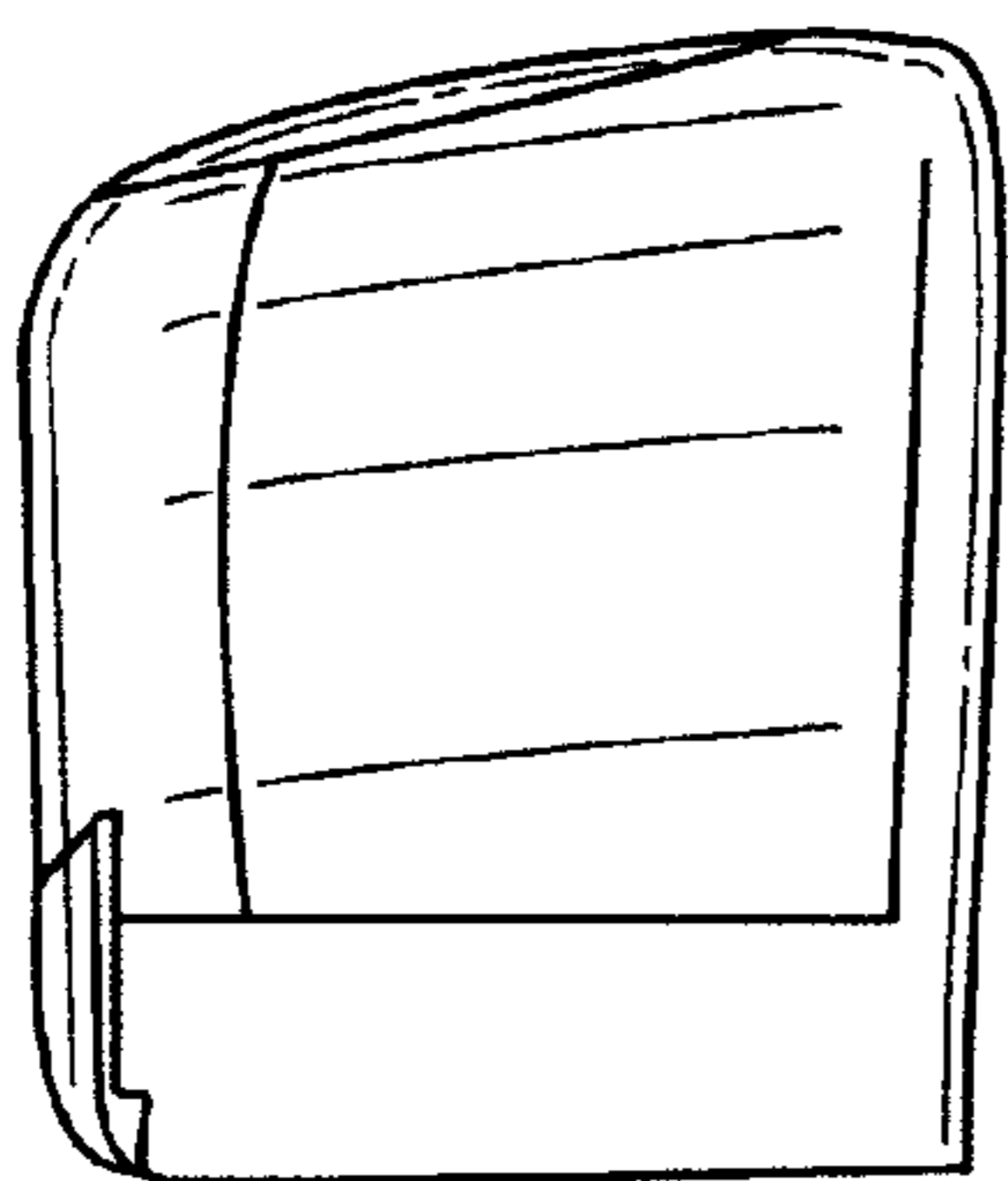

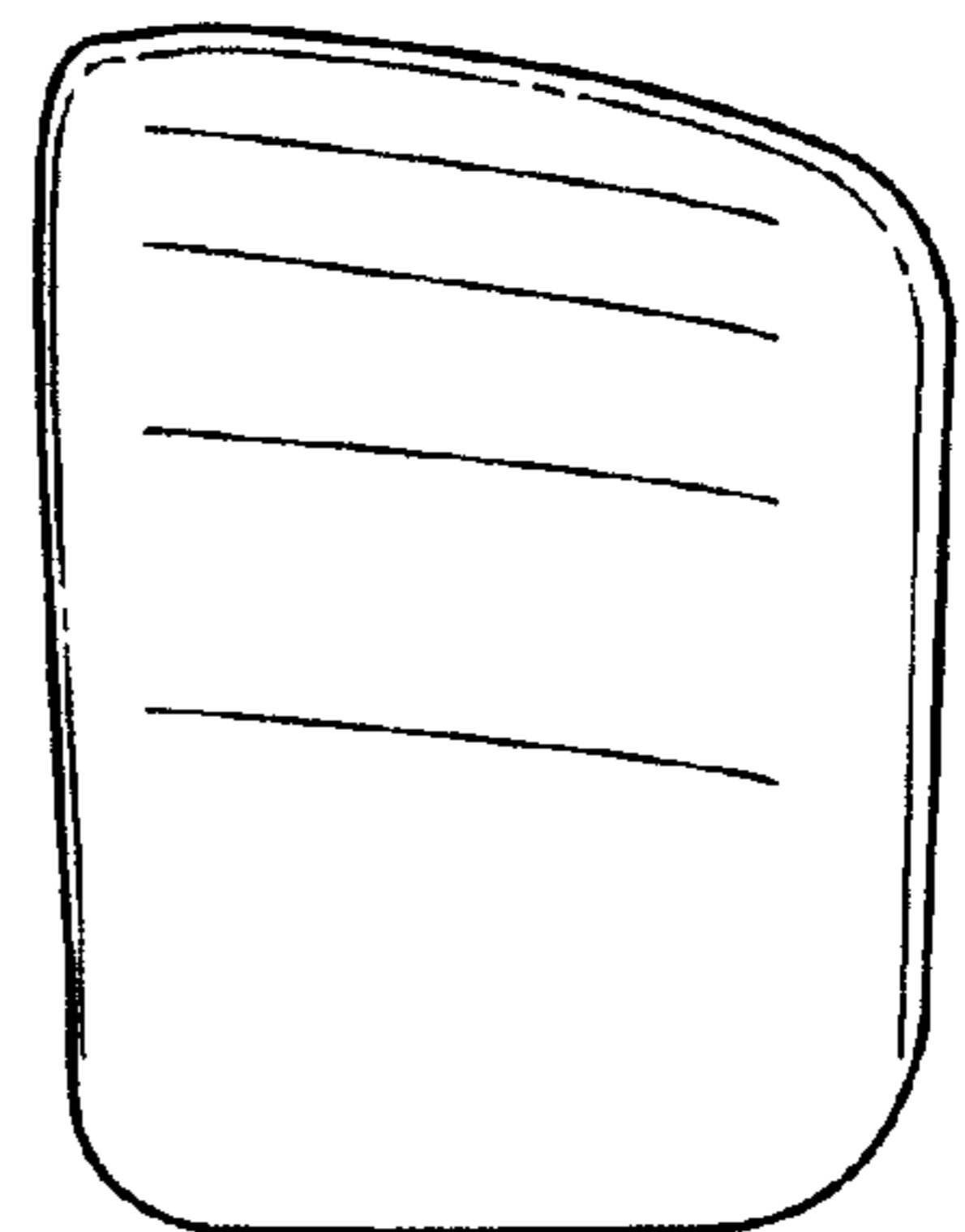
