DESCRIPTION

FIG. 1 is a perspective view of a blender according to the present invention;

FIG. 2 is a top view of the blender of FIG. 1;

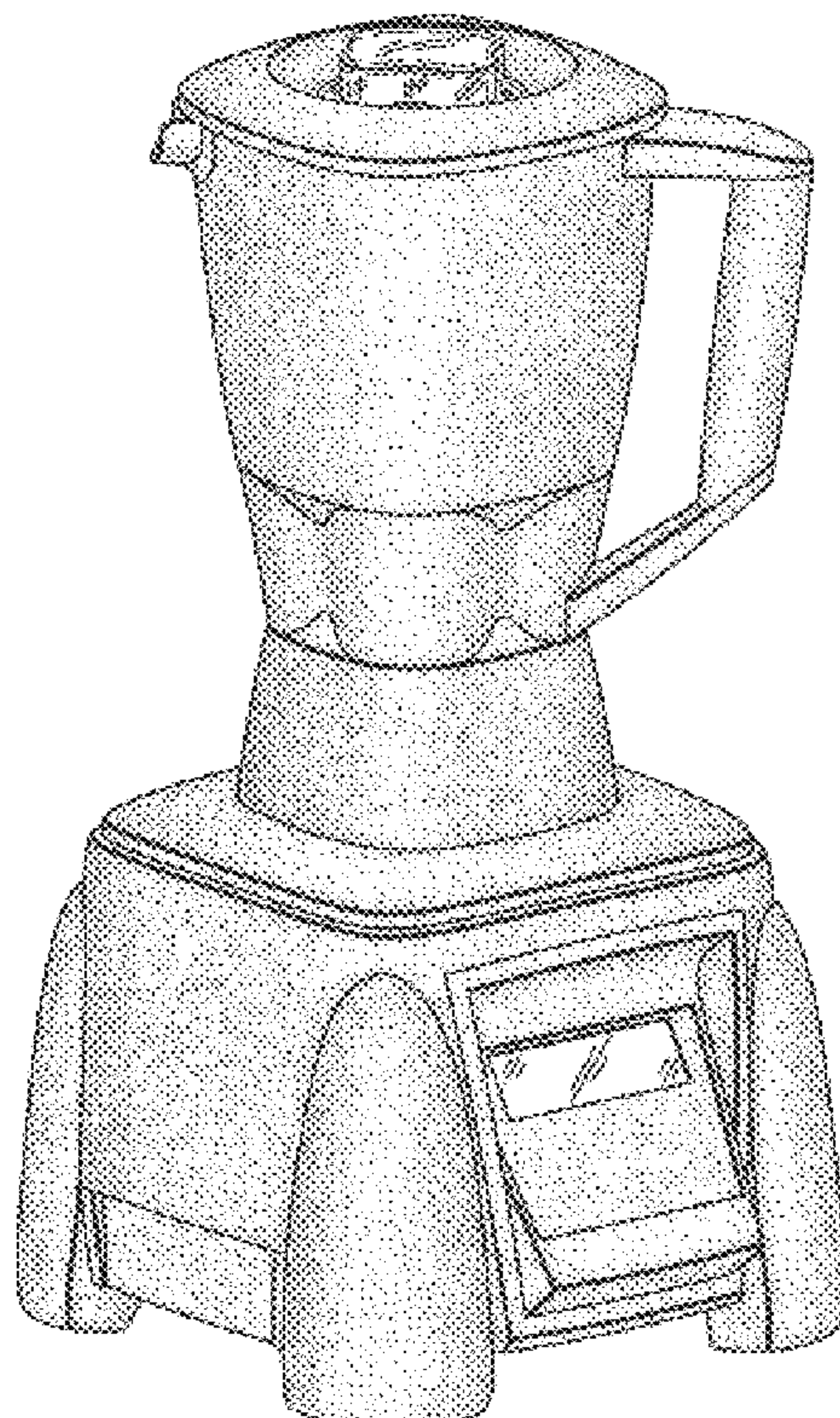
FIG. 3 is a first side view of the blender of FIG. 1;

FIG. 4 is a second side view, opposite the first side view, of the blender of FIG. 1;

FIG. 5 is a third side view, rotated ninety degrees from the second side view, of the blender of FIG. 1; and,

FIG. 6 is a fourth side view, opposite the third side view, of the blender of FIG. 1.

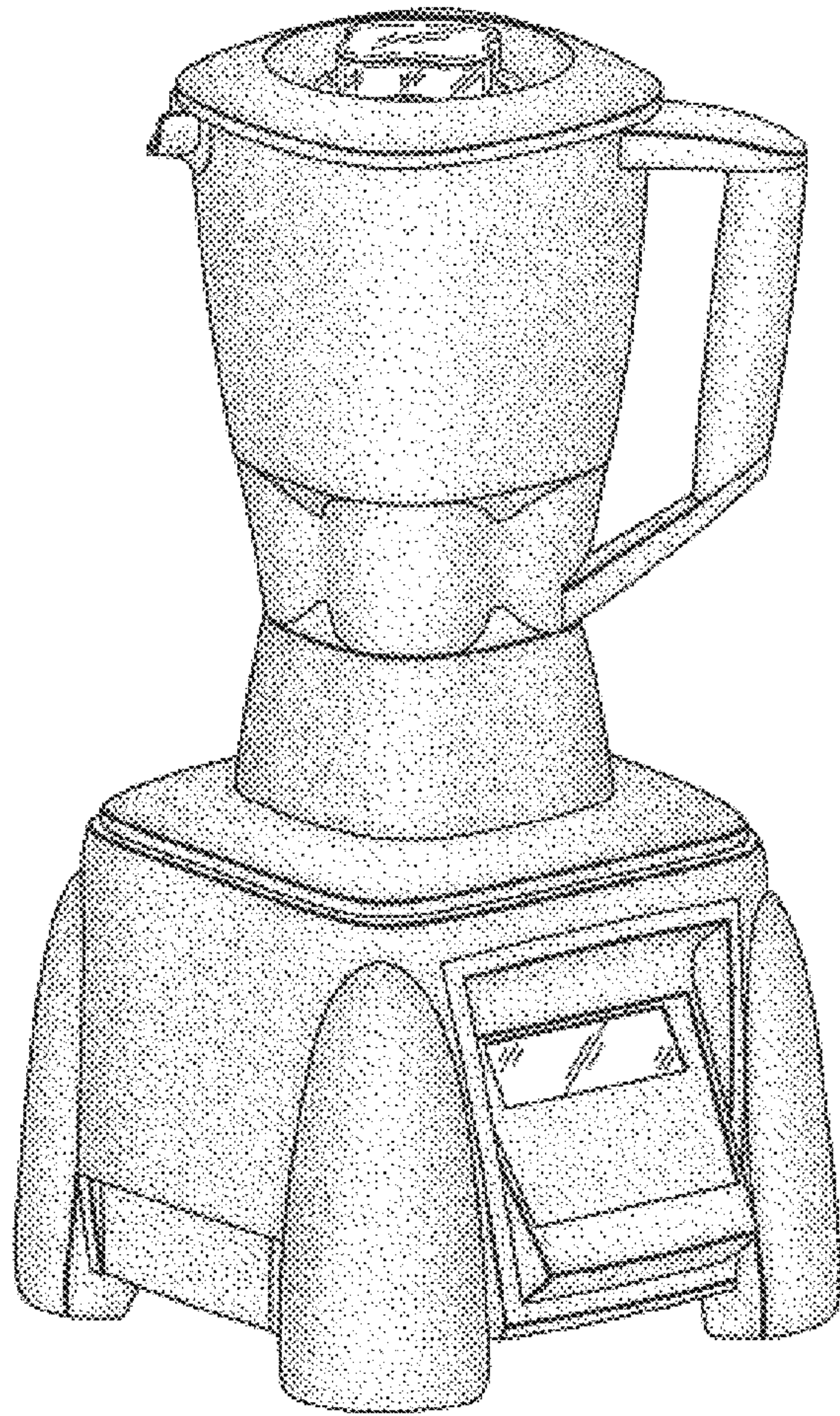

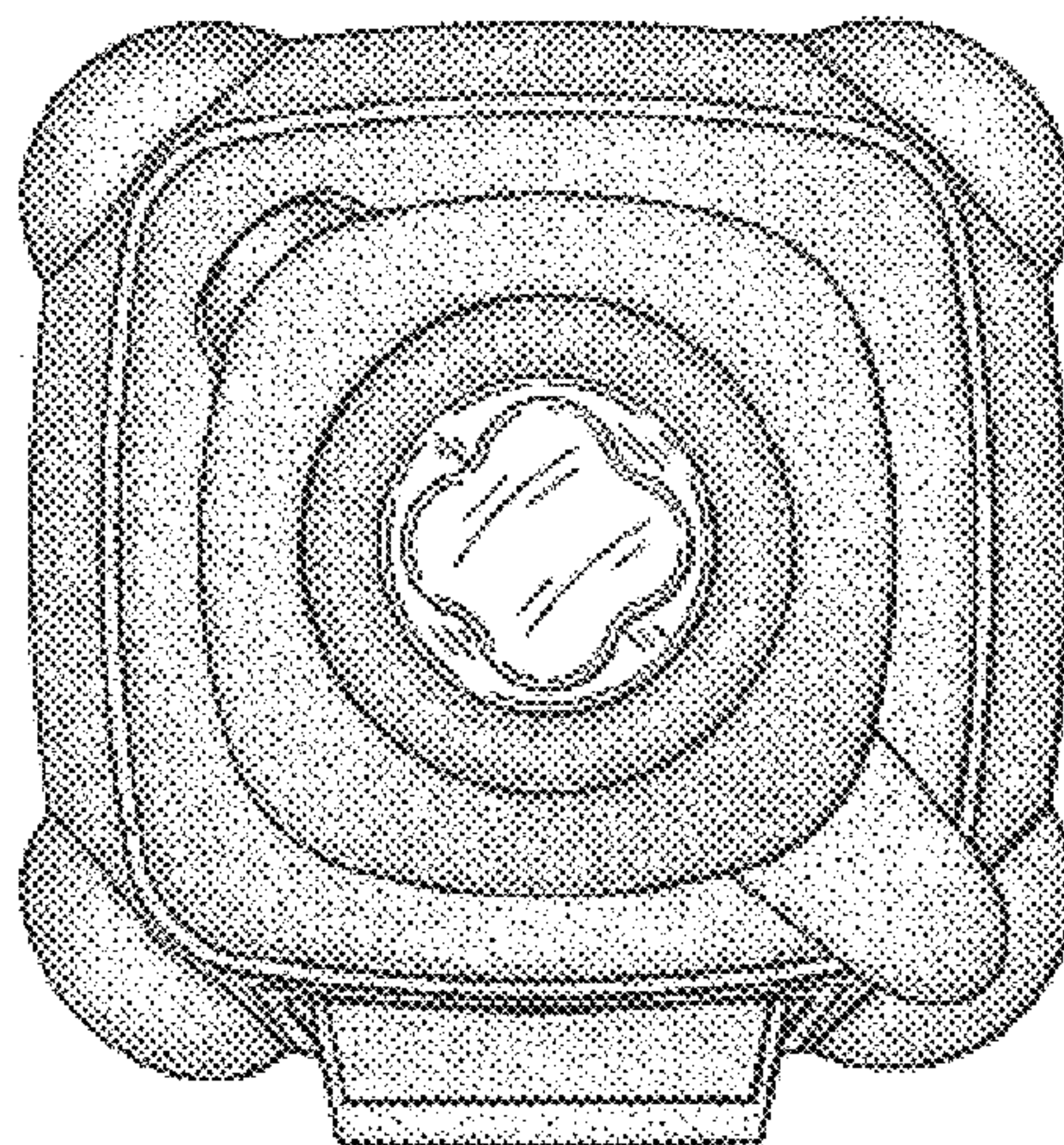

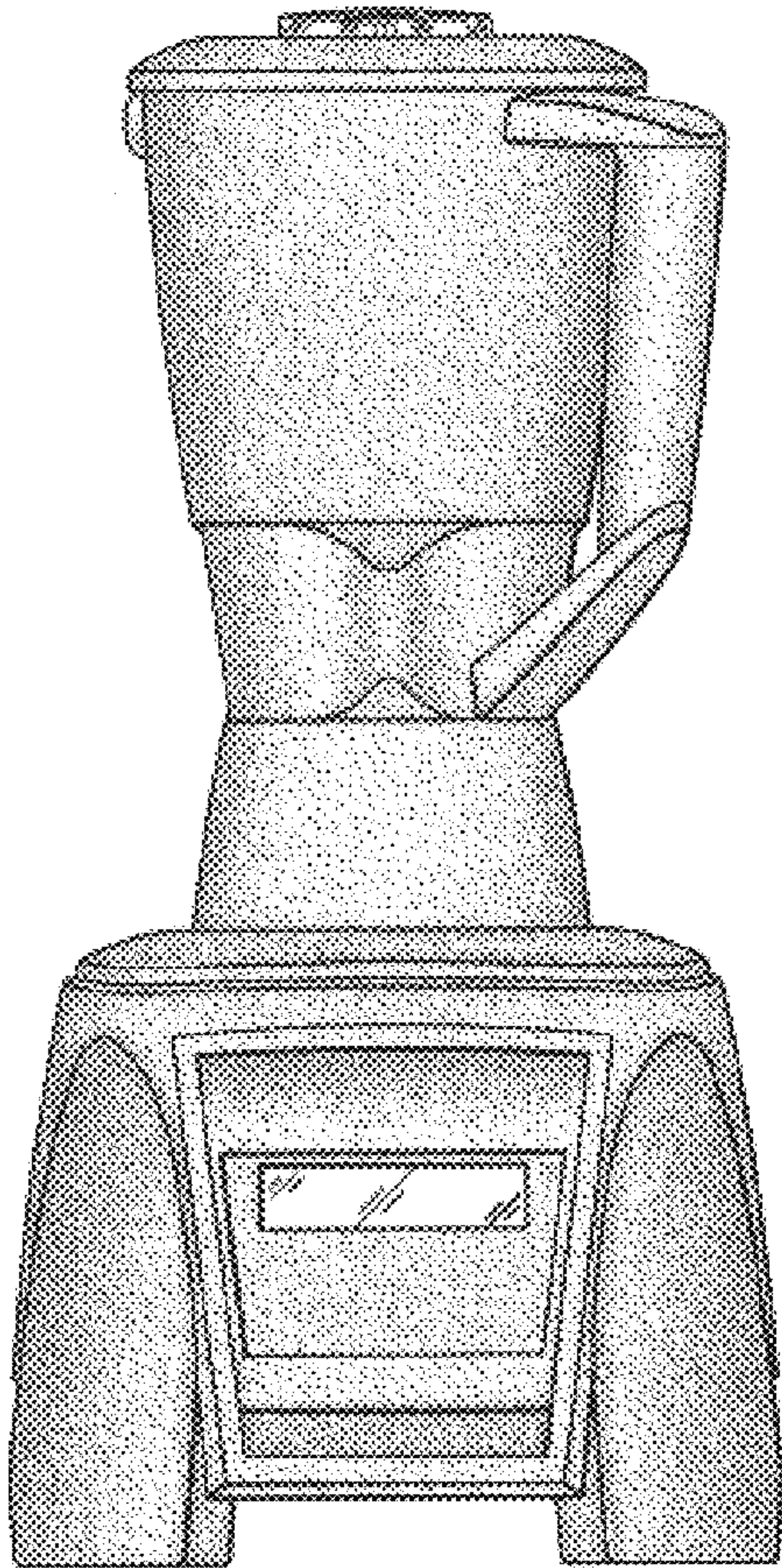

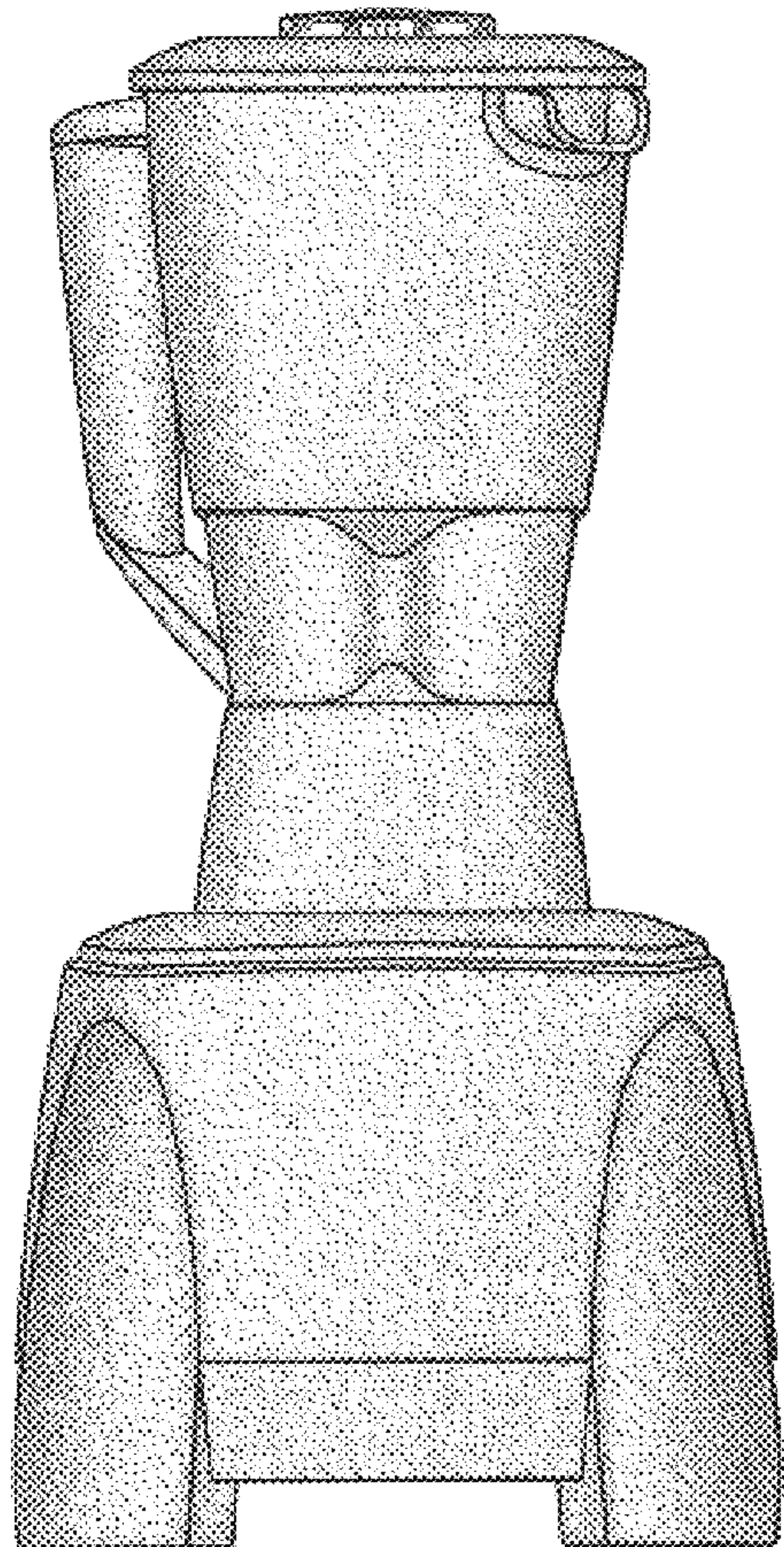

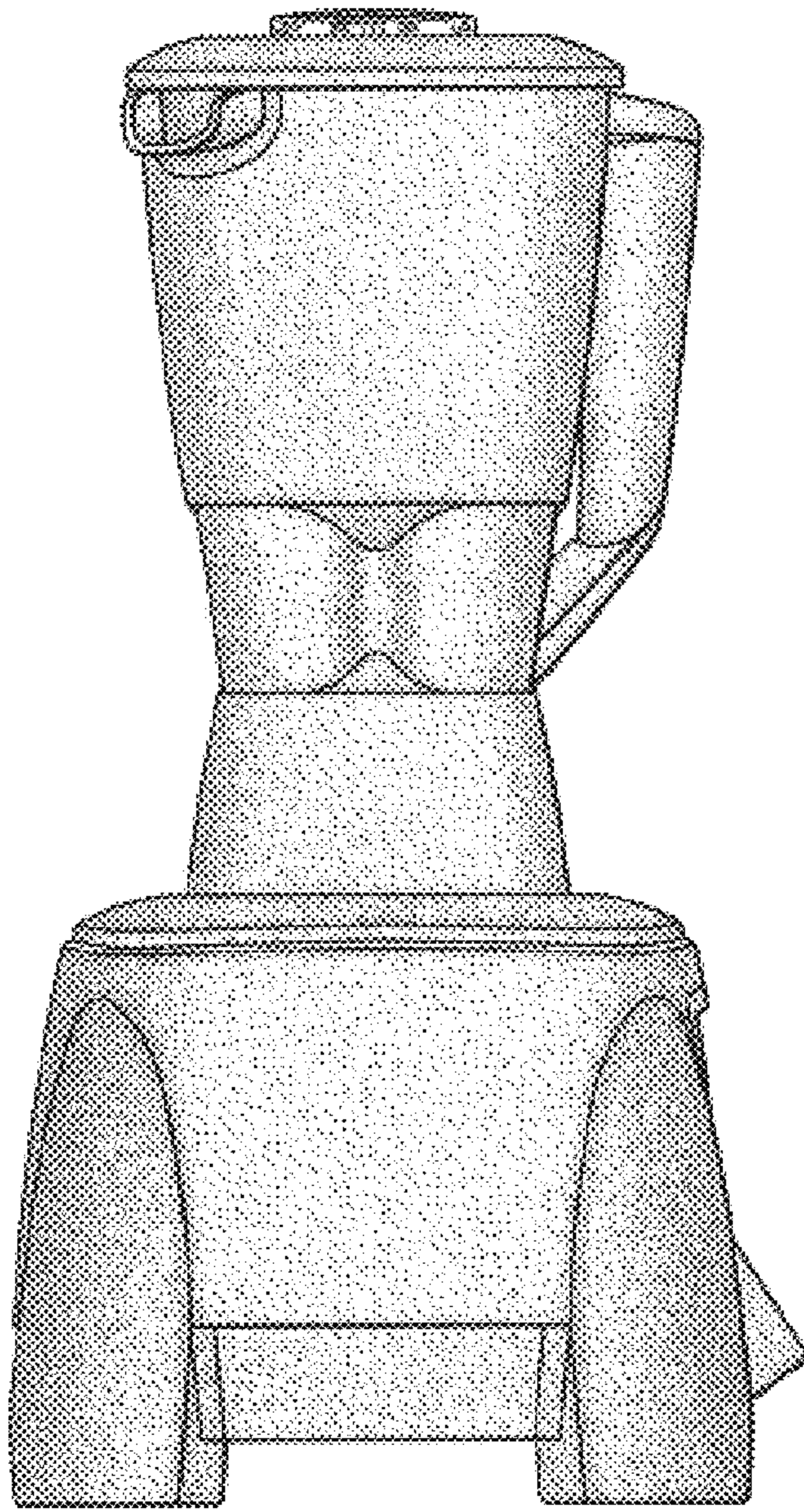

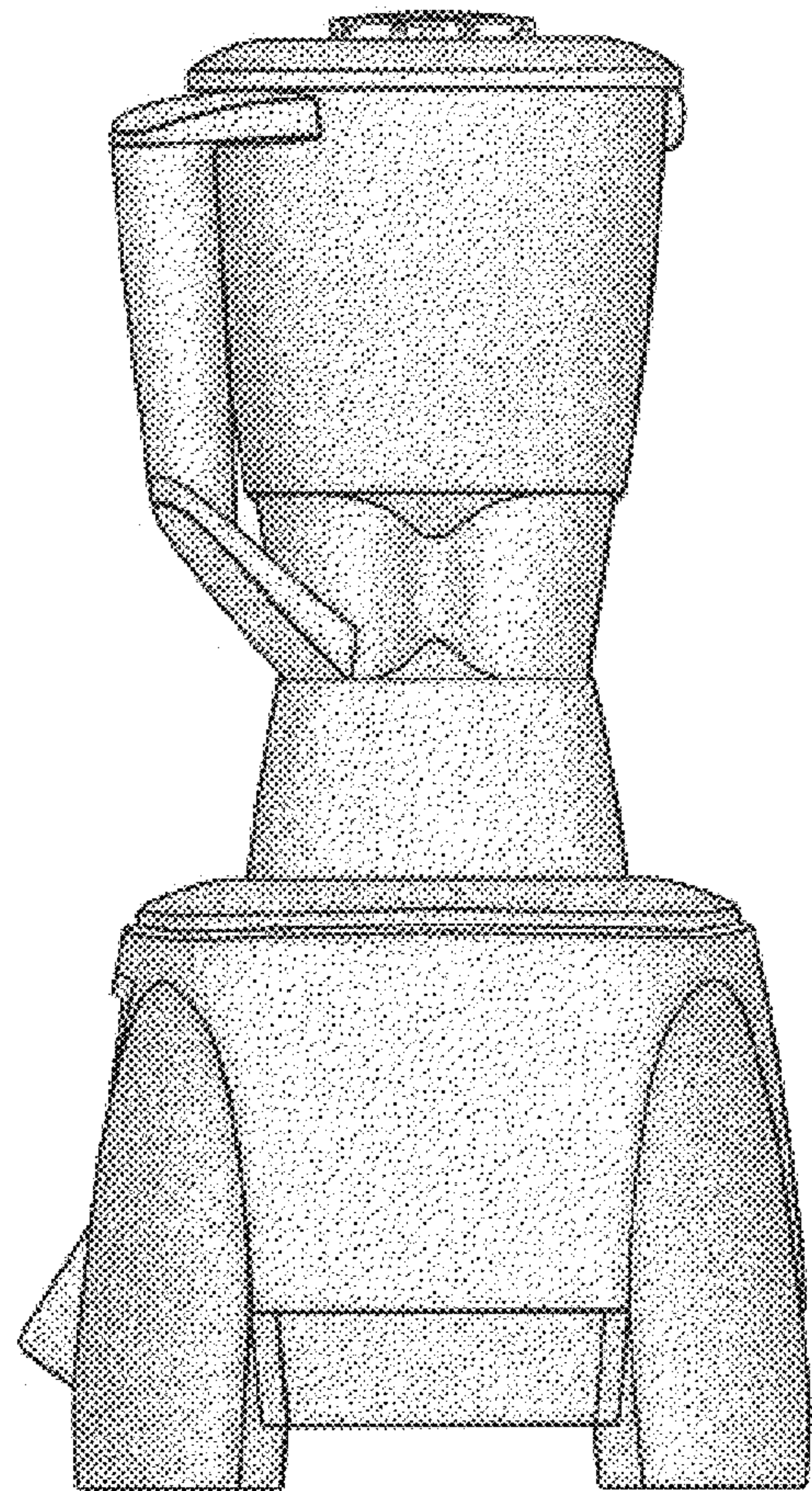
