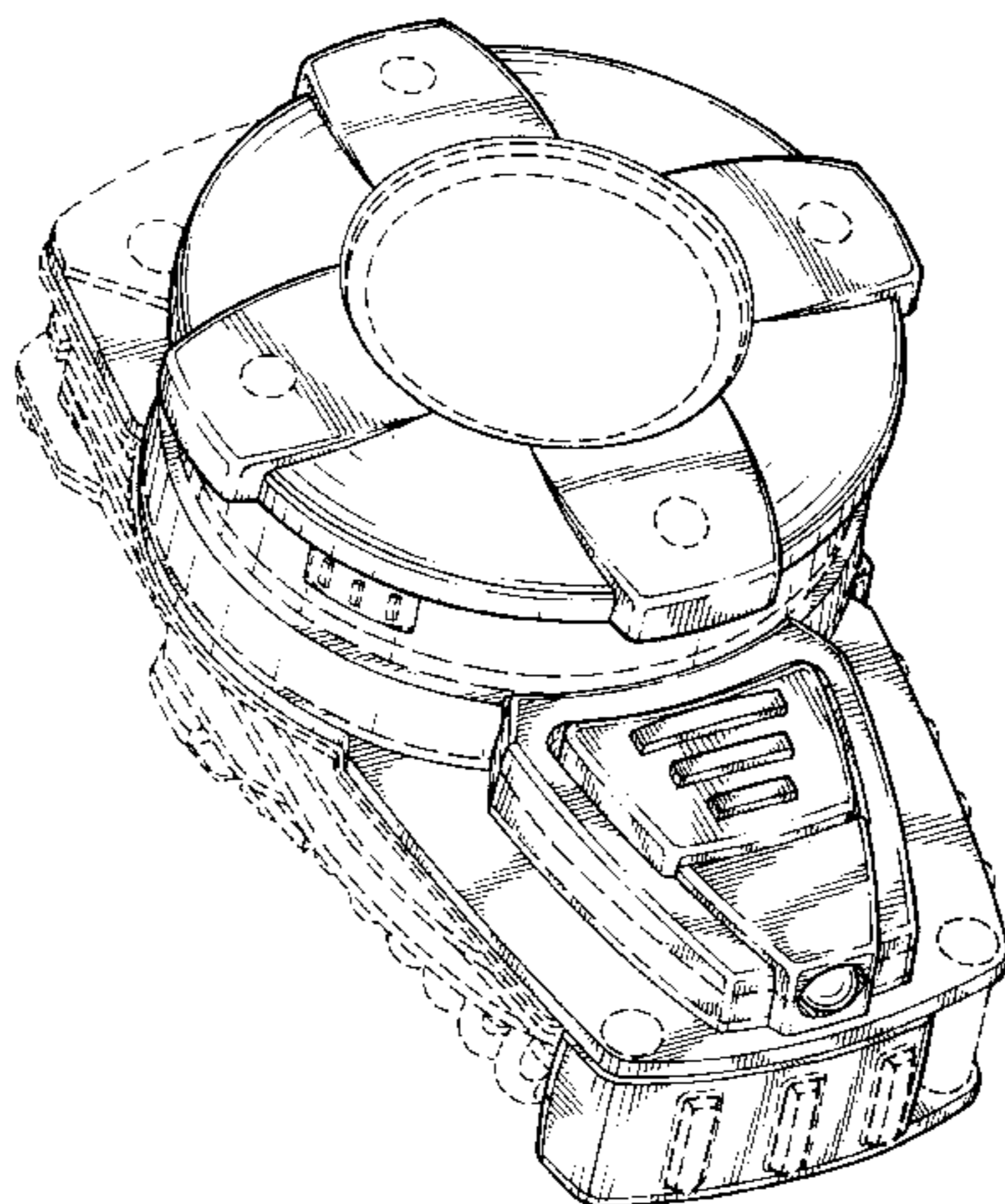
The ornamental design for multi-function equipment, as shown and described.

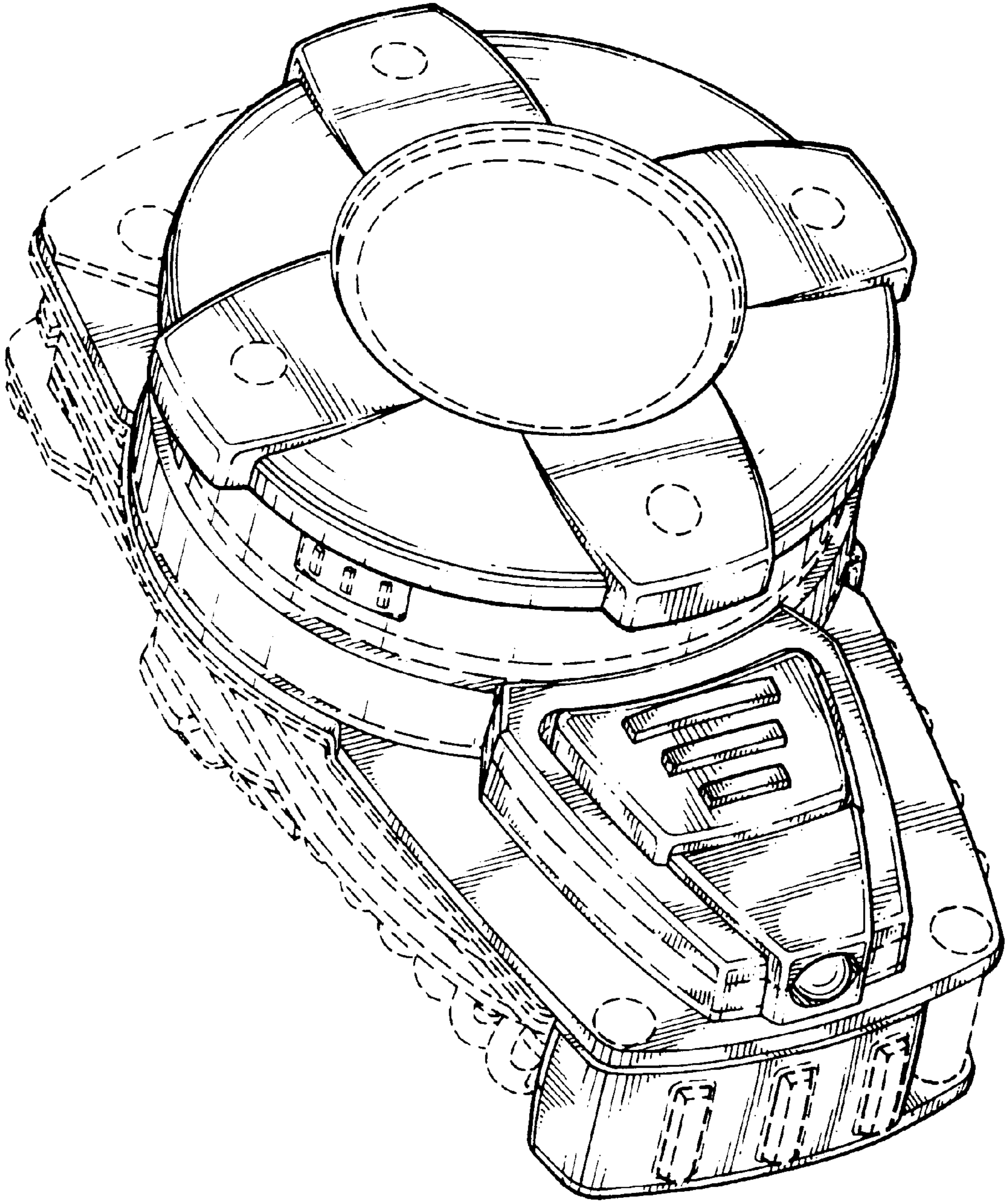

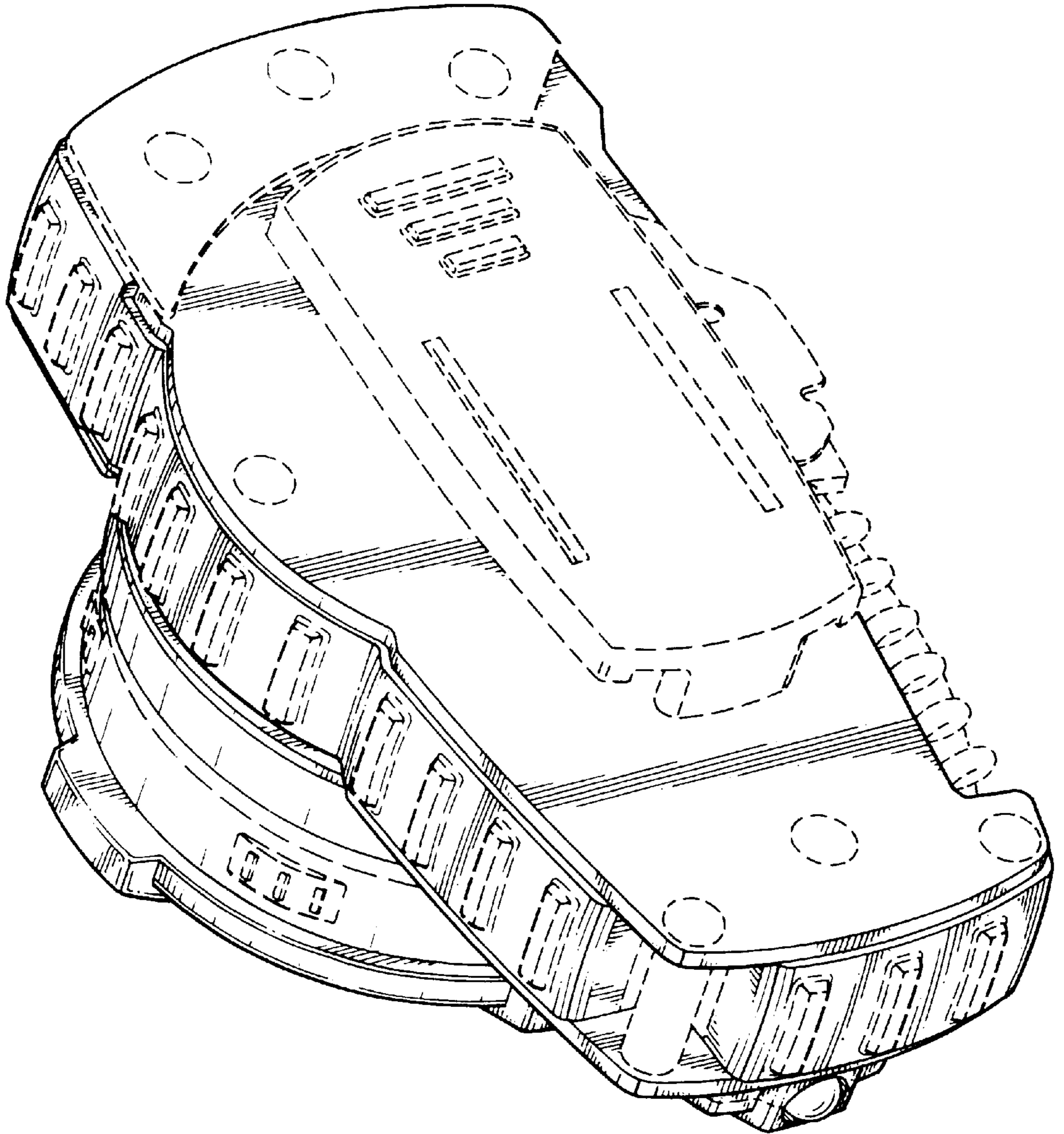

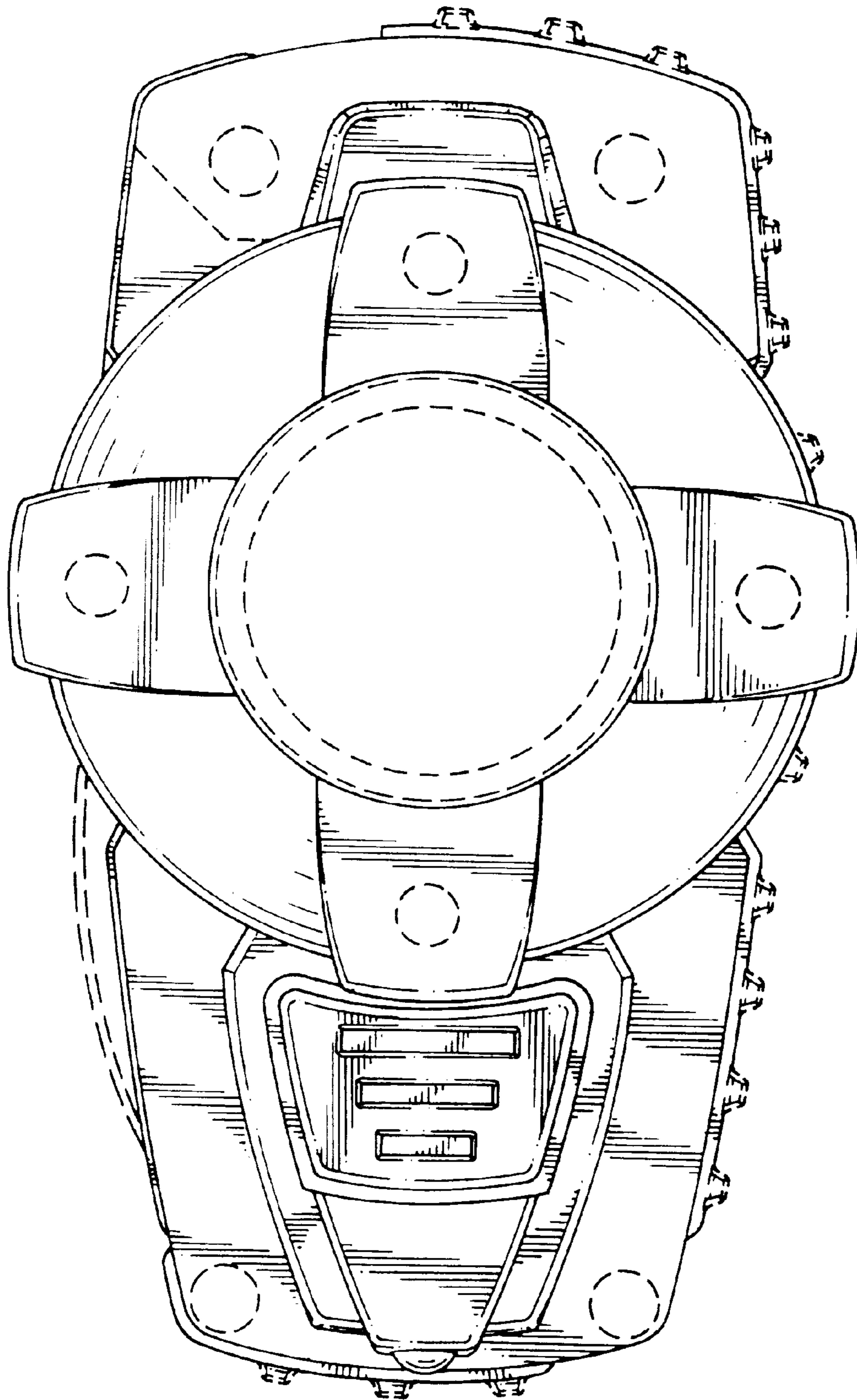

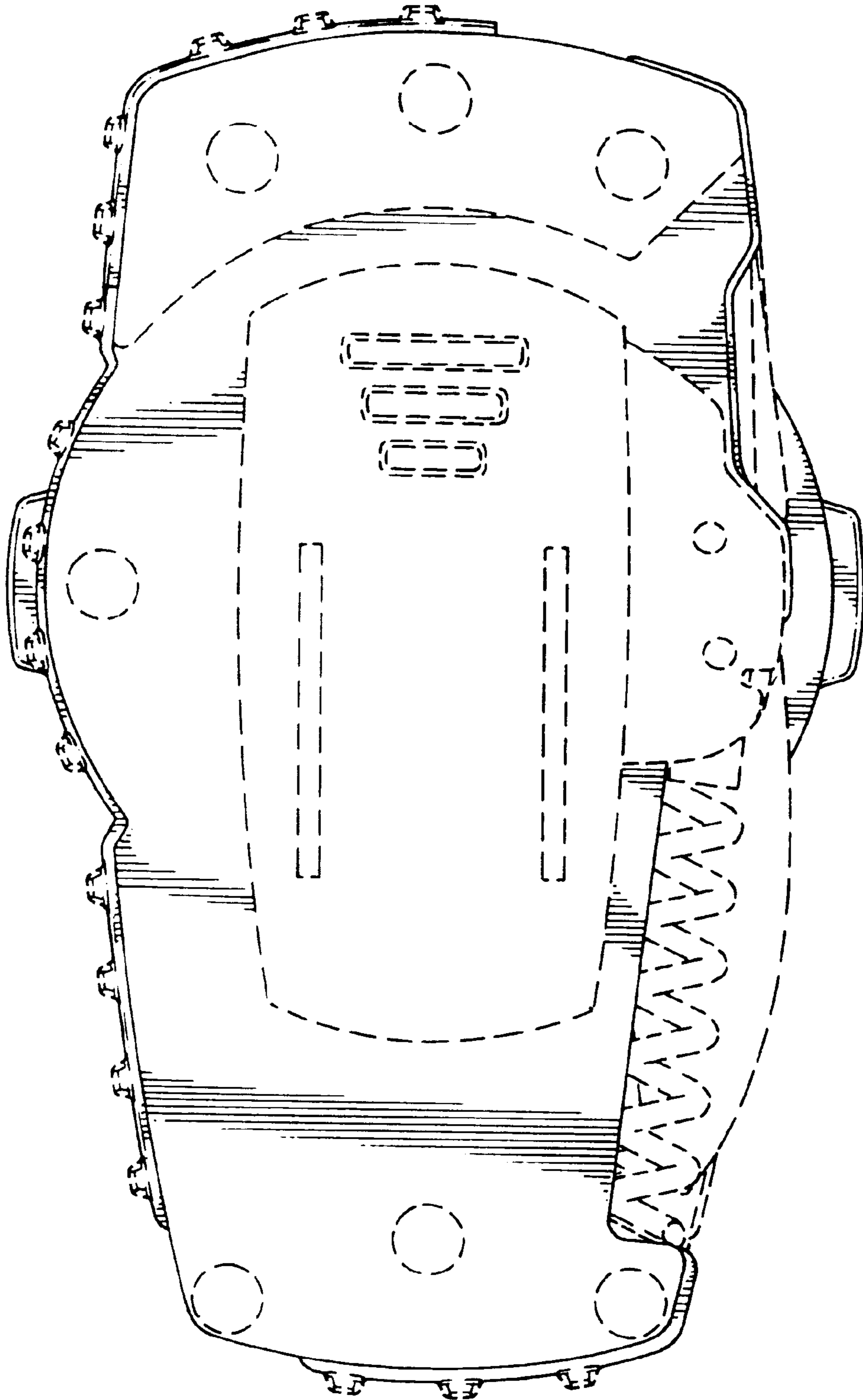

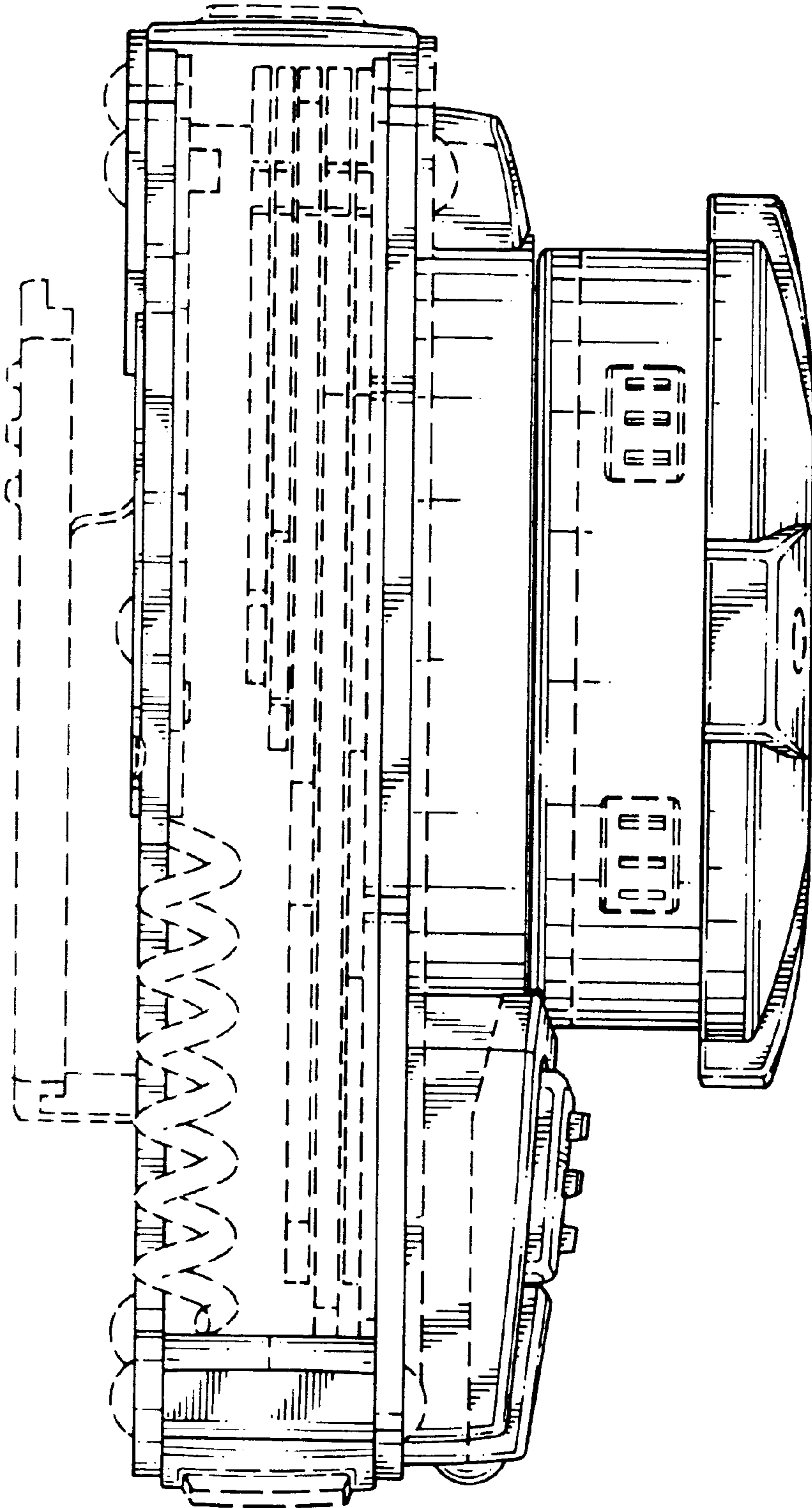

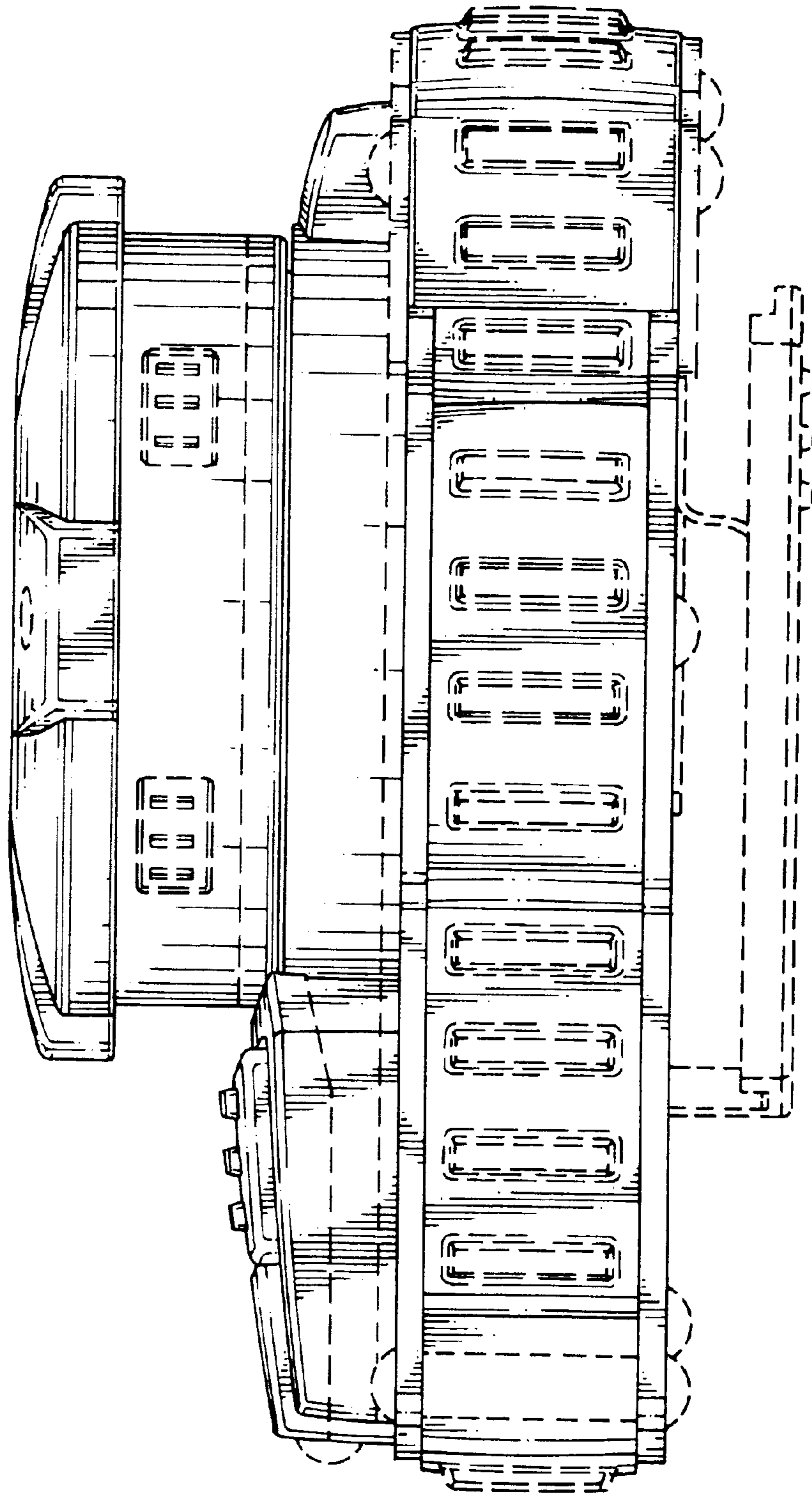

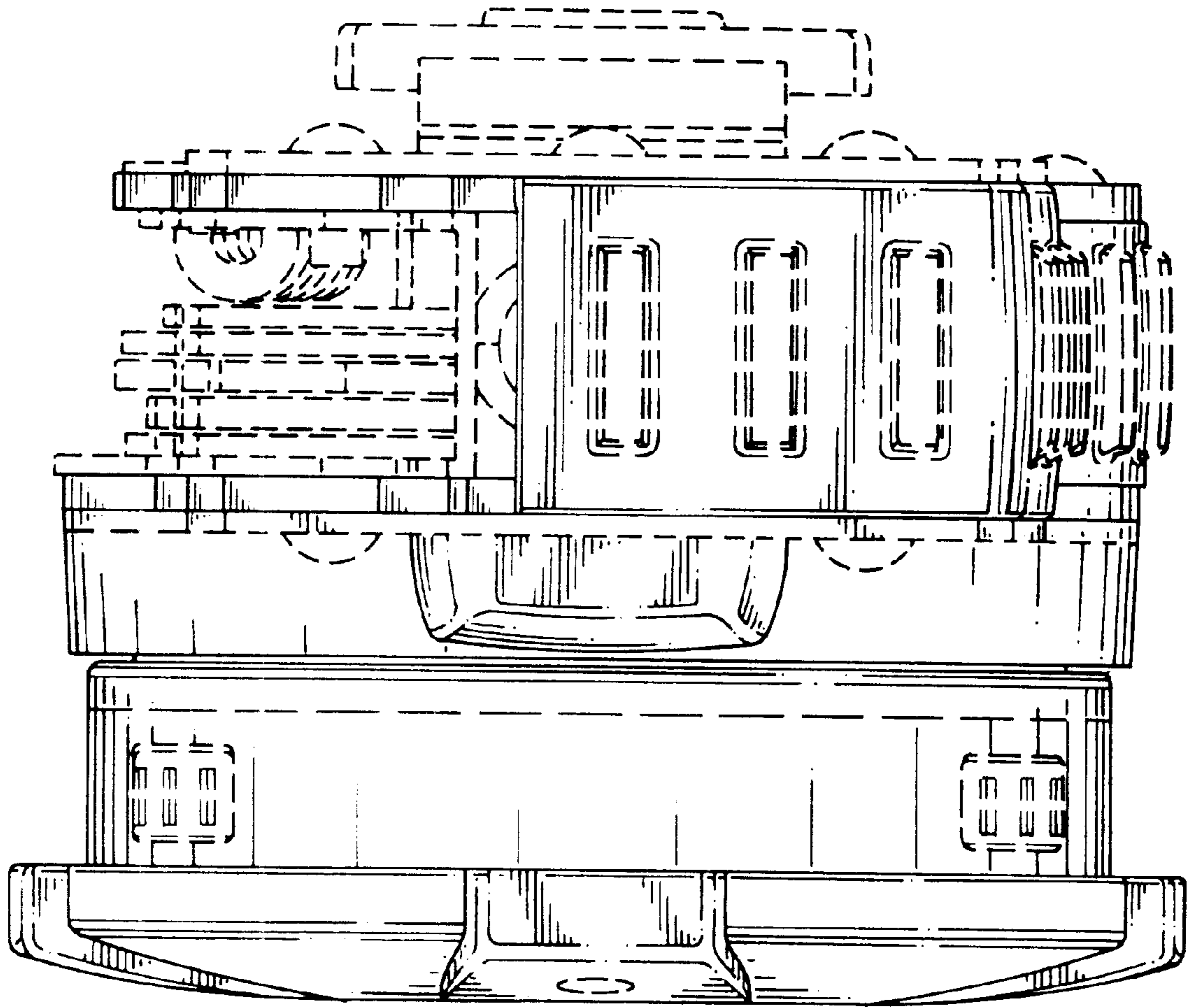

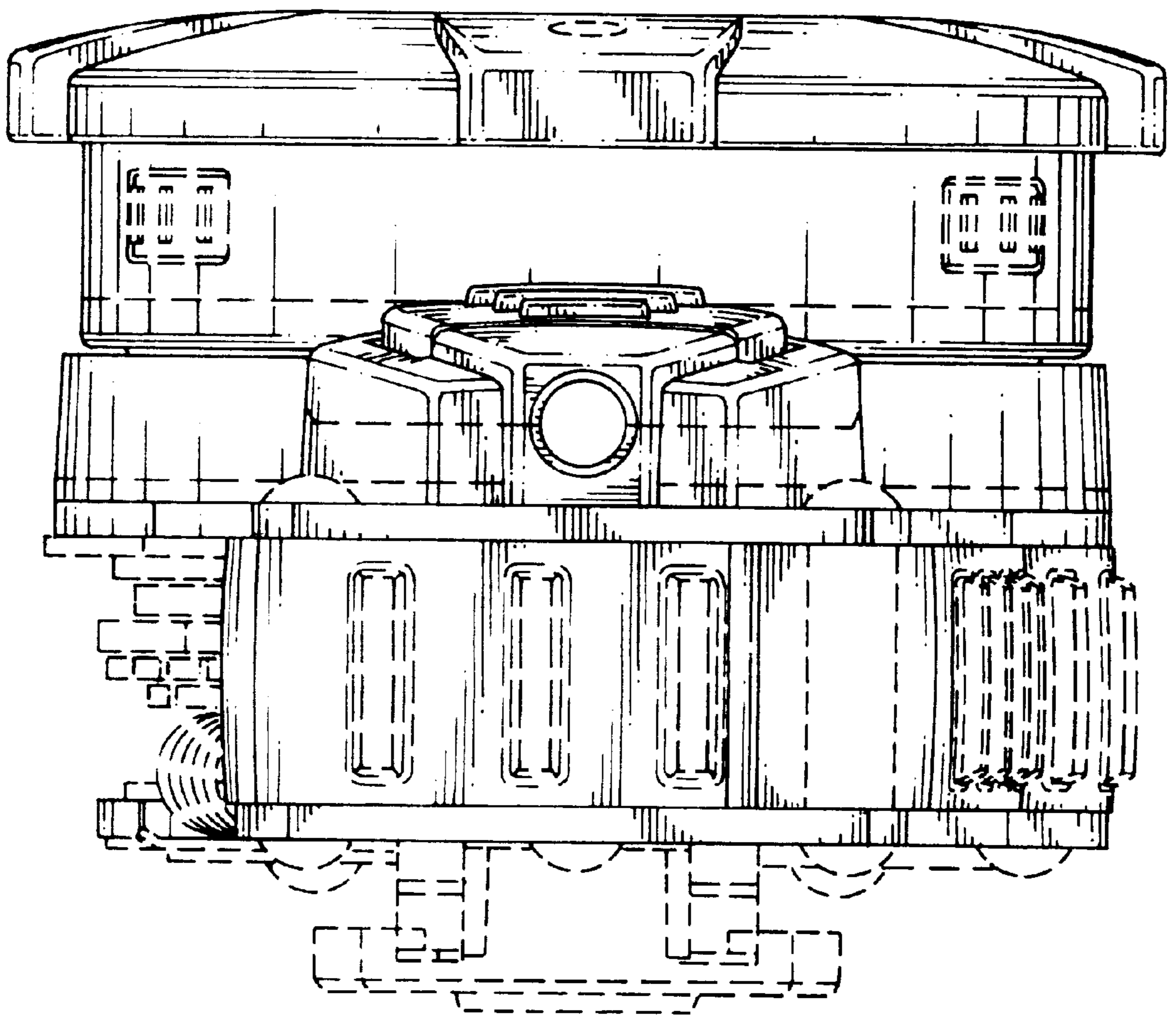
