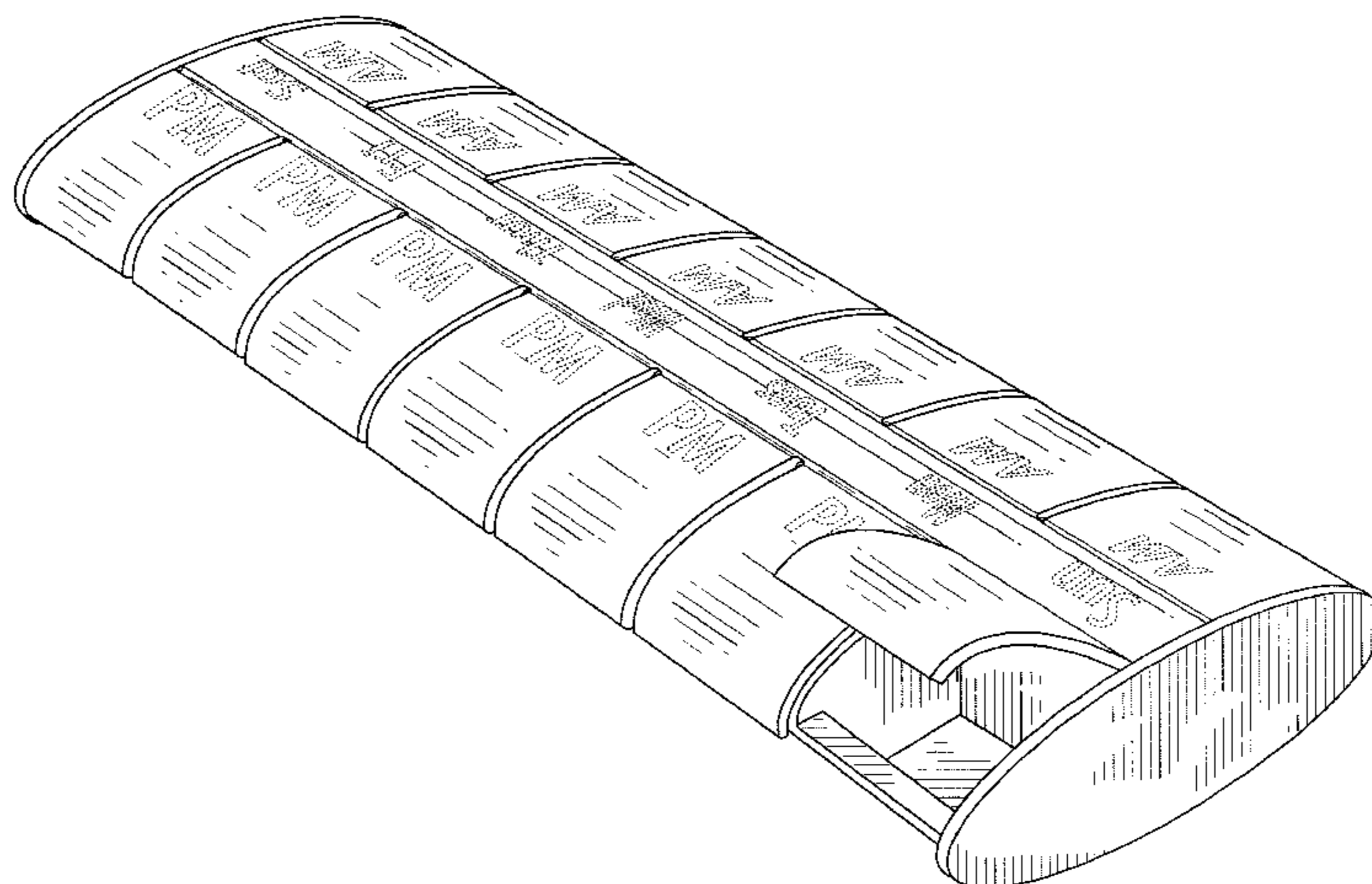
The ornamental design for a pill container, as shown and described.

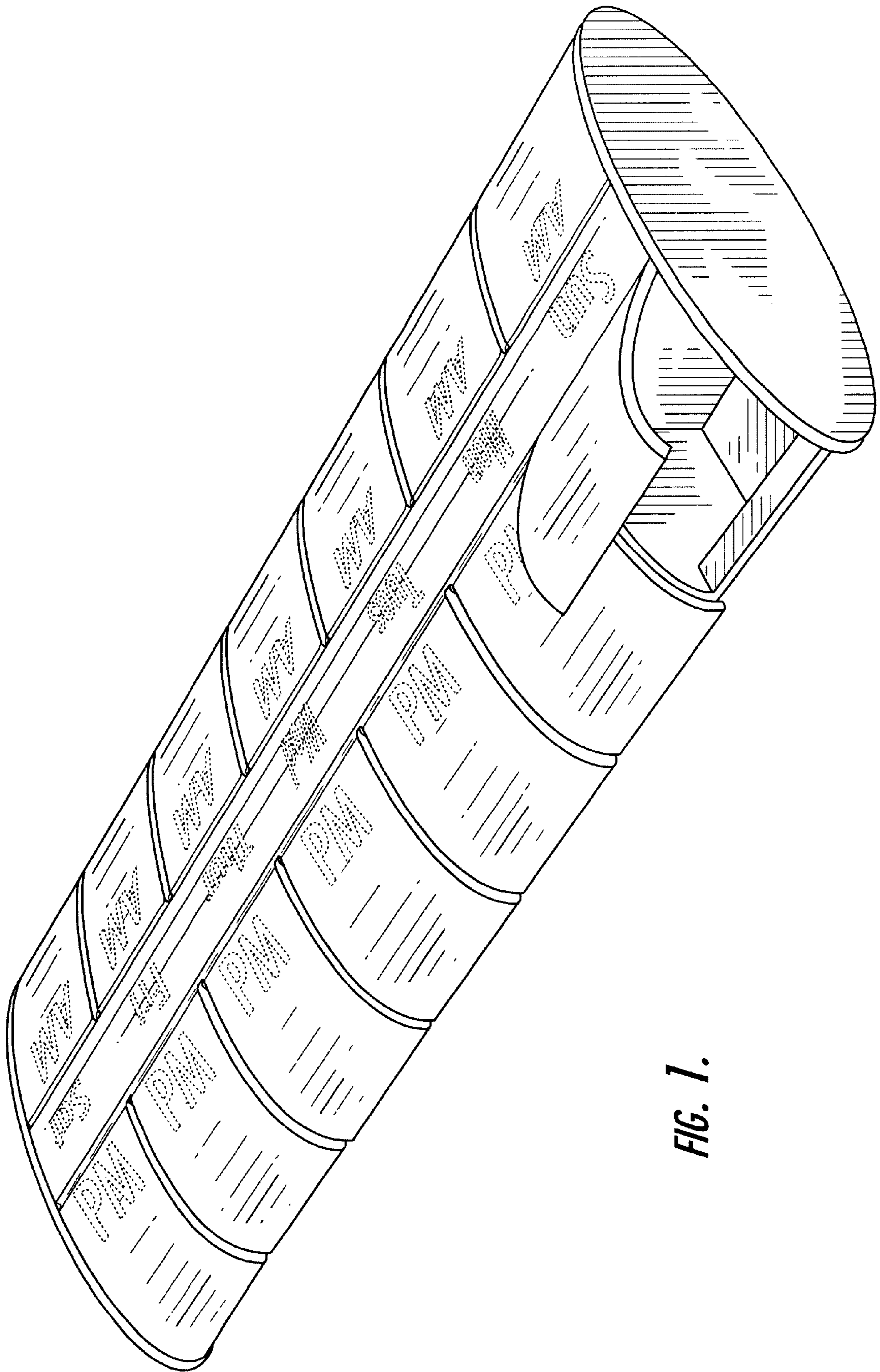
**DESCRIPTION**

FIG. 1 is a perspective view of a pill container, showing my new design;

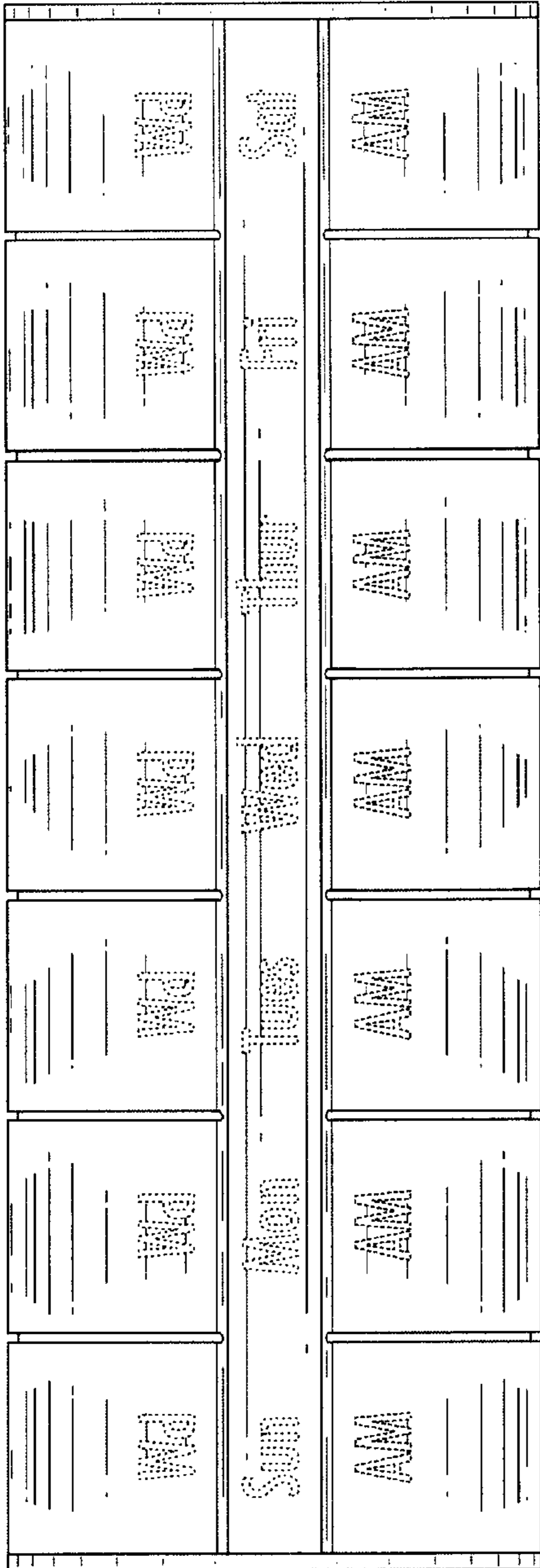

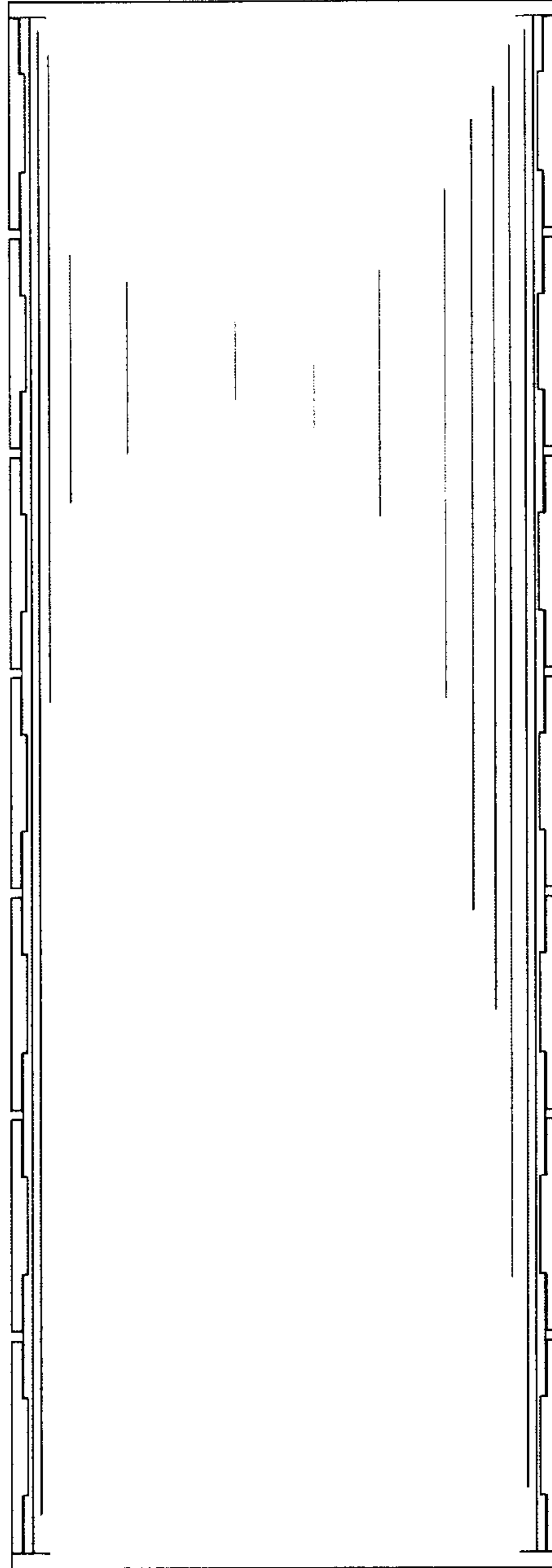
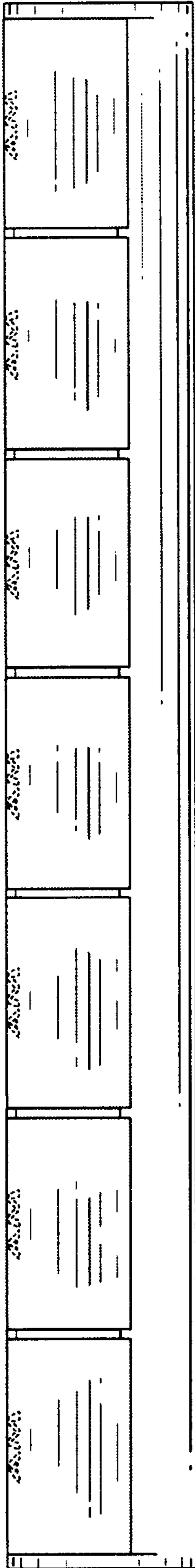
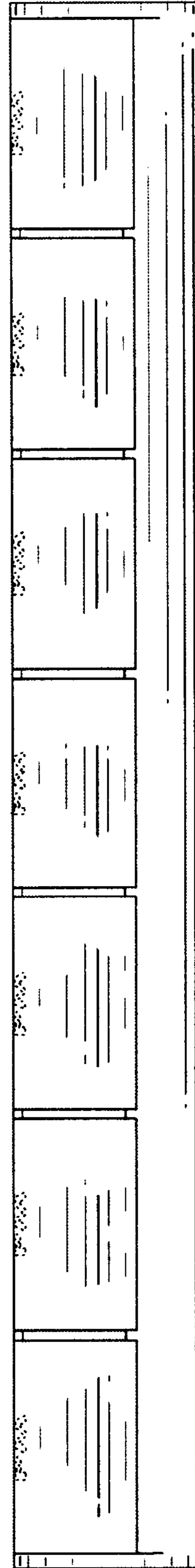


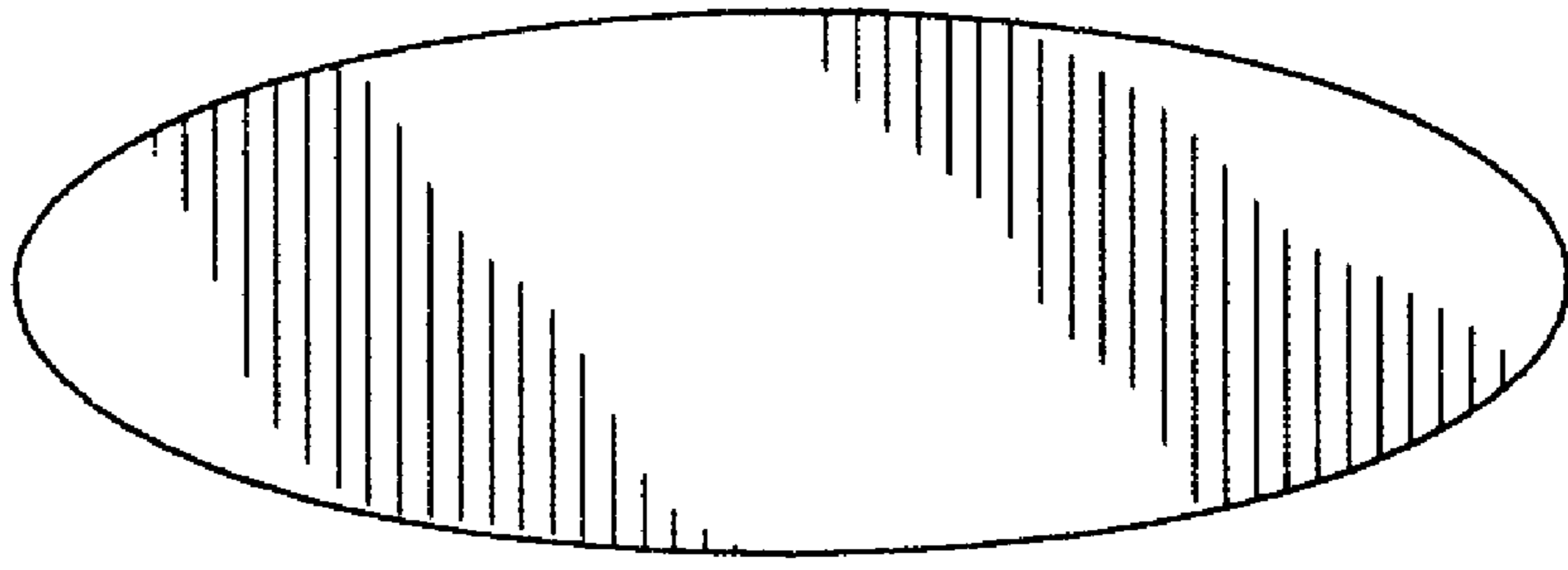

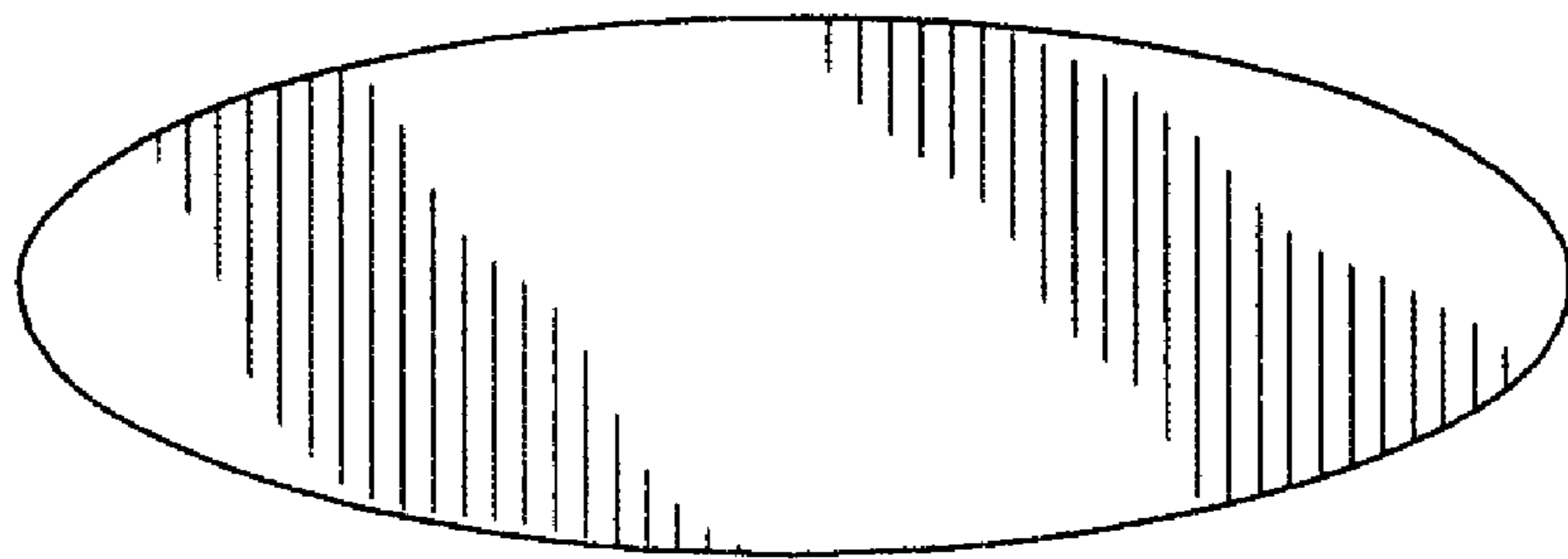
