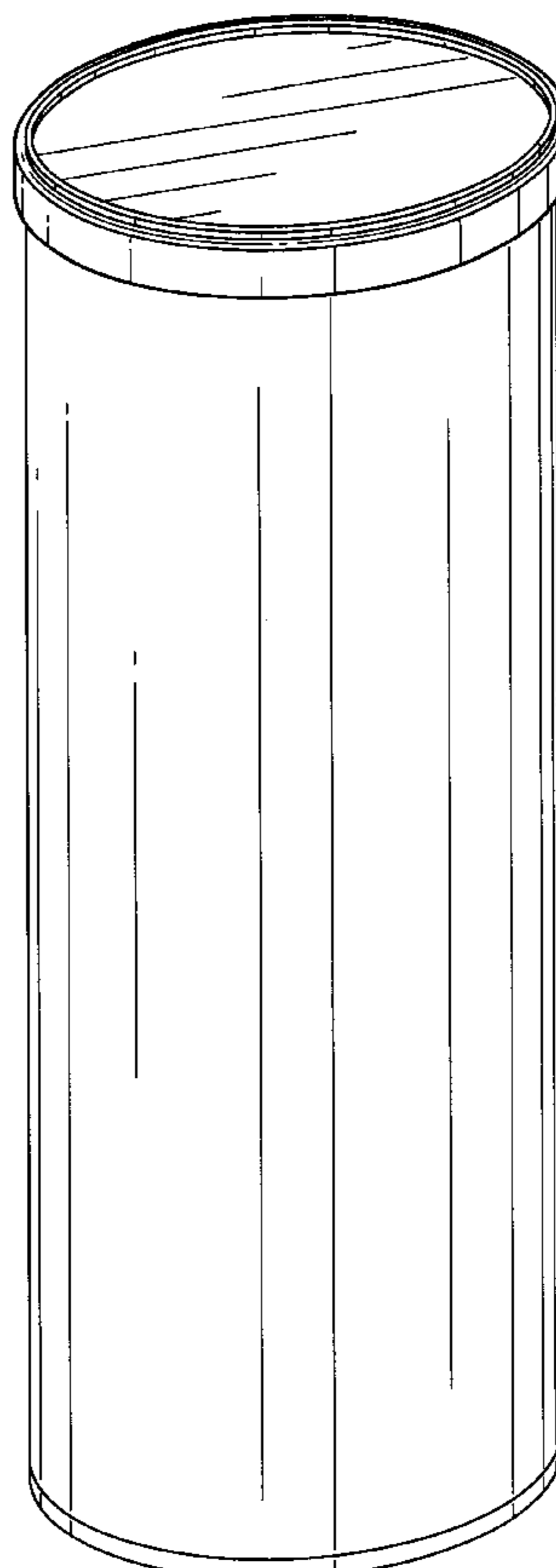

DESCRIPTION

FIG. 1 is a top perspective view of the container body with a reclosable cap over the open top;
FIG. 2 is a front view of the container body in FIG. 1 (rear view not illustrated is similar);
FIG. 3 is a left view of FIG. 1 (rear view not illustrated is similar);
FIG. 4 is a top view of the container body shown in FIG. 1 showing the reclosable cap over the open top; and,
FIG. 5 is a bottom view of the container body shown in FIG. 1 showing the closed container bottom.

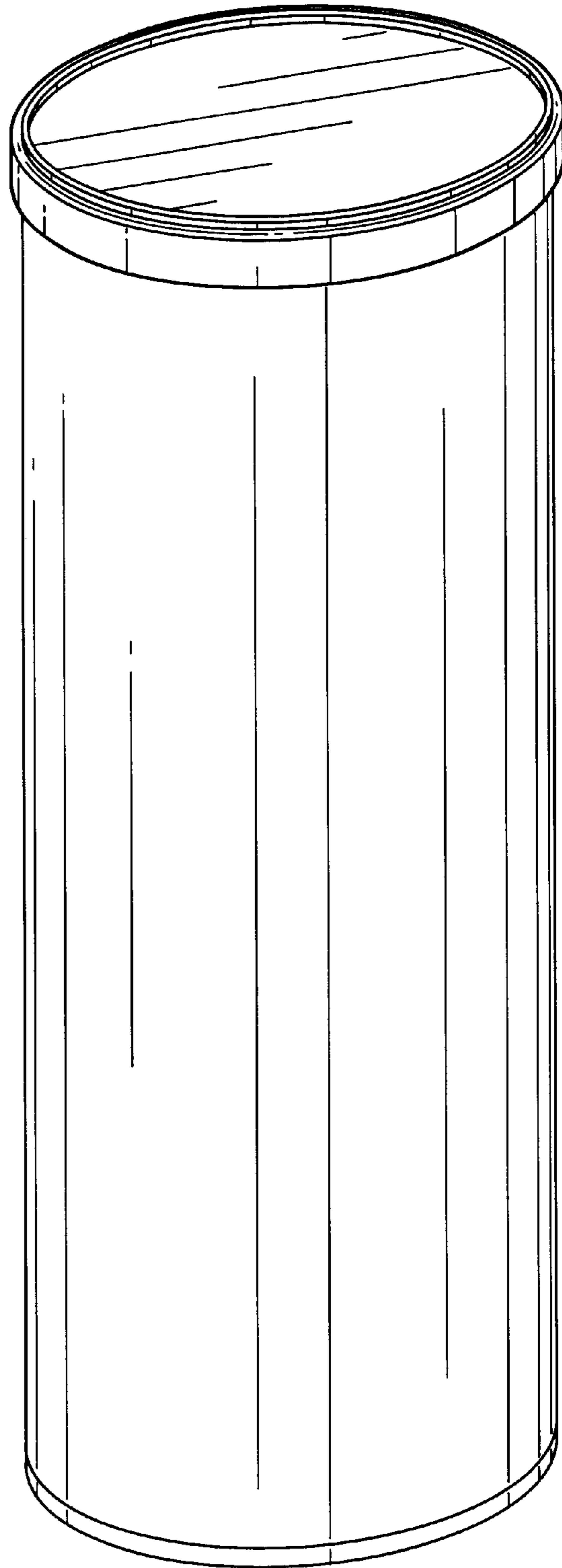

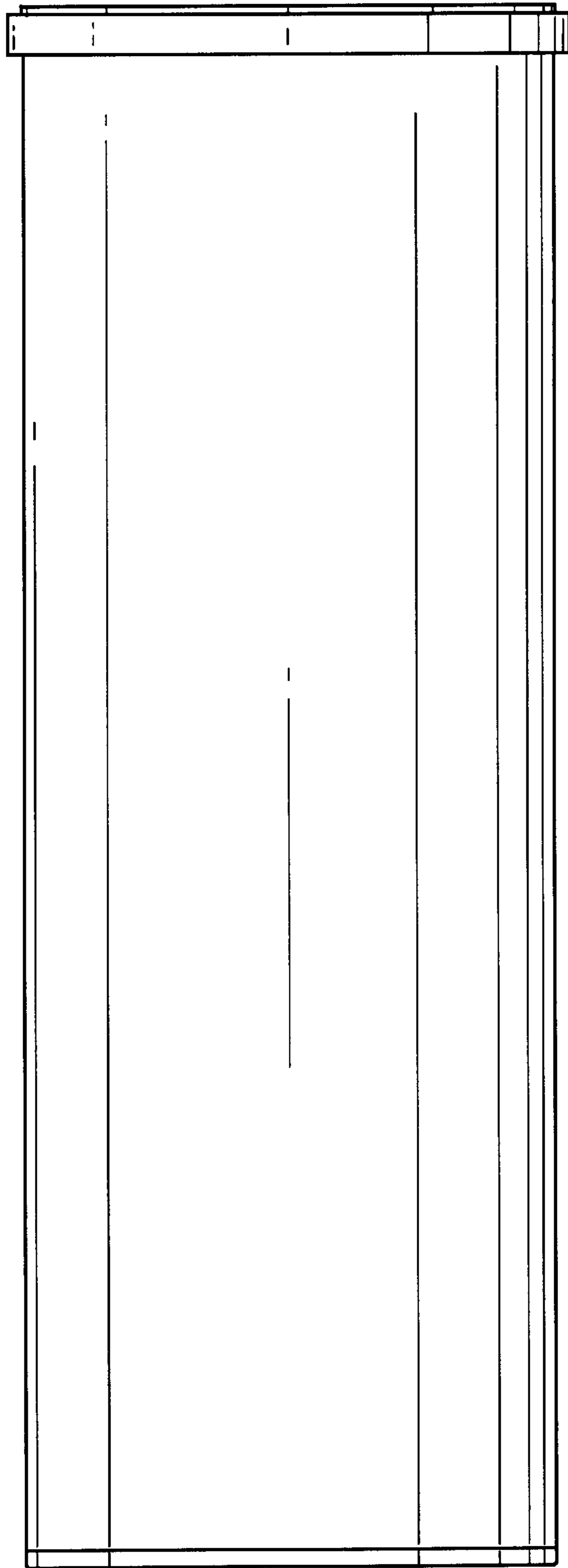

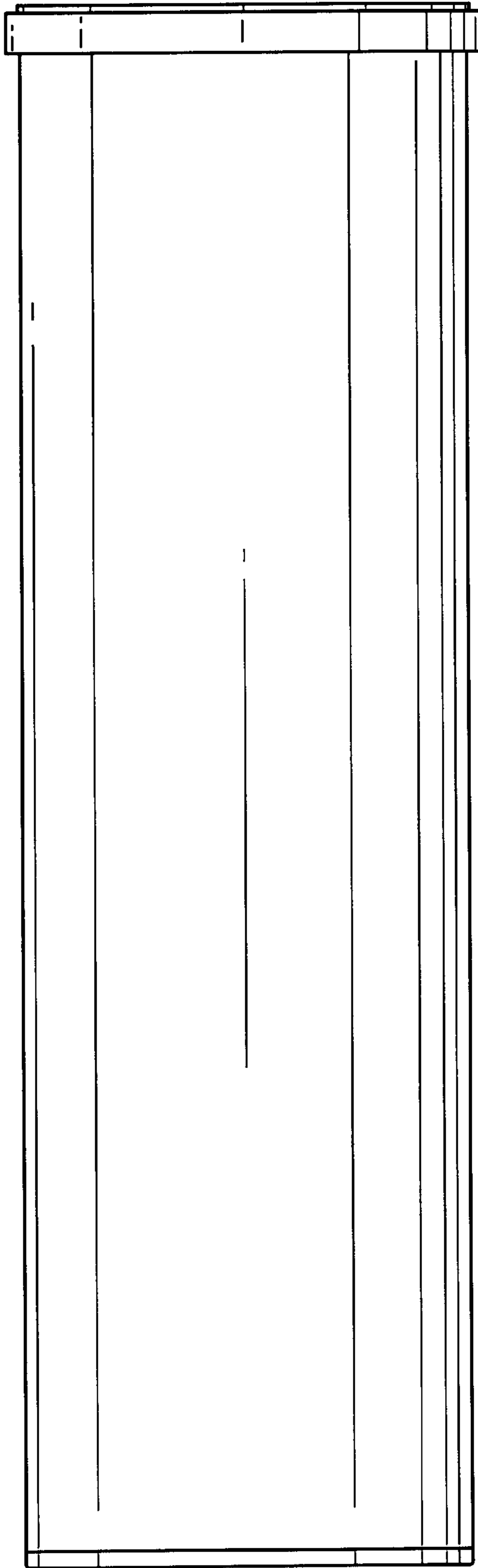

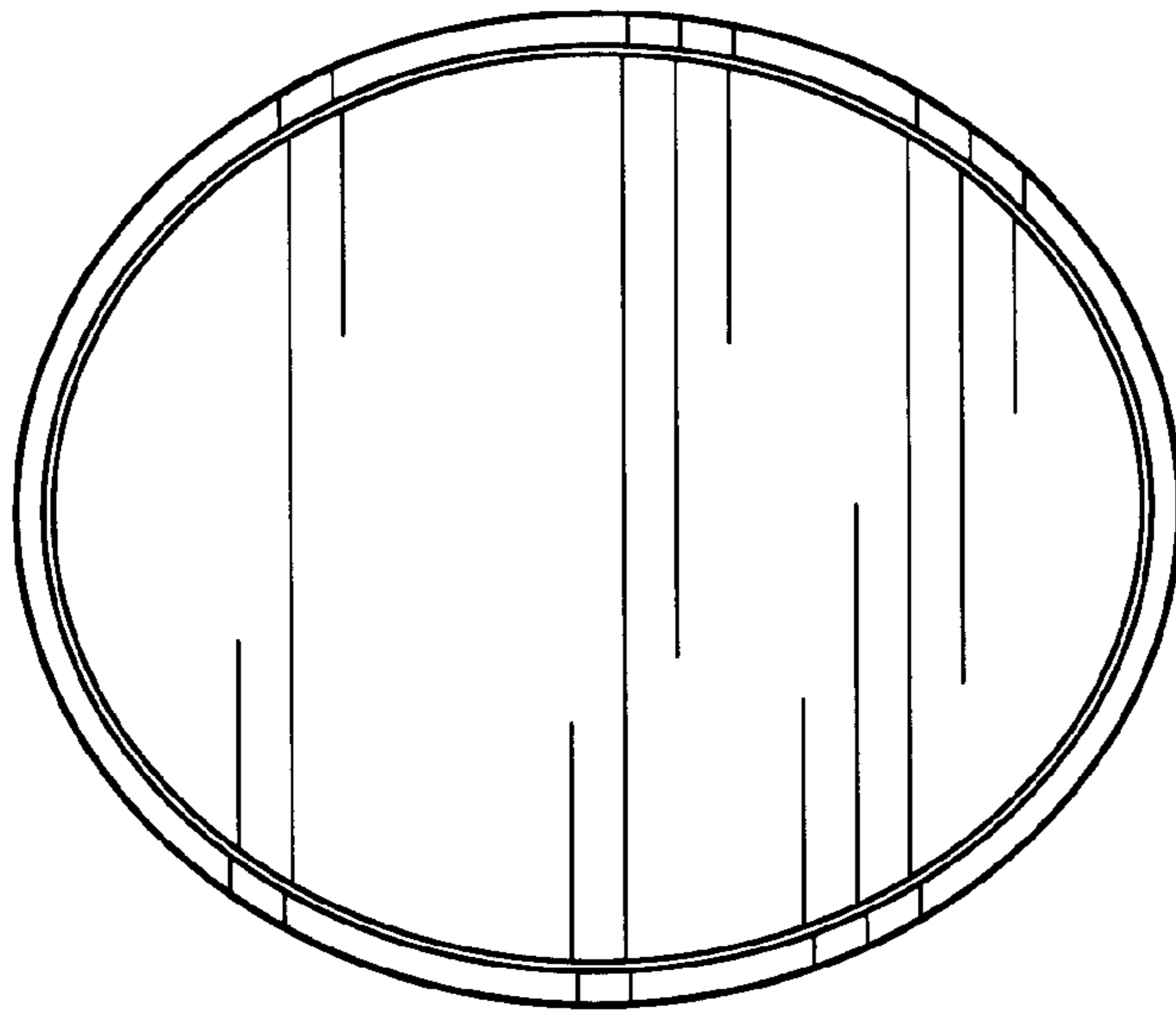

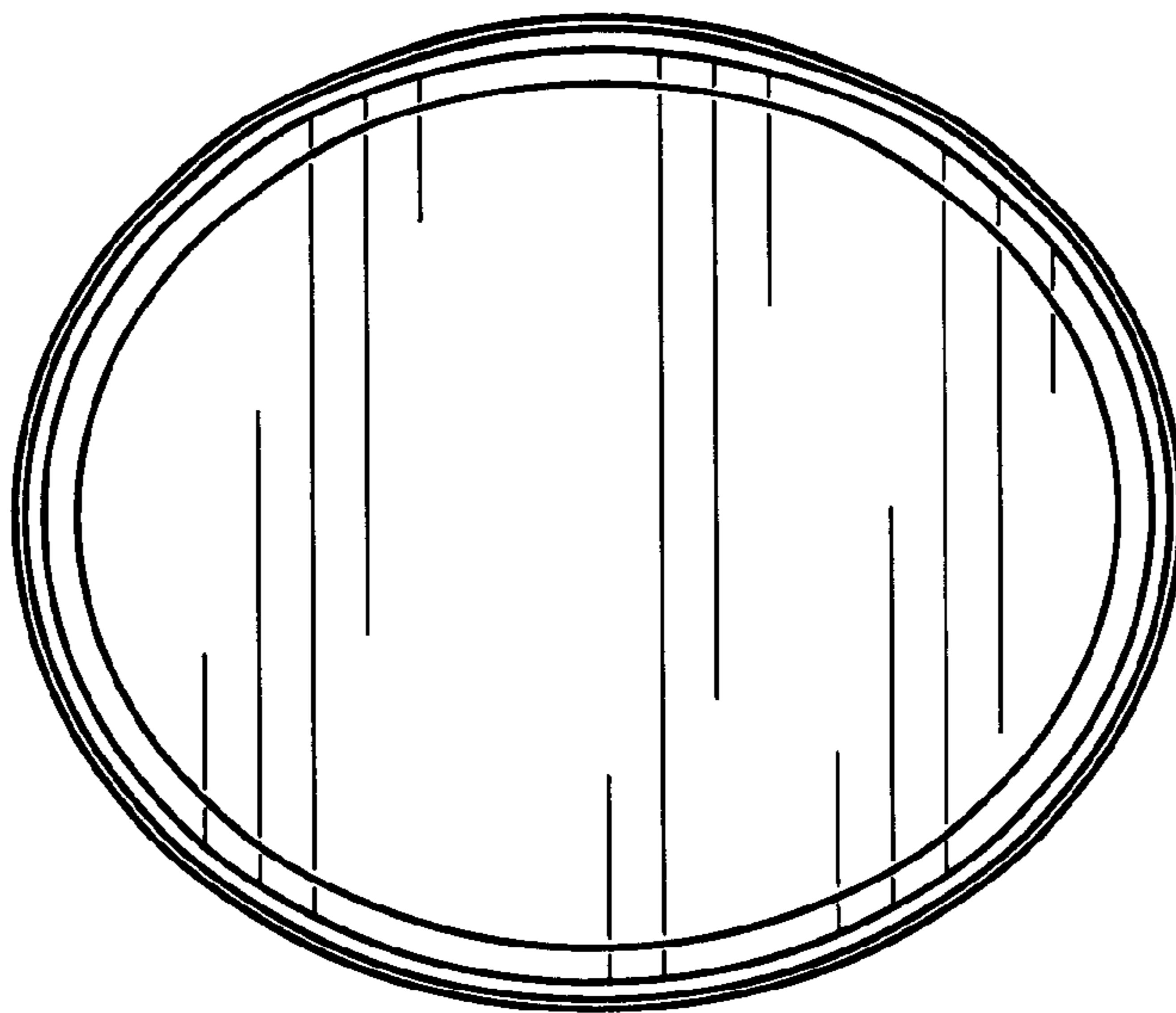
