design.

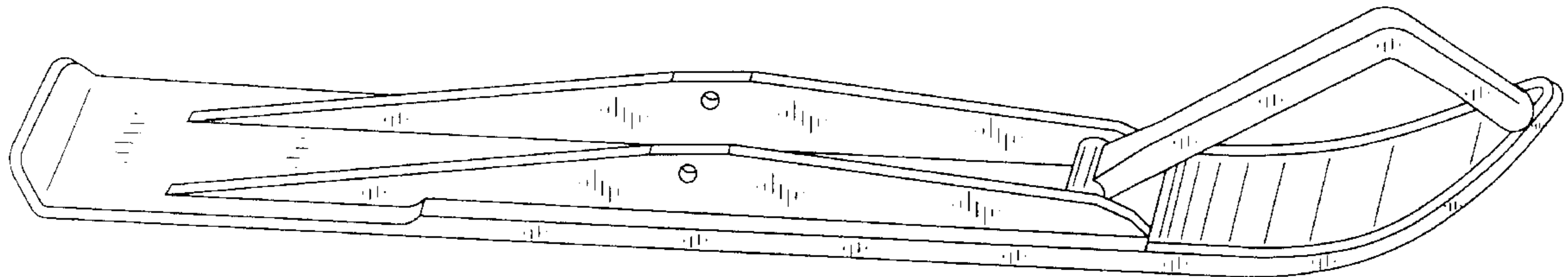
FIG. 4 is a top view of a snowmobile ski showing my new

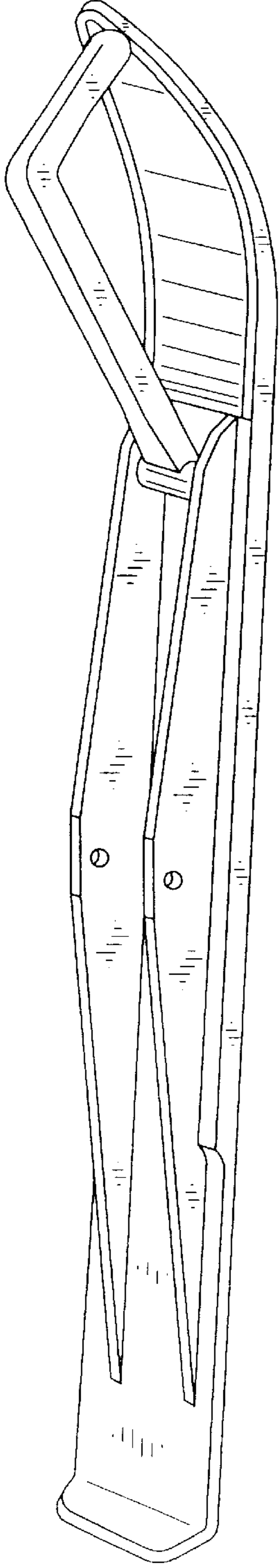

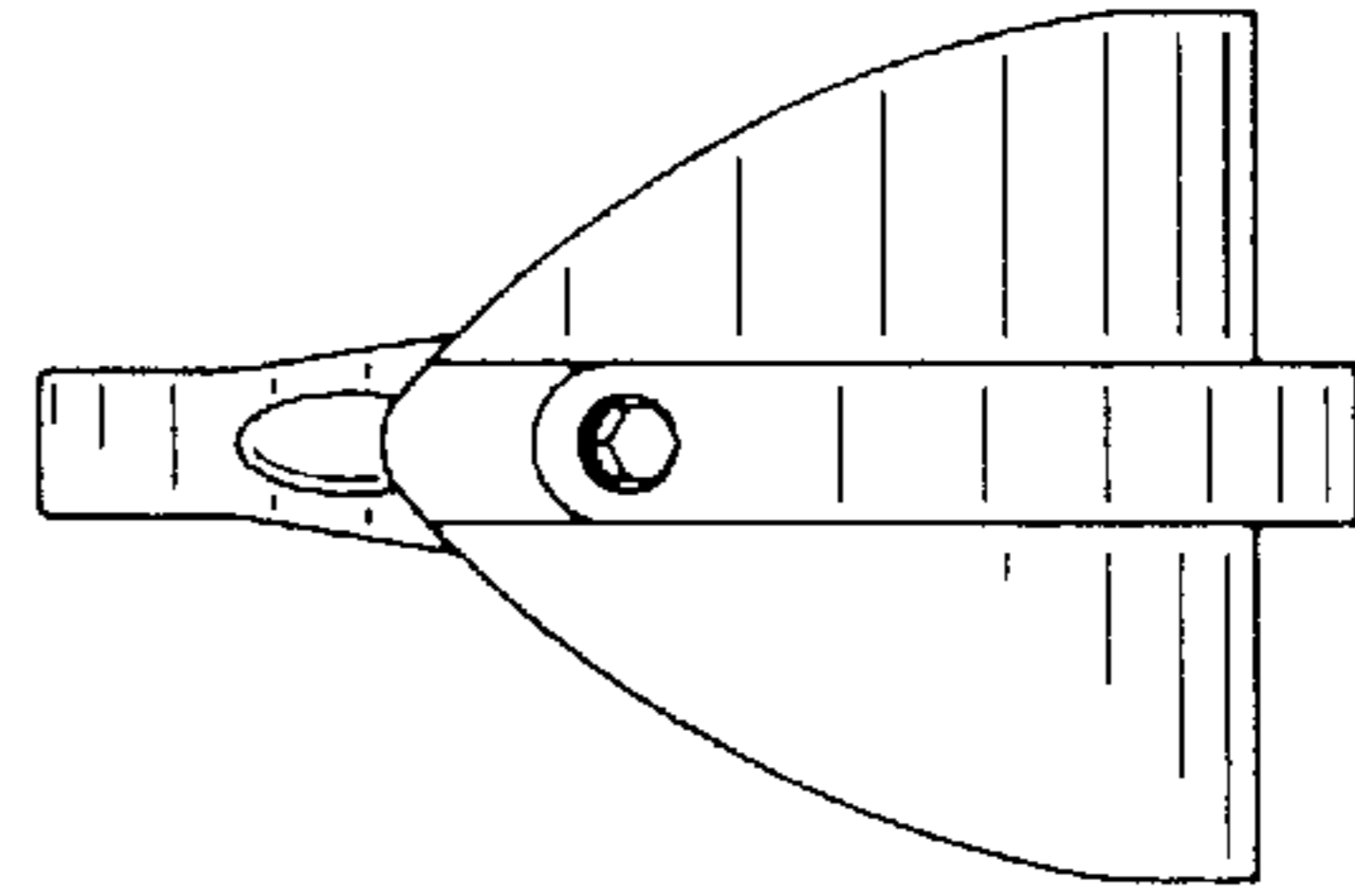

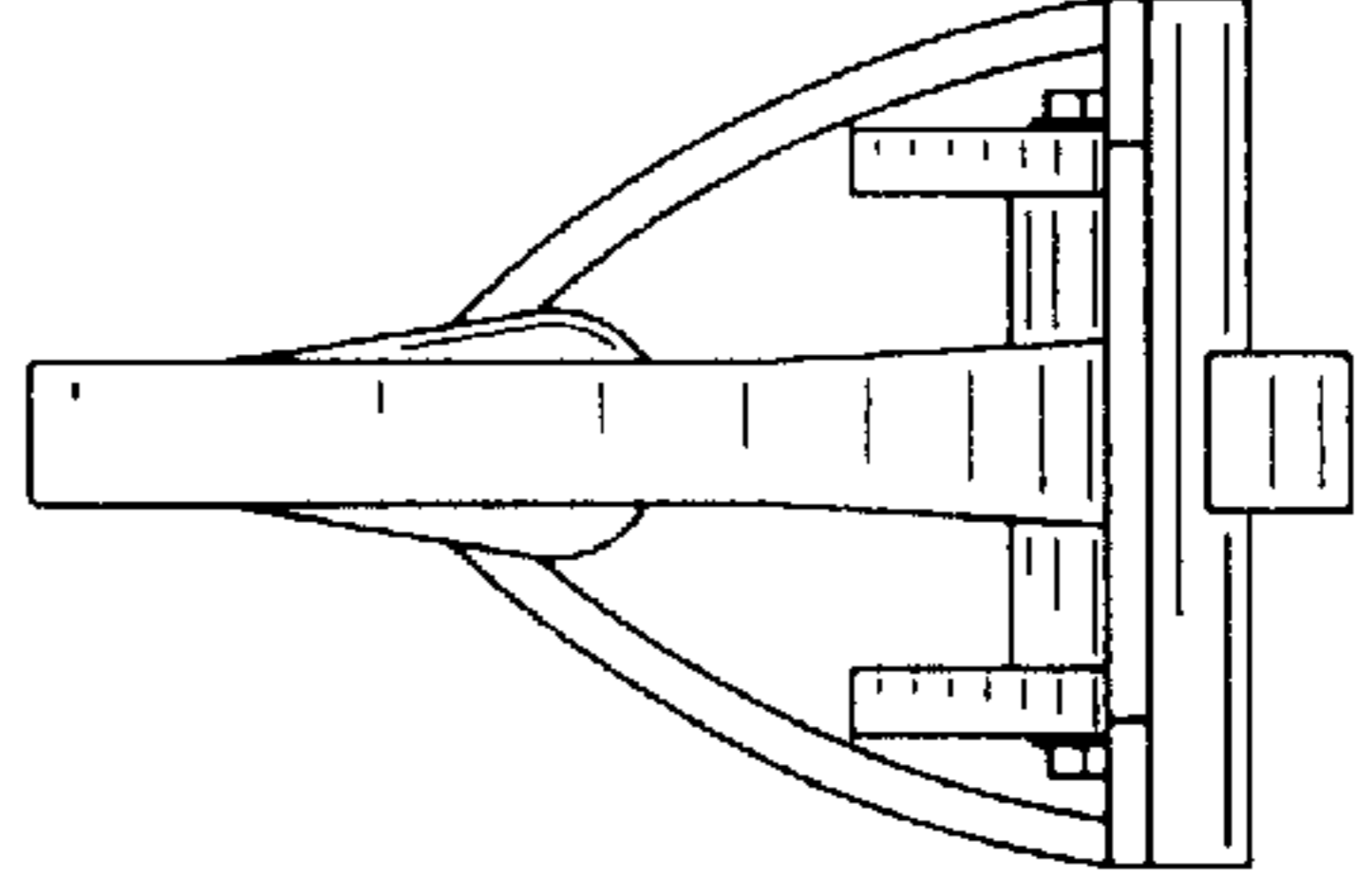

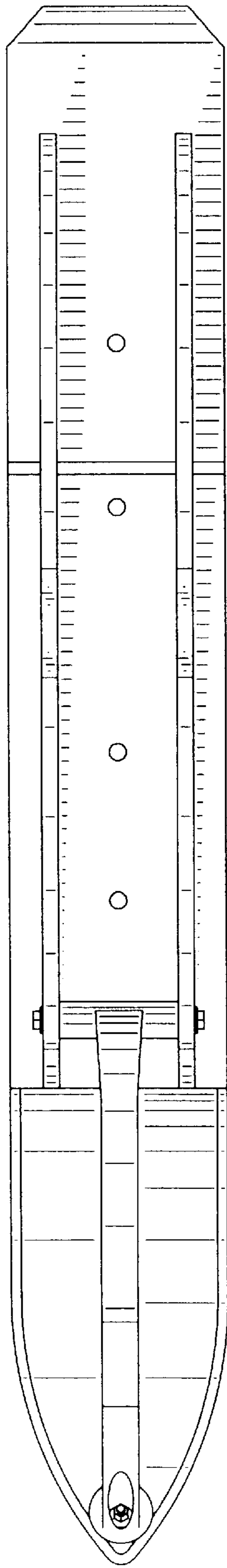

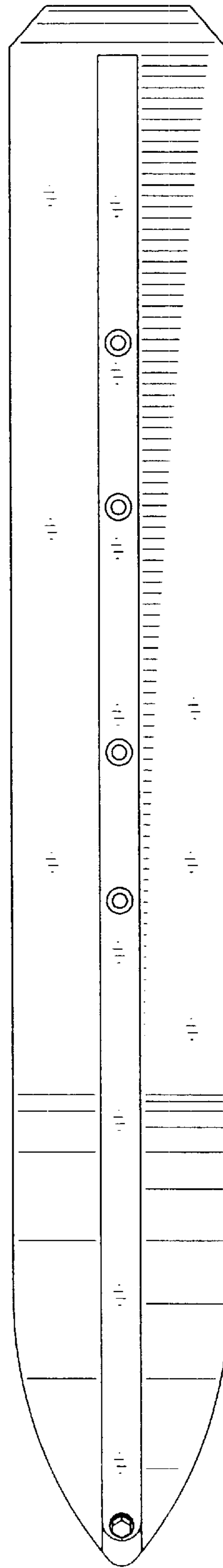

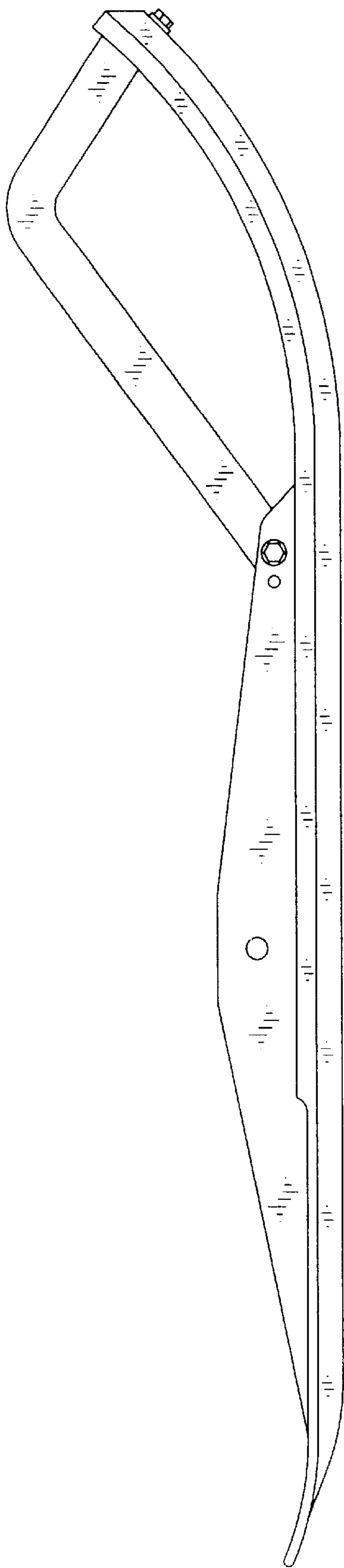

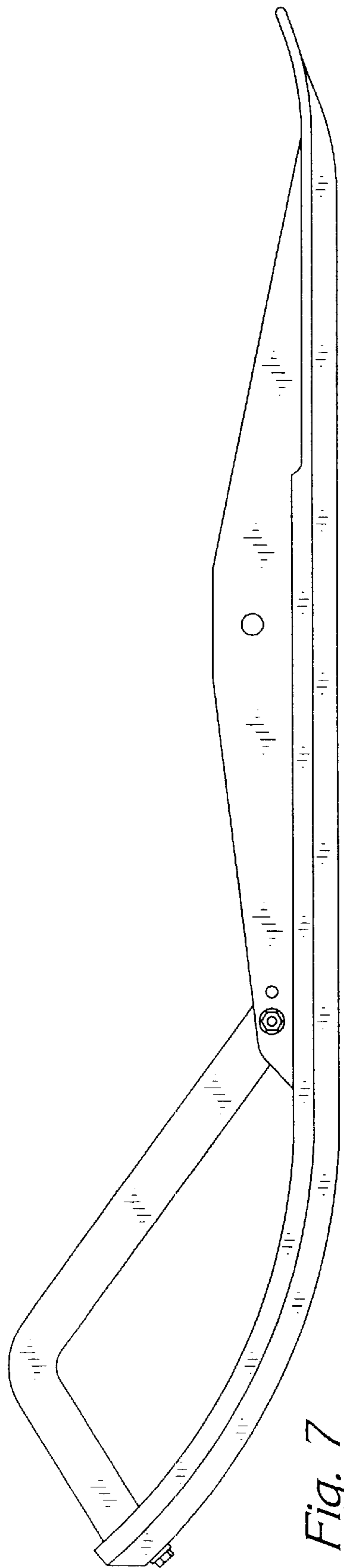
