(57) **CLAIM**

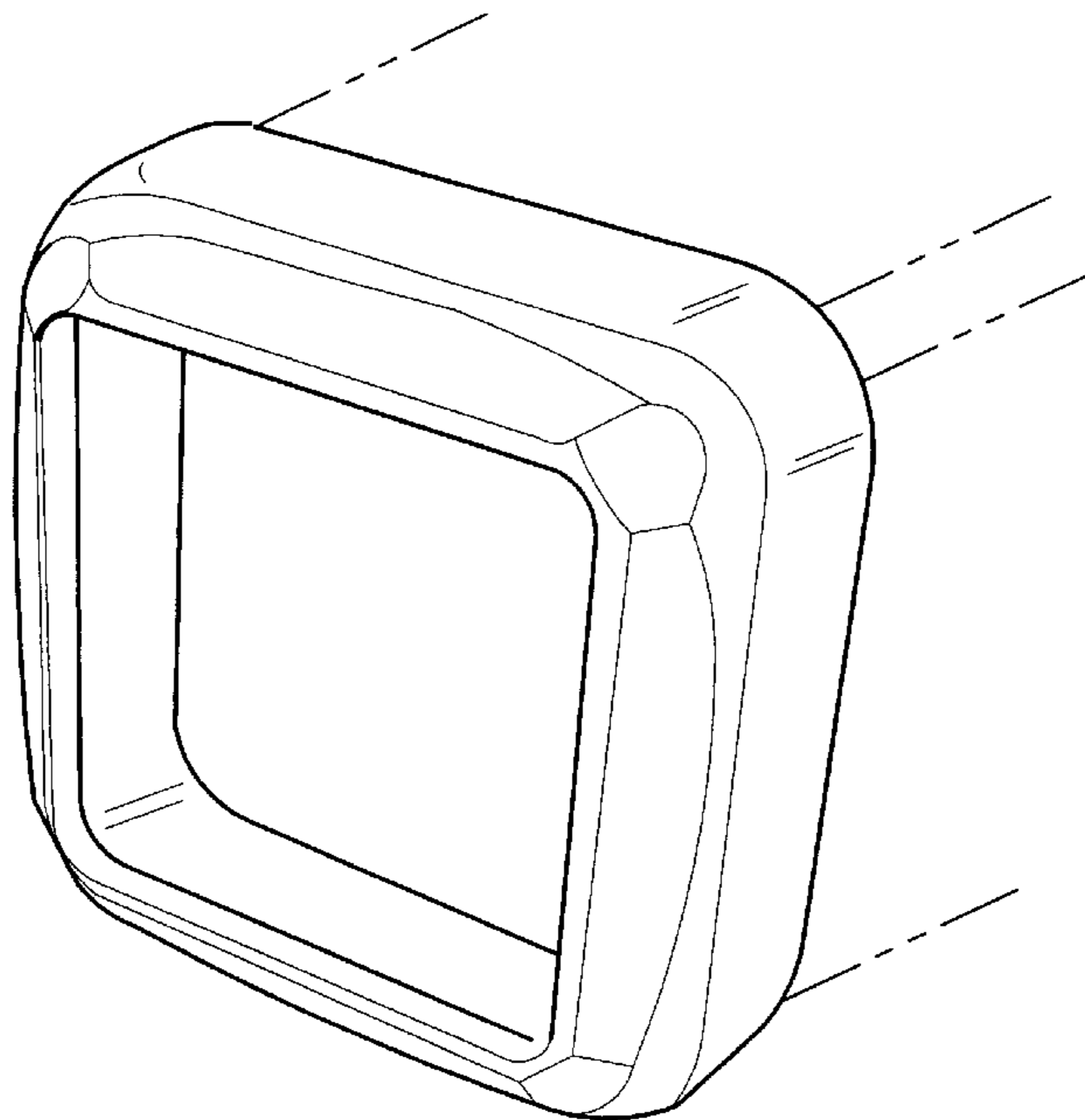
The ornamental design for a reinforcement ring for a trailer hitch receiver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a reinforcement ring for a trailer hitch receiver showing my new design;
 FIG. 2 is a front elevational view of the reinforcement ring for a trailer hitch receiver shown in FIG. 1;
 FIG. 3 is a top plan view of the reinforcement ring for a trailer hitch receiver shown in FIG. 1;
 FIG. 4 is a left side view of the reinforcement ring for a trailer hitch receiver shown in FIG. 1;
 FIG. 5 is a right side view of the reinforcement ring for a trailer hitch receiver shown in FIG. 1; and,
 FIG. 6 is a bottom plan view of the reinforcement ring for a trailer hitch receiver shown in FIG. 1.

The broken lines are for environmental purposes only and form no part of the claimed design. It will be understood that the rear view is not seen during normal use and forms no part of the present invention.

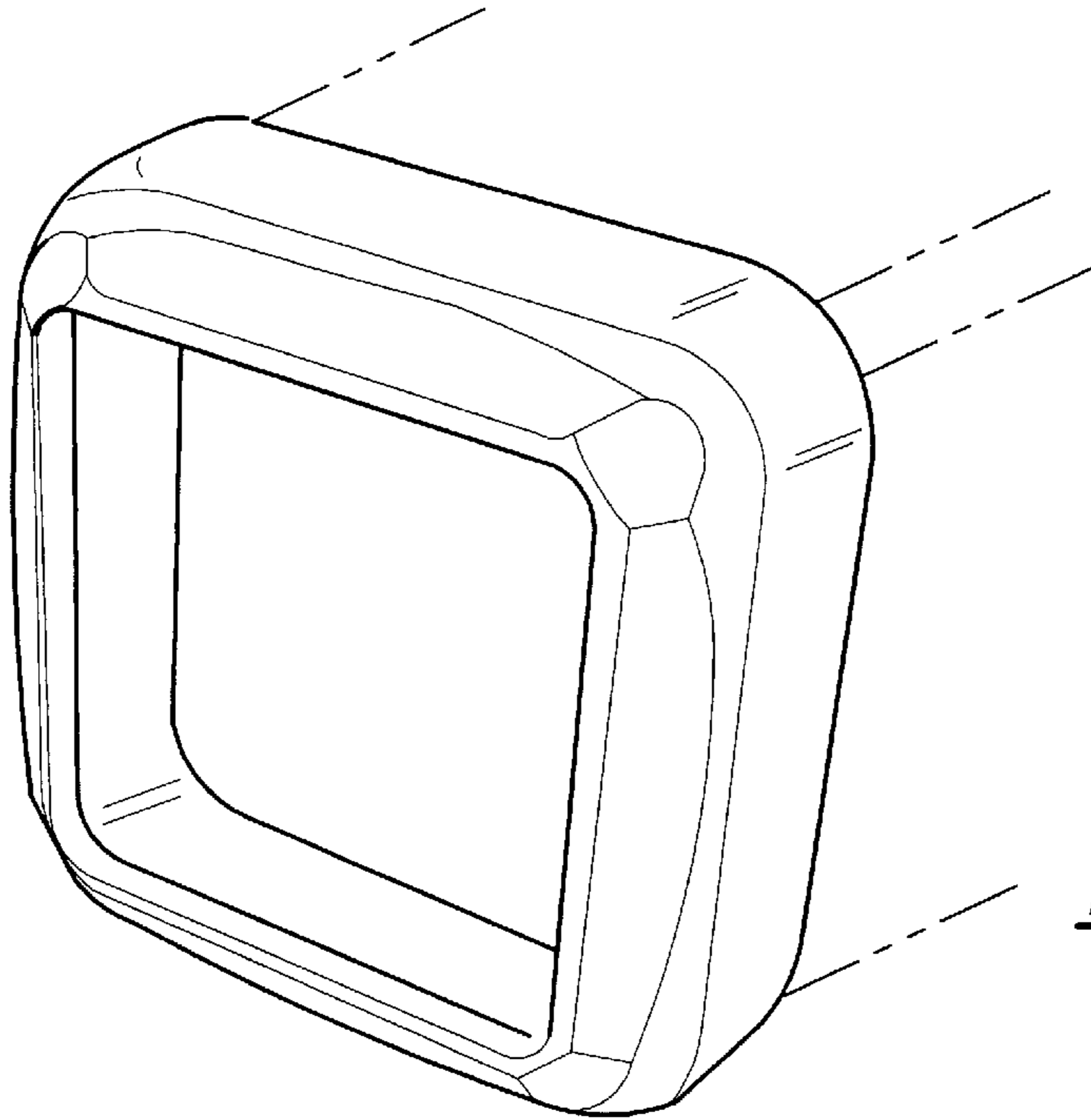

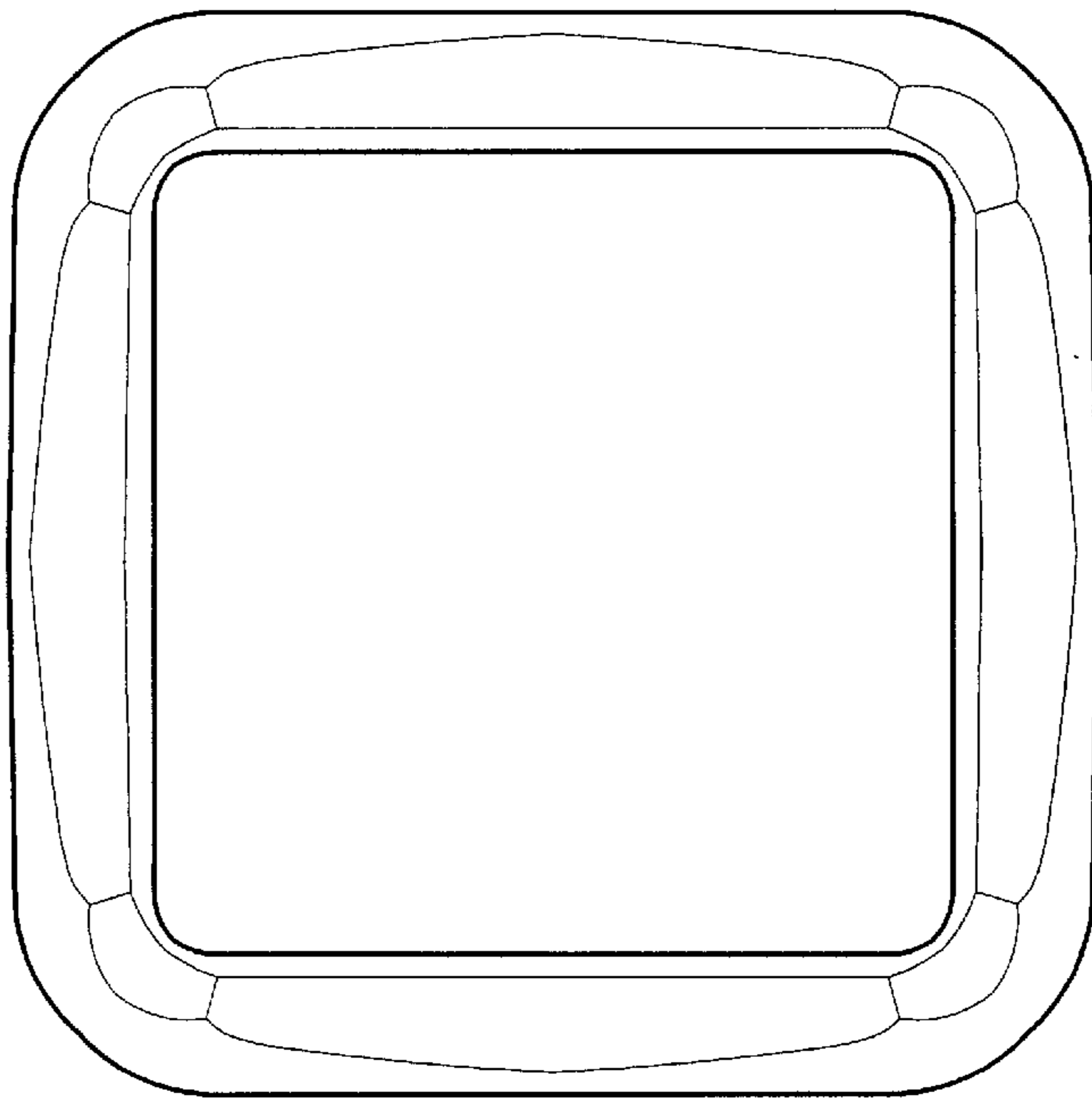

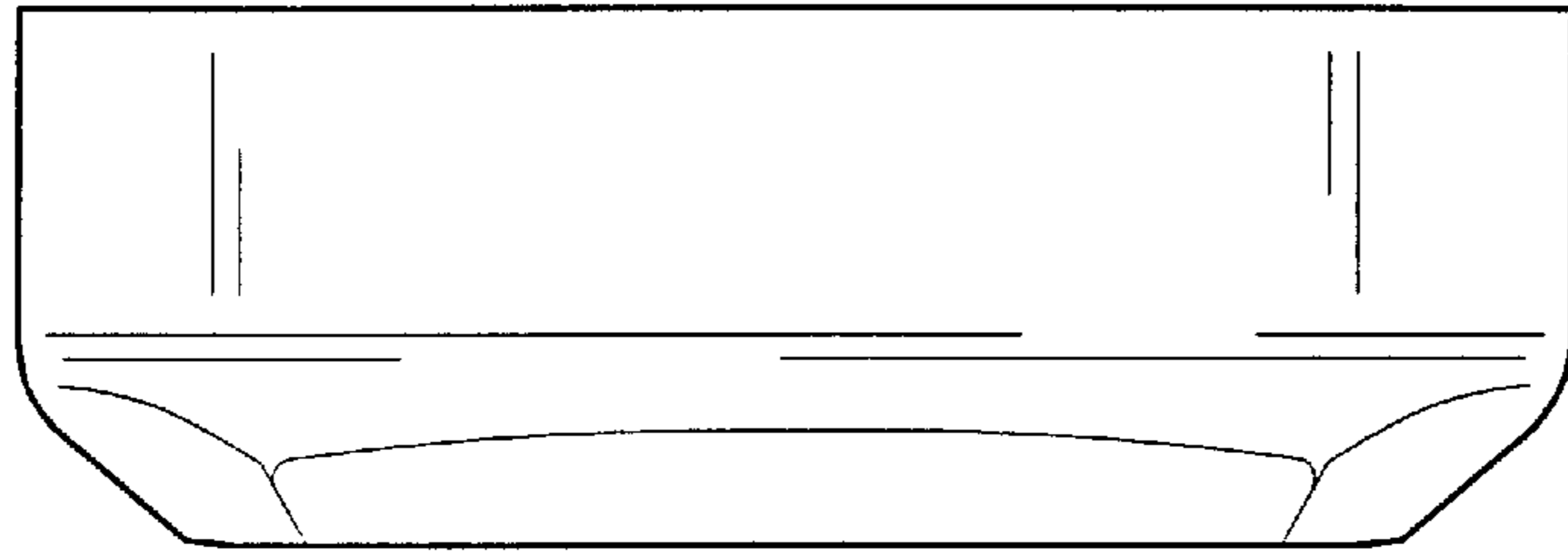

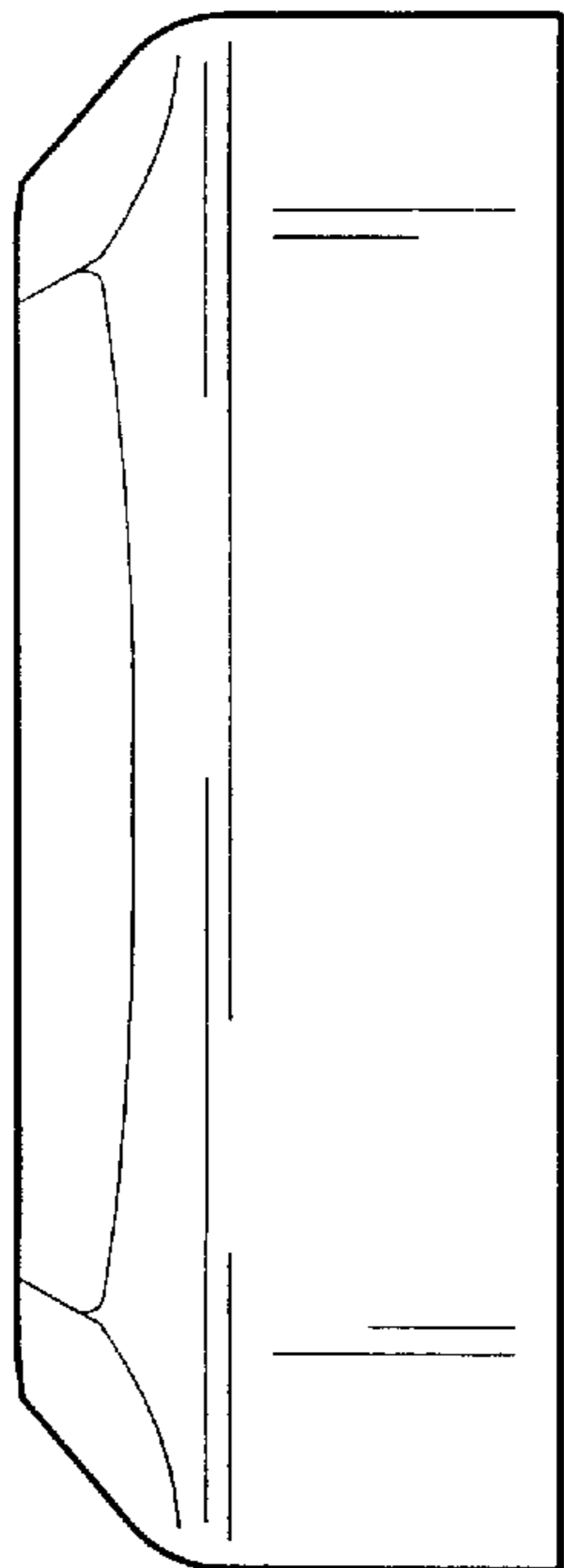

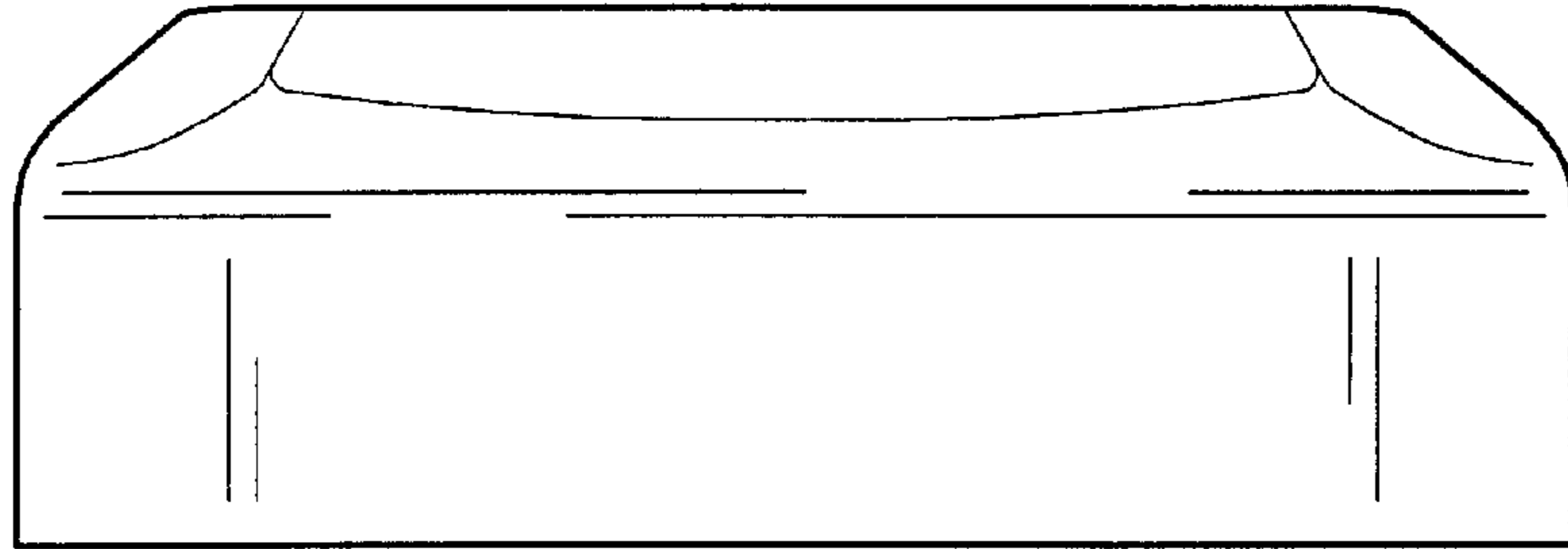

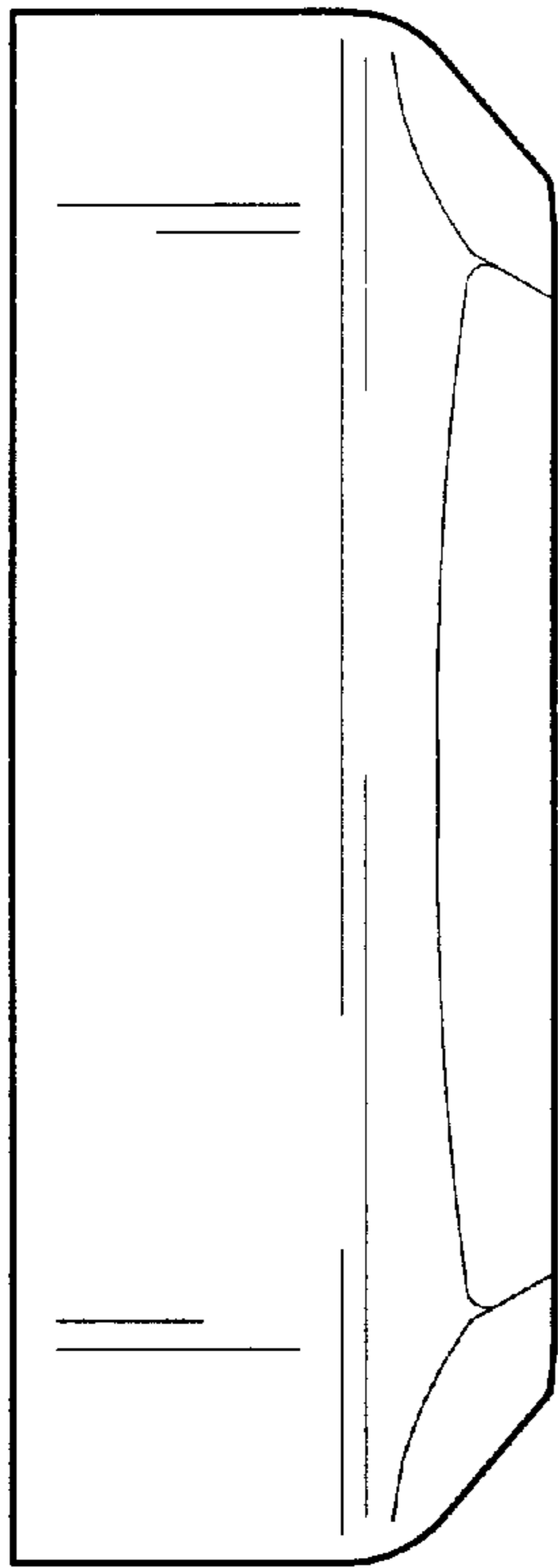
