(57) **CLAIM**

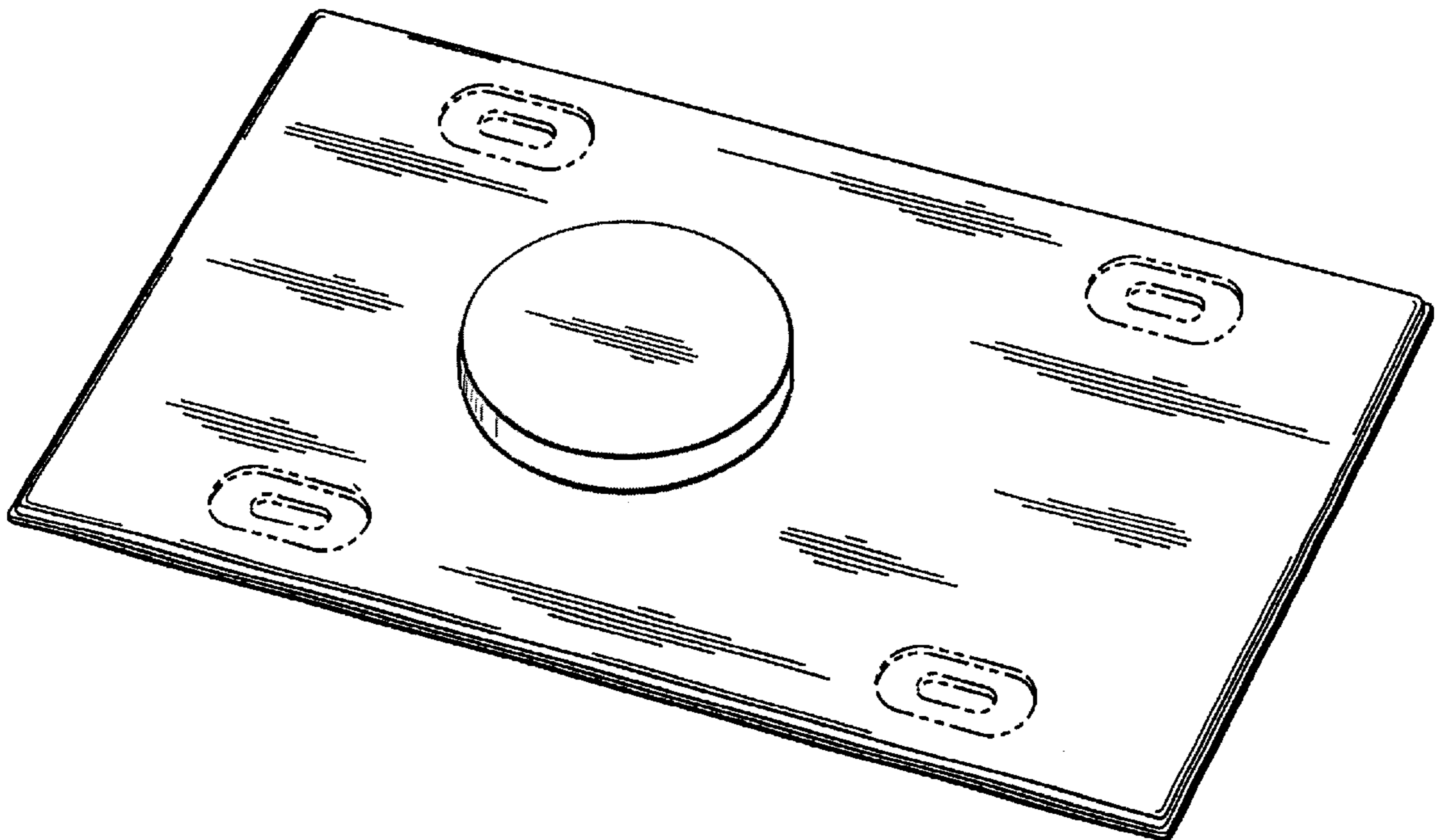
The ornamental design for a novelty license plate, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a novelty license plate;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a top plan view, the bottom plan view being a mirror image thereof;
 FIG. 5 is a left side elevational view, the right side elevational view being a mirror image thereof;
 FIG. 6 is a perspective view of an alternative embodiment of a novelty license plate;
 FIG. 7 is a front elevational view thereof;
 FIG. 8 is a rear elevational view thereof;
 FIG. 9 is a top plan view thereof;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is a left side elevational view thereof; and,
 FIG. 12 is a right side elevational view thereof.

The broken lines in the drawings depict environmental structure, which forms no part of the claimed design.

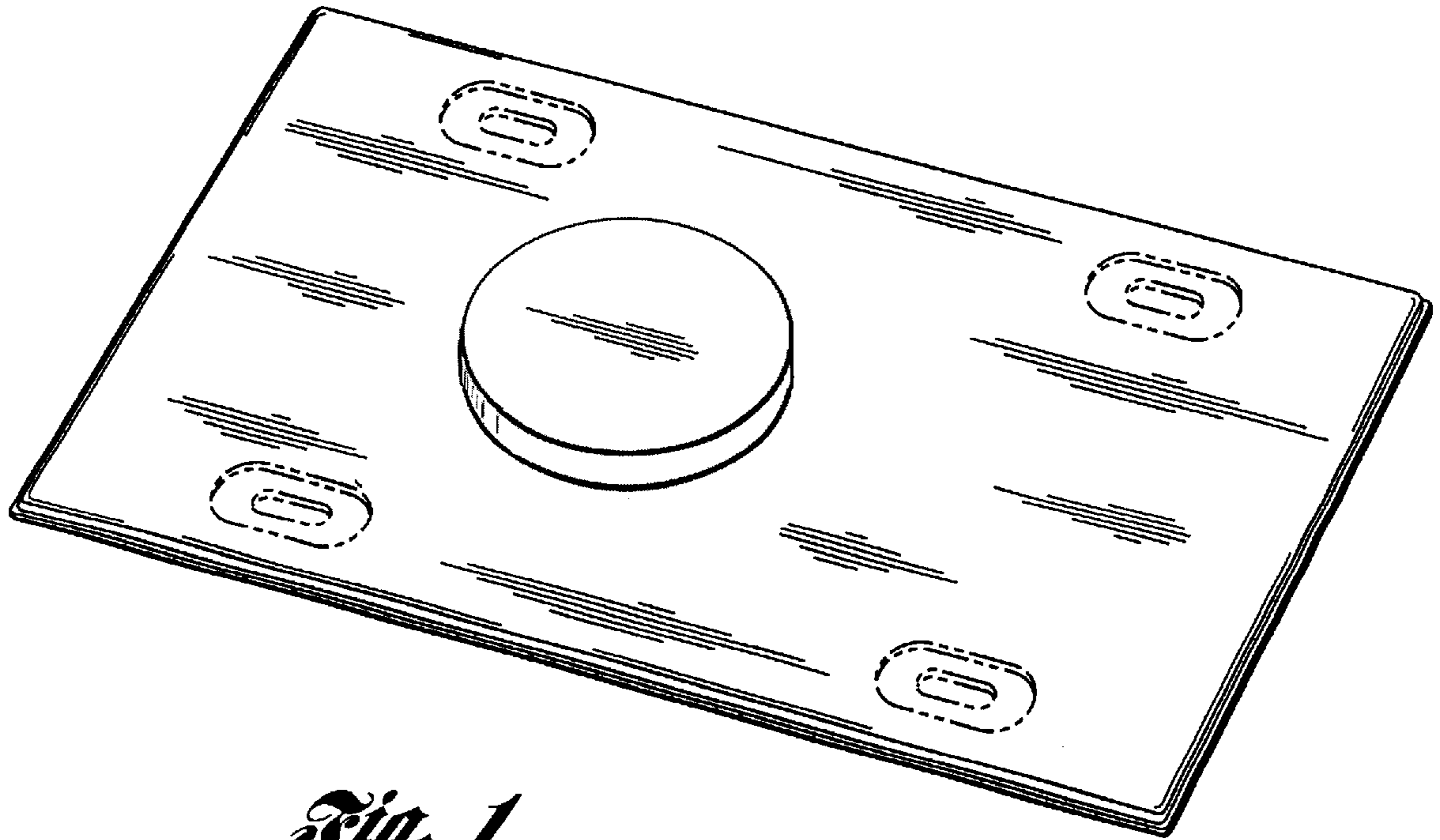

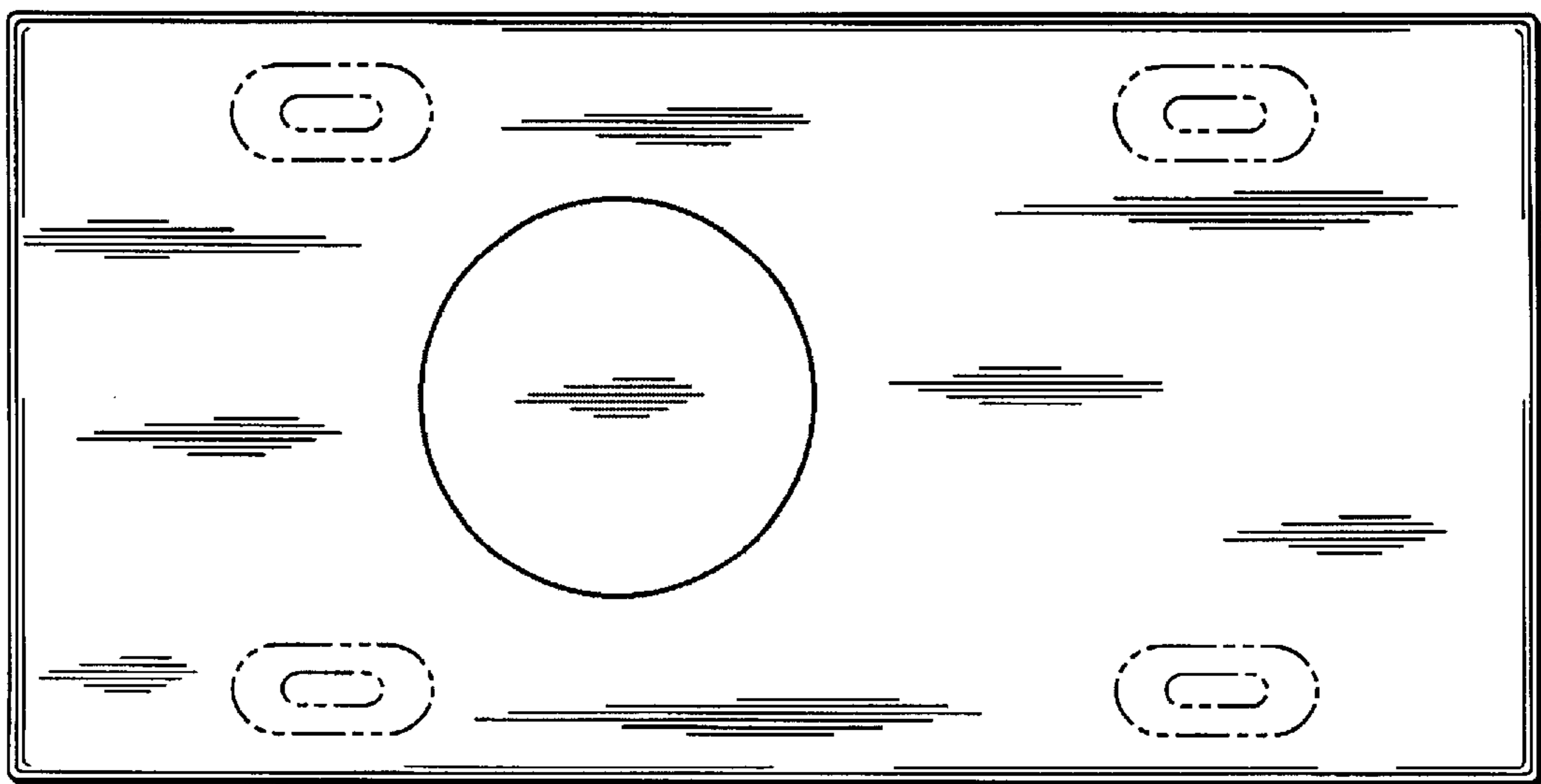

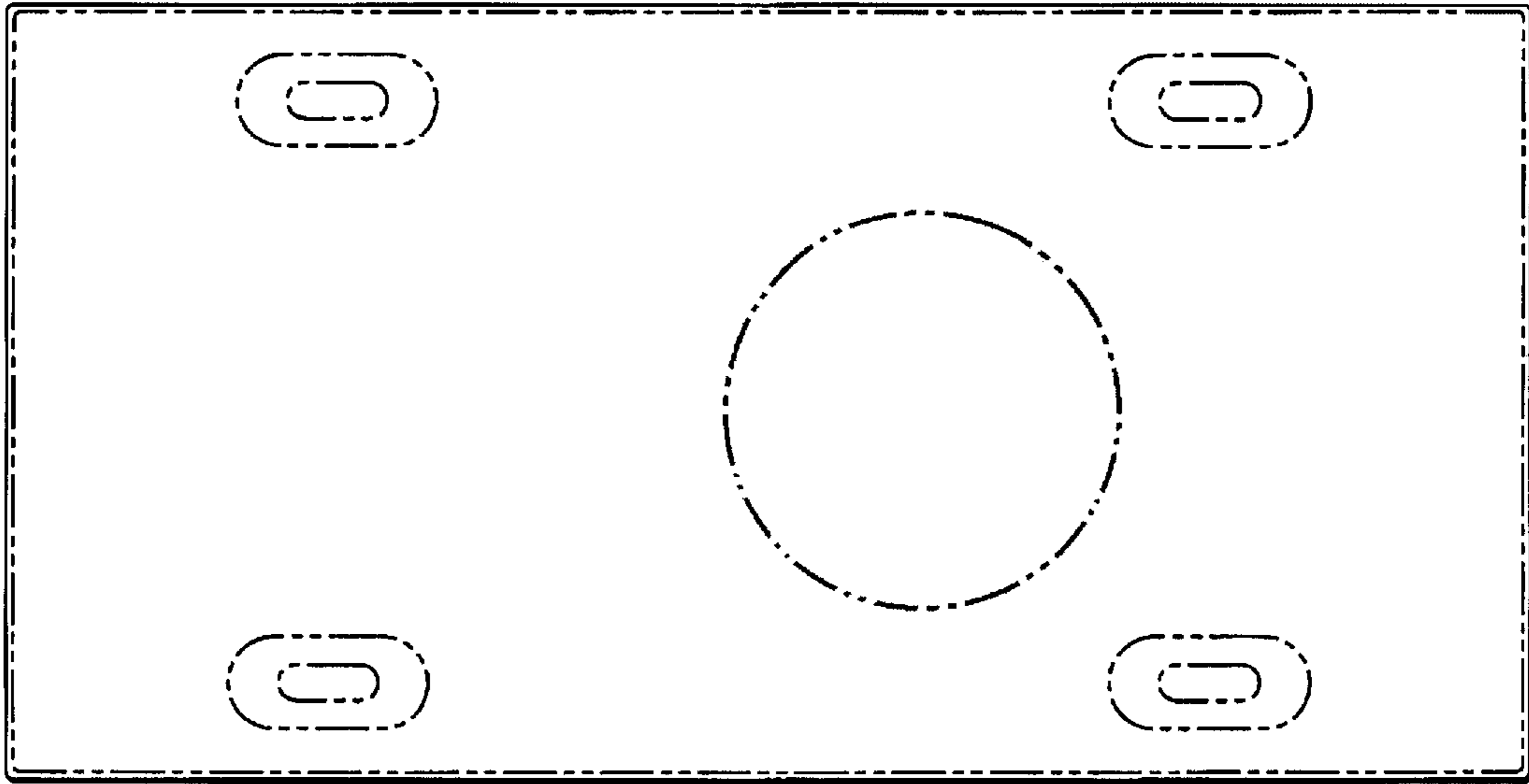

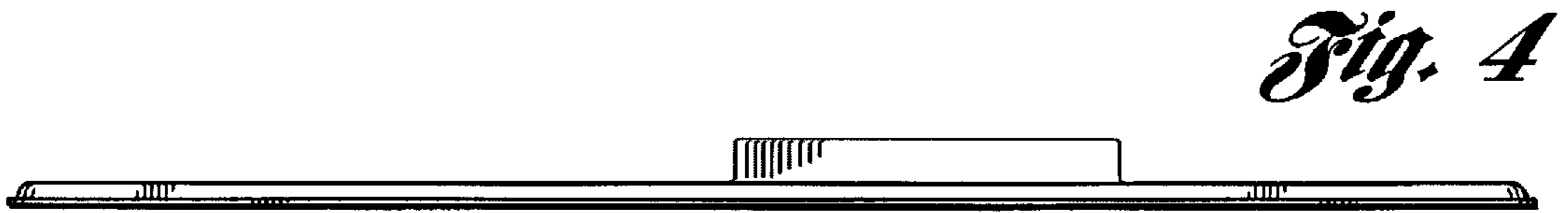

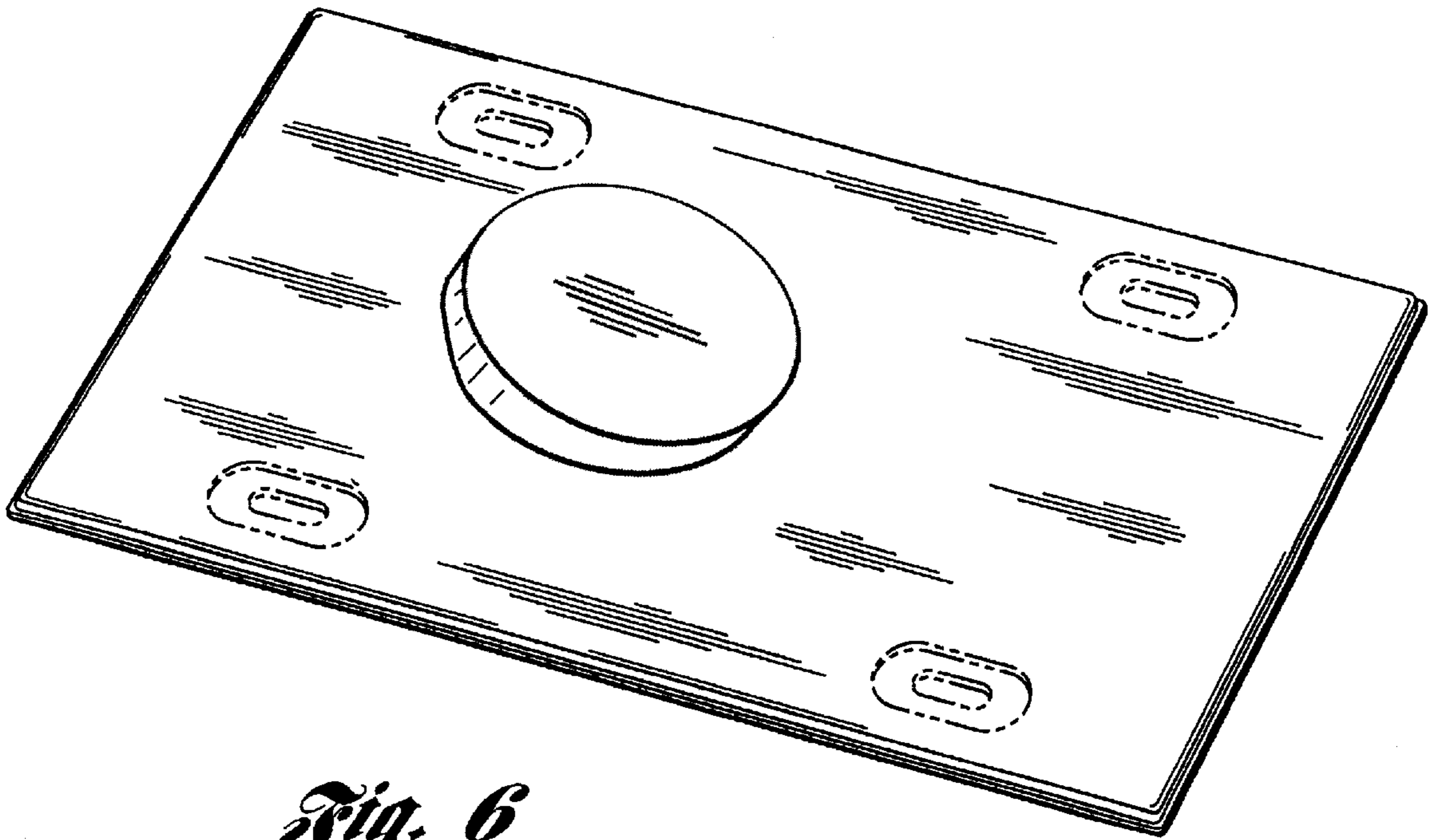

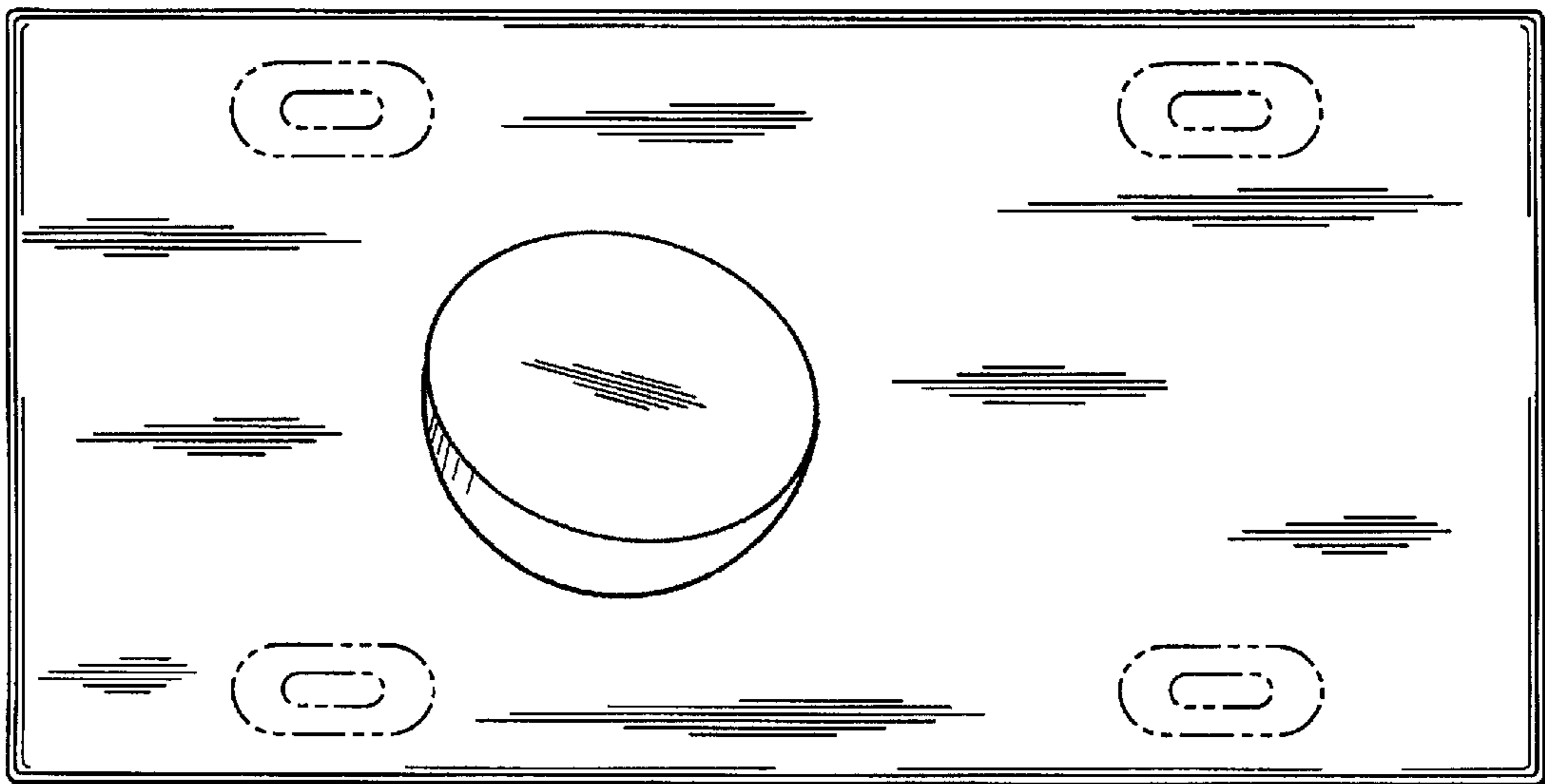

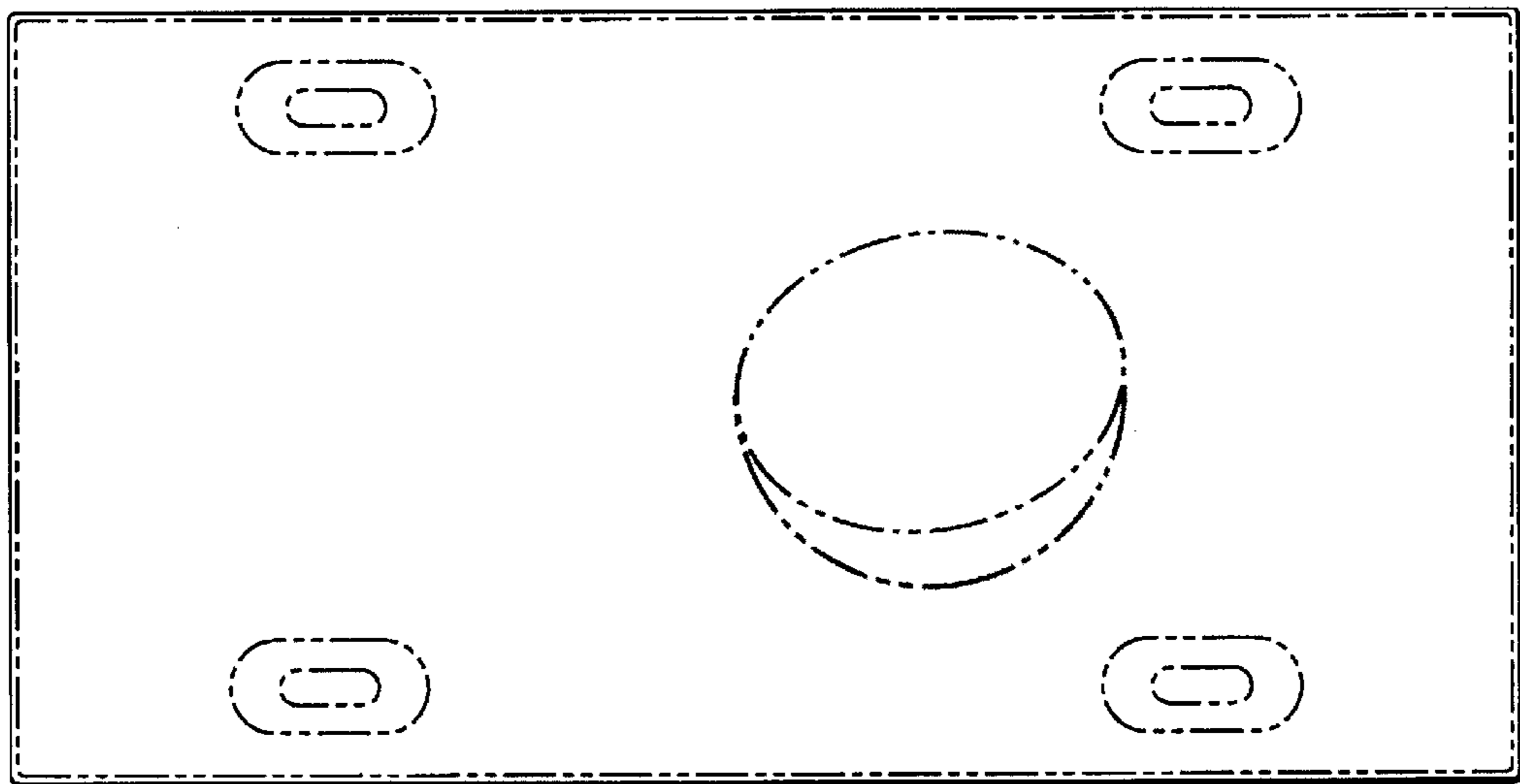

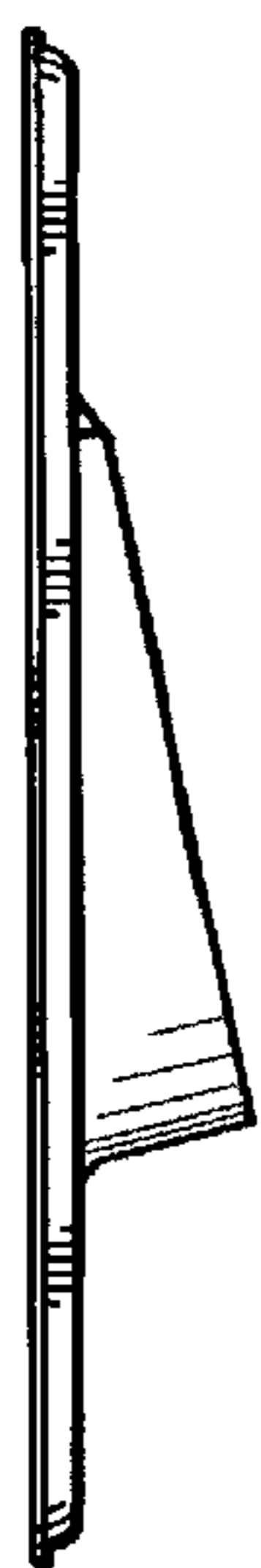

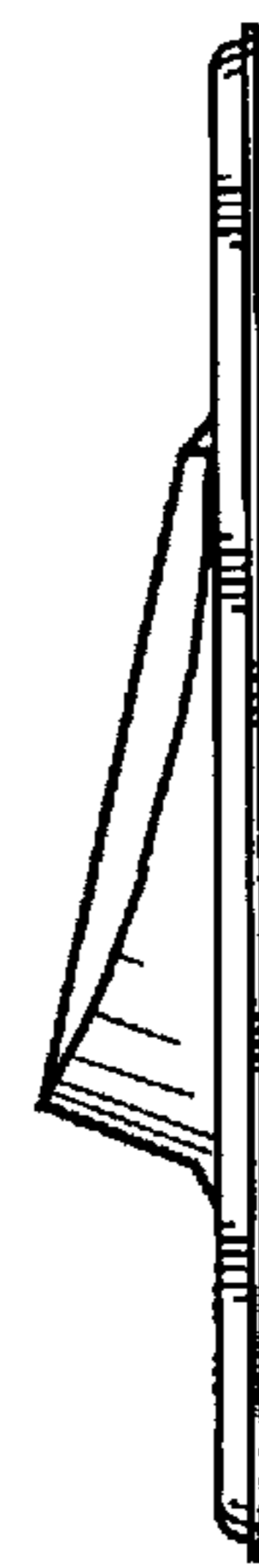
