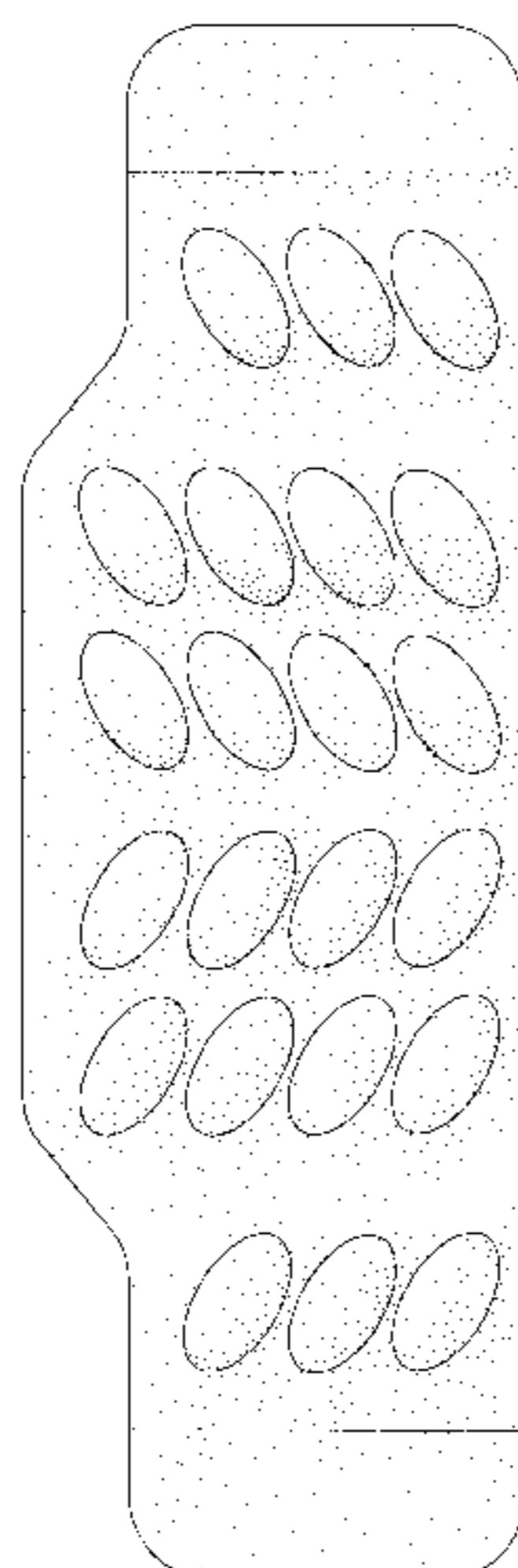
(57) **CLAIM**

The ornamental design for a back wrap with thermal cells and adhesive tabs, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a back wrap with thermal cells and adhesive tabs, showing our new design; FIG. 2 is a side elevational view thereof; FIG. 3 is a side elevational view thereof, opposite that shown in FIG. 2; FIG. 4 is a bottom plan view thereof, the top plan view being a mirror image thereof; FIG. 5 is a back elevational view thereof; FIG. 6 is a front elevational view of an alternate embodiment of the back wrap having thermal cells and adhesive tabs, showing our new design; FIG. 7 is a side elevational view thereof; FIG. 8 is a side elevational view thereof, opposite that shown in FIG. 7; FIG. 9 is a bottom plan view thereof, the top plan view being a mirror image thereof; and, FIG. 10 is a back elevational view thereof.

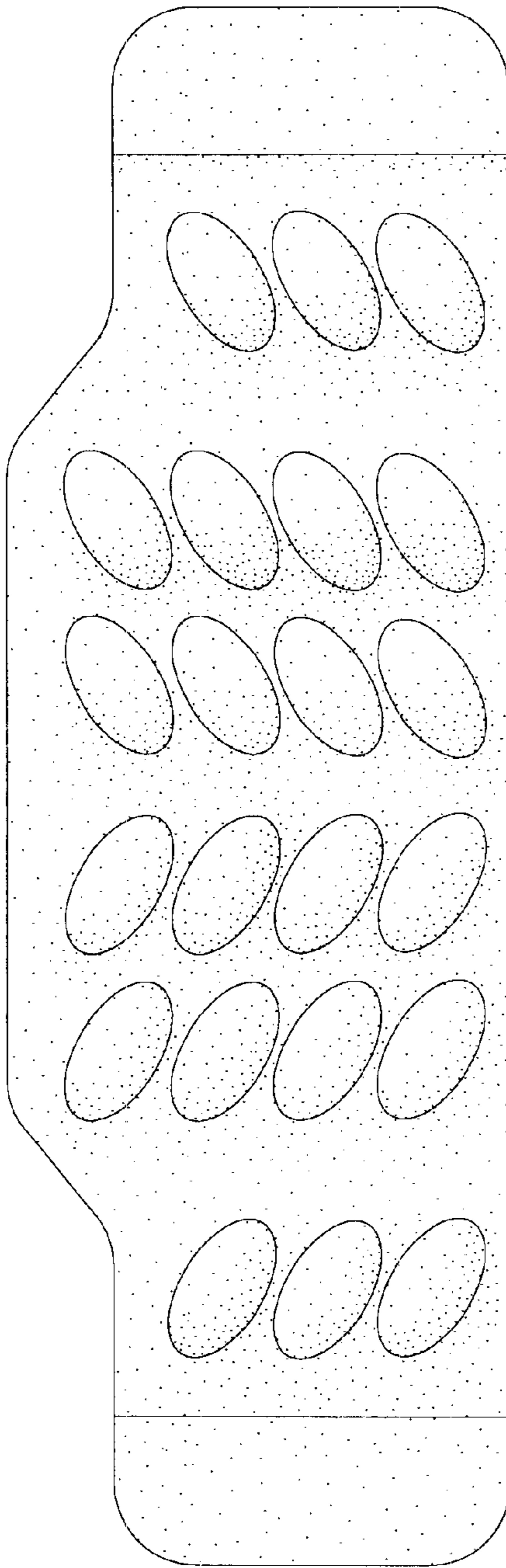

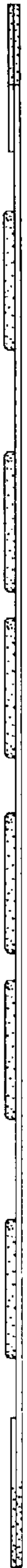

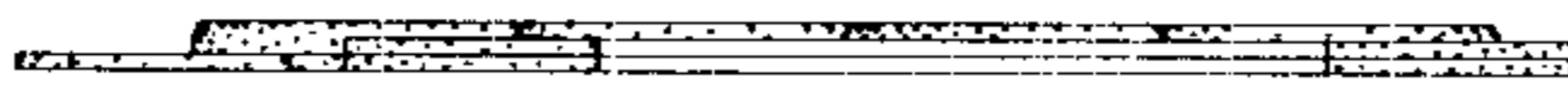

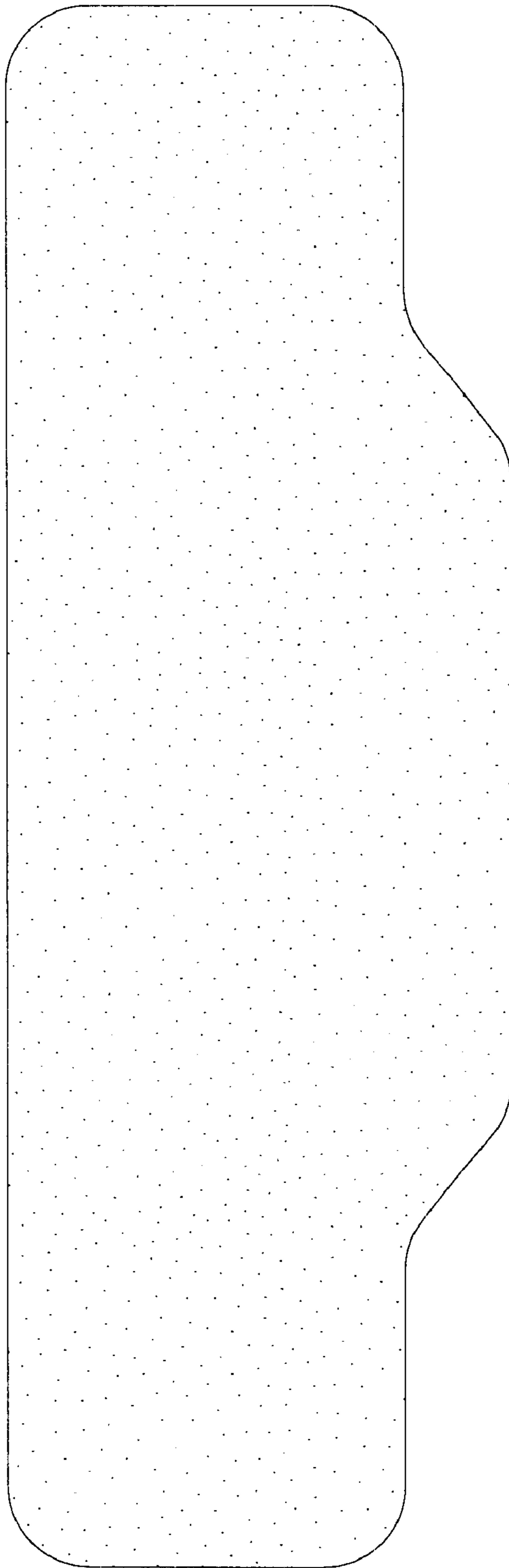

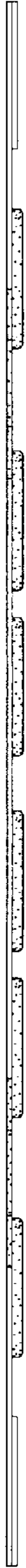

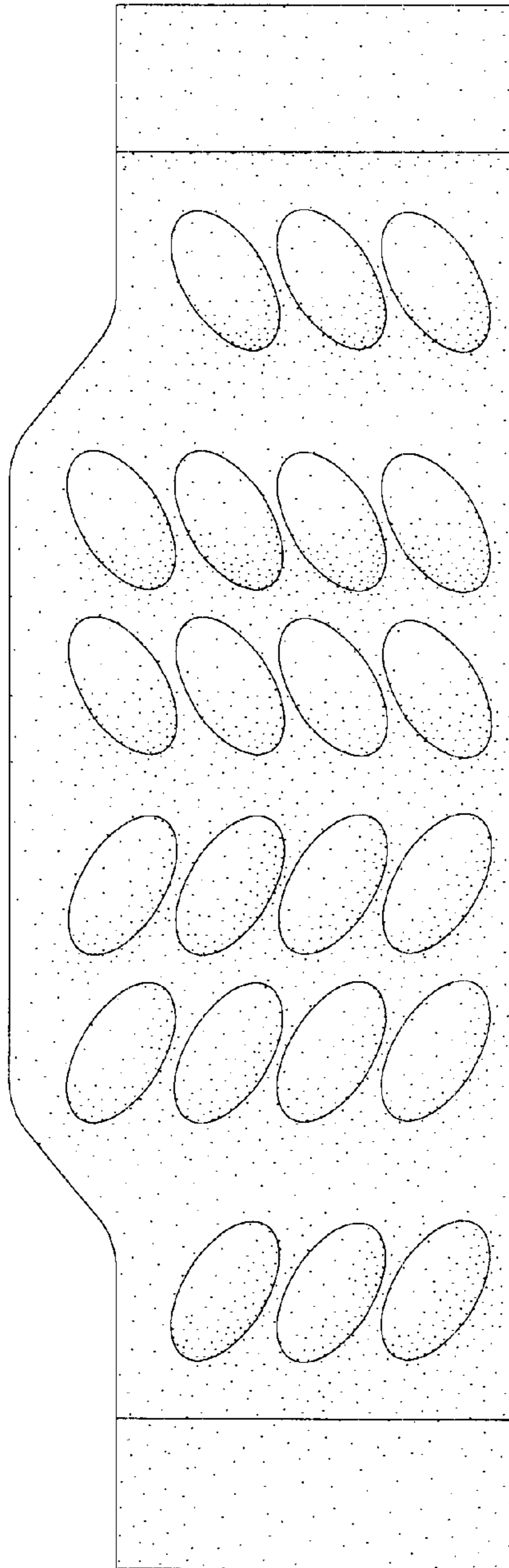

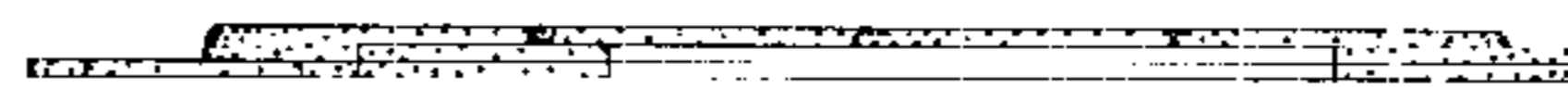

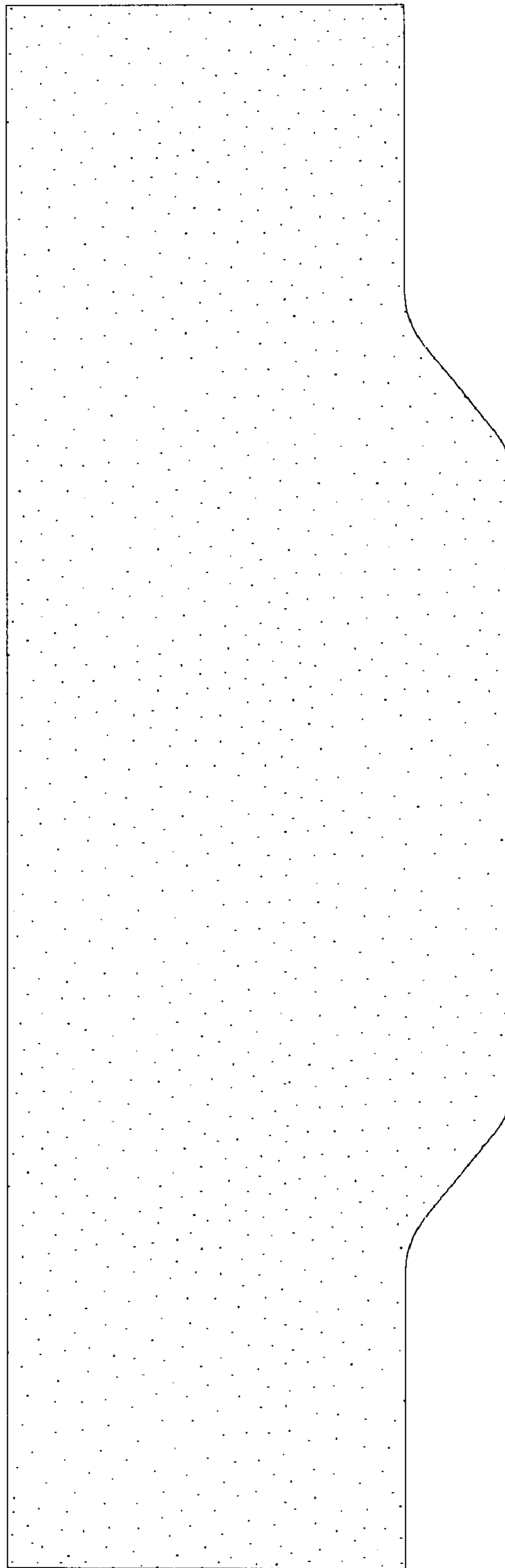
