(57) **CLAIM**

The ornamental design of a novelty hat and wig, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of my novelty hat and wig of the present invention, the broken line drawing of the letters being for illustrative purposes only;

FIG. 2 is a right side view of the novelty hat and wig in FIG. 1;

FIG. 3 is a left side view of the novelty hat and wig in FIG. 1;

FIG. 4 is a back view of the novelty hat and wig in FIG. 1; FIG. 5 is a bottom view of the novelty hat and wig in FIG. 1;

FIG. 6 is a top view of the novelty hat and wig in FIG. 1; FIG. 7 is a front perspective view of the novelty hat and wig in FIG. 1, the broken line drawing of the human being for illustrative purposes only;

FIG. 8 is a front perspective view of a second embodiment of my novelty hat and wig of the present invention, the broken line drawing of the letters and the broken line drawing of the human being for illustrative purposes only;

FIG. 9 is a front view of a third embodiment of my novelty hat and wig of the present invention, the broken line drawing of the letters being for illustrative purposes only;

FIG. 10 is a right side view of the novelty hat and wig in FIG. 9;

FIG. 14 is a top view of the novelty hat and wig in FIG. 9;

FIG. 15 is a front perspective view of the novelty hat and wig in FIG. 9, the broken line drawing of the human being for illustrative purposes only;

FIG. 16 is a front view of a fourth embodiment of my novelty hat and wig of the present invention, the broken line drawing of the letters being for illustrative purposes only;

FIG. 17 is a right side view of the novelty hat and wig in FIG. 16;

FIG. 18 is a left side view of the novelty hat and wig in FIG. 16;

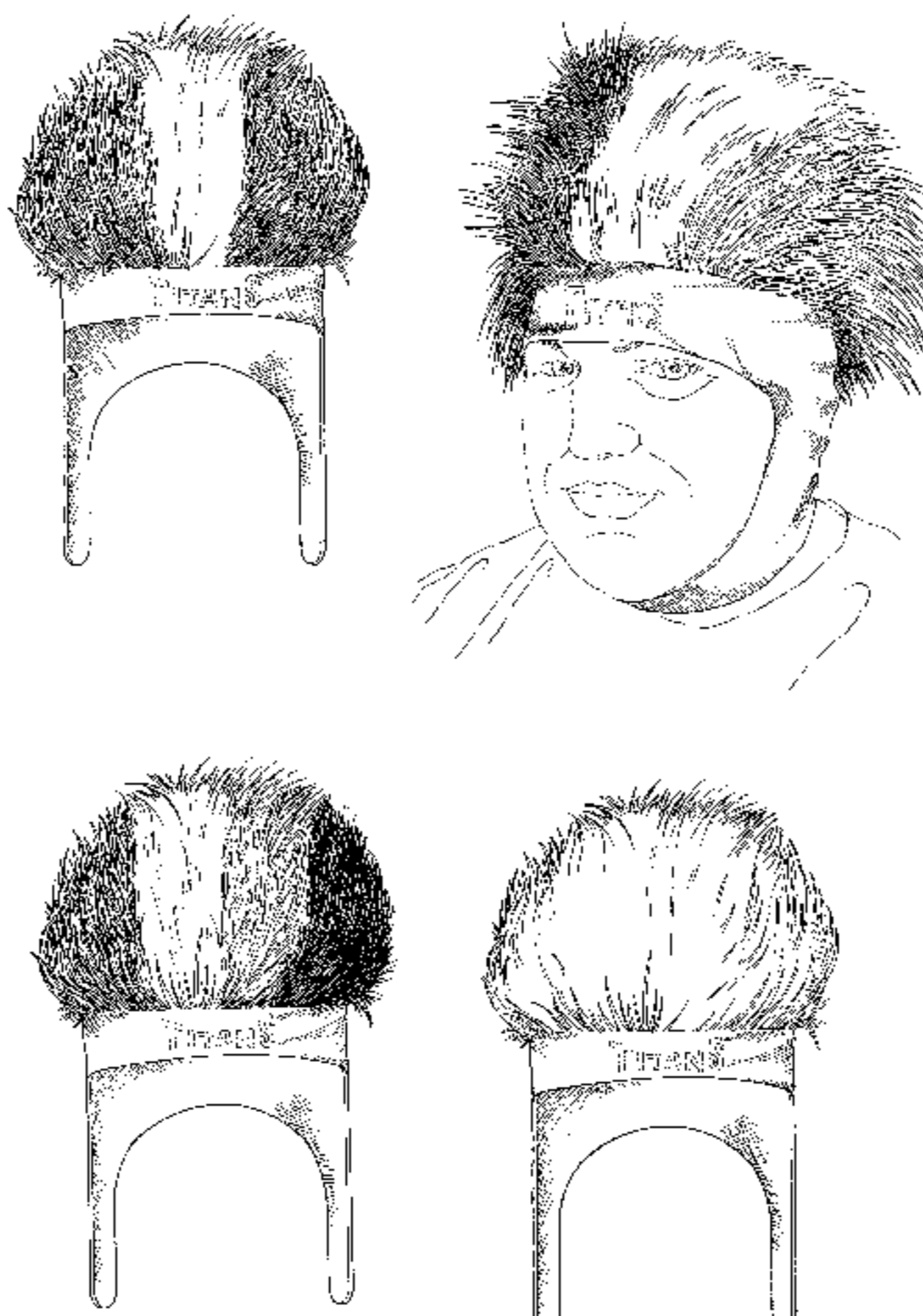
FIG. 19 is a back view of the novelty hat and wig in FIG. 16;

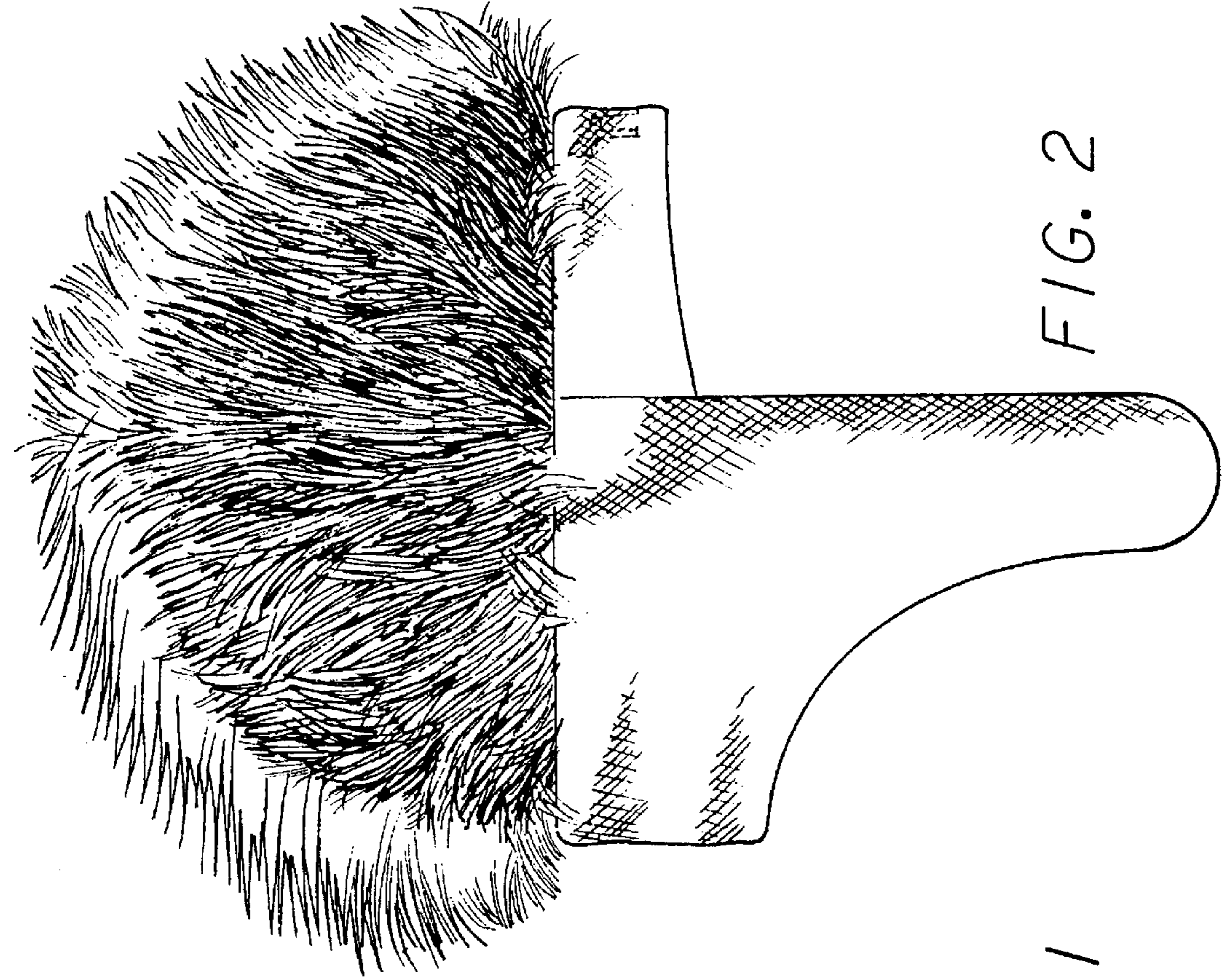

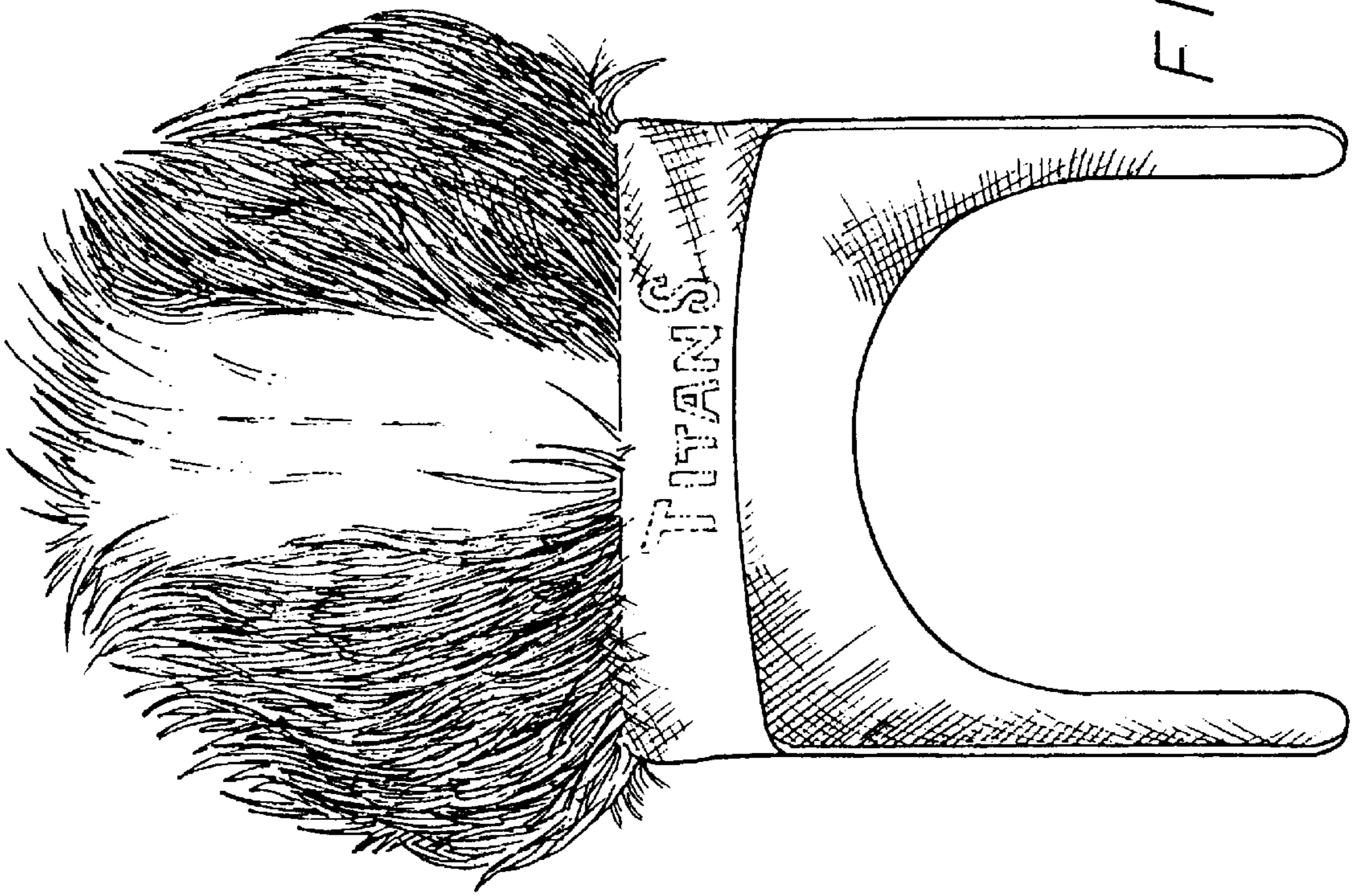

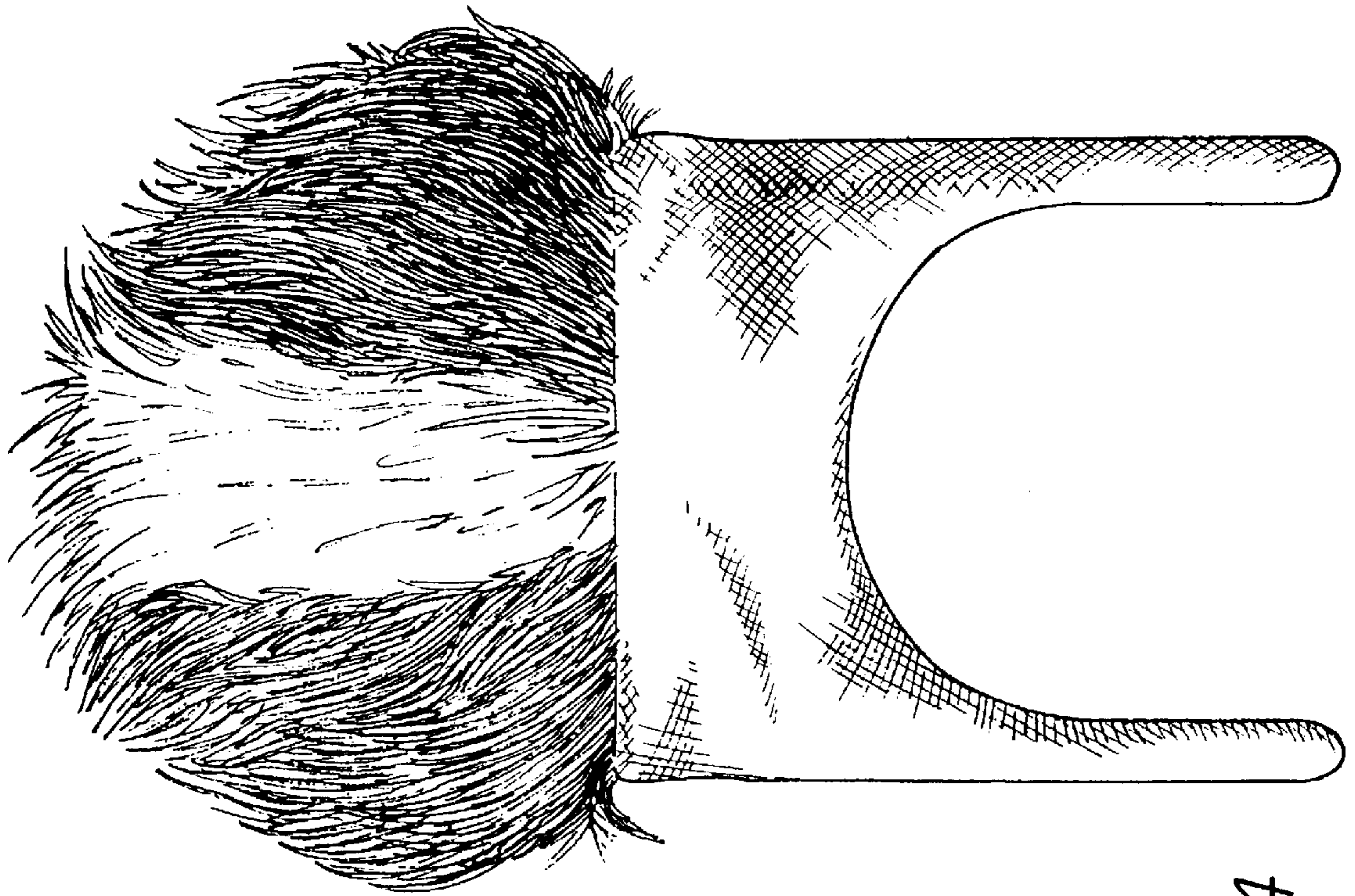

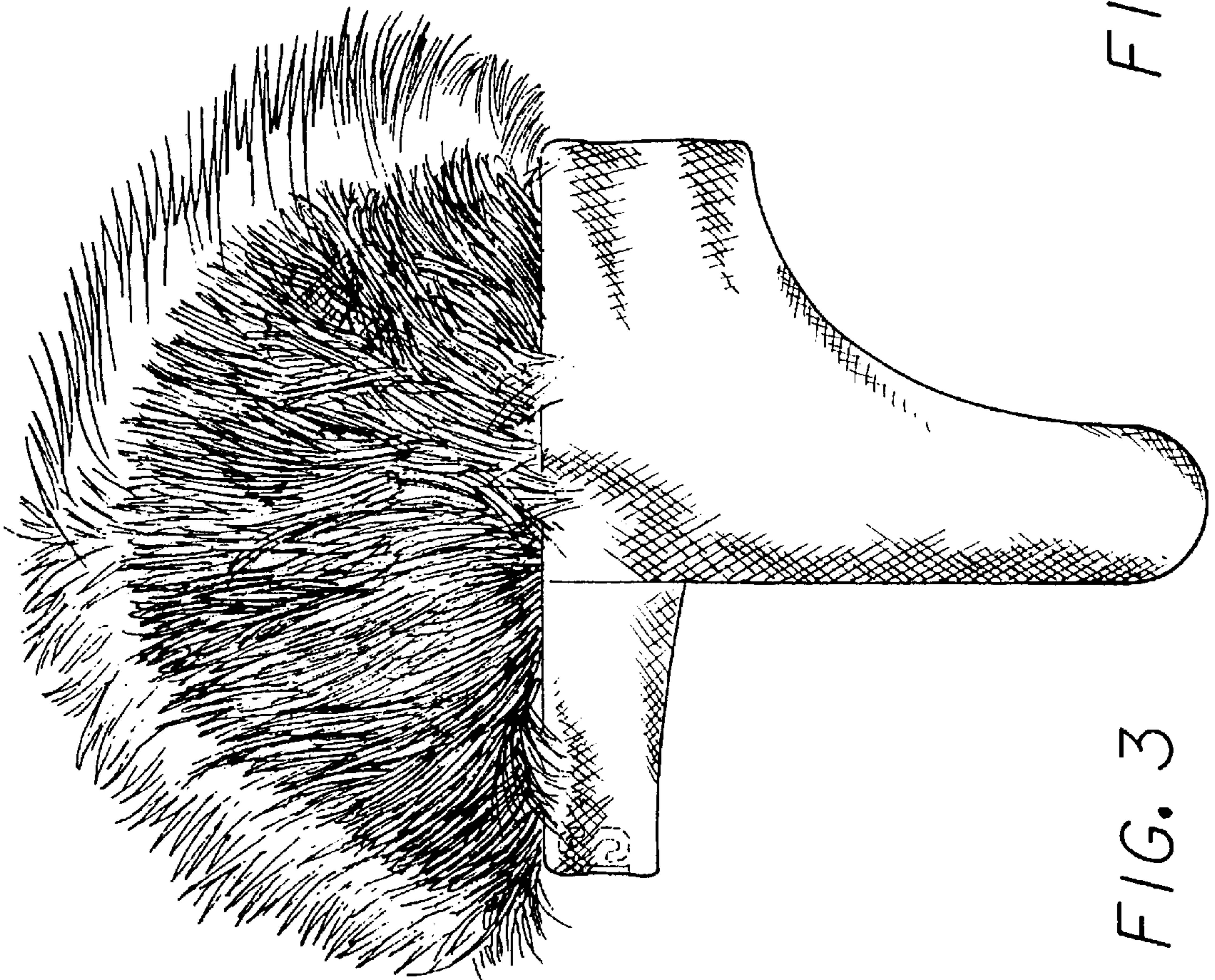

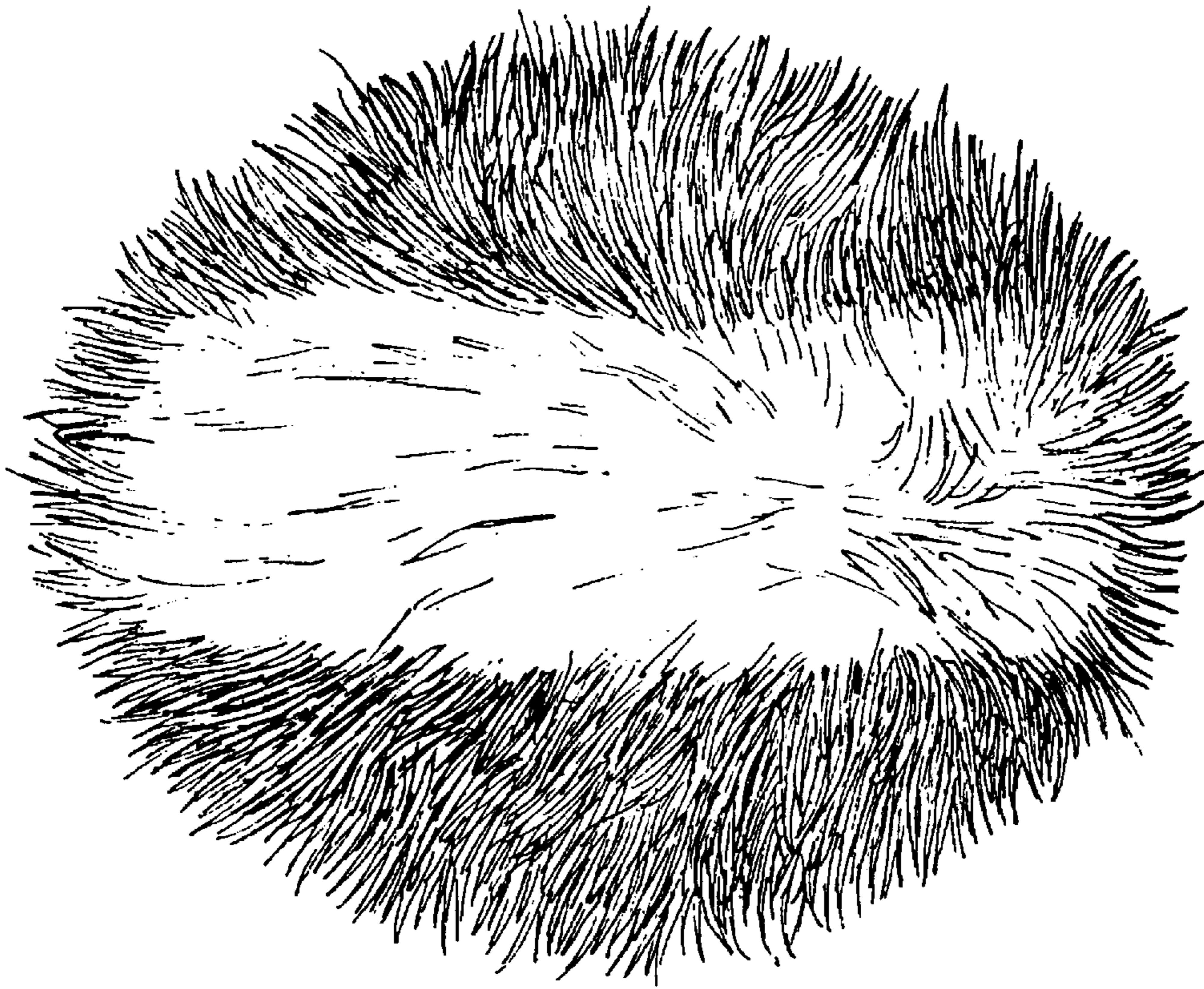

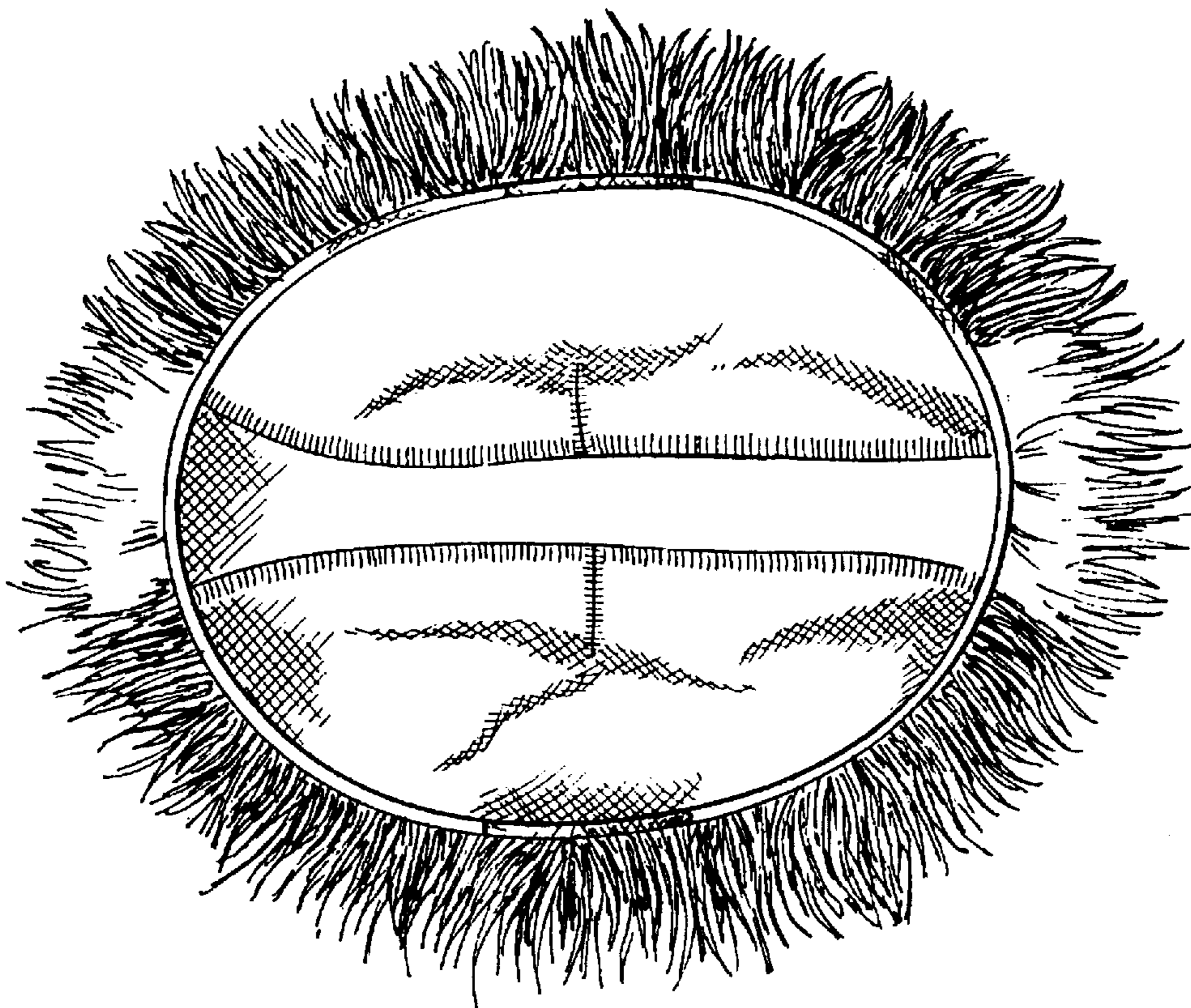

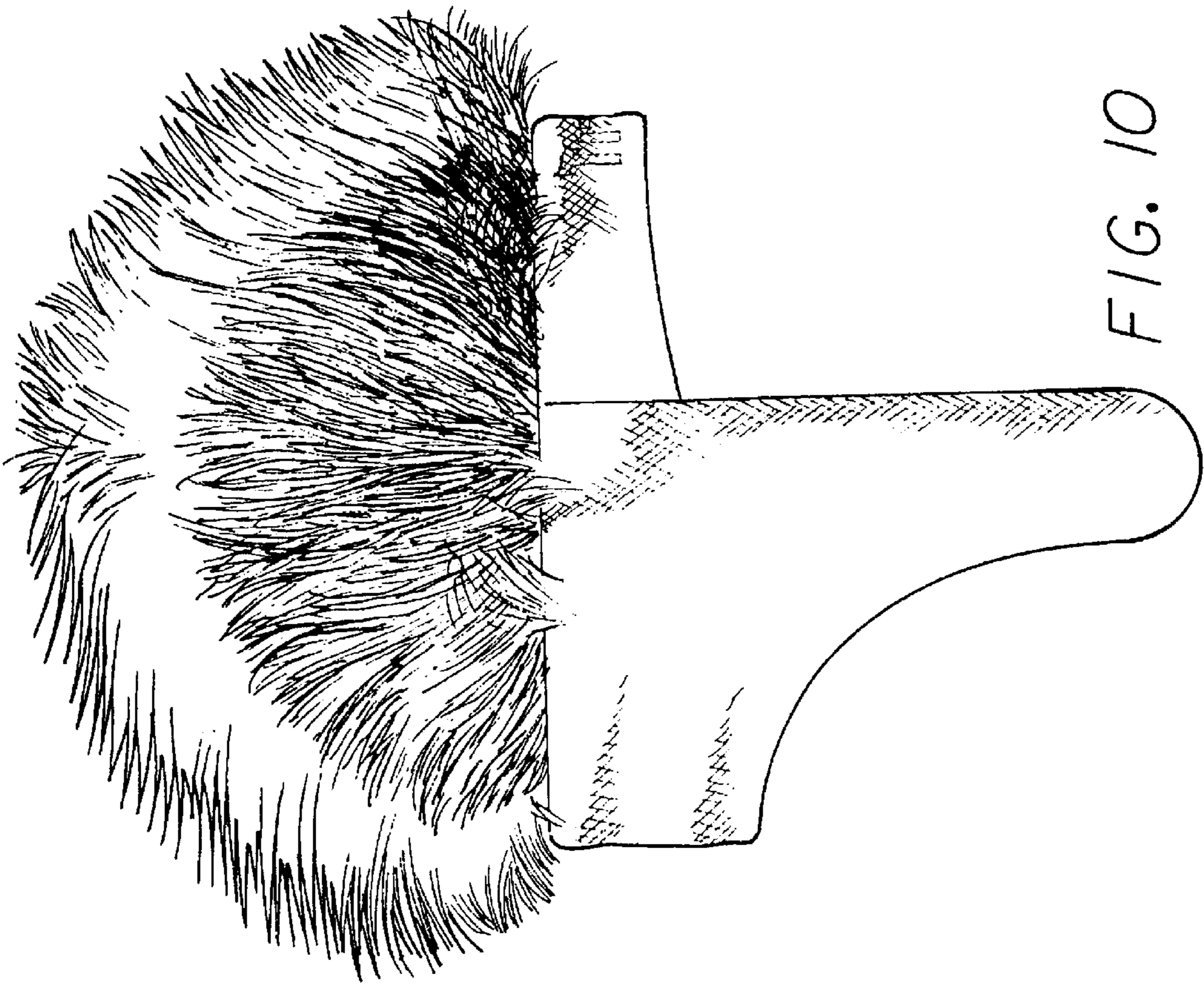

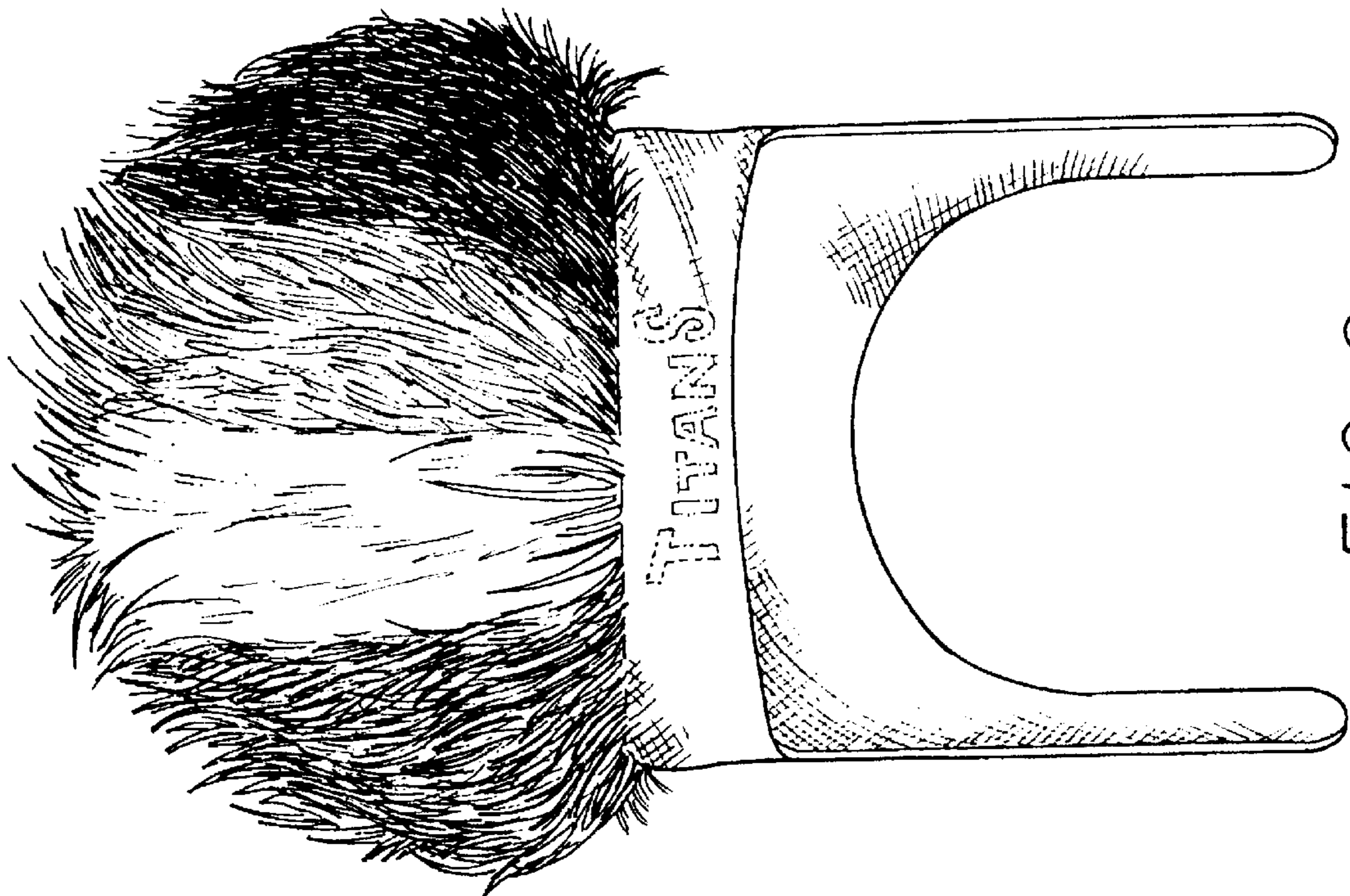

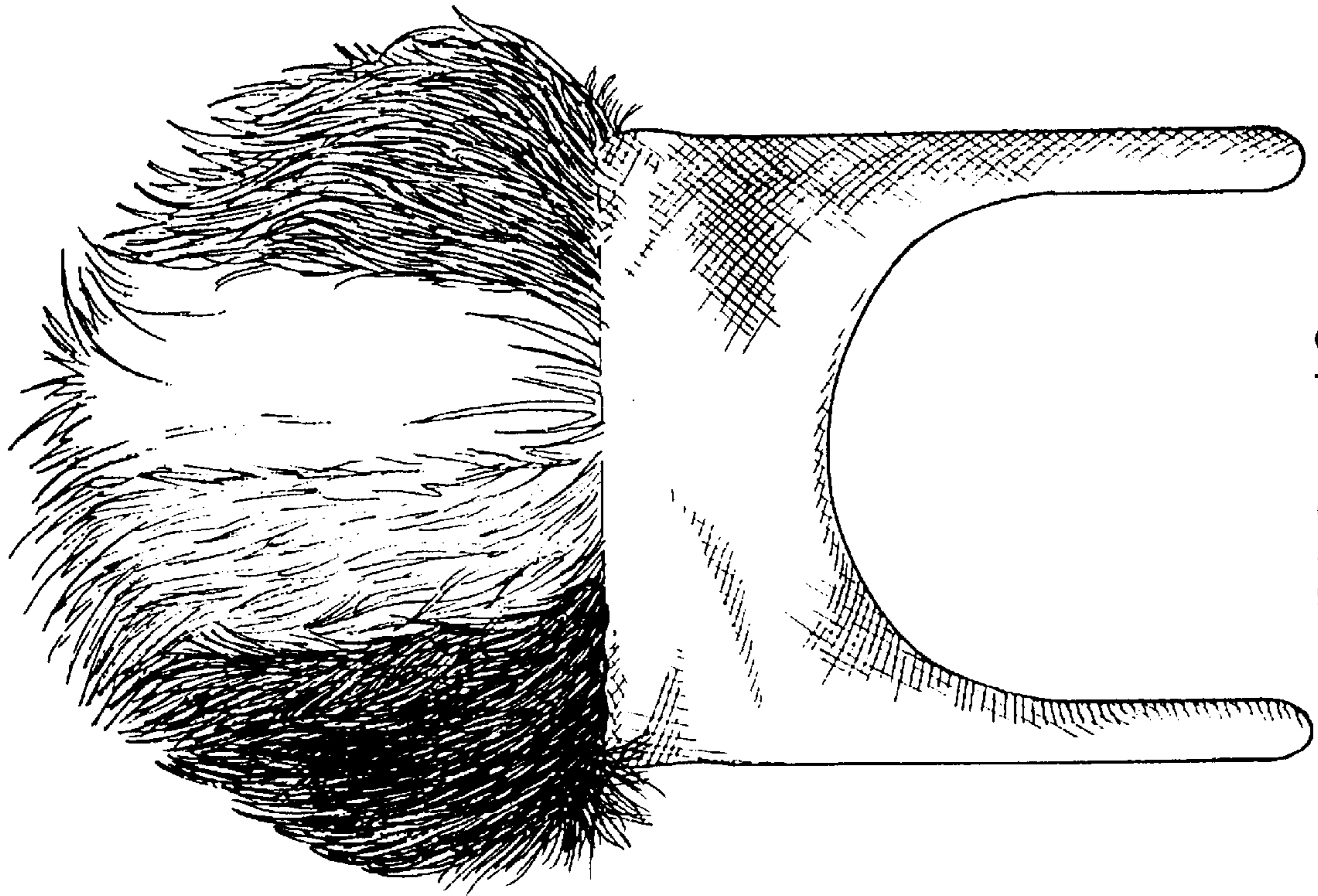

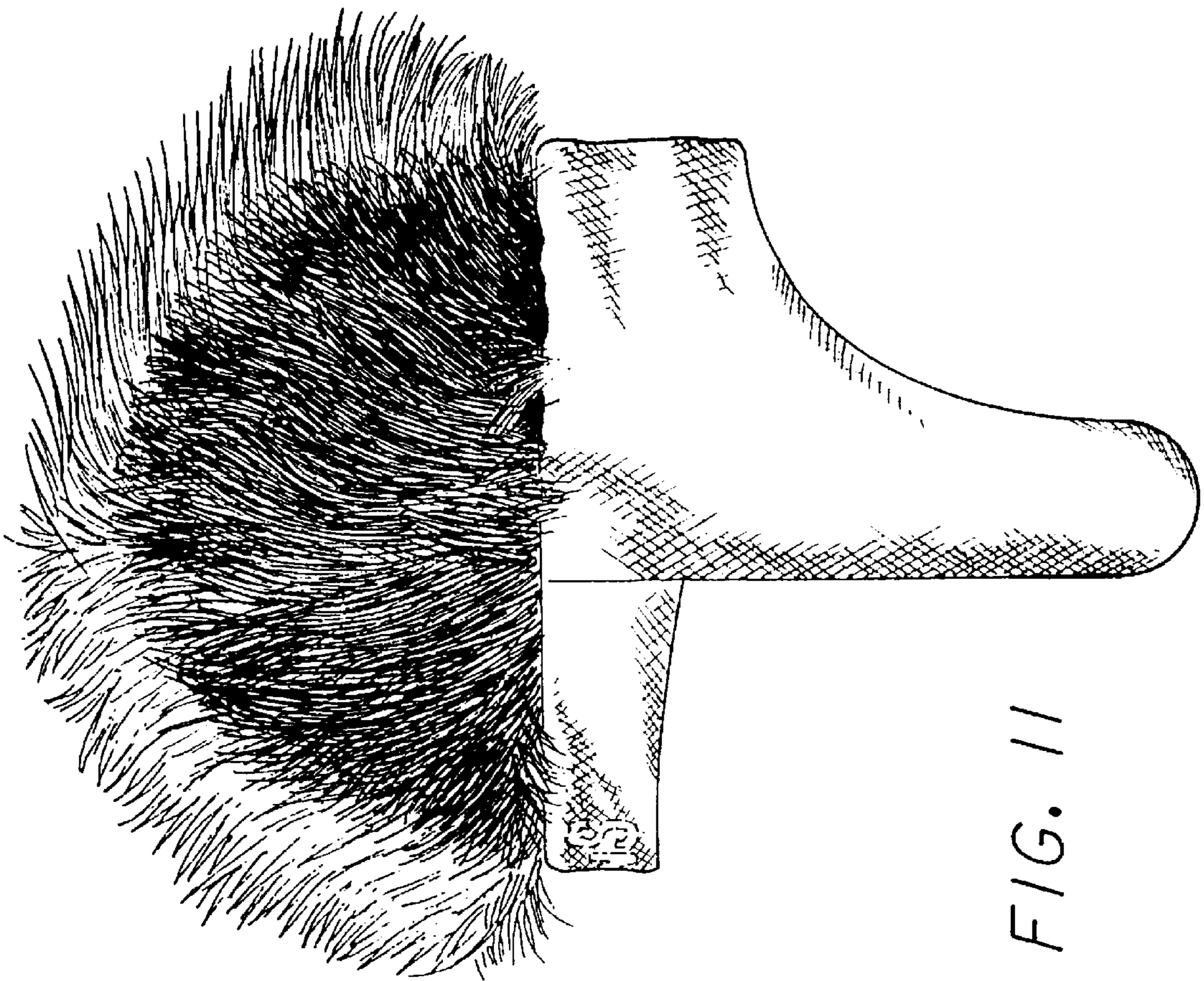

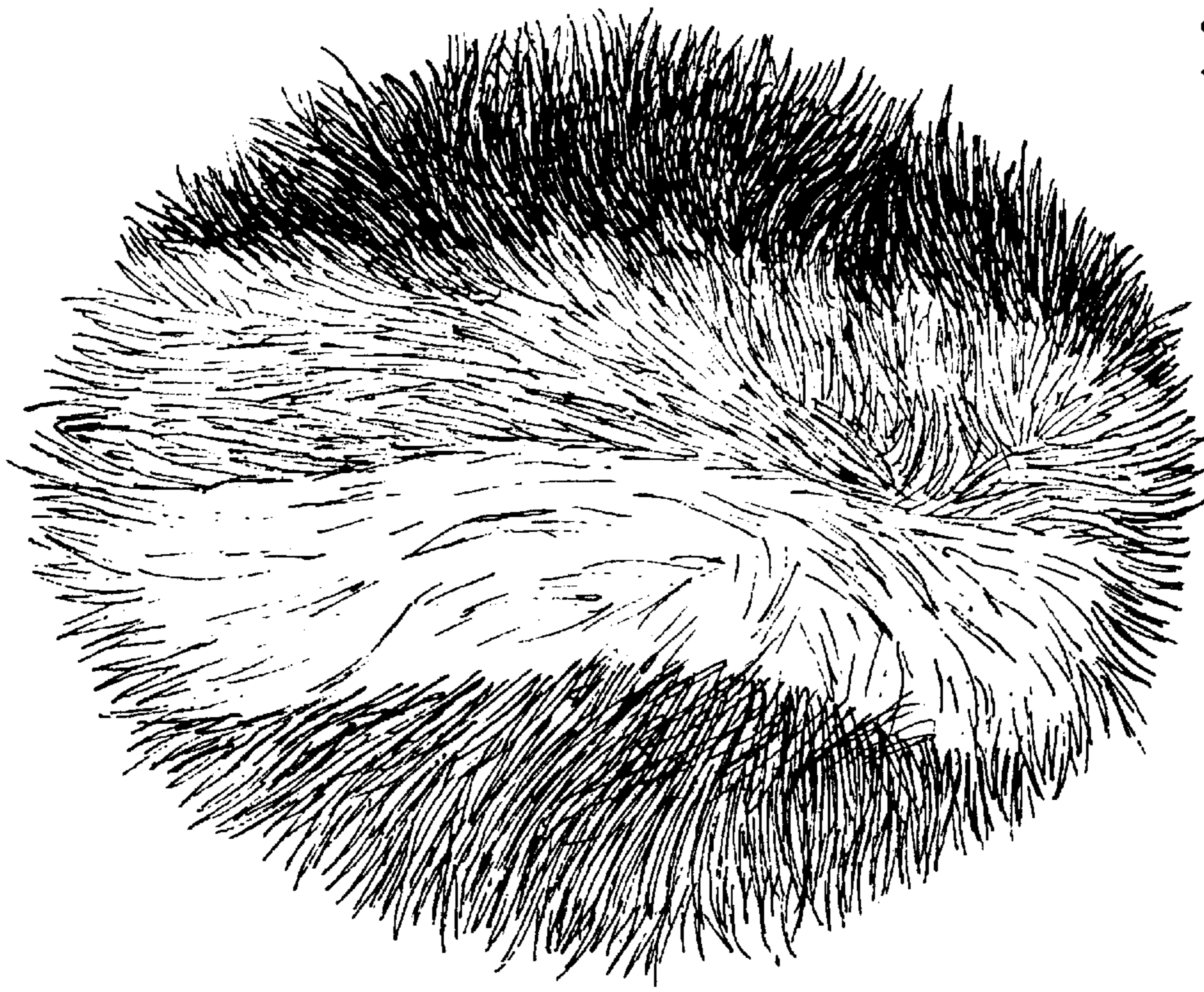

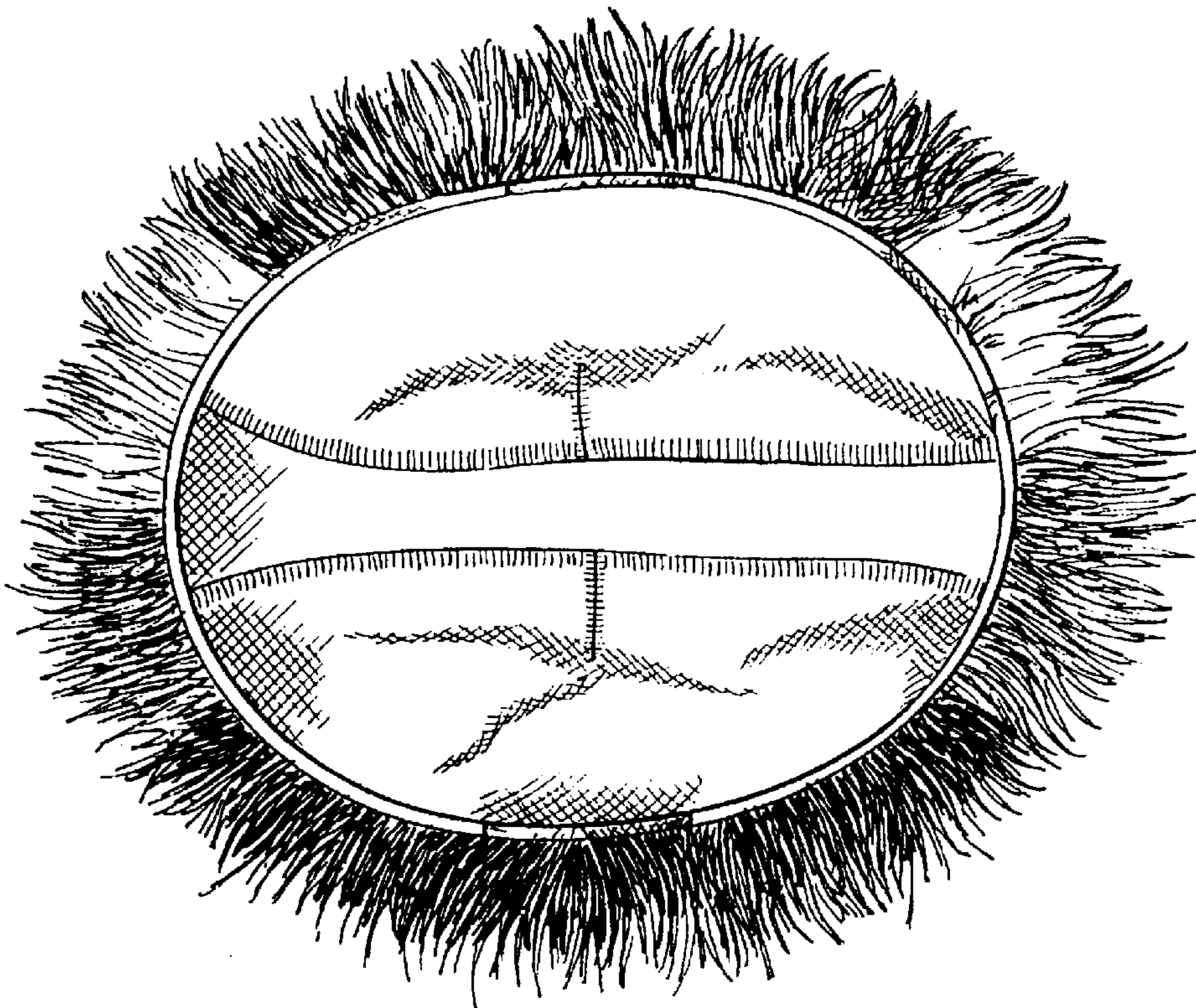

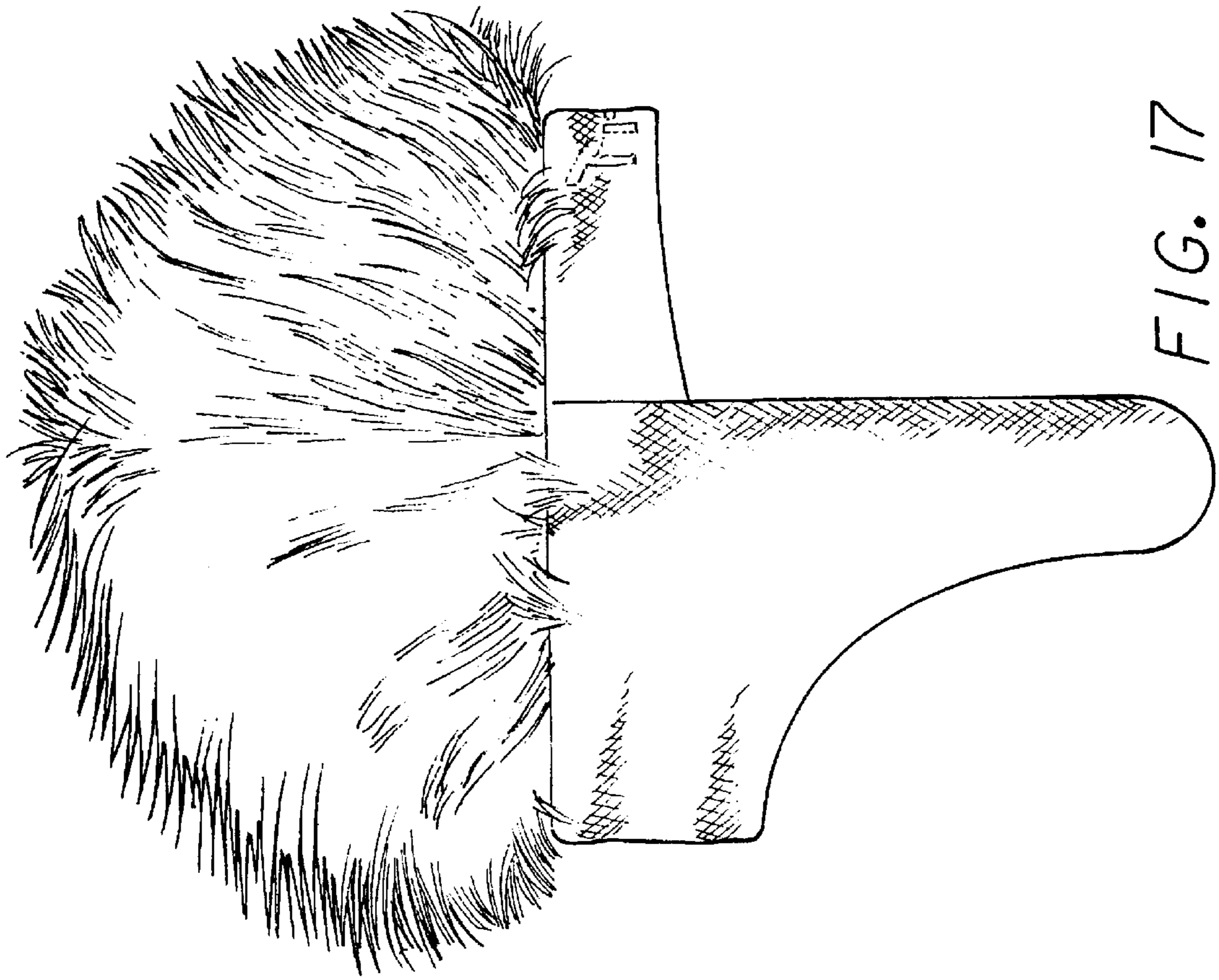

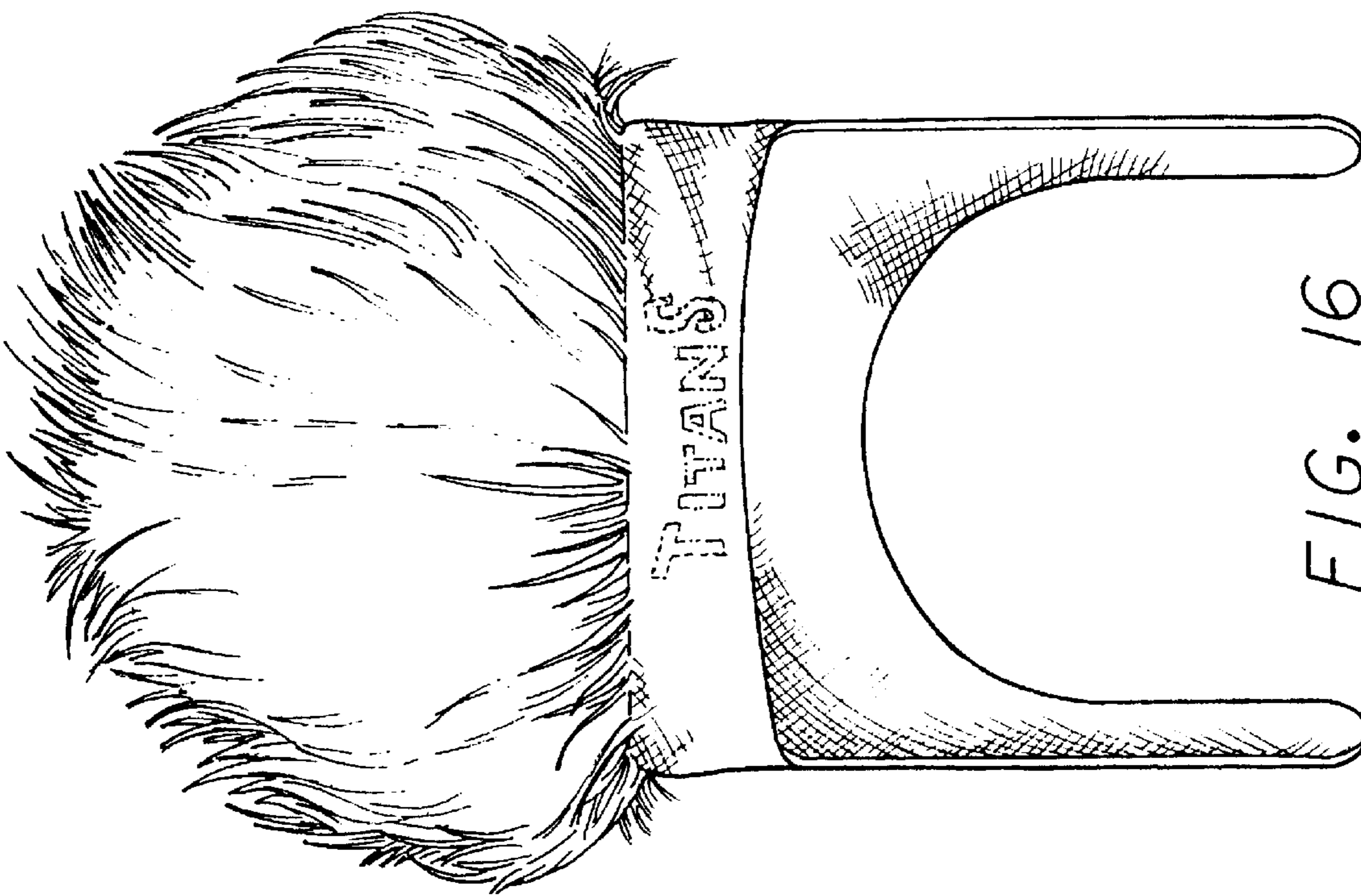

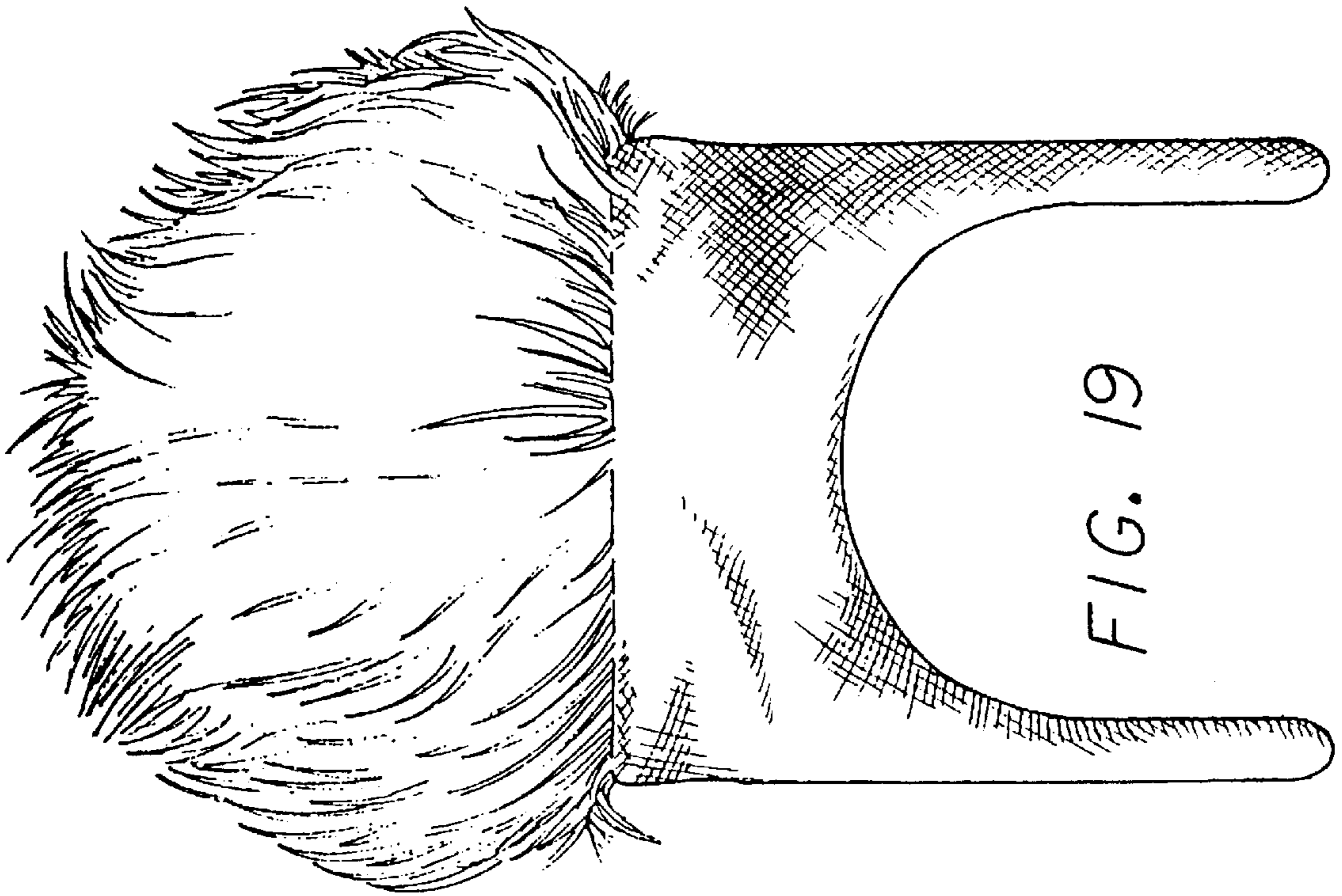

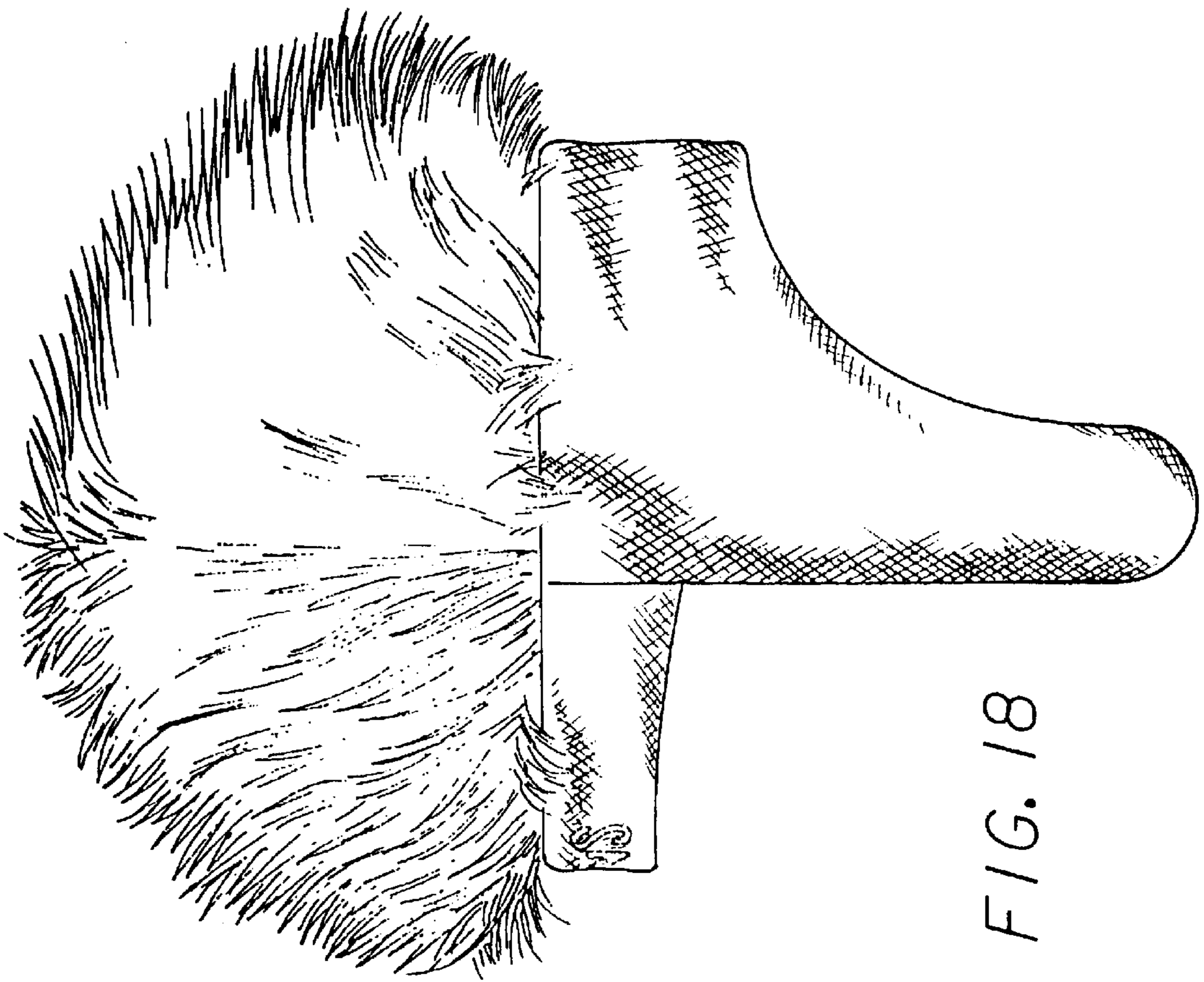

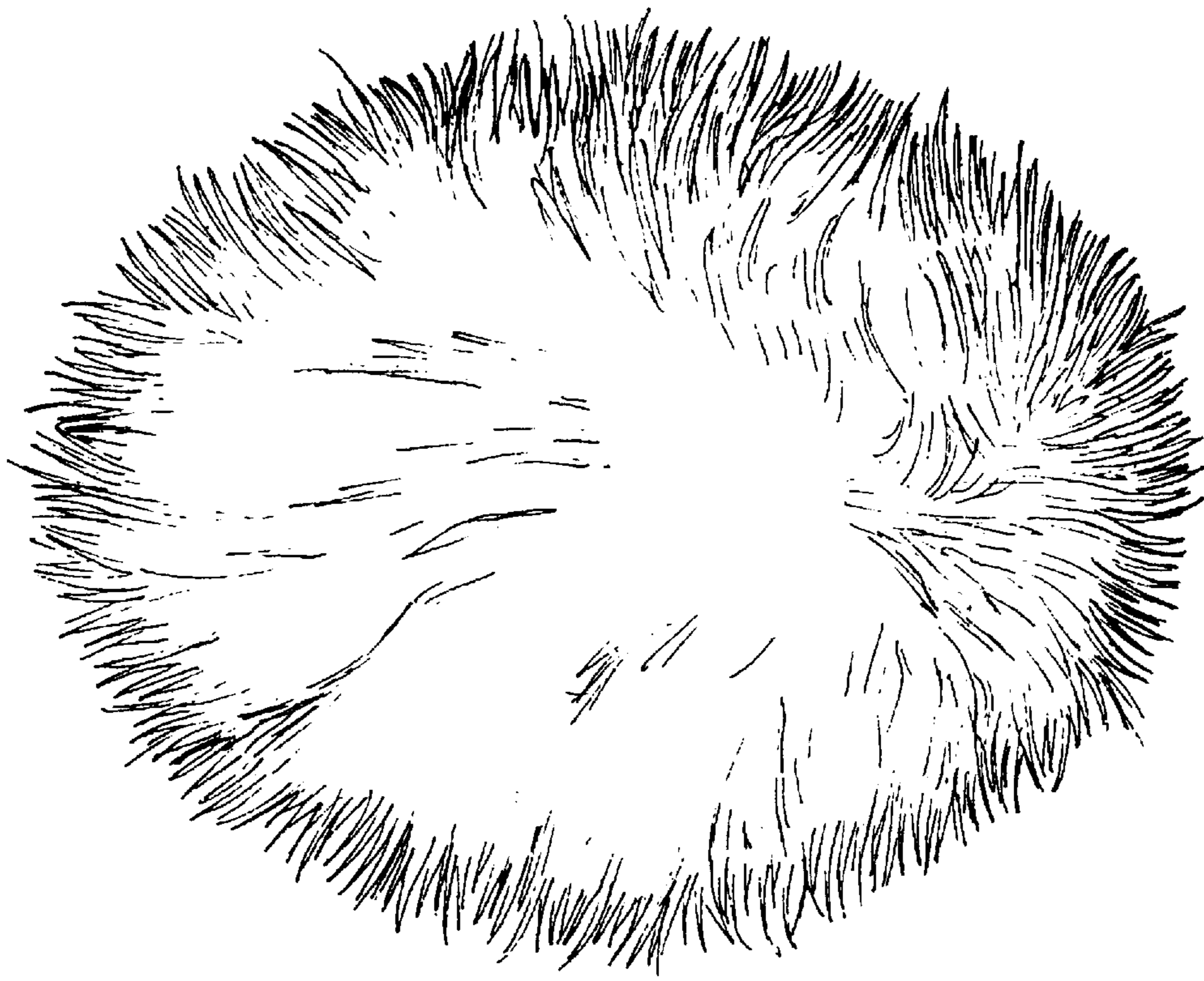

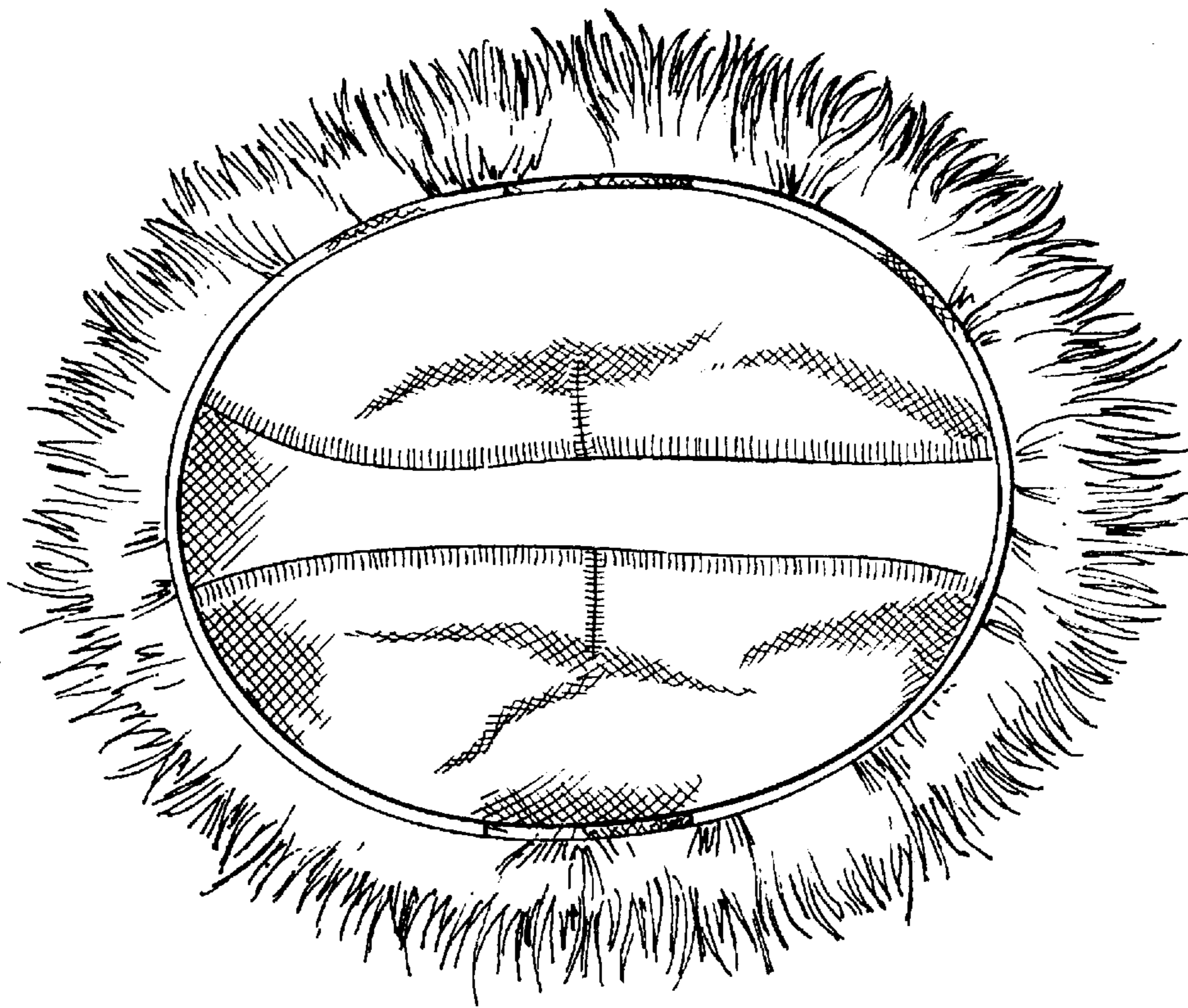
