(57) **CLAIM**

The ornamental design for a clutch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the clutch in a folded configuration with a broken line representation of a clasp forming no part of the claimed design; FIG. 2 is a front elevational view thereof with a broken line representation of the clasp forming no part of the claimed design;

FIG. 3 is a right side elevational view thereof with a broken line representation of the clasp and a connector forming no part of the claimed design;

FIG. 4 is a top plan view thereof with a broken line representation of the clasp forming no part of the claimed design;

FIG. 5 is a bottom plan view thereof with a broken line representation of the clasp and the connector forming no part of the claimed design;

FIG. 6 is a perspective view of the clutch in an open configuration with a broken line representation of the connector, keys and card slots forming no part of the claimed design;

FIG. 7 is a front elevational view thereof with a broken line representation of the connector, the keys and the card slots forming no part of the claimed design;

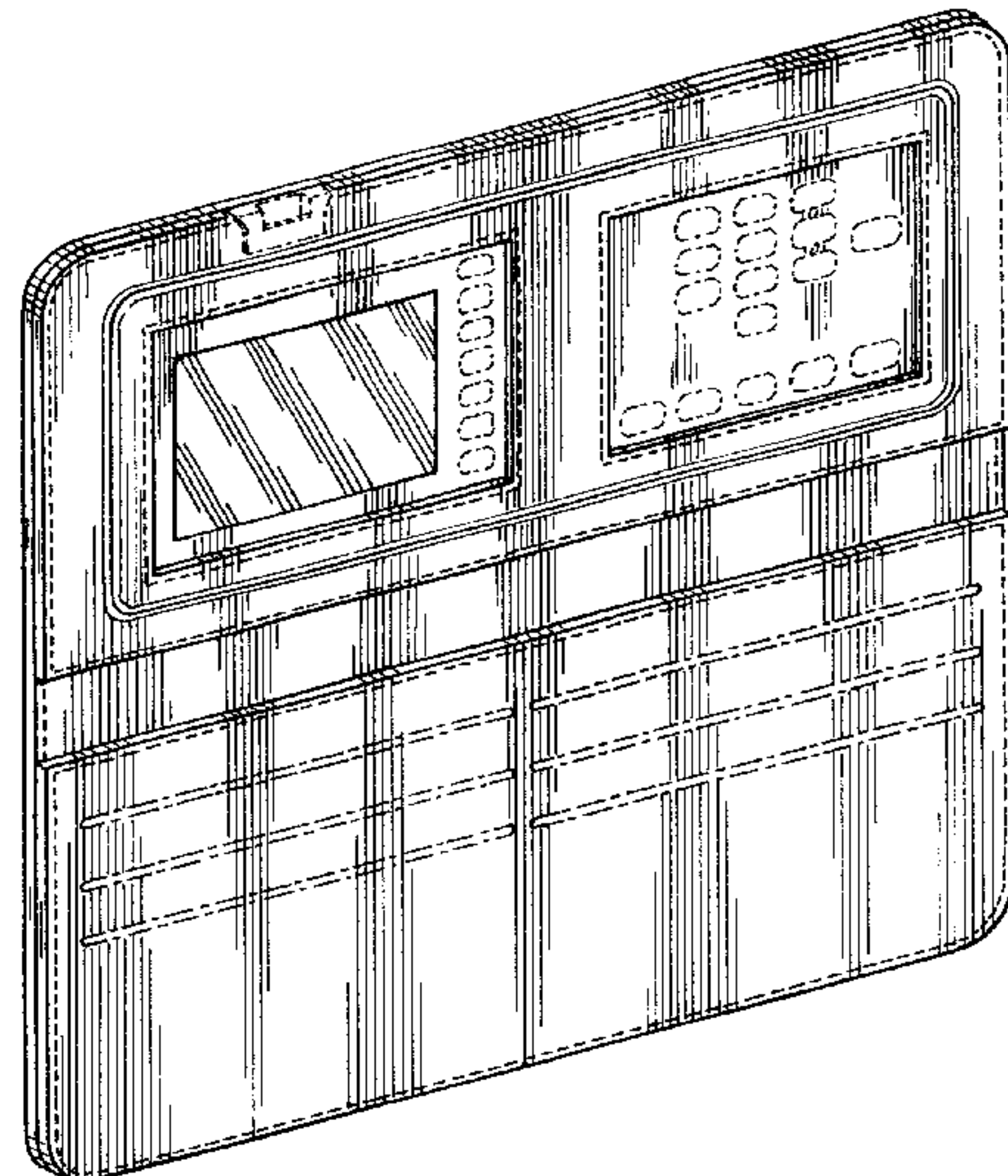
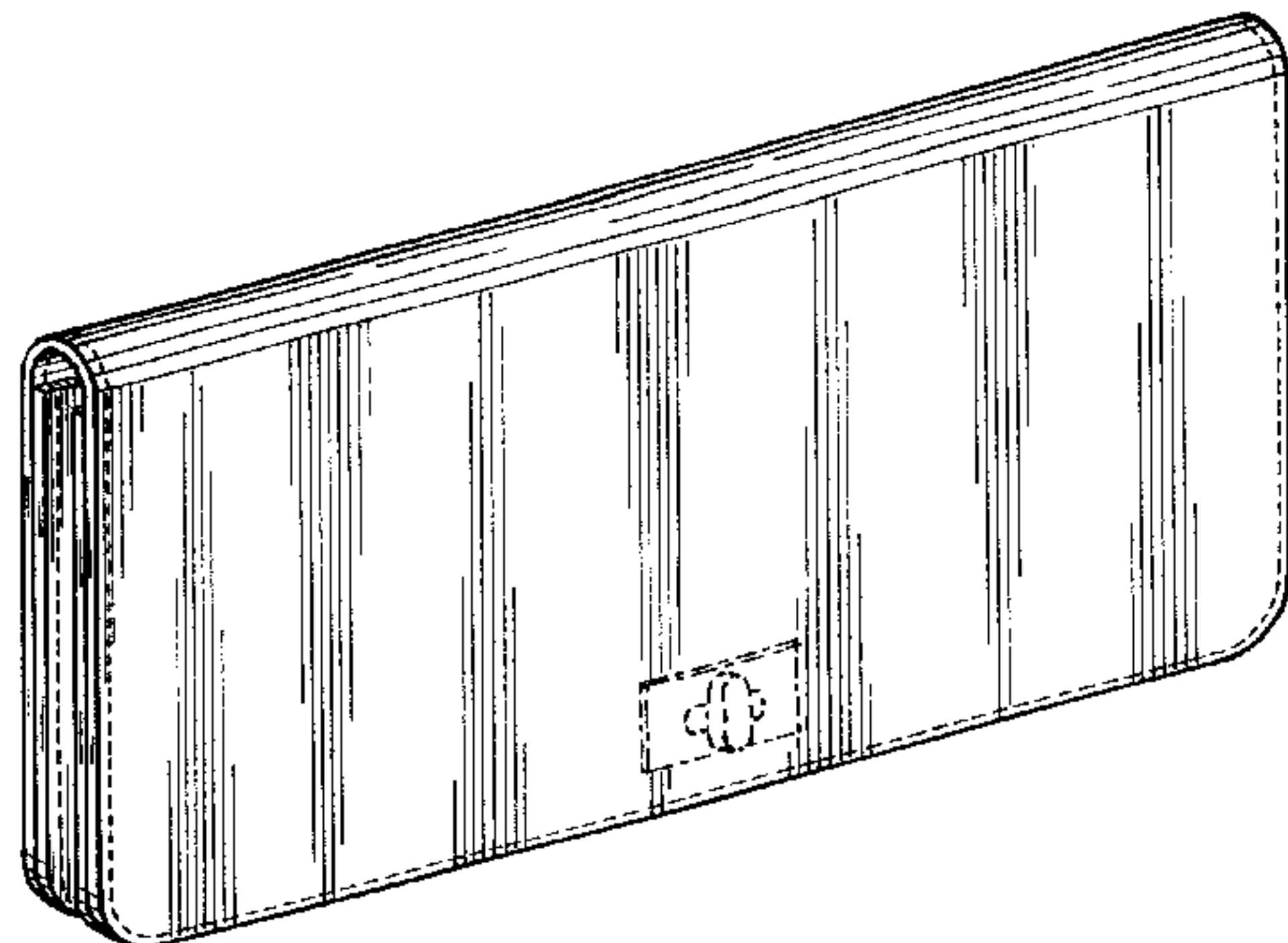
FIG. 8 is a right side elevational view thereof with a broken line representation of the connector and the clasp forming no part of the claimed design;

FIG. 9 is a top plan view thereof with a broken line representation of the connector and the clasp forming no part of the claimed design;

FIG. 10 is a bottom plan view thereof with a broken line representation of the clasp forming no part of the claimed design; and,

FIG. 11 is a rear elevational view thereof with a broken line representation of the clasp forming no part of the claimed design.

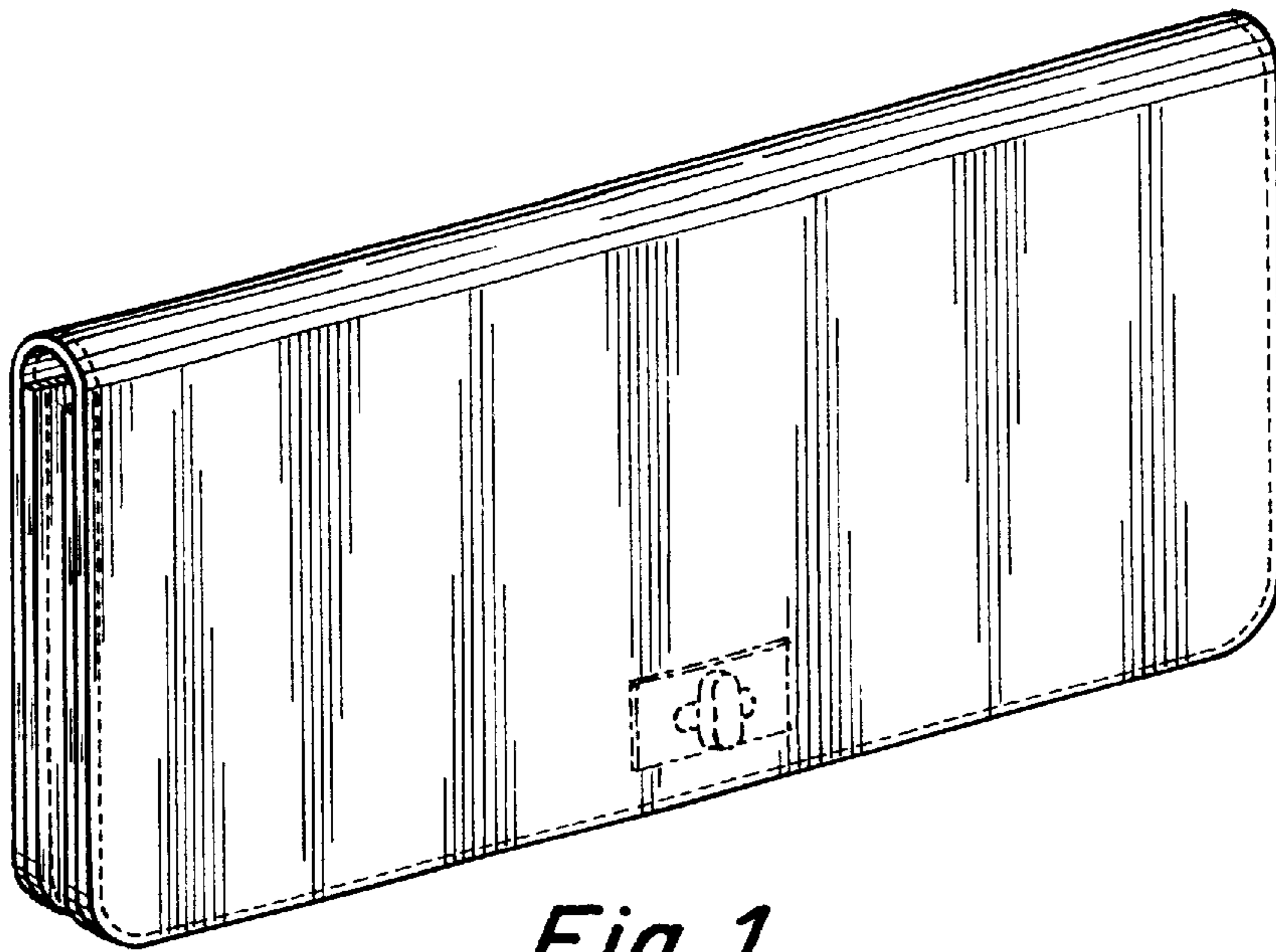

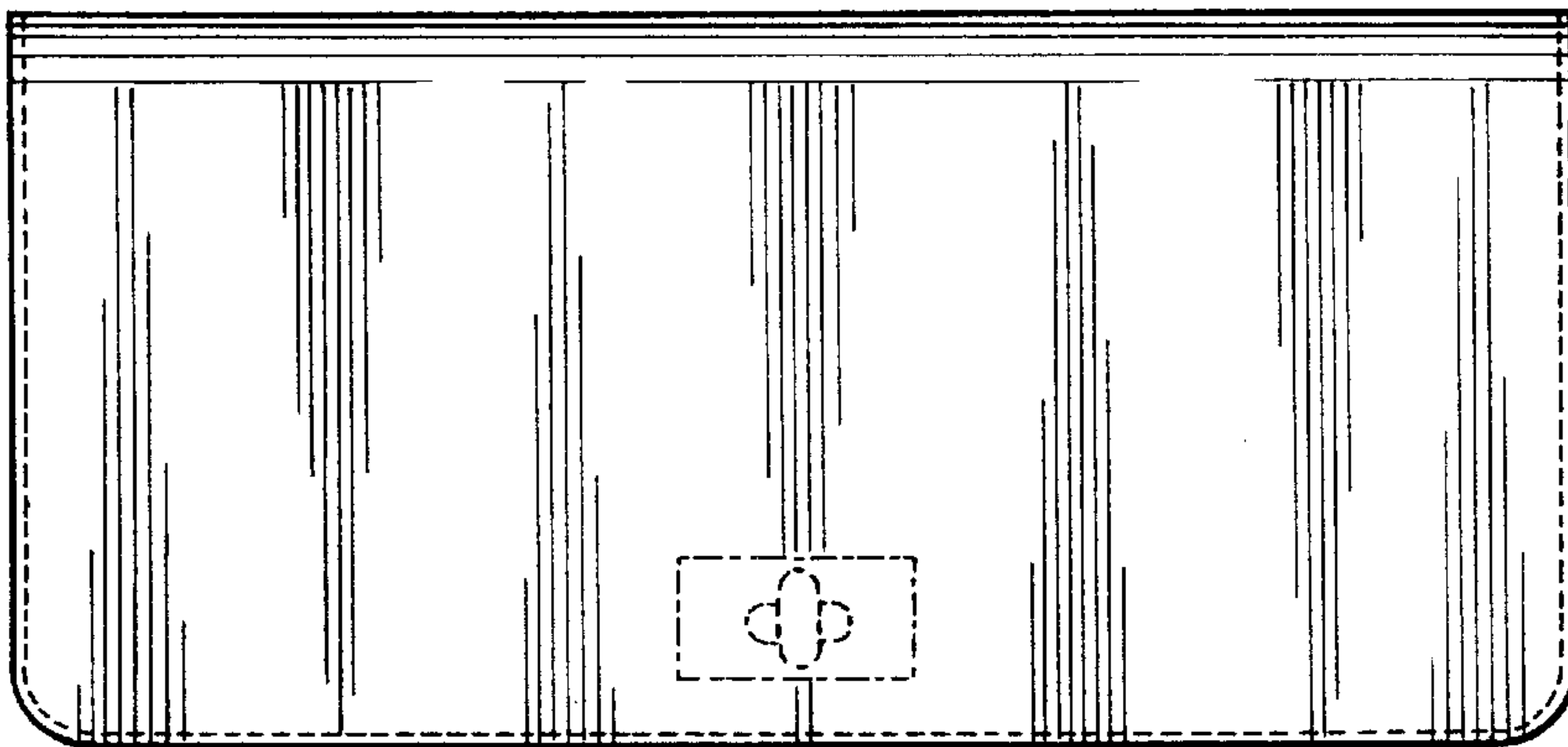

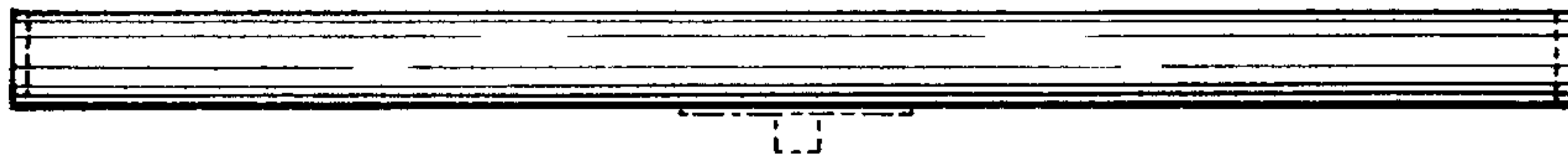

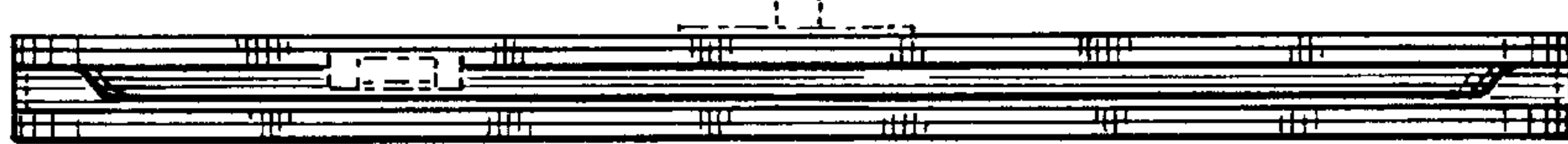

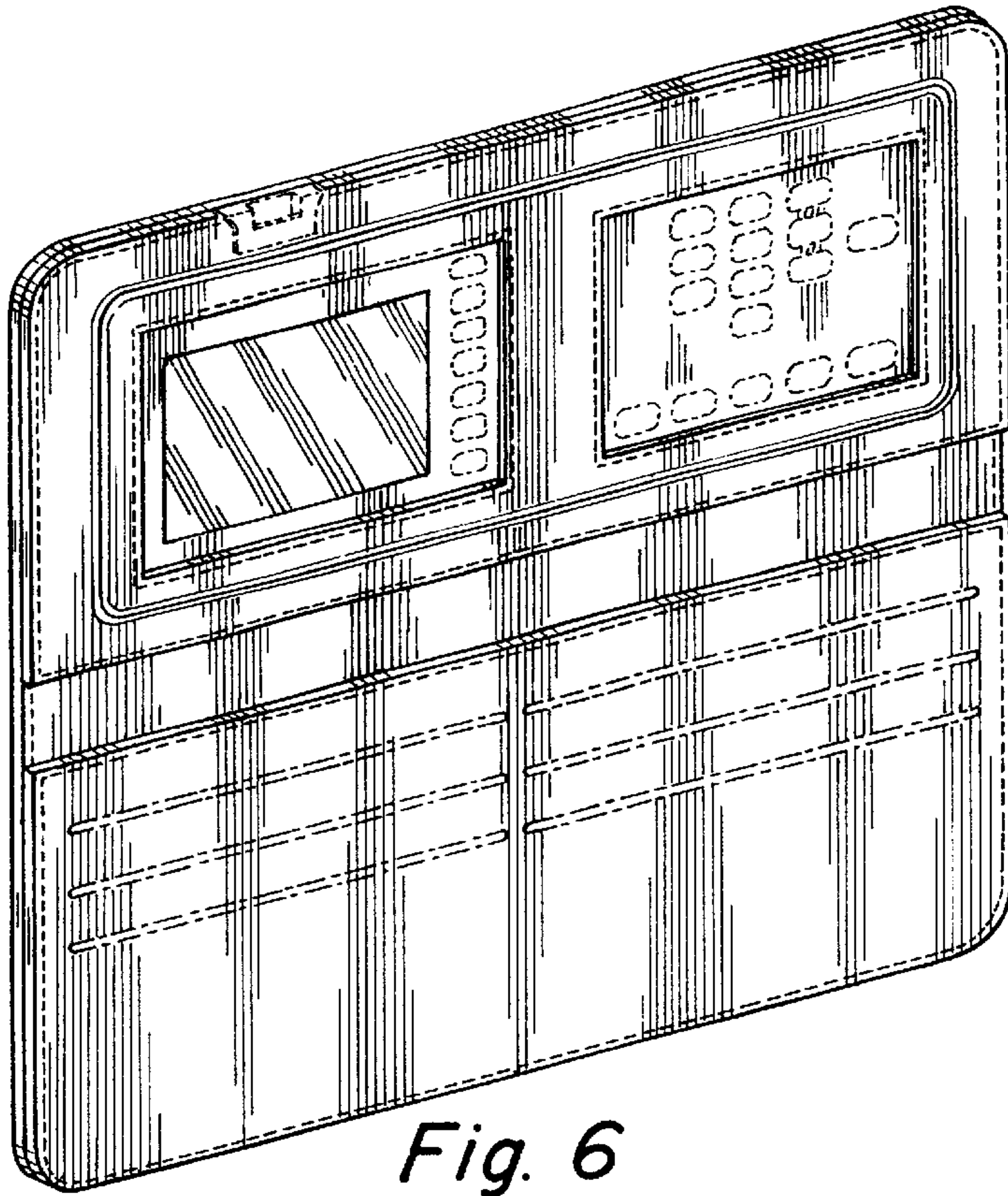

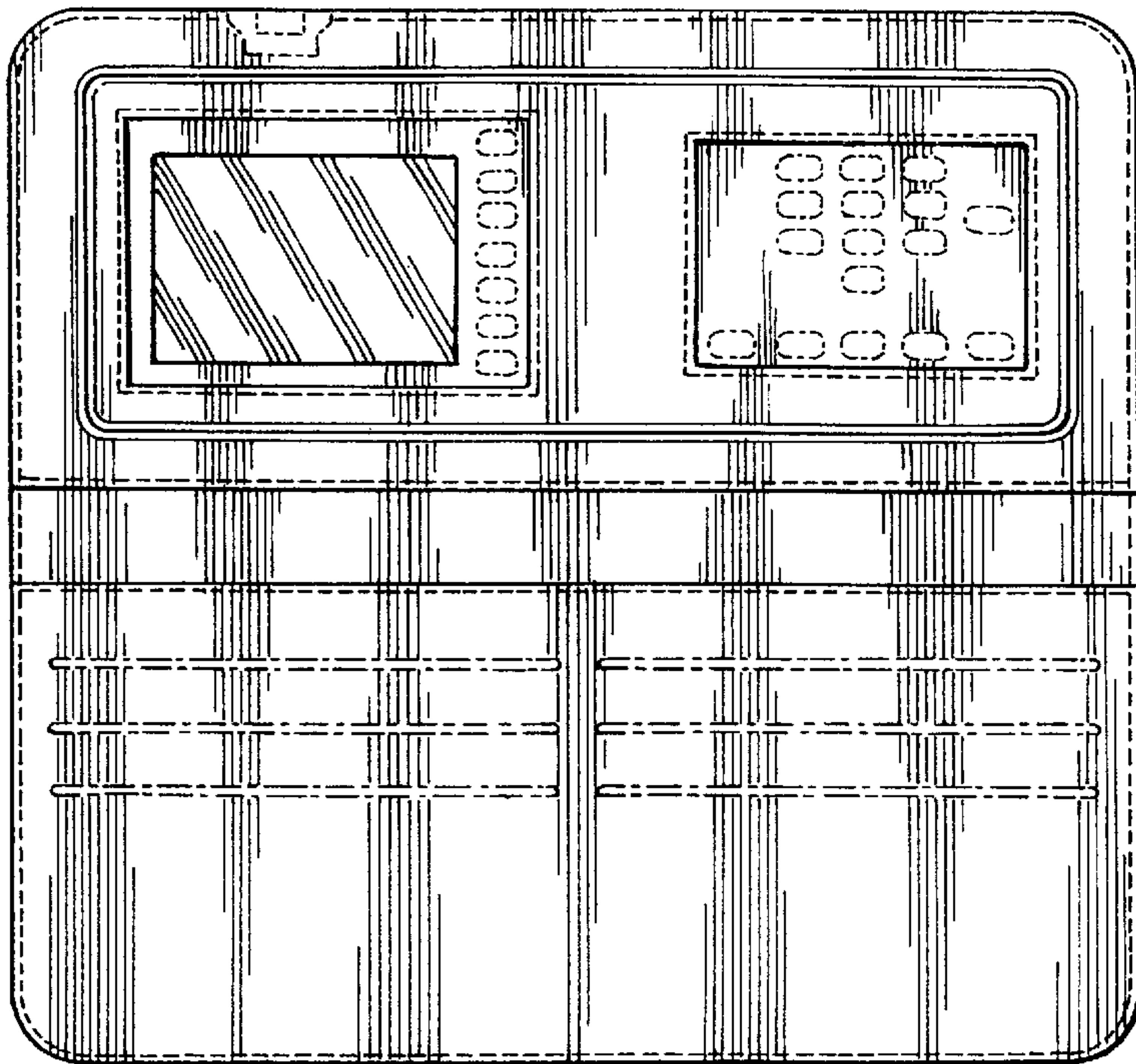

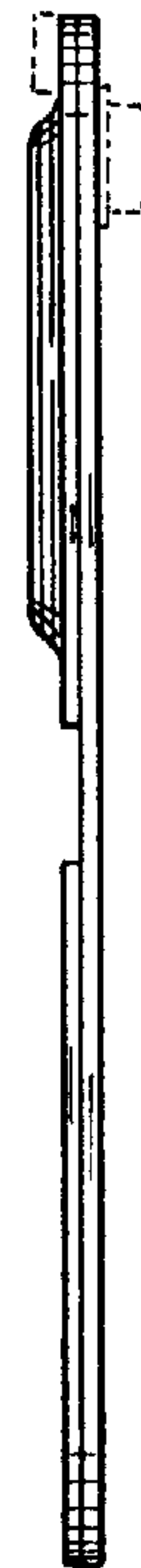

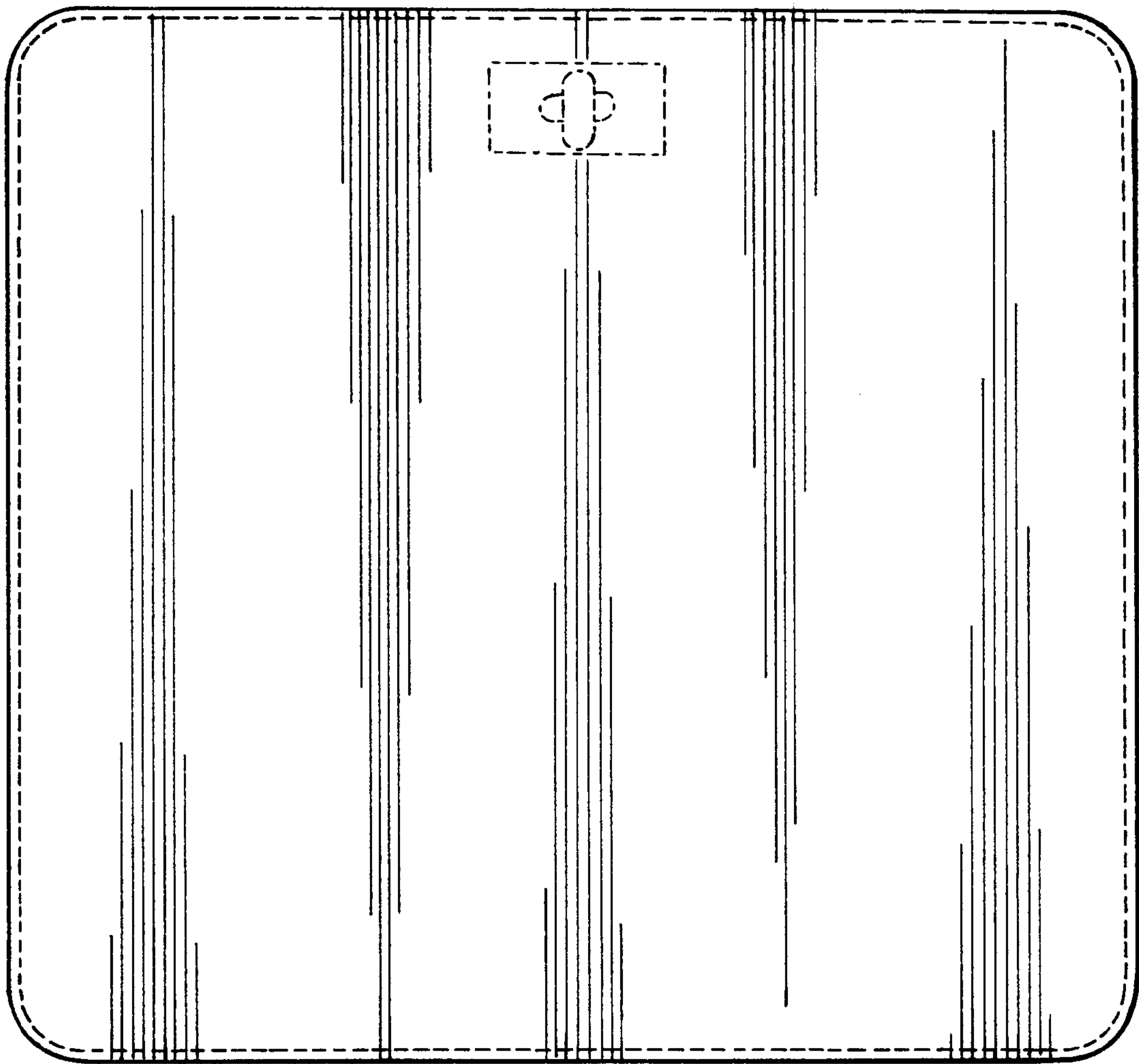
