FIG. 1 is a perspective view of a beverage bottle showing the new design;

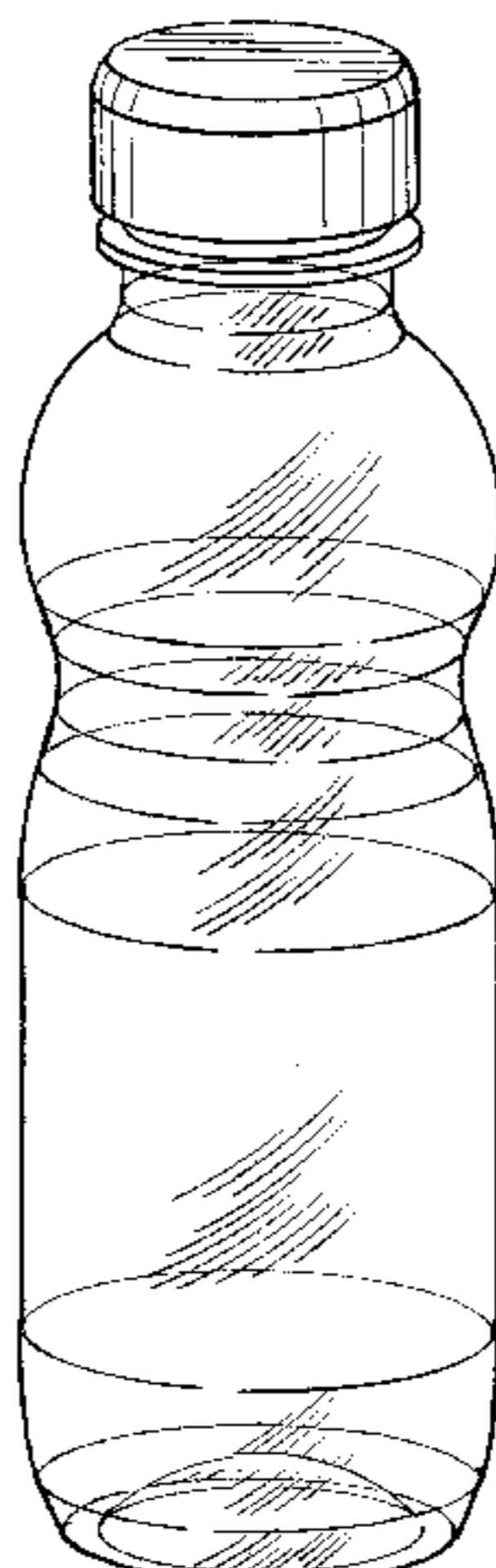
FIG. 2 is an elevational view thereof;

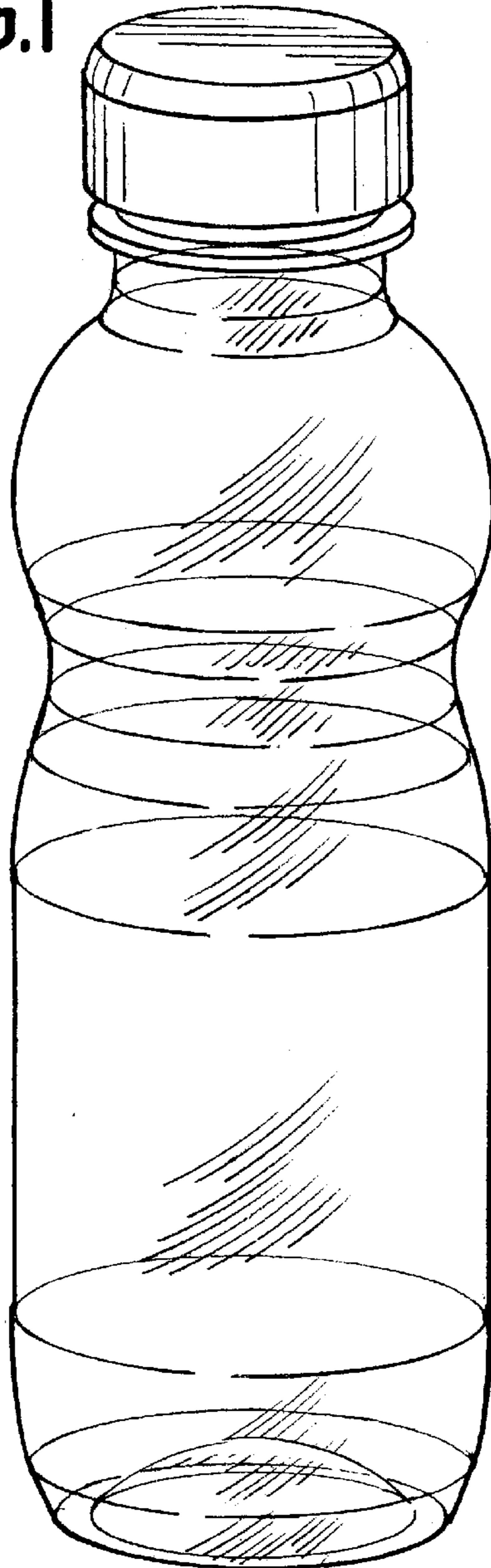

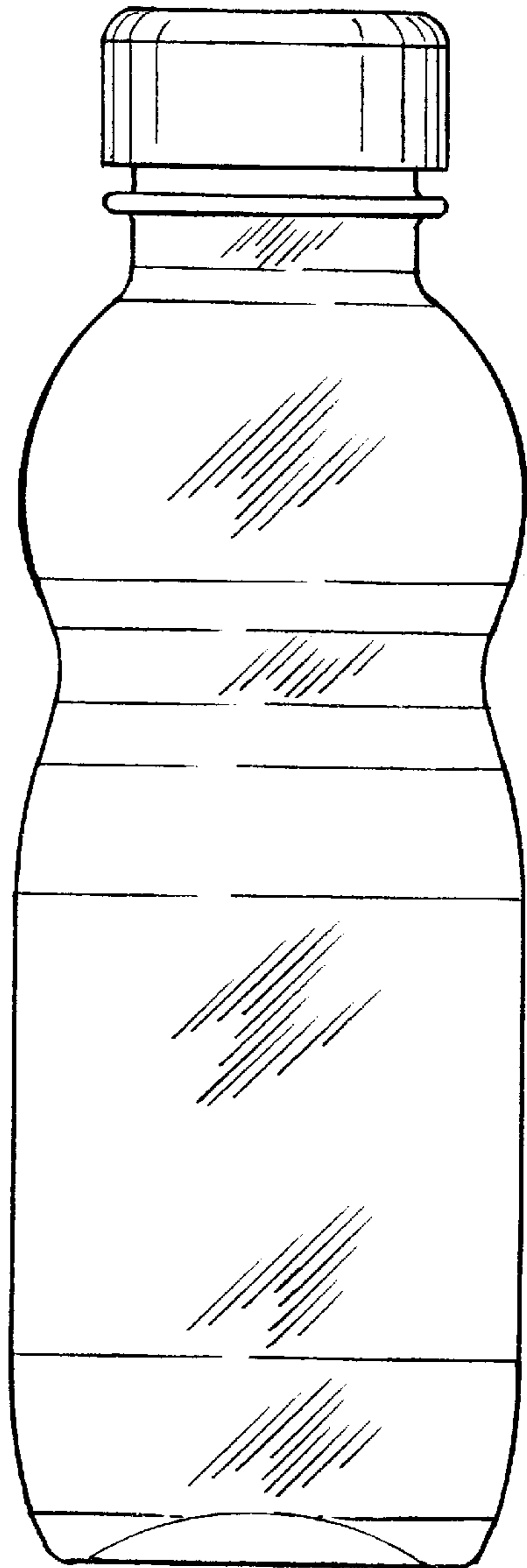

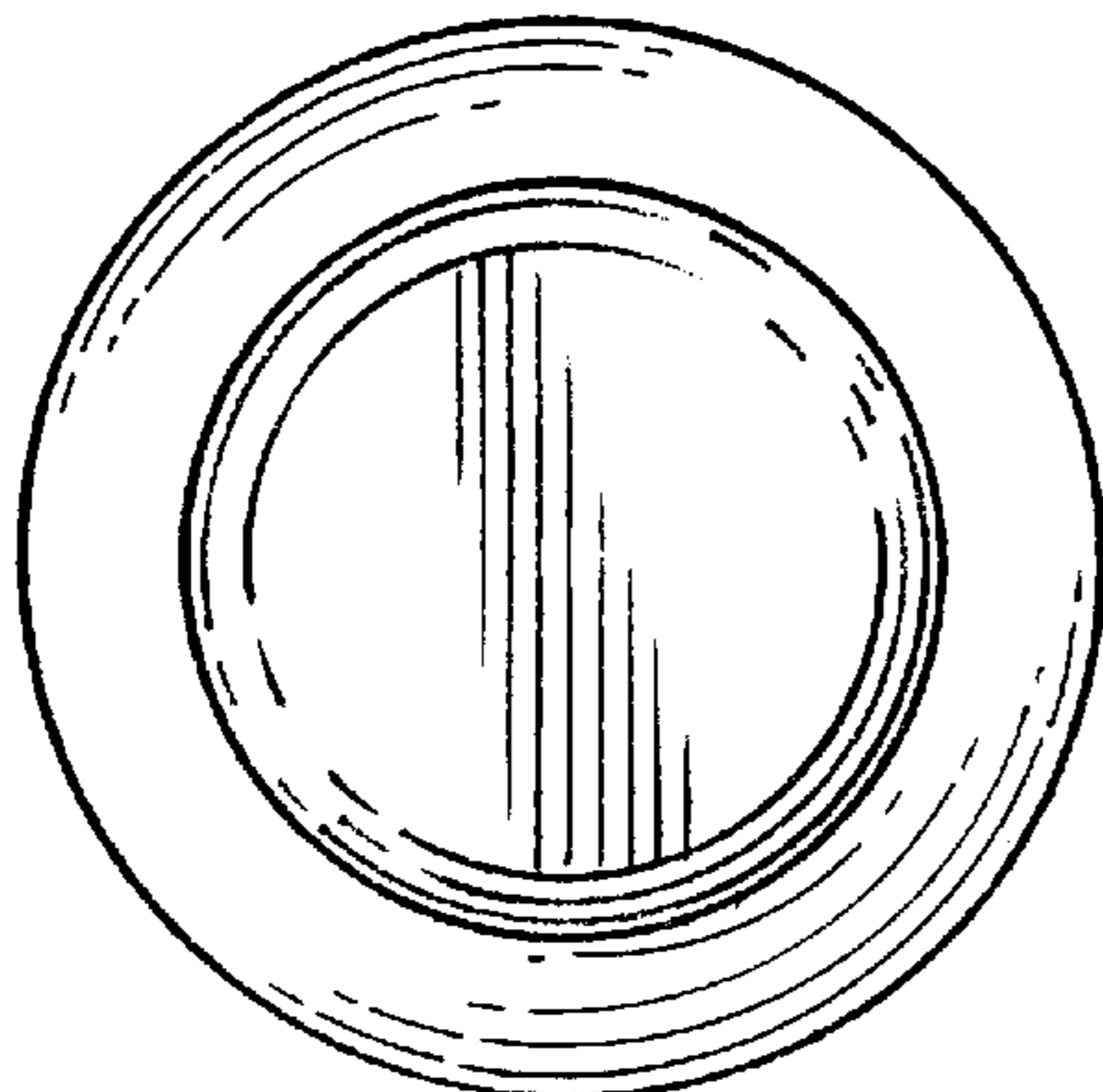
