(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a bottle showing my new design, the closure shown in dotted lines being for illustrative purposes only and not a part of the design;

FIG. 2 is a top plan view thereof, the closure shown in dotted lines being for illustrative purposes only and not a part of the design;

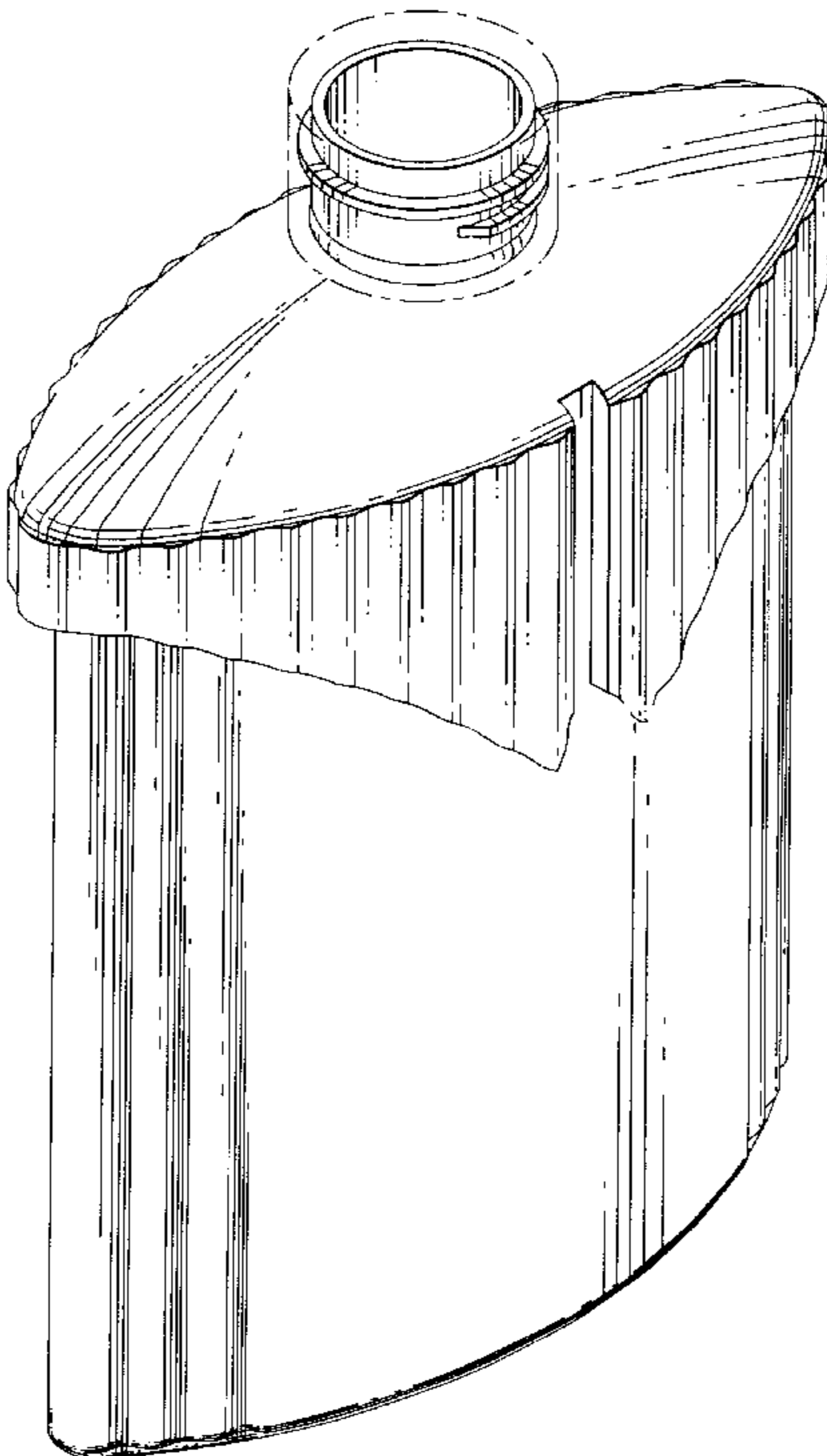
FIG. 3 is a bottom plan view thereof;

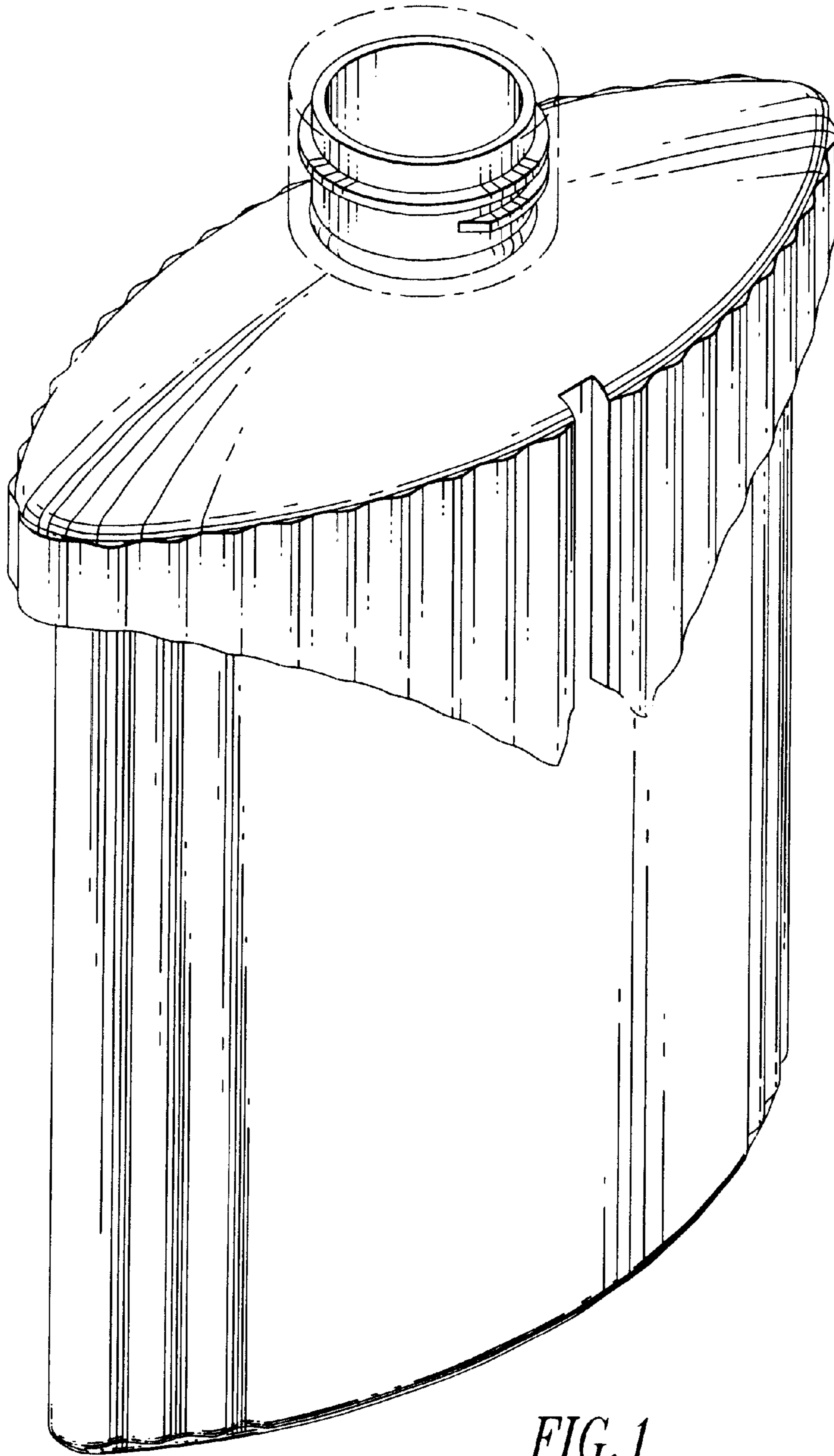
FIG. 4 is a front elevational view thereof, the closure shown in dotted lines being for illustrative purposes only and not a part of the design;

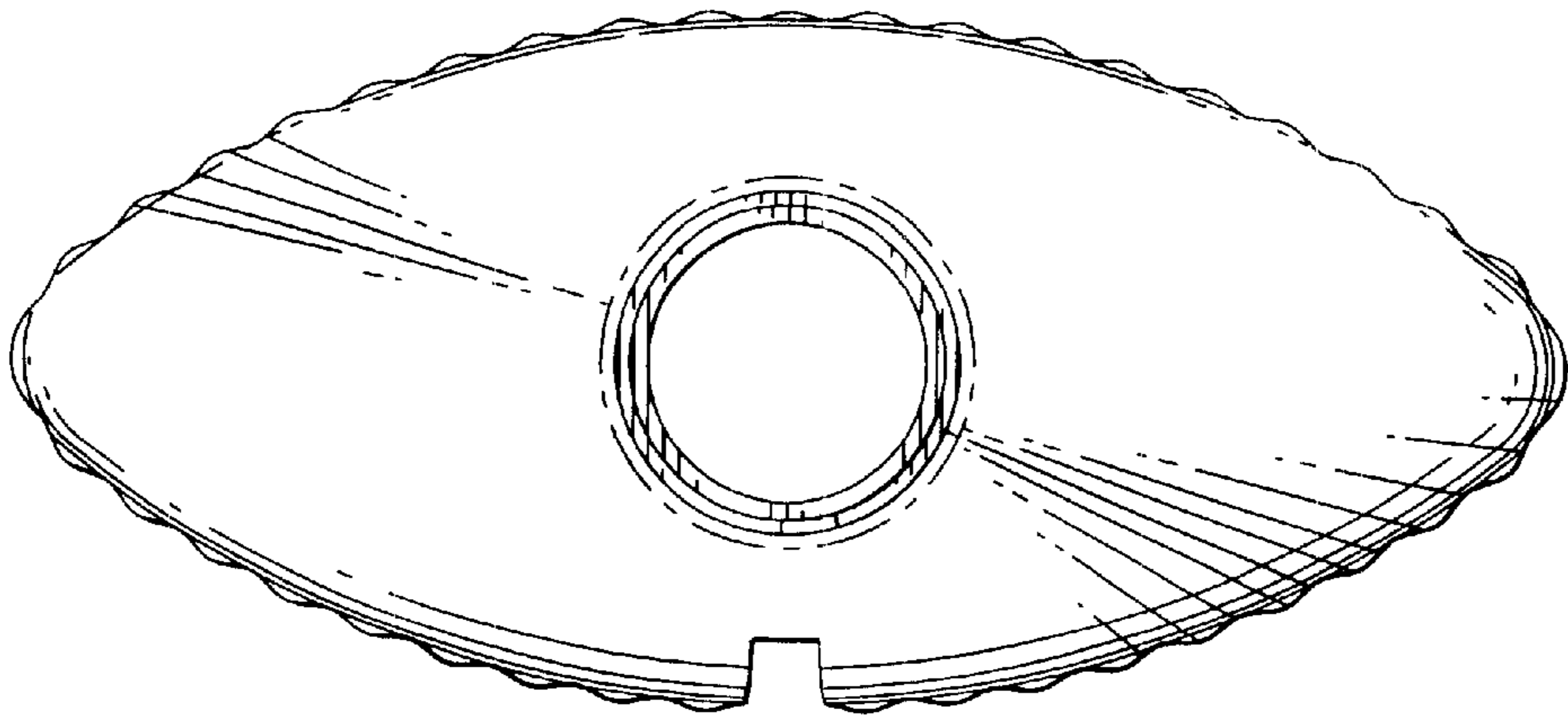
FIG. 5 is a back elevational view thereof, the closure shown in dotted lines being for illustrative purposes only and not a part of the design; and,

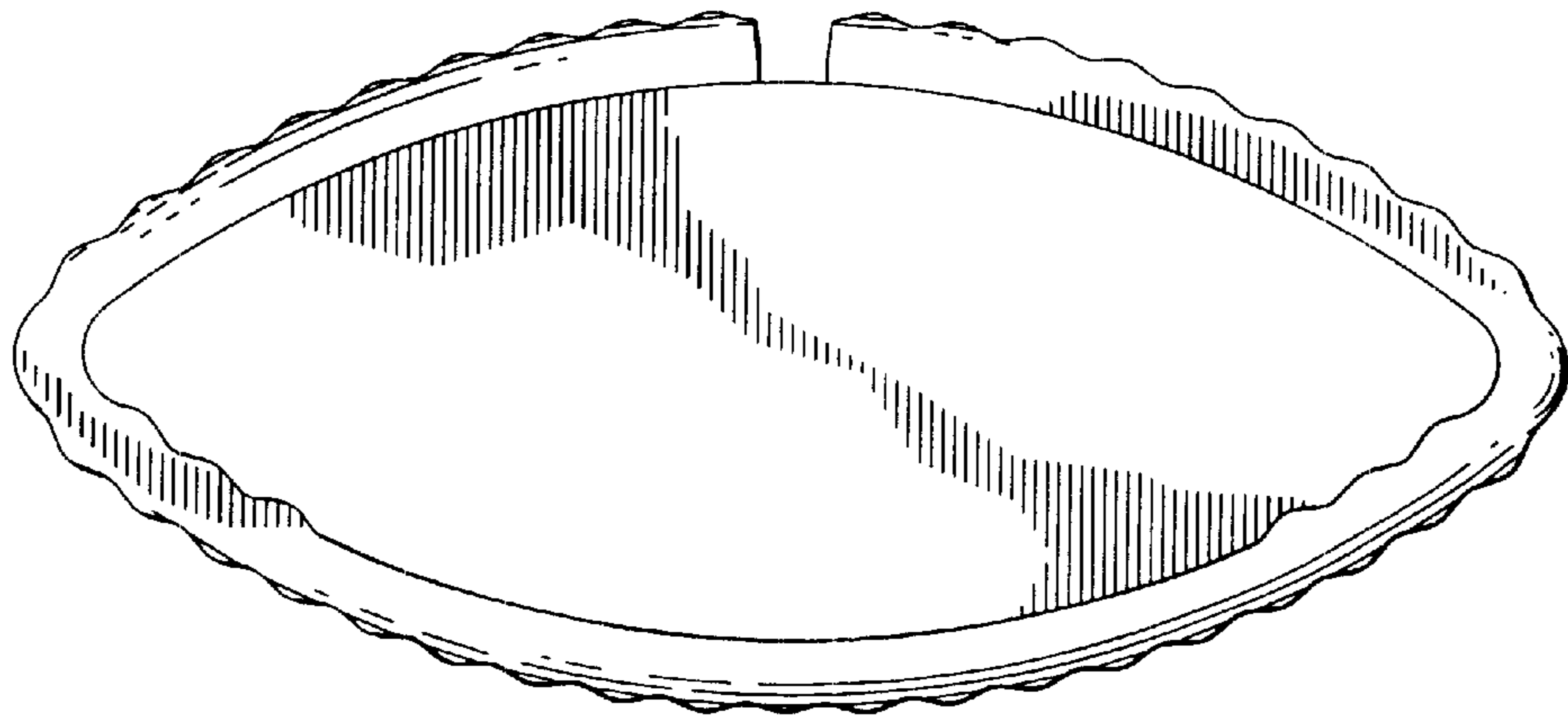

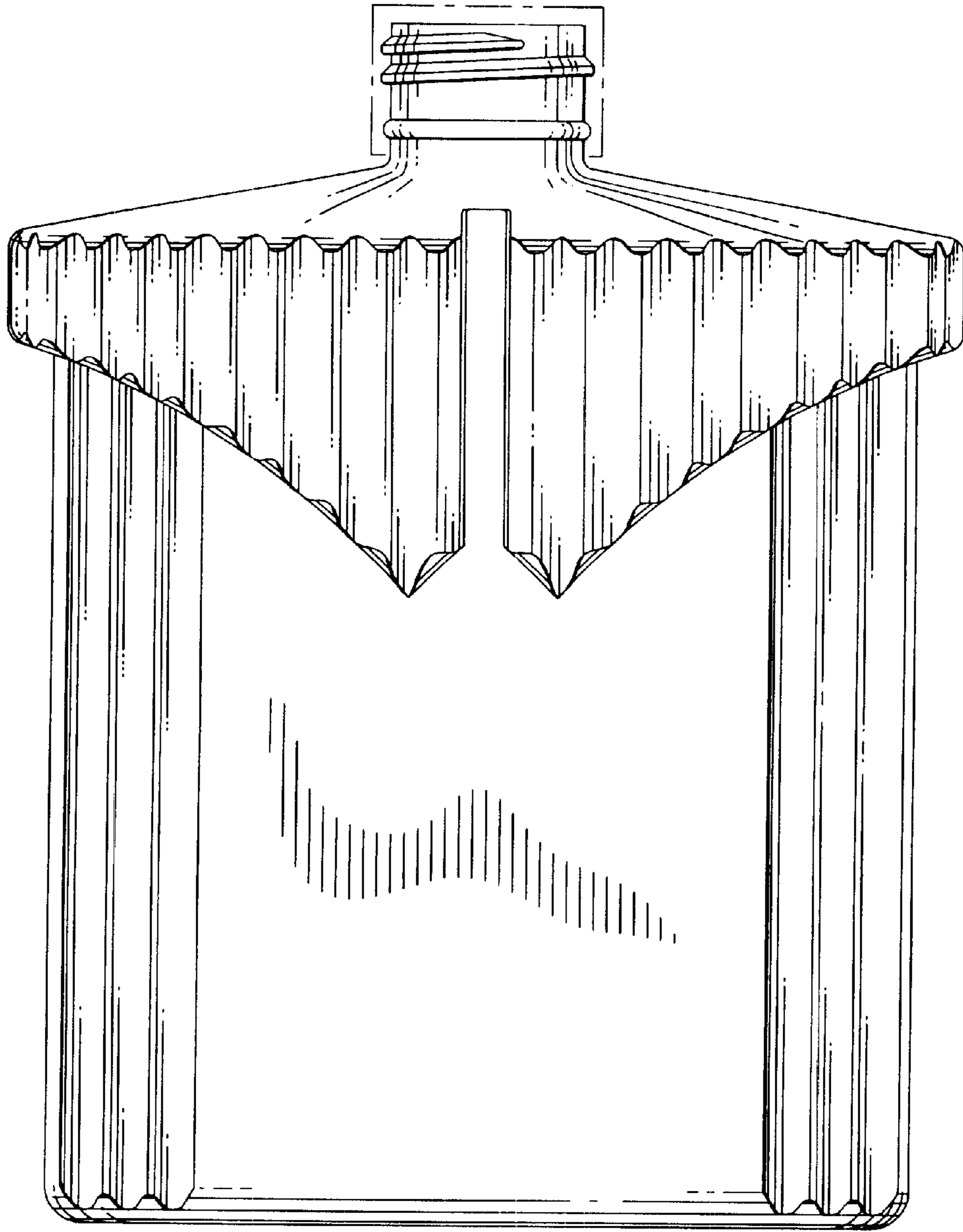

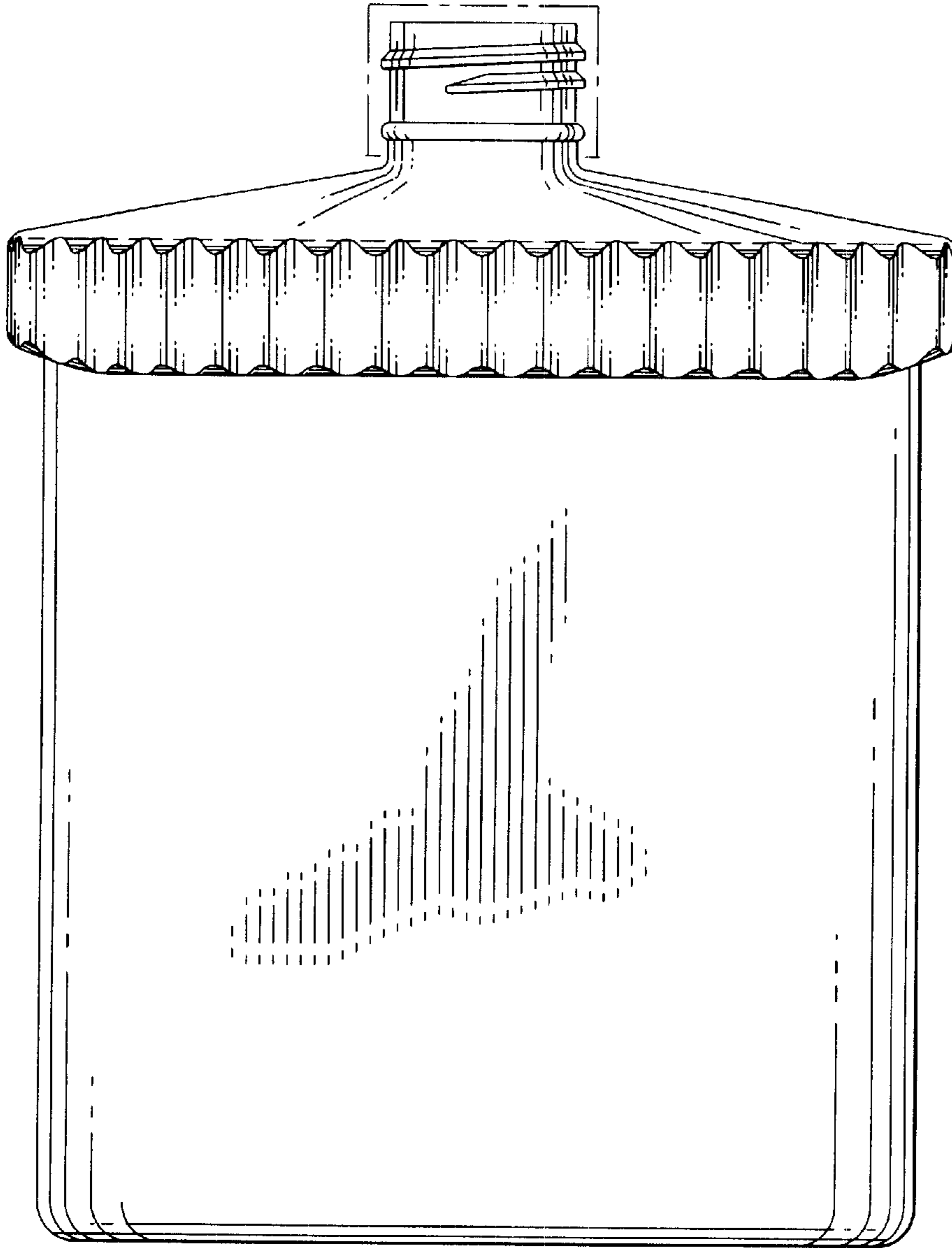
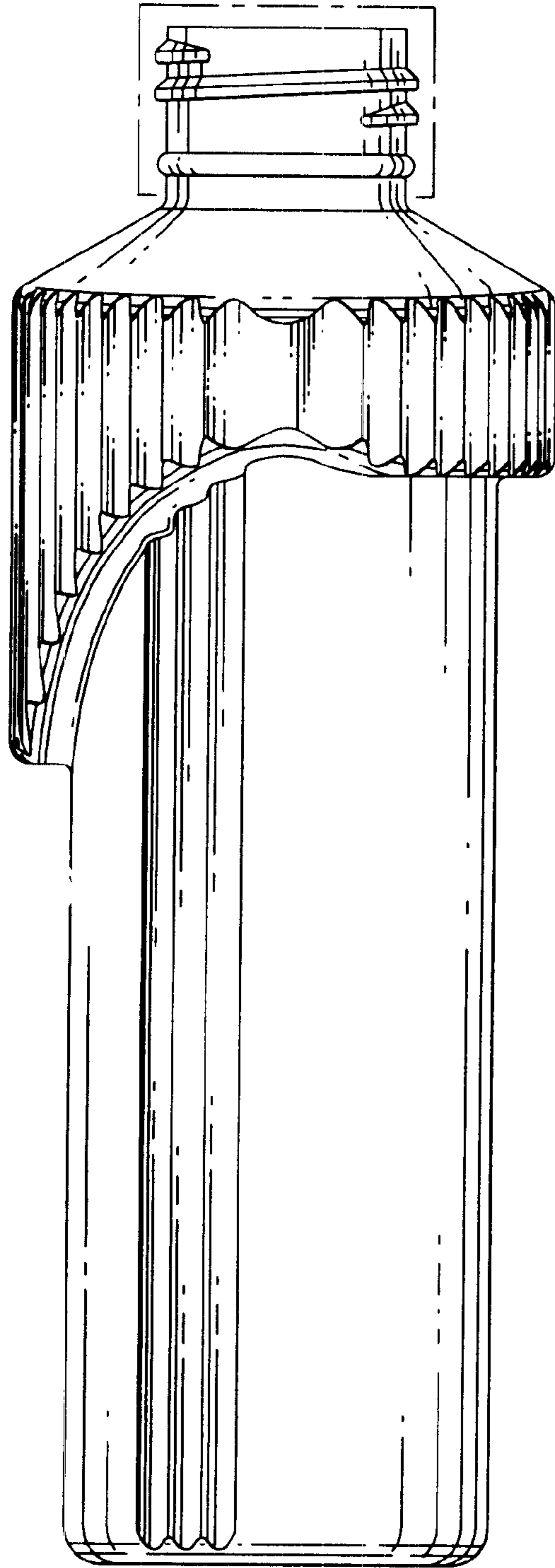
