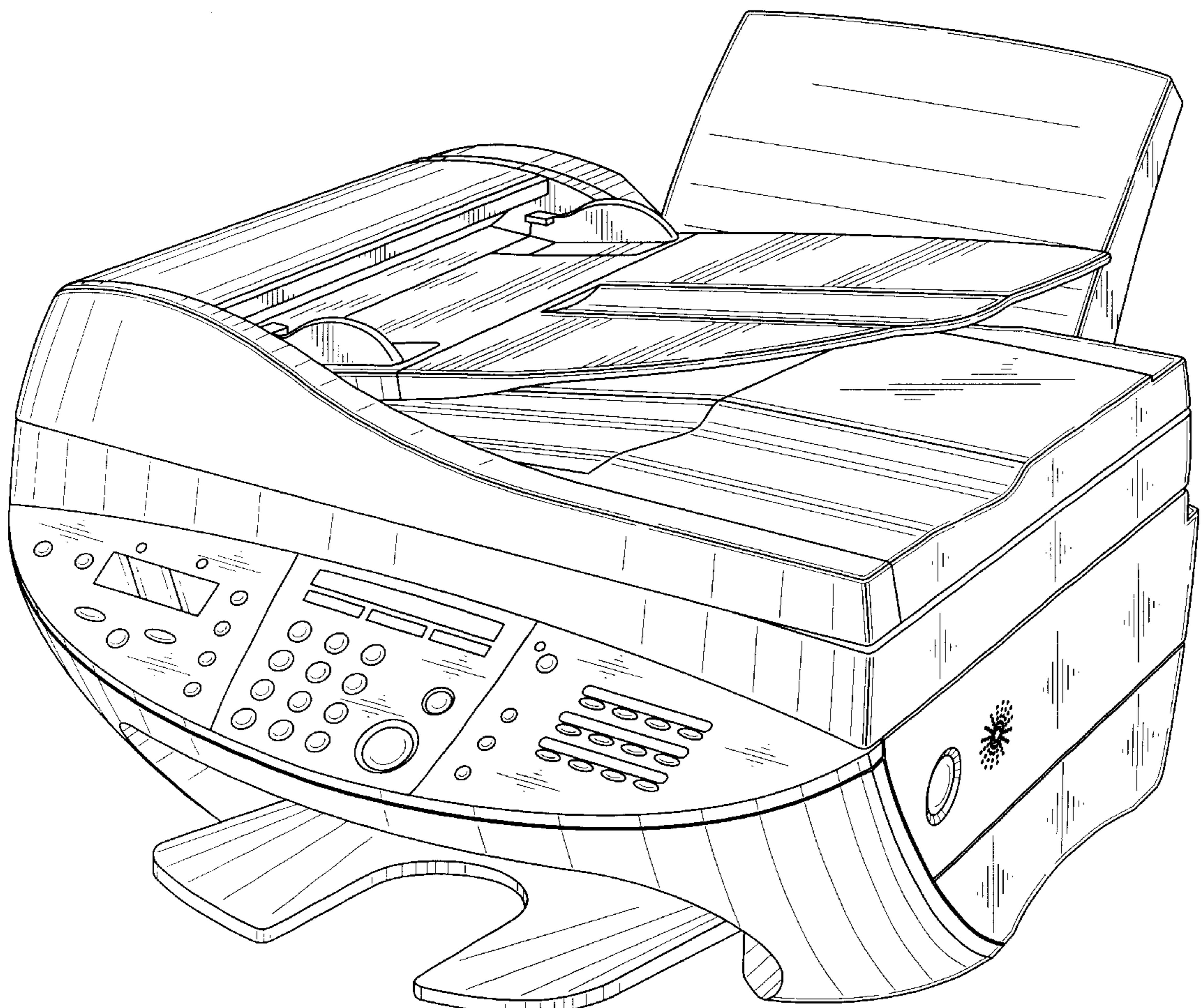

The ornamental design for a facsimile transmitter-receiver, as shown and described.

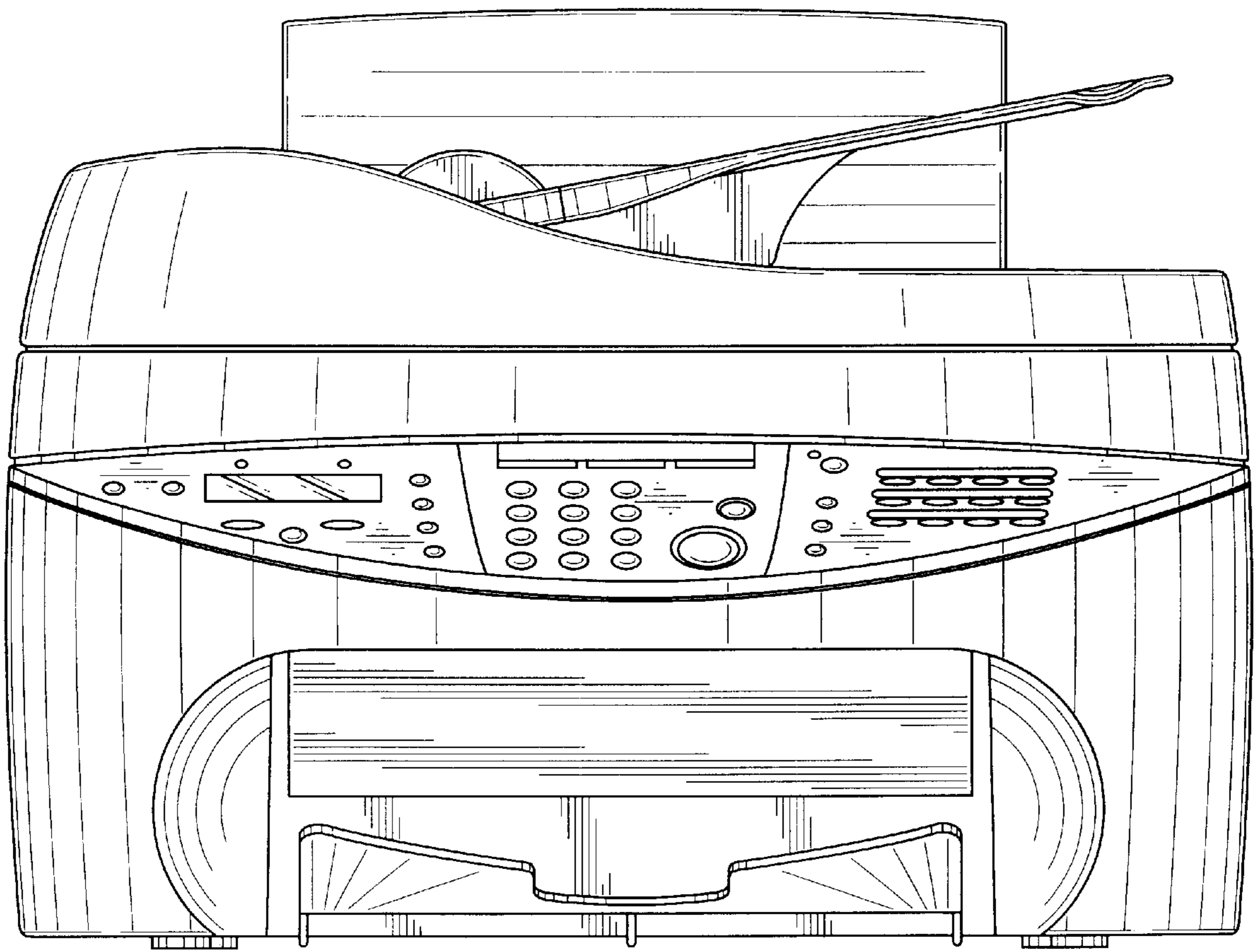
**DESCRIPTION**

 FIG. 7 is a perspective view thereof.

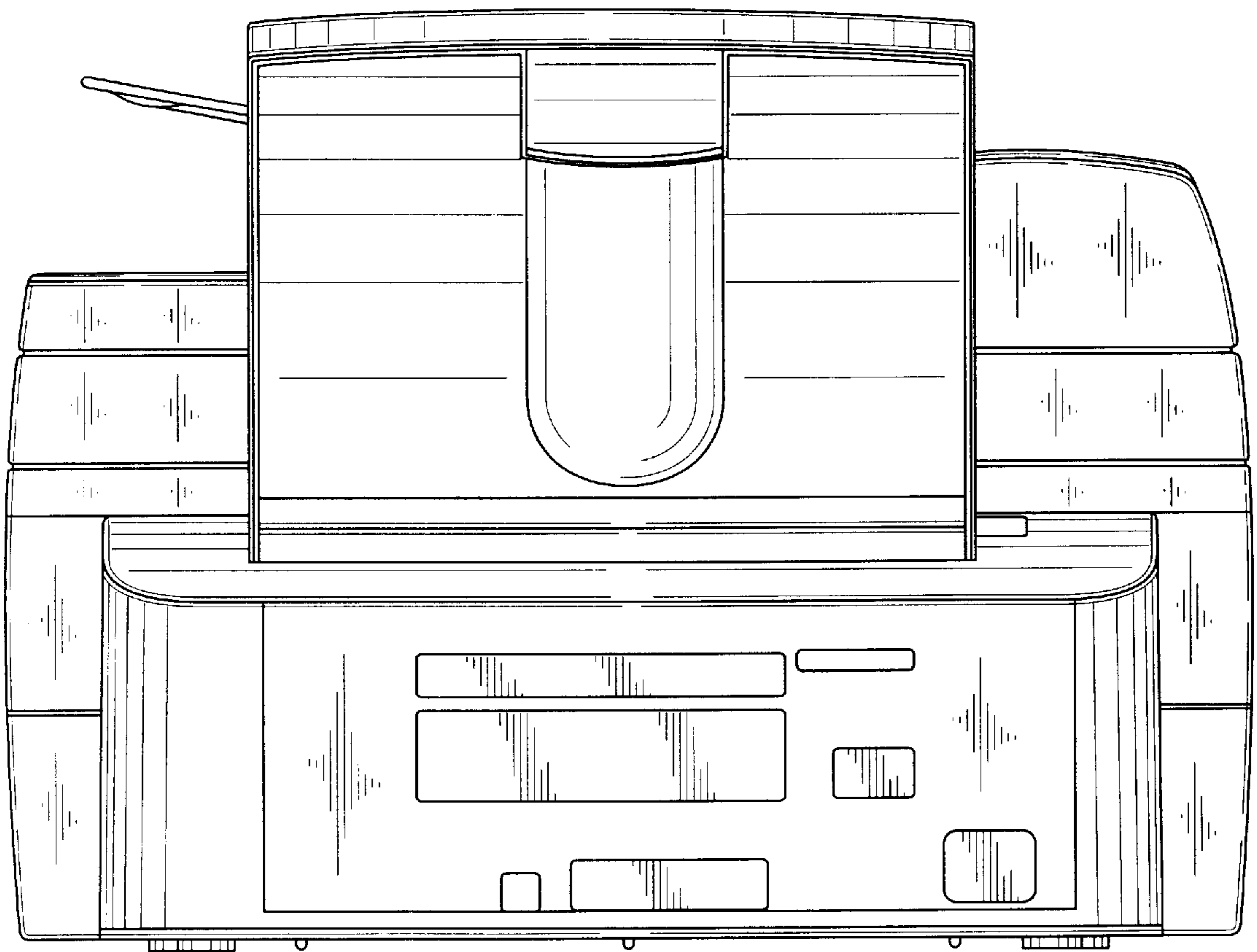

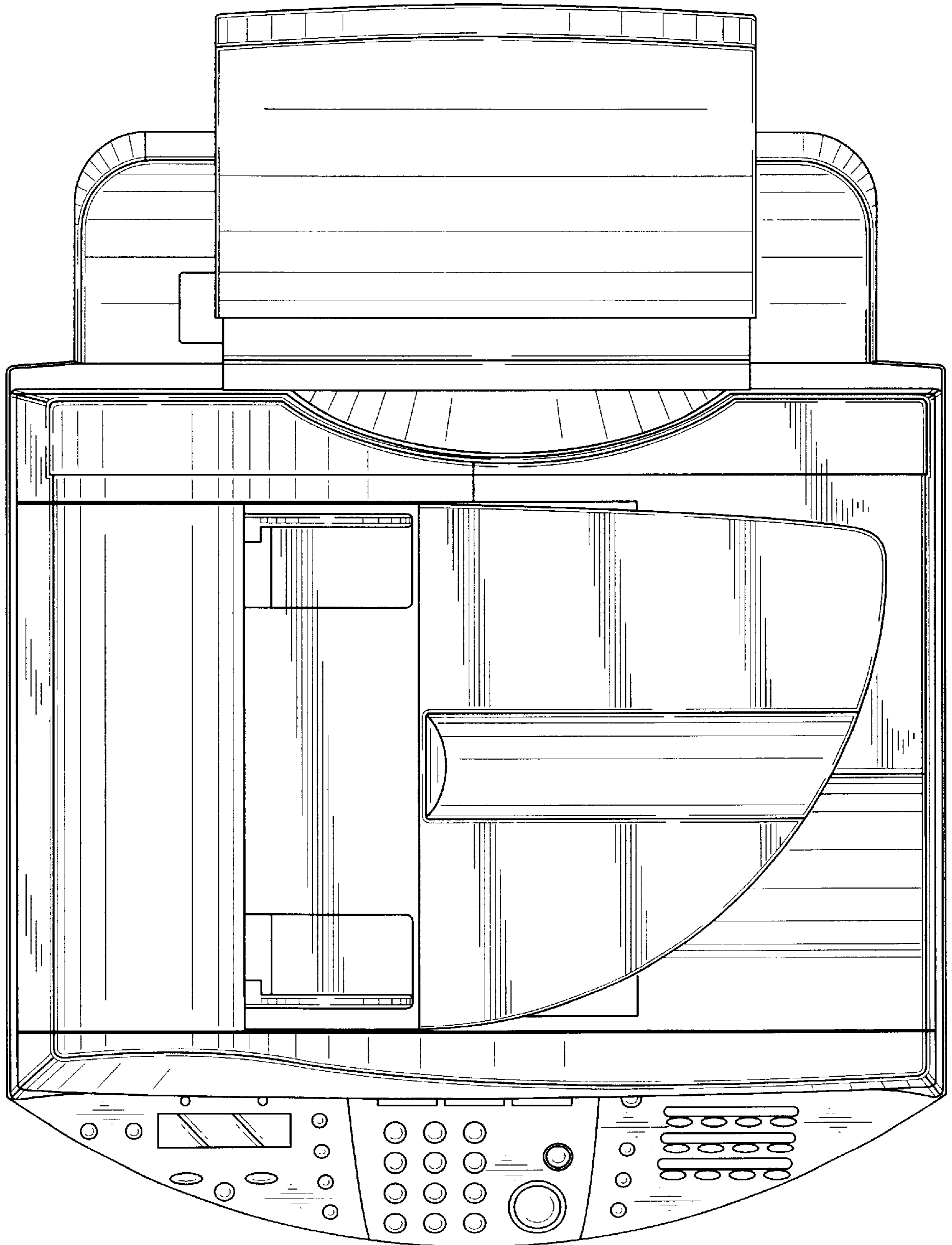

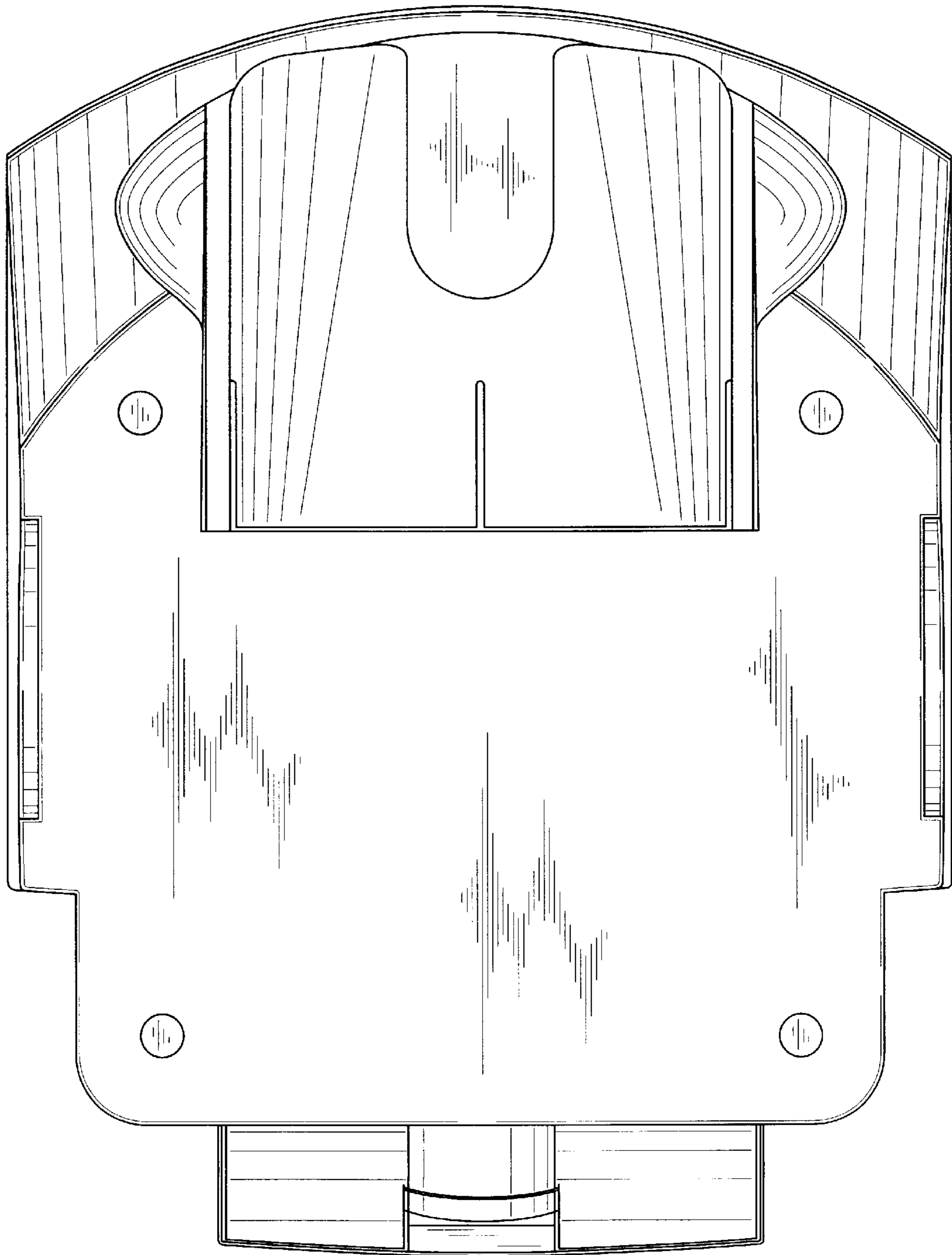

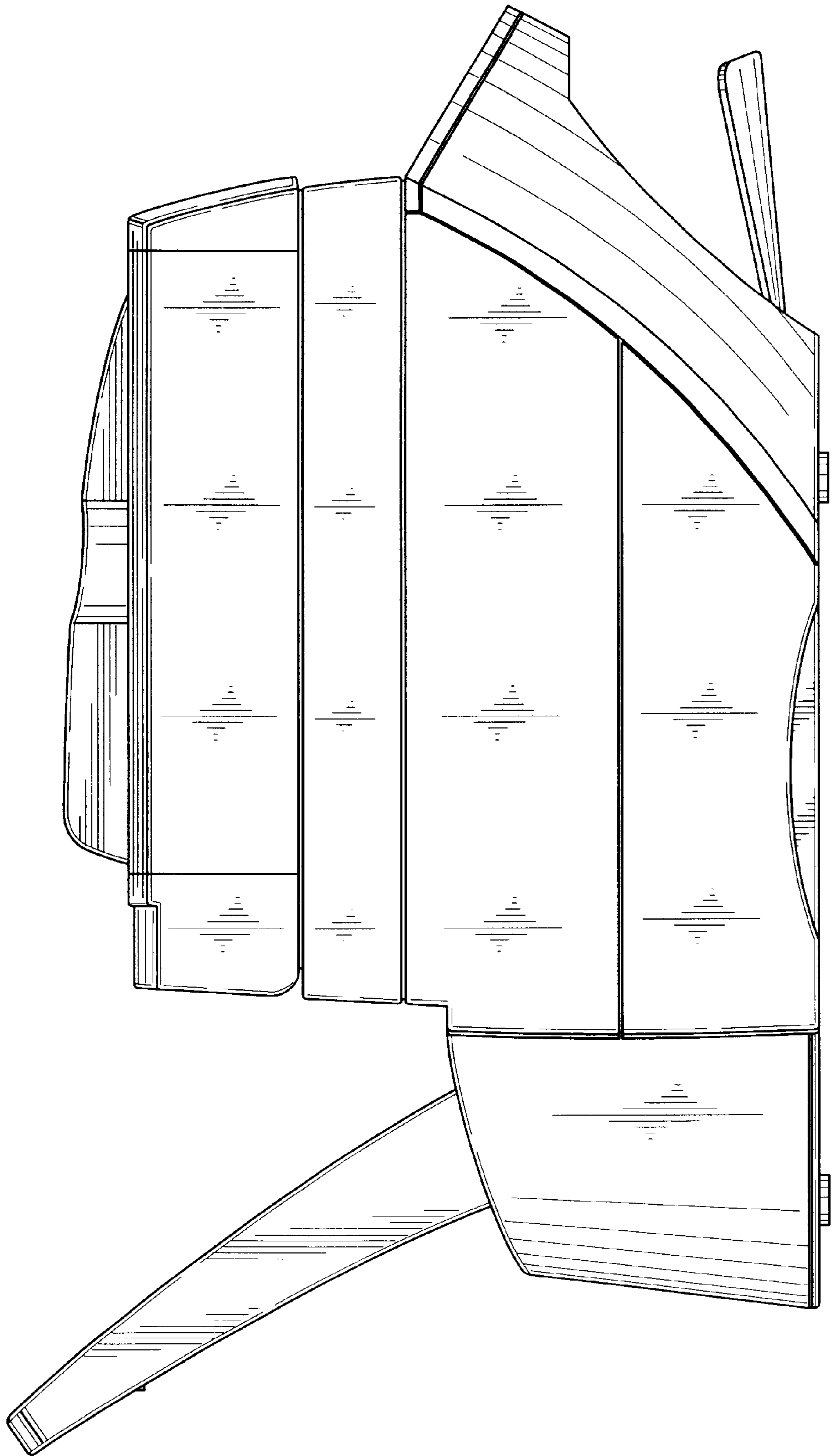
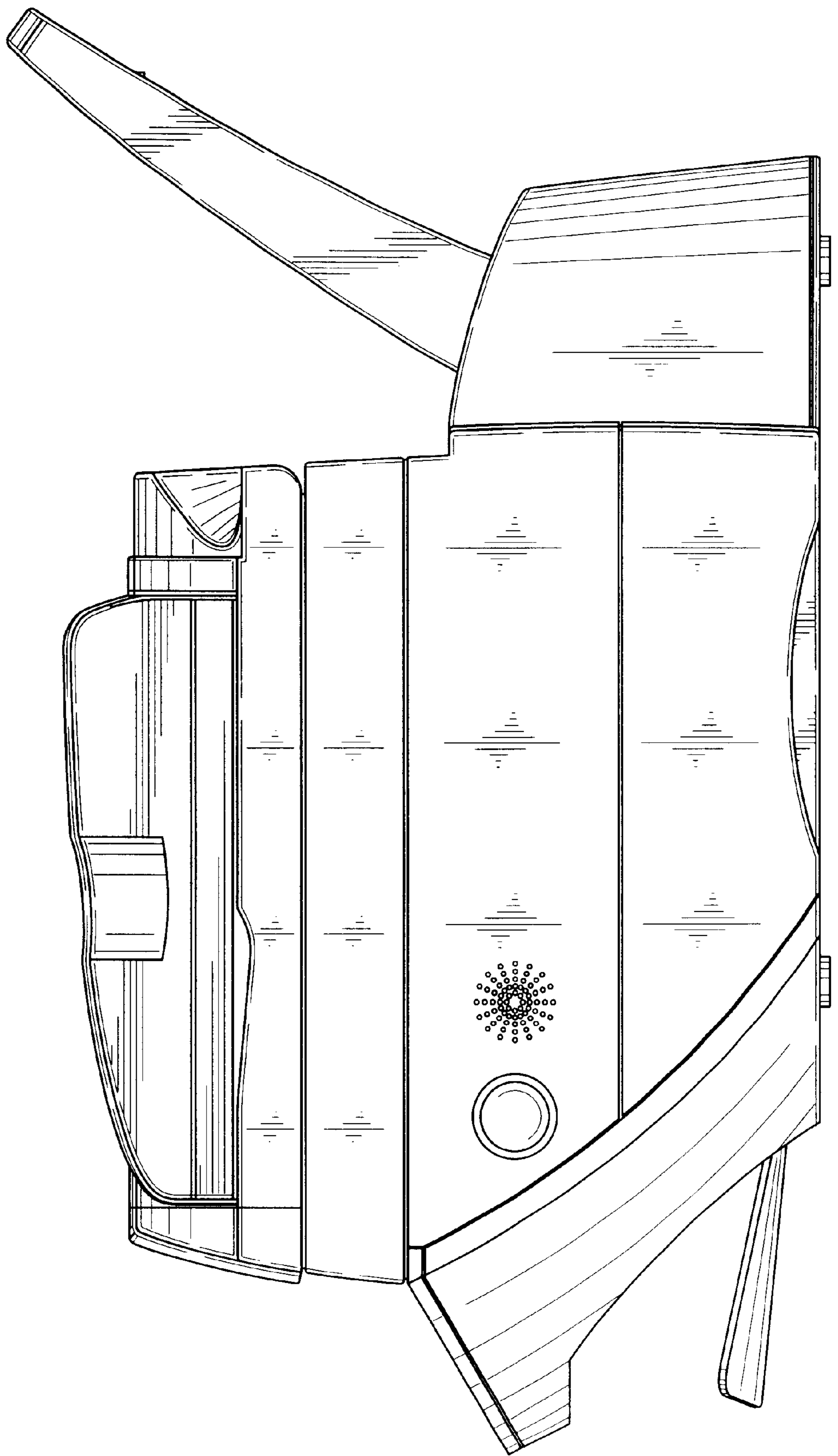

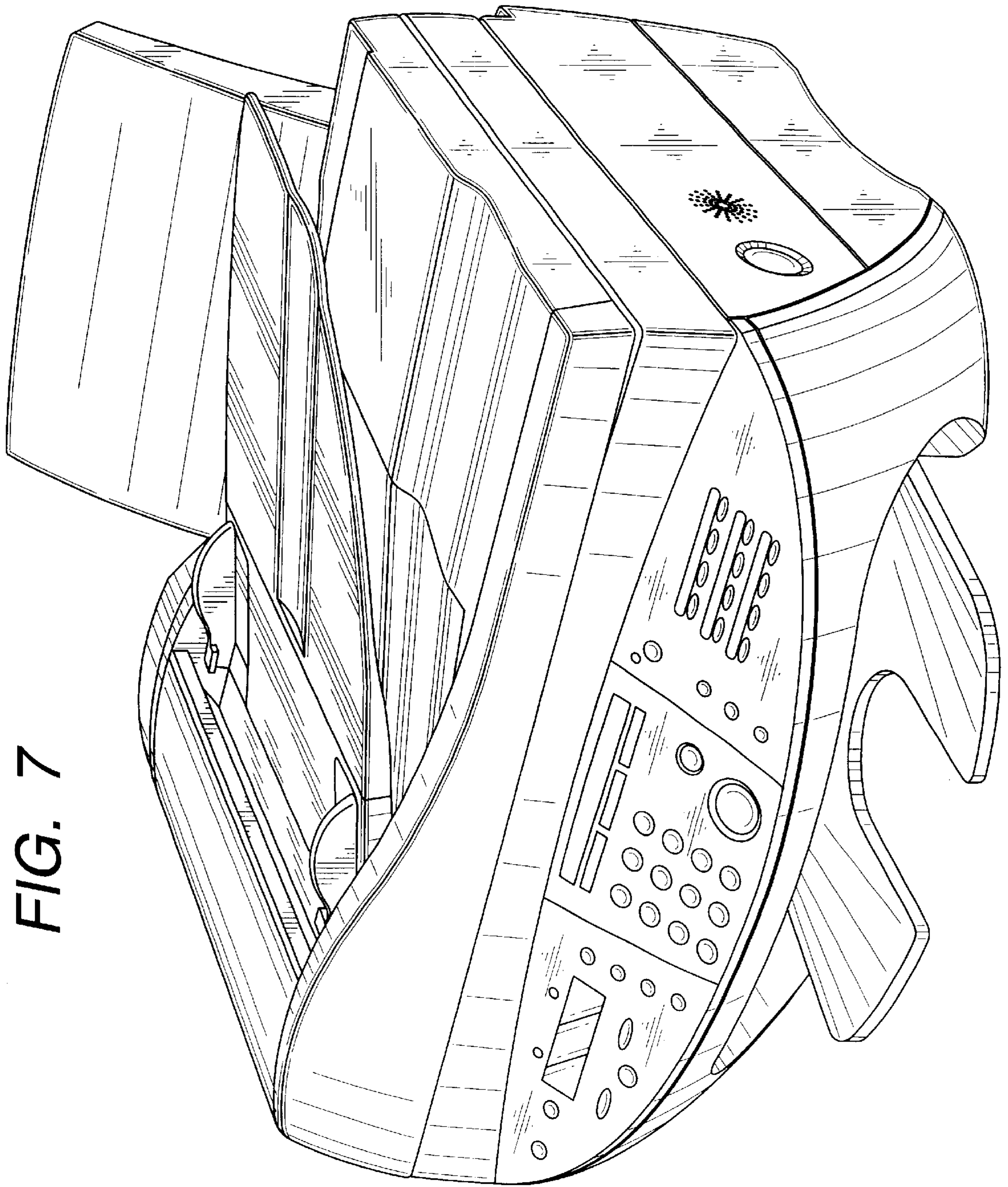
