FIG. 2 is a front view thereof;

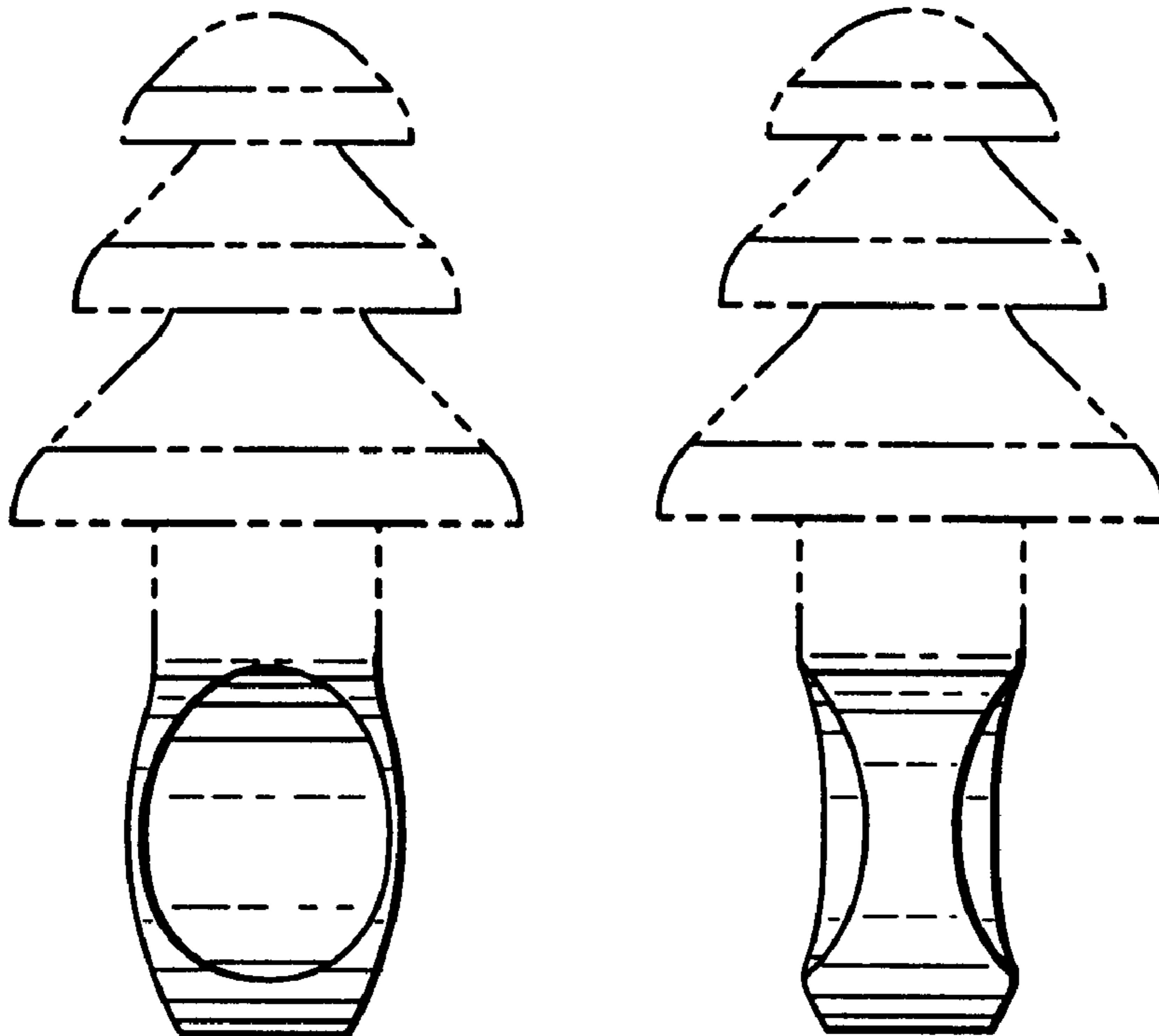
FIG. 3 is a left side view thereof, the right side view being the same as the left;

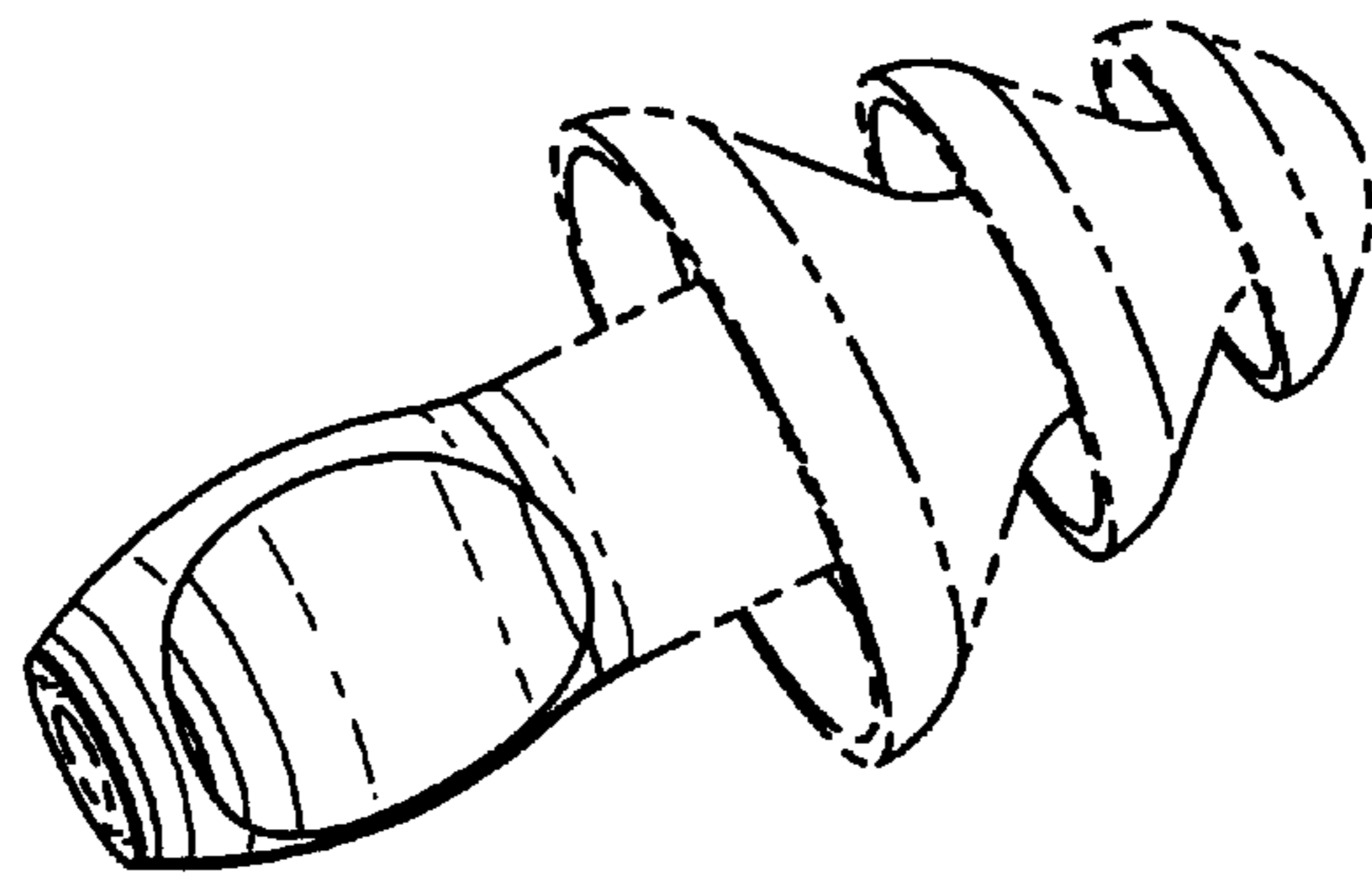
FIG. 4 is a top view thereof; and,

FIG. 5 is a bottom view thereof.

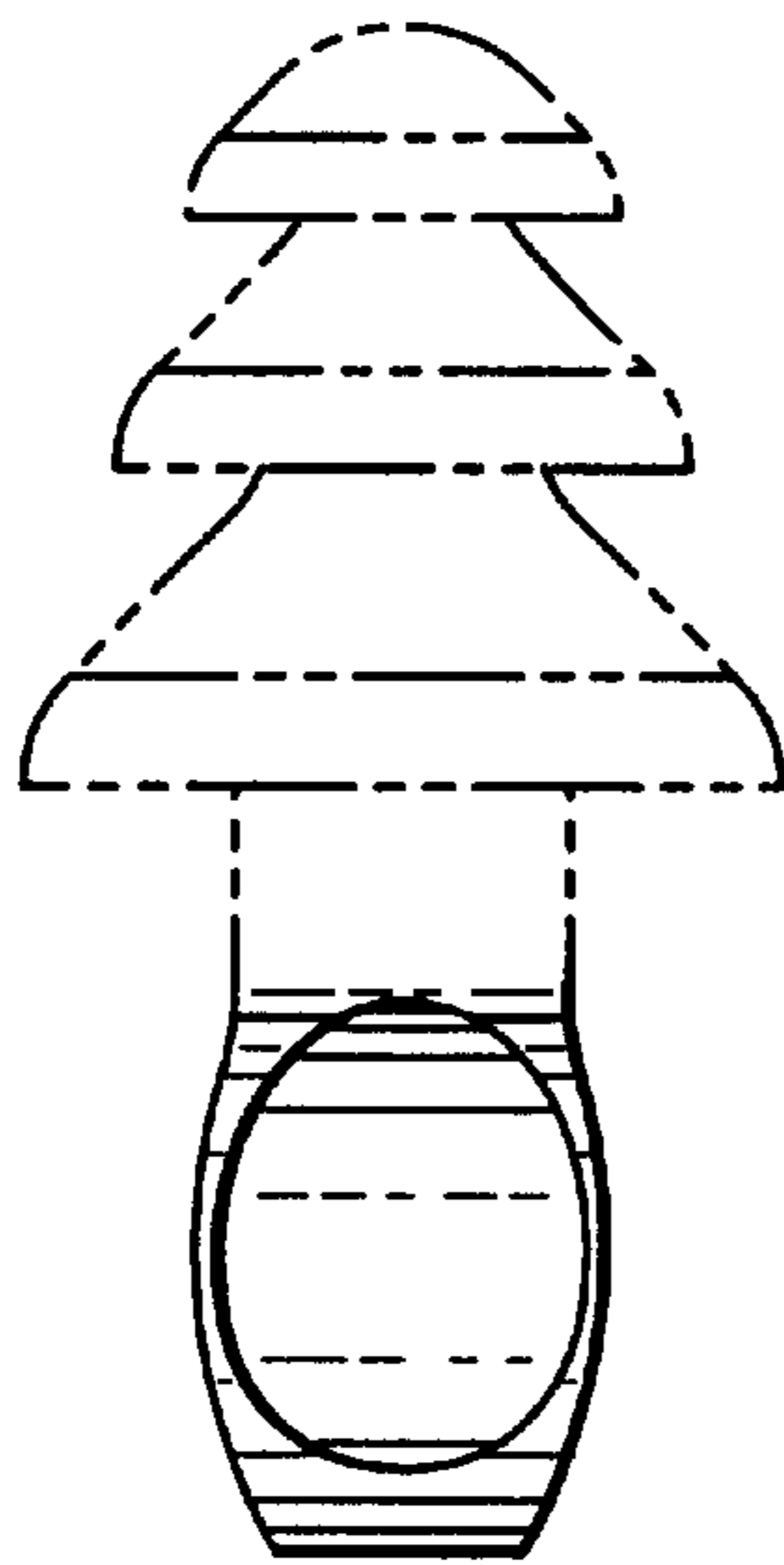
The broken line showing forms no part of the claimed design.

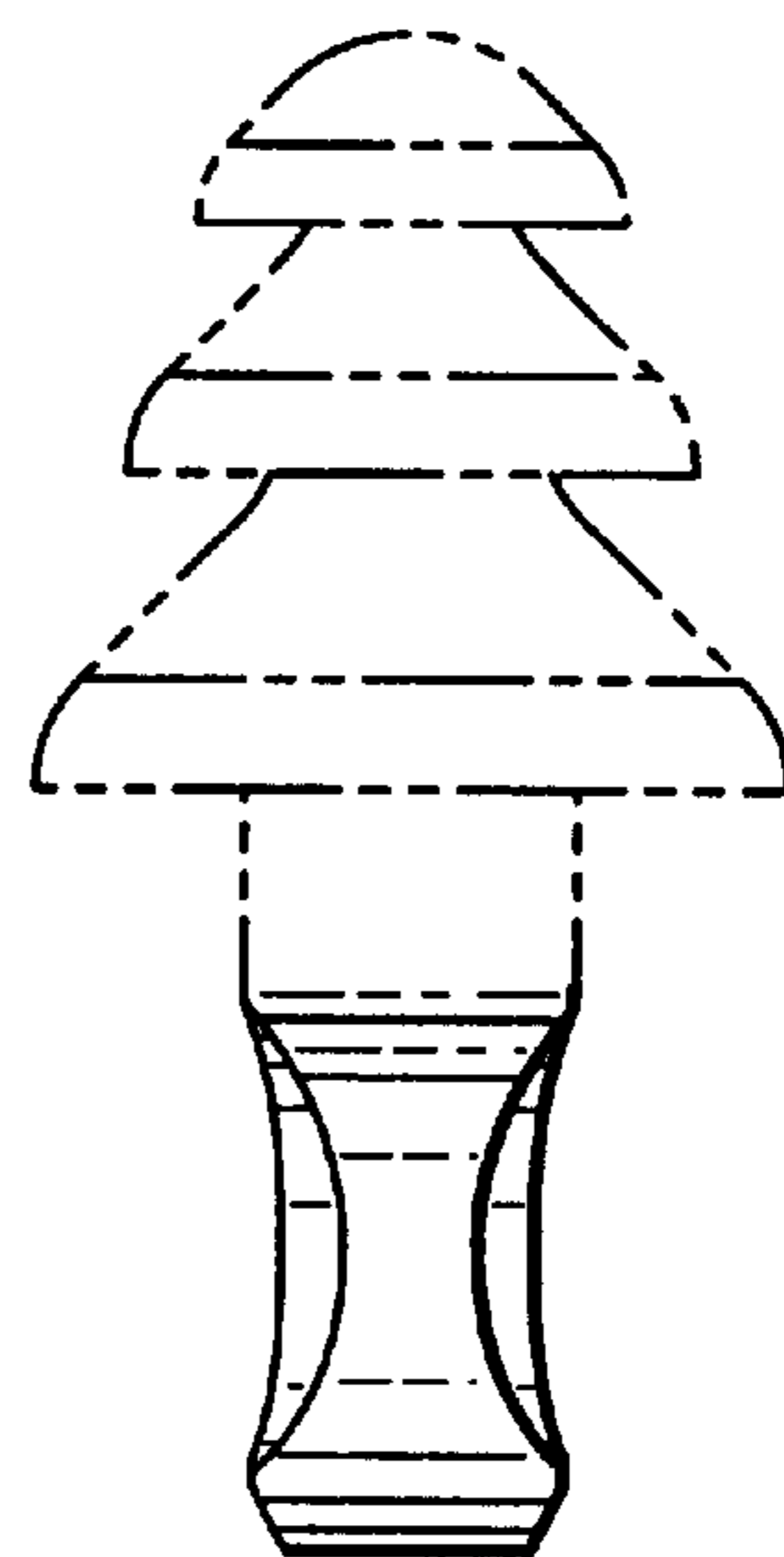




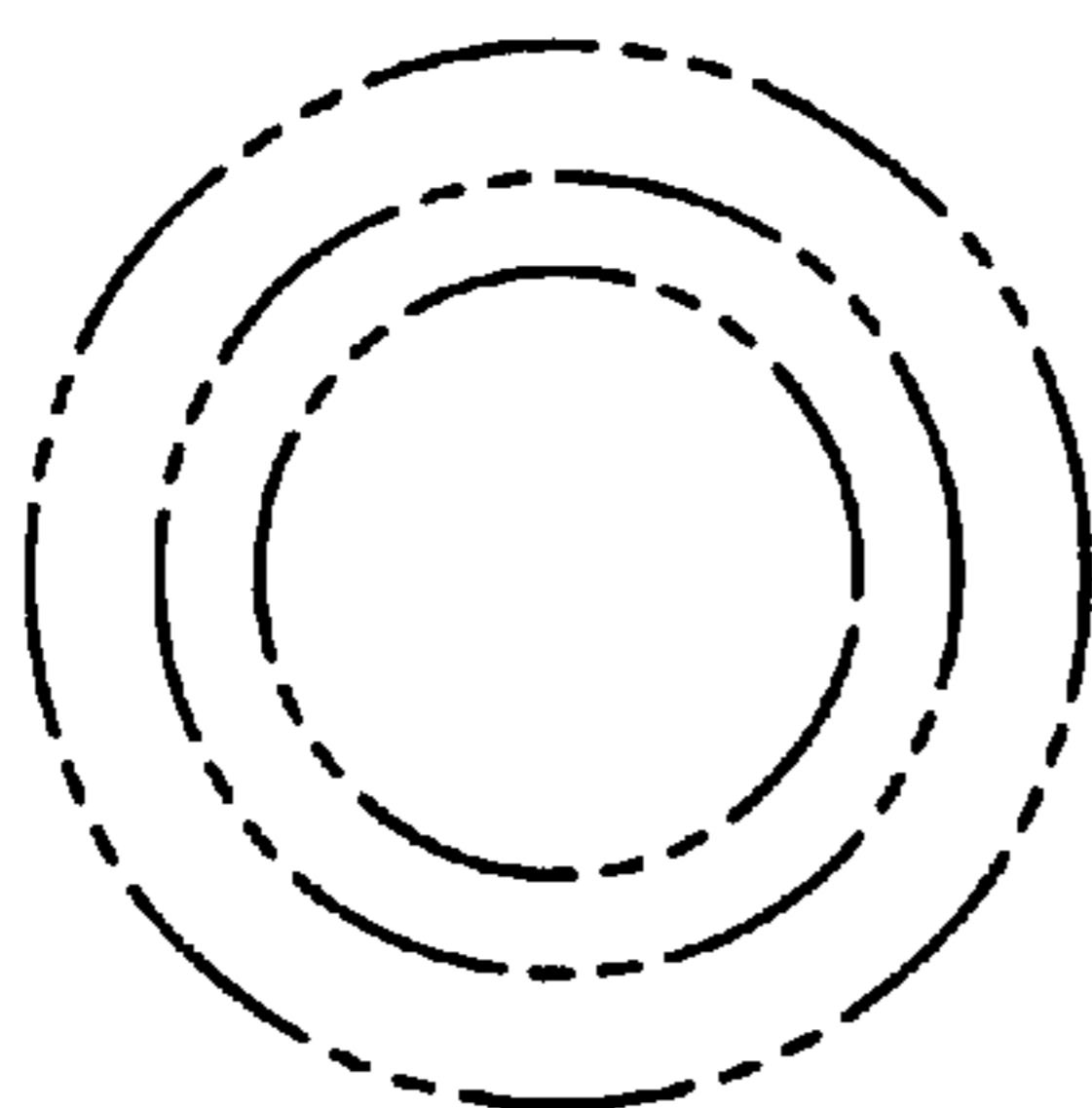

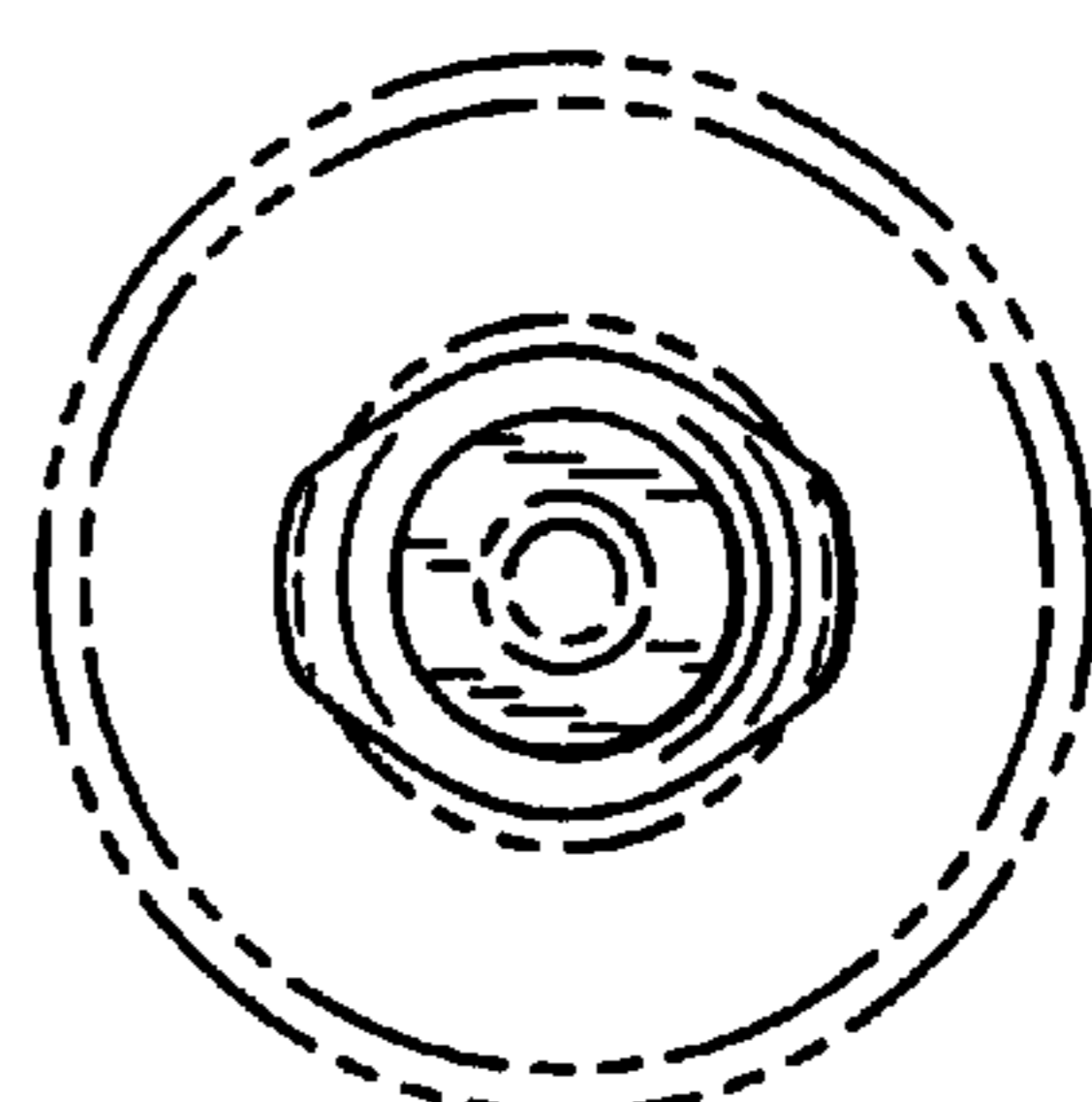
