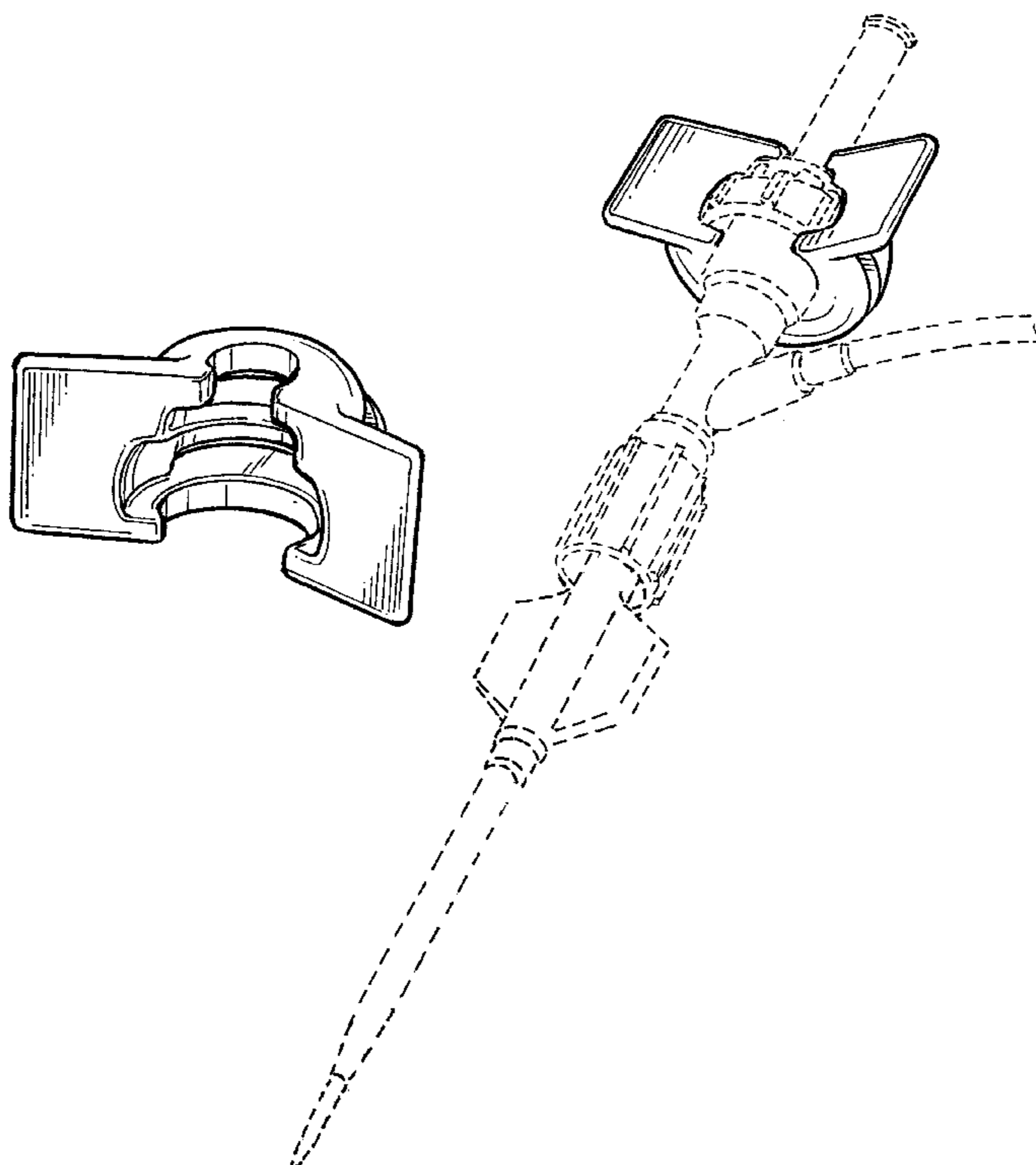
(57) **CLAIM**

The ornamental design for a sheath and dilator retaining clip, as shown and described.

DESCRIPTION

FIG. 1 is a front upper perspective view of the sheath and dilator retaining clip showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a rear view thereof; and, FIG. 8 is a front lower perspective view thereof. The broken line showing of the sheath and the dilator in FIG. 8 is for illustrational purposes only and forms no part of the claimed design.

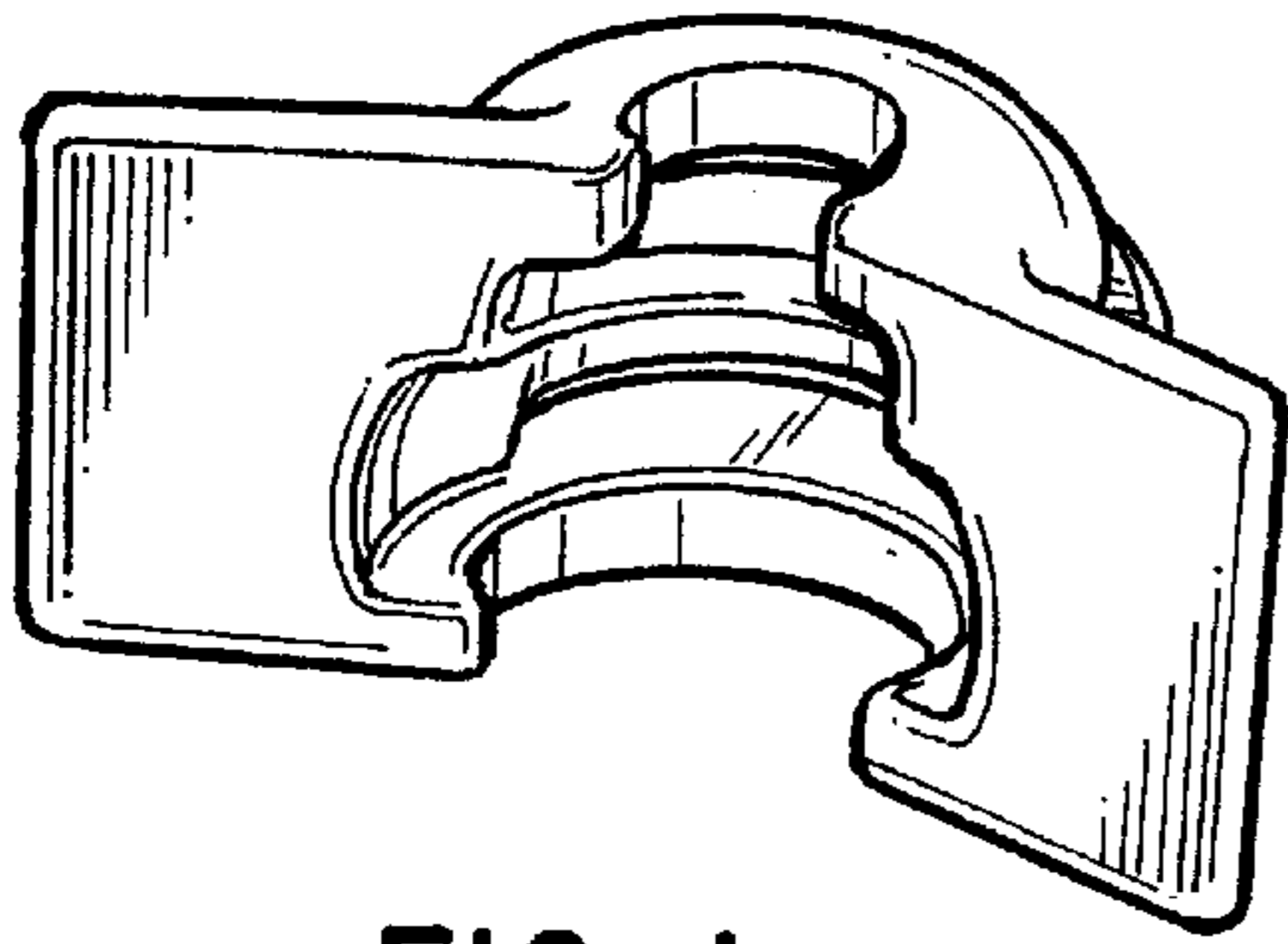

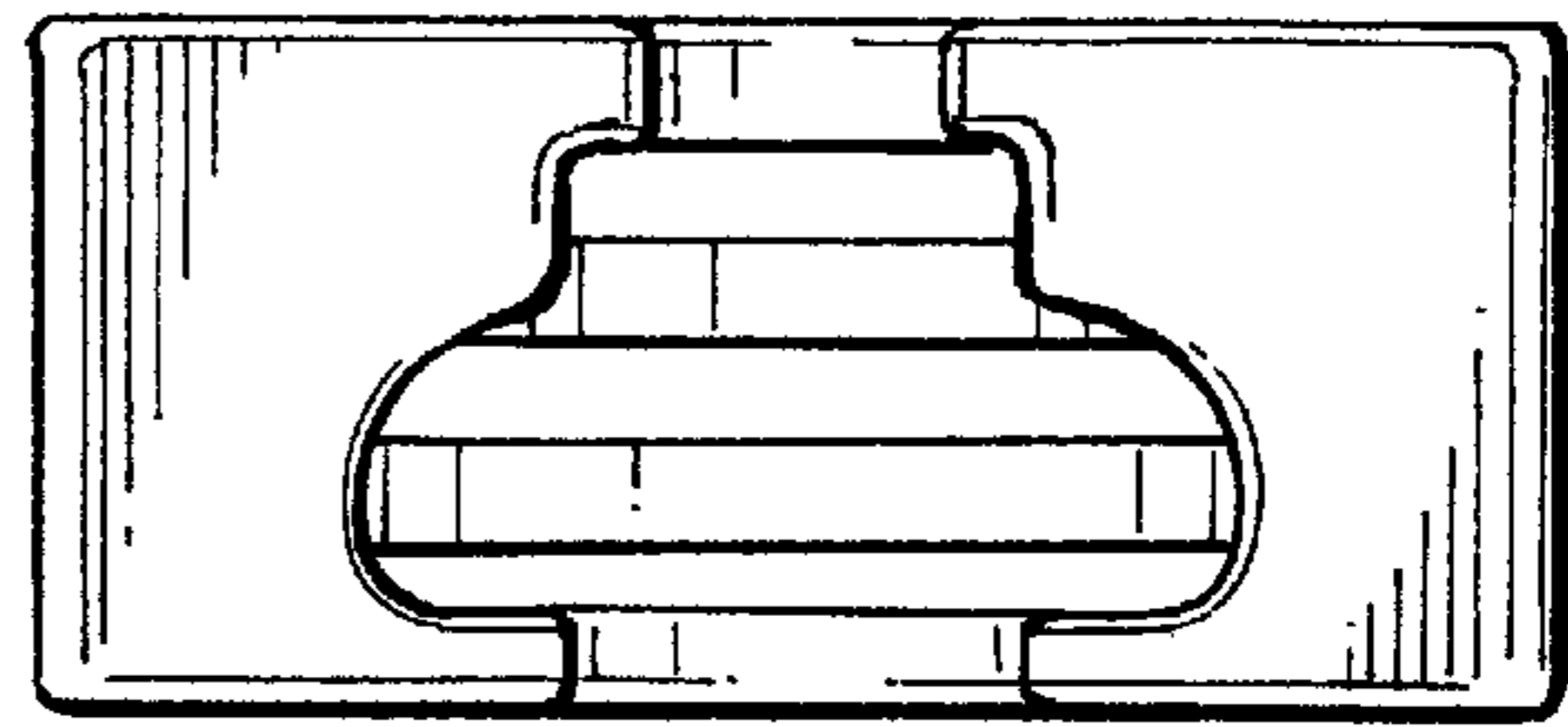

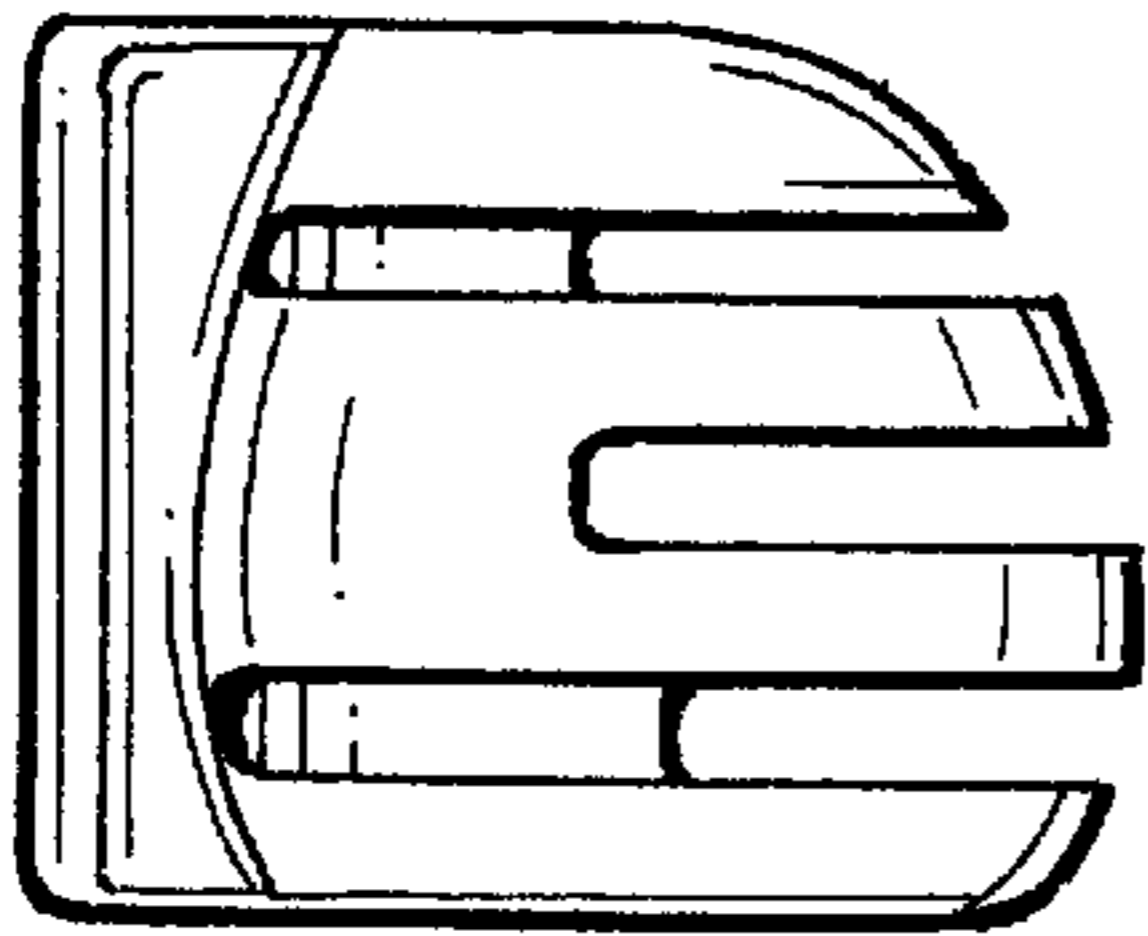

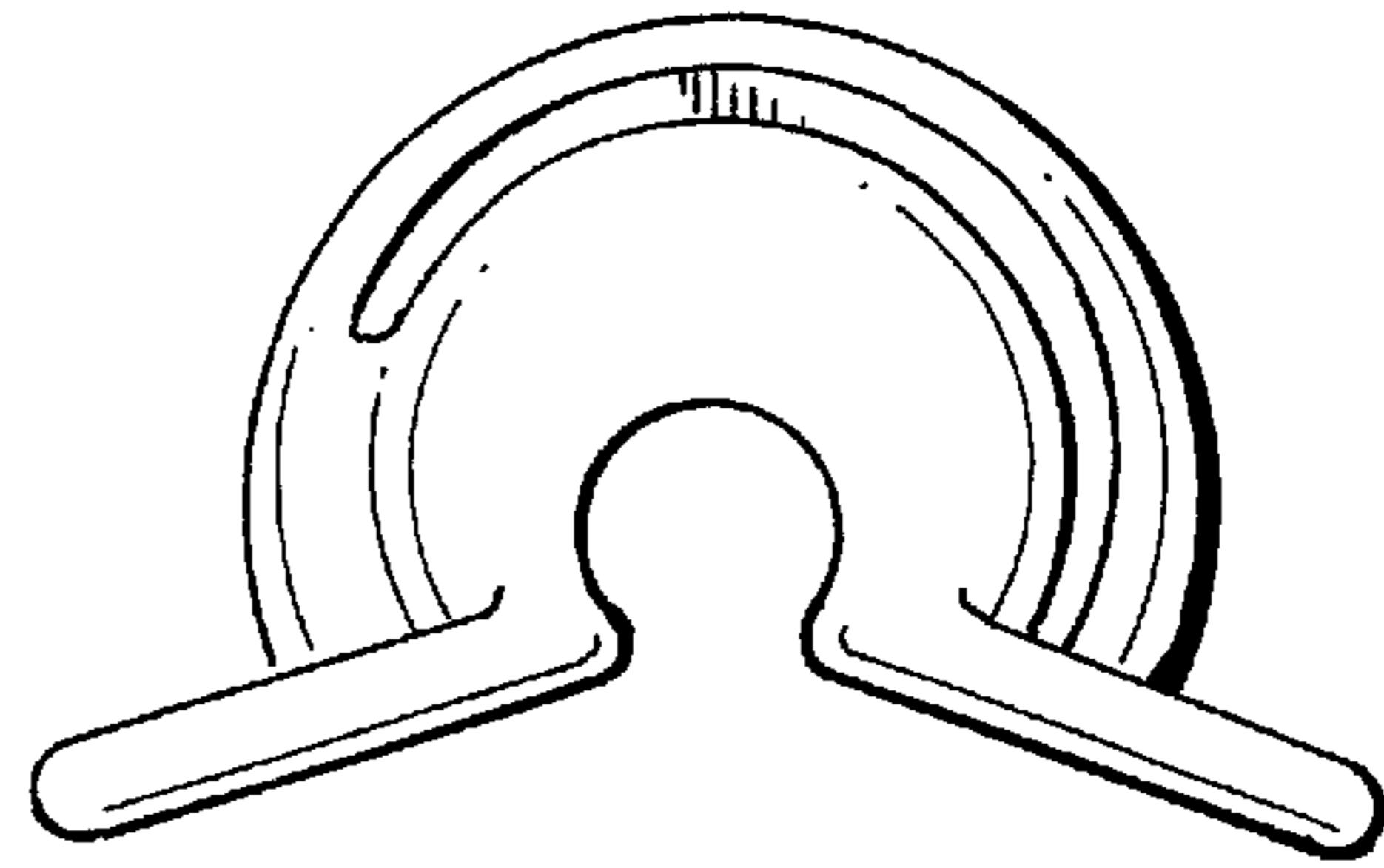

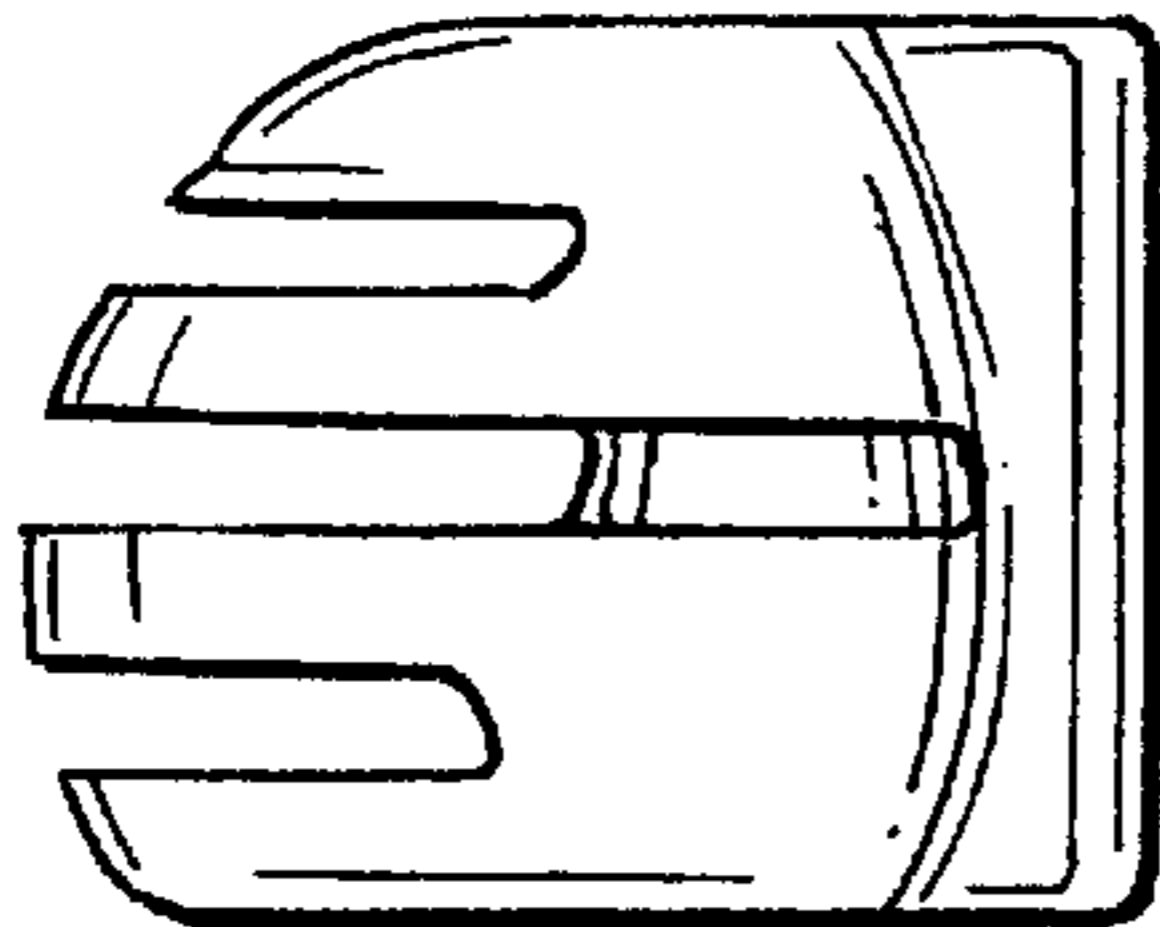

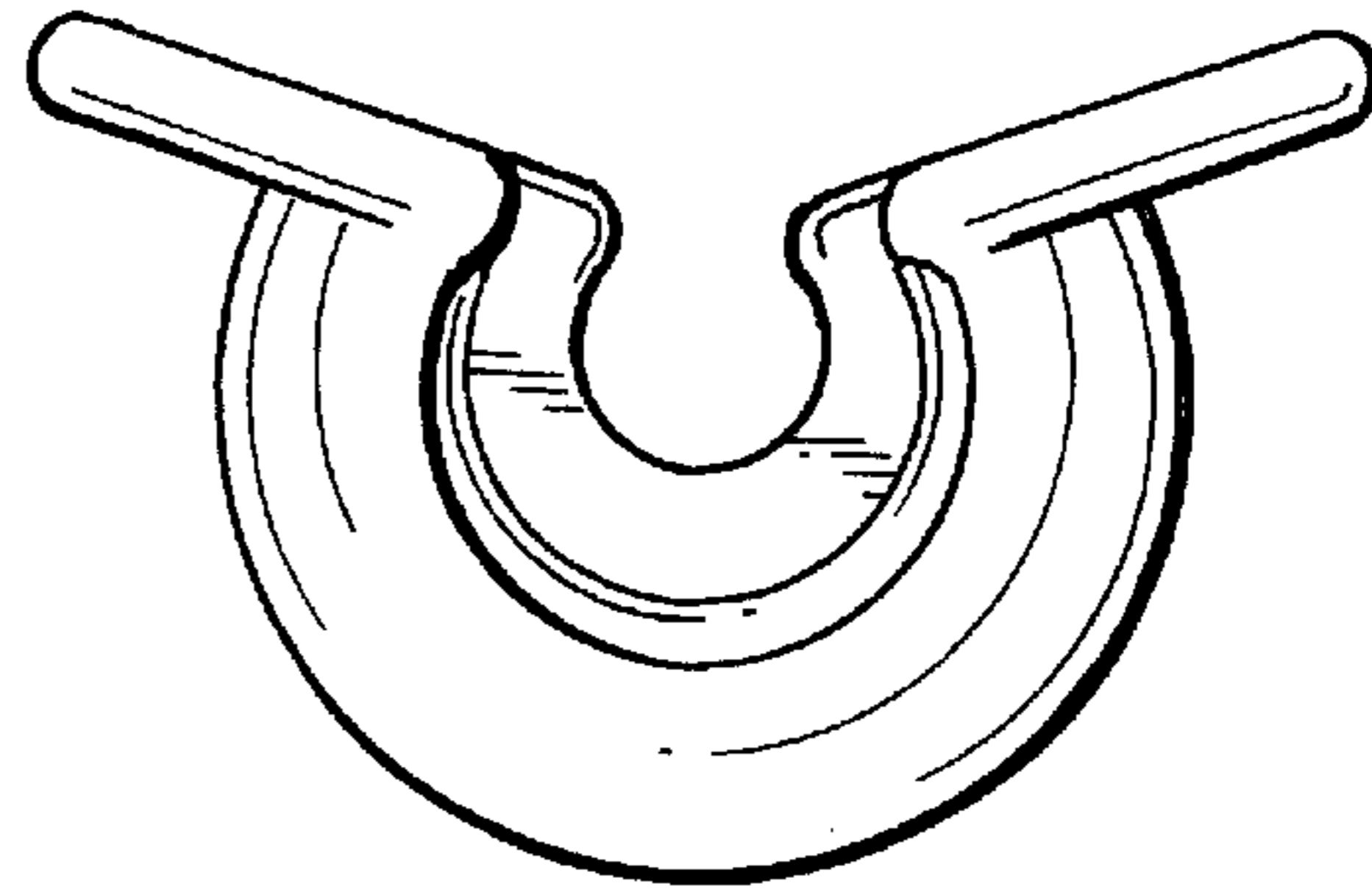

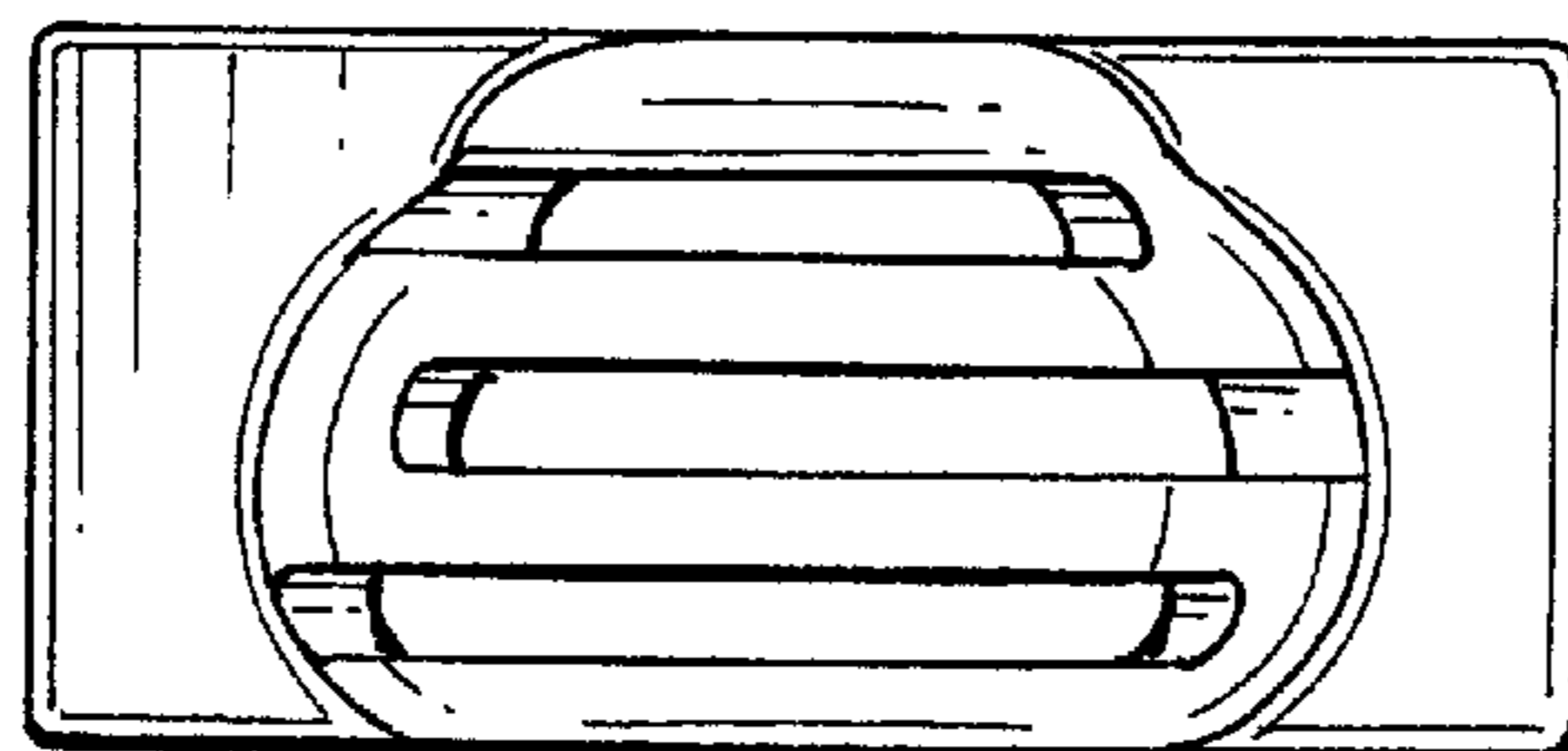

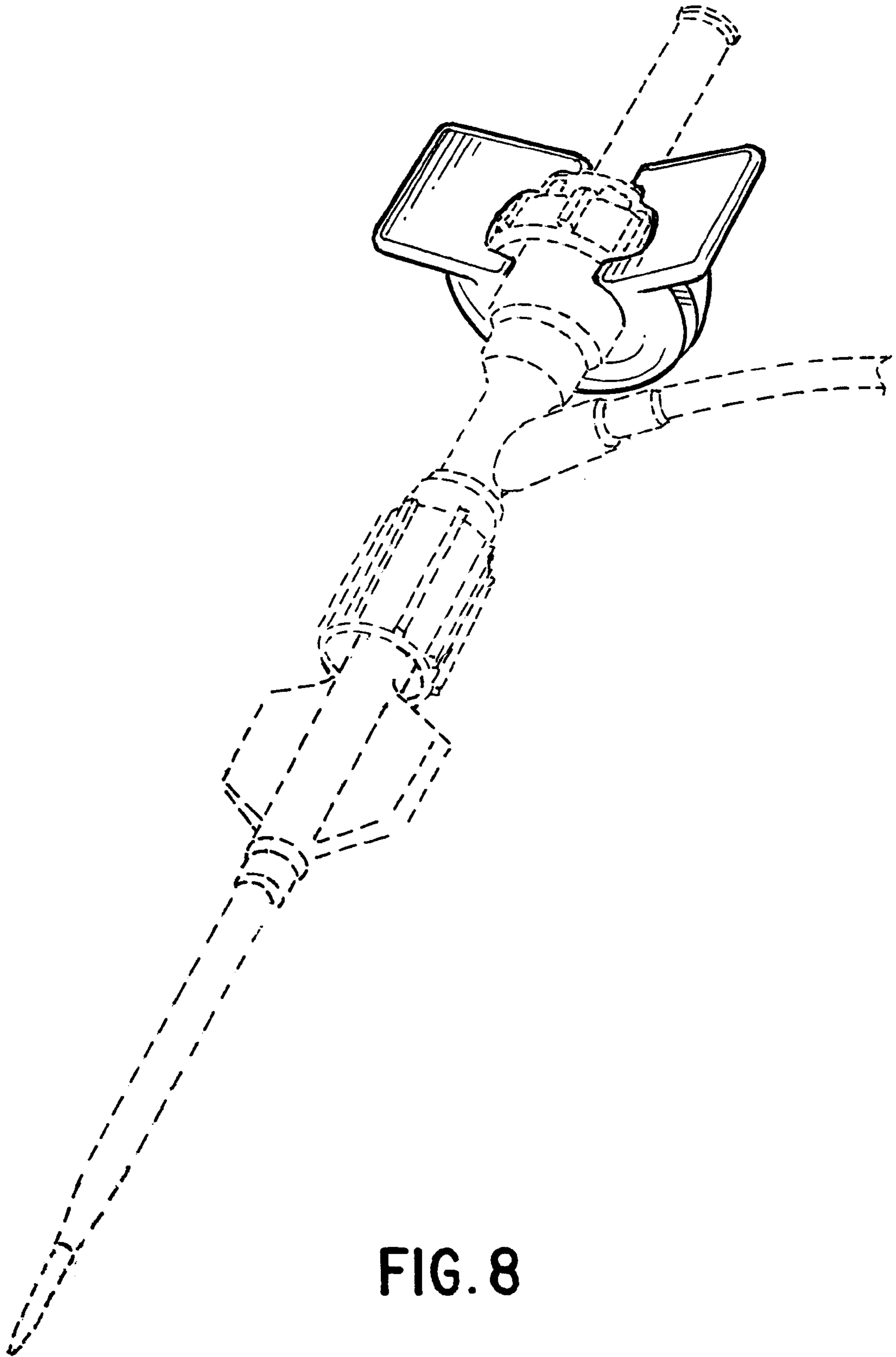
