image;

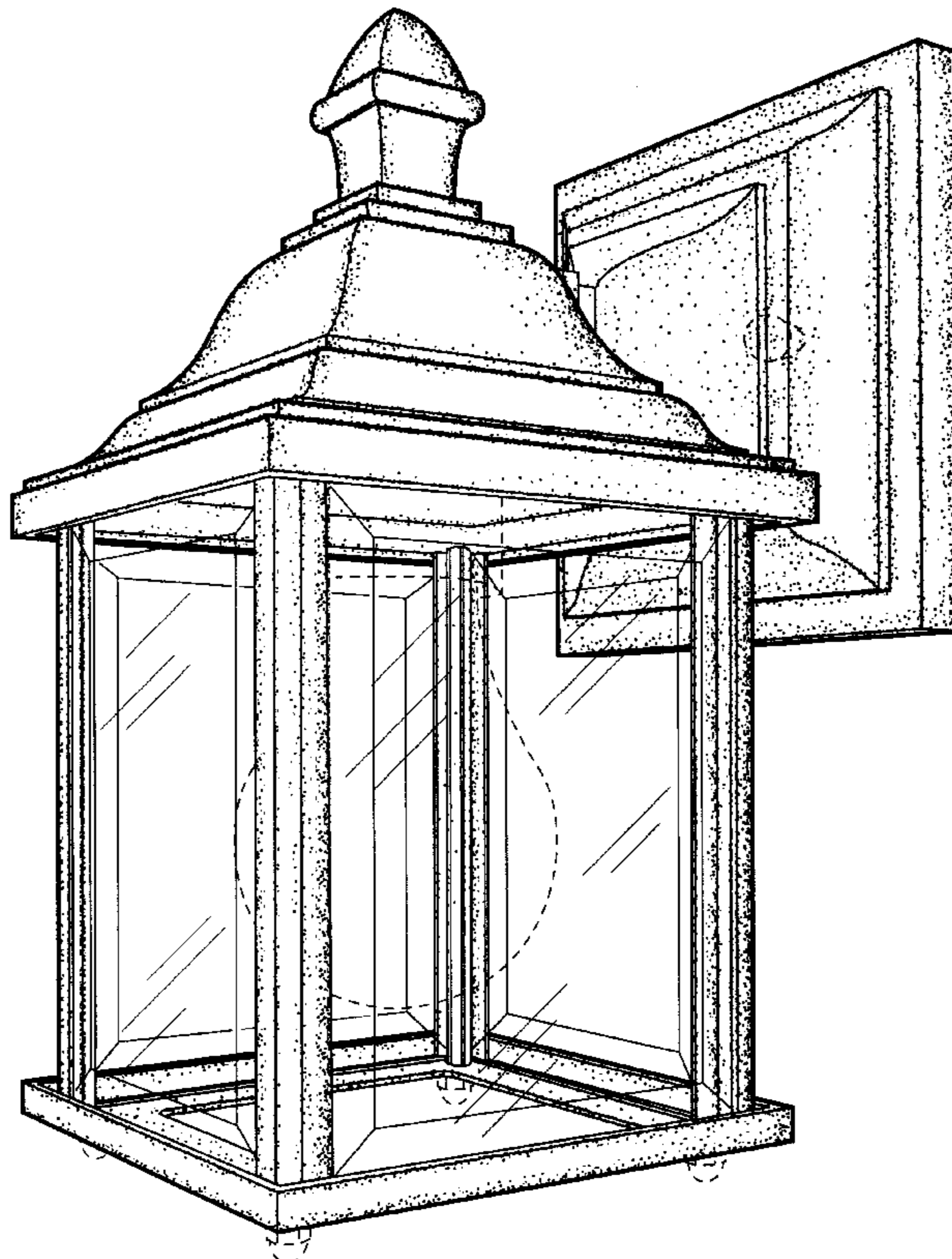
FIG. 4 is a back plan view thereof;

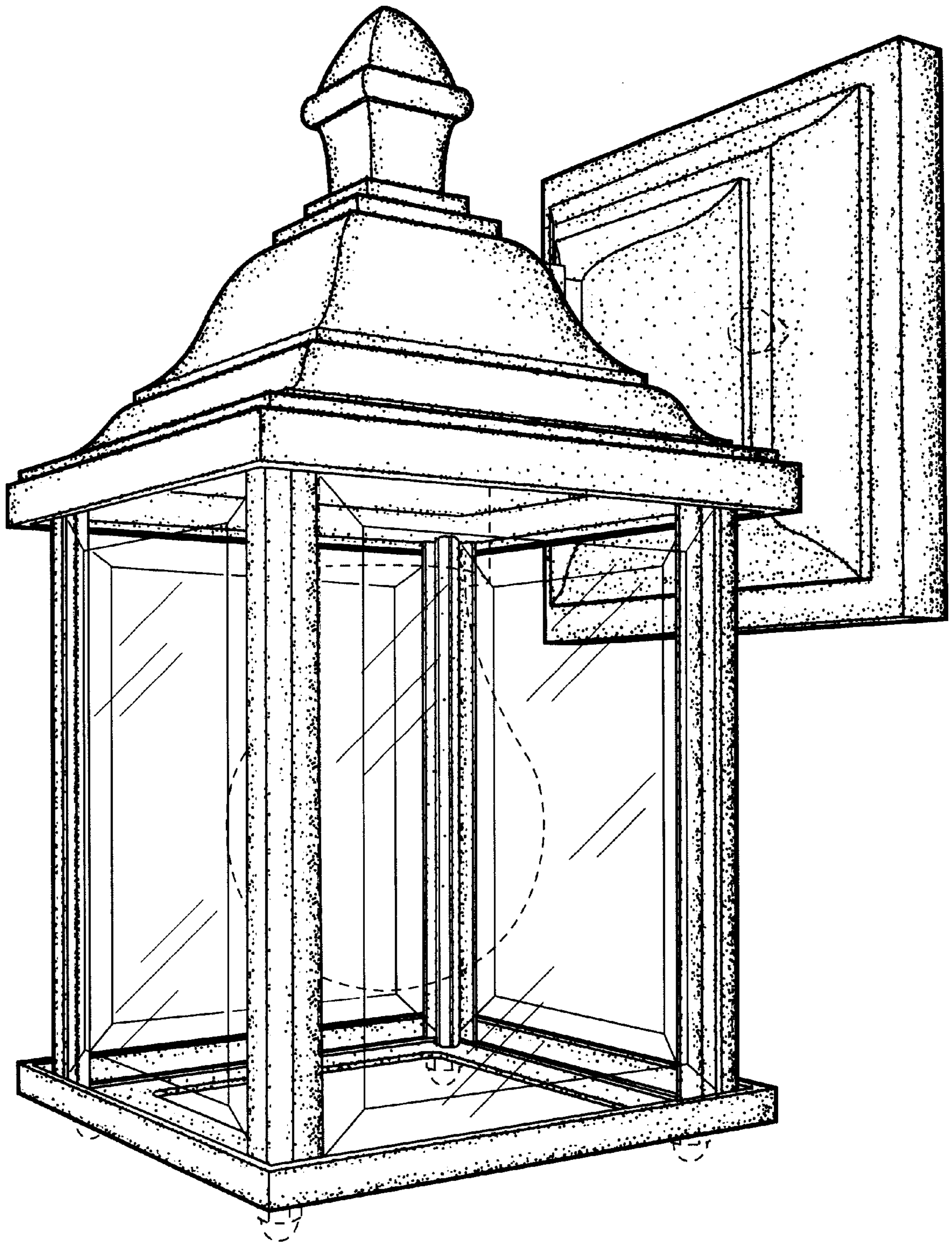

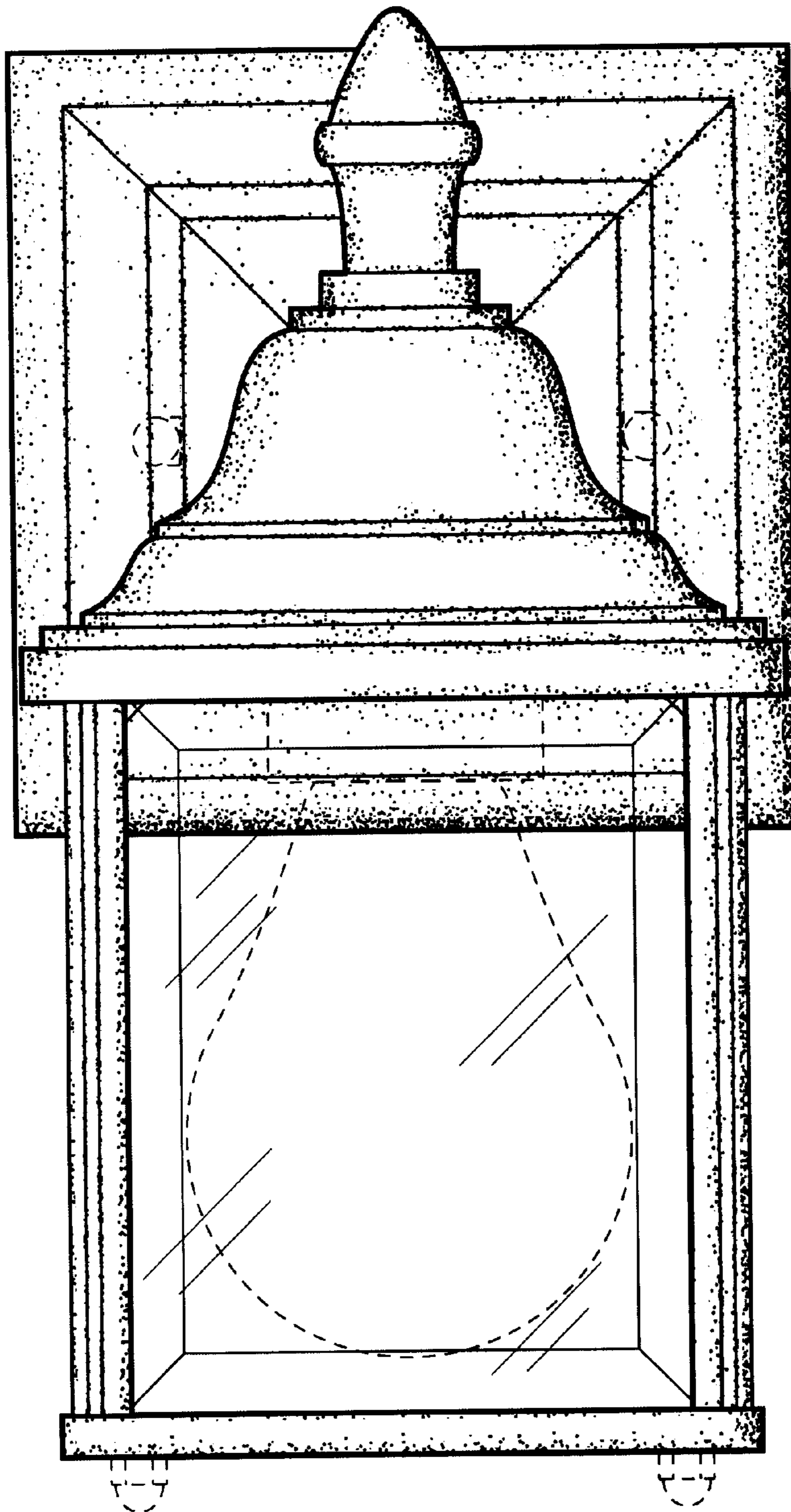

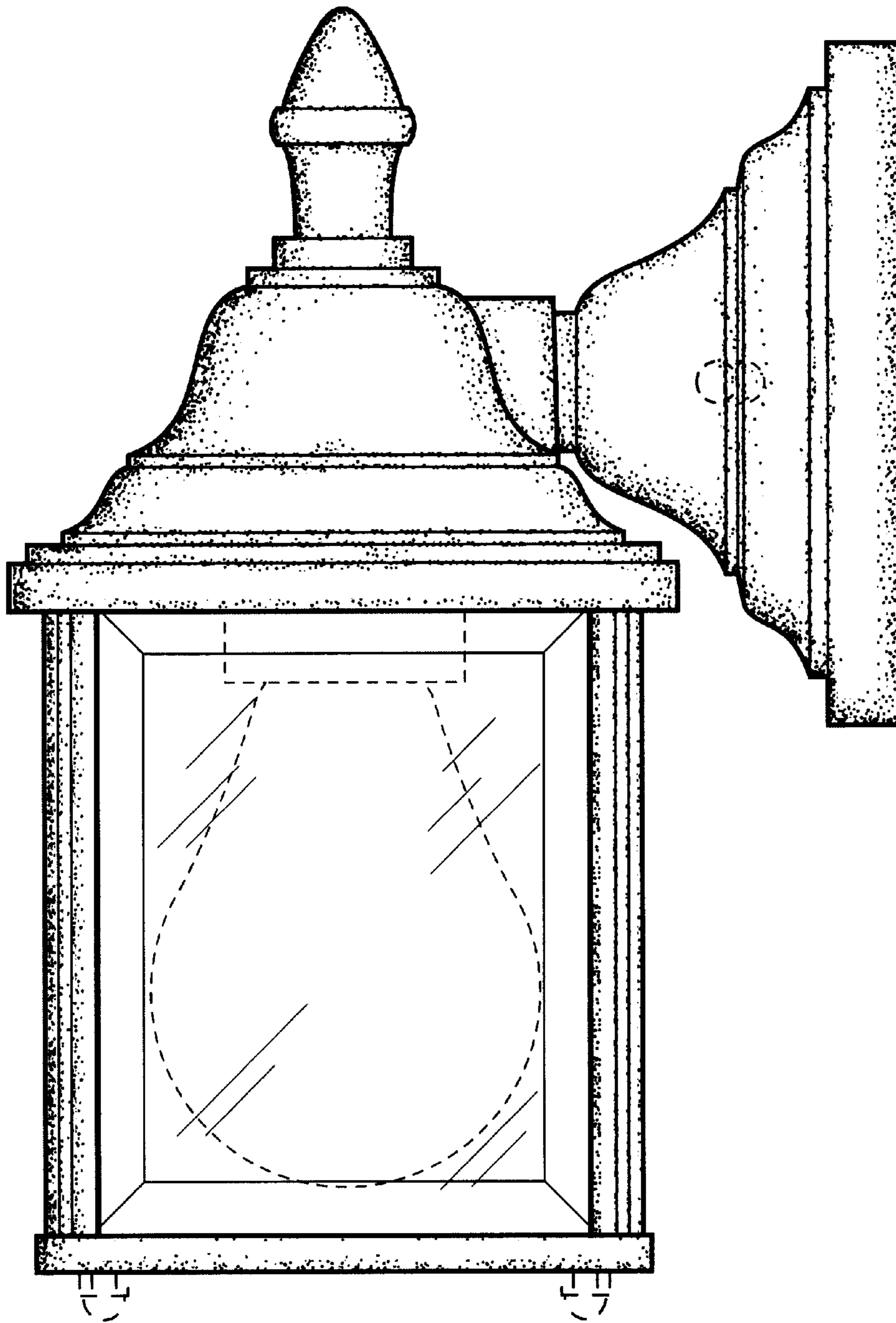

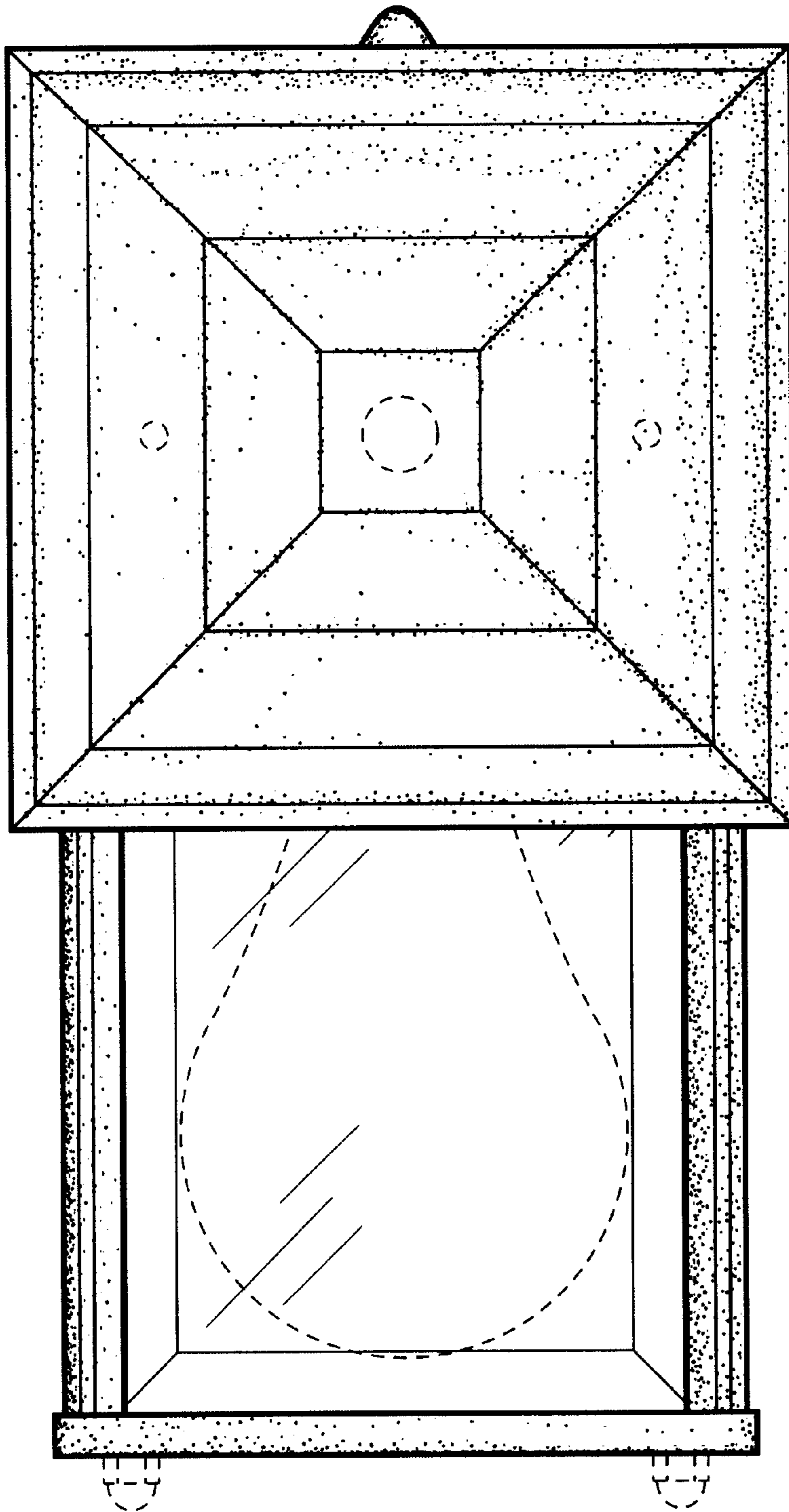

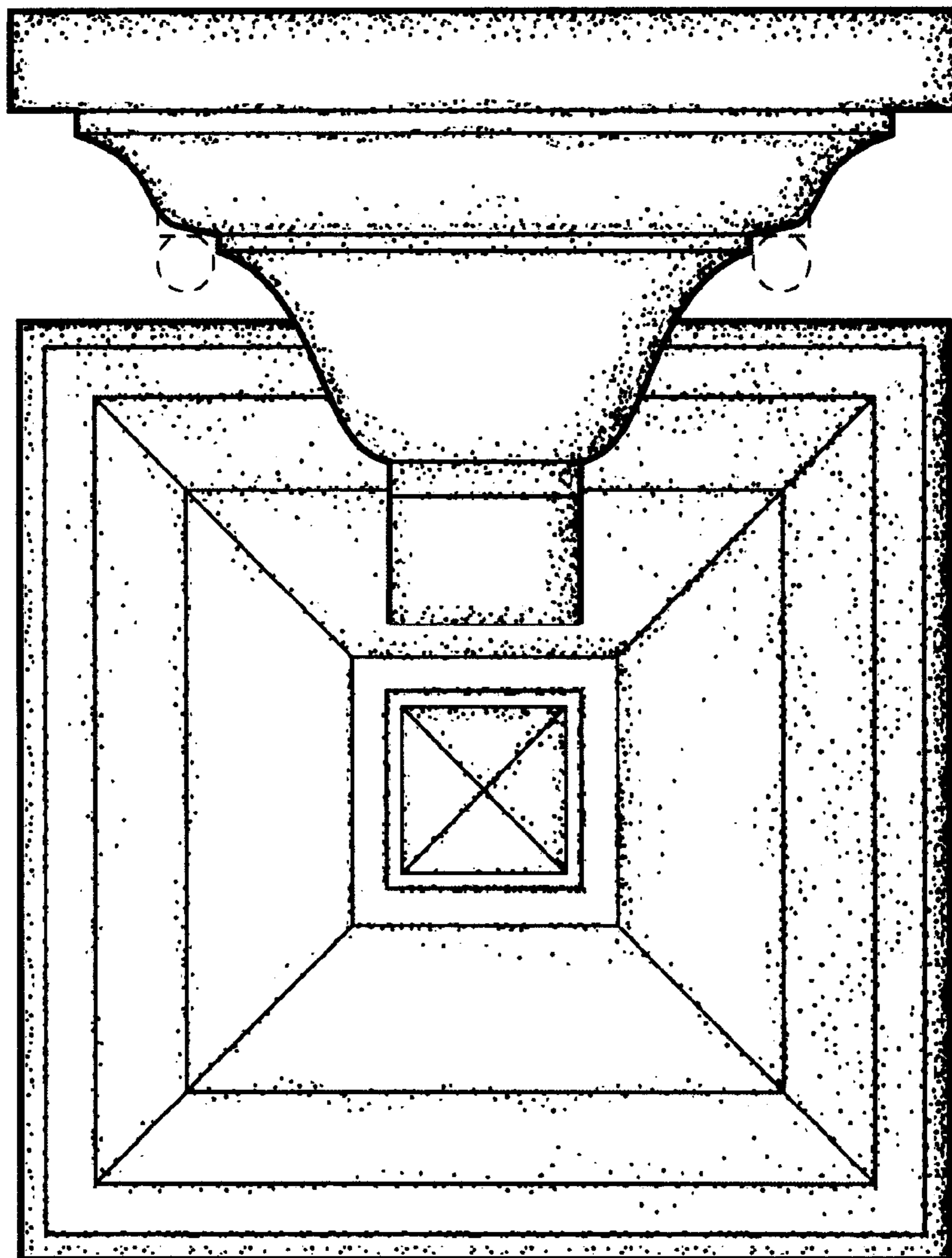

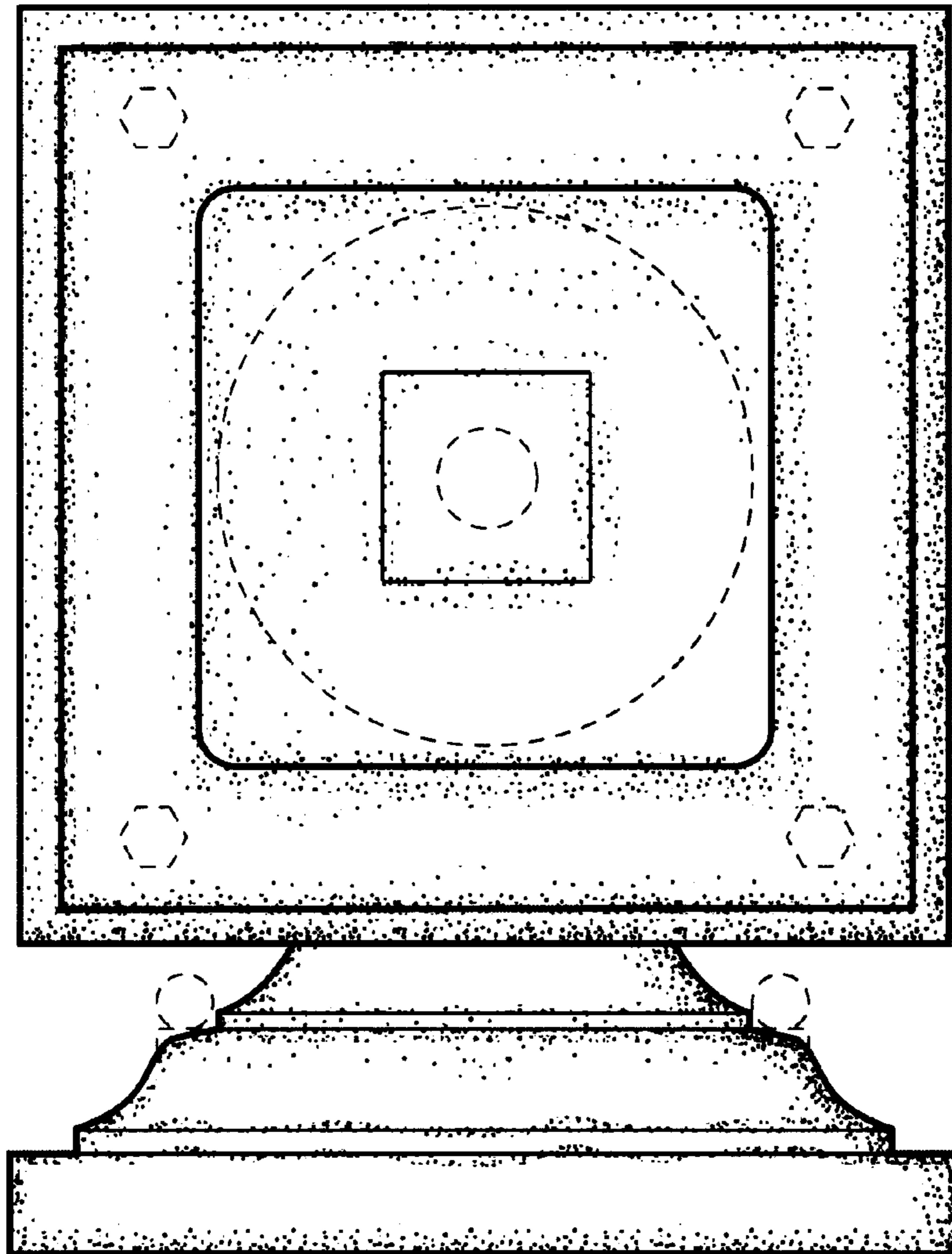
