(57) **CLAIM**

I claim the ornamental design for a hard case for a PDA, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a hard case for a PDA embodying the design.

FIG. 2 is front view of the hard case.

FIG. 3 is a back view of the hard case.

FIG. 4 is a bottom view of the hard case.

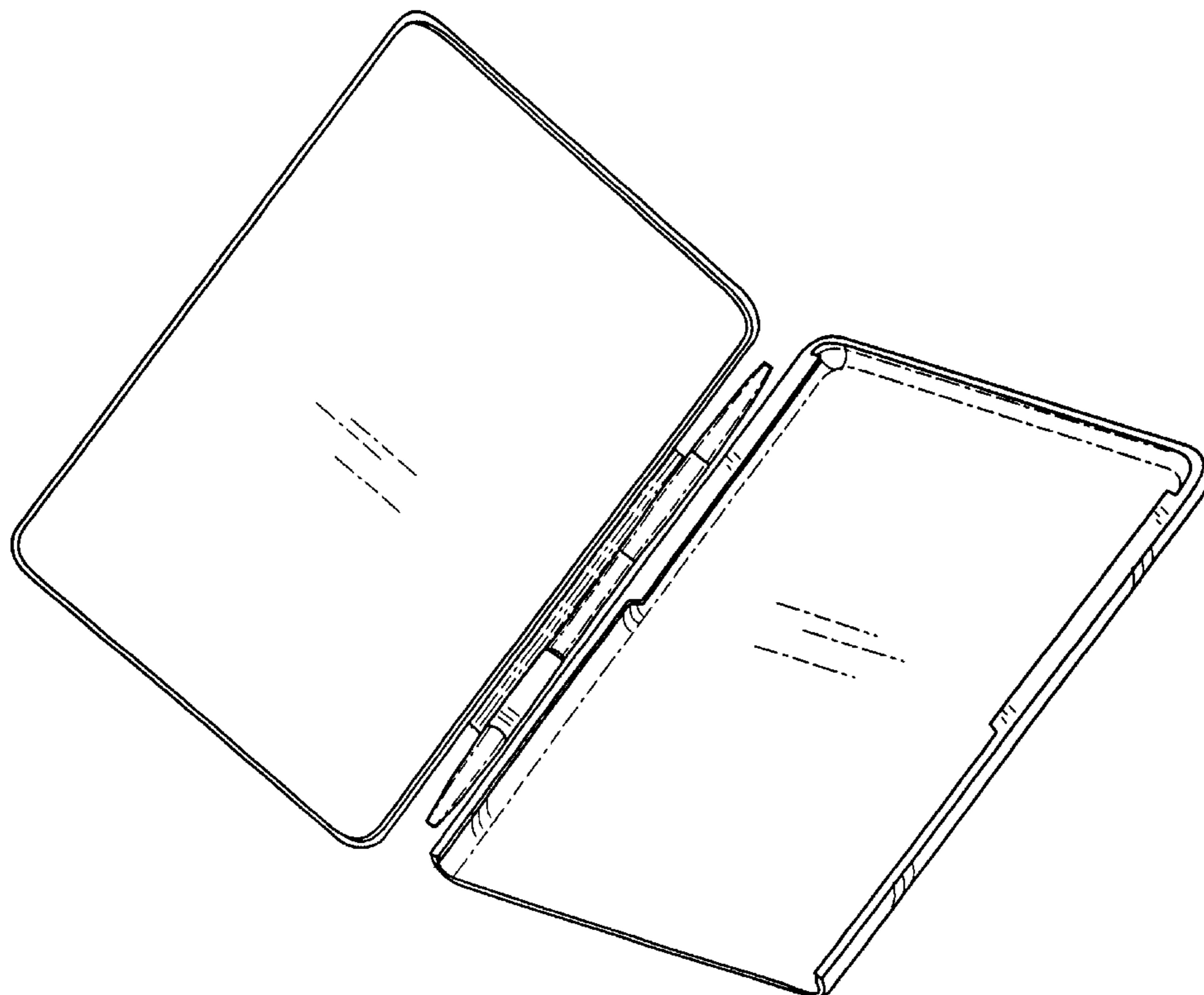
FIG. 5 is a plan view of the hard case viewed from the left side of FIG. 1.

FIG. 6 is a plan view of the hard case viewed from the right side of FIG. 1.

FIG. 7 is a perspective view shown on a reduced scale of the hard case in an open position with no button depressions; and,

FIG. 8 is a perspective view shown on a reduced scale of the hard case in an open position with button depressions.

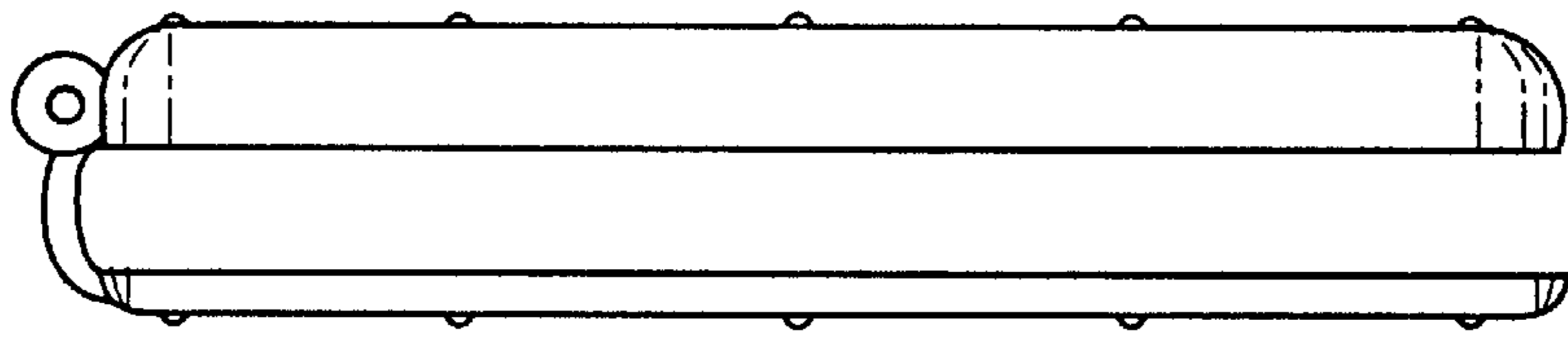

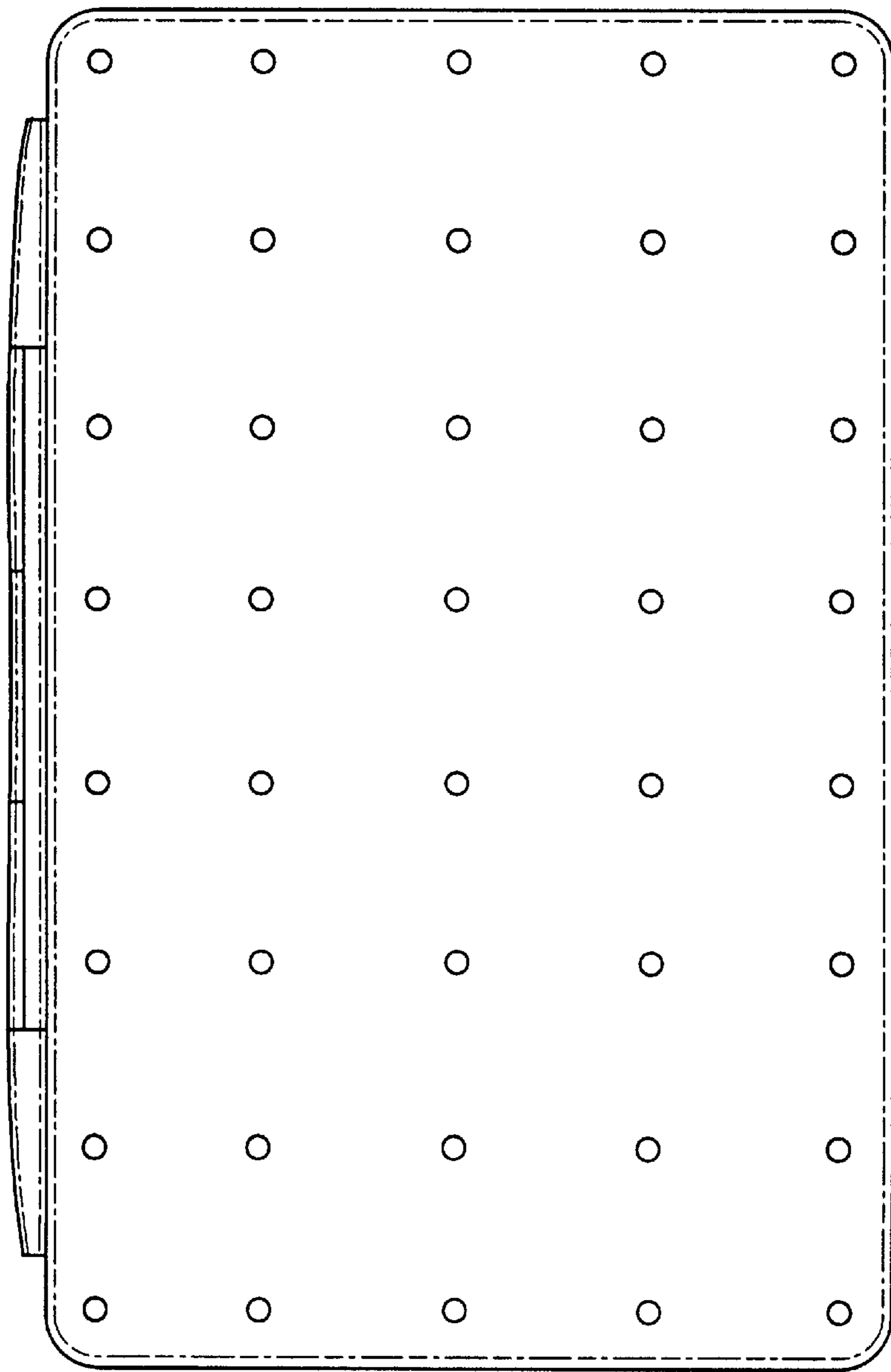

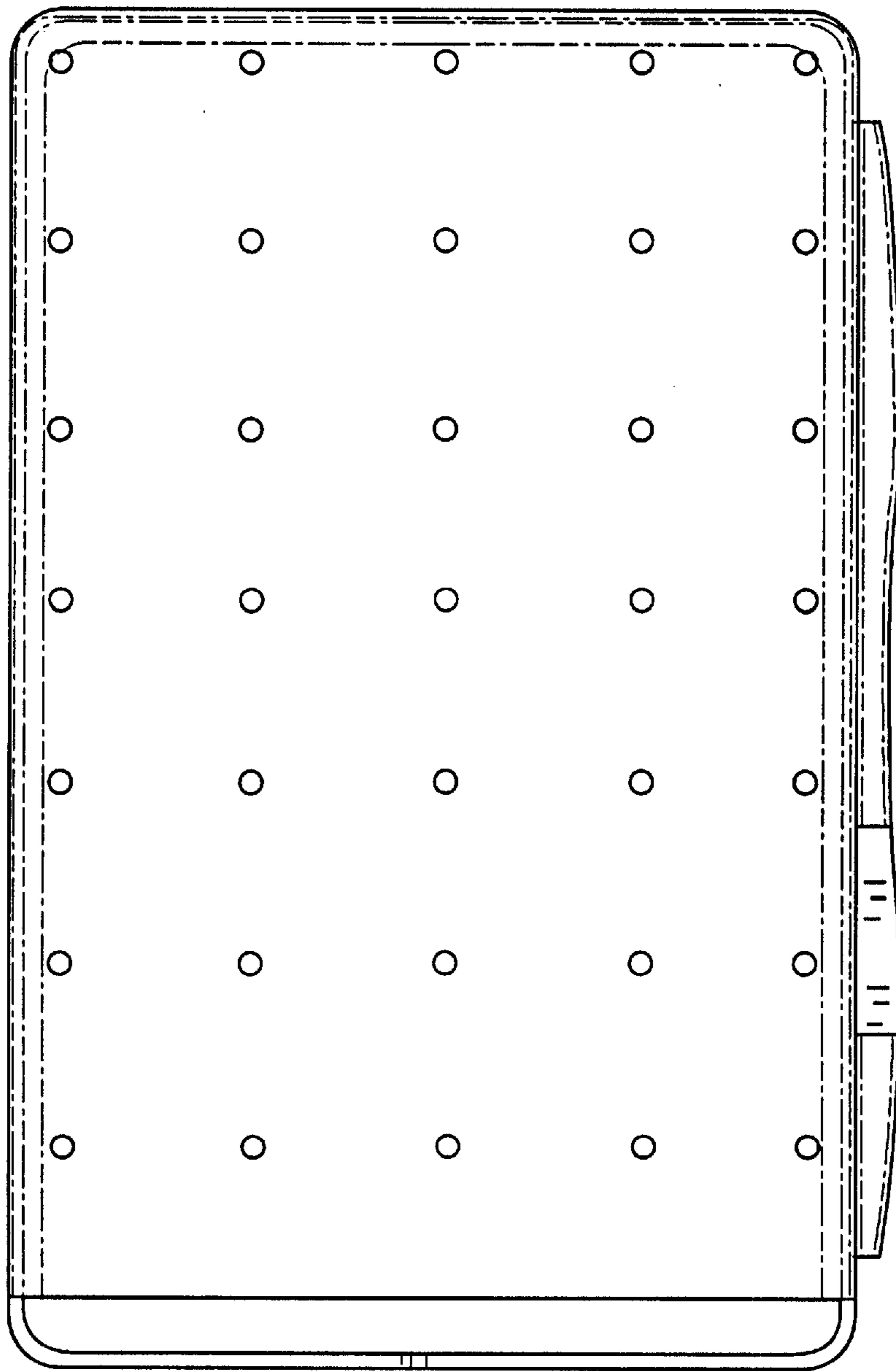

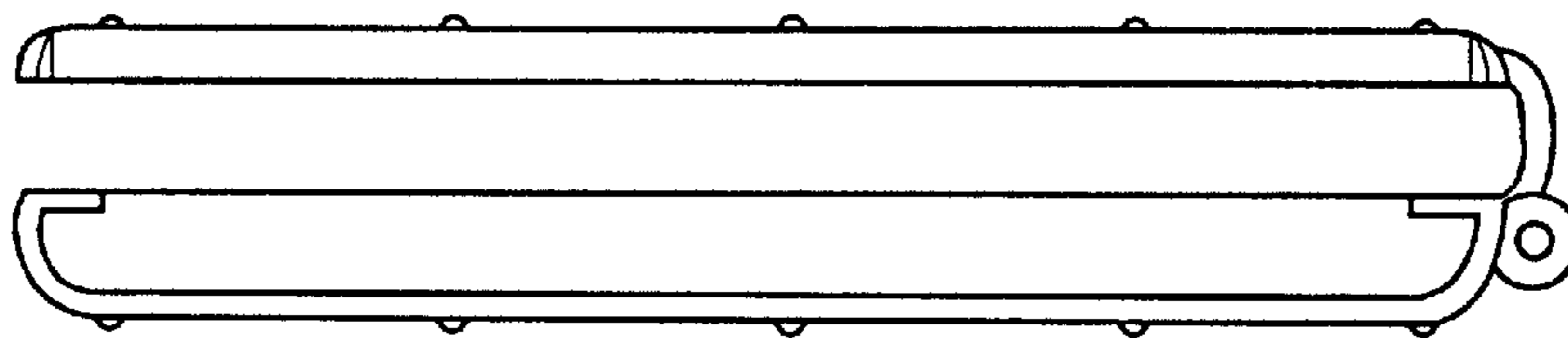

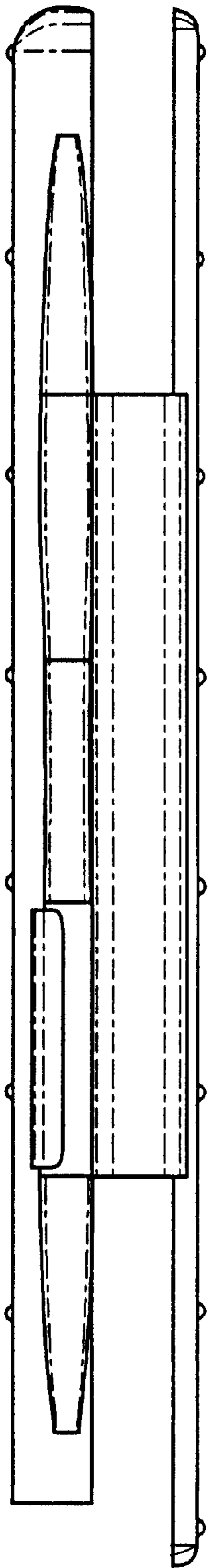

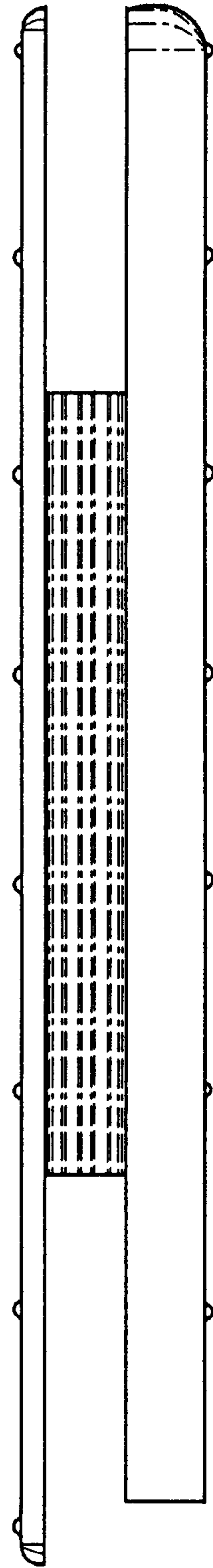

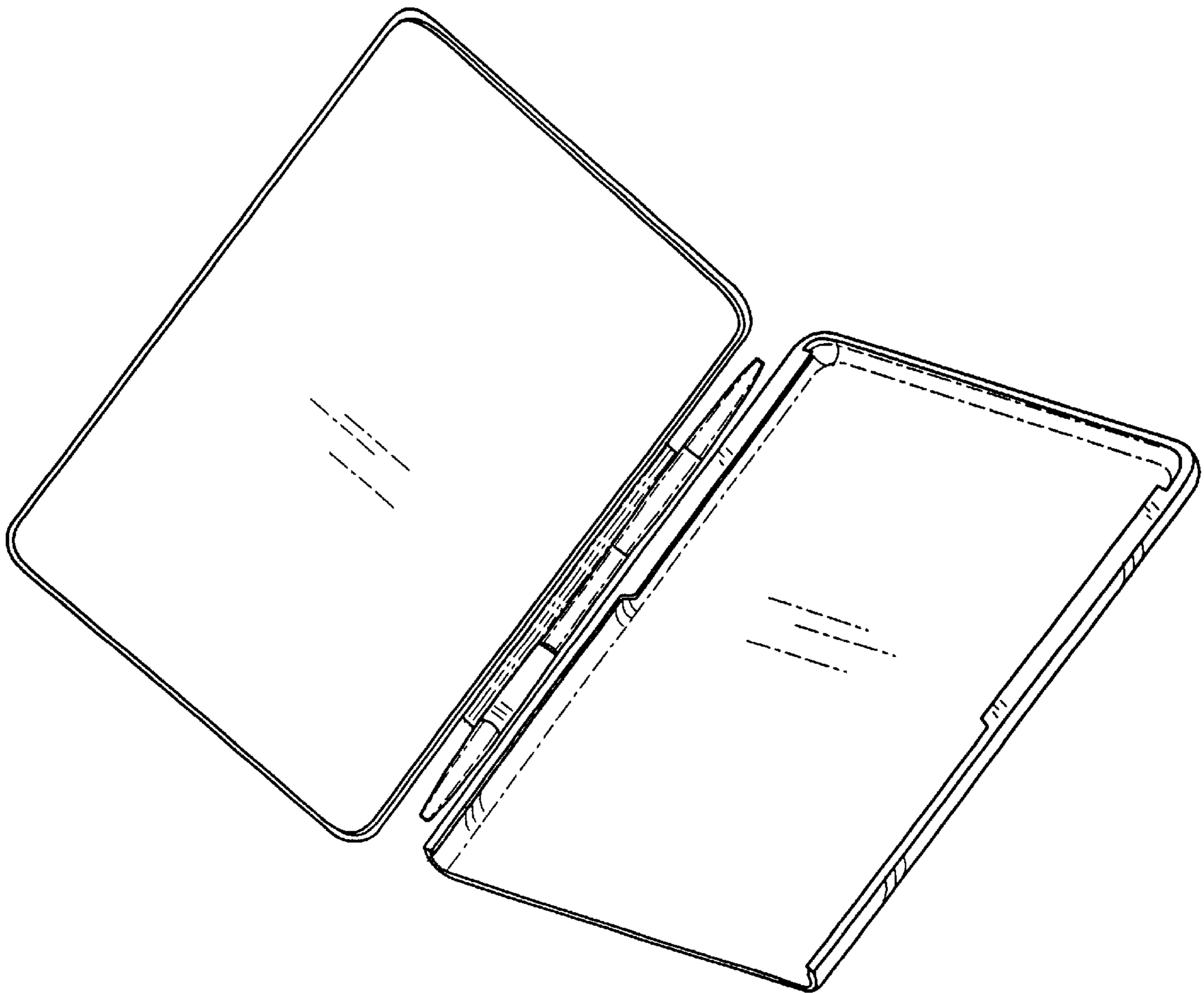

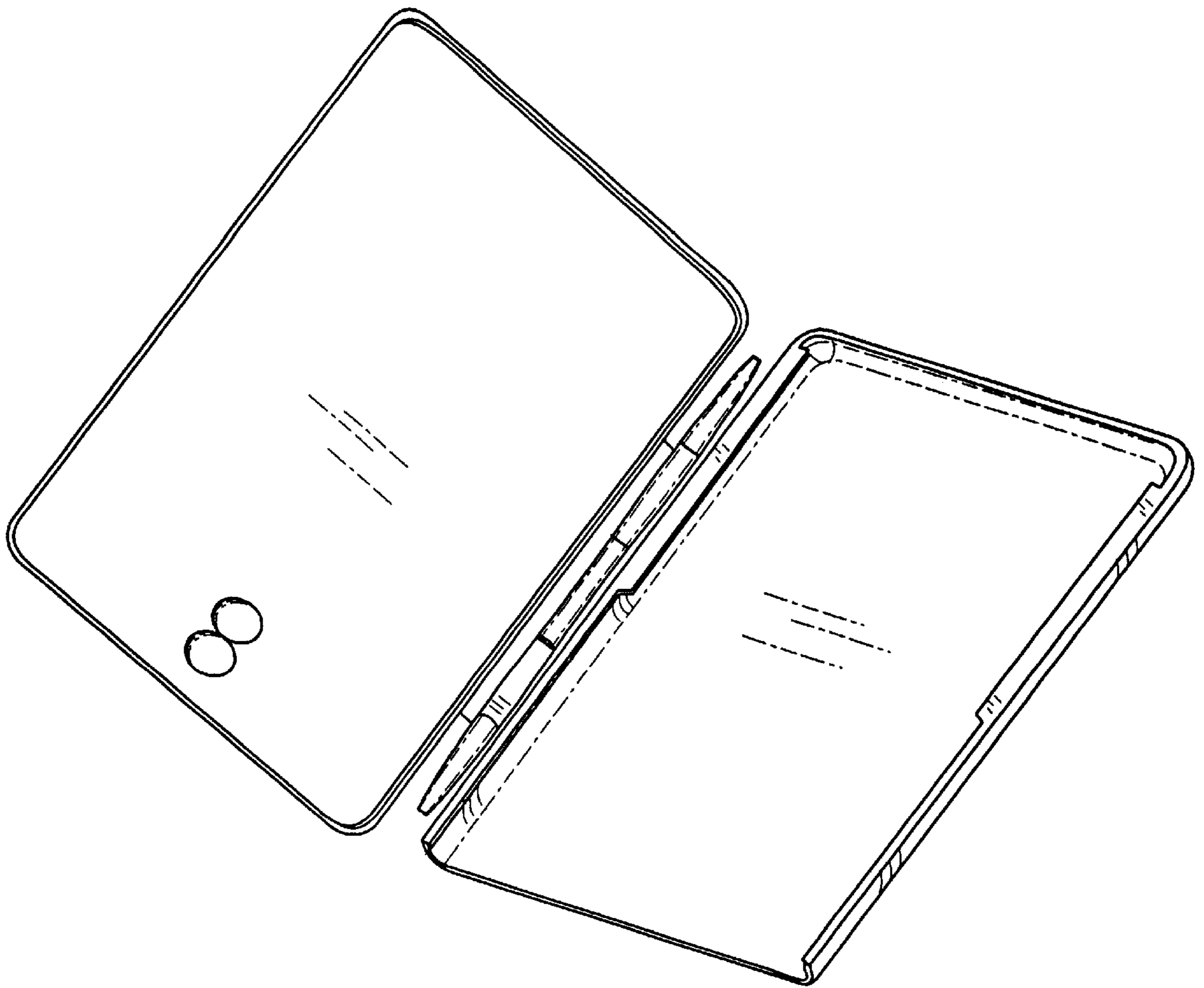
