The ornamental design for packaging for an electronic game accessory, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the packaging for an electronic game accessory according to the present invention.

 FIG. 3 is a front view of the packaging of FIG. 1.
 FIG. 4 is a rear view of the packaging of FIG. 1.

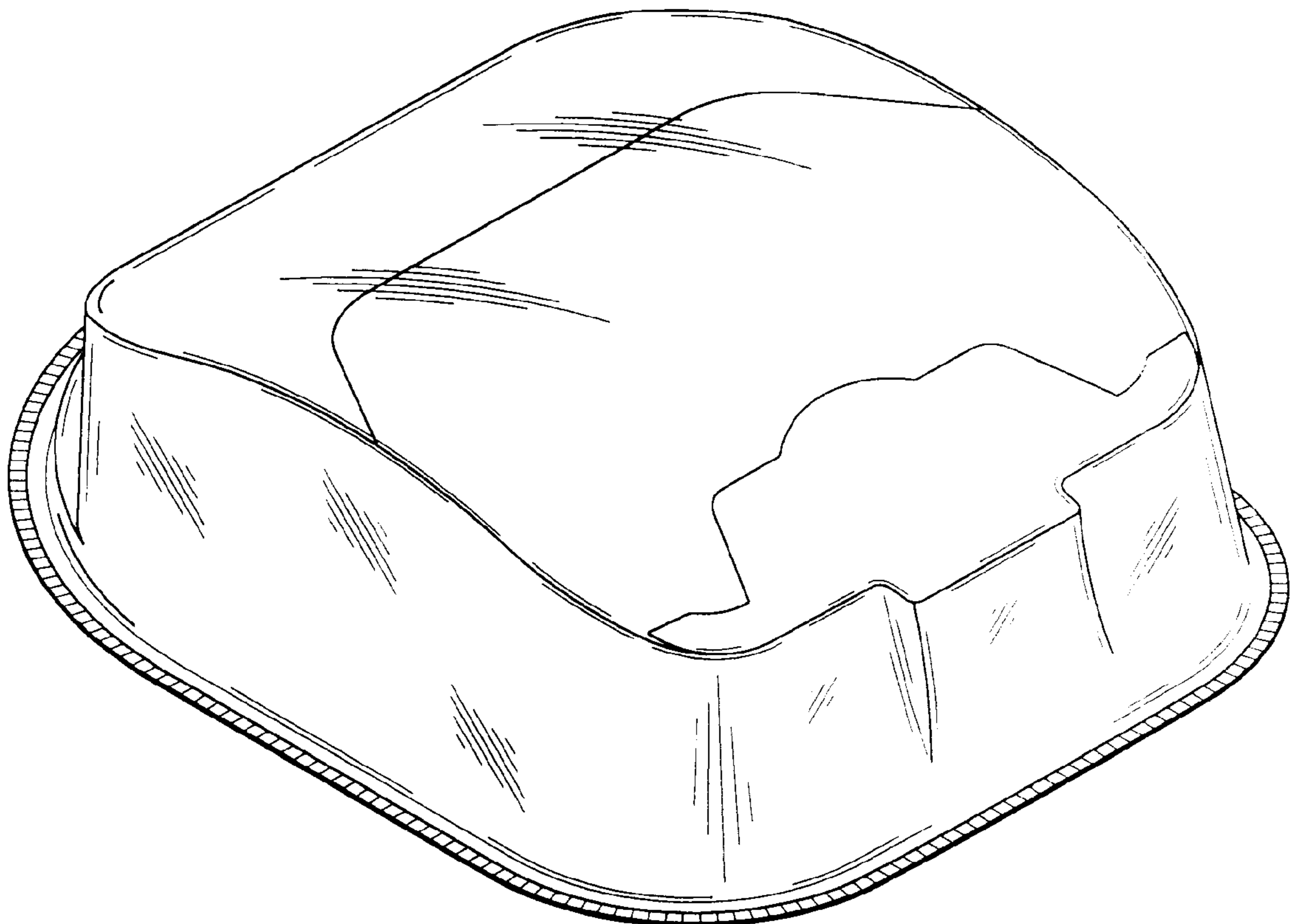

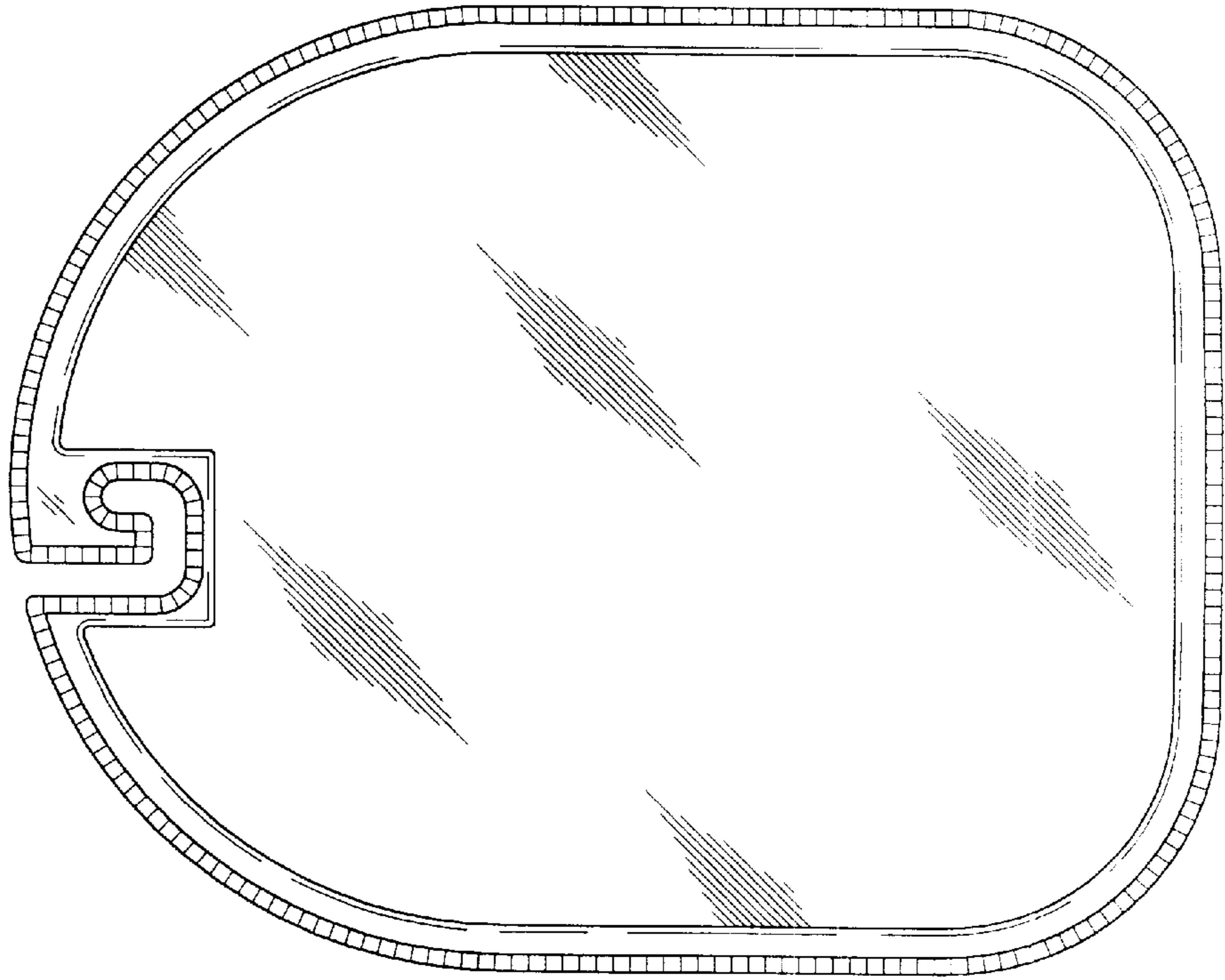

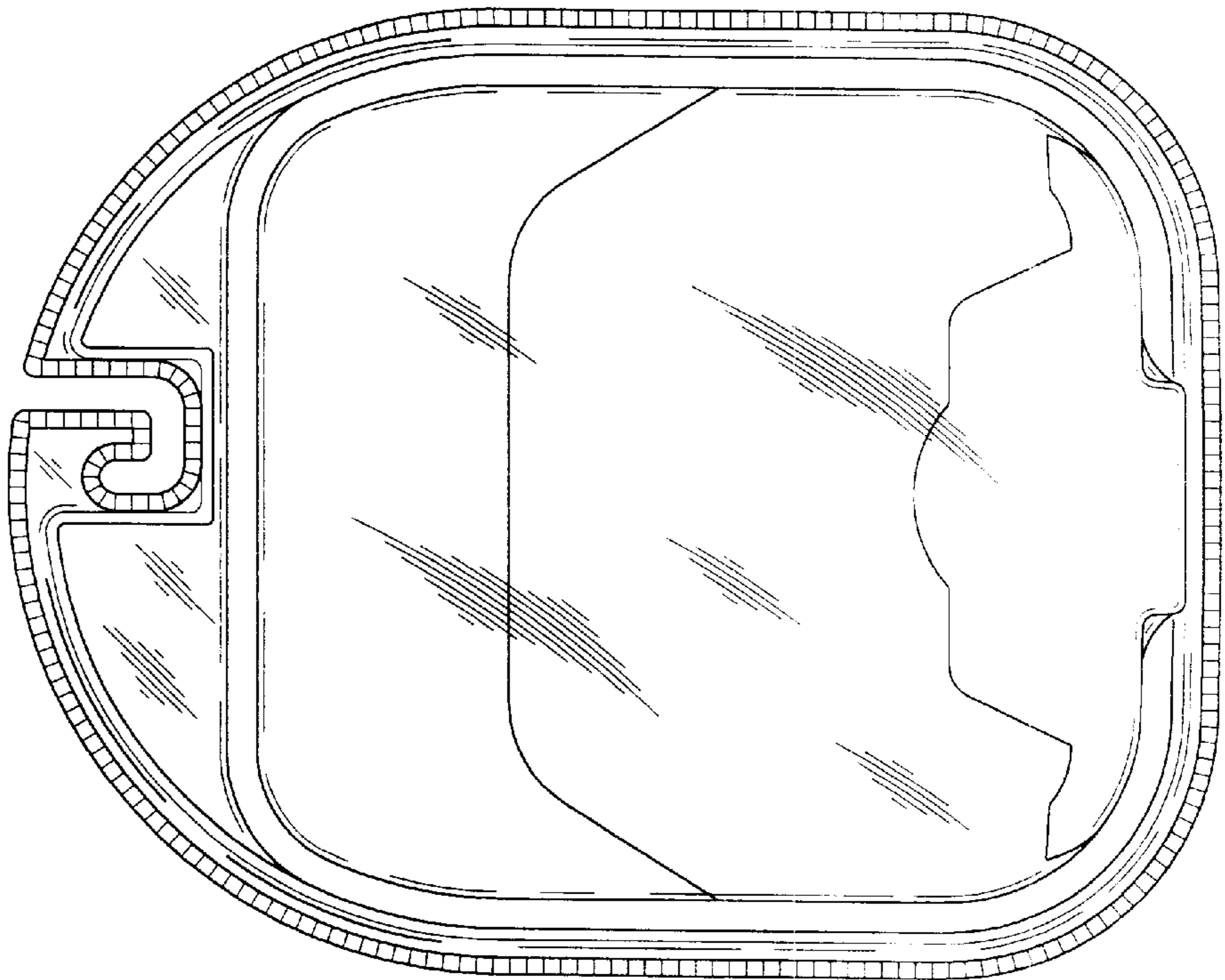

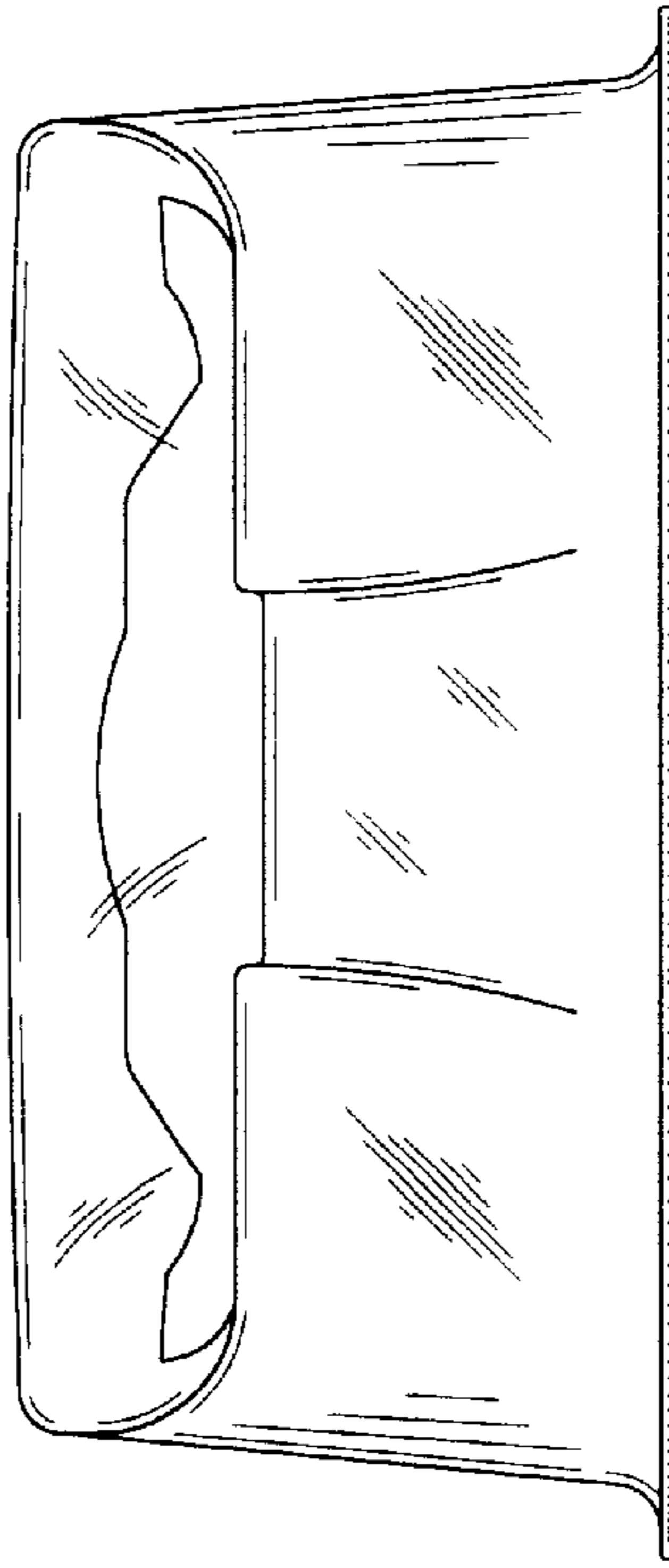

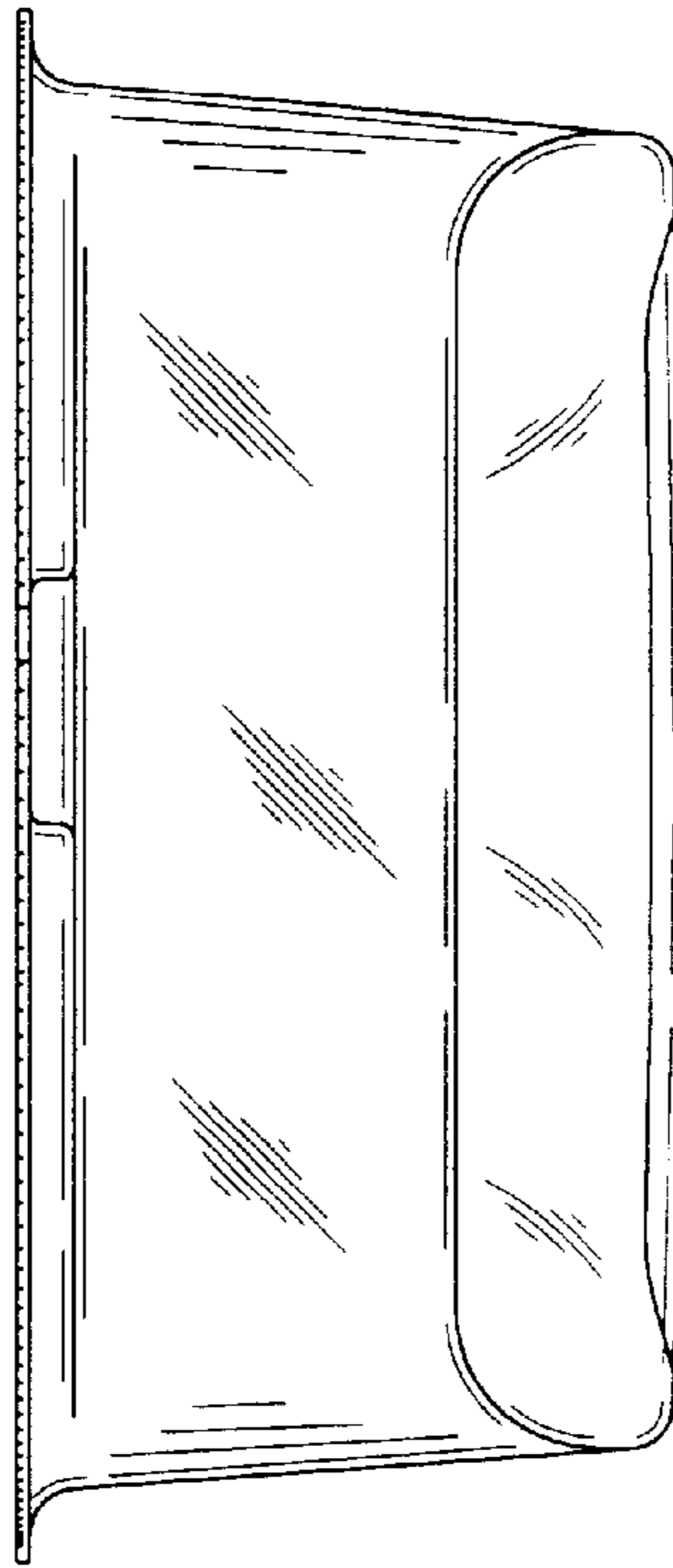

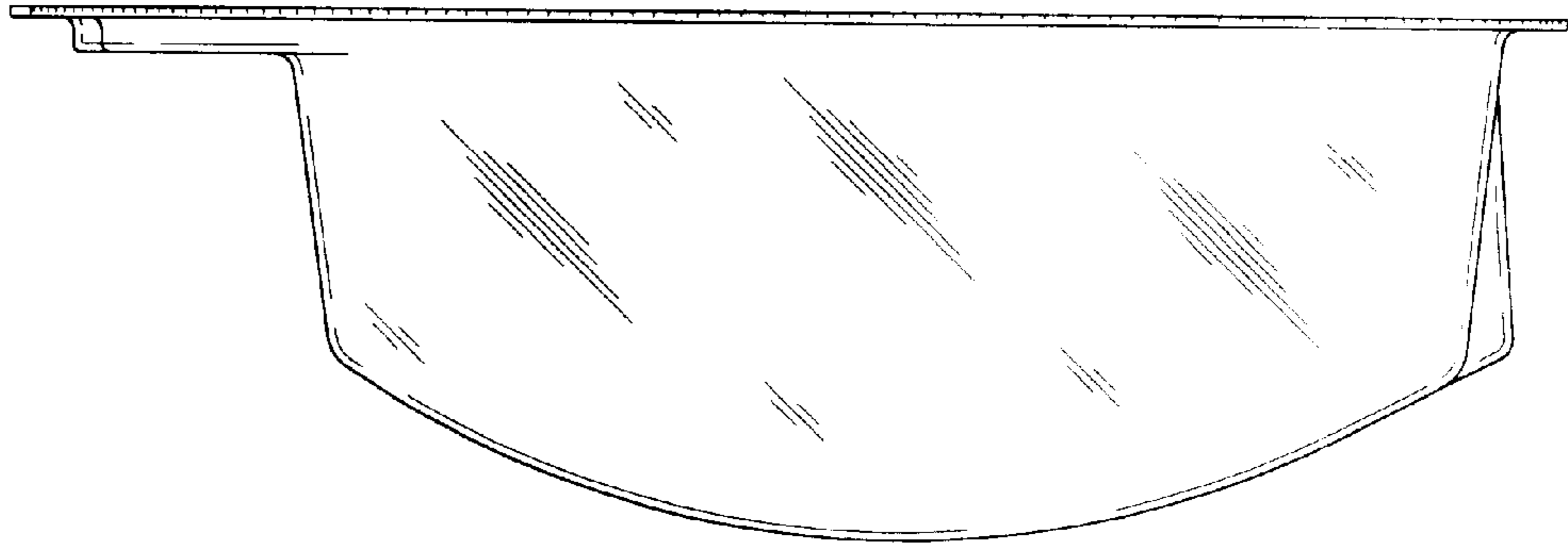

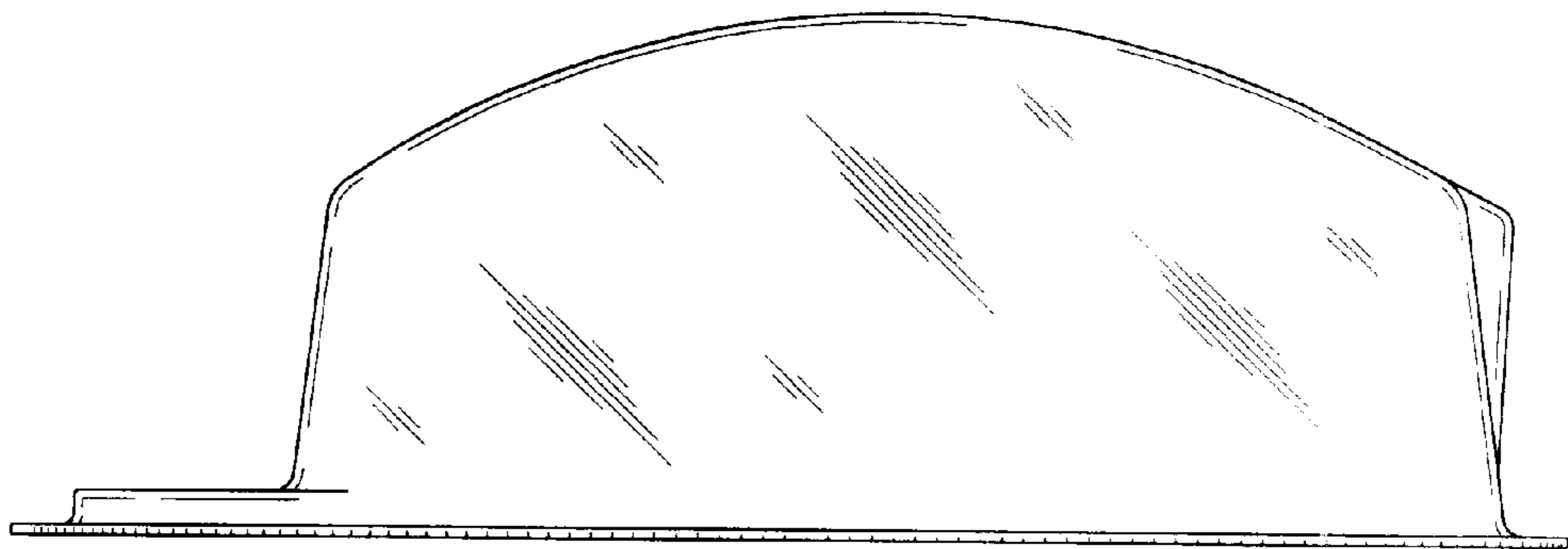
