We claim the ornamental design for T-ball kit, as shown.

DESCRIPTION

FIG. 1 is a perspective view showing the T-ball kit of the present invention in a typical environmental position, in its packaging.
FIG. 2 is a bottom view of the T-ball kit shown in FIG. 1.
FIG. 3 is a front view of the T-ball kit shown in FIG. 1.
FIG. 4 is a left side view of the T-ball kit shown in FIG. 1.
FIG. 5 is a right side view of the T-ball kit shown in FIG. 1.
FIG. 6 is a rear view of the T-ball kit shown in FIG. 1; and, FIG. 7 is the top view of the T-ball kit shown in FIG. 1.

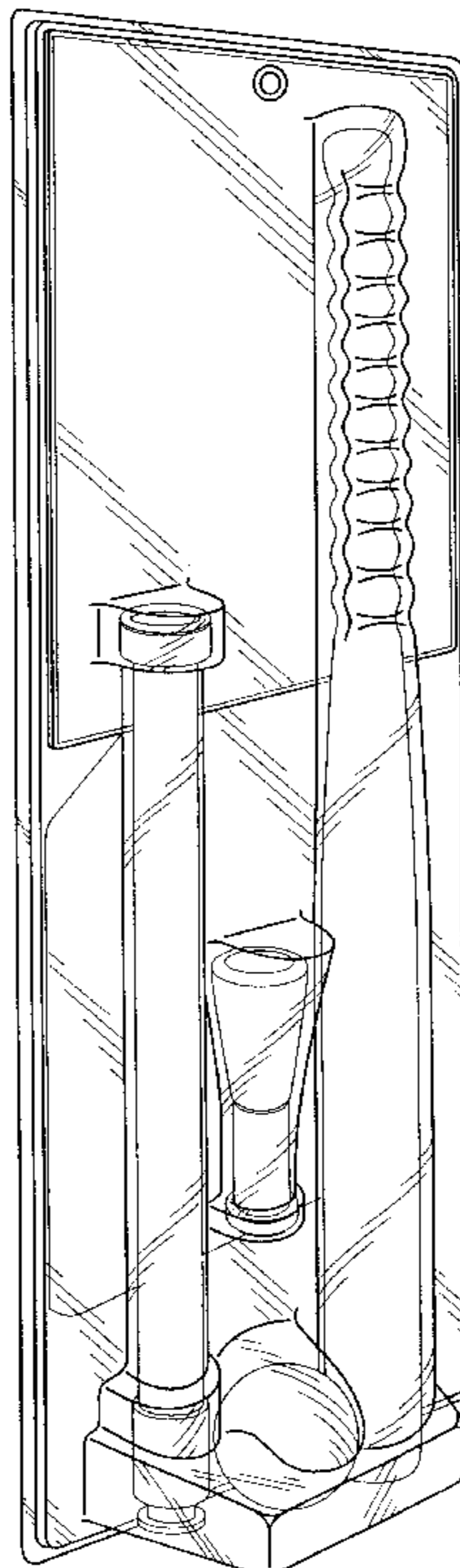

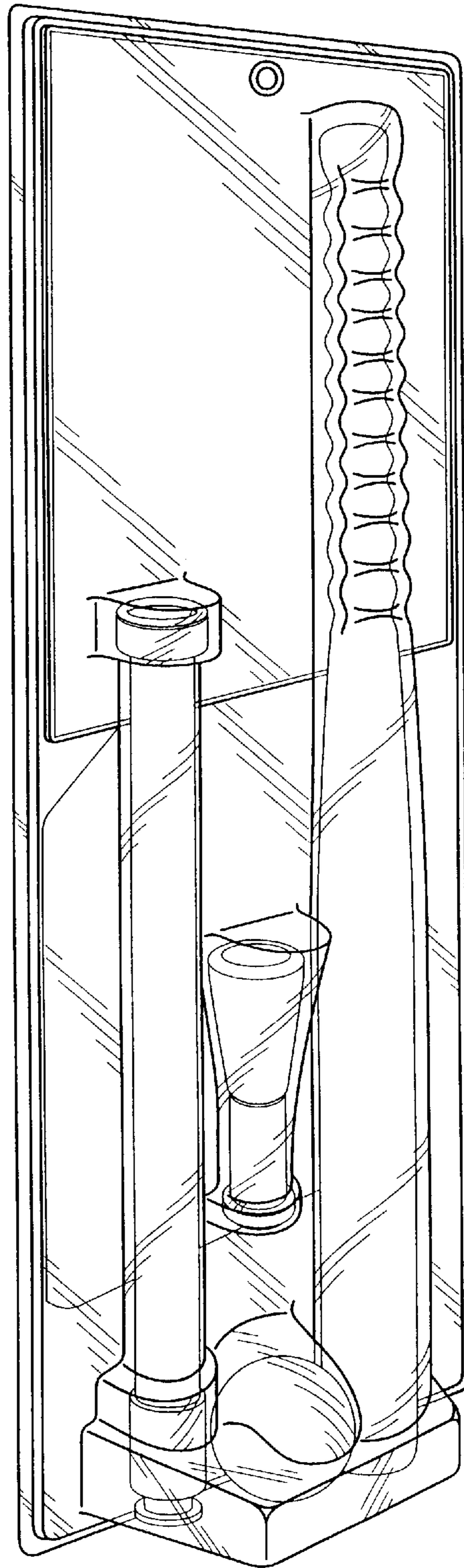

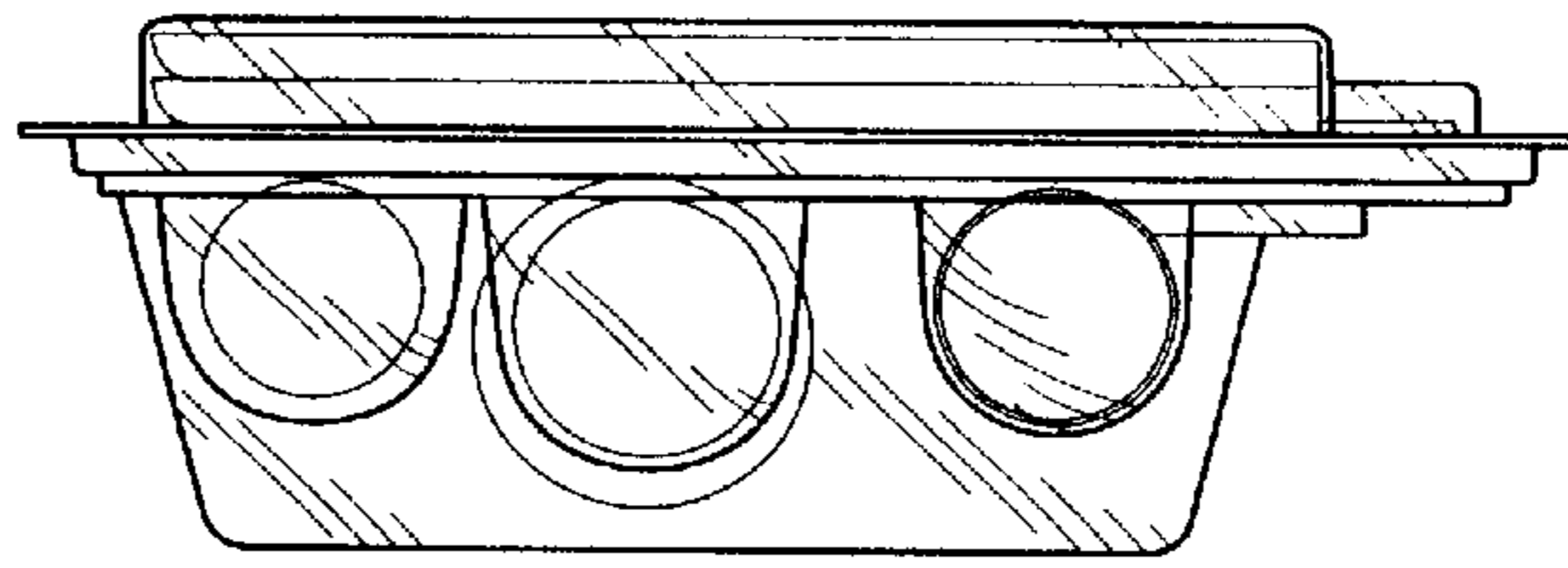

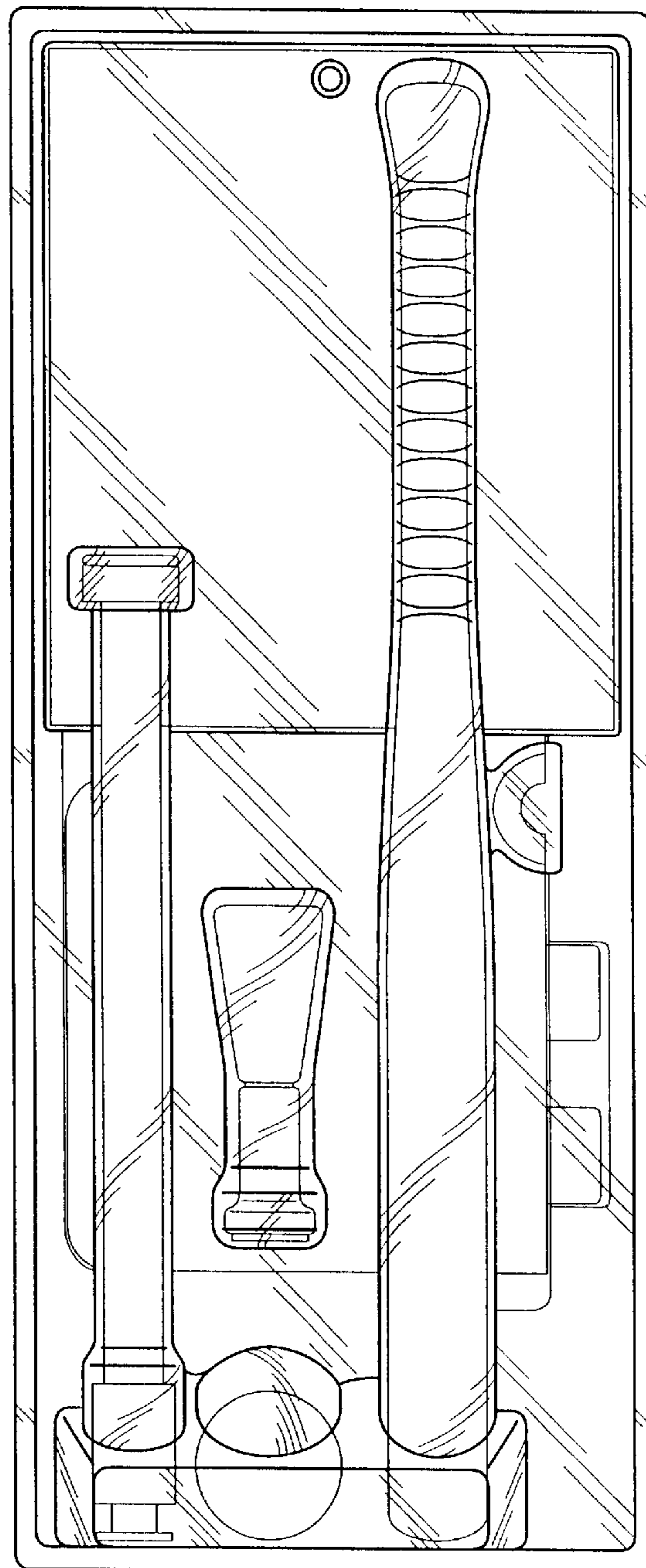

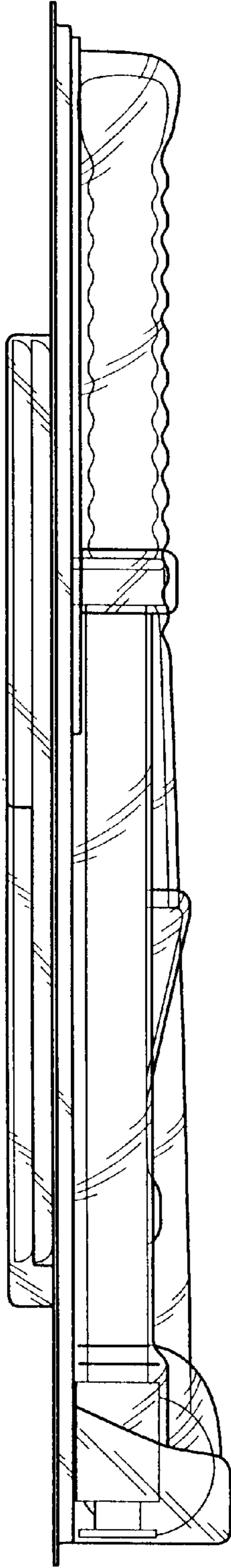

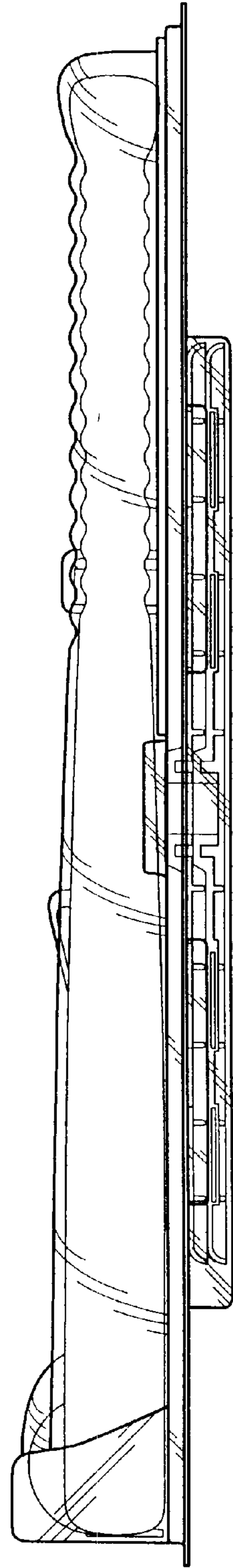

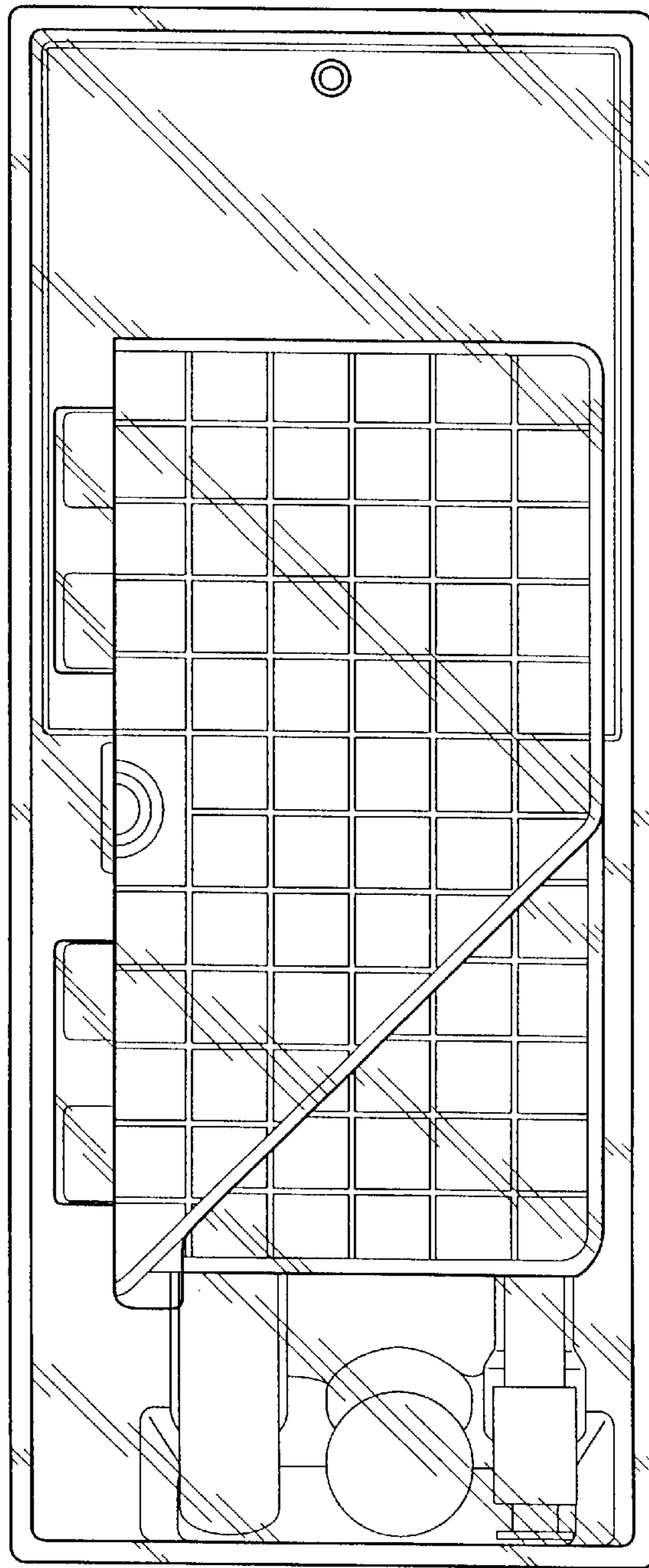
