**DESCRIPTION**

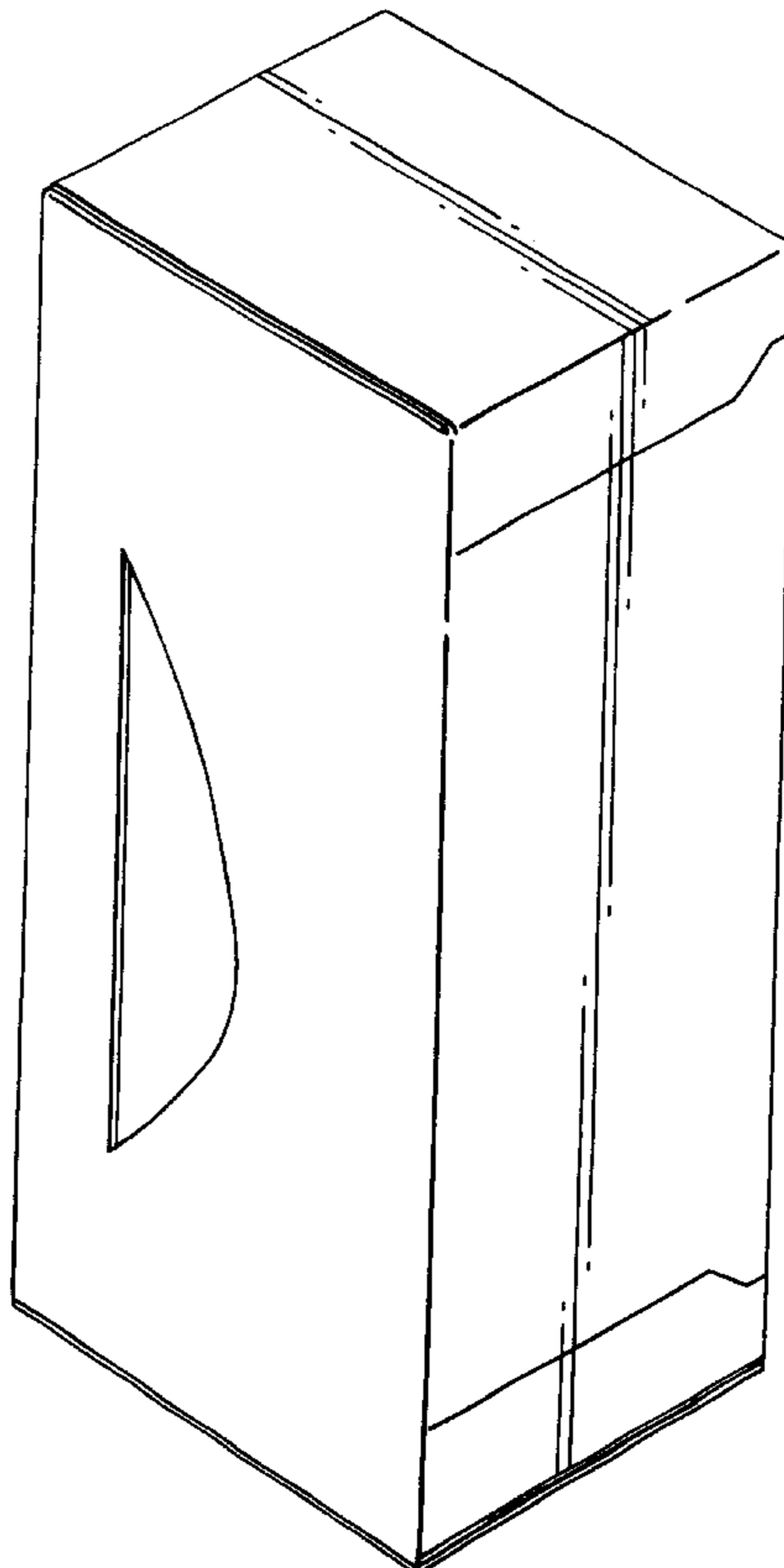
FIG. 1 is a perspective view showing the front, top and right side of a container—particularly for a pantiliner embodying our design;

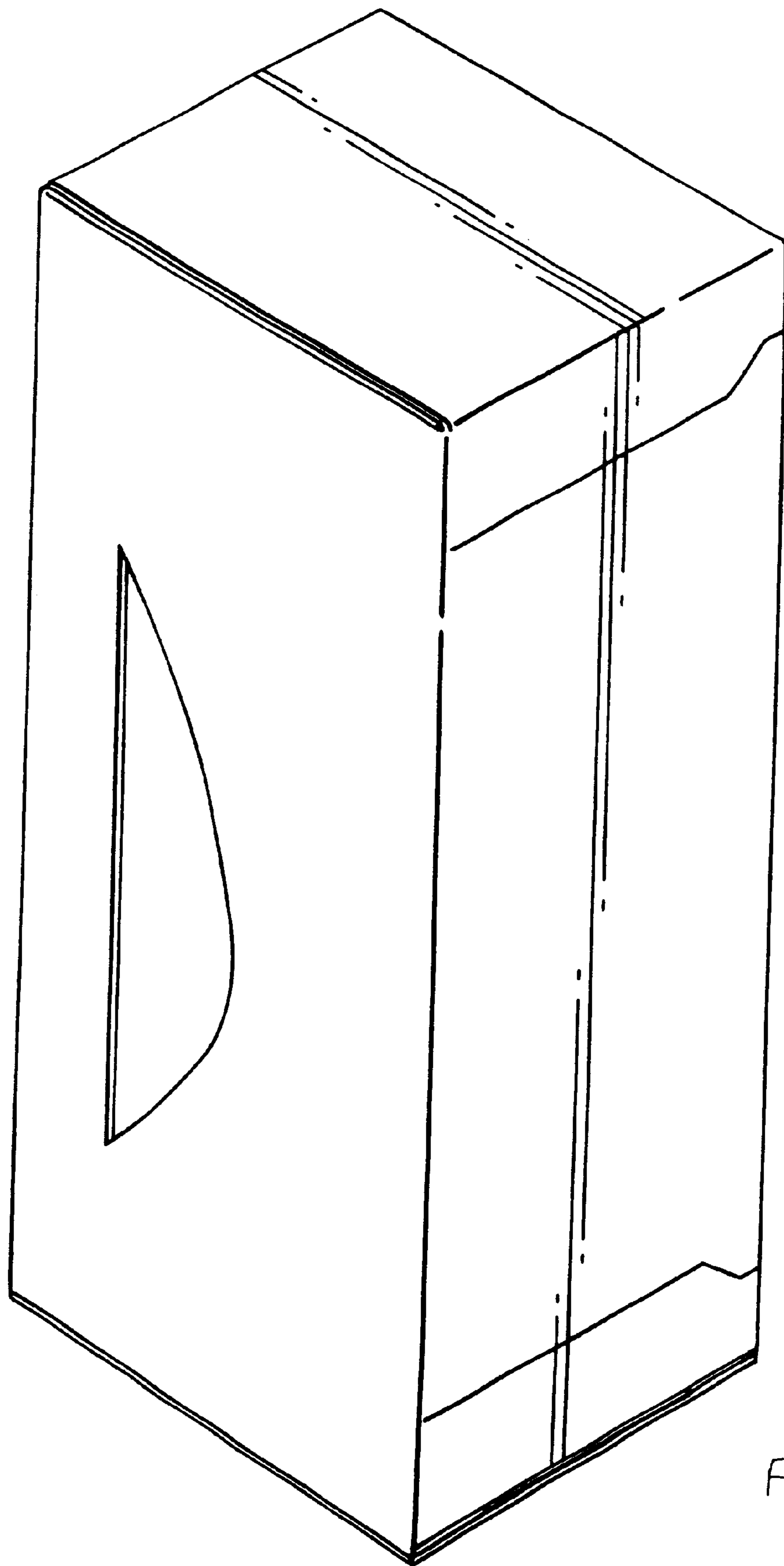

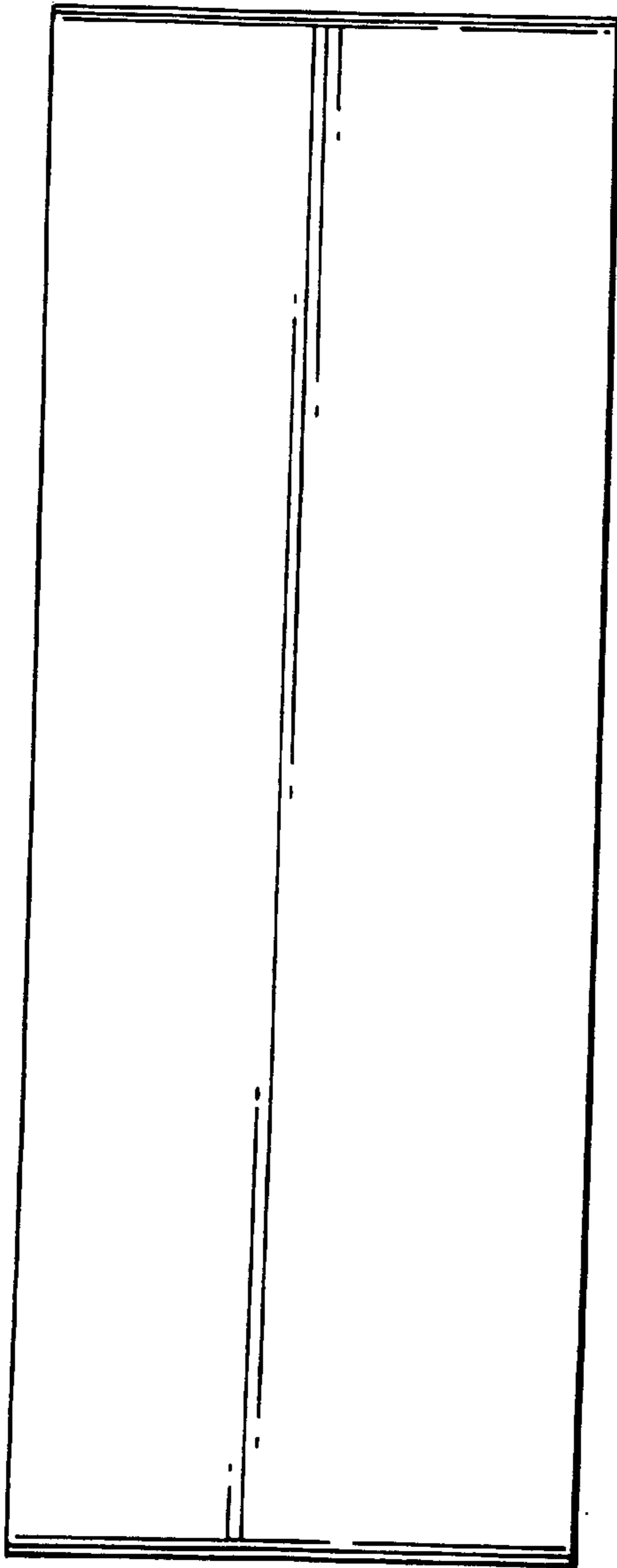

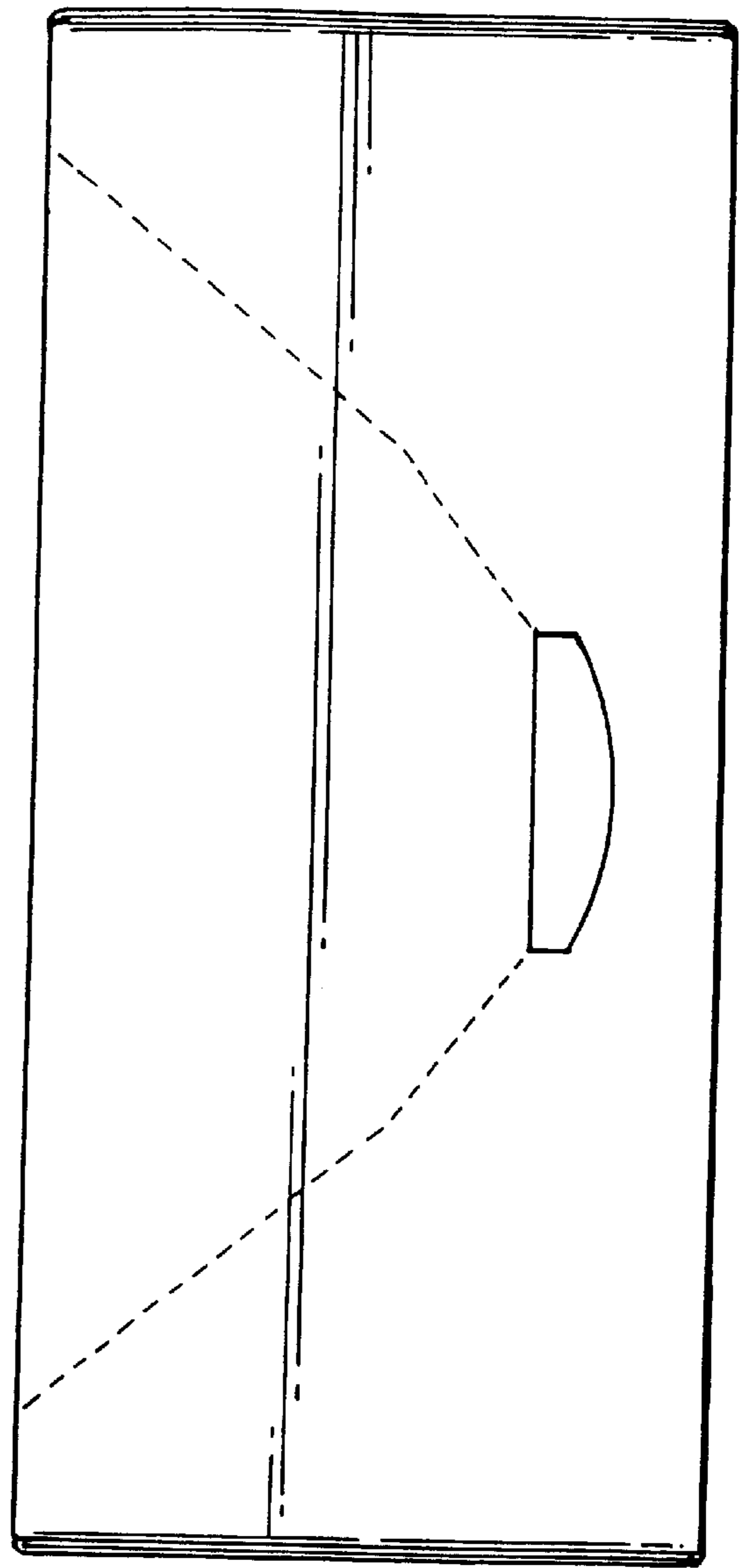

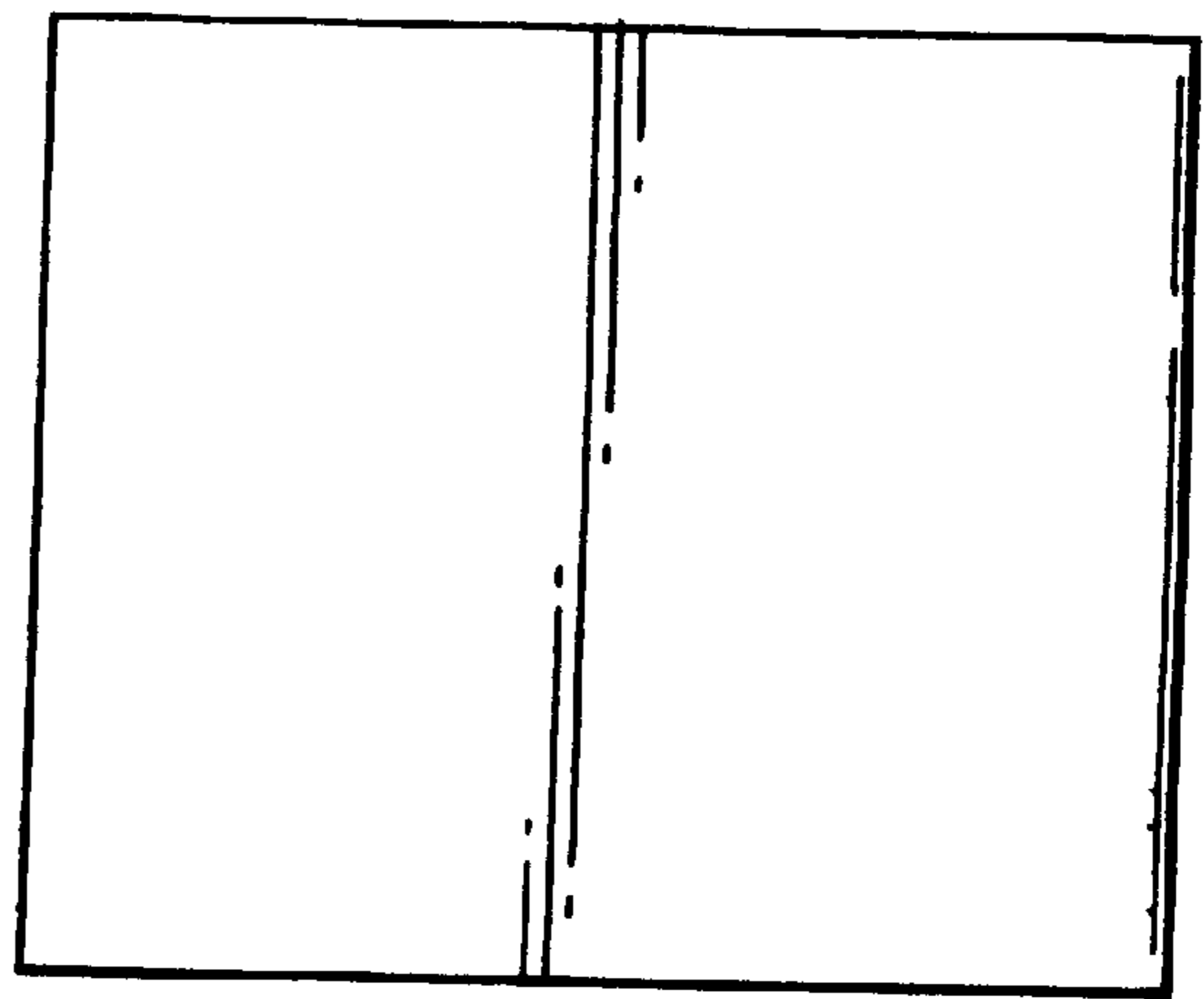
