The ornamental design for a toy, as shown and described.

**DESCRIPTION**

FIG. 26 is right side elevational view thereof; and

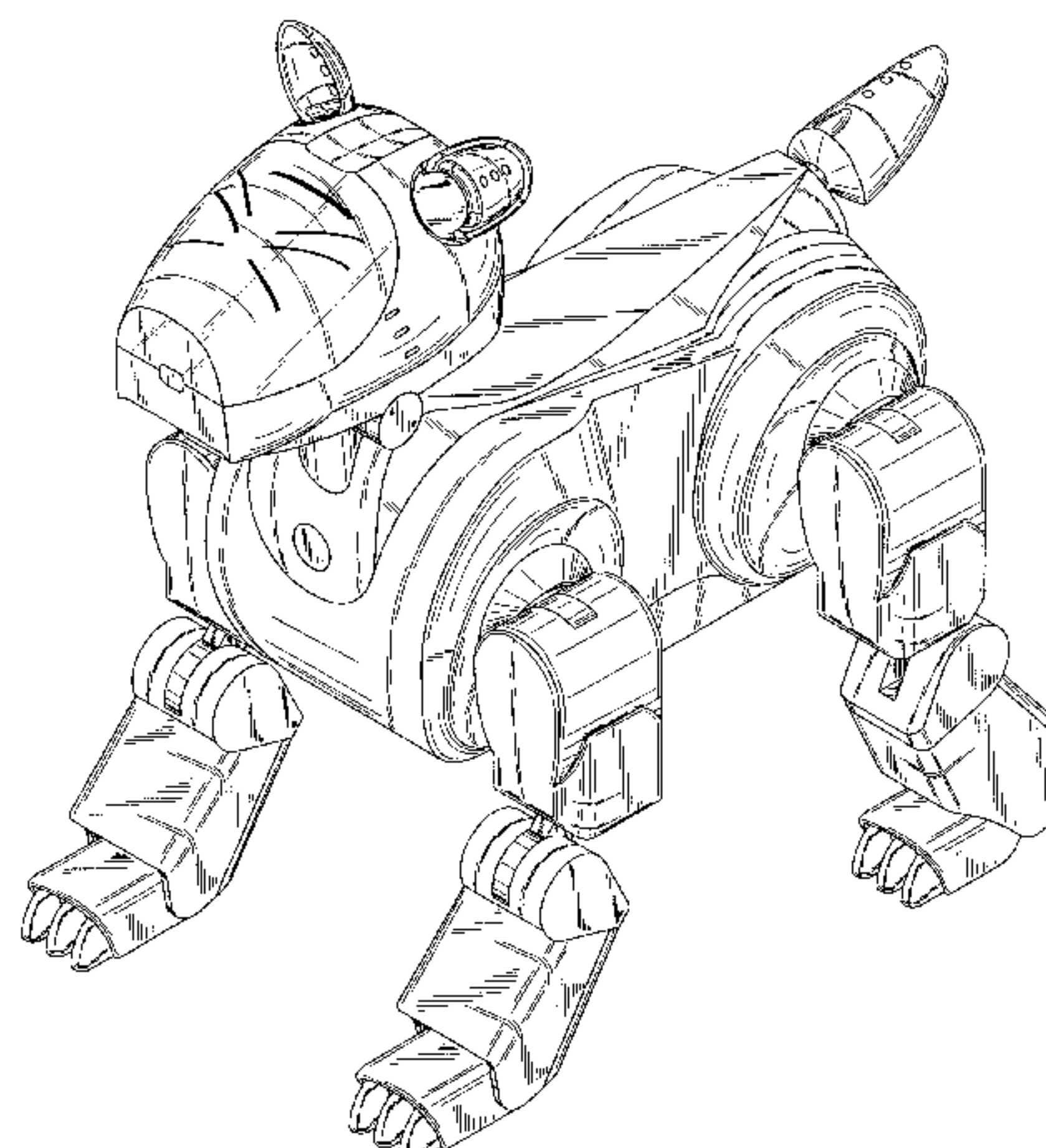
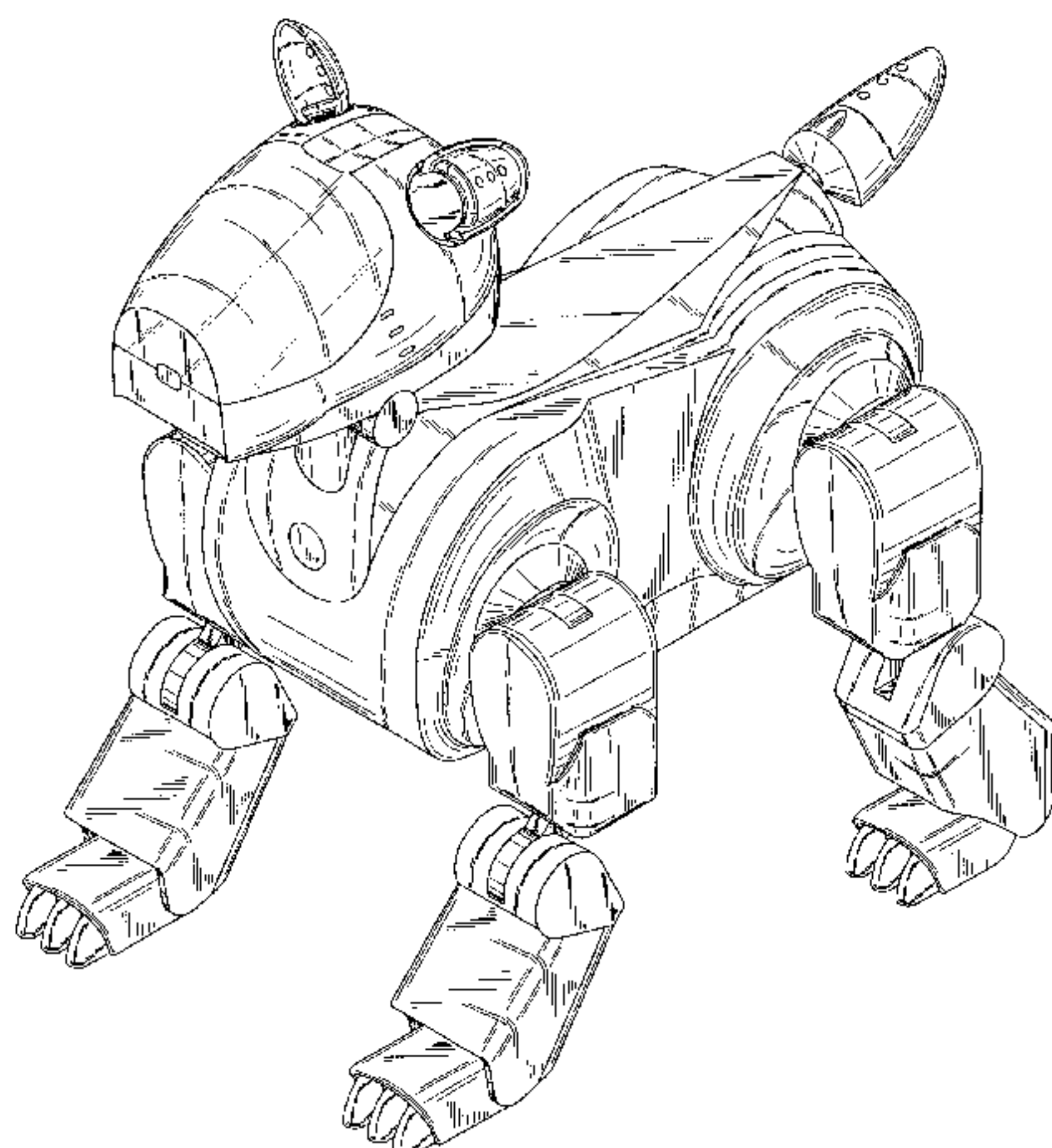


FIG. 27 is a left side elevational view thereof. The rest of views thereof is the same as those of the embodiments of FIG. 1.

FIG. 59 is a front elevational view thereof;

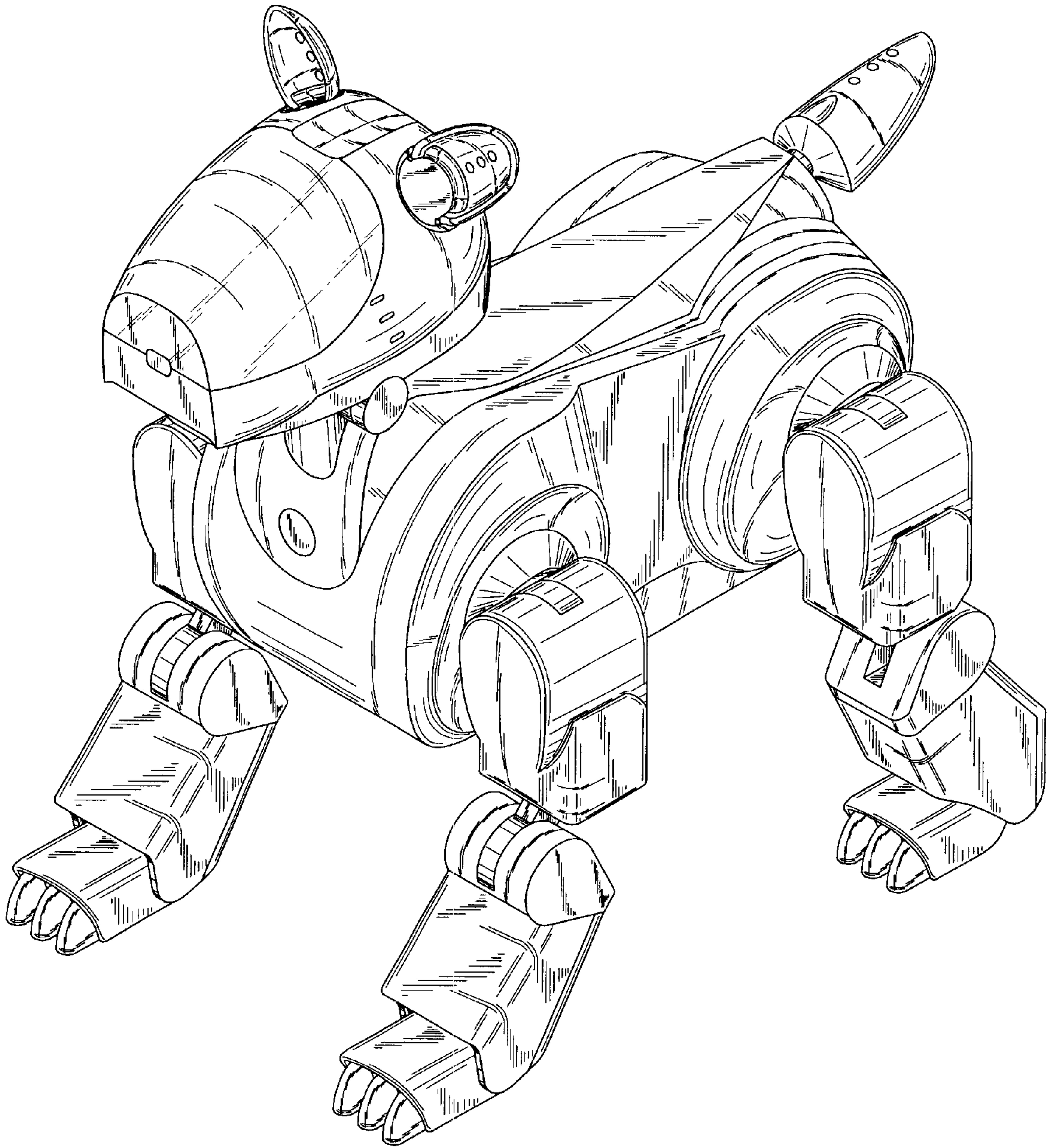

FIG. 61 is right side elevational view thereof; and,

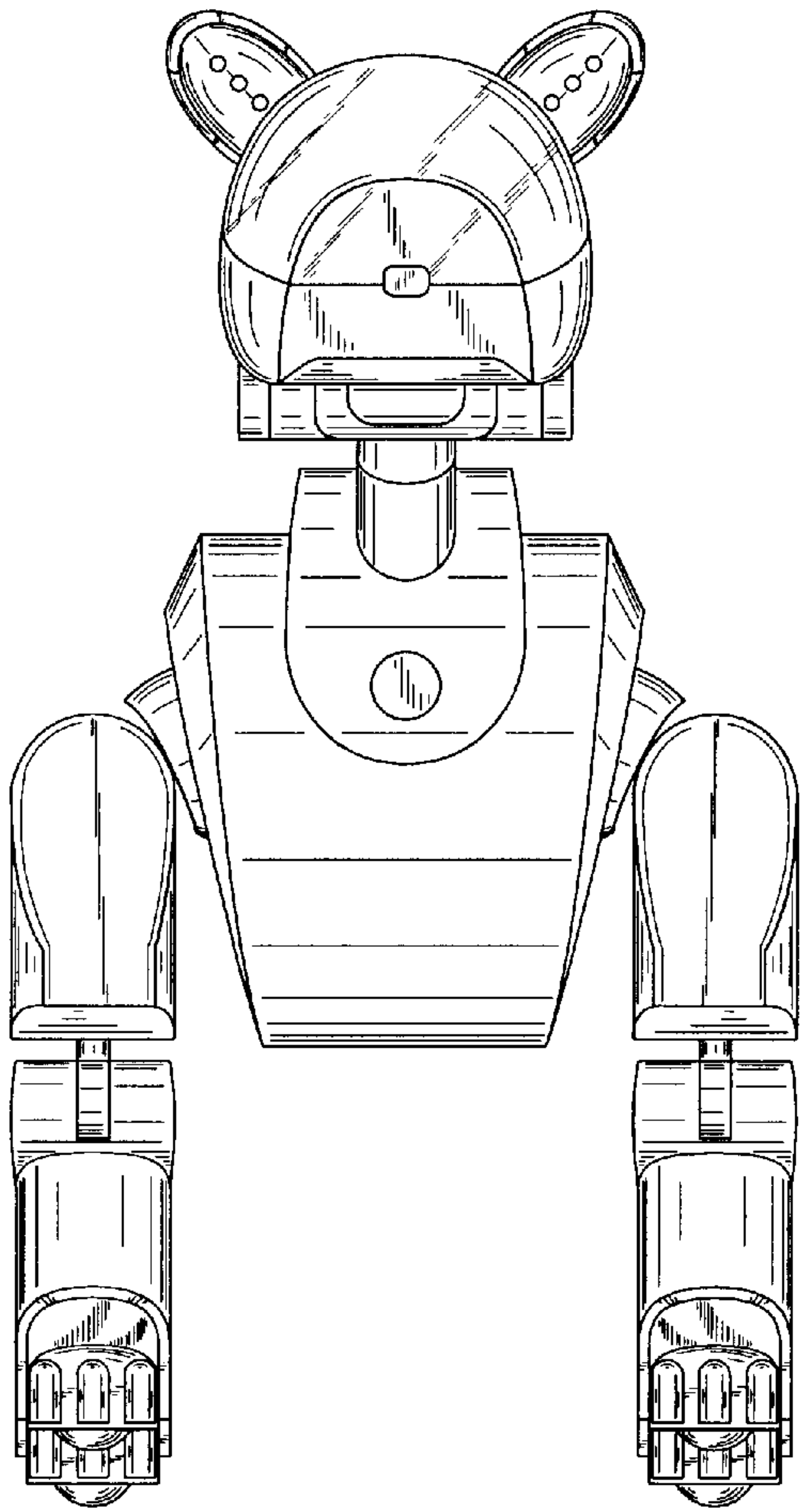

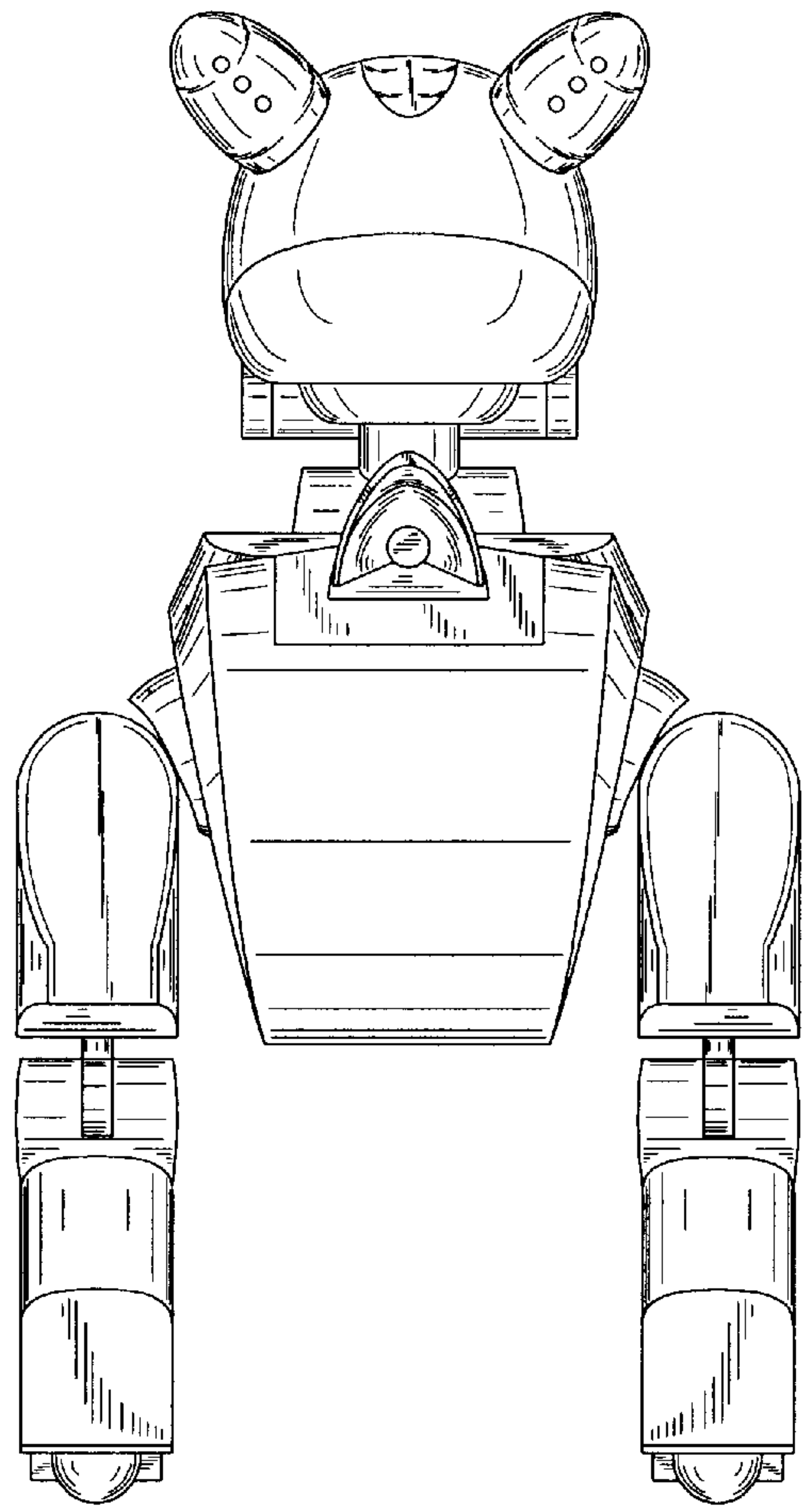

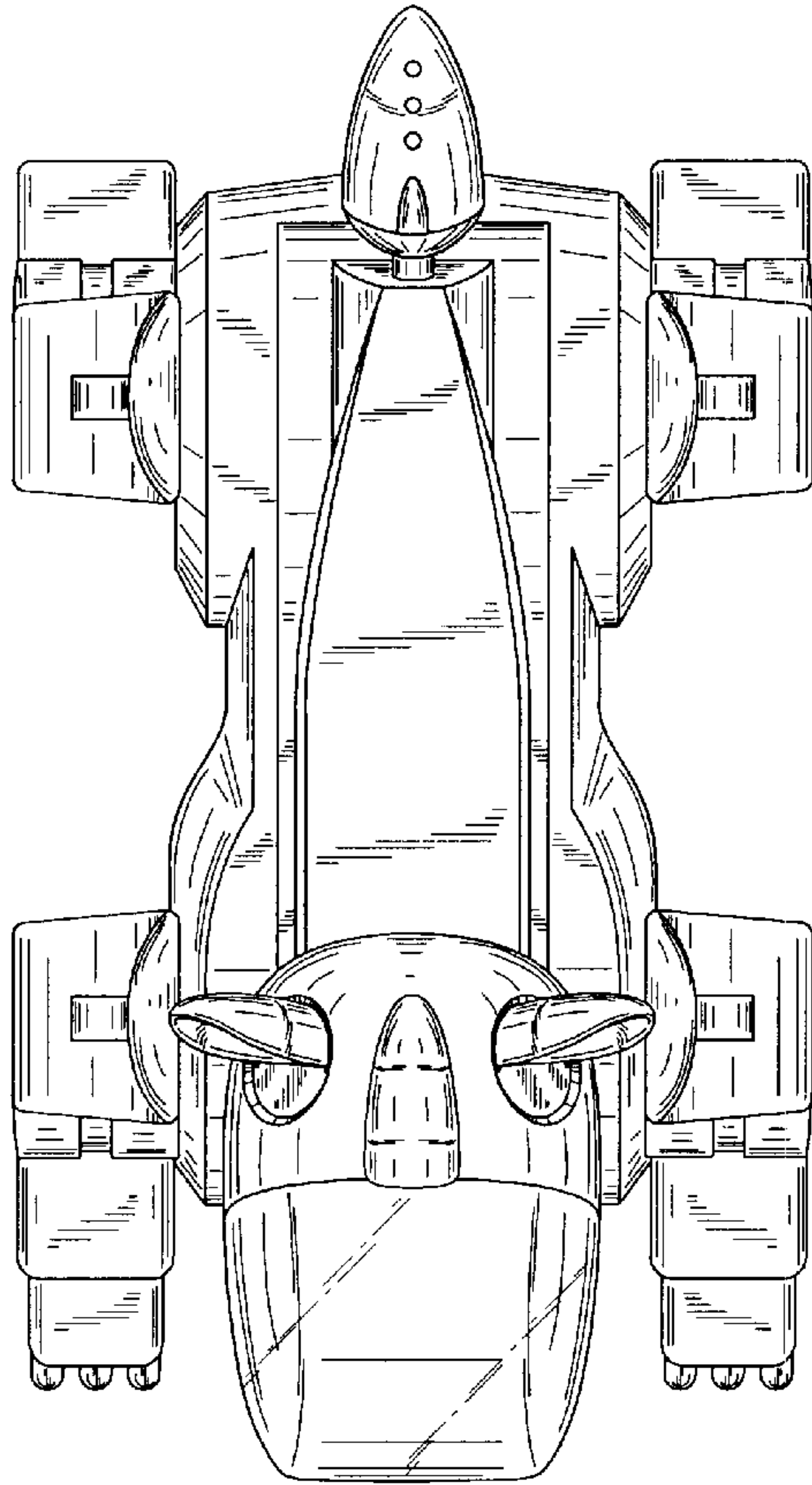

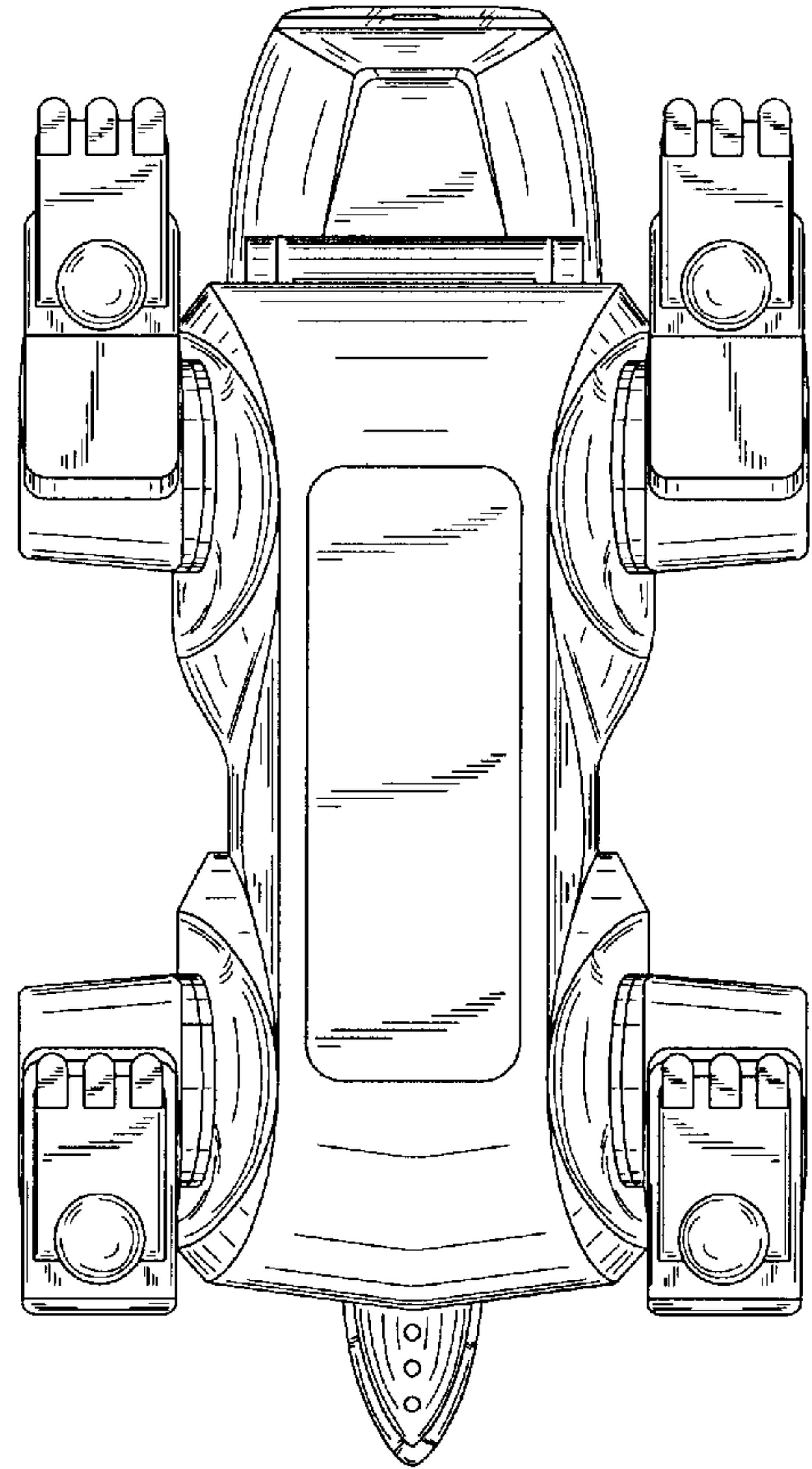
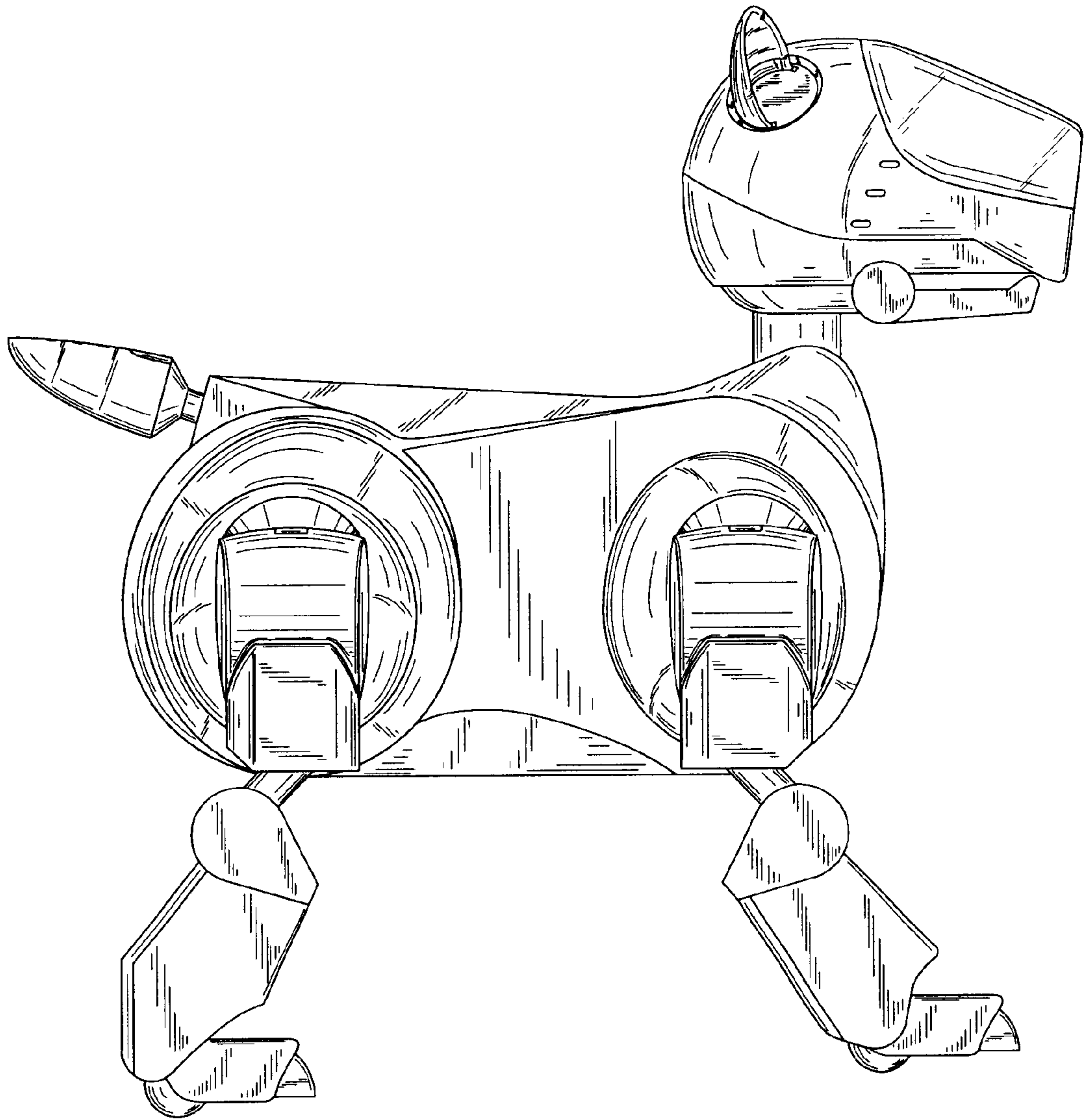
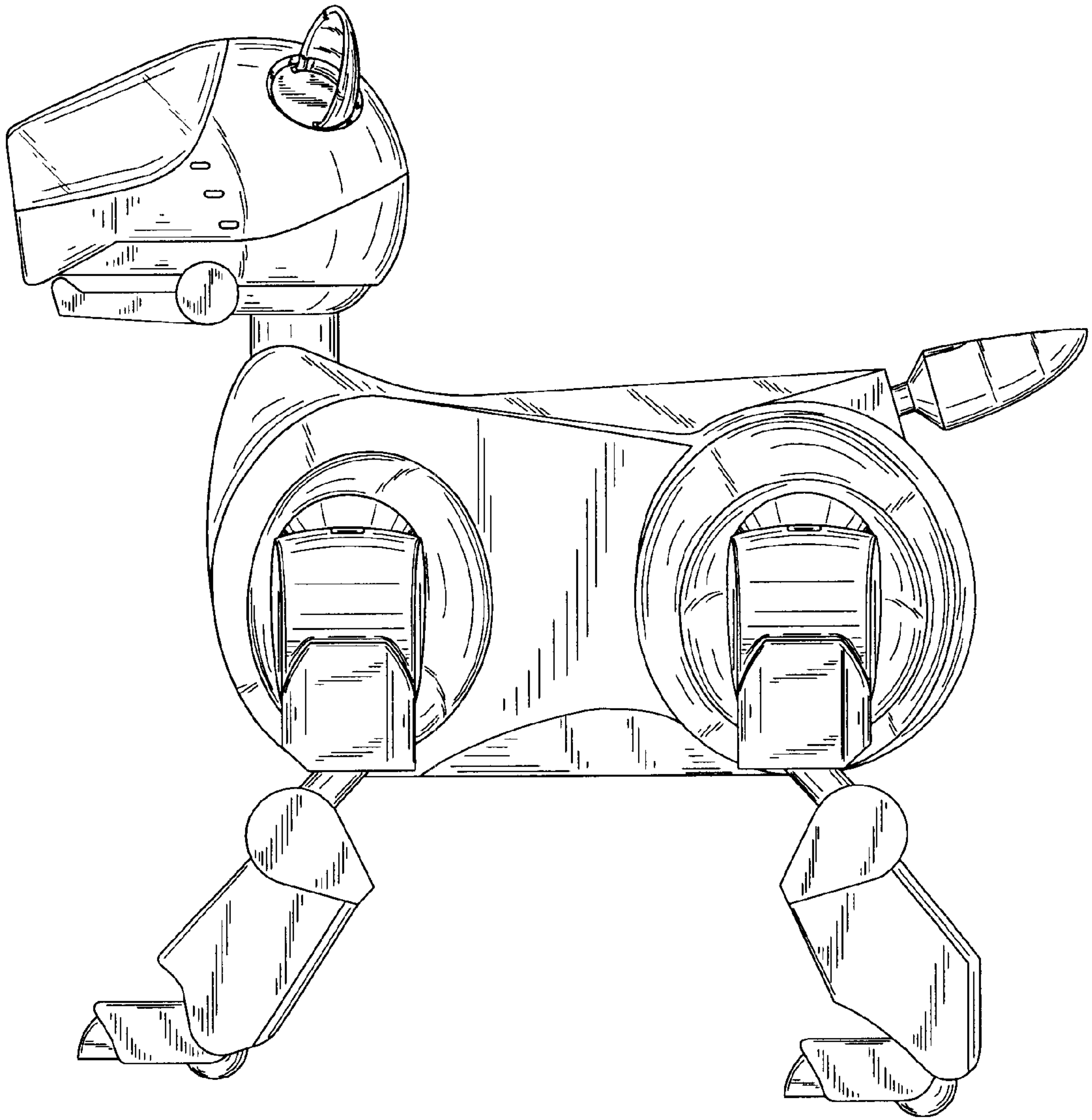

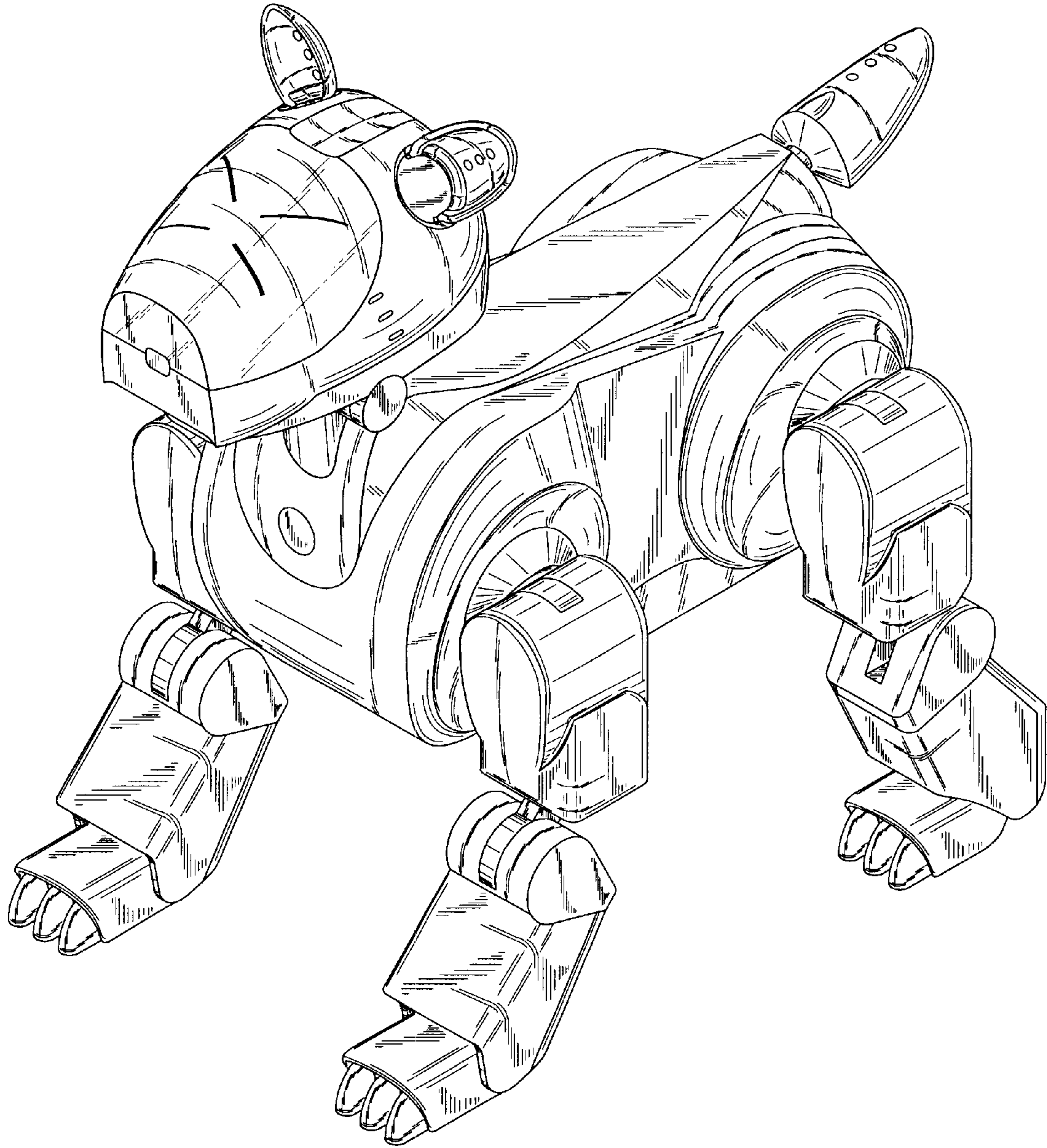

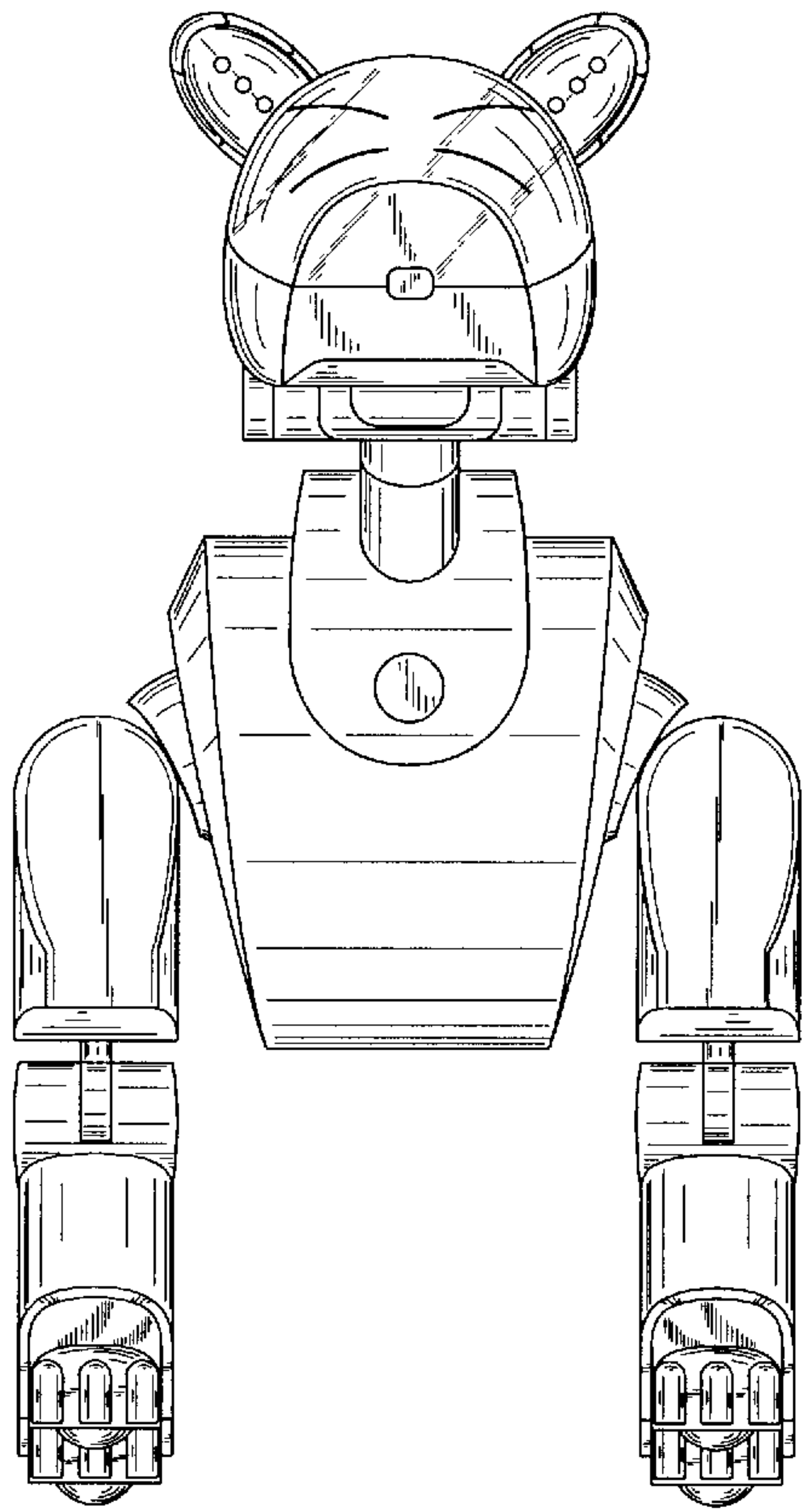

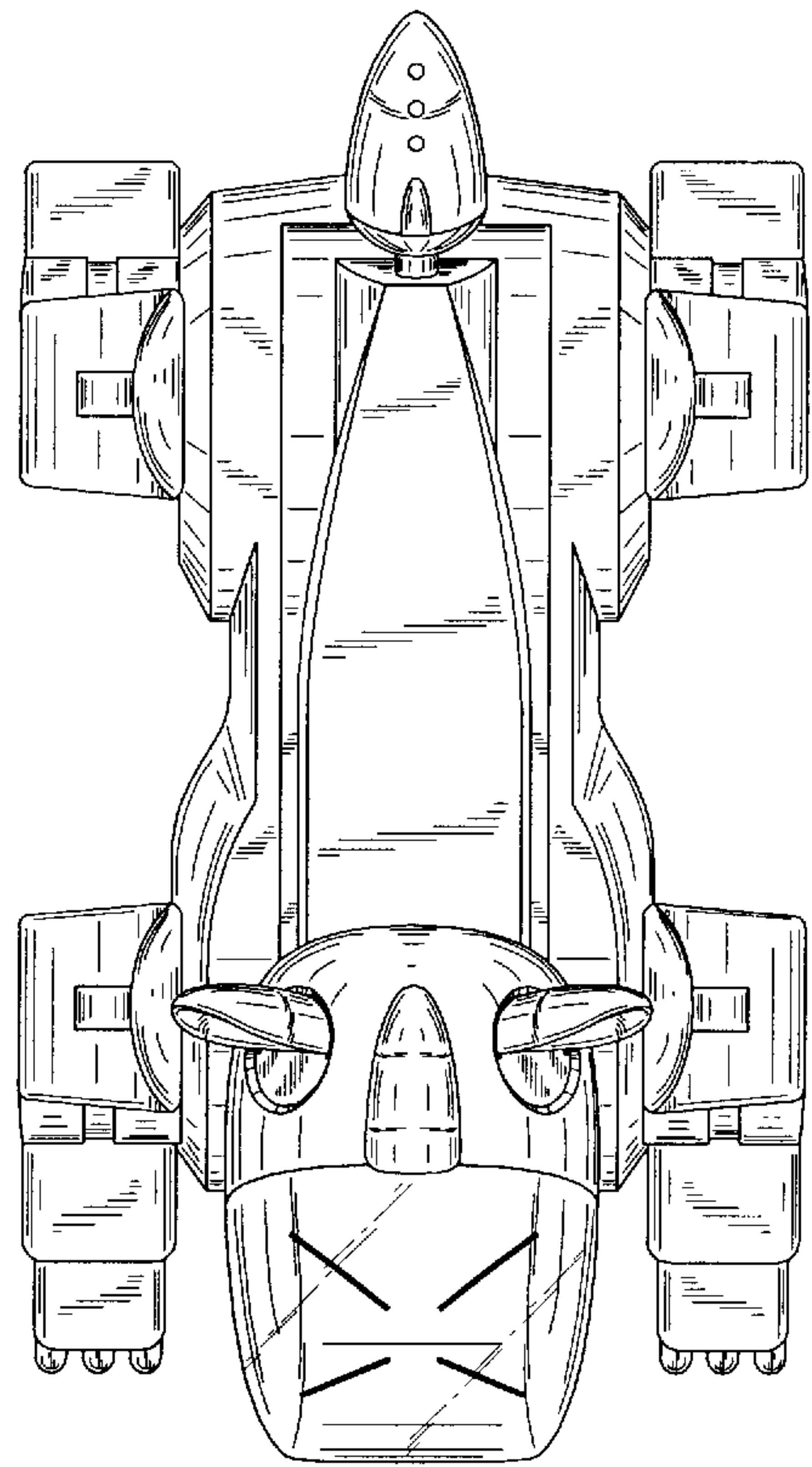
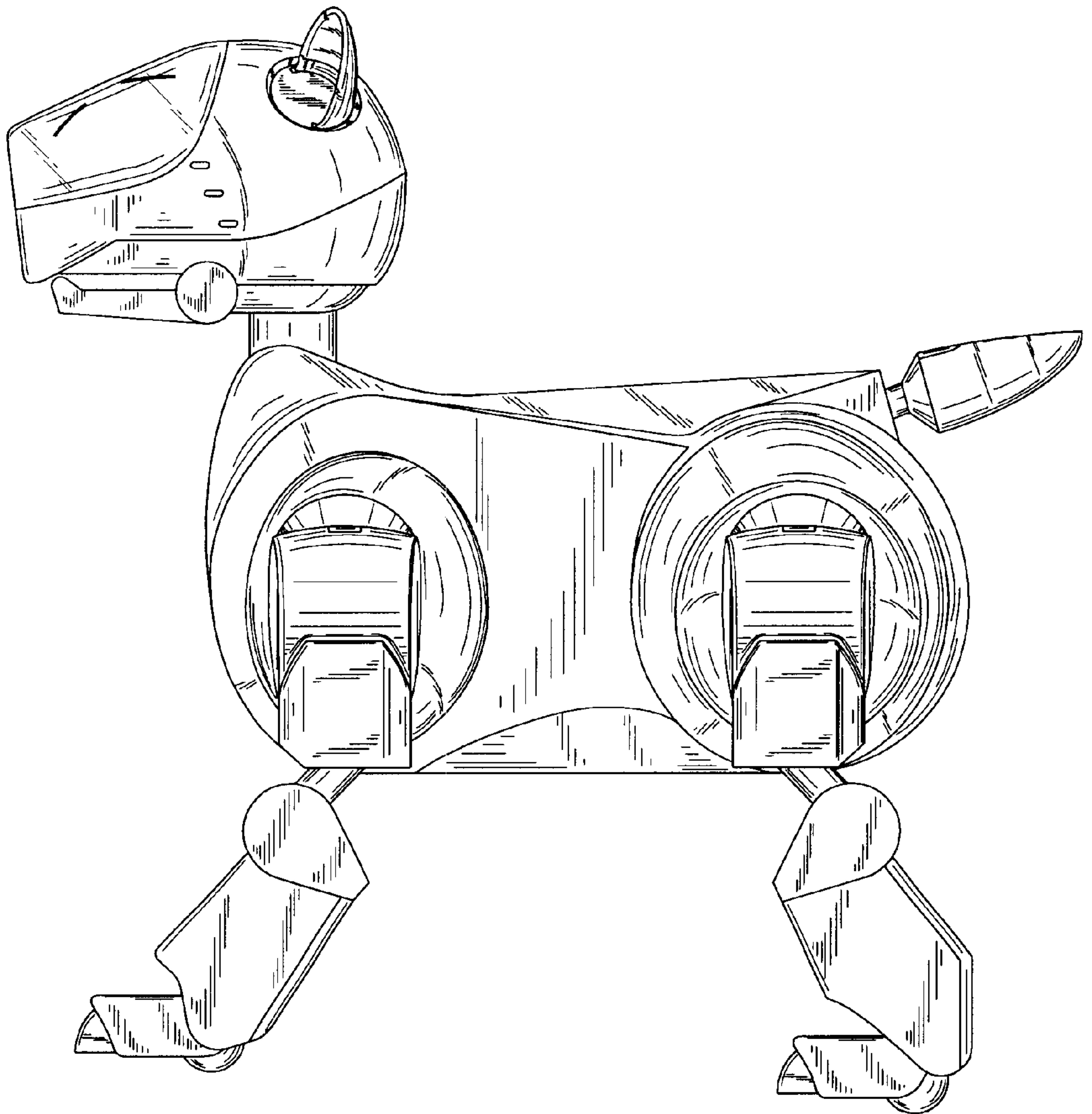
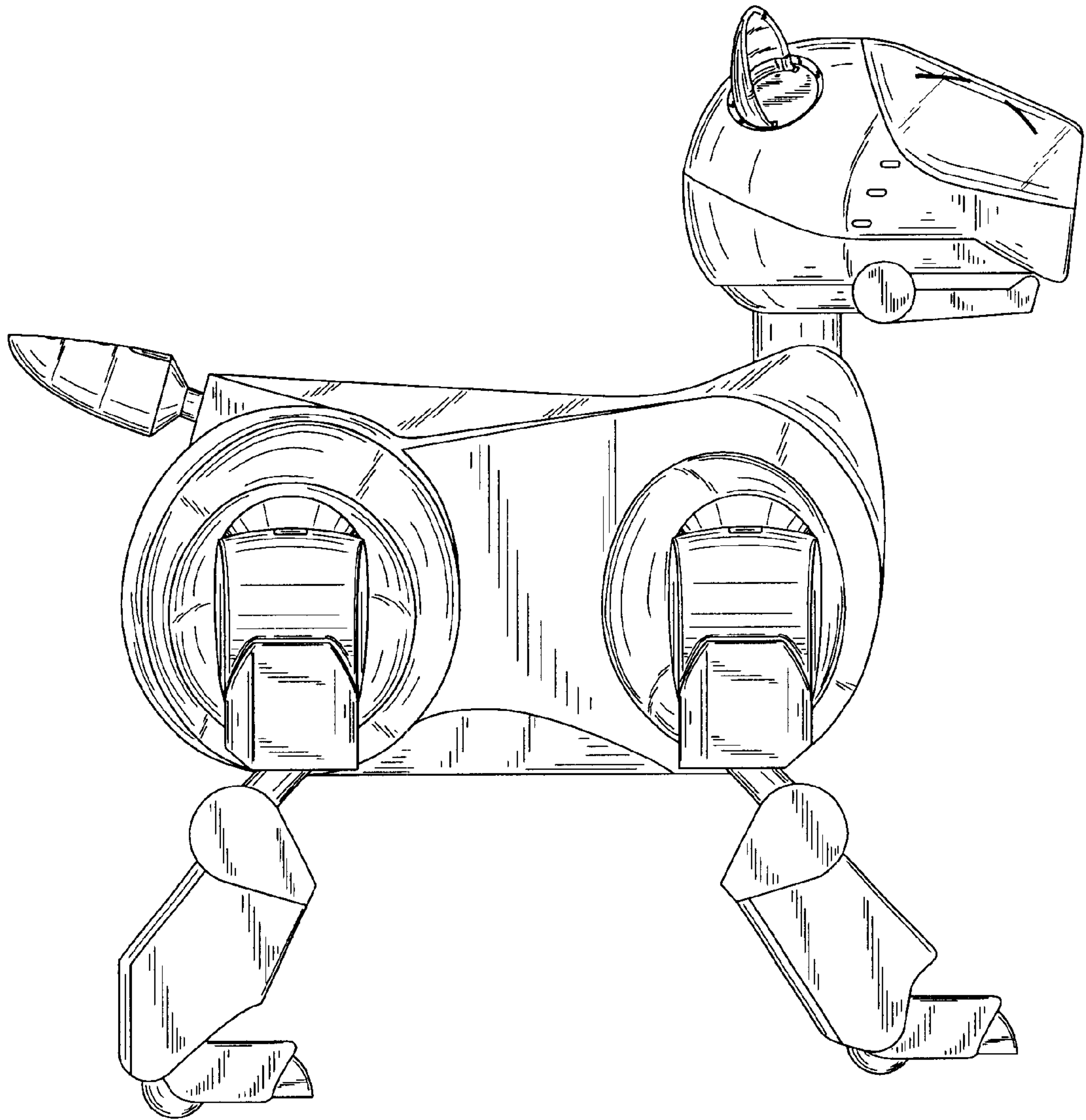

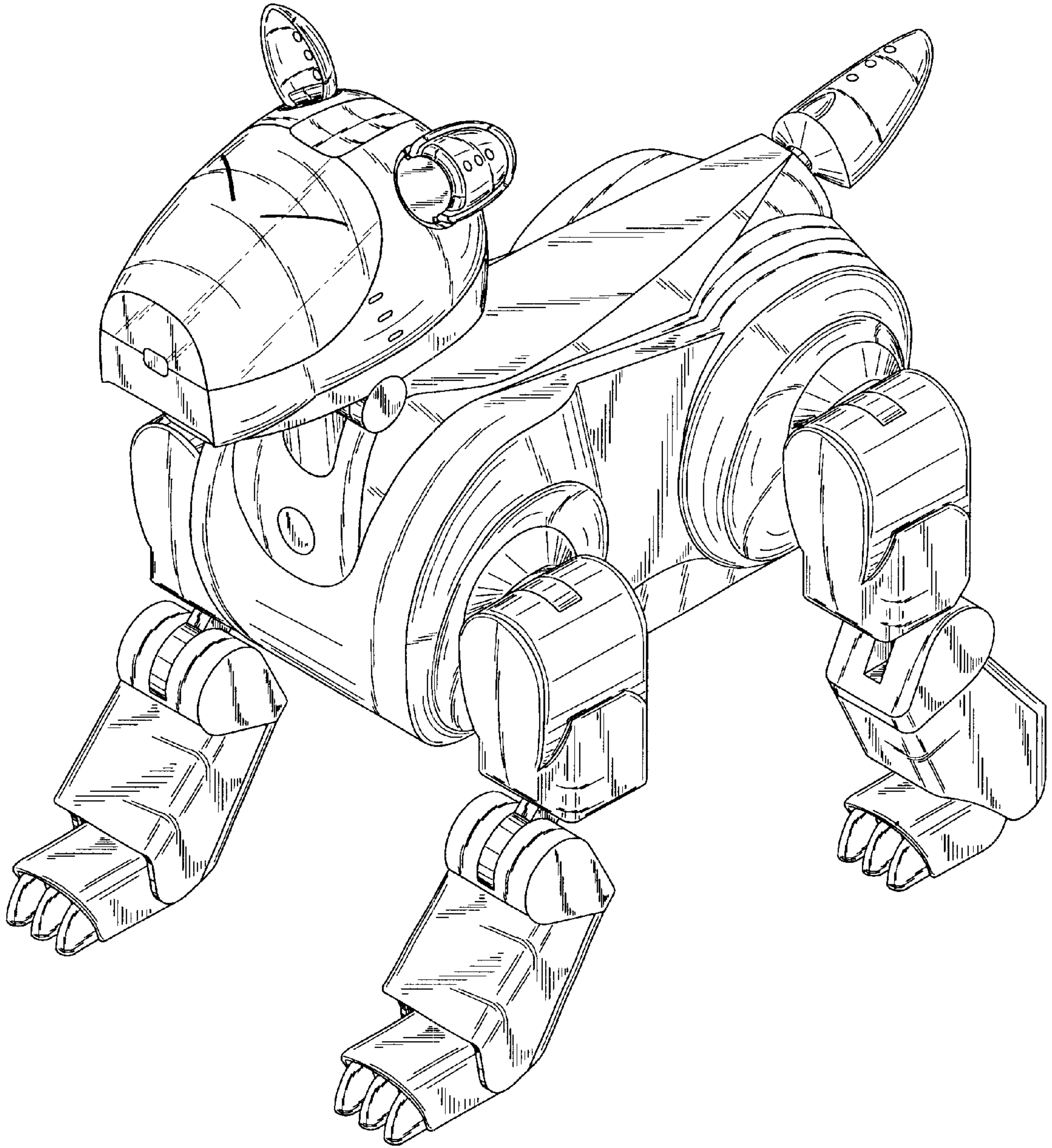

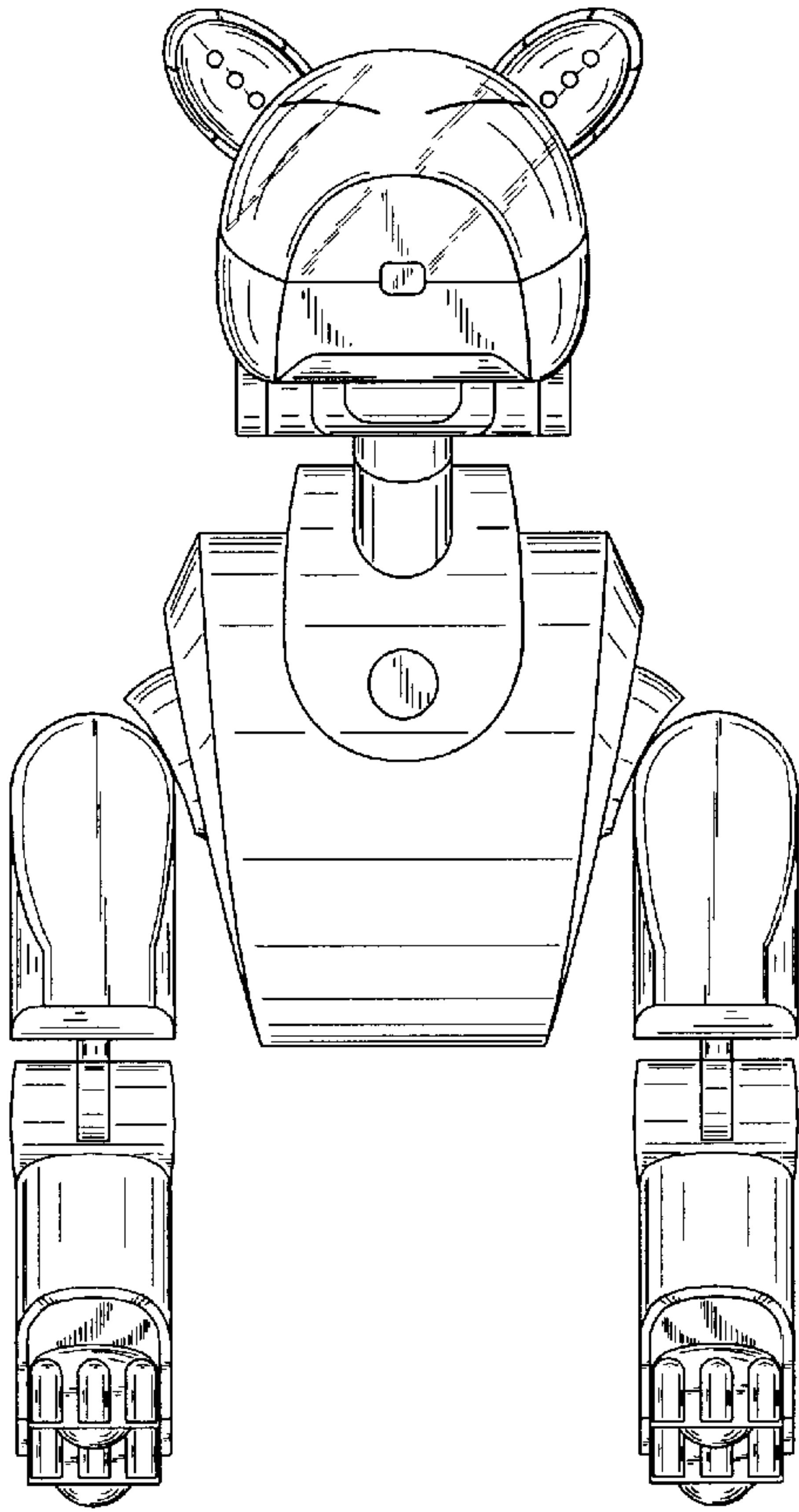

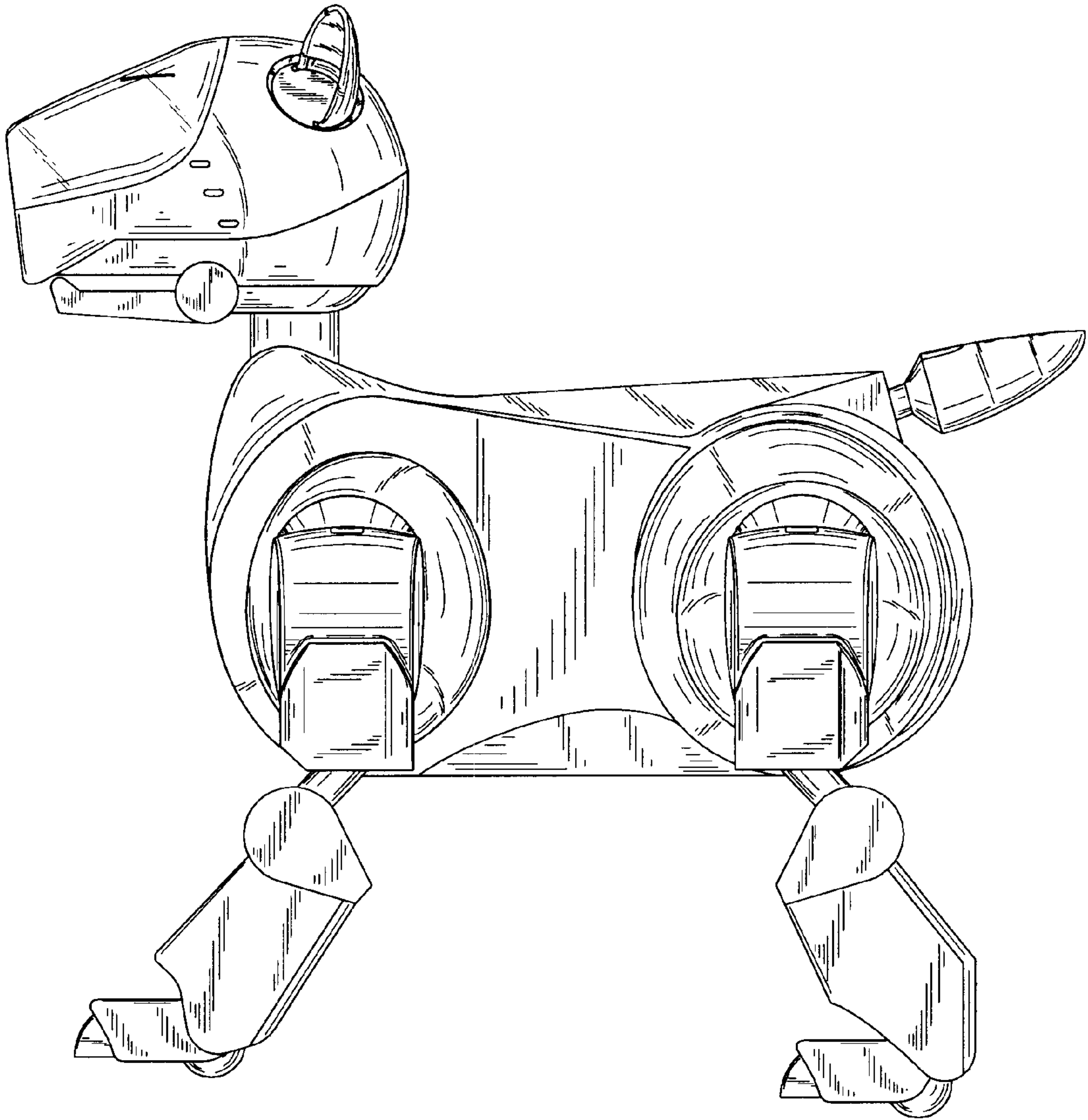
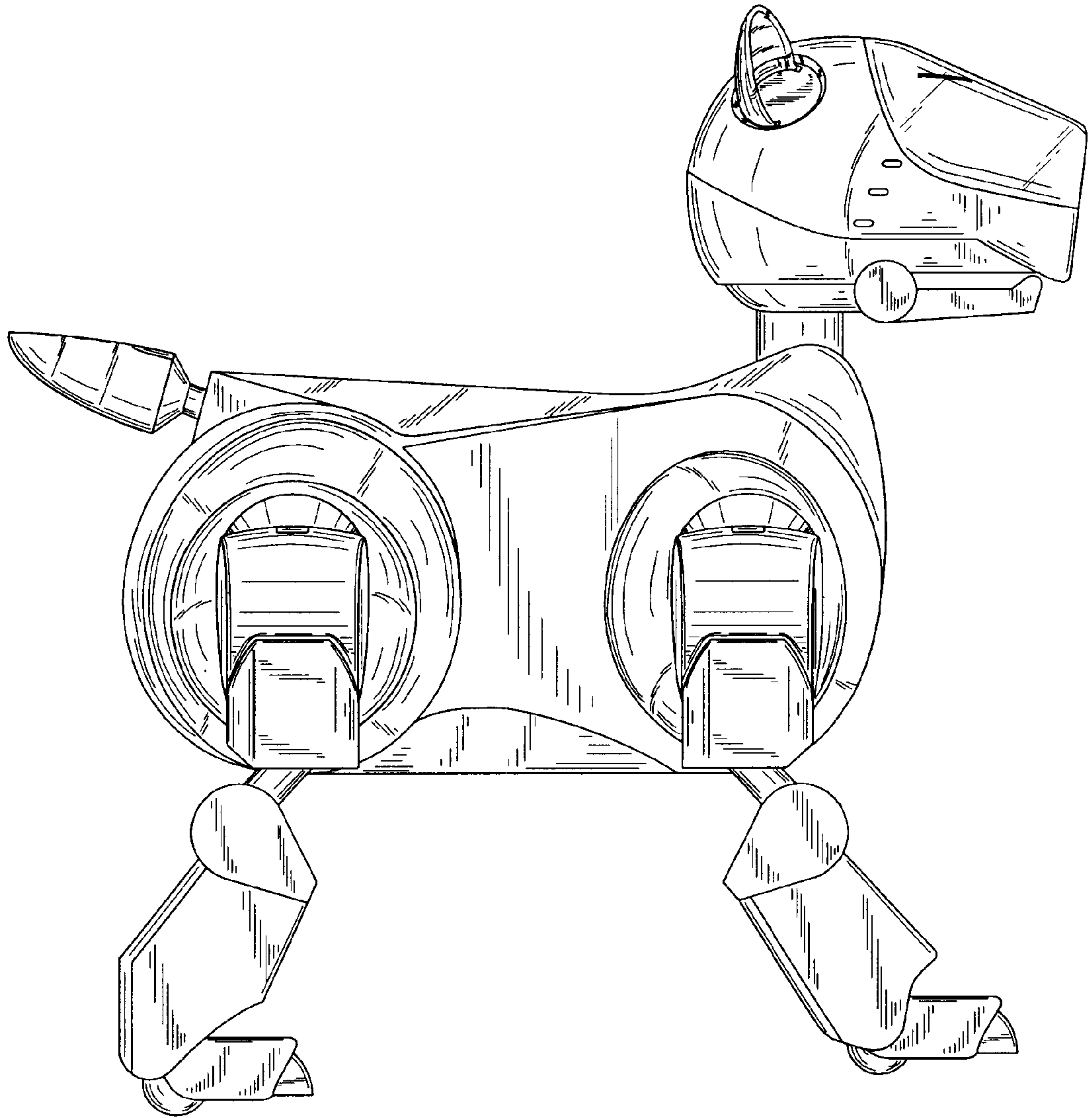

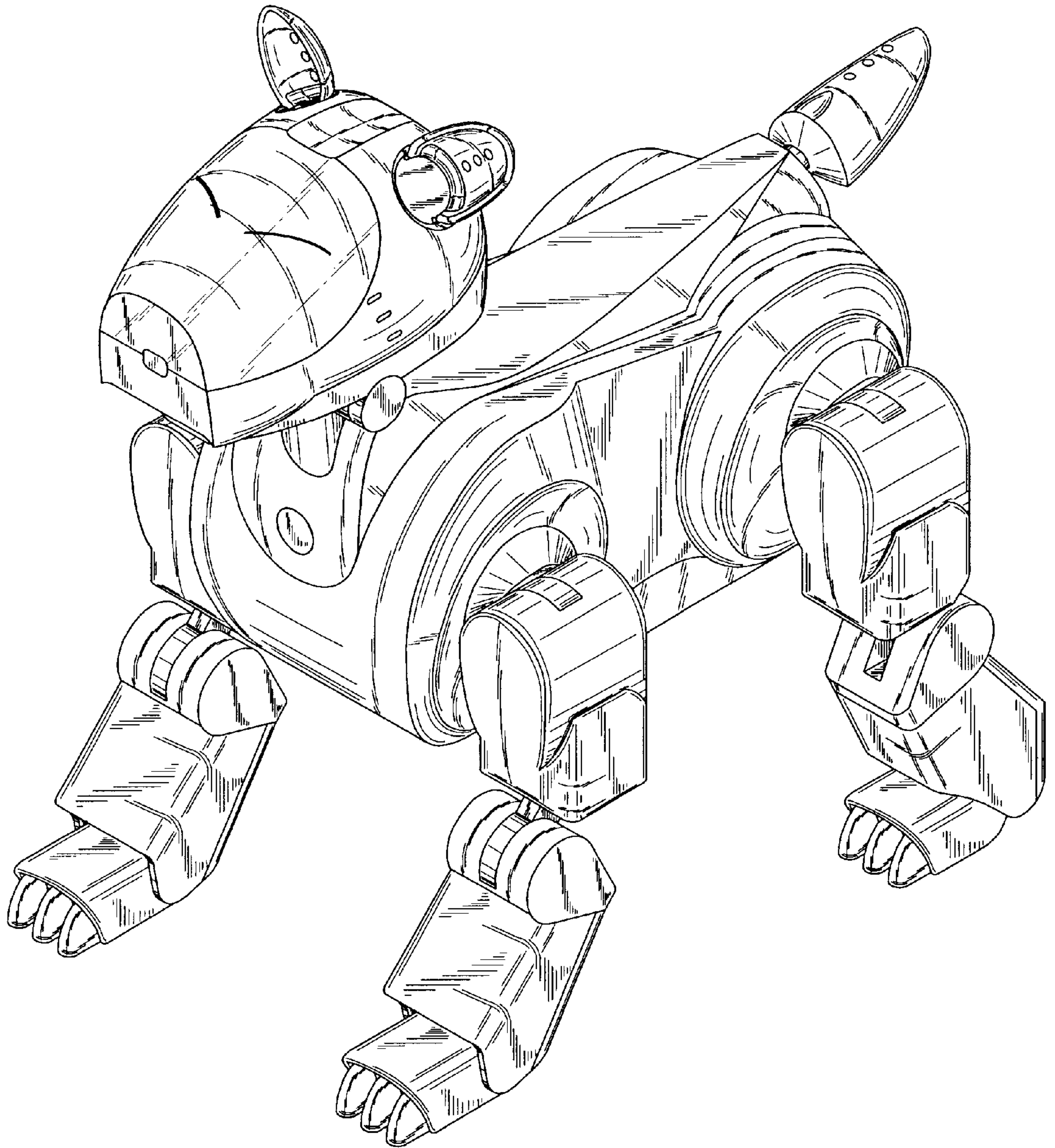

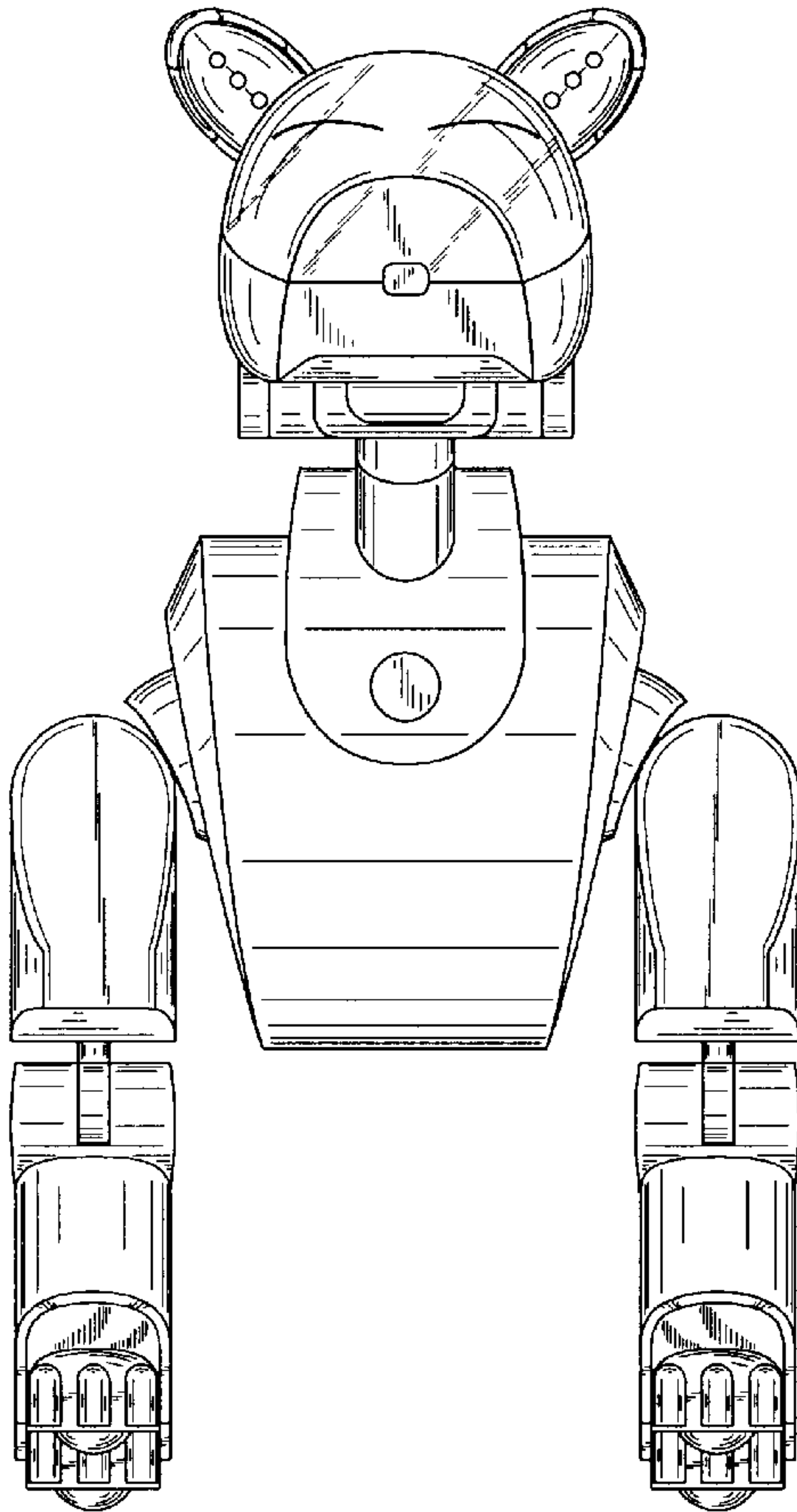

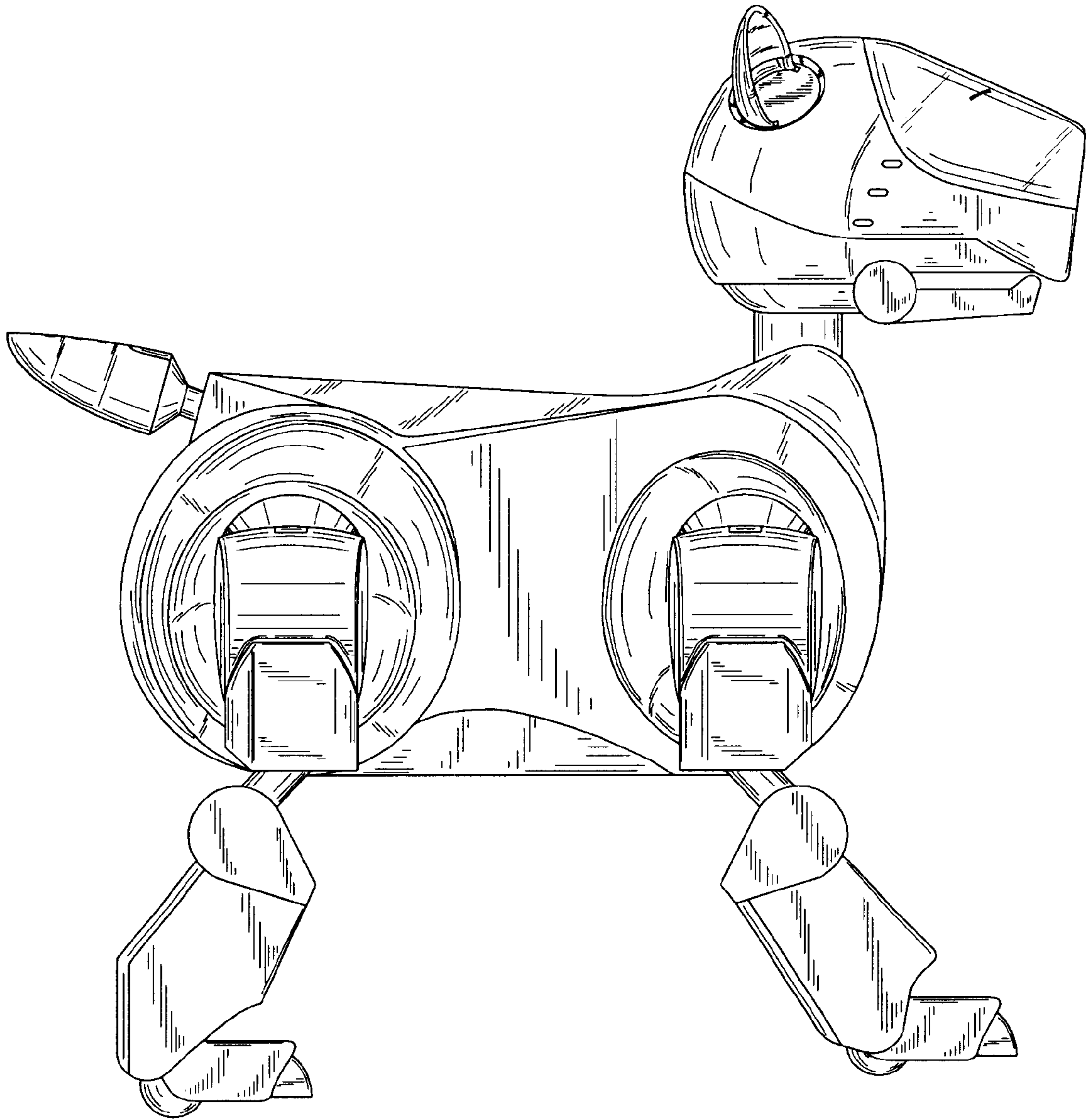

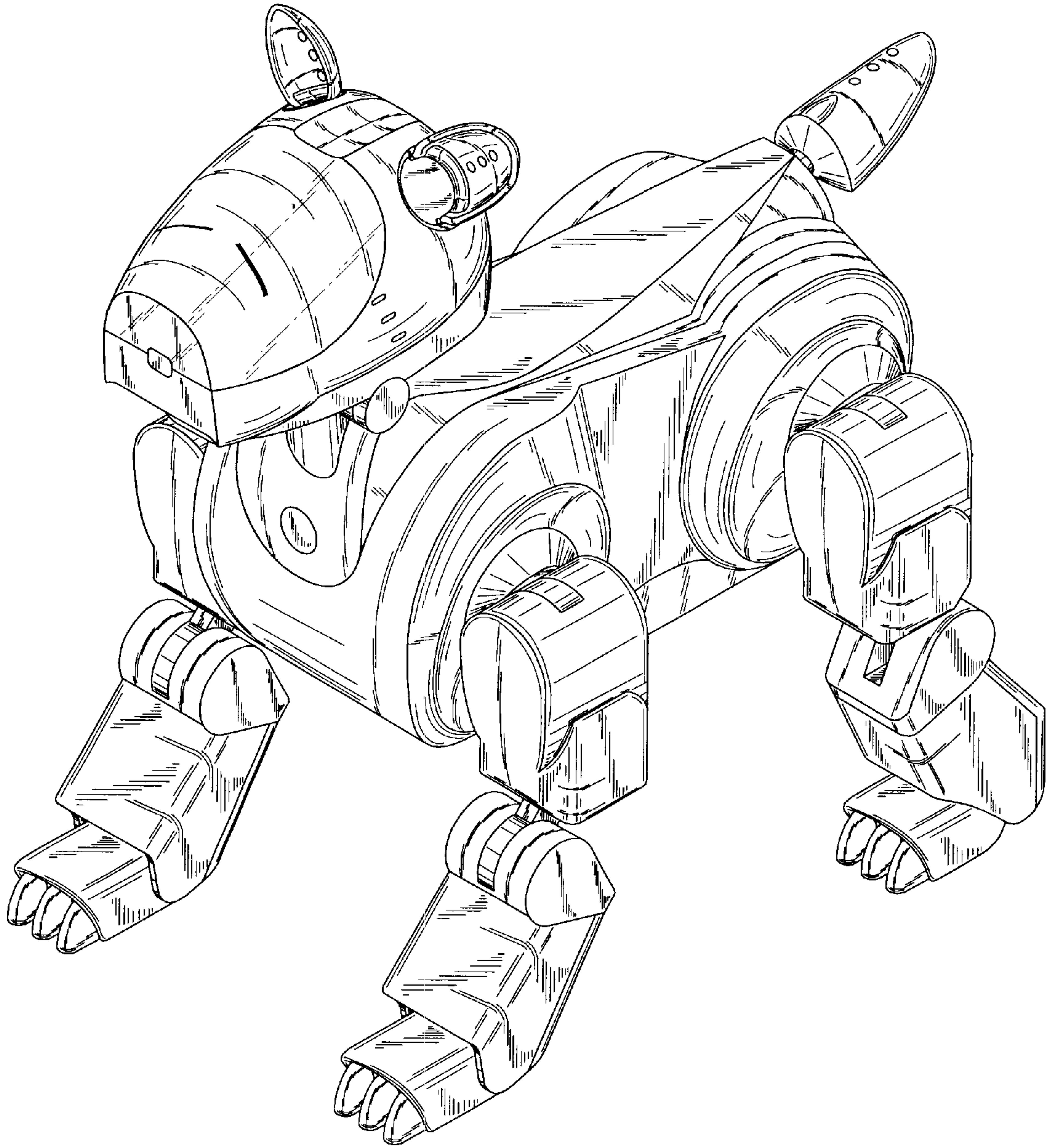

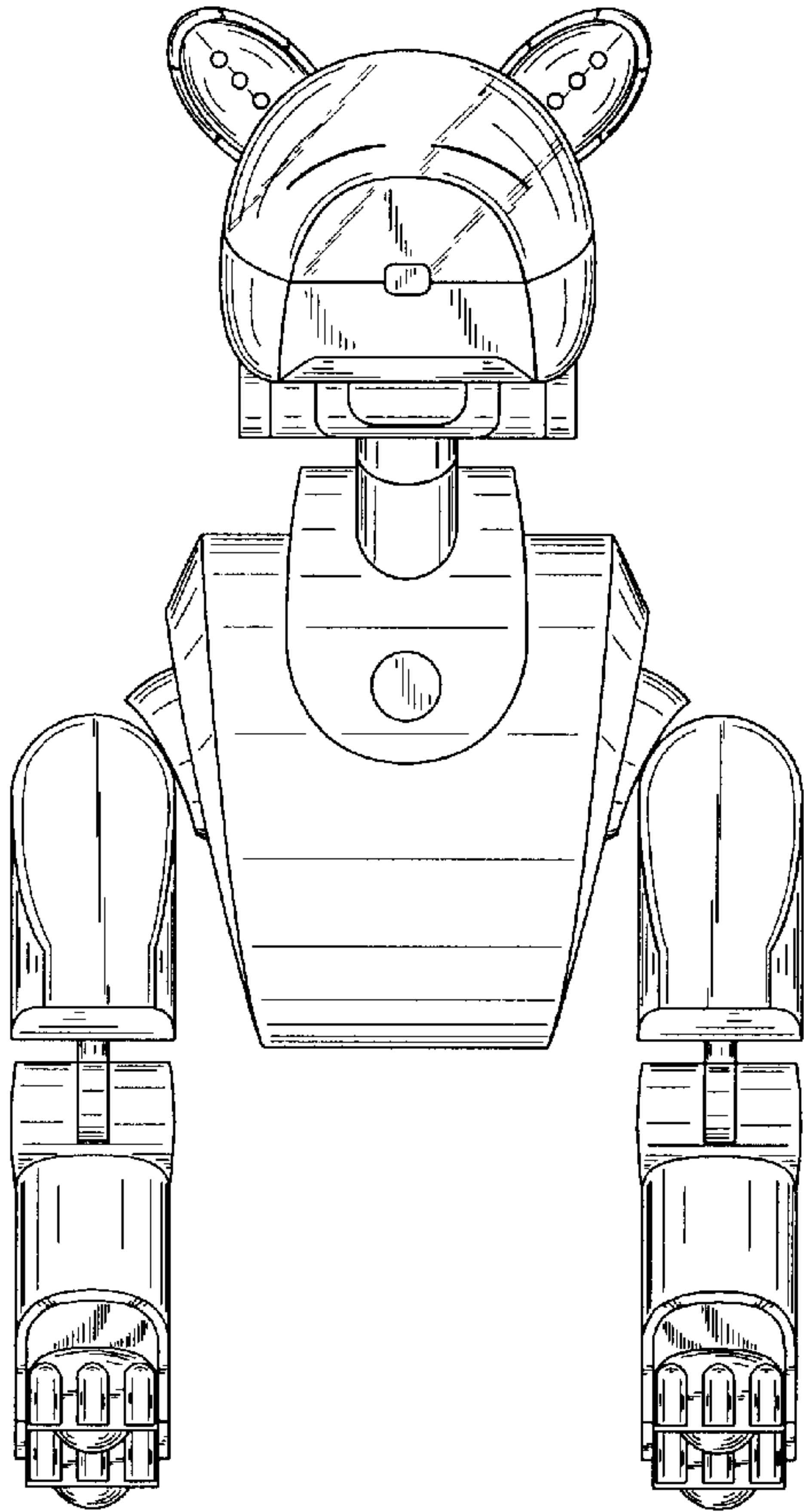

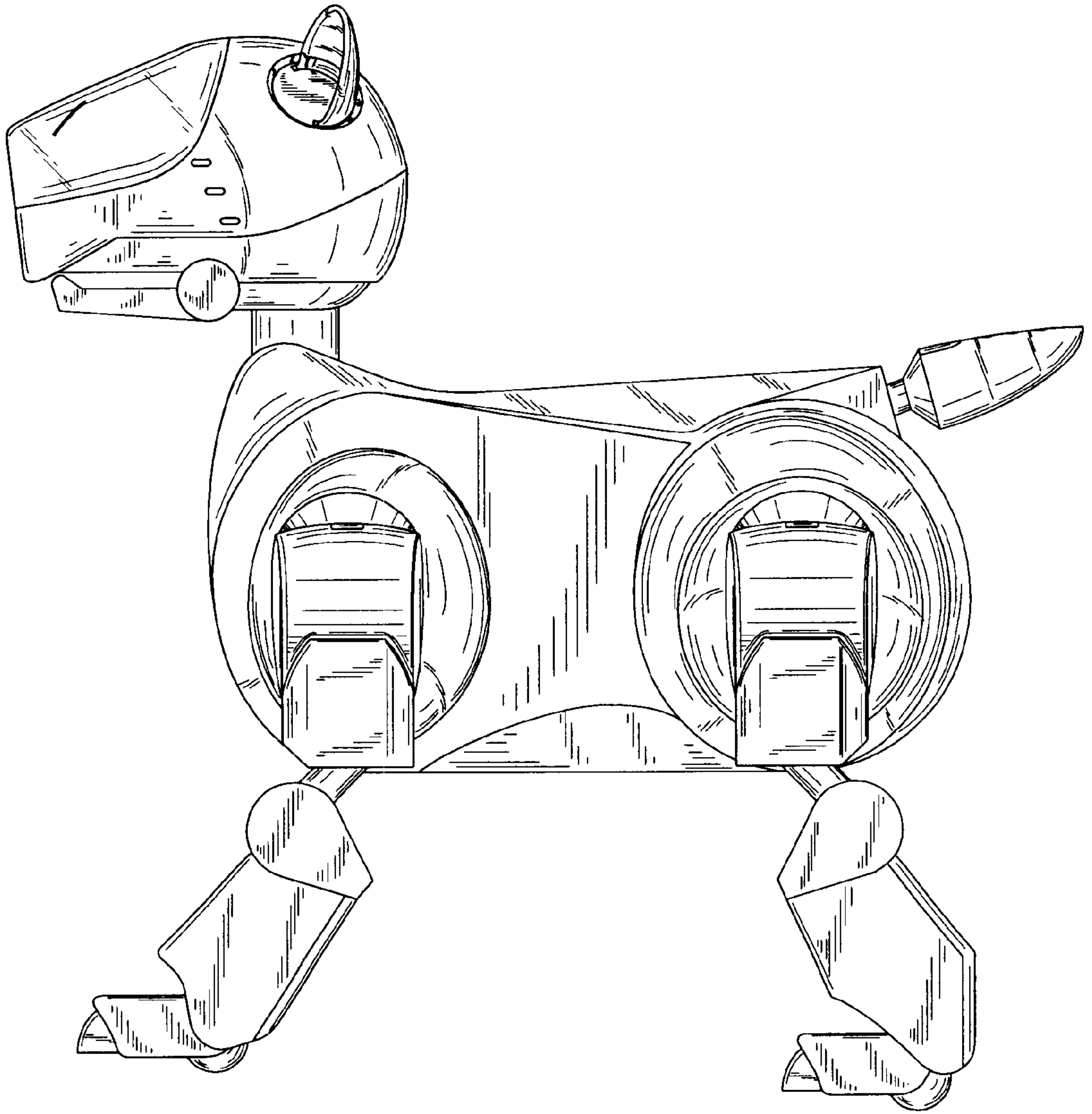

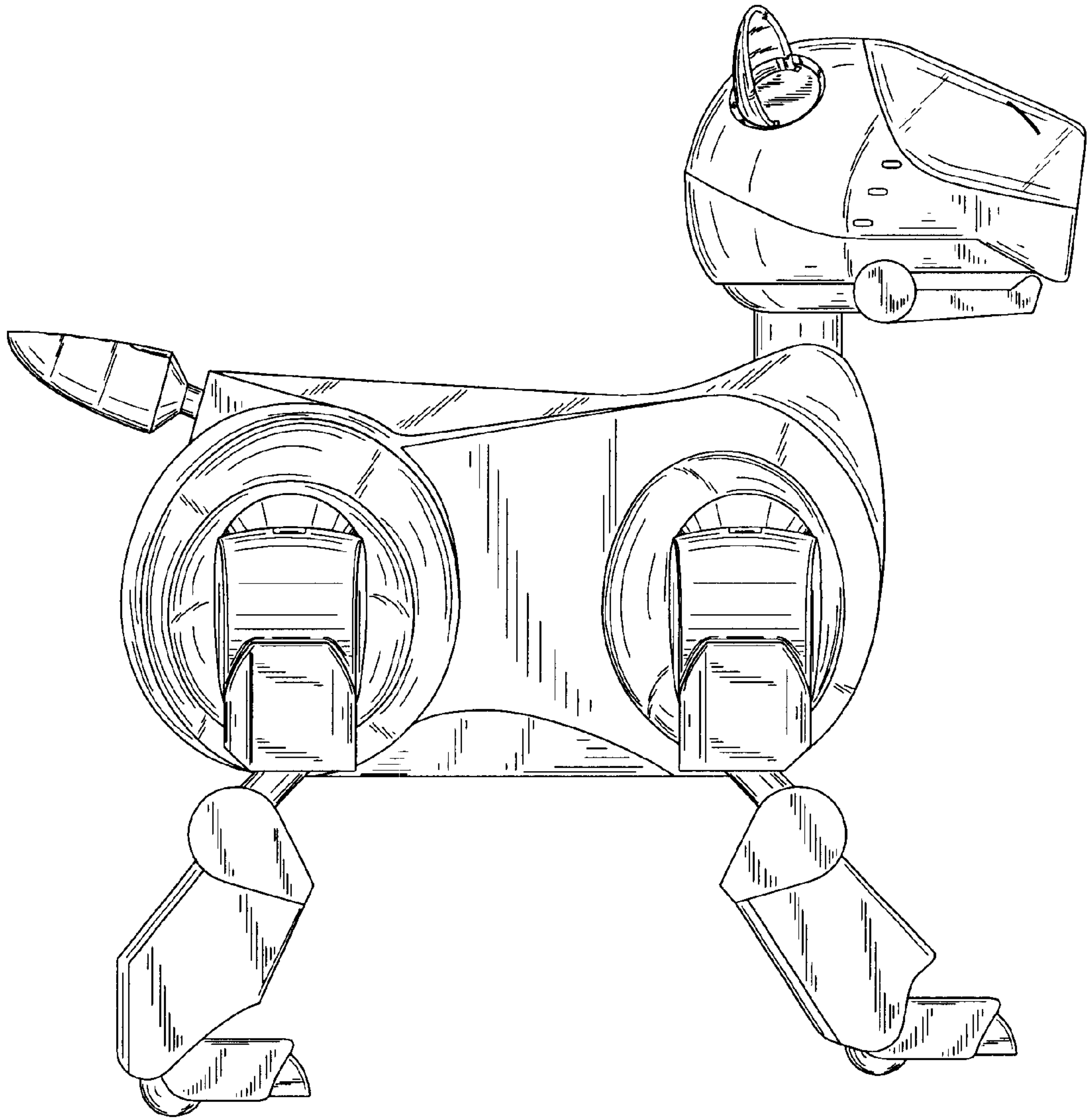

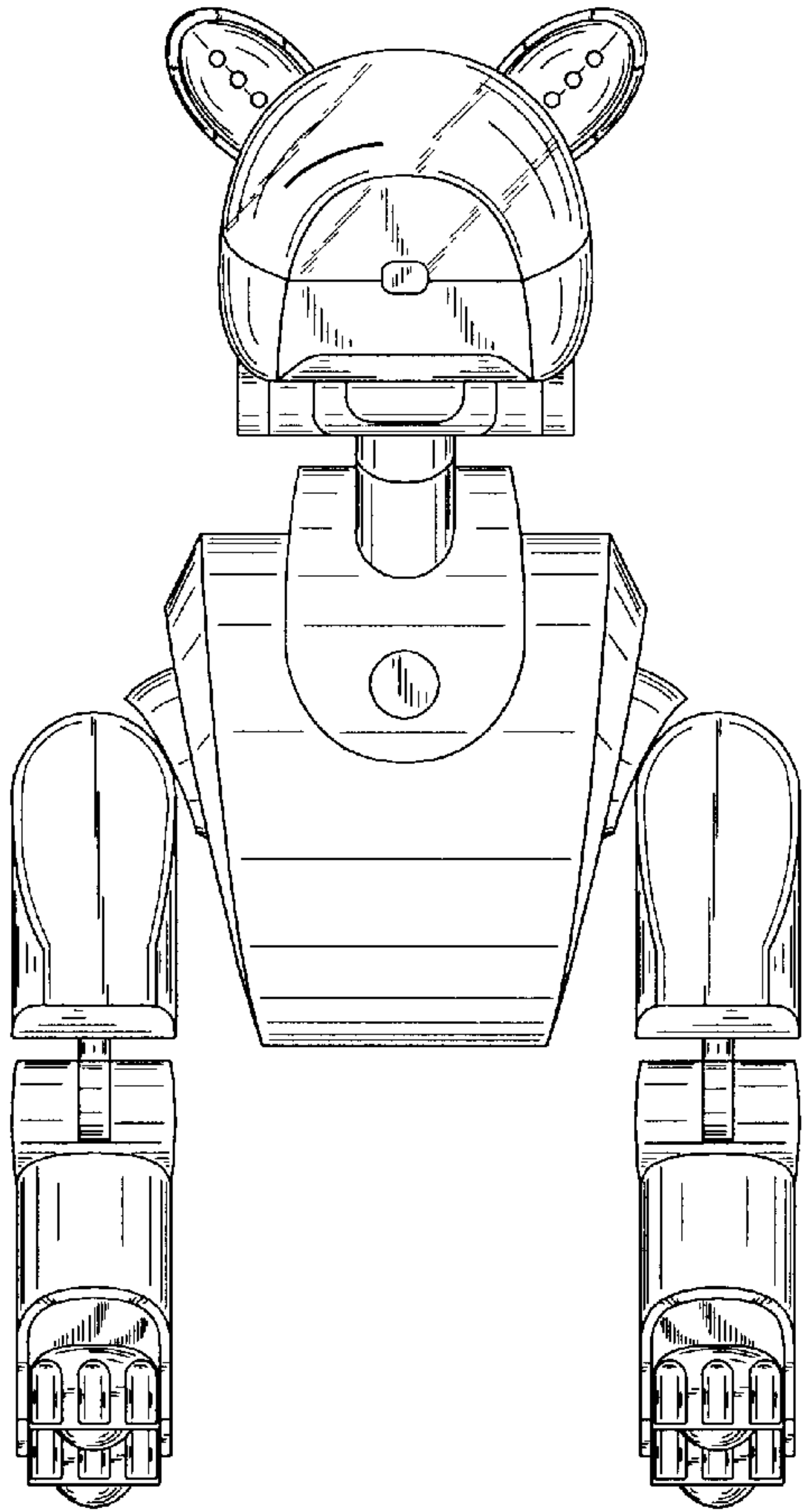

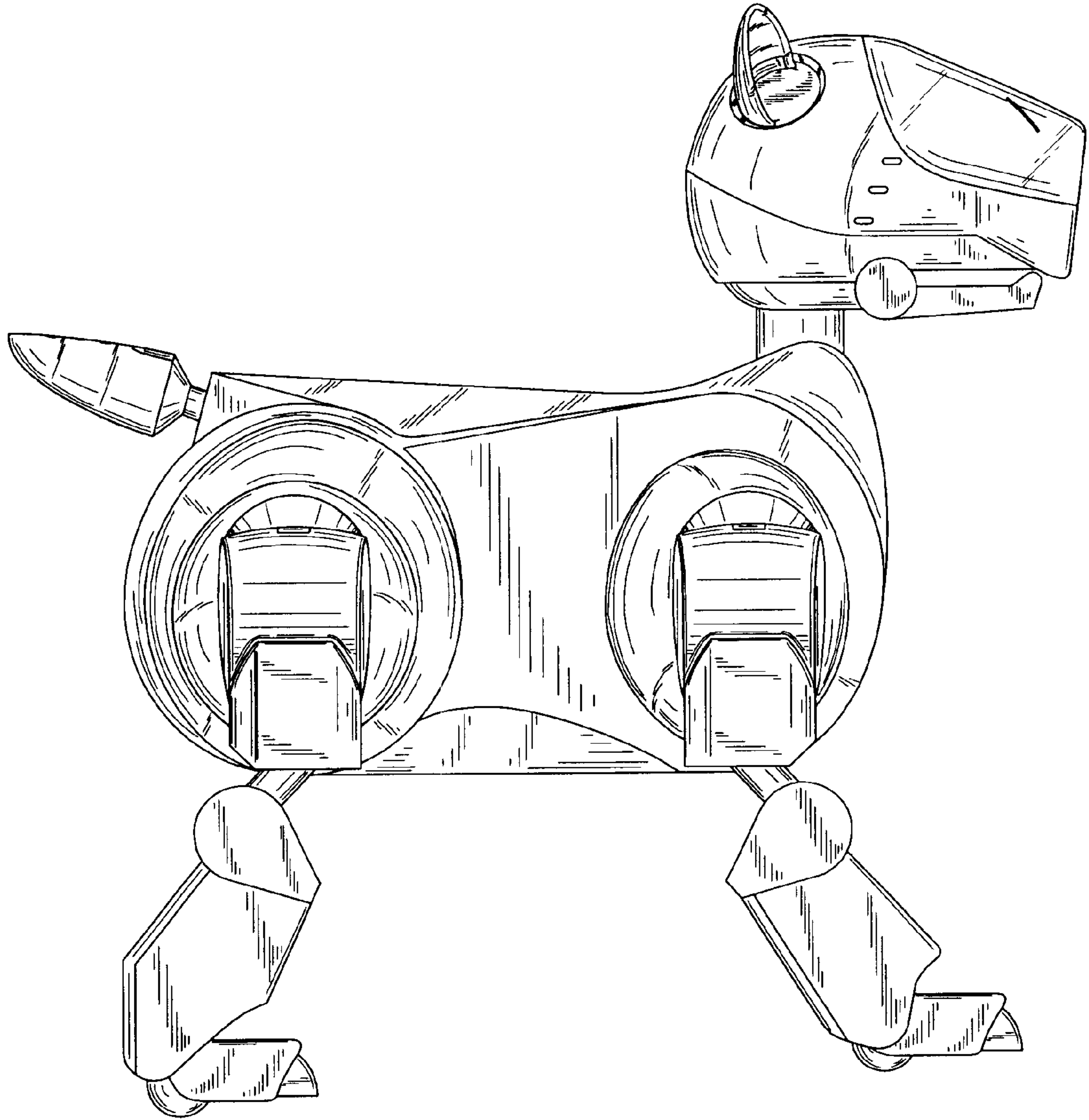

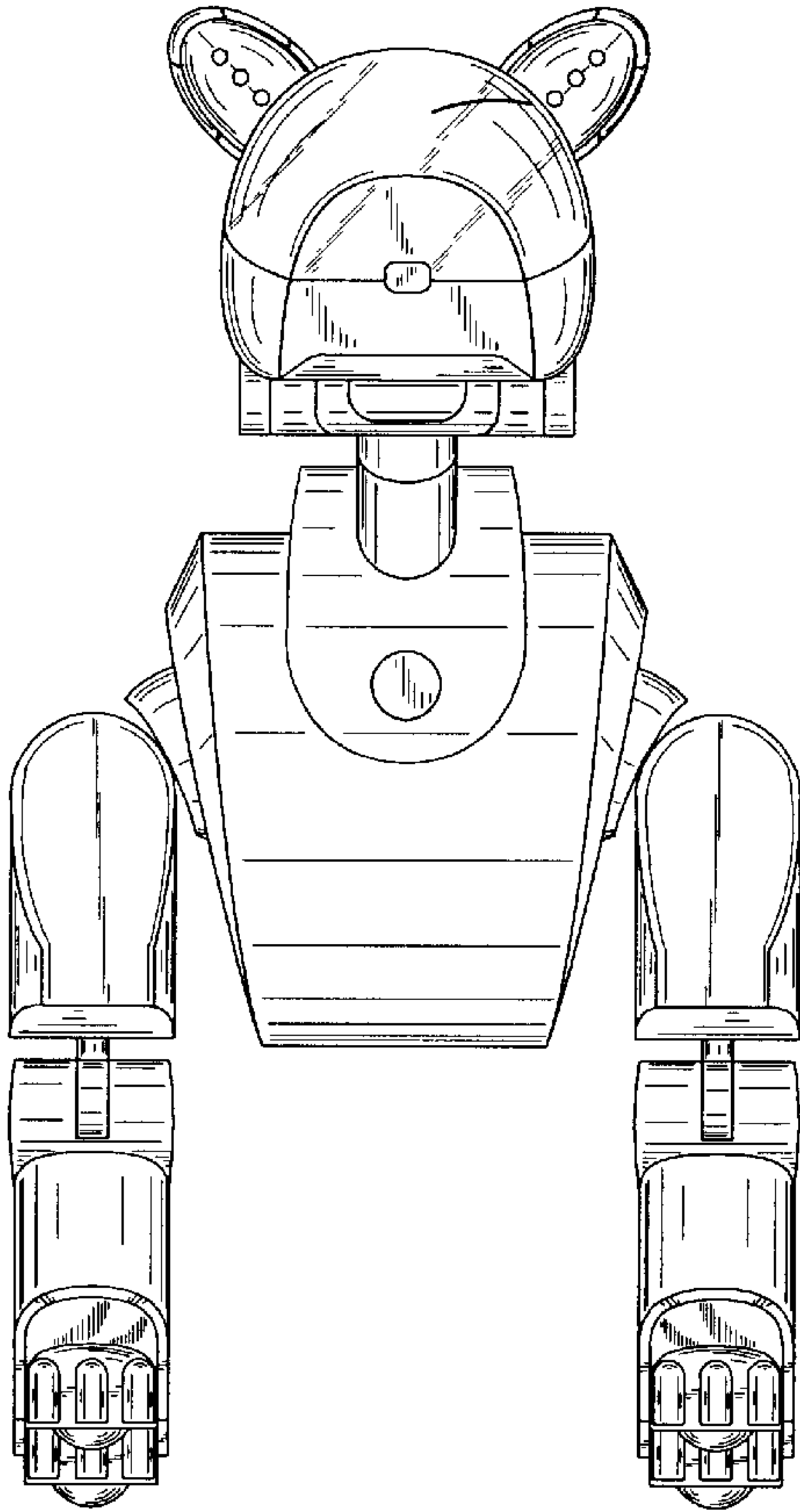

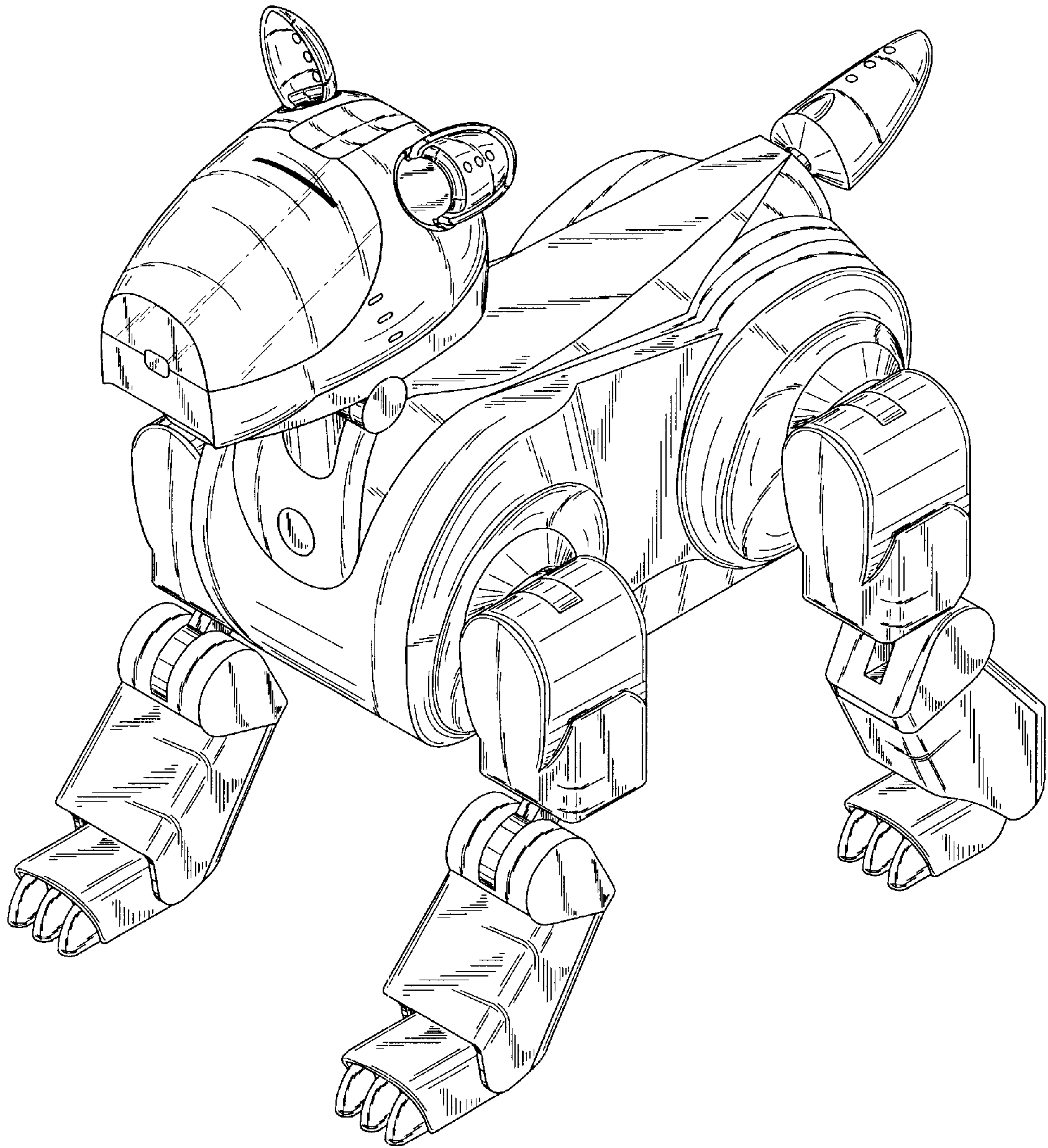

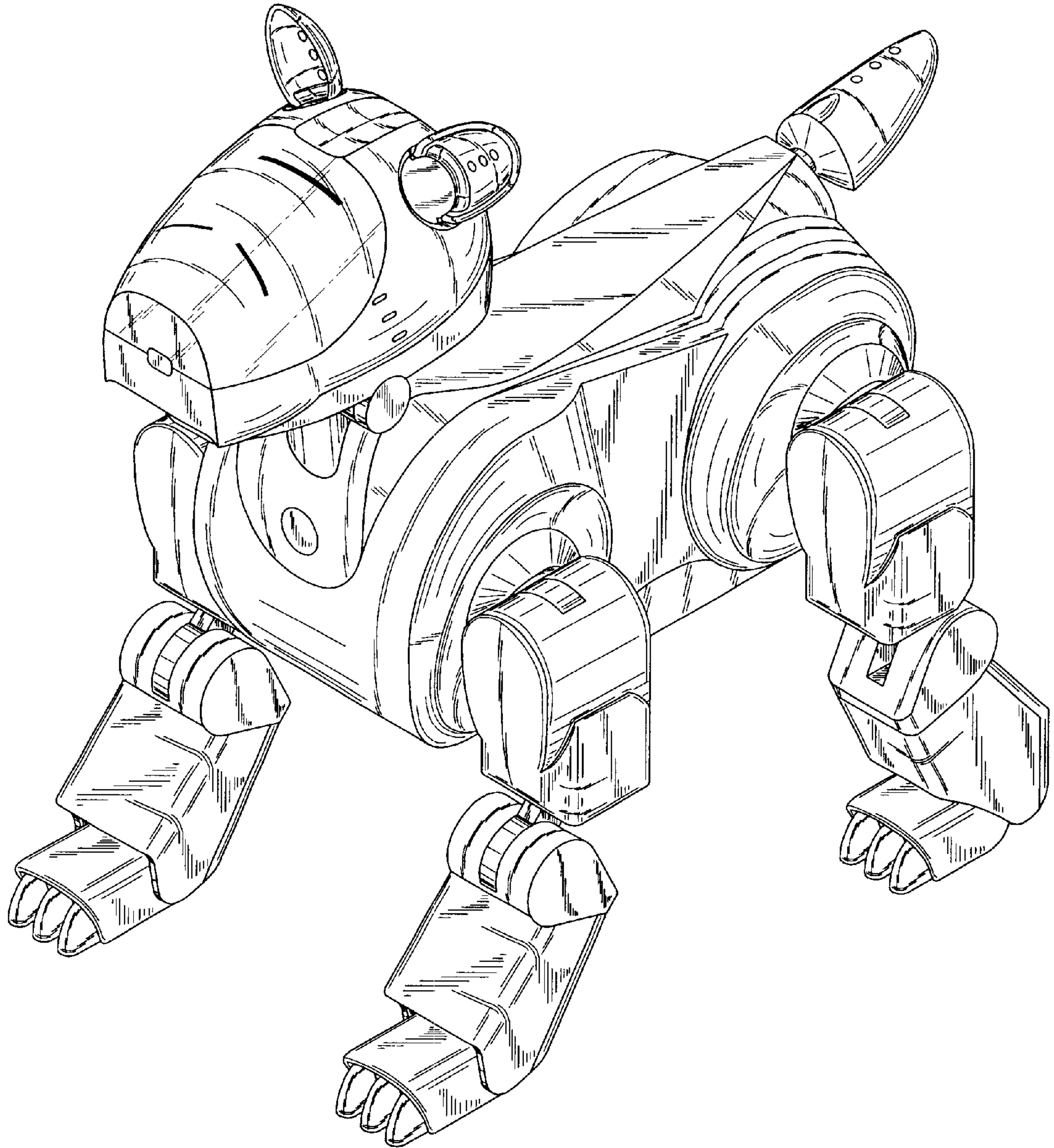

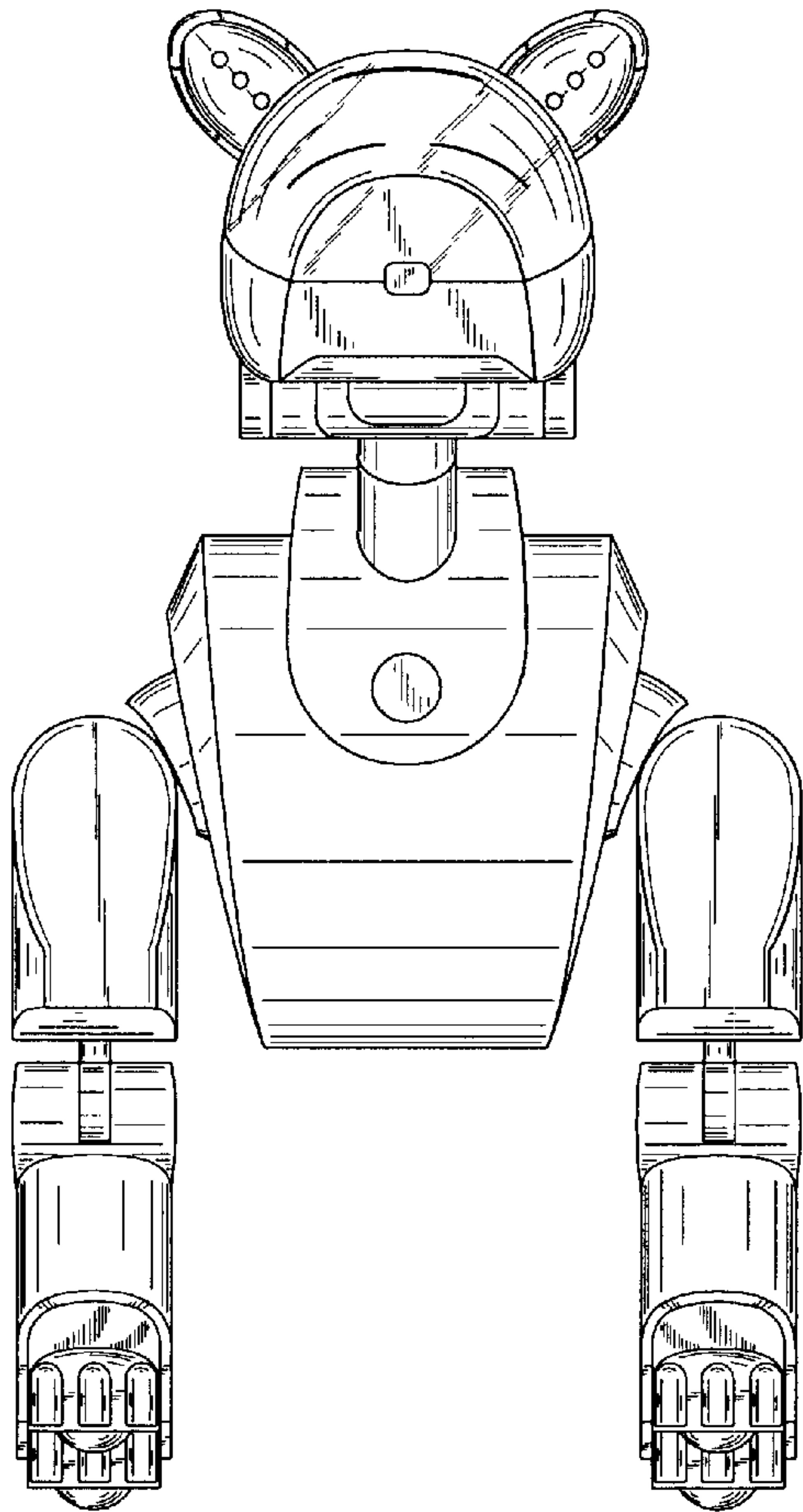
