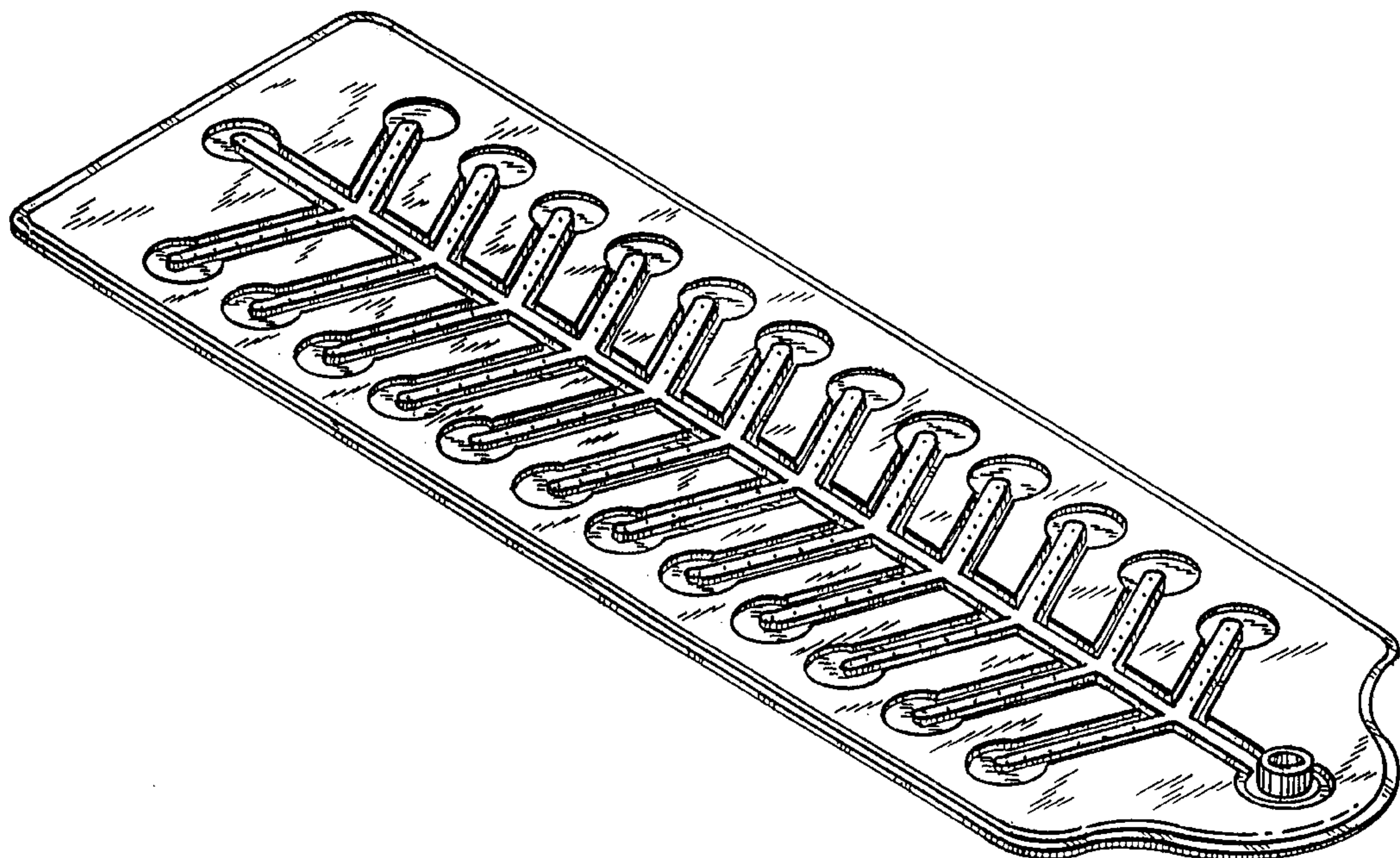
(57) **CLAIM**

The ornamental design for a bubbling bath mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bubbling bath mat according to the present invention; FIG. 2 is a top view of the bubbling bath mat of FIG. 1; FIG. 3 is a bottom view of the bubbling bath mat of FIG. 1; FIG. 4 is a side view of the bubbling bath mat of FIG. 1; and FIG. 5 is a side view of the bubbling bath mat of FIG. 1. The broken lines showing suction cups are for illustrative purposes only and form no part of the claimed design.

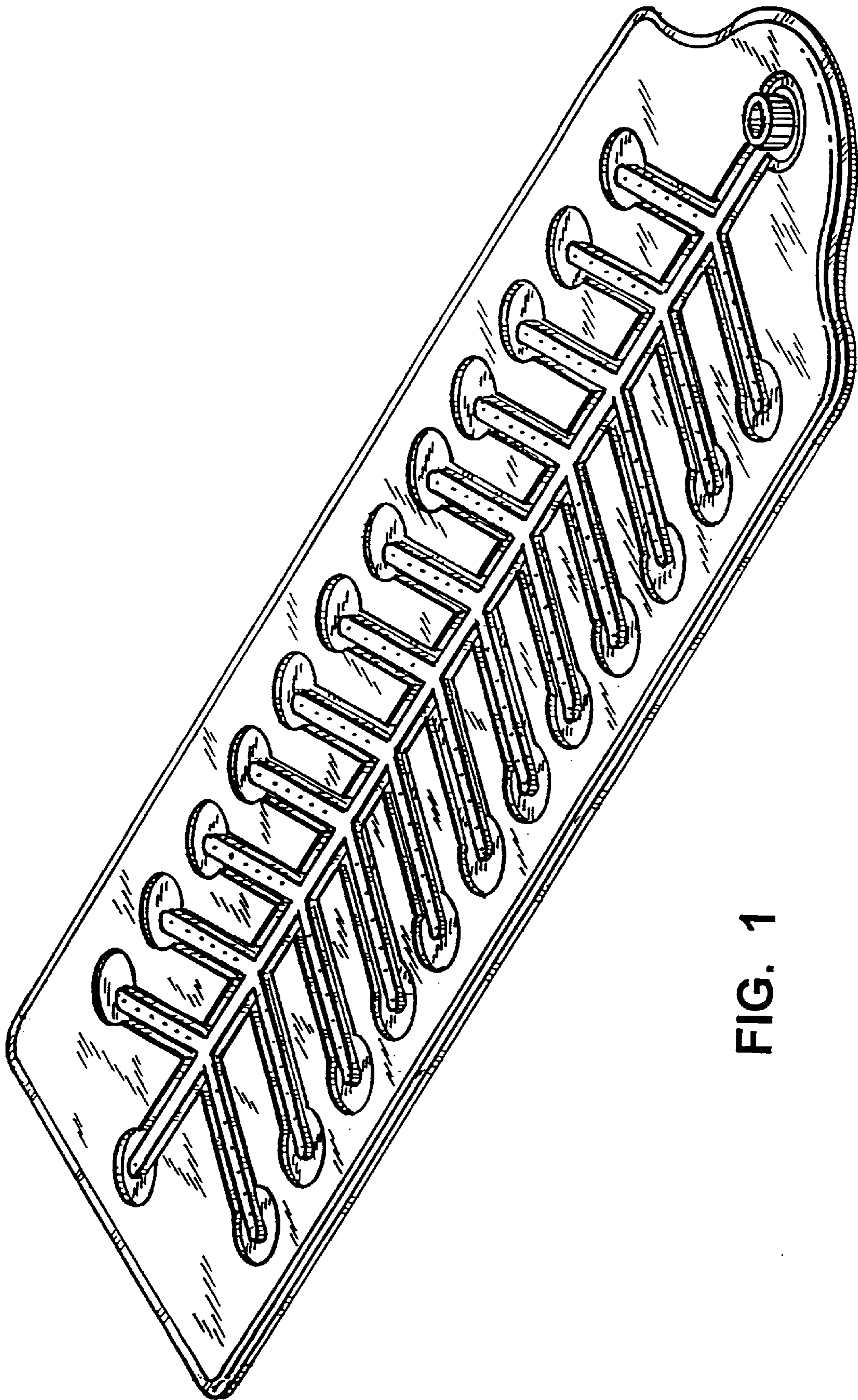

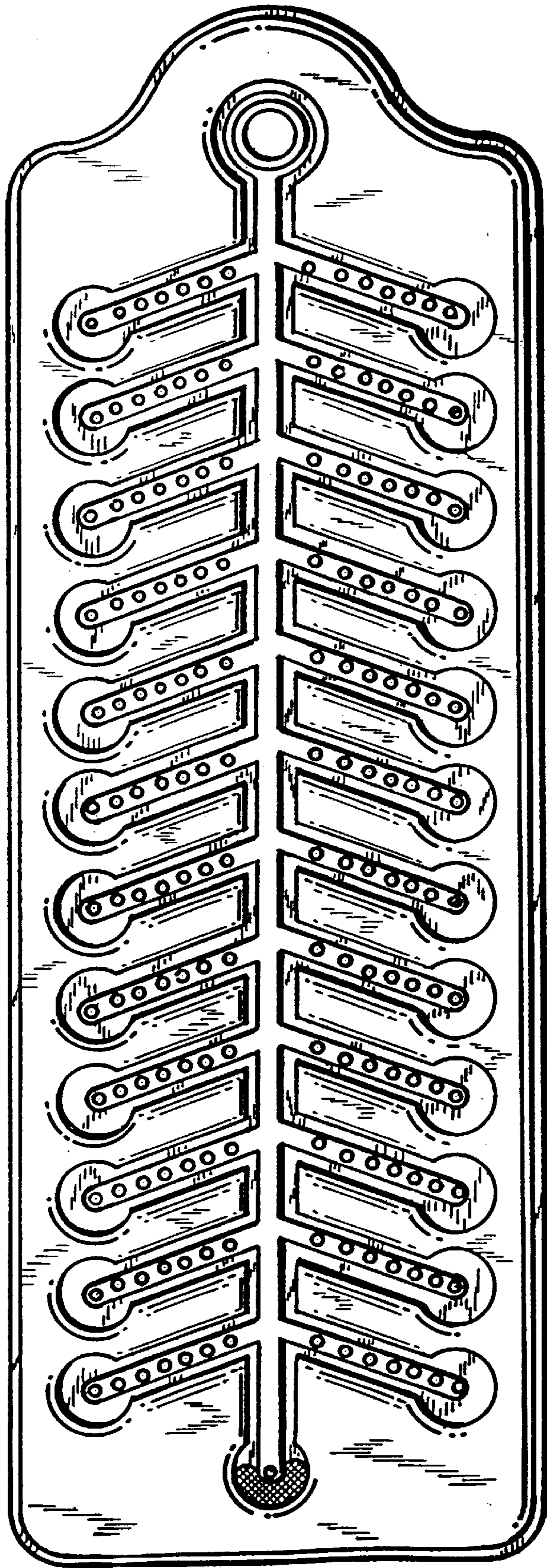

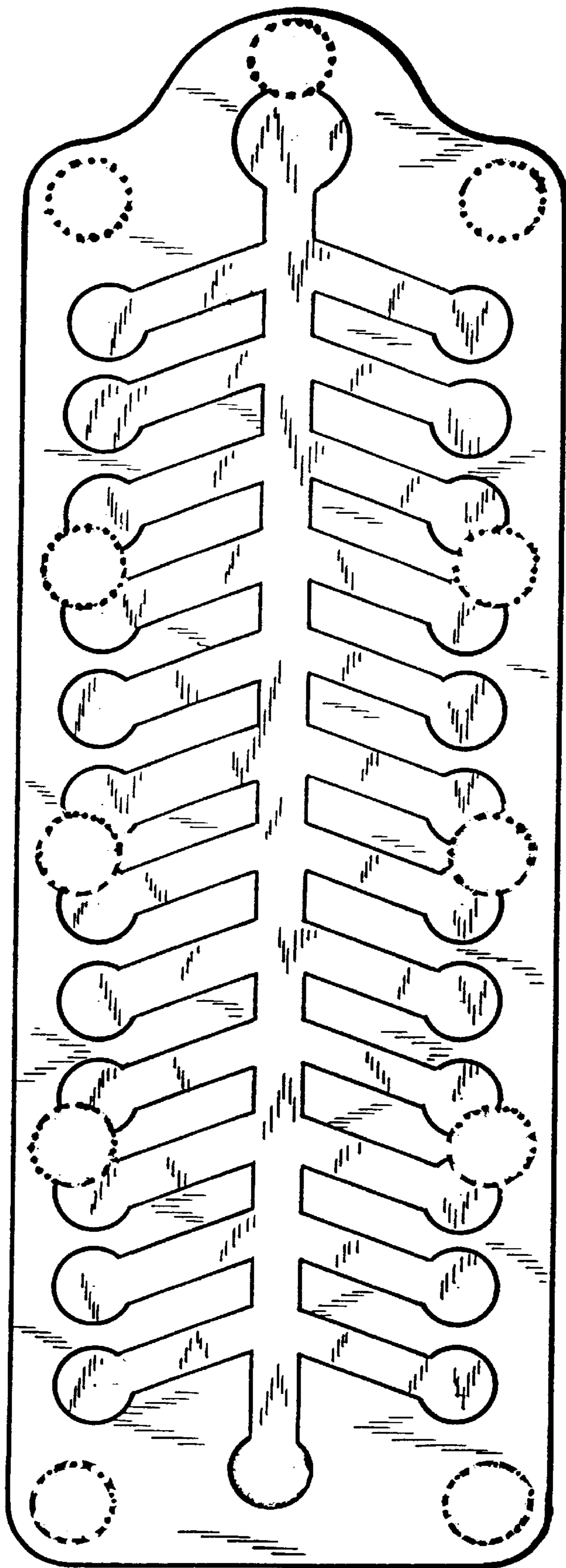

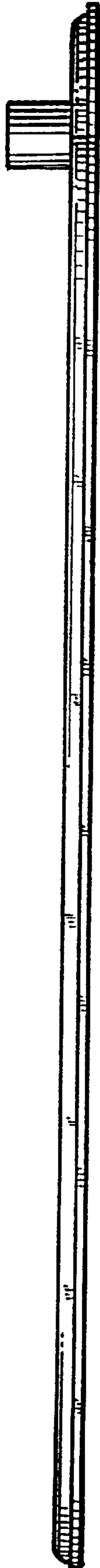

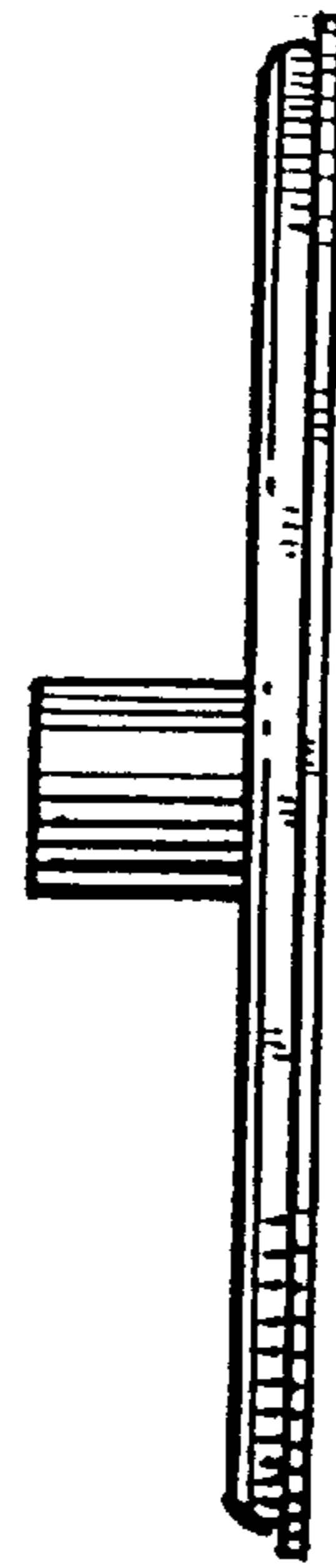
