The ornamental design for shock absorbing rodeo pants with shin guard pockets, as shown and described.

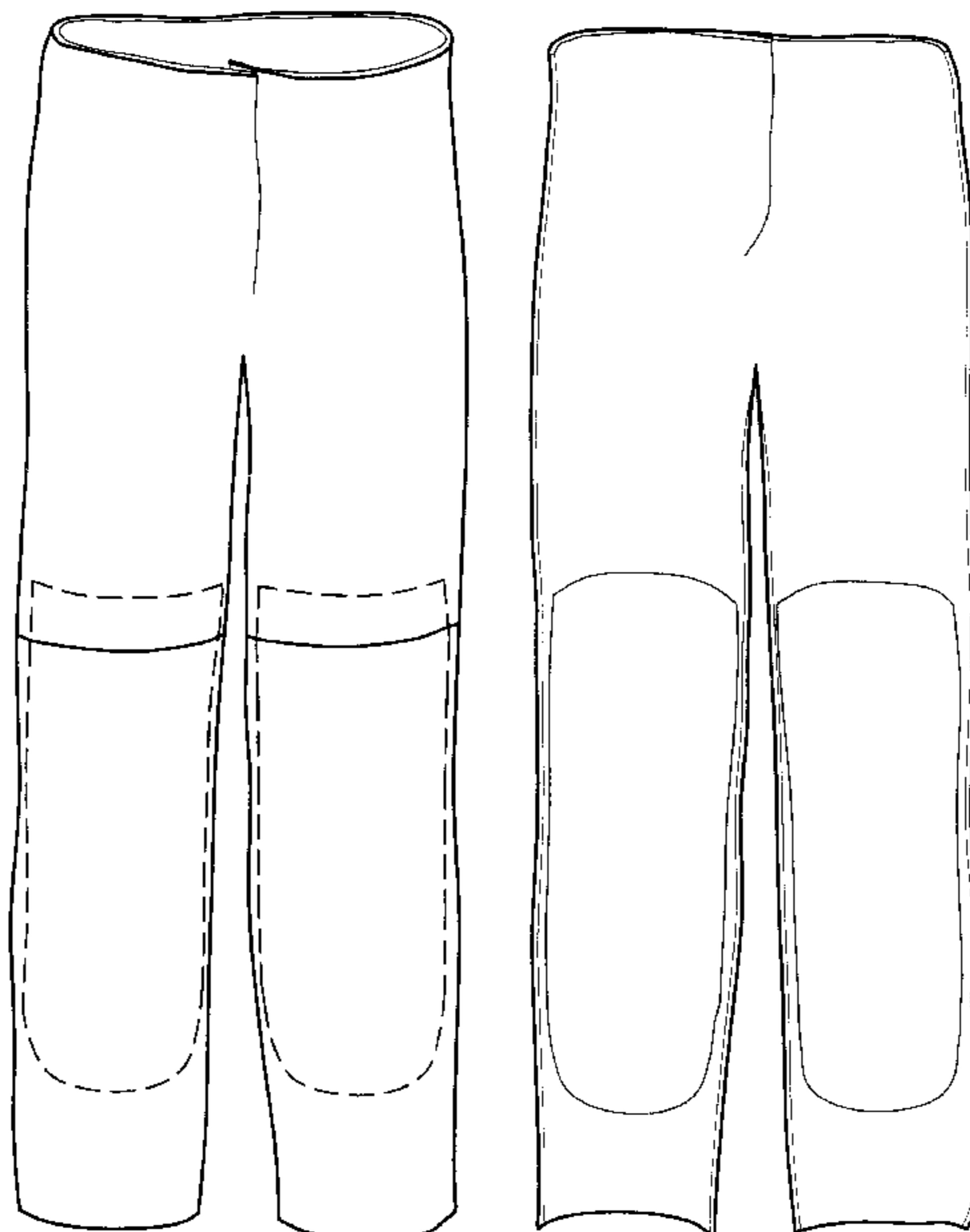
DESCRIPTION

FIG. 1 is a front perspective view of shock-absorbing rodeo pants with shin guard pockets, showing our new design, the broken lines being understood to represent top stitching; and,

FIG. 2 is a cross section inside front view thereof.

The appearance of the pants from the rear, form no part of the claimed design.

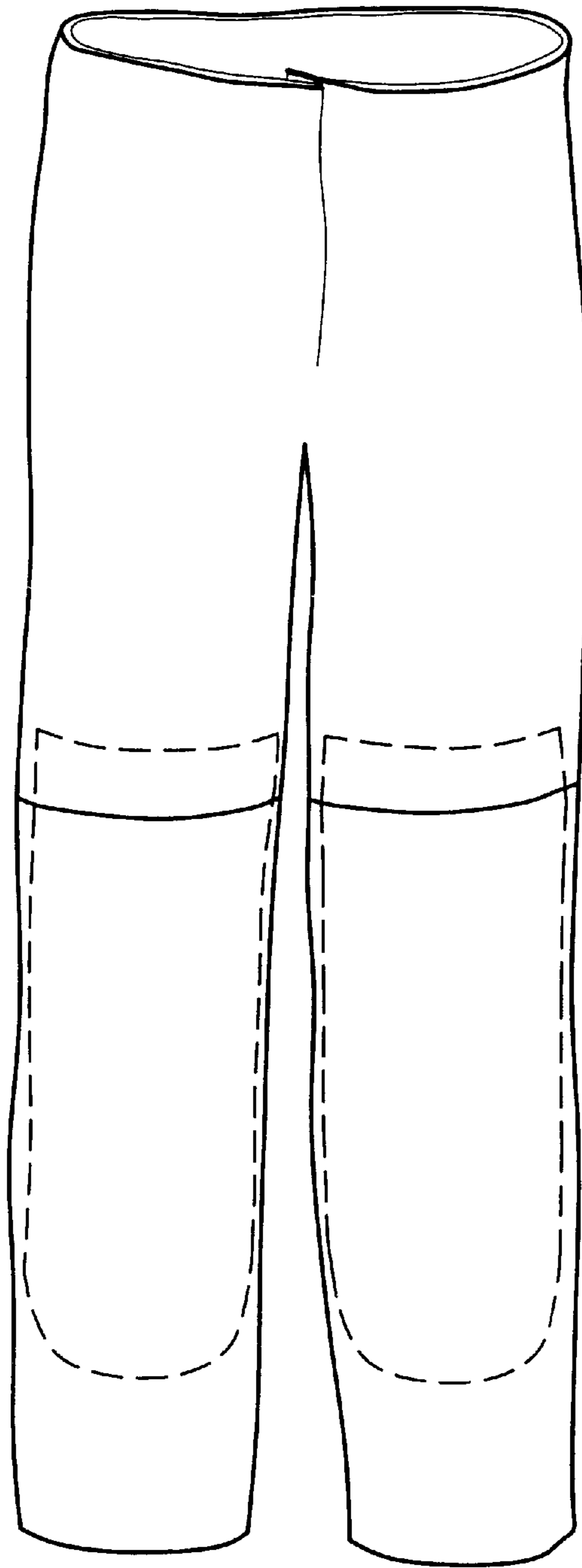

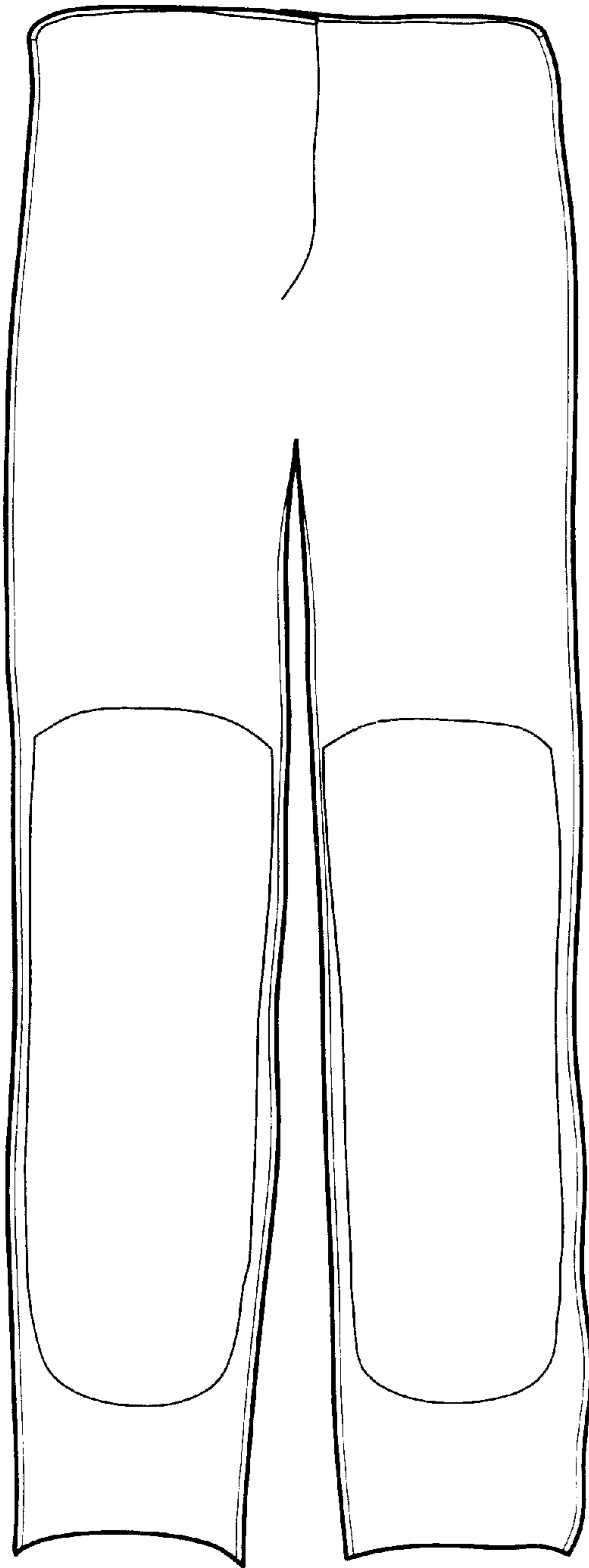
