FIG. 2 is left side view thereof;

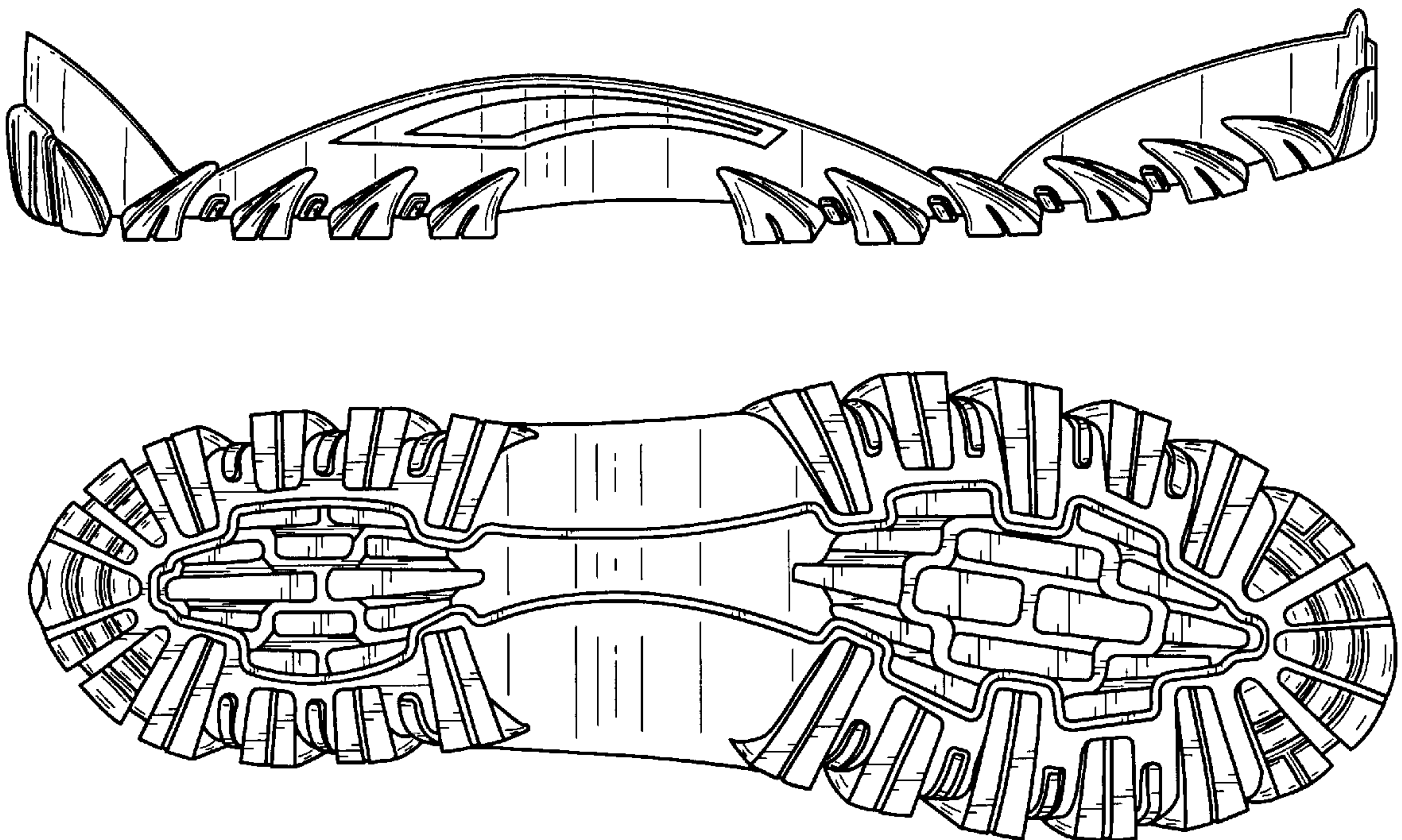
FIG. 3 is a bottom view thereof;

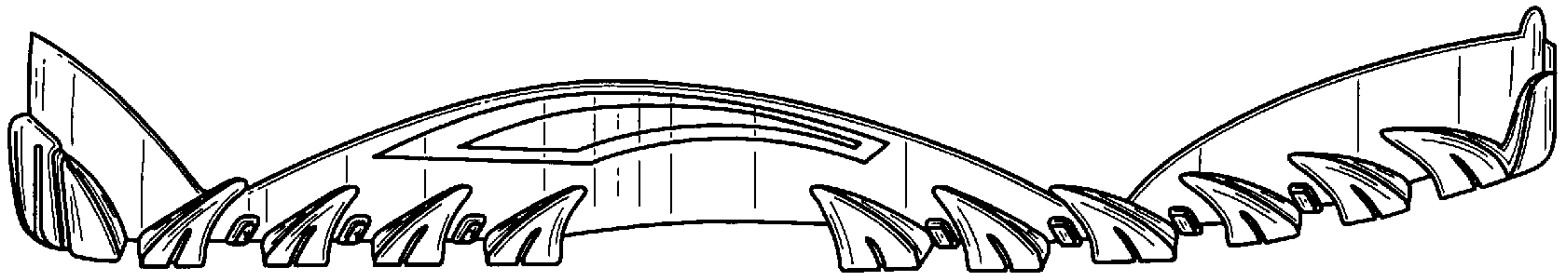

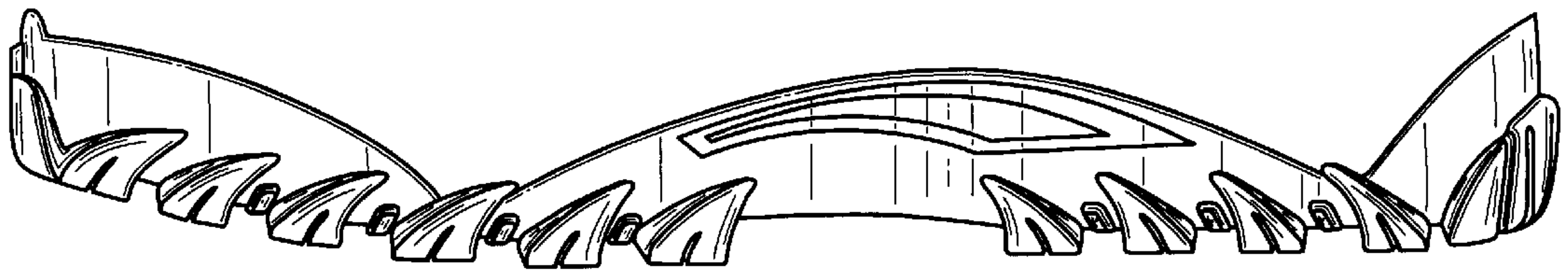

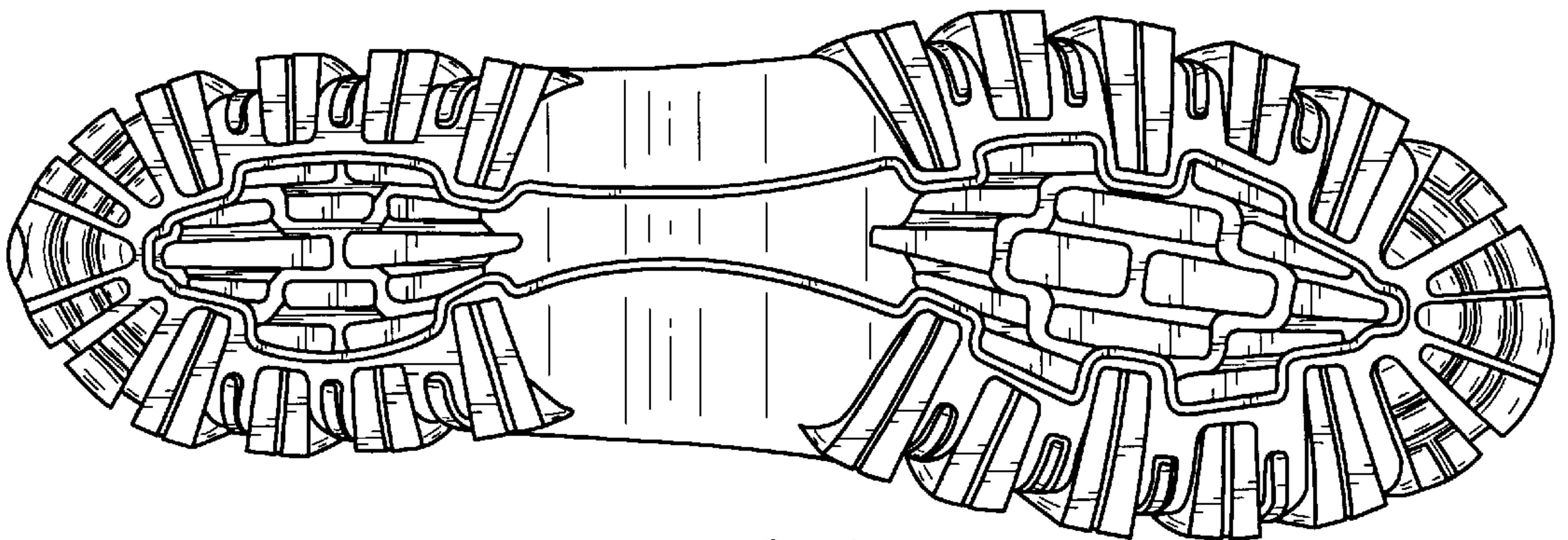

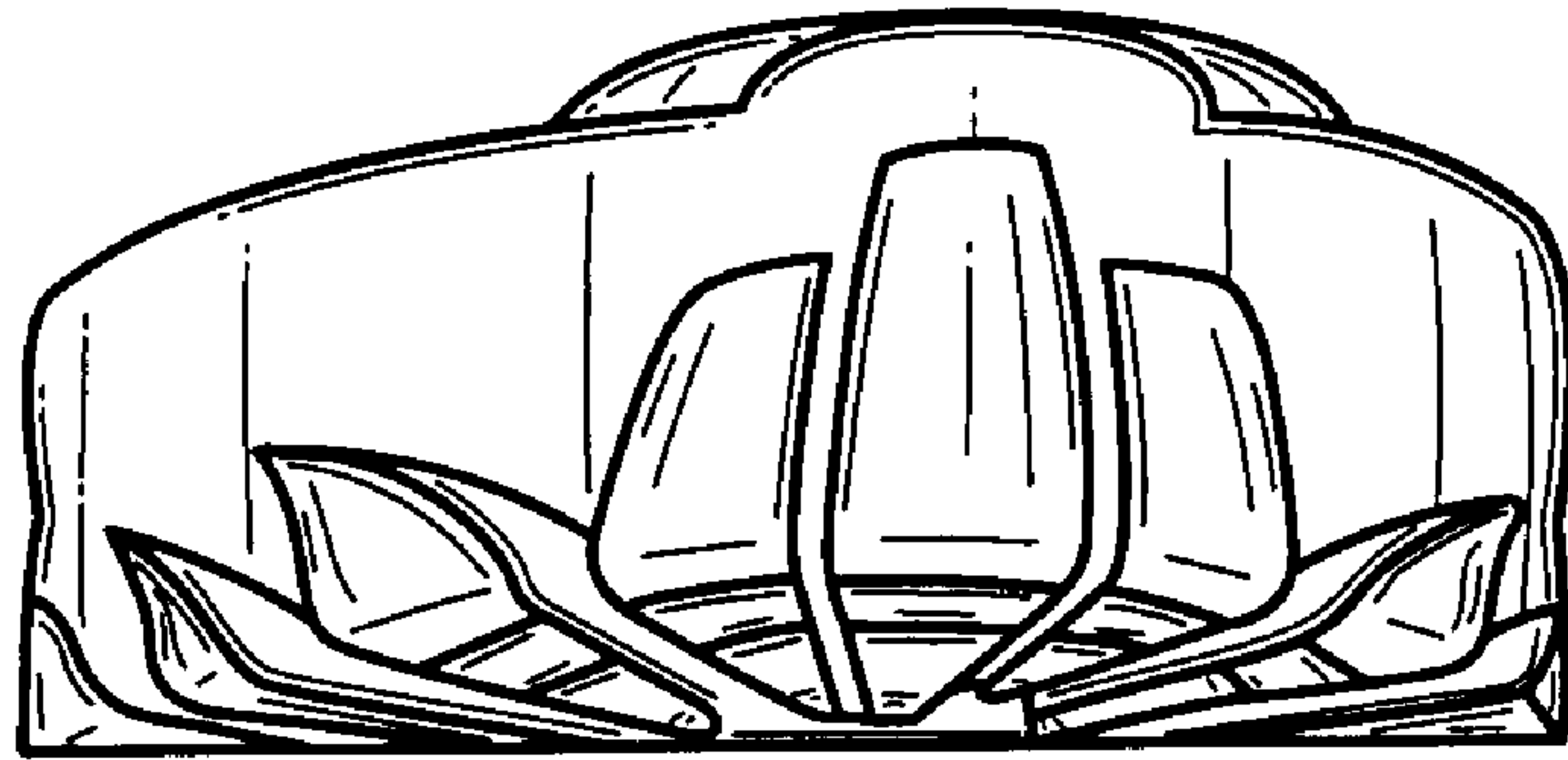

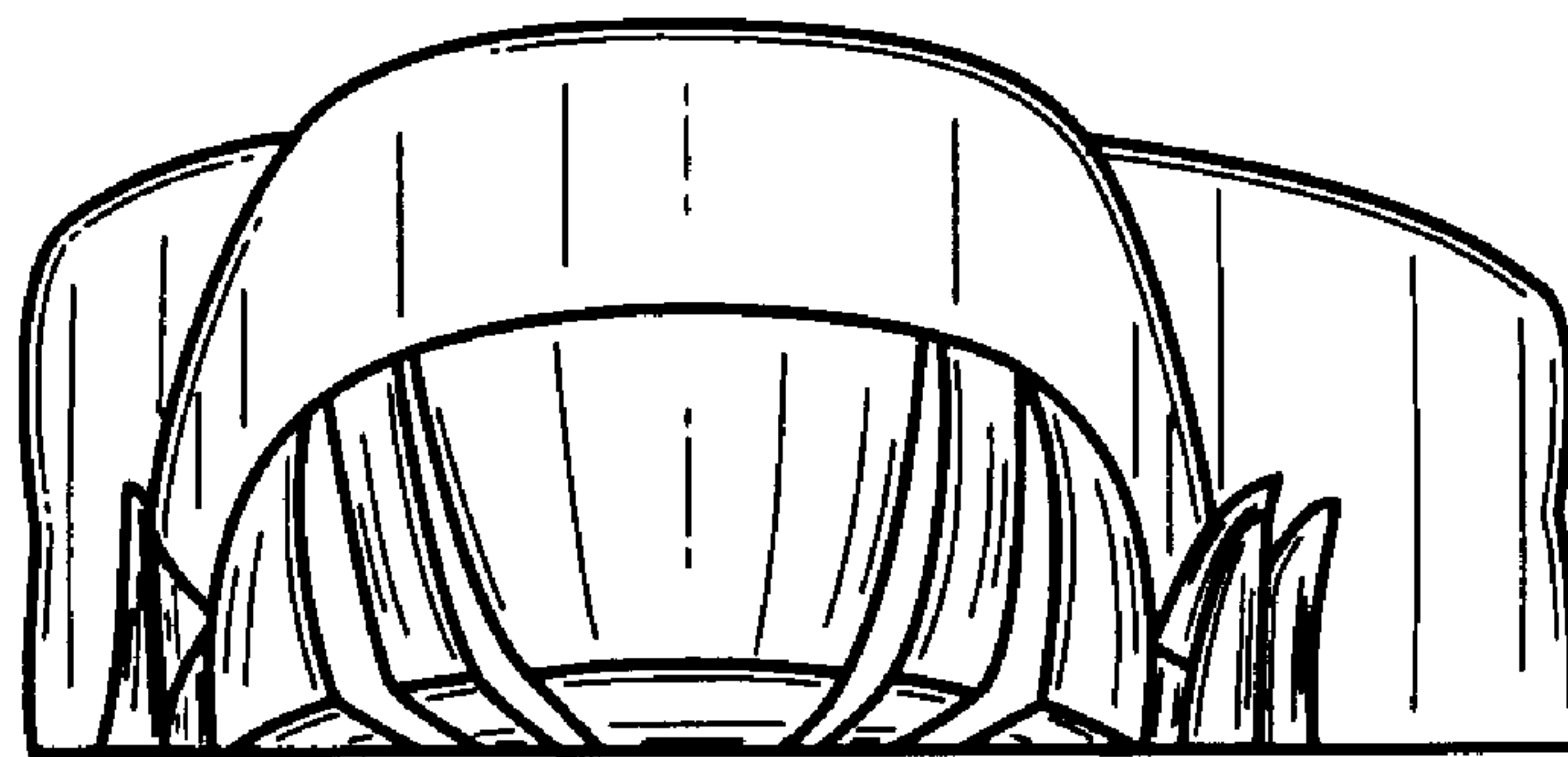

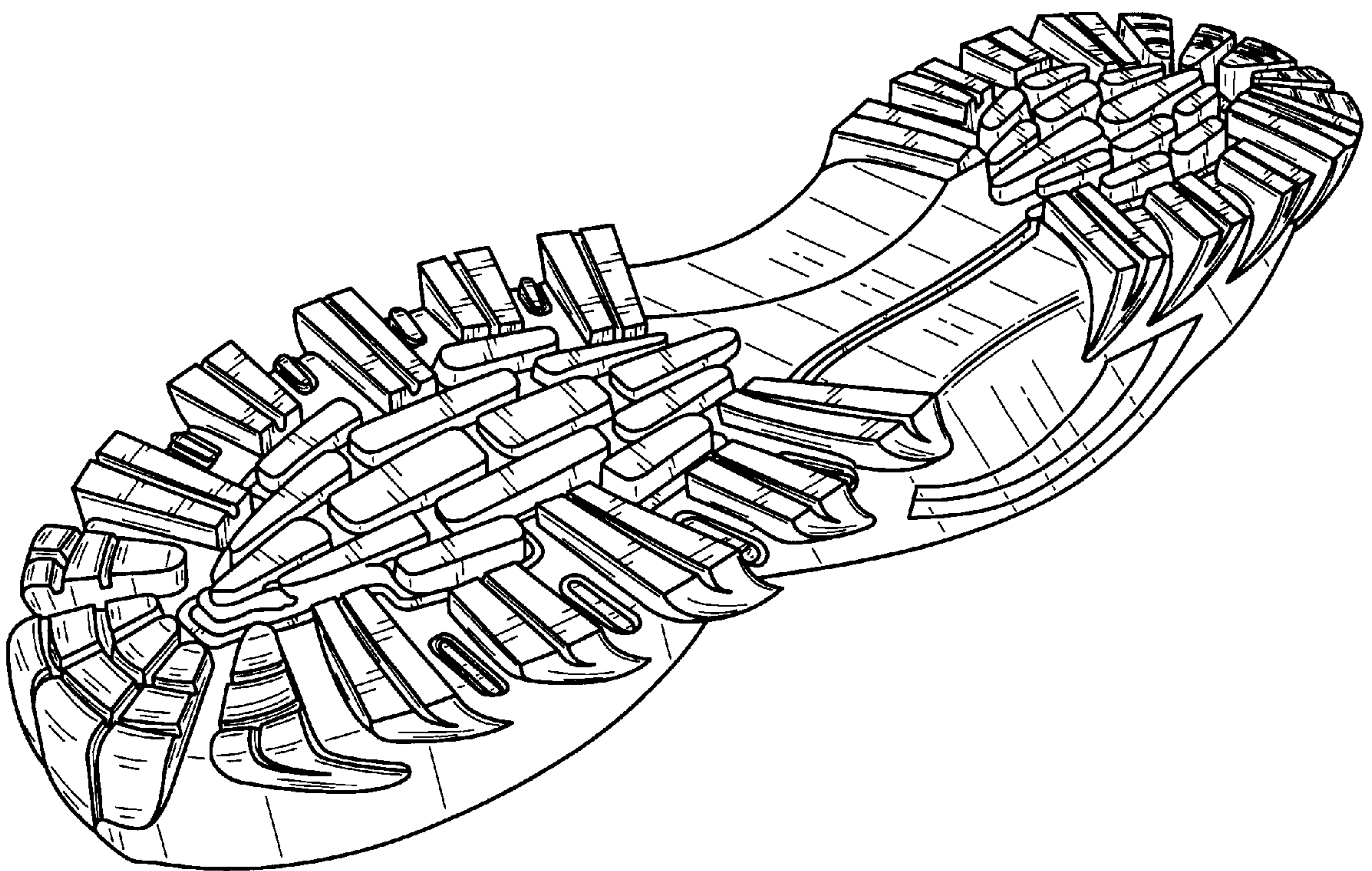
