FIG. 2 is a reduced front view thereof;

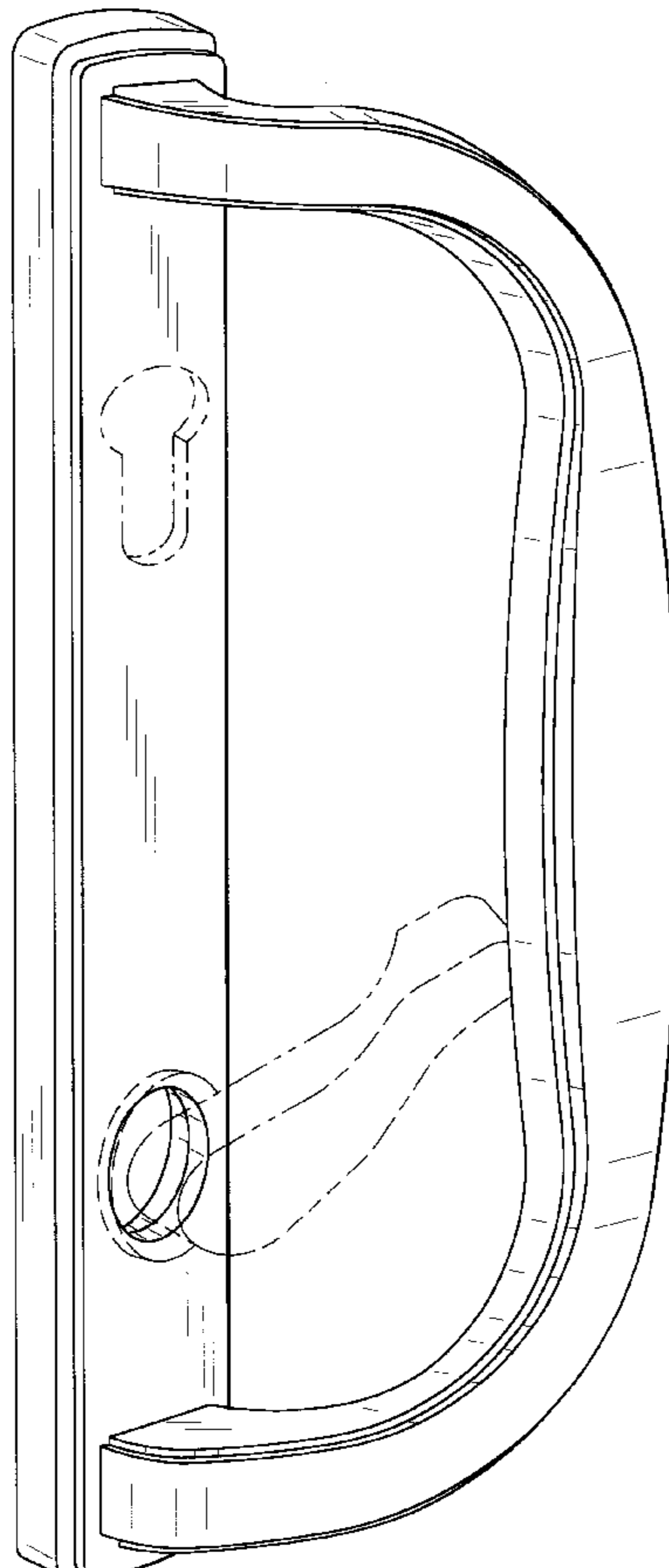
FIG. 3 is a right side view thereof;

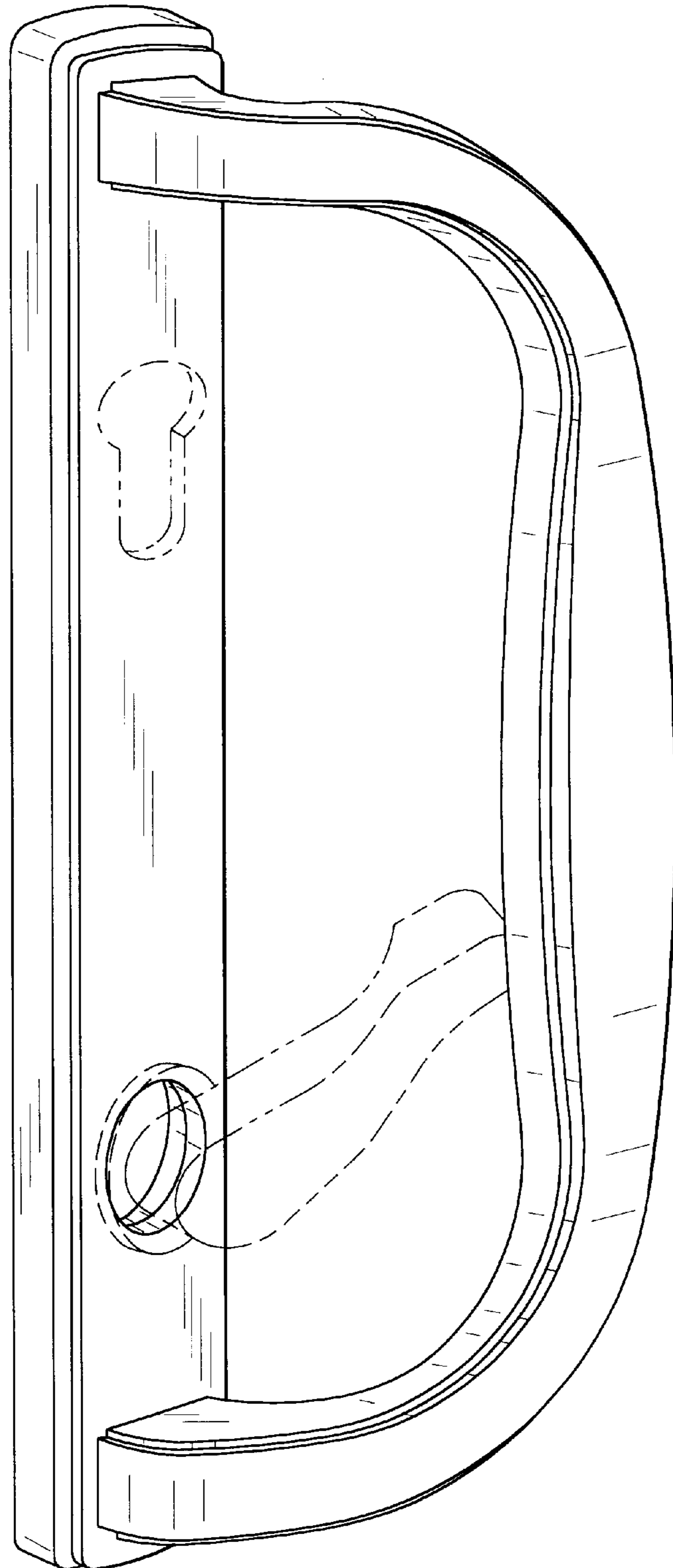

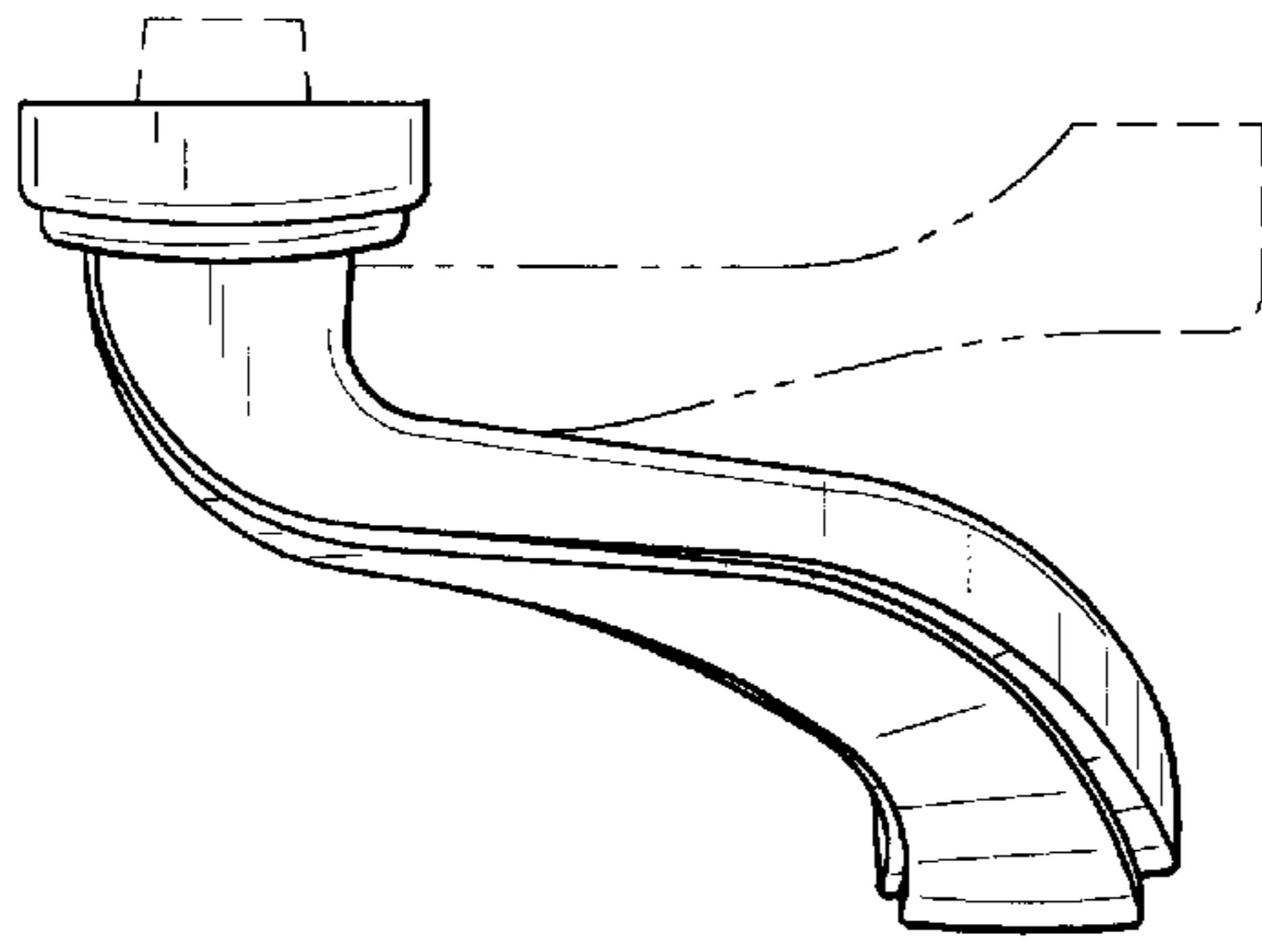

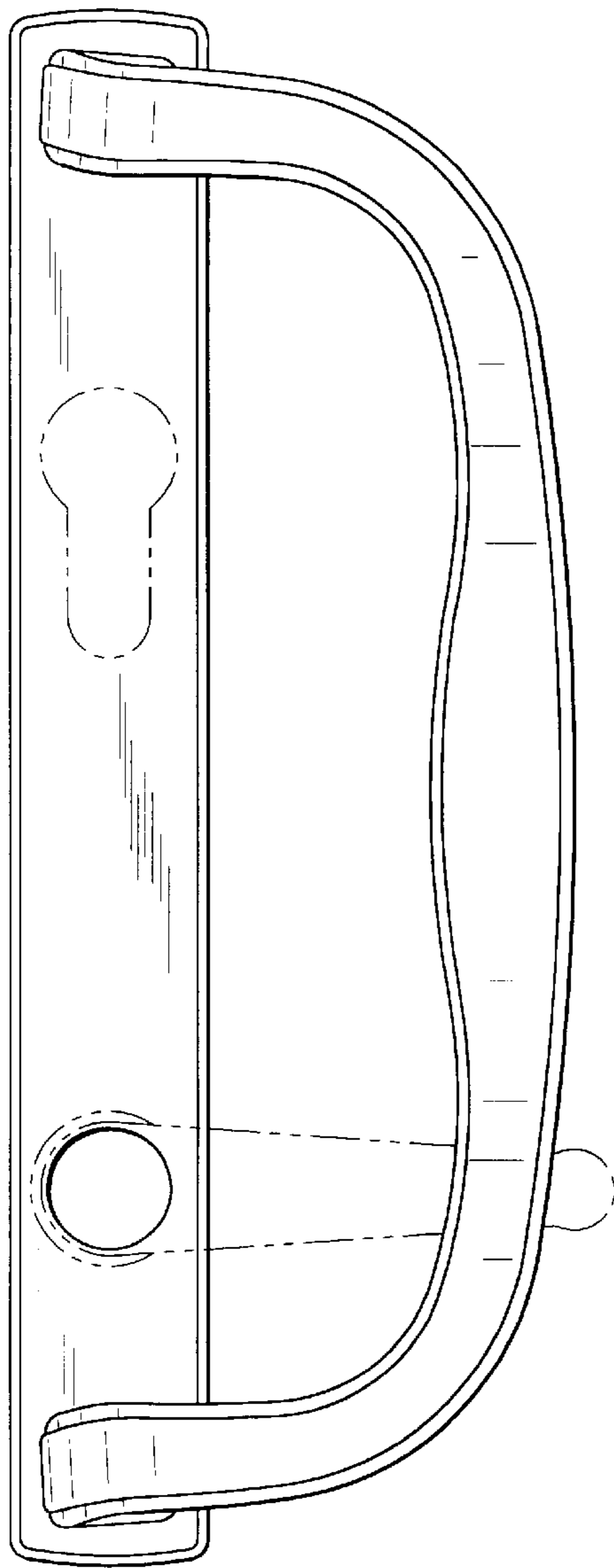

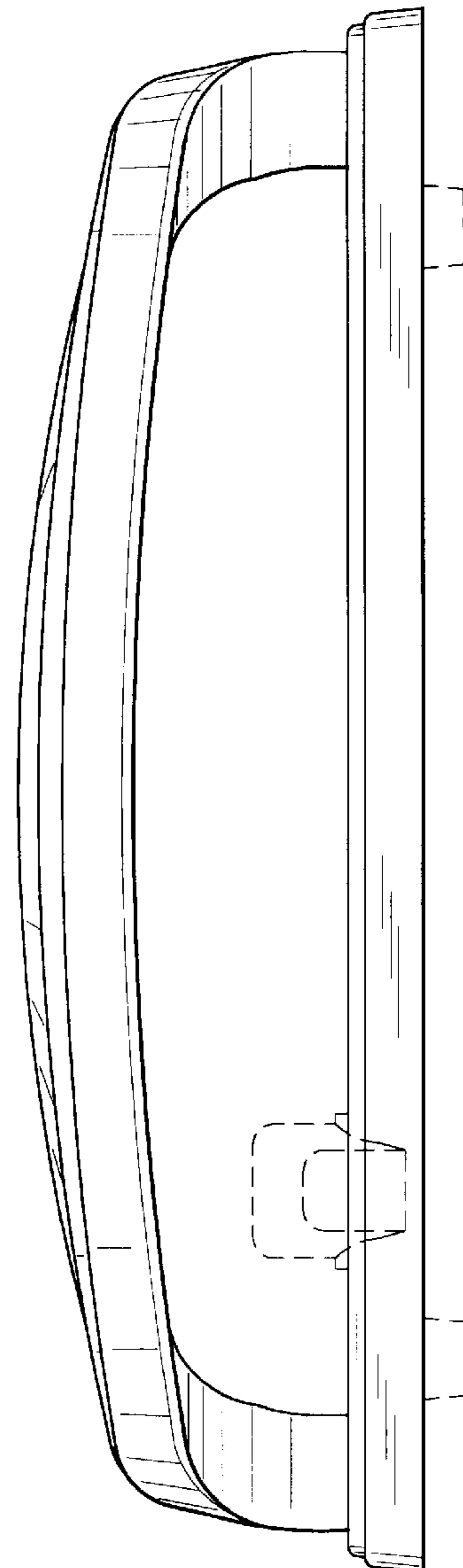

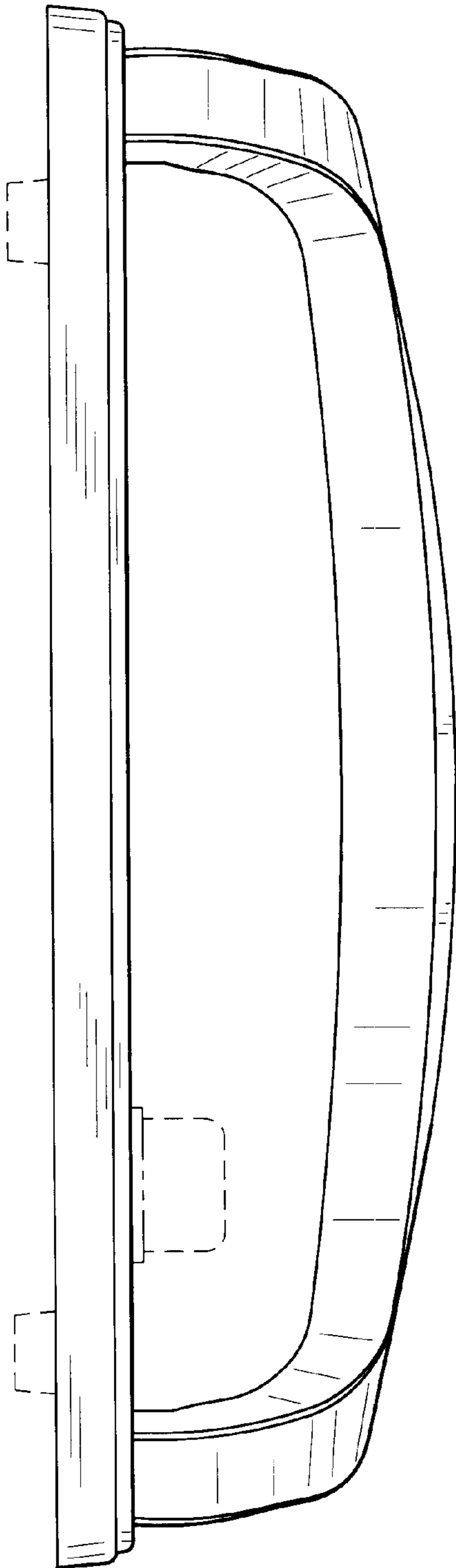

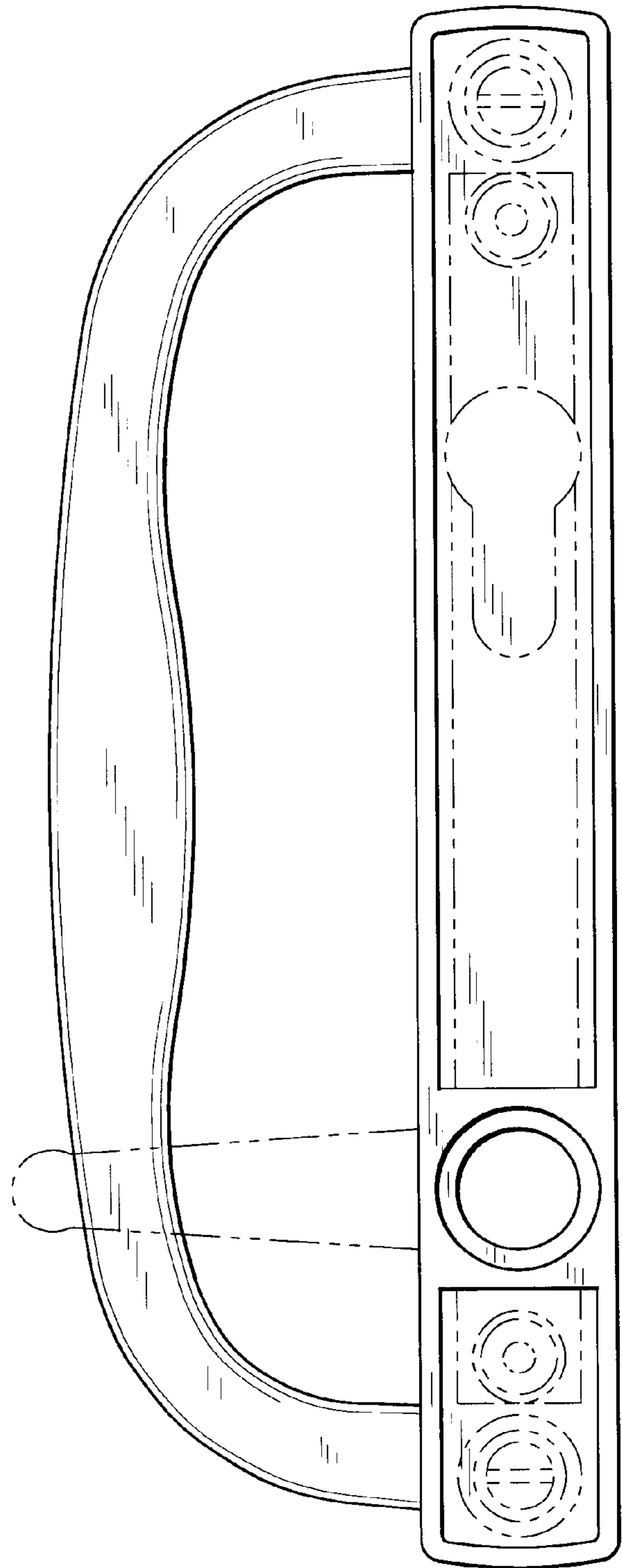
