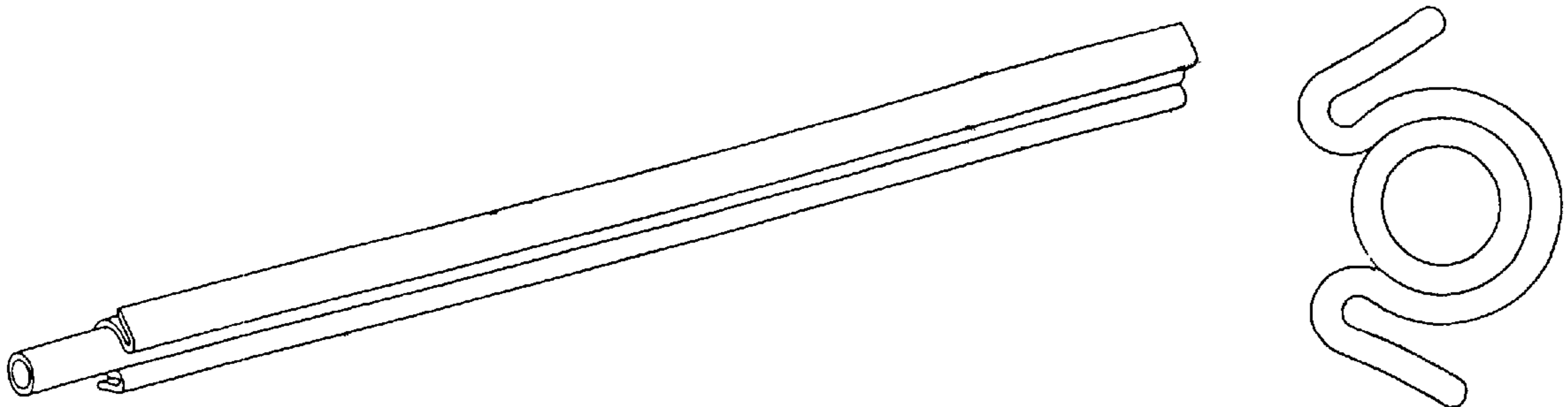
(57) **CLAIM**

I claim the ornamental design for a bag closure device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present invention; FIG. 2 is a front plan view thereof; FIG. 3 is a rear plan view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side plan view thereof (enlarged relative to FIG. 1 through FIG. 5, same scale as FIG. 7); and, FIG. 7 is a left side plan view thereof (enlarged relative to FIG. 1 through FIG. 5, same scale as FIG. 6).

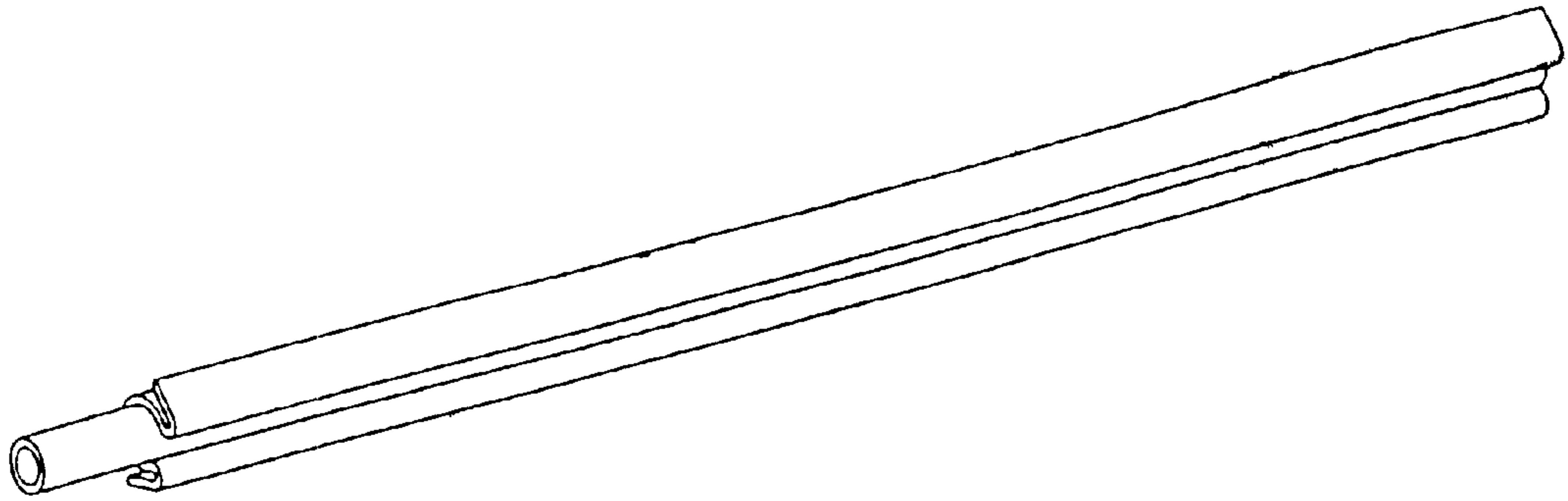

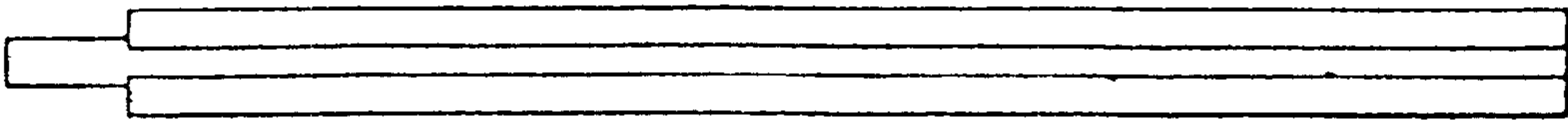

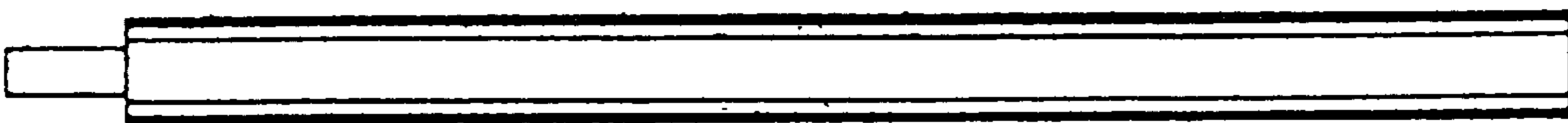

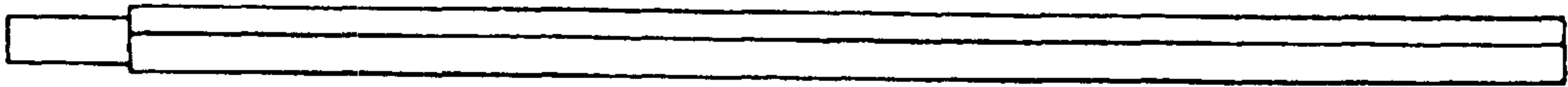

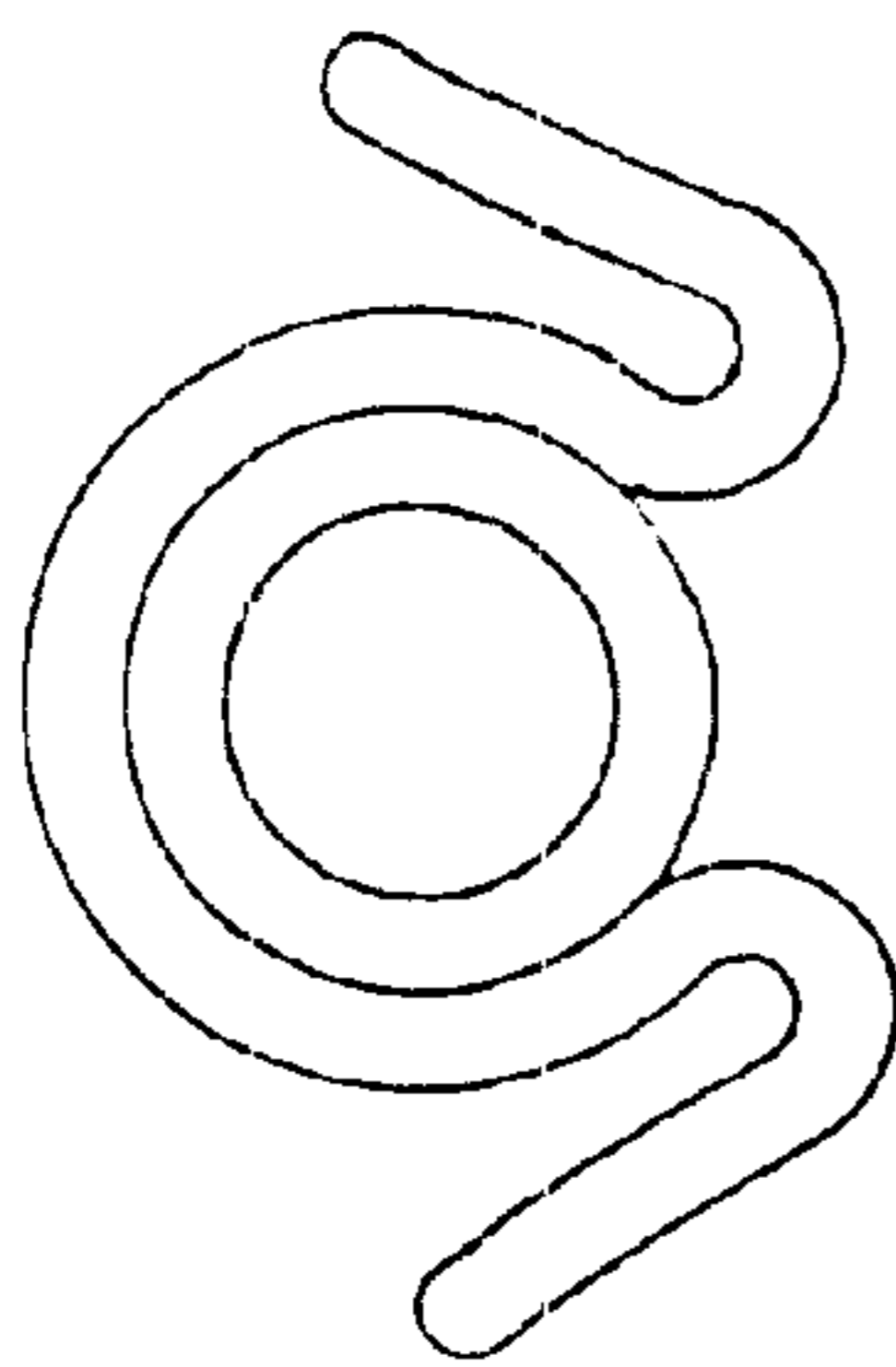

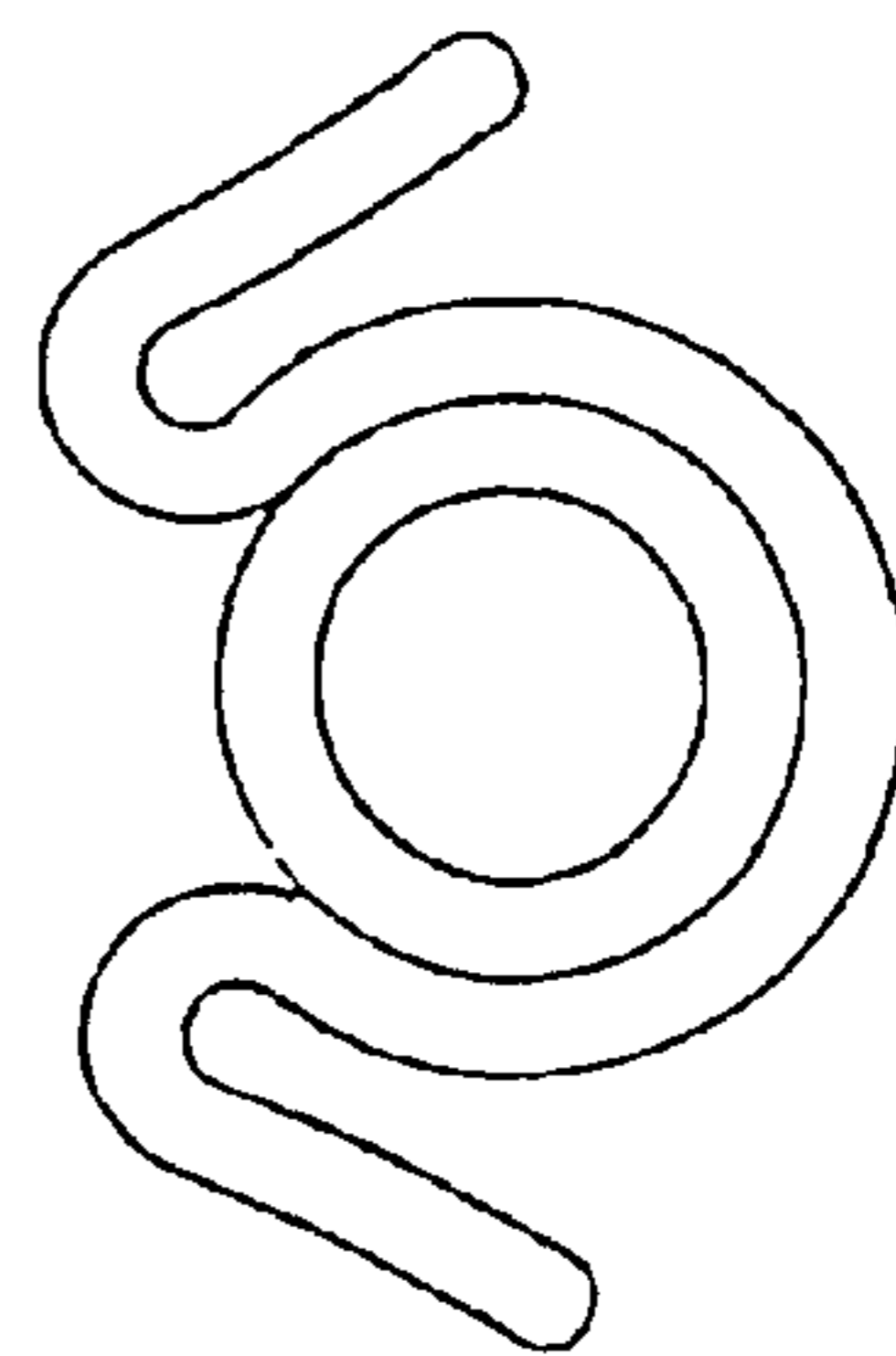
