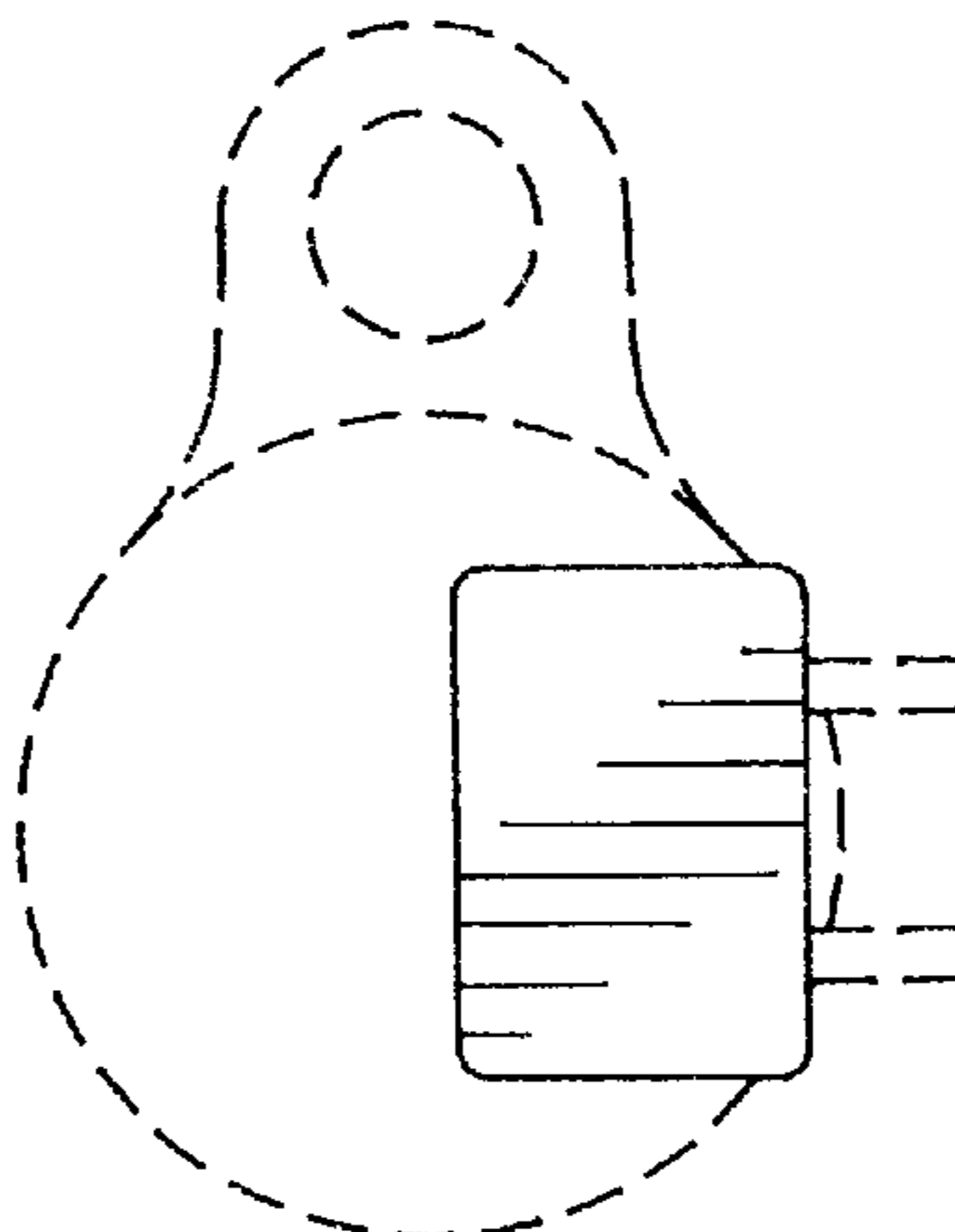
(57) **CLAIM**

The ornamental design for an electrical connector housing for an electromagnetic control valve, as shown and described above.

DESCRIPTION

FIG. 1 is a left side view of electrical connector housing for an electromagnetic control valve, according to the design. FIG. 2 is a right side view of the electrical connector housing for an electromagnetic control valve, as shown in FIG. 1. FIG. 3 is a rear view of the electrical connector housing for an electromagnetic control valve, as shown in FIG. 1. FIG. 4 is a front view of the electrical connector housing for an electromagnetic control valve, as shown in FIG. 1. FIG. 5 is a top plan view of the electrical connector housing for an electromagnetic control valve, as shown in FIG. 1. FIG. 6 is a bottom plan view of the electrical connector housing for an electromagnetic control valve, as shown in FIG. 1. FIG. 7 is a side view of a compressor including an electrical connector housing for an electromagnetic control valve, as shown in FIG. 1; and, FIG. 8 is a rear view of the compressor of FIG. 7, including the electrical connector housing for an electromagnetic control valve, as shown in FIG. 1.

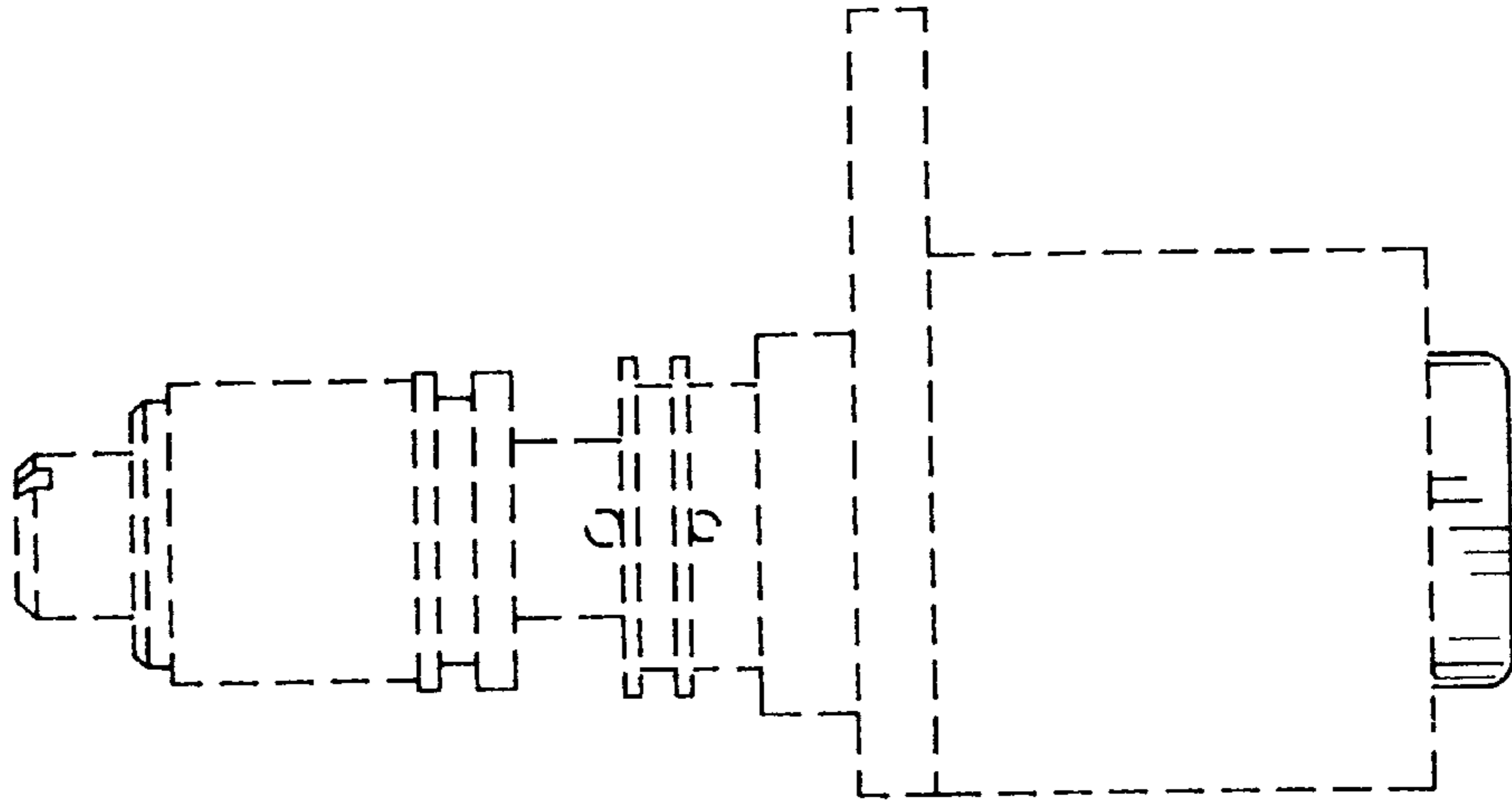

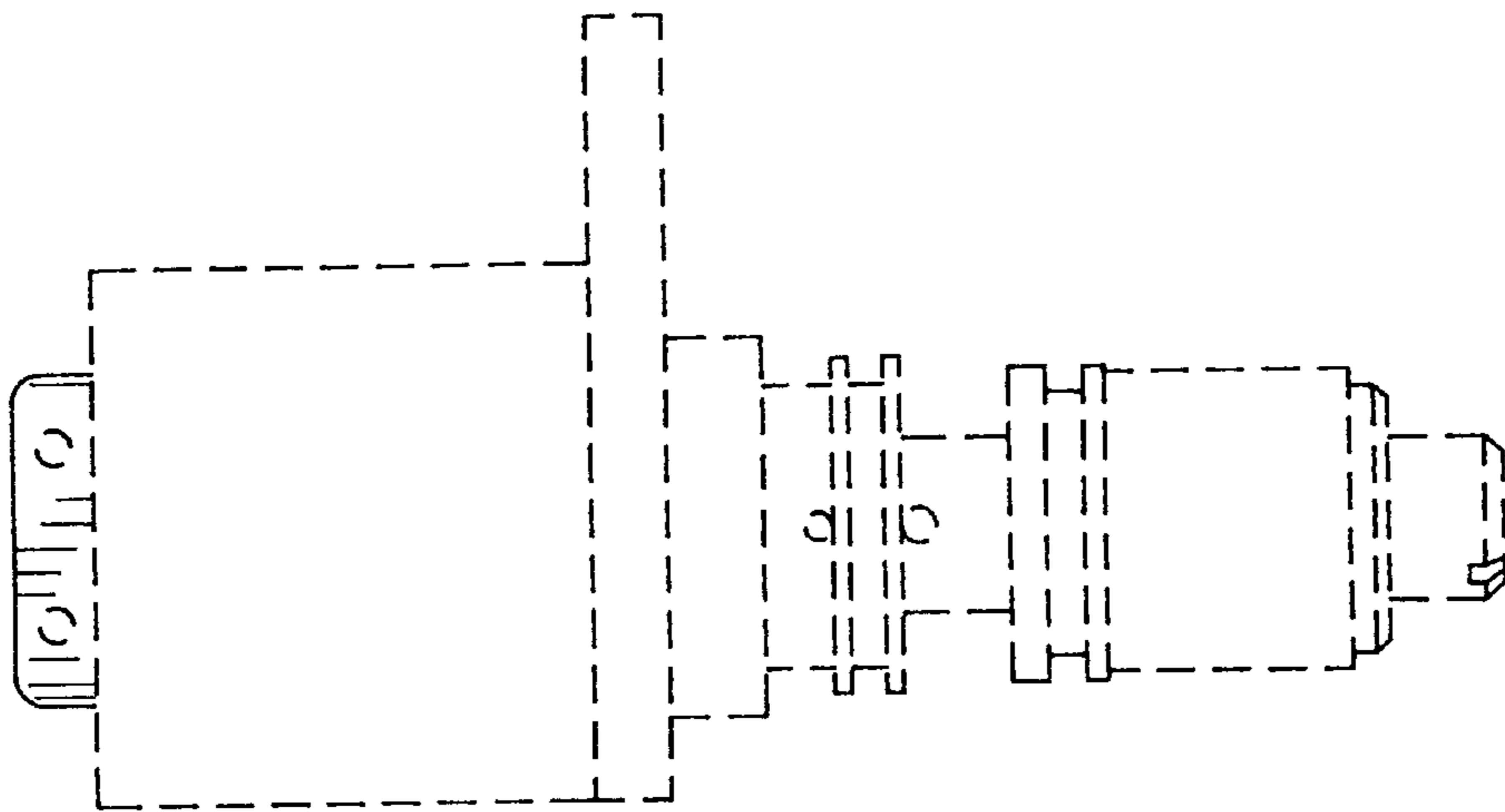

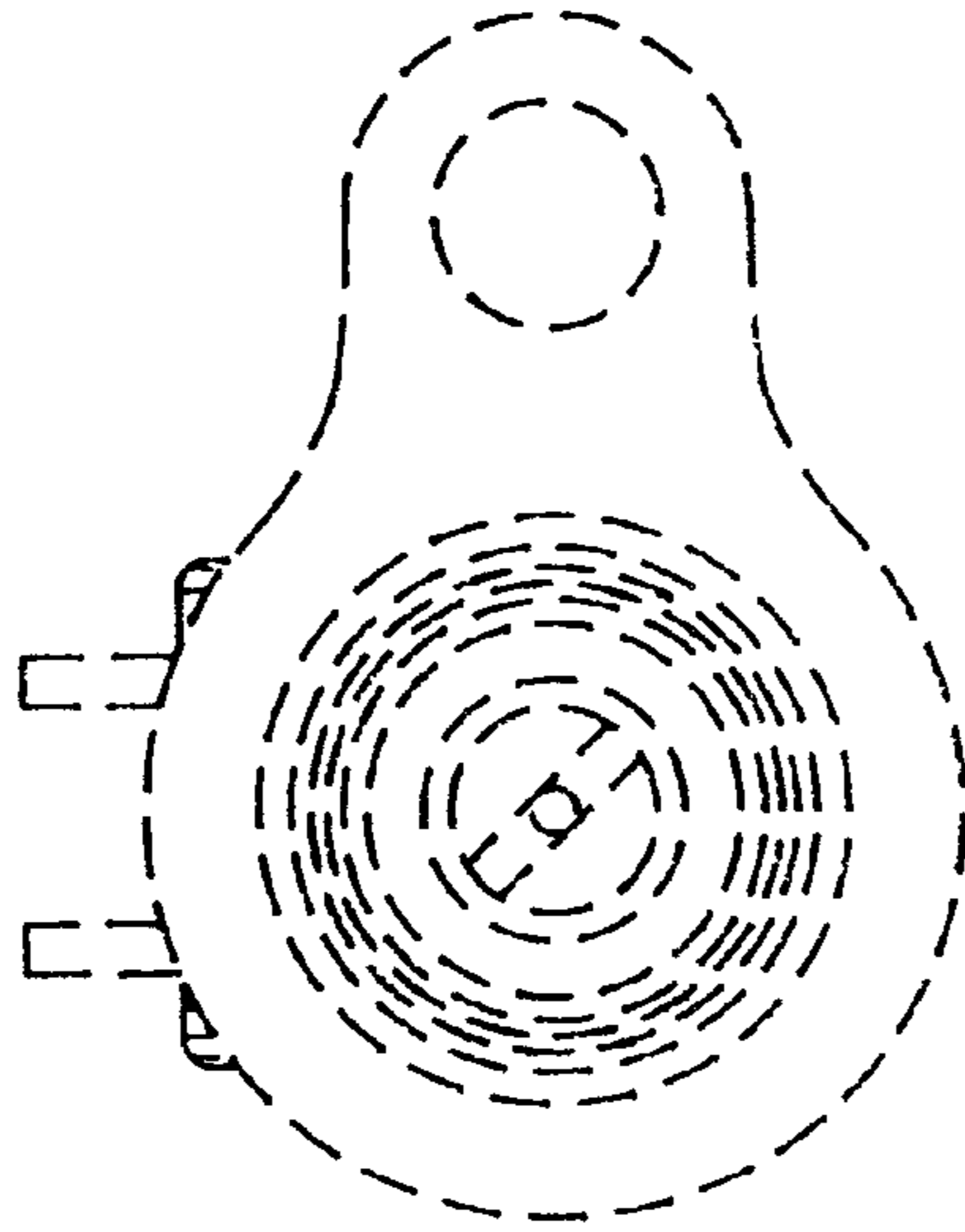

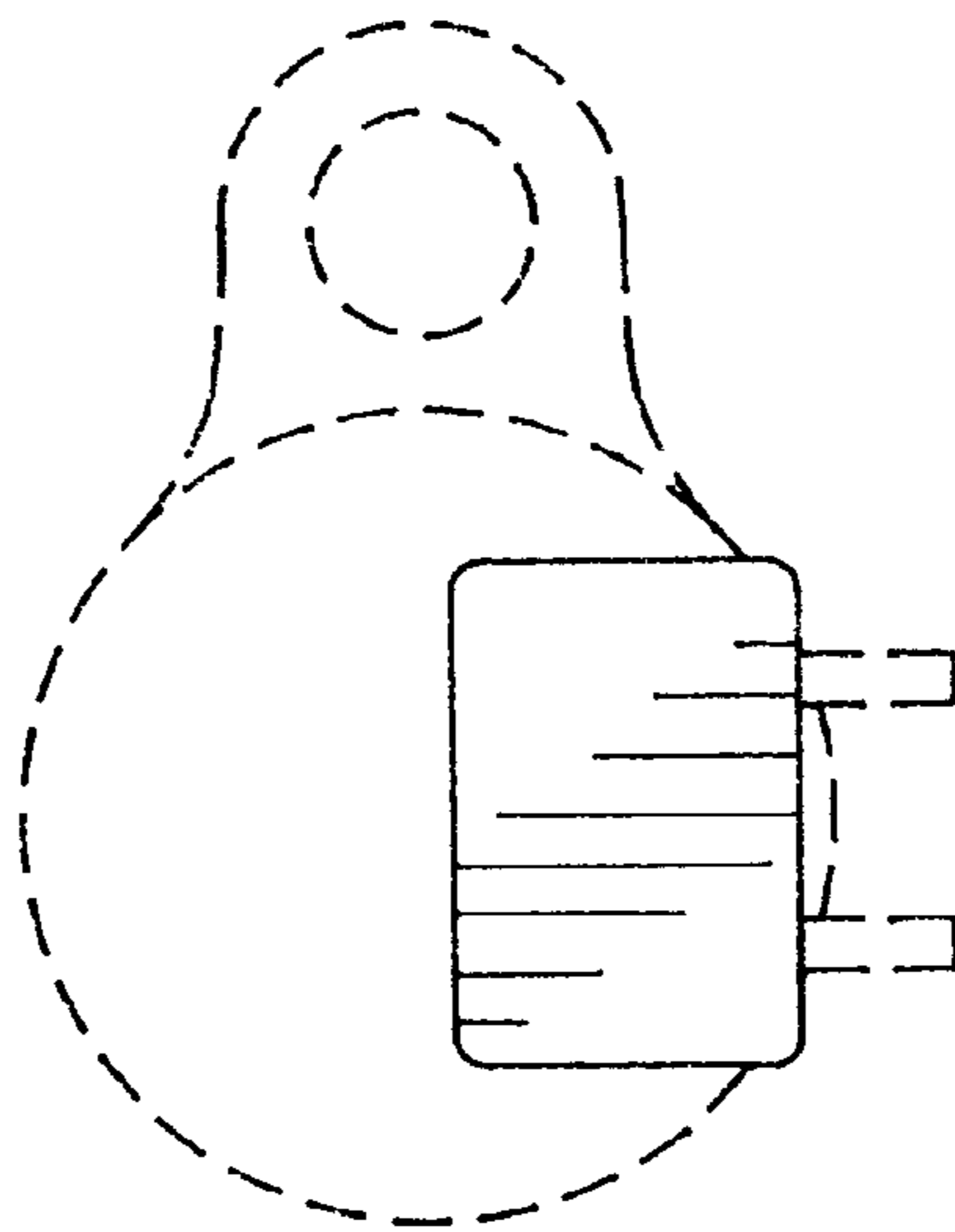

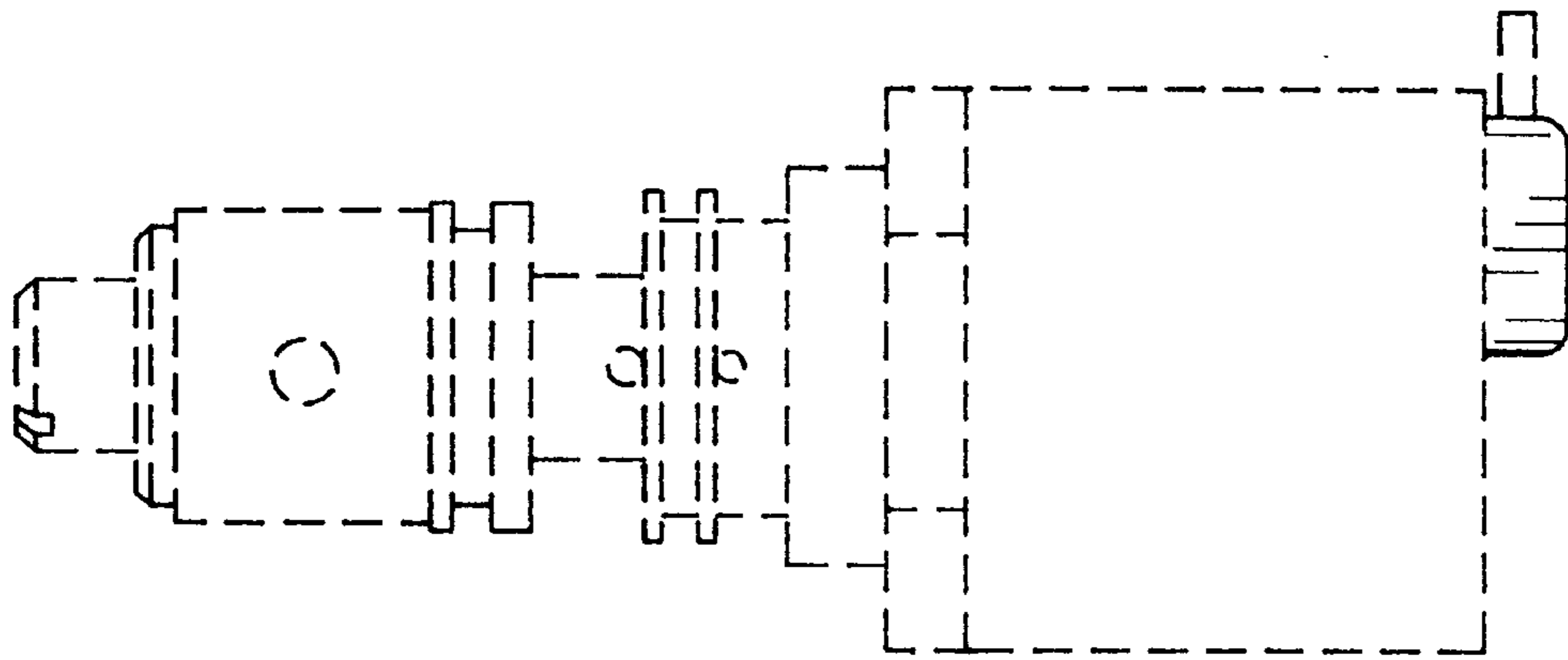

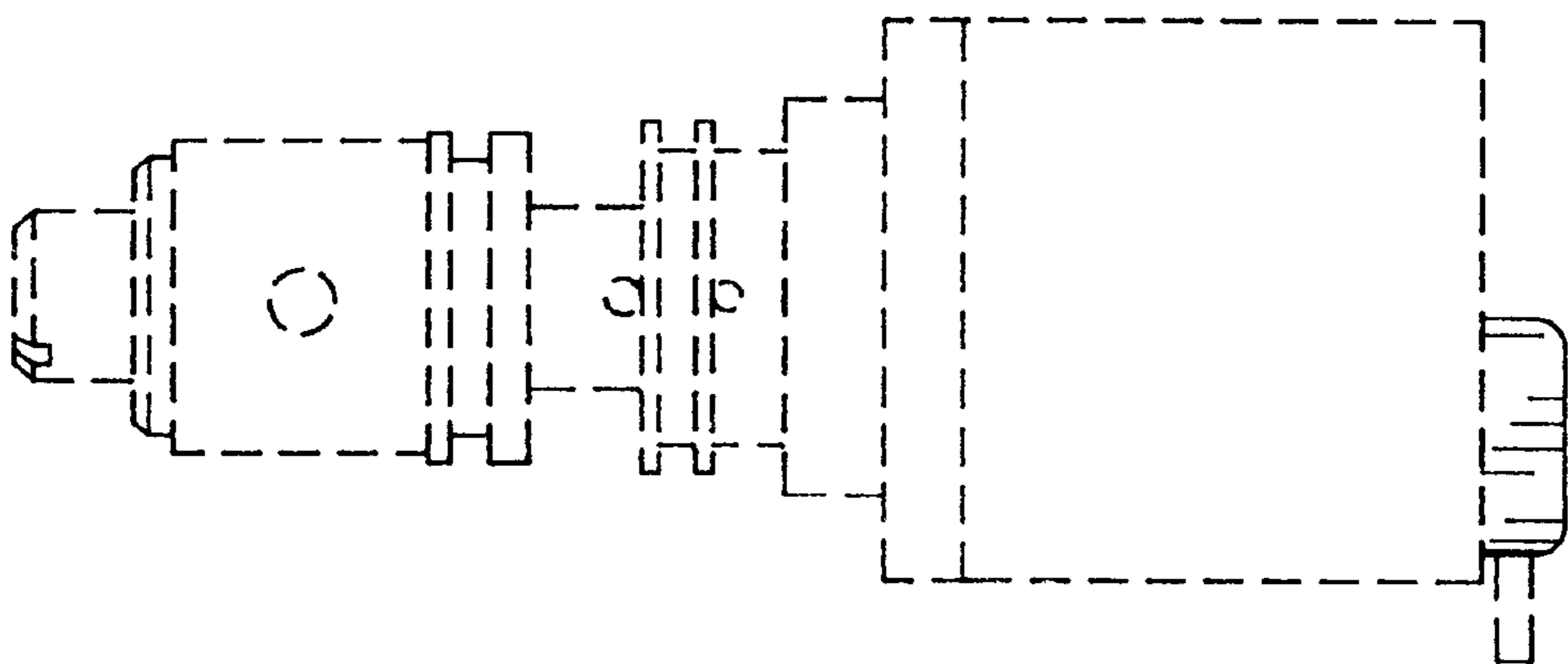

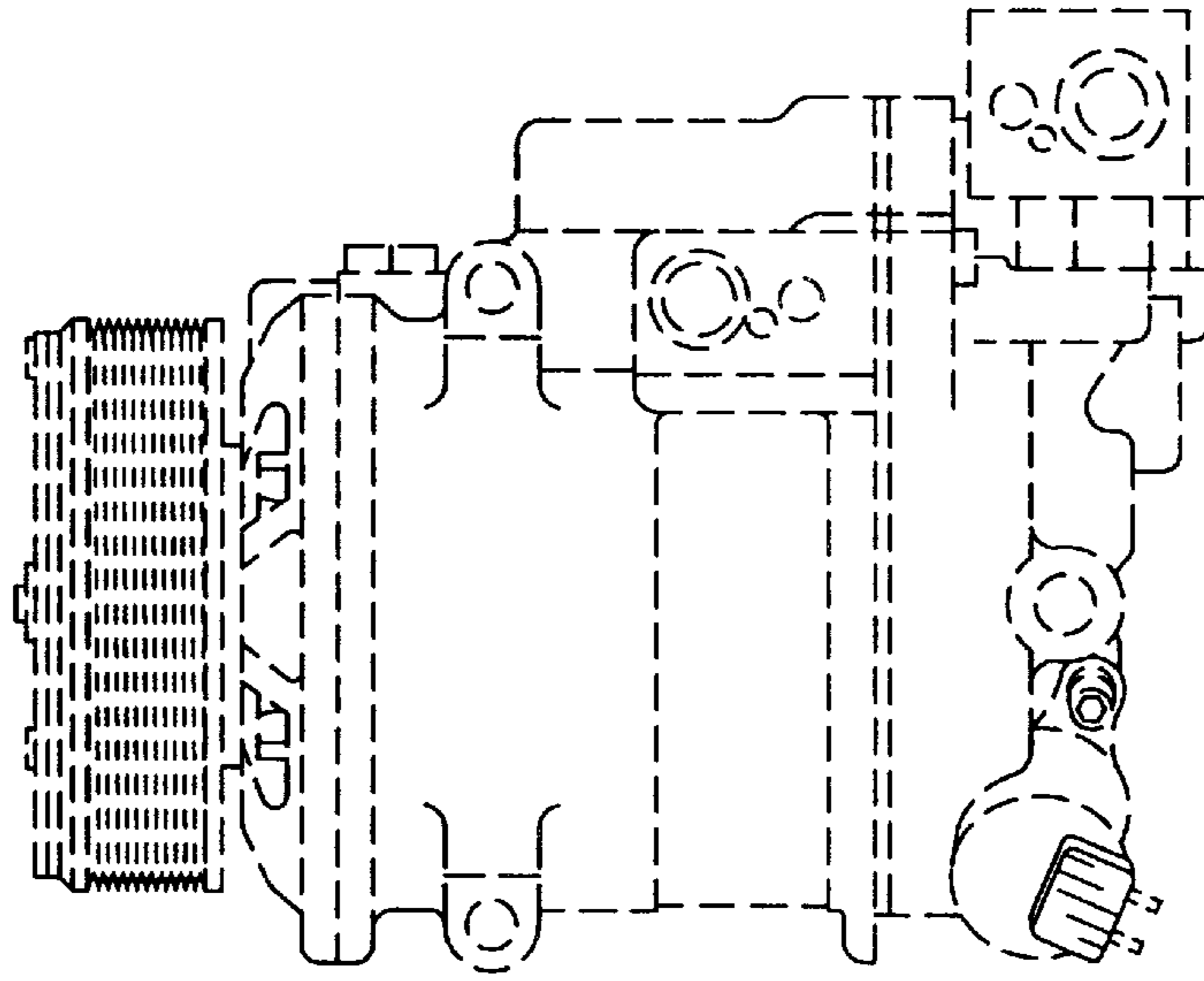

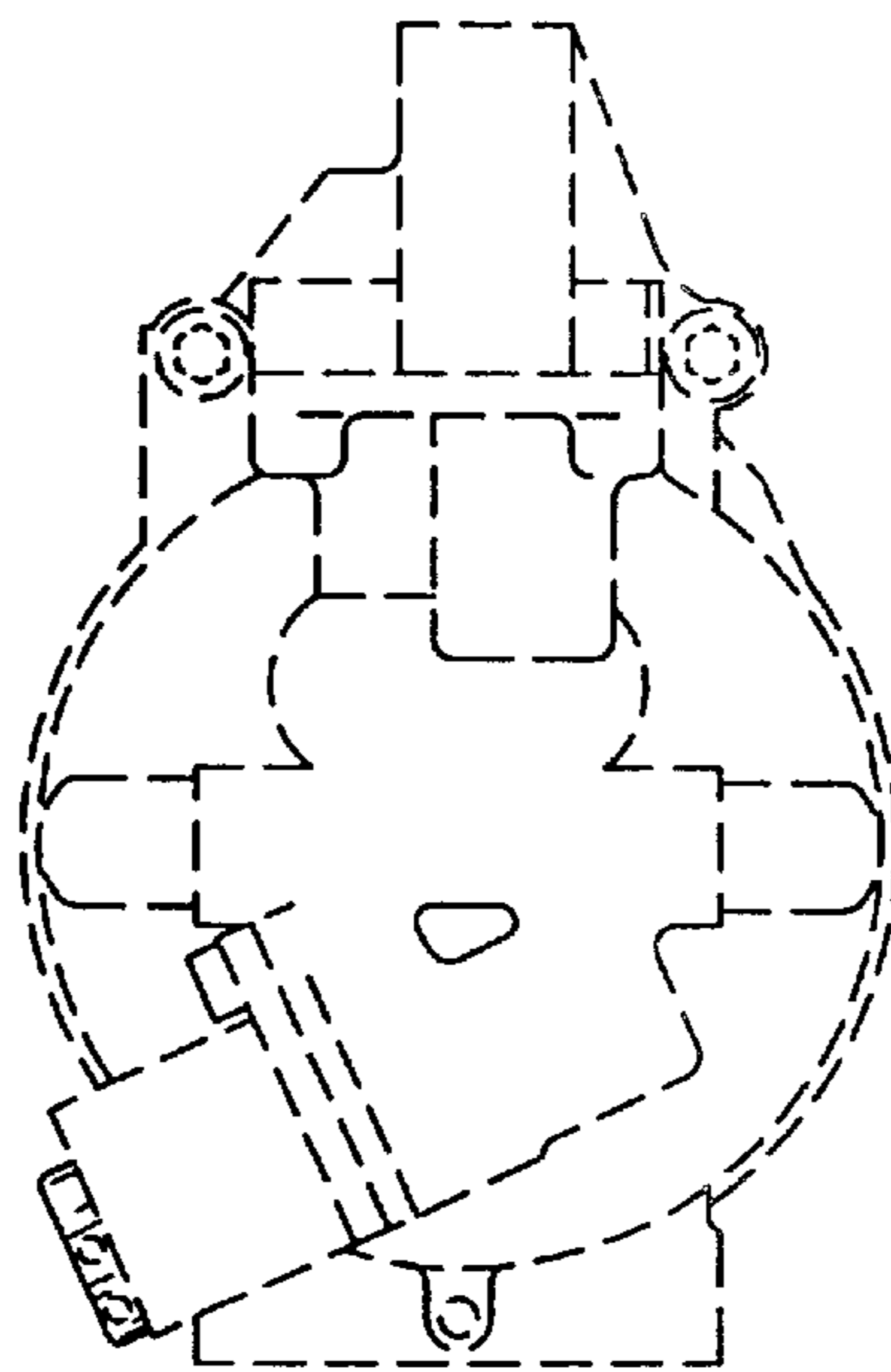
