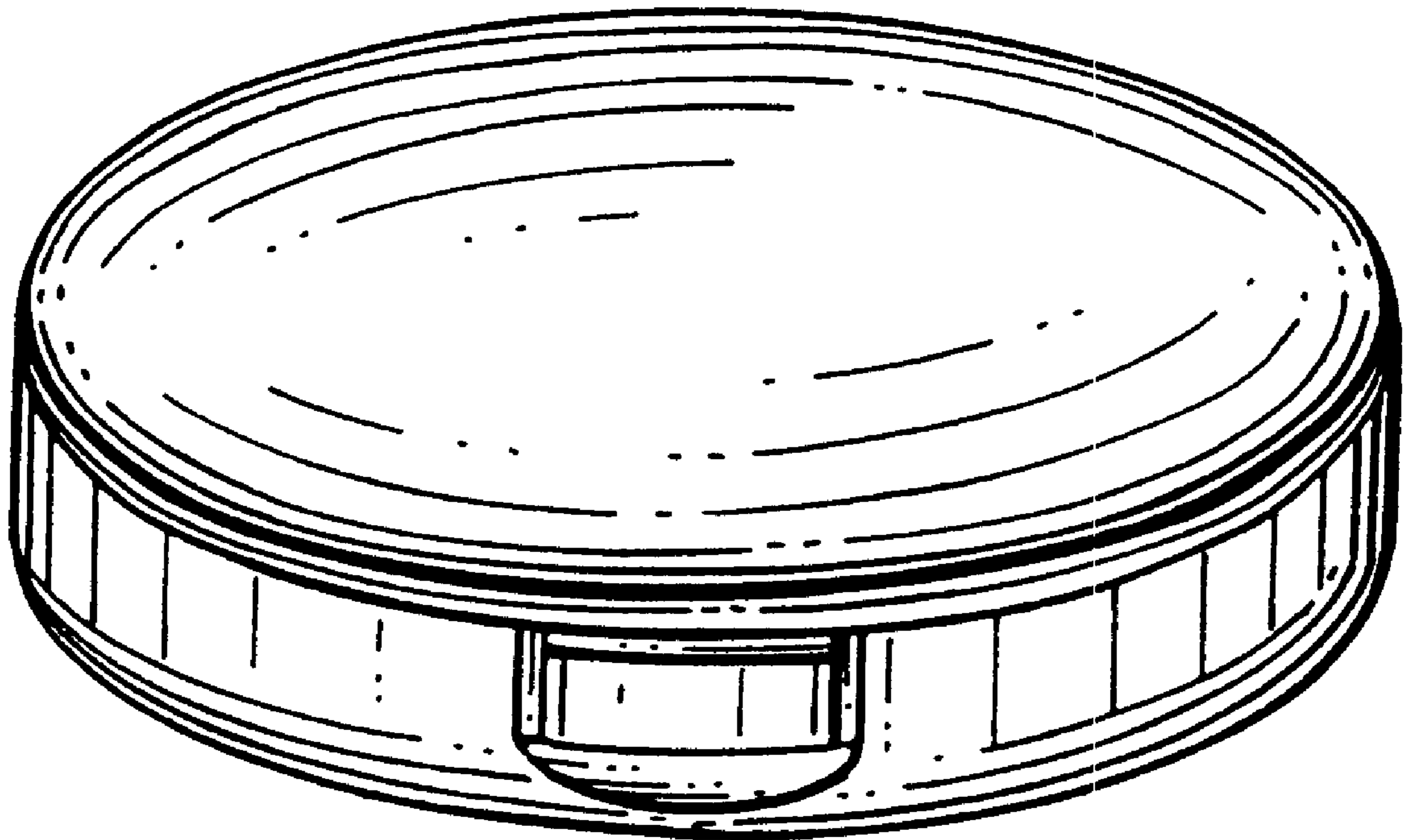

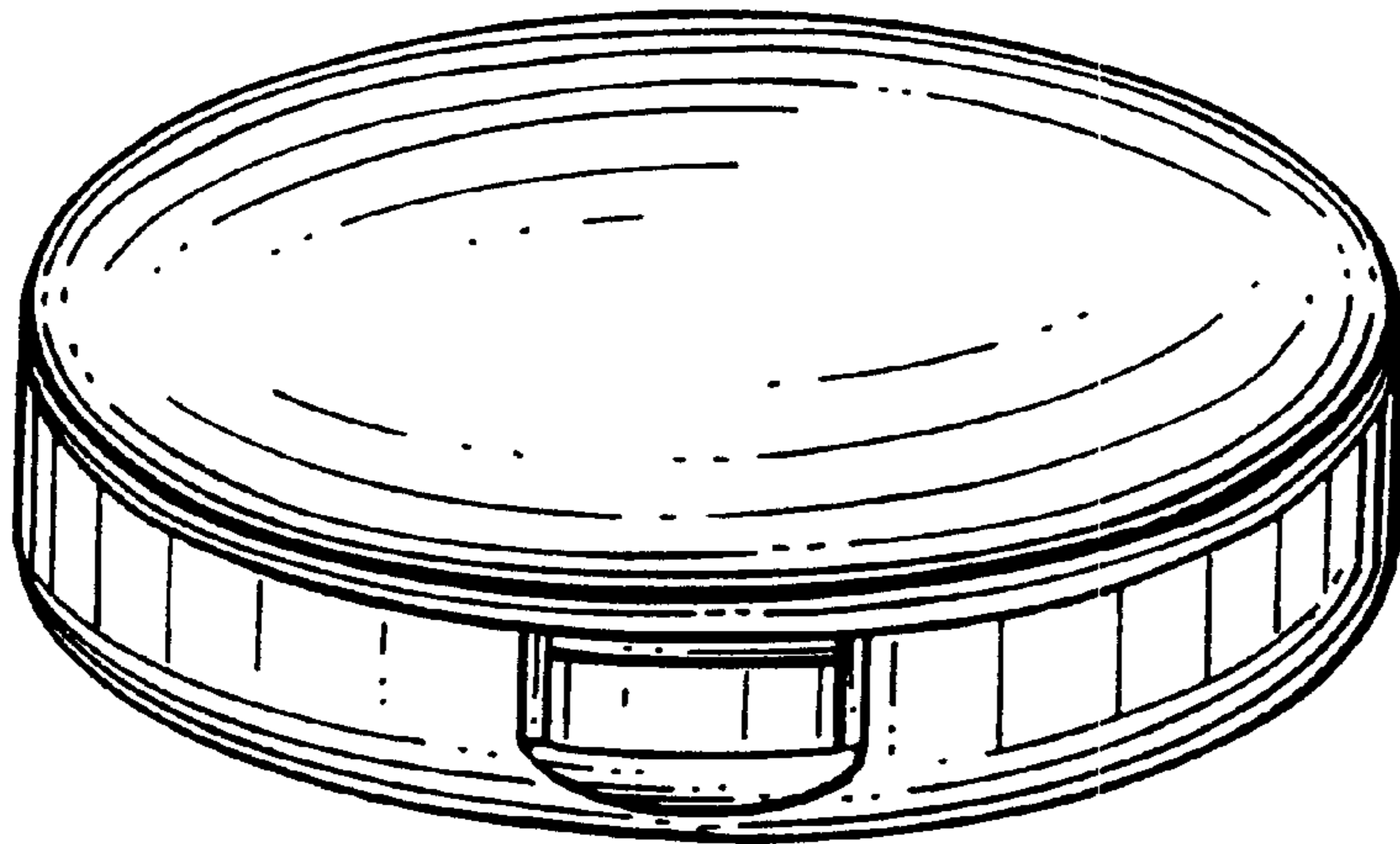
The ornamental design for a make-up compact case, as shown and described.

**DESCRIPTION**

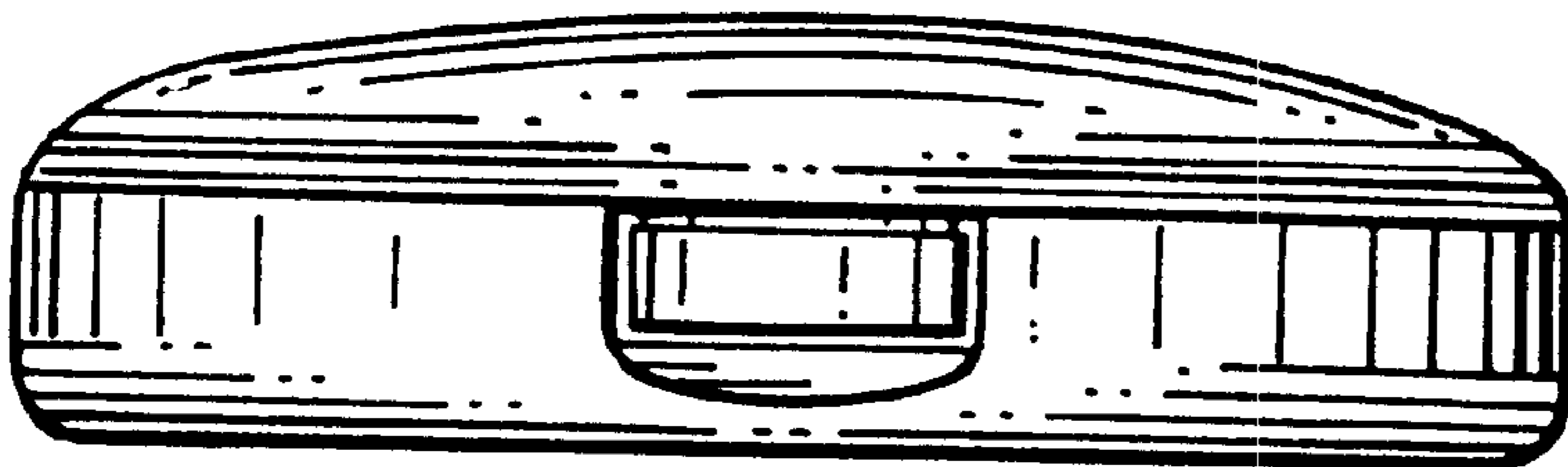
FIG. 1 is a perspective view of a make-up compact case showing my new design;

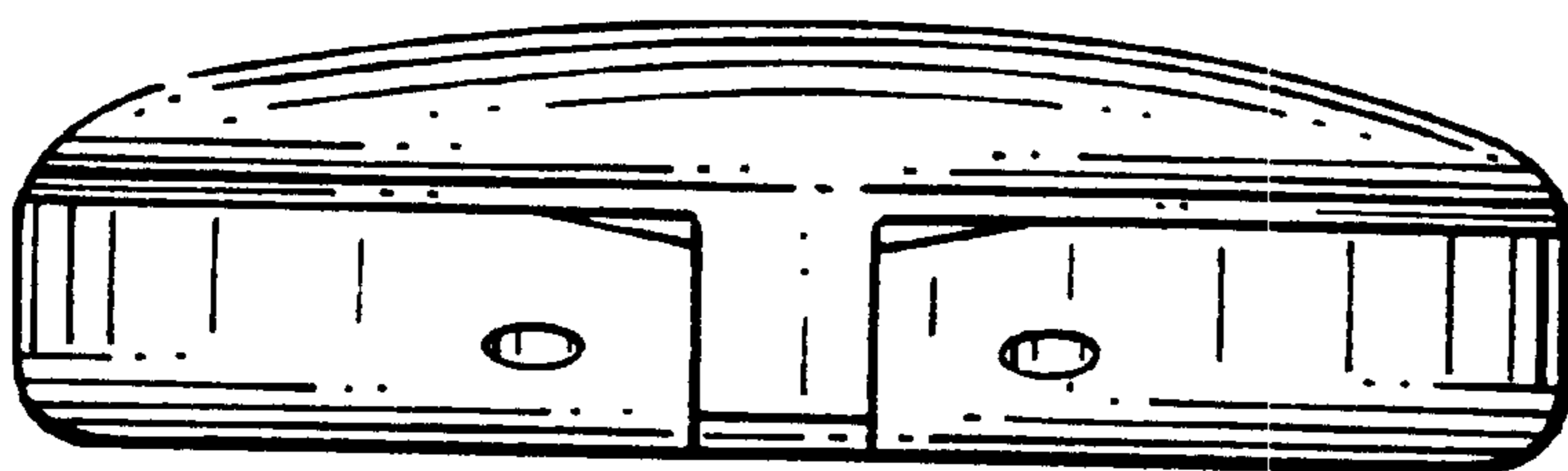




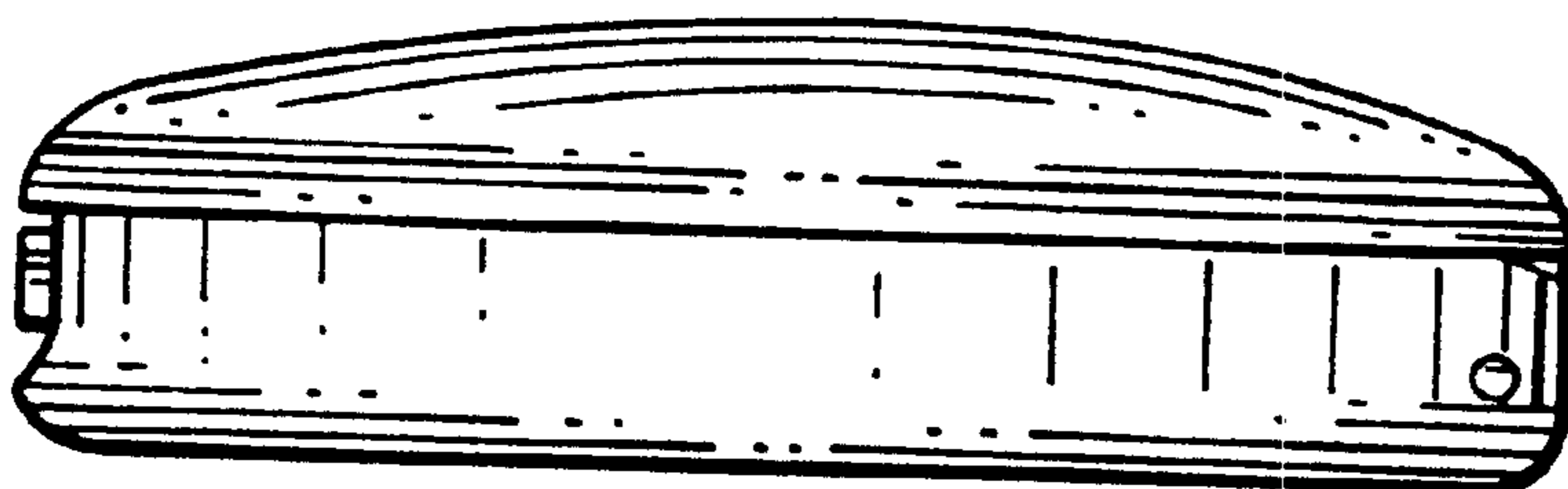

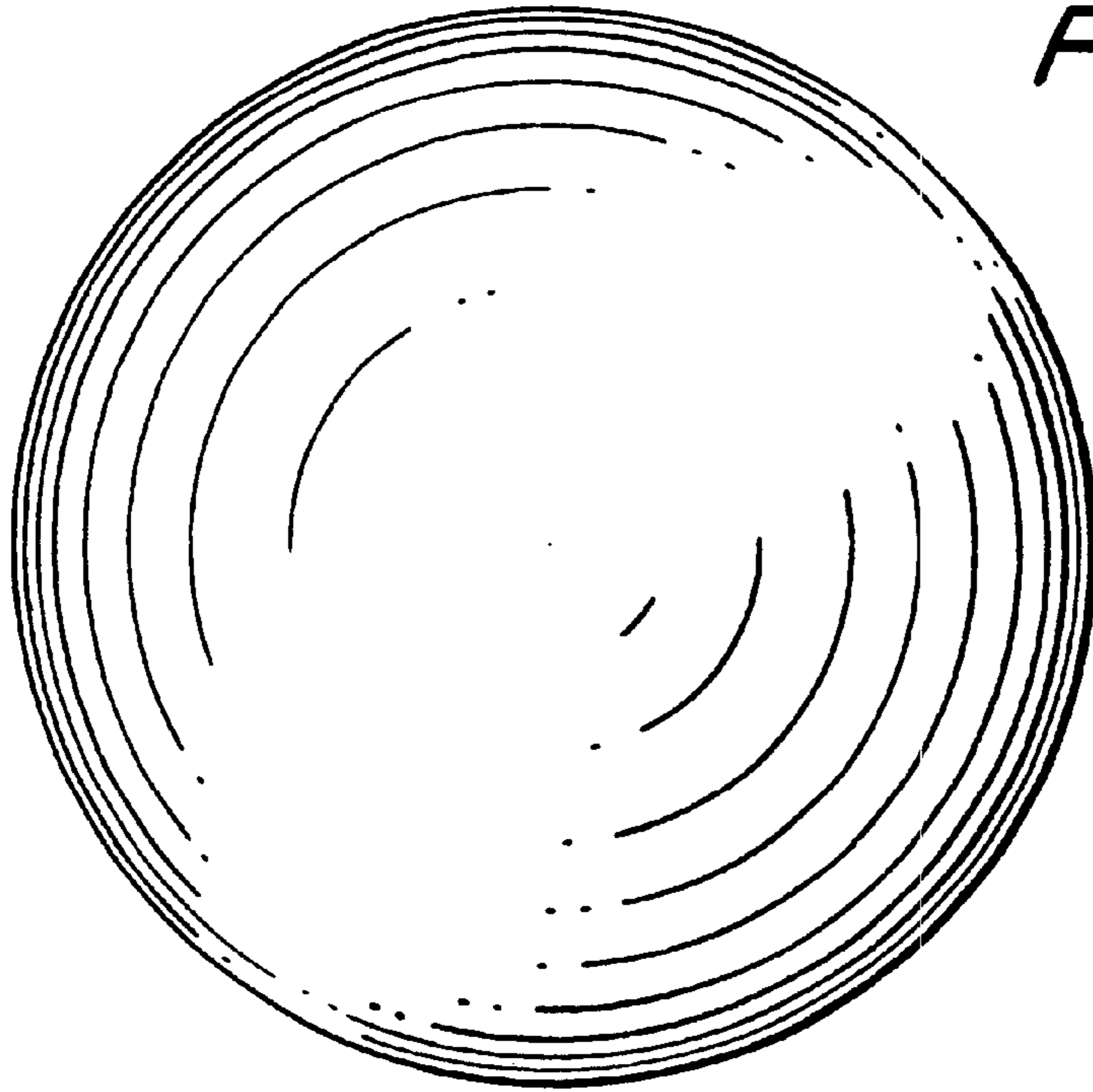
