FIG. 1 is a three-dimensional perspective view of the container;

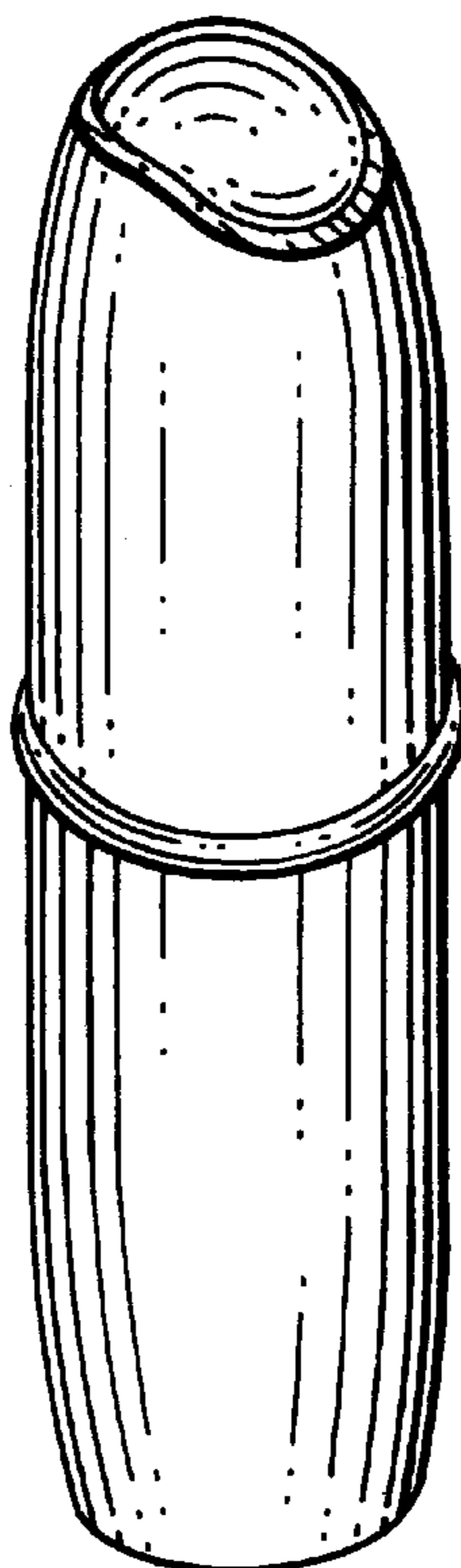
FIG. 2 is a front view of the container;

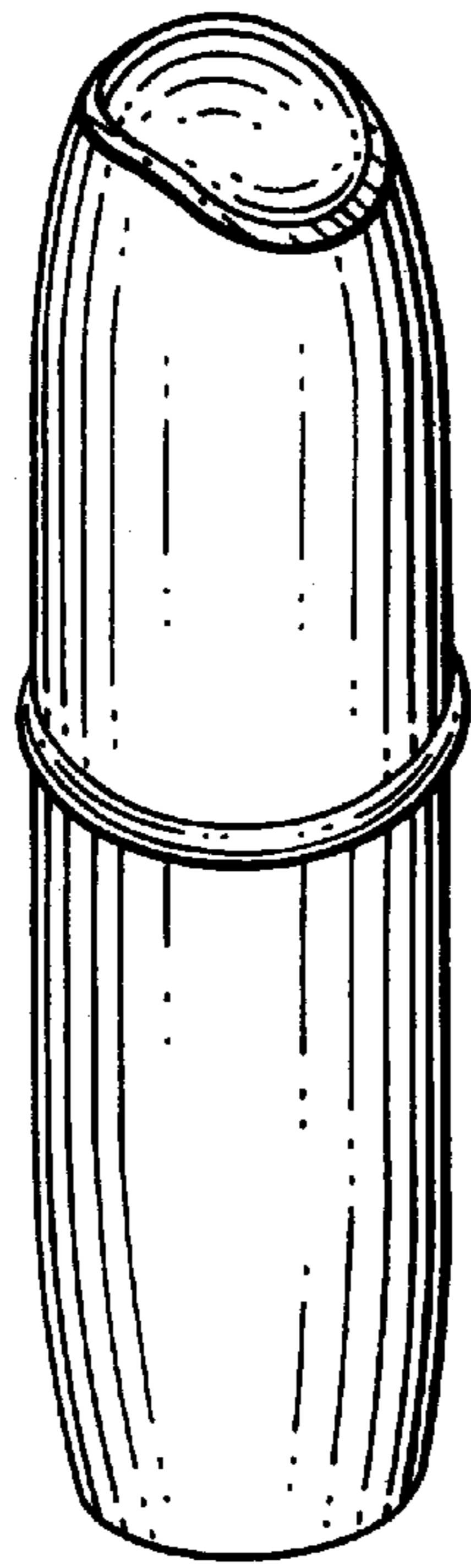

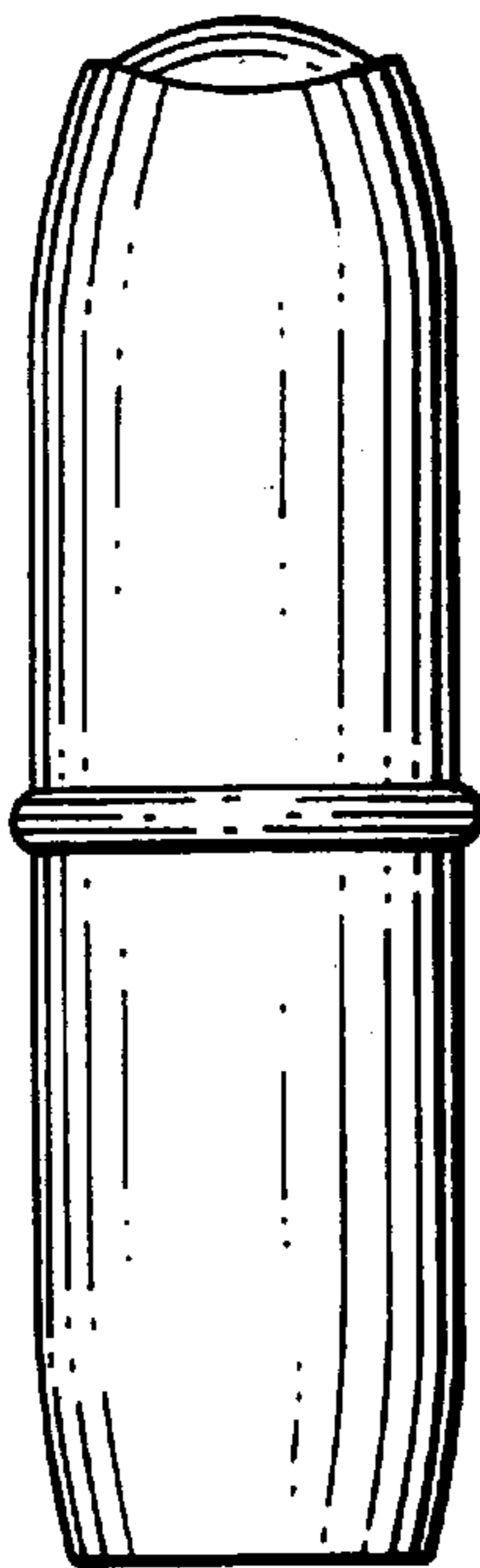

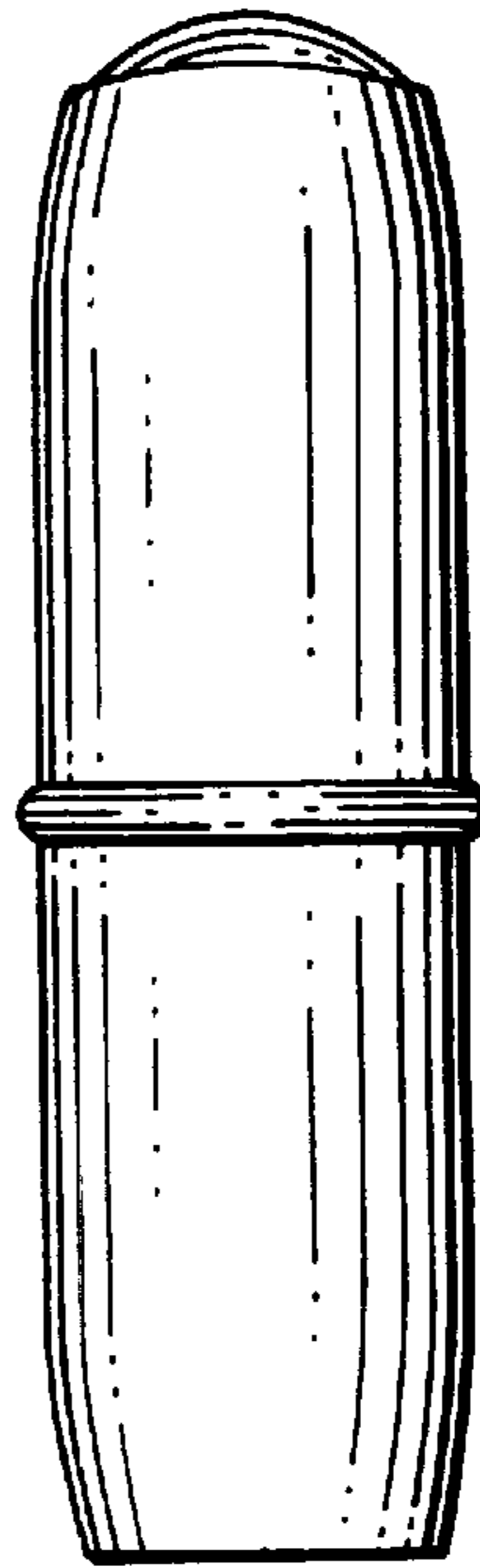

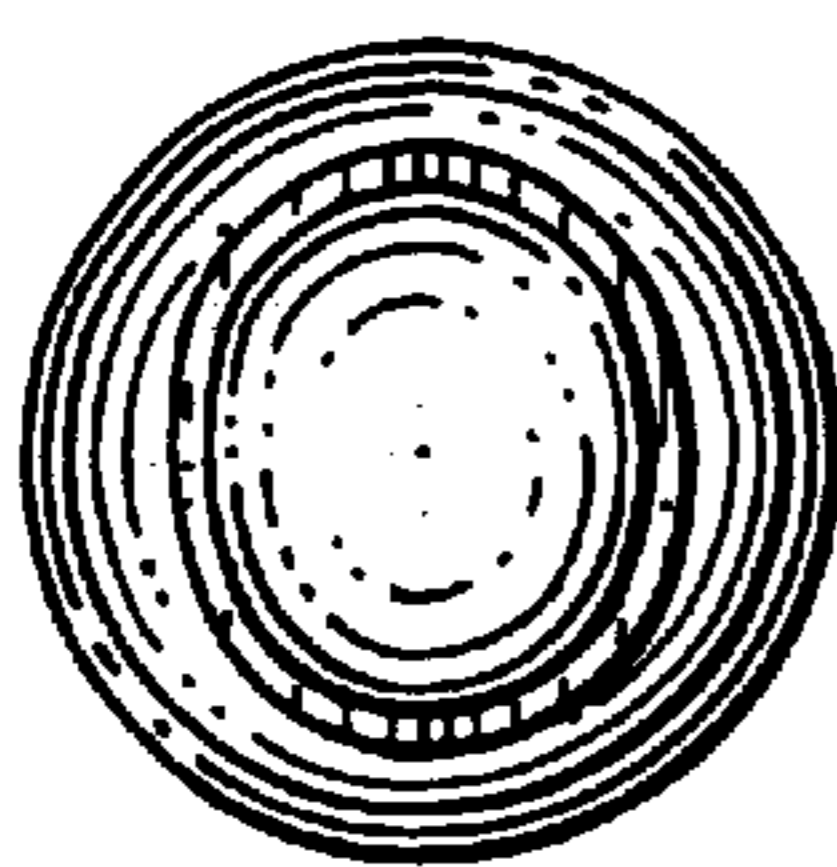

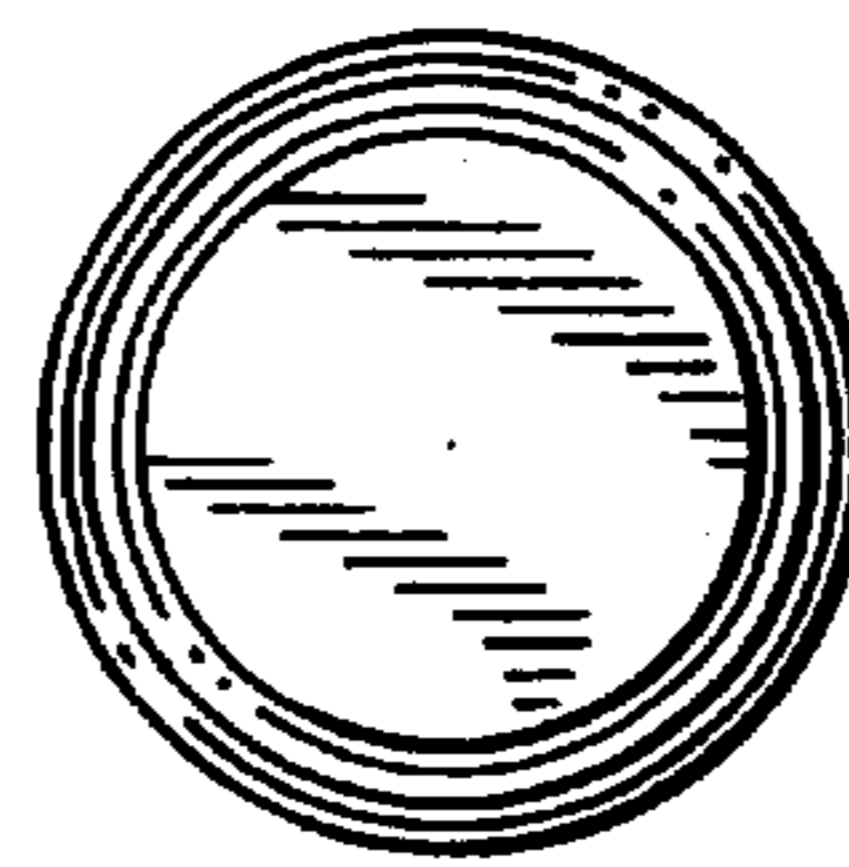
