FIG. 4 is a top plan view of the invention illustrated in FIG. 1;

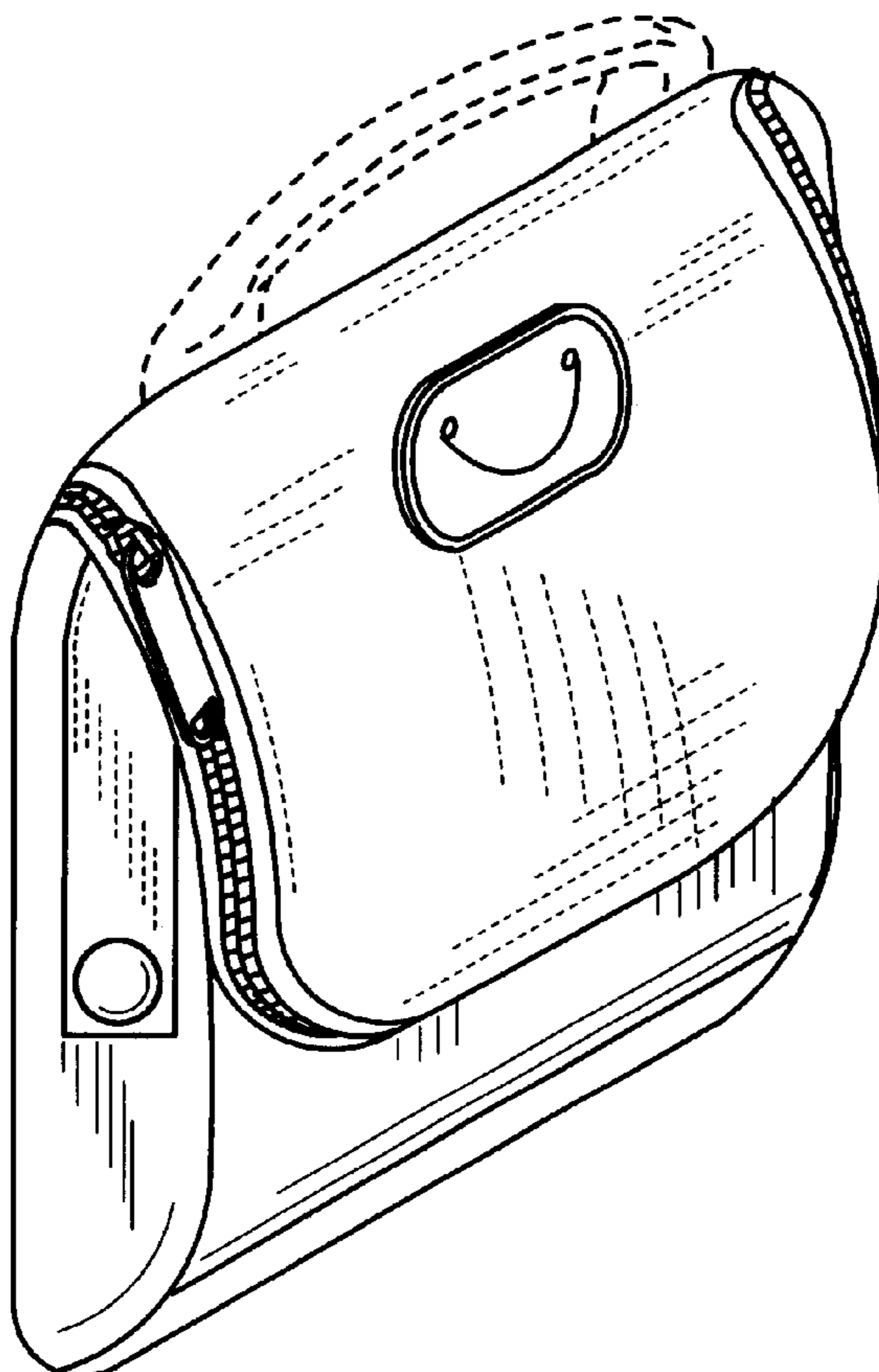
FIG. 5 is a rear elevation view of the invention illustrated in FIG. 1;

FIG. 6 is a bottom plan view of the invention illustrated in FIG. 1;

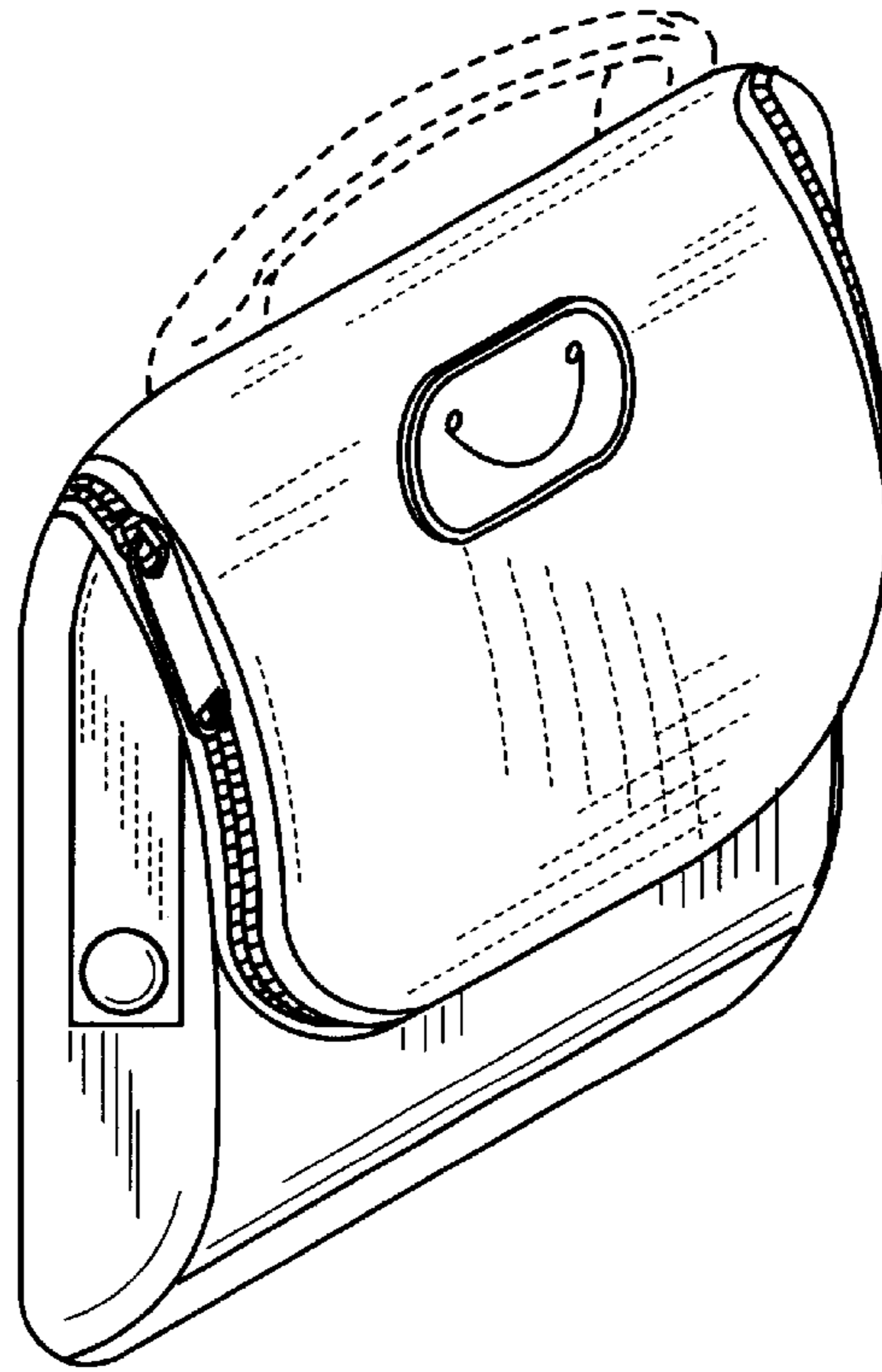
FIG. 7 is a left elevation view of the invention illustrated in FIG. 1; and,

FIG. 8 is a front perspective view of the invention shown in FIG. 1, depicted in an open position.

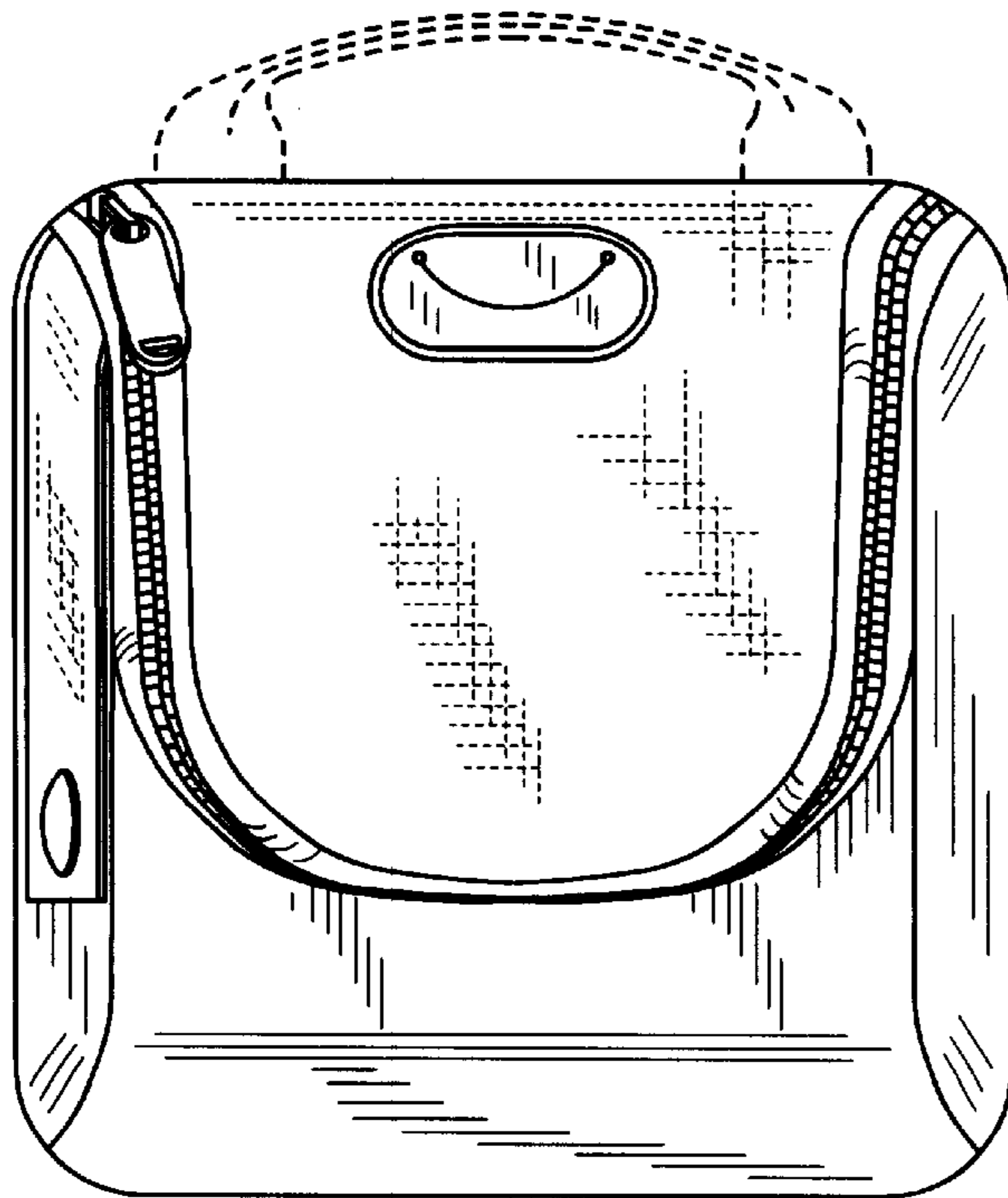

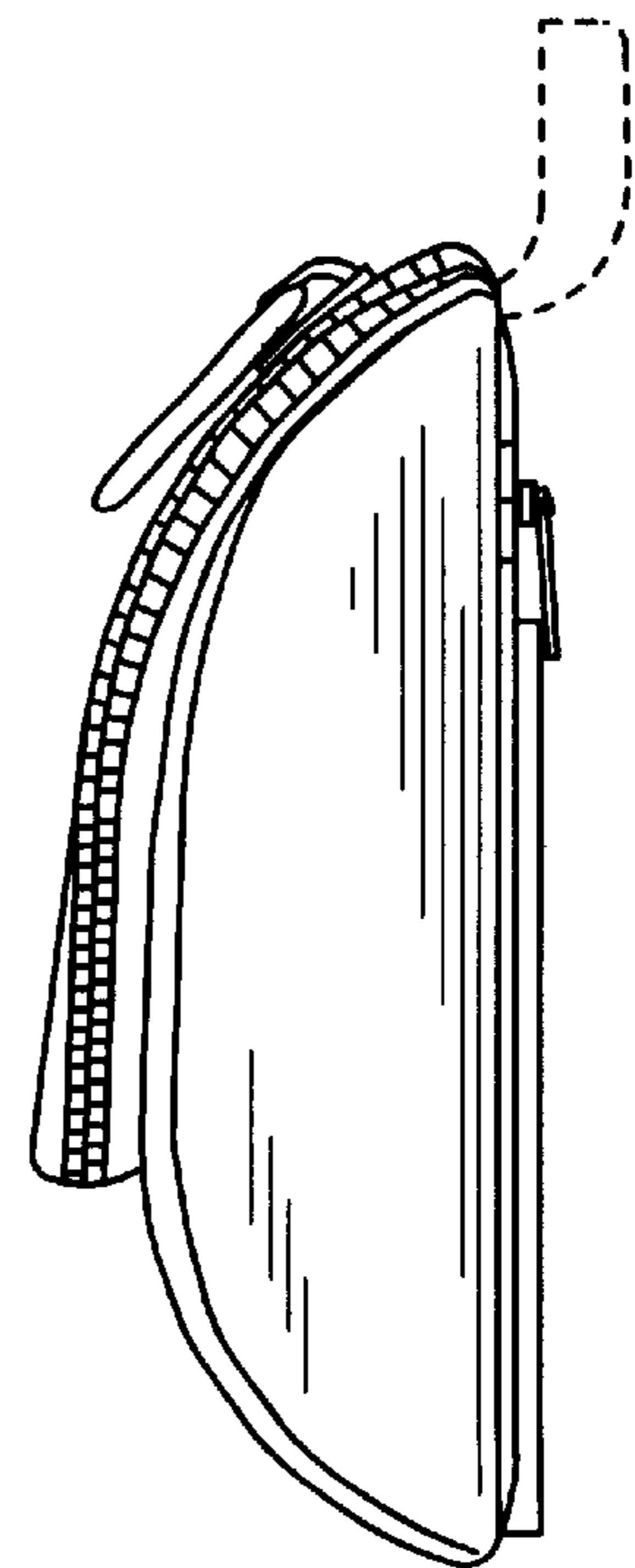

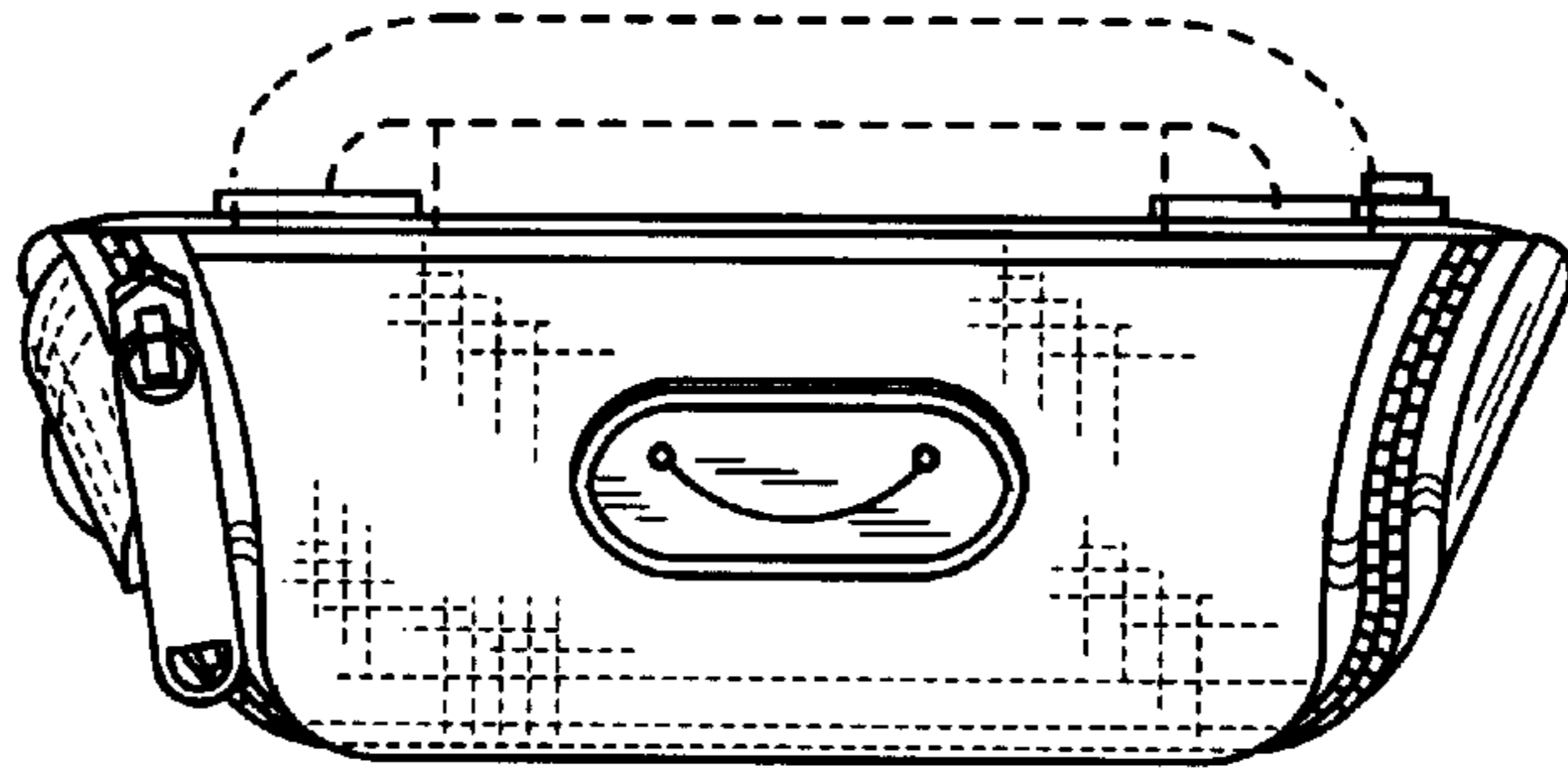

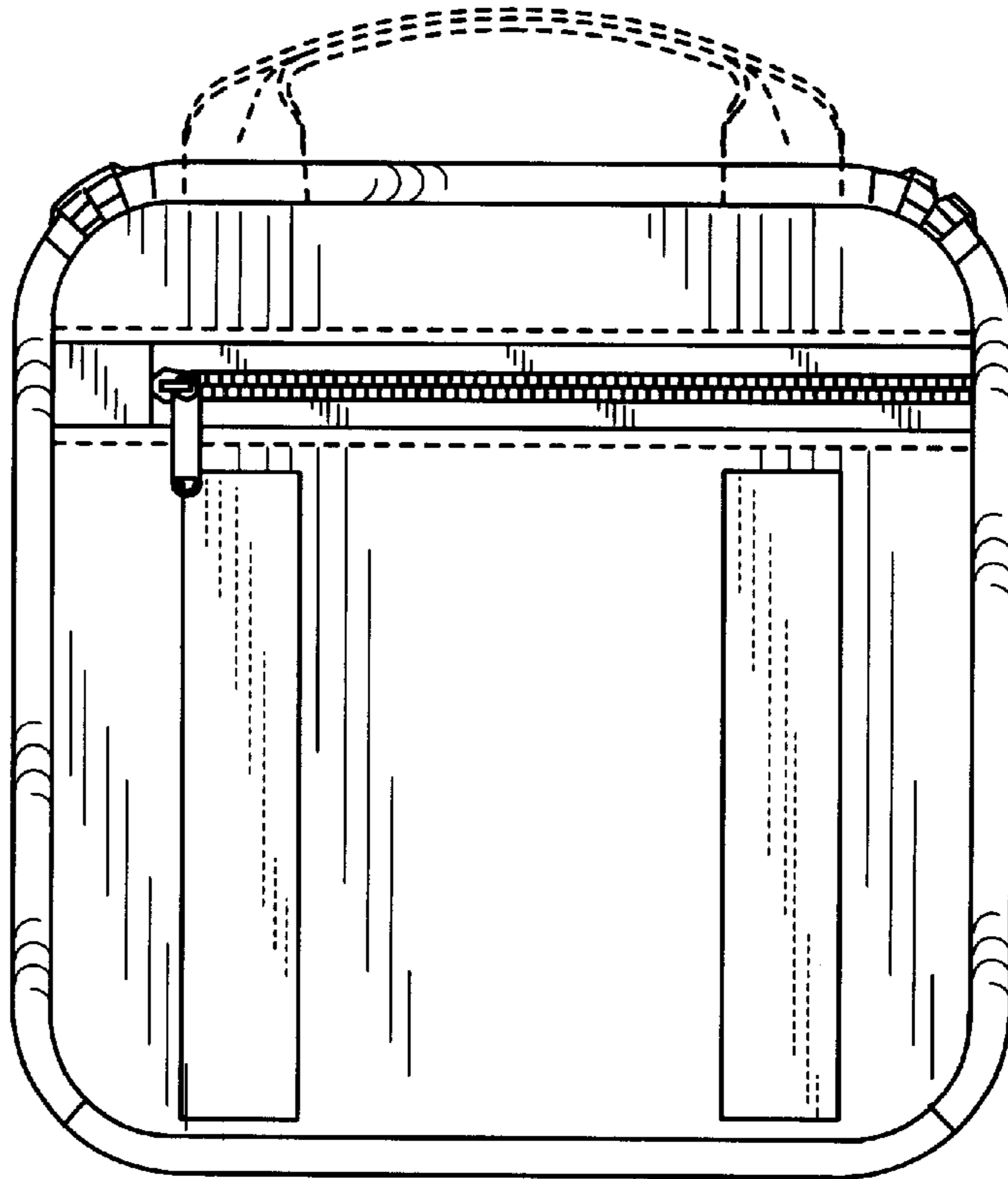

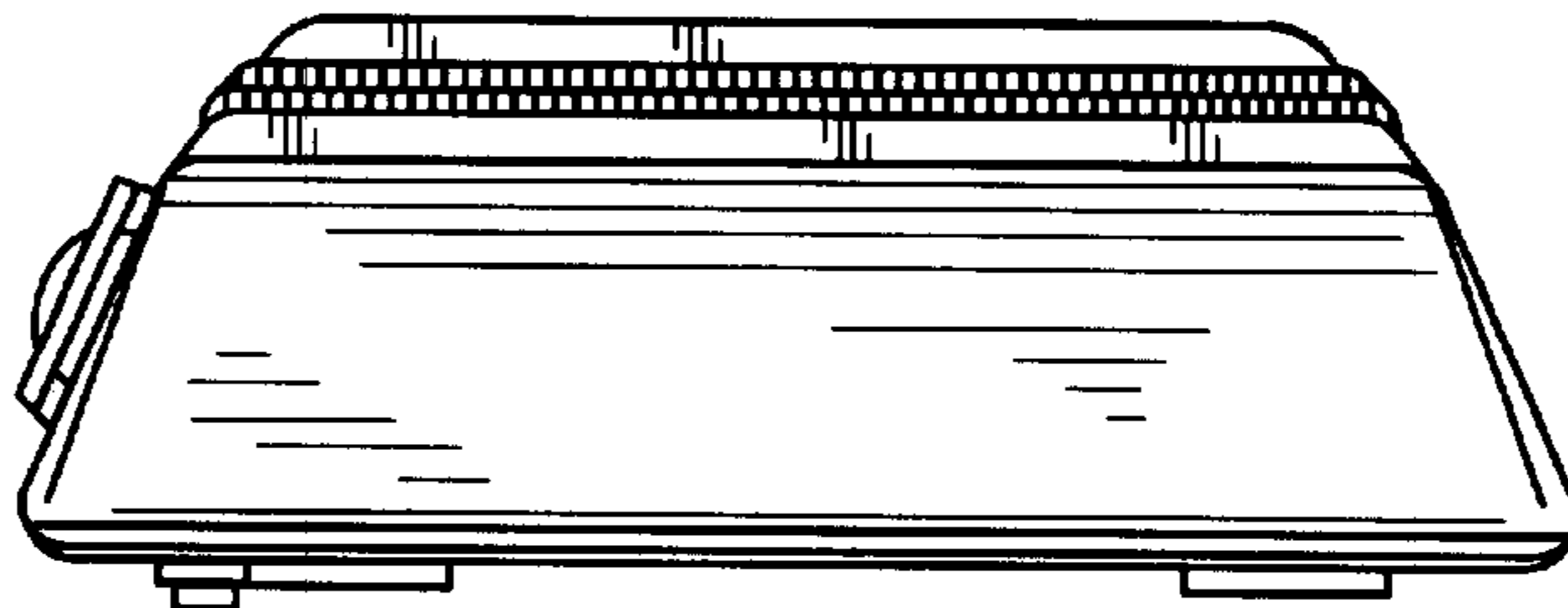

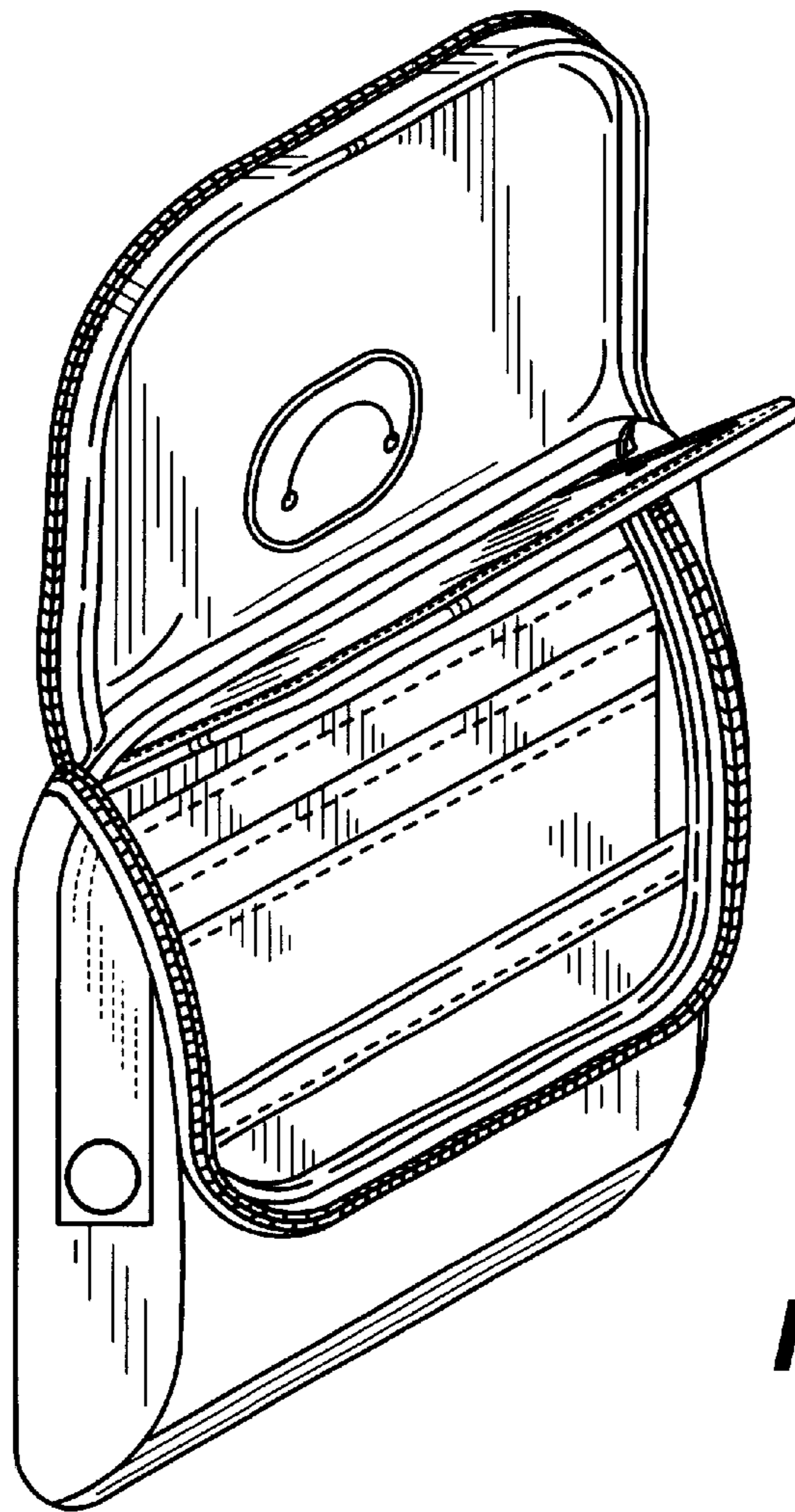
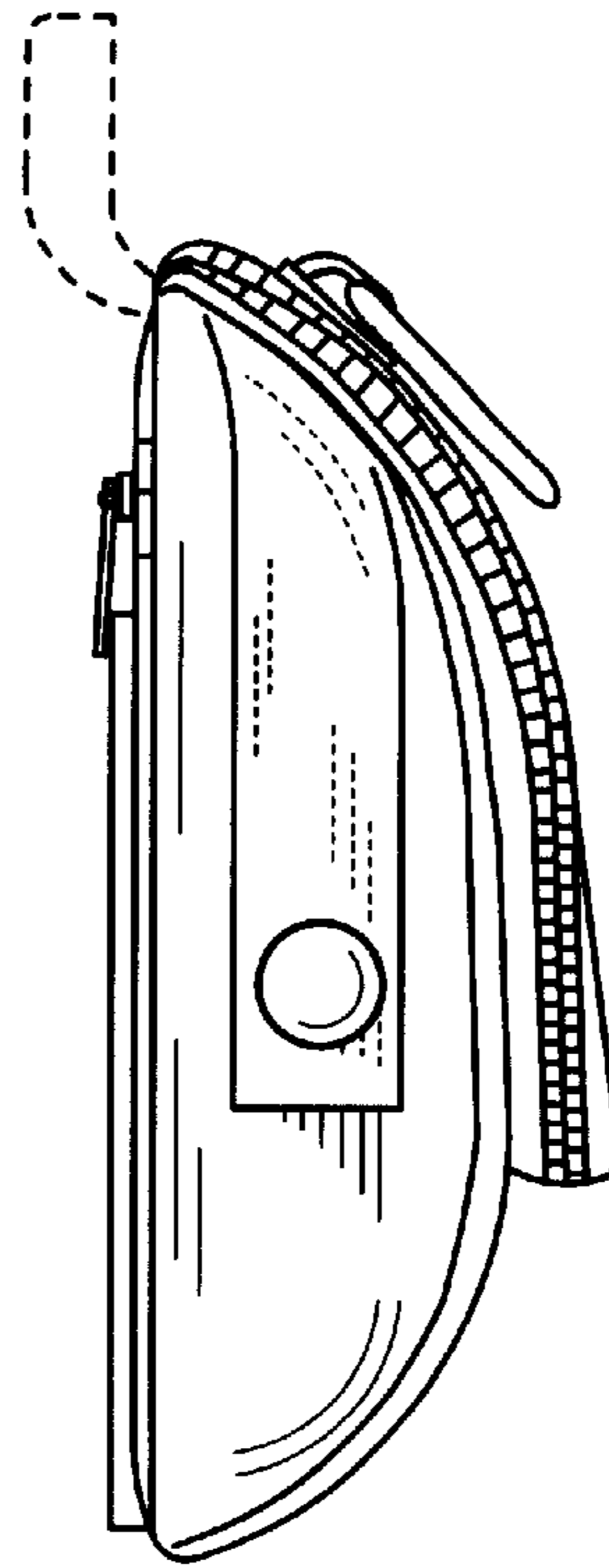
