(57) **CLAIM**

The ornamental design of a seat of an all terrain vehicle, as shown and described.

**DESCRIPTION**

FIG. 10 is a left side view thereof;

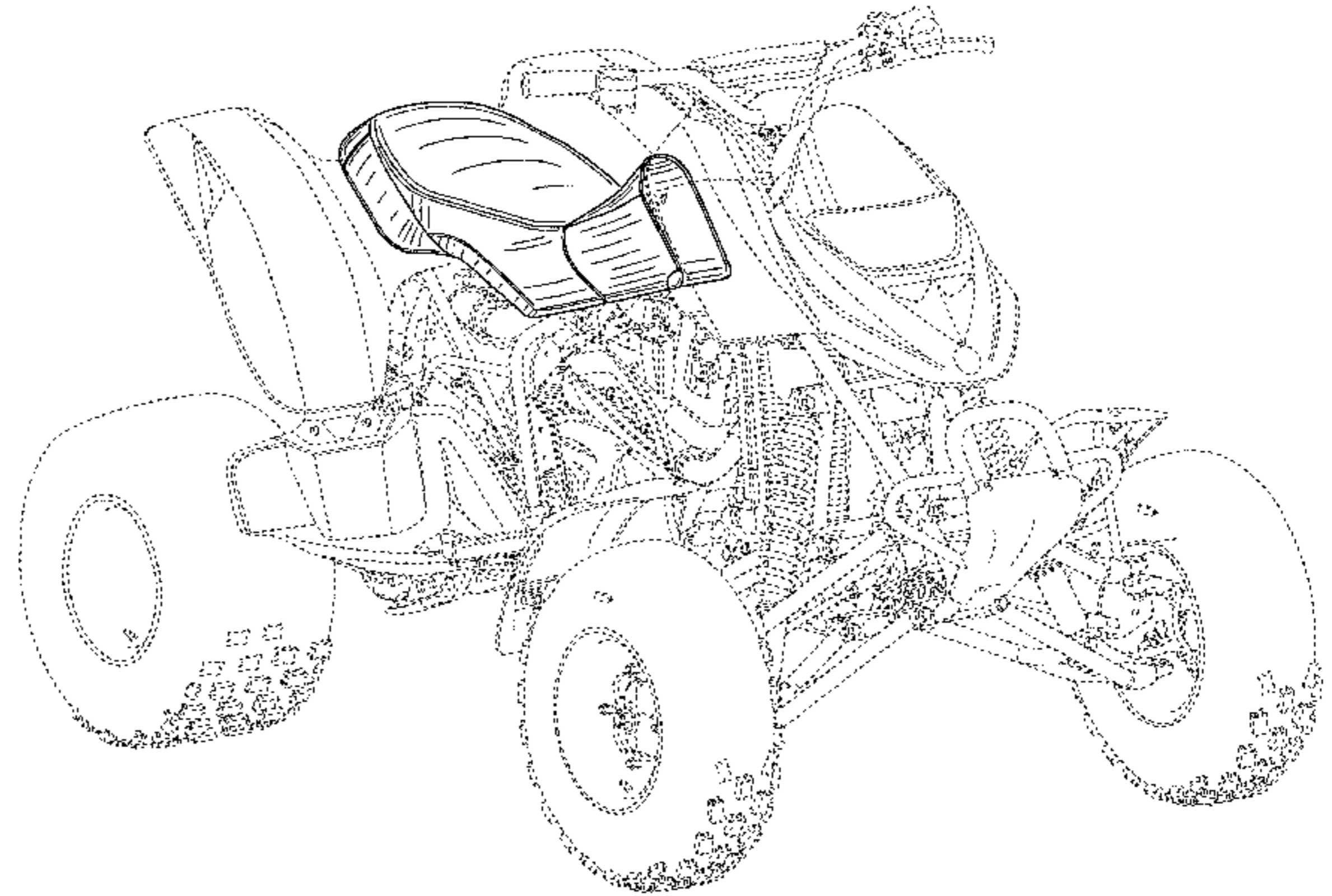
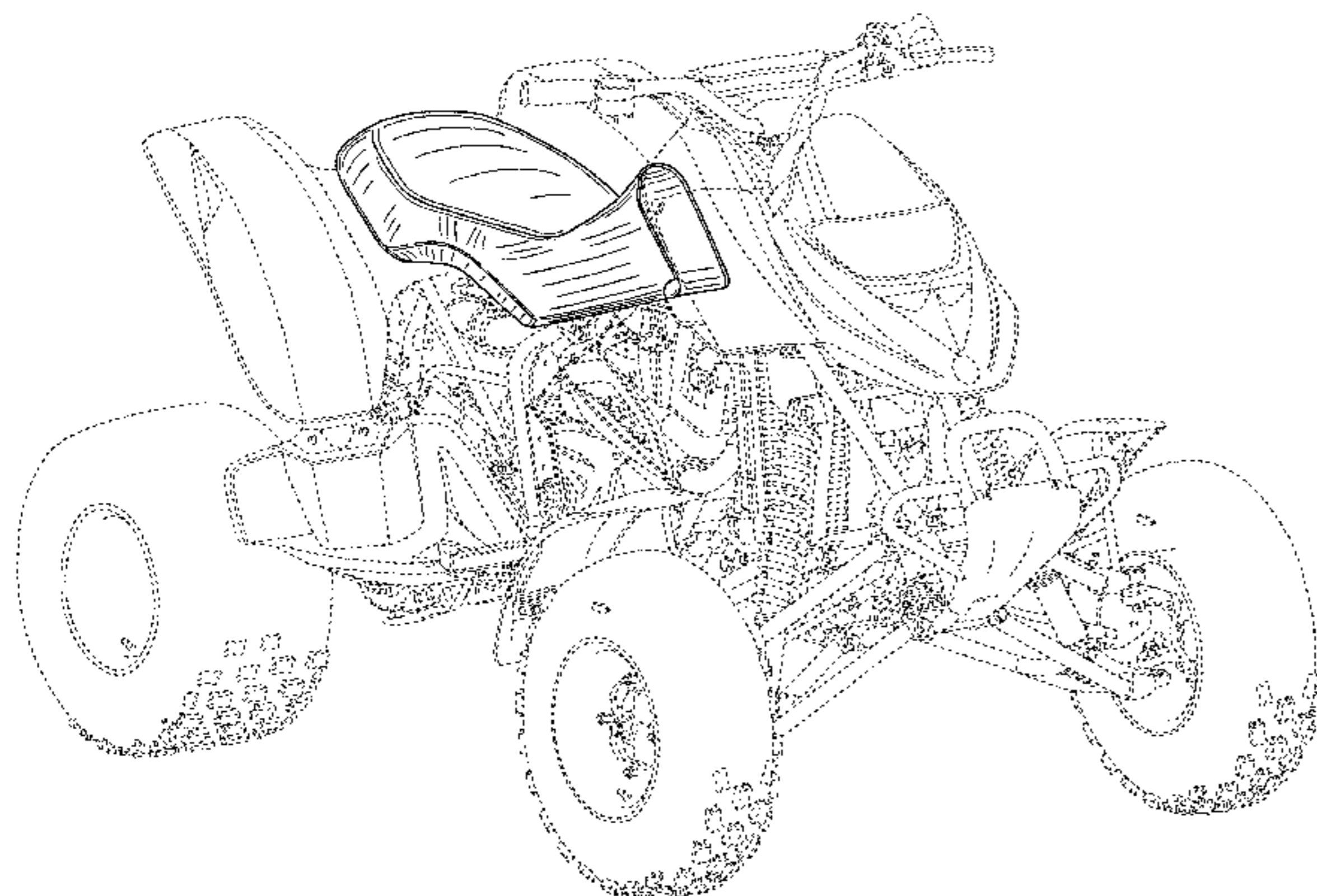
FIG. 11 is a rear view thereof; and,

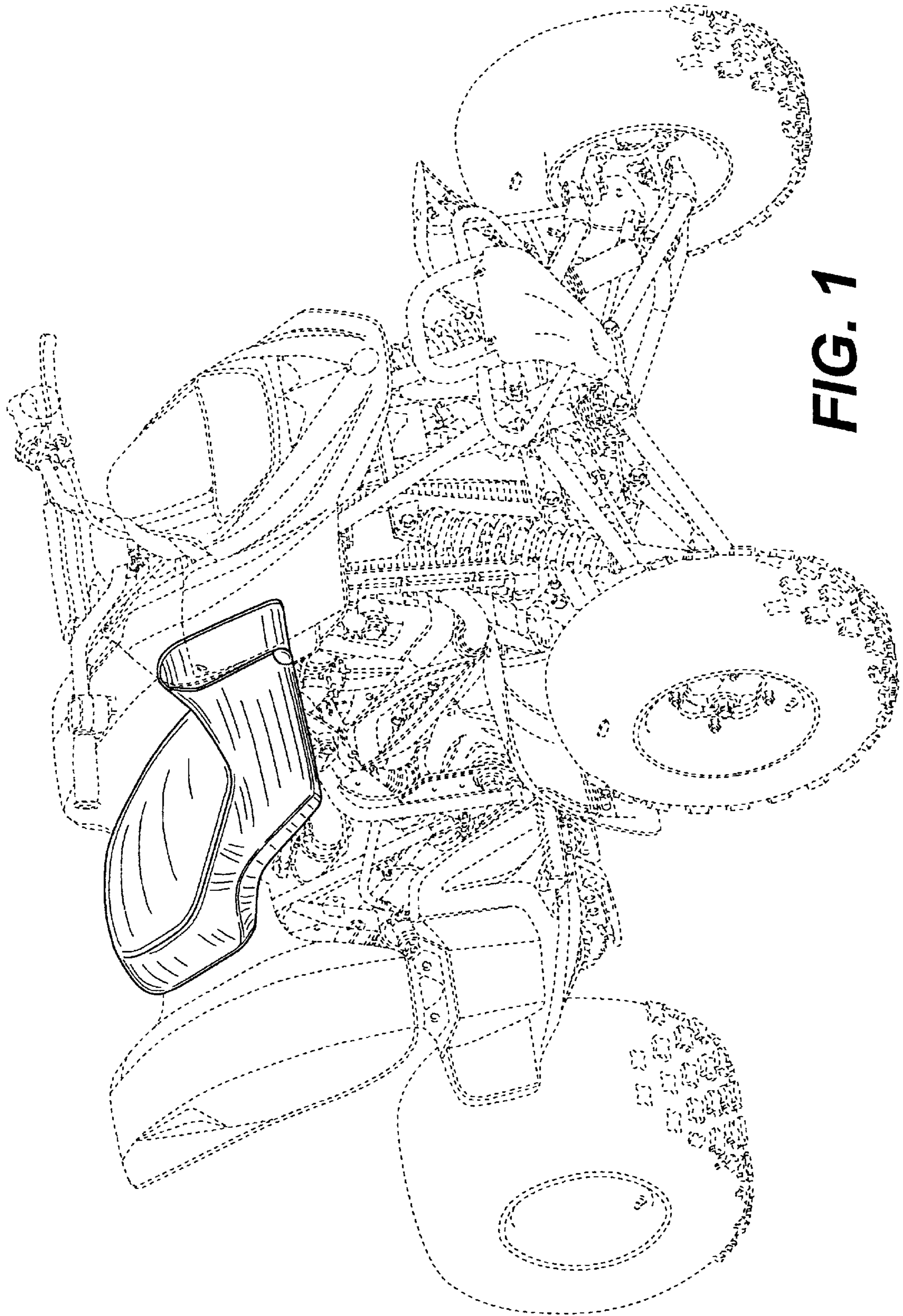
FIG. 12 is a front view thereof.

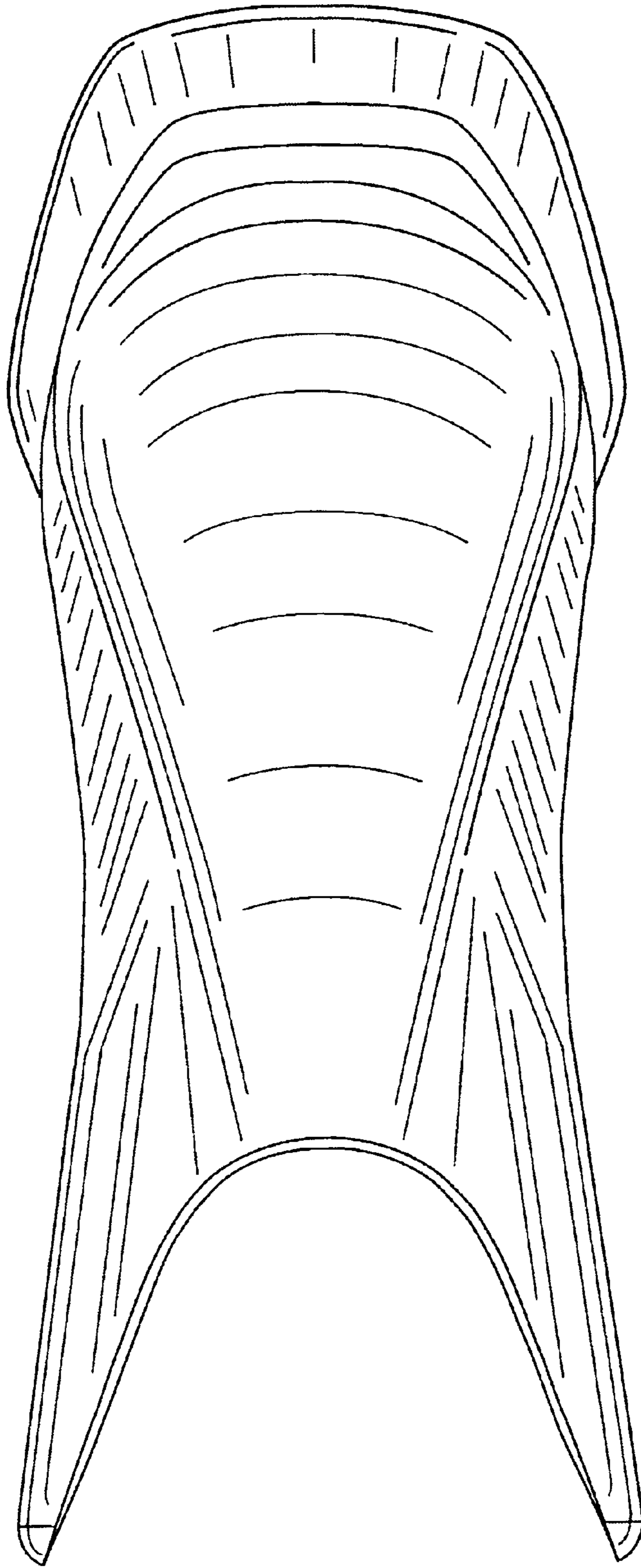

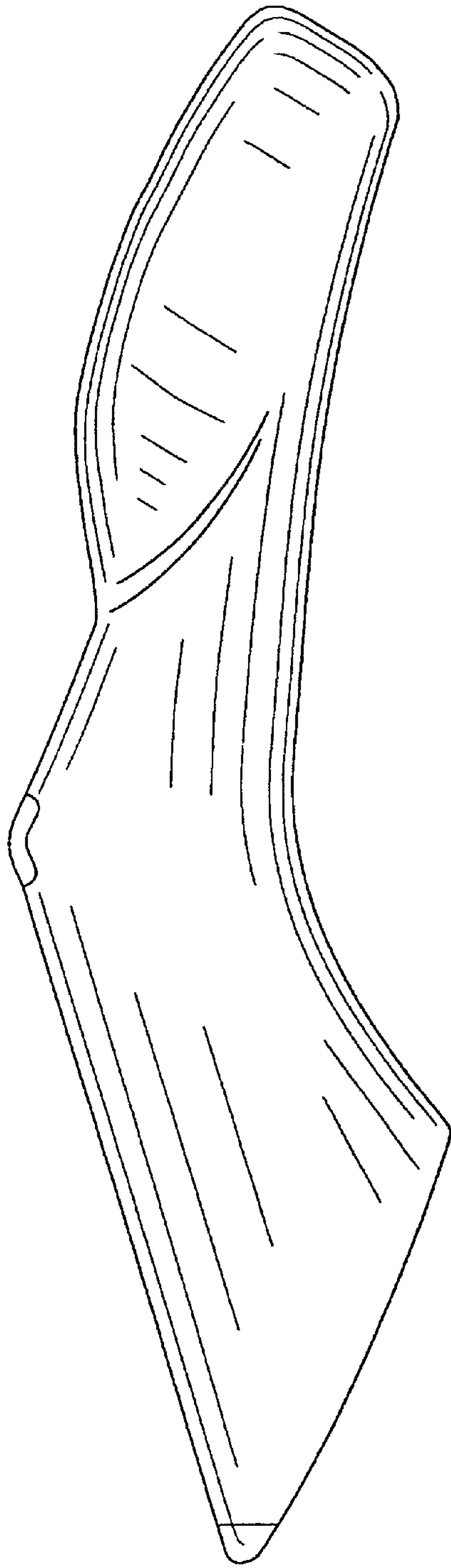




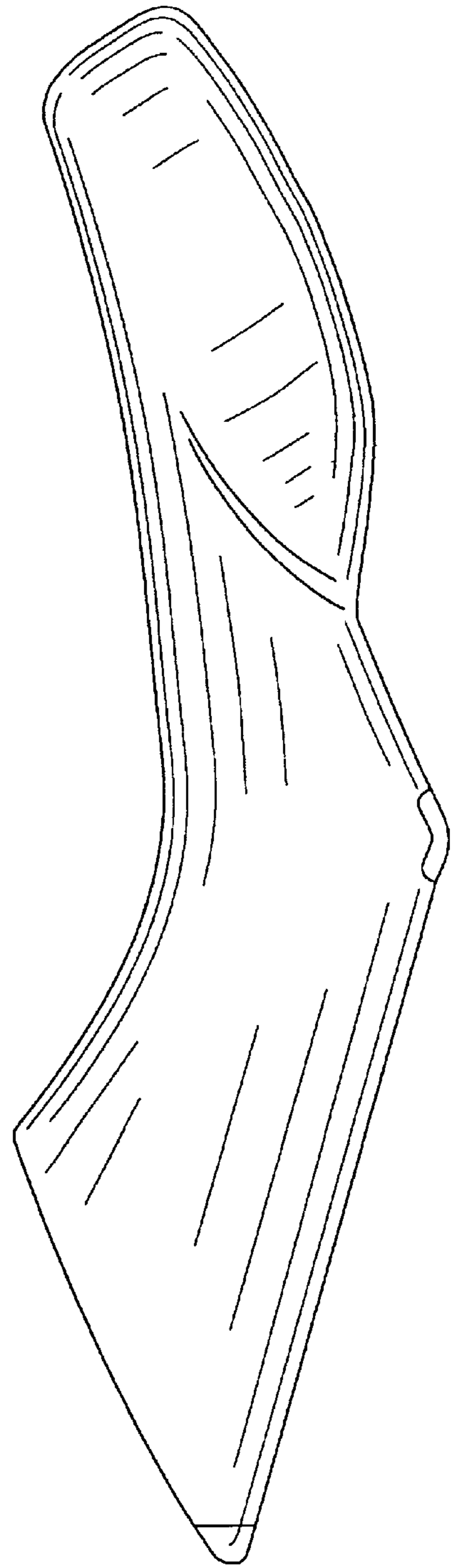

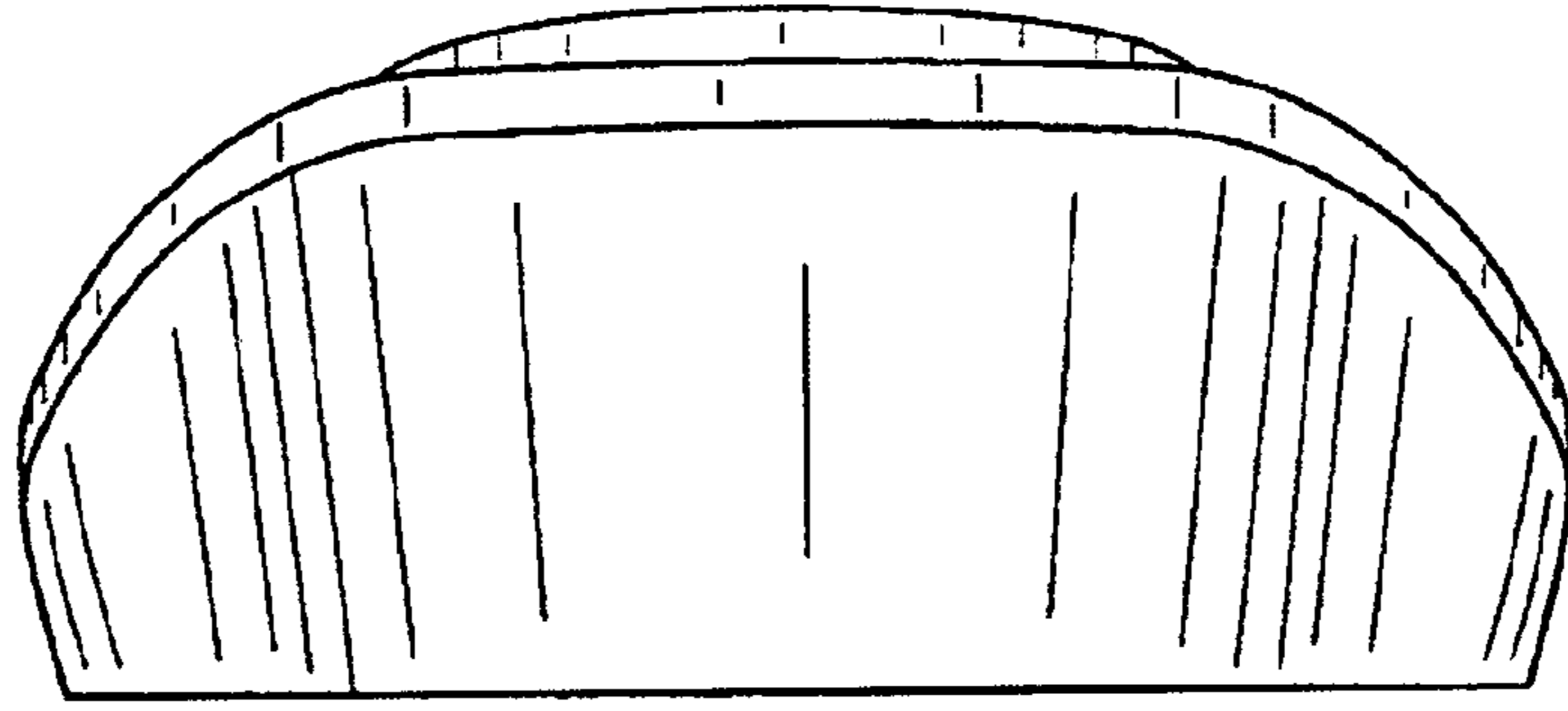

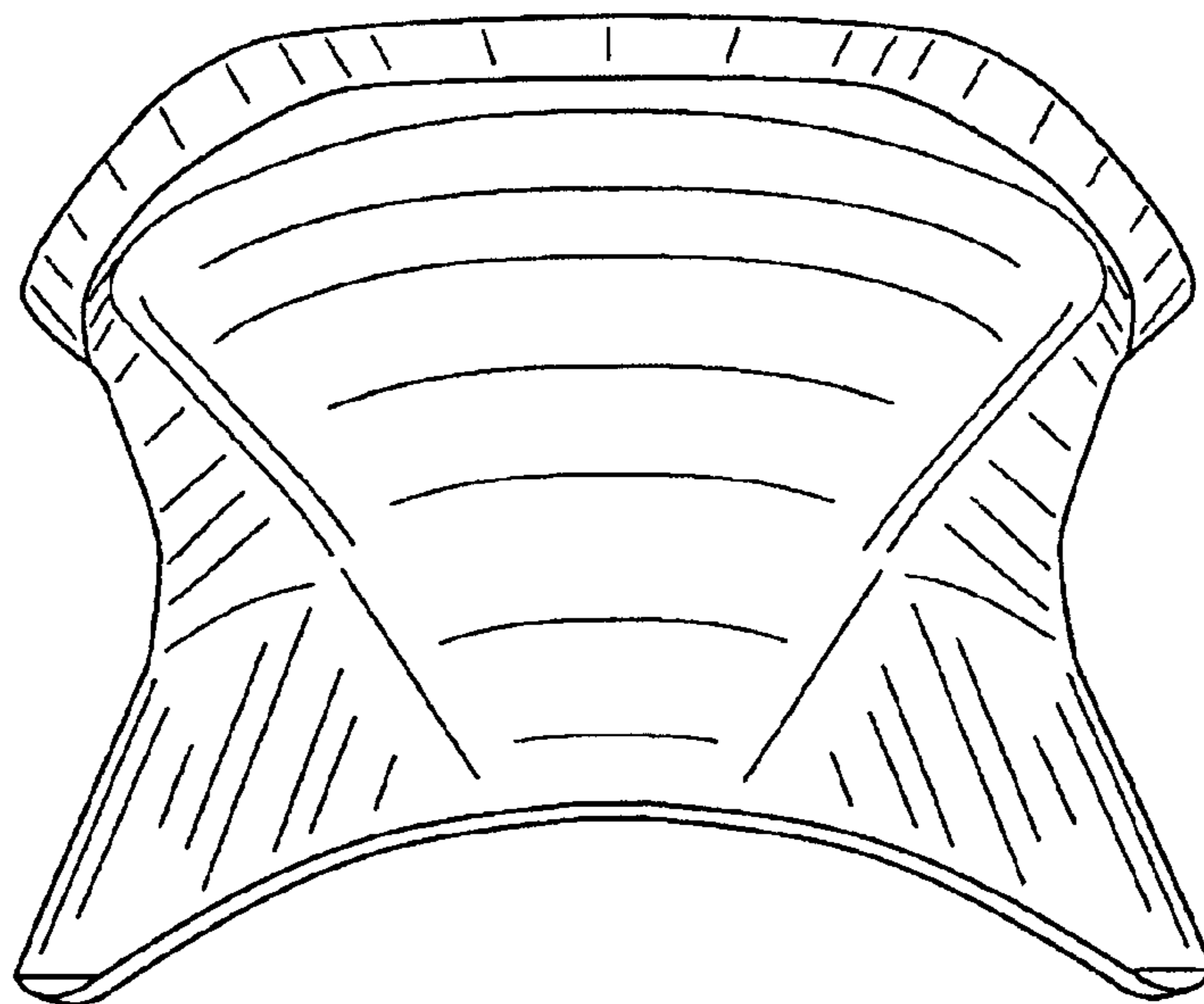

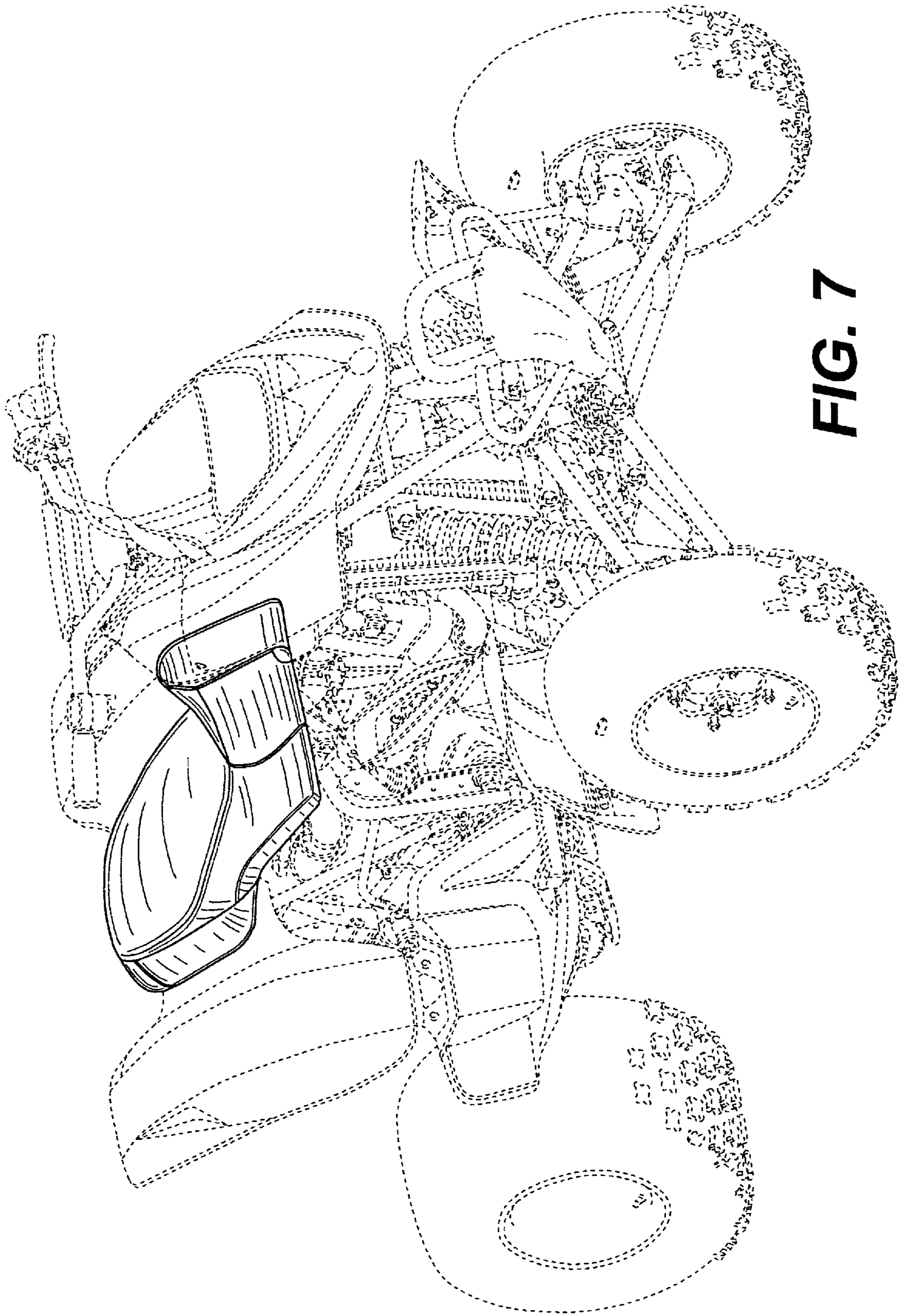

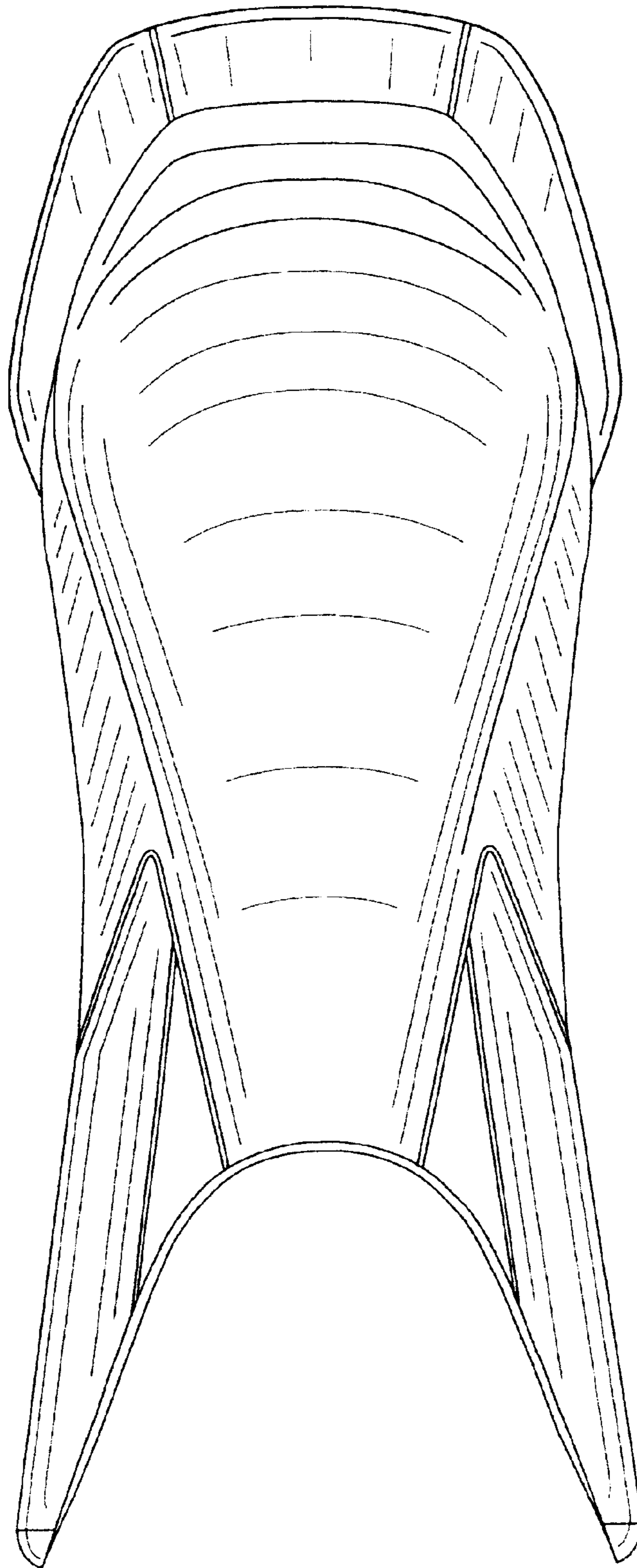

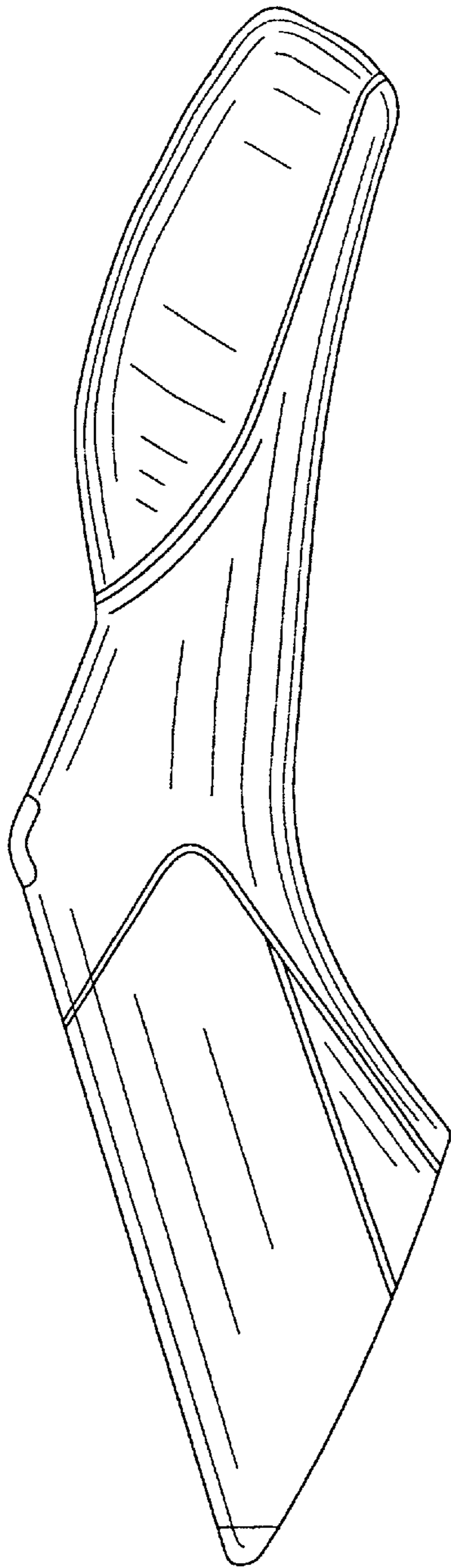

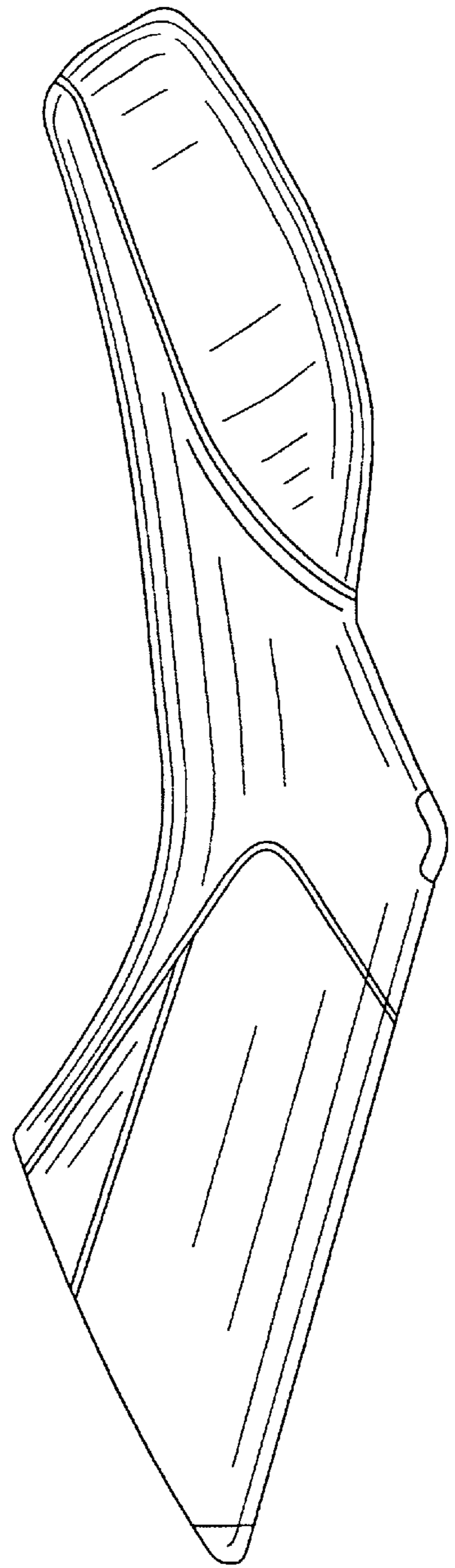

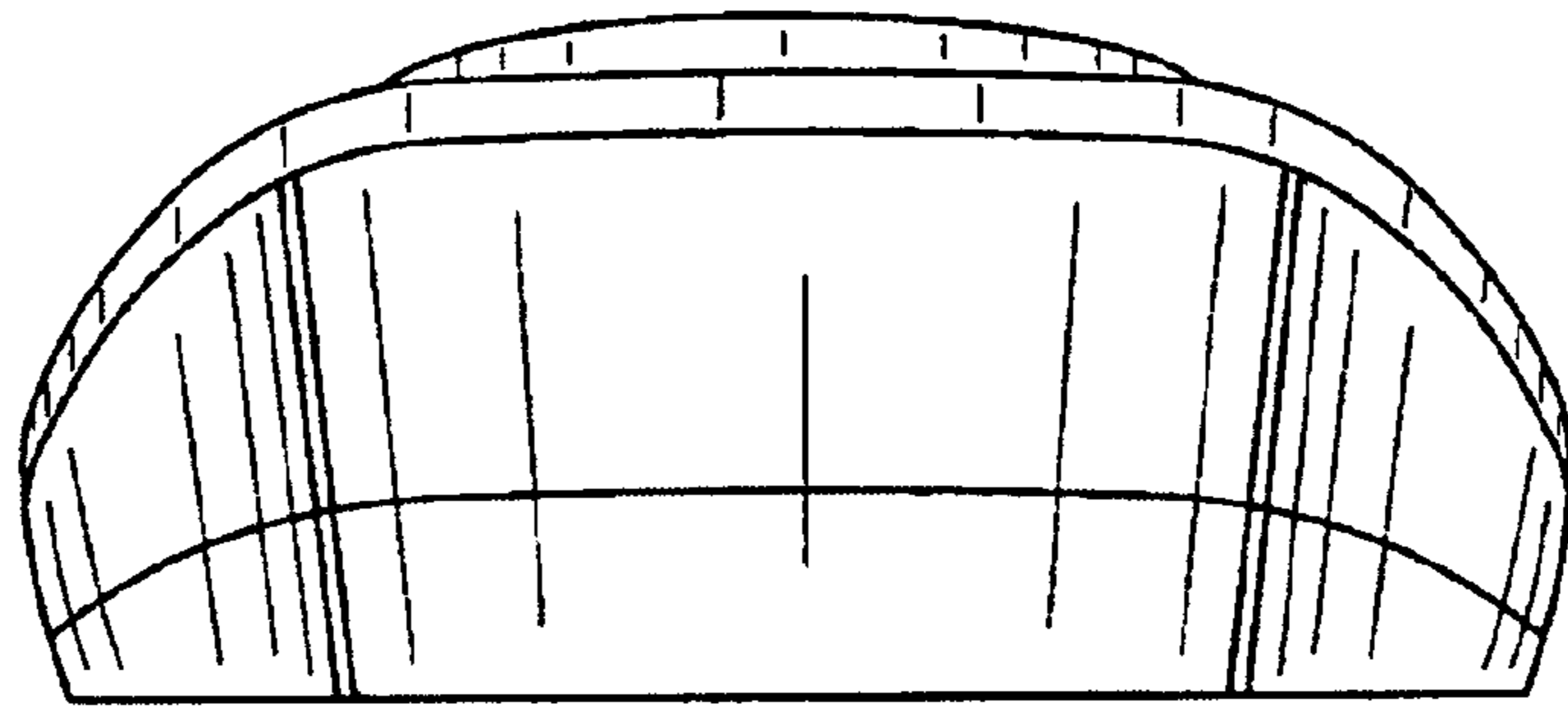

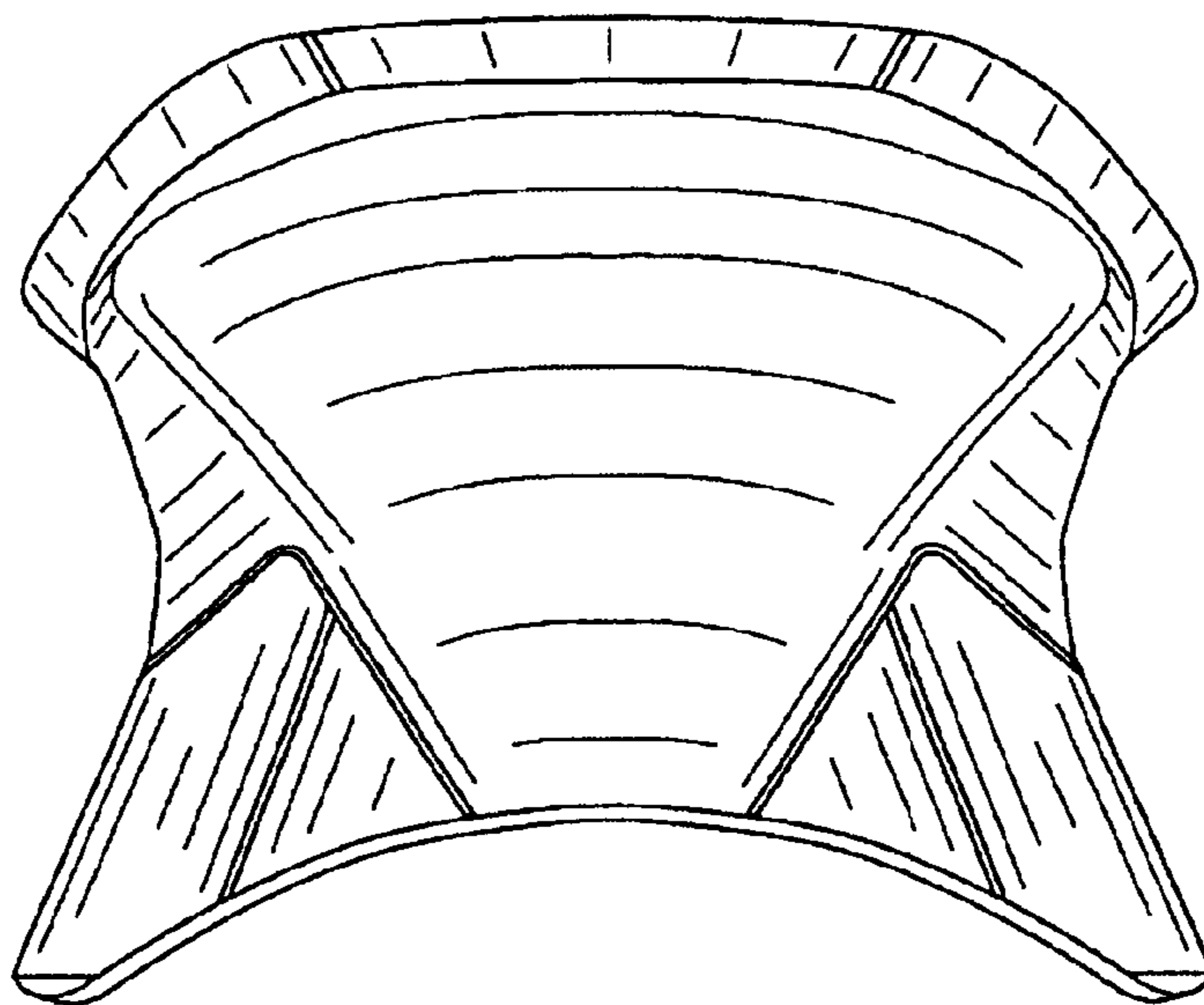
