The ornamental design for a squeezable container for liquid and lotion dispensing, as shown and described.

DESCRIPTION

FIG. 1 illustrates a front perspective view of an embodiment of the squeezable container for liquid and lotion dispensing showing my new and ornamental design; the opposite side being a mirror-image thereof;

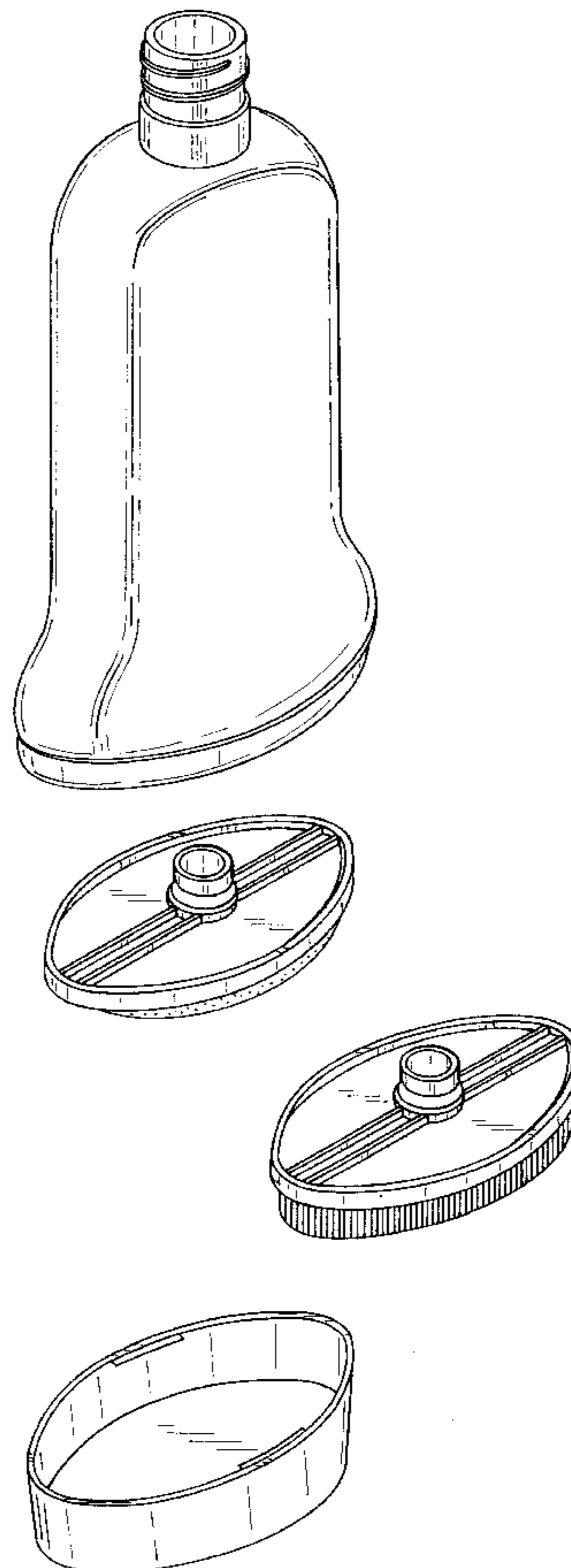
FIG. 2 illustrates a side view, the opposite being a mirror-image thereof;

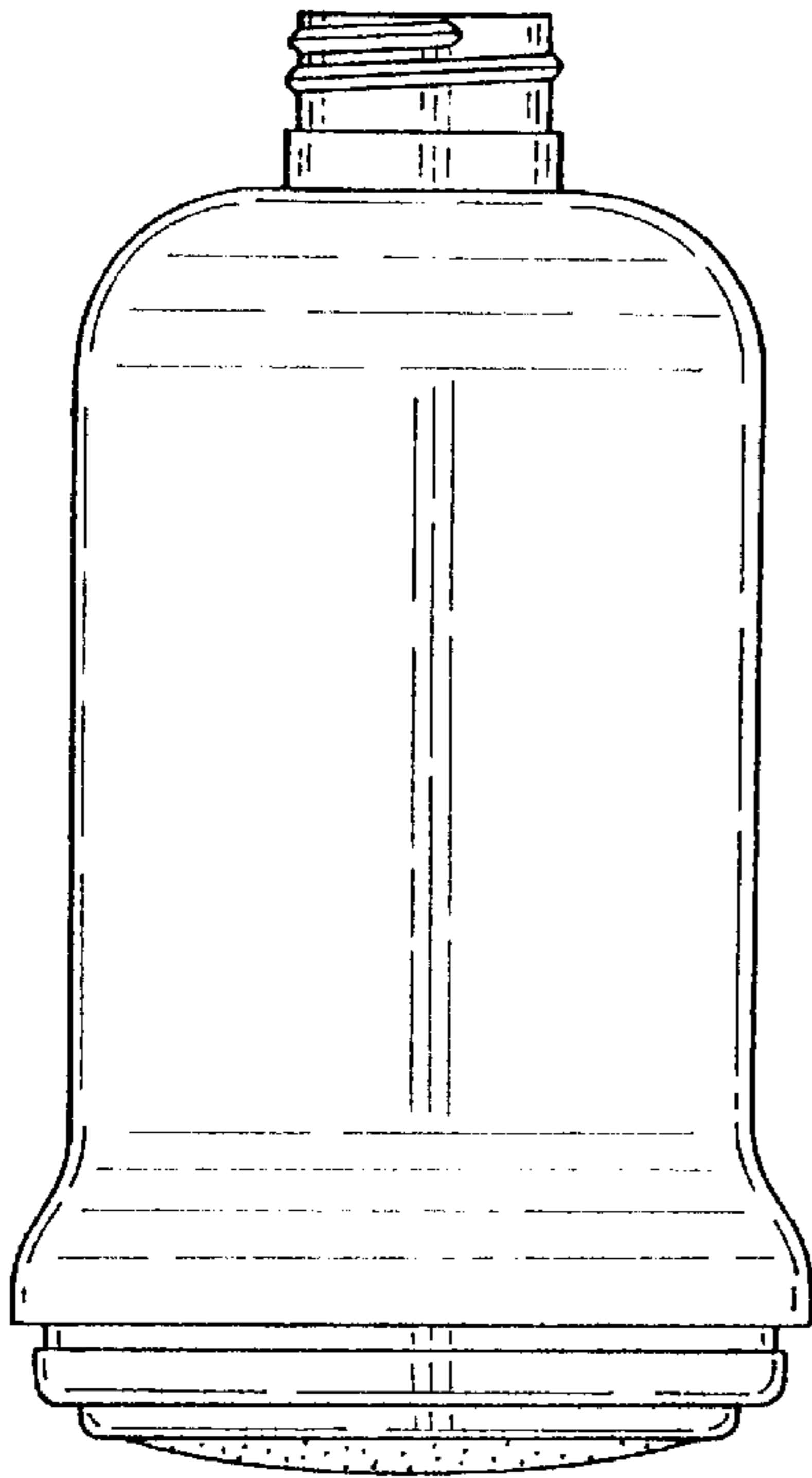

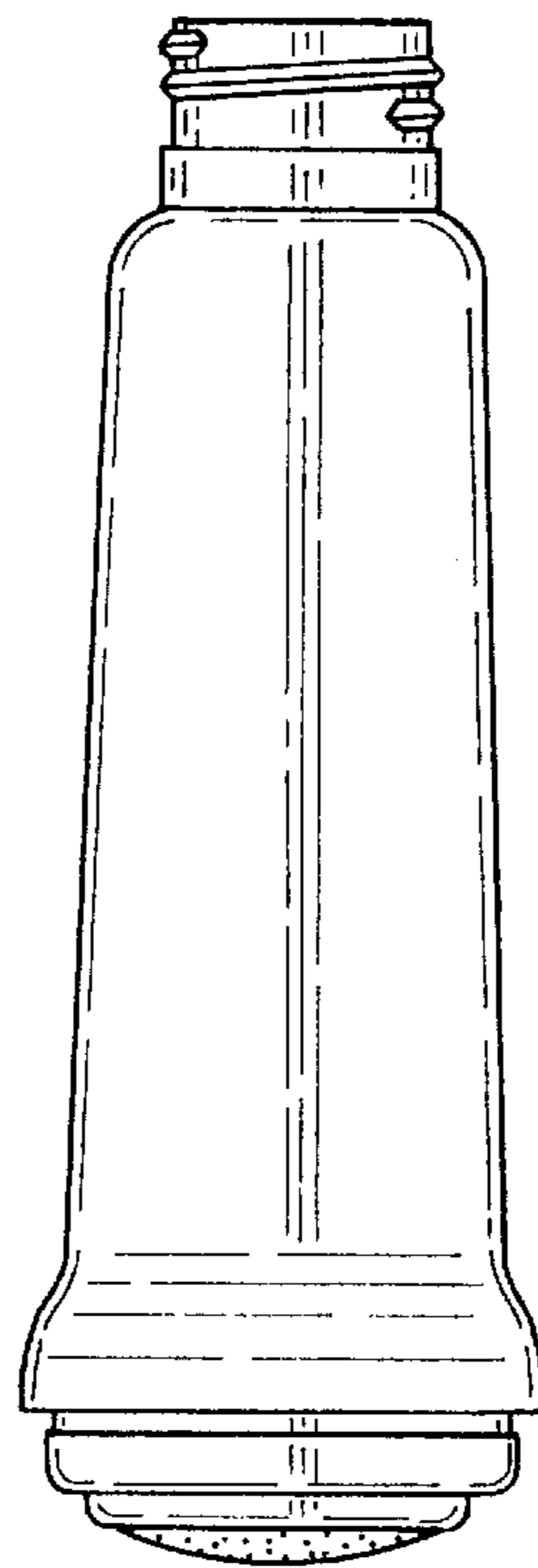

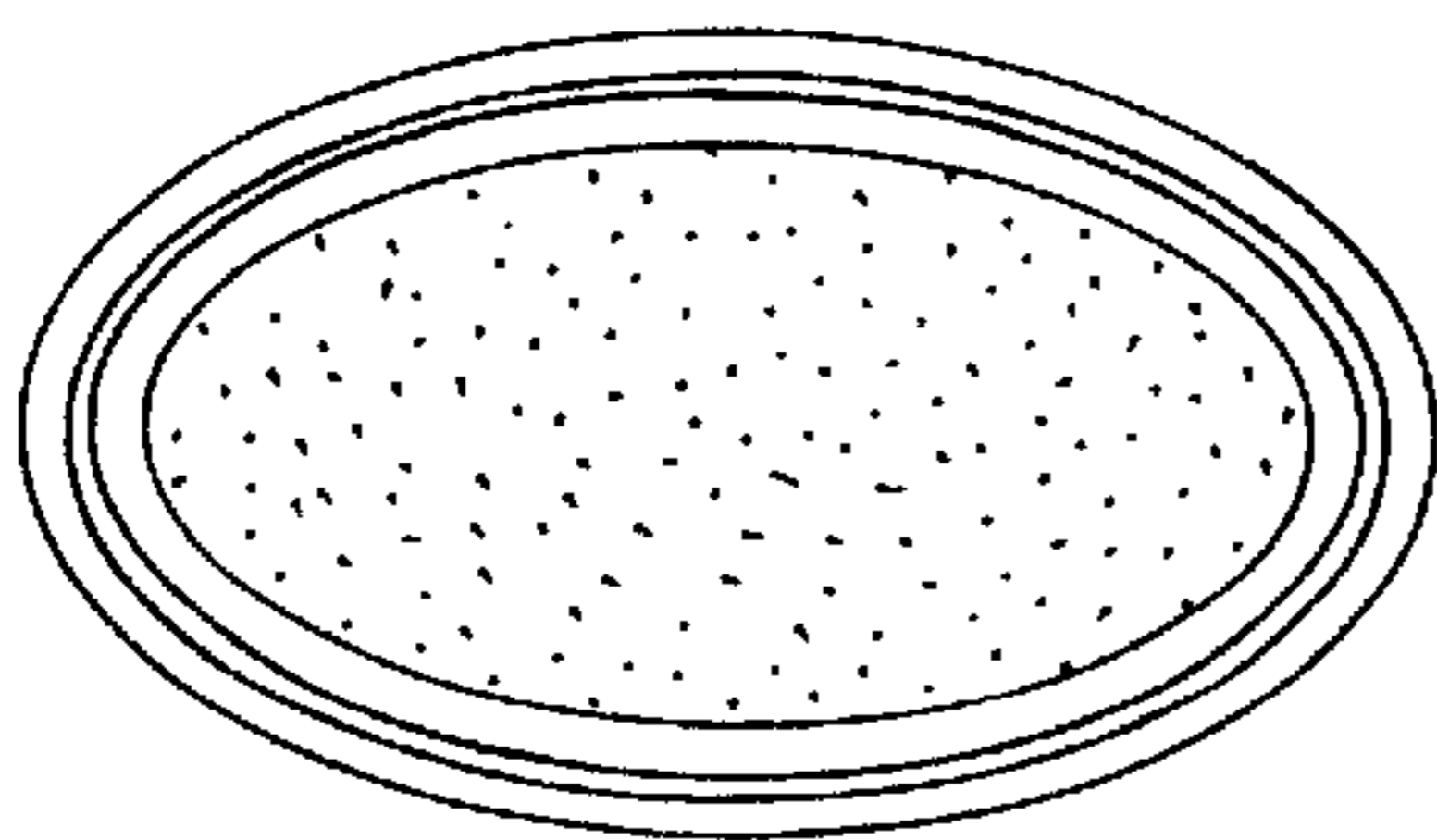

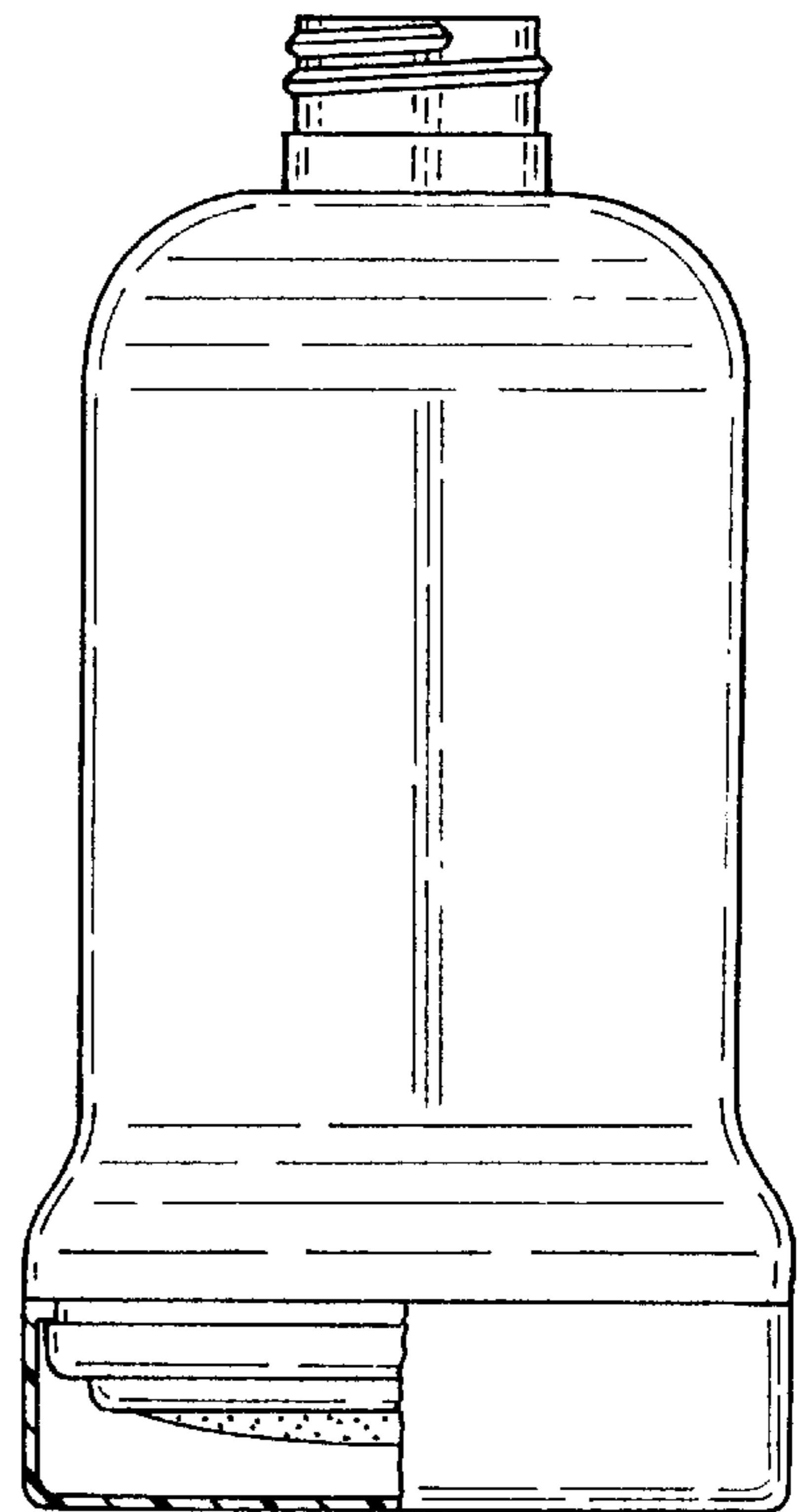
