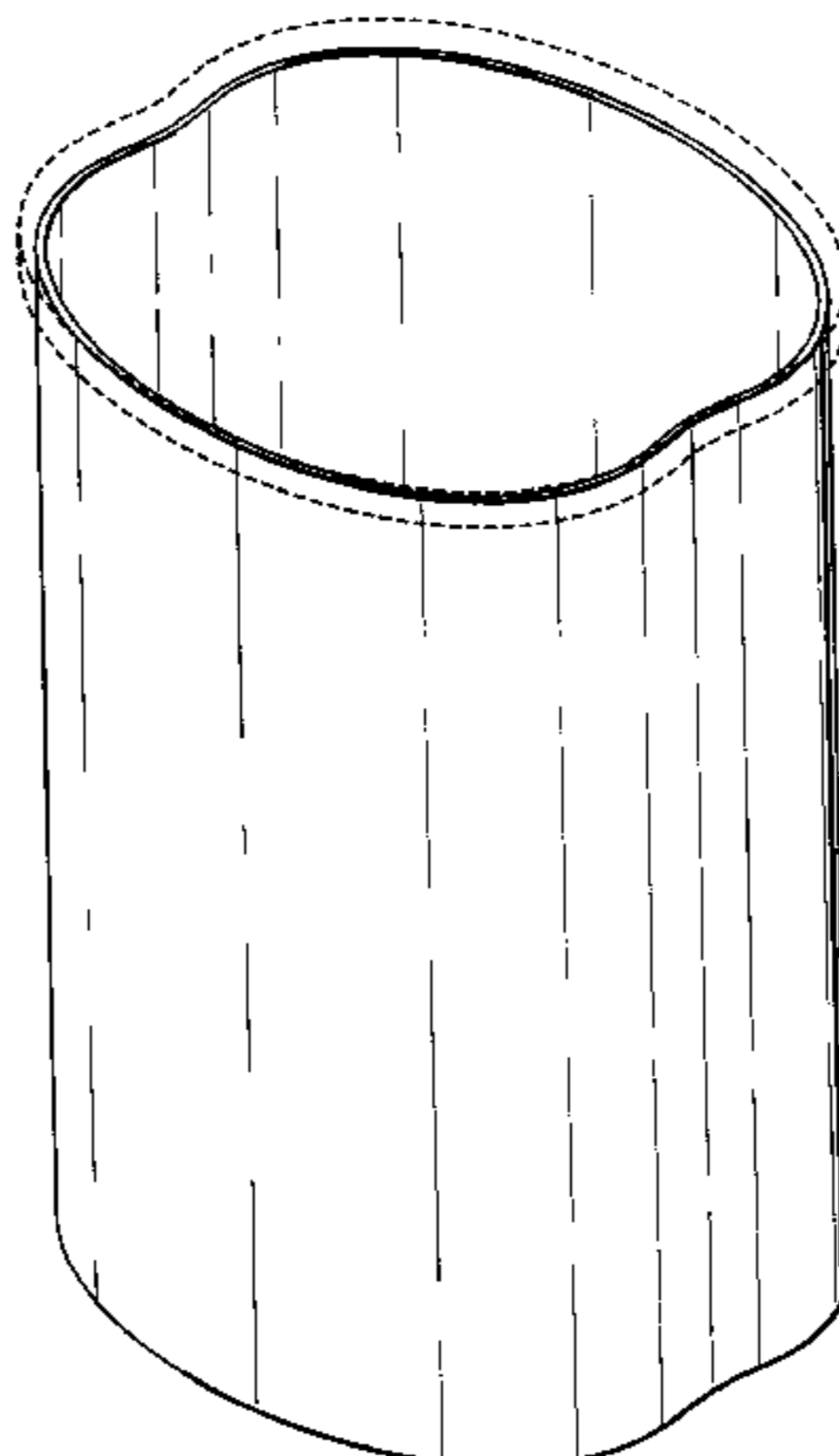
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing an embodiment of our new design, comprising a container;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is front elevational view thereof, the rear elevational view being identical thereto; and,
FIG. 5 is a right side elevational view thereof, the left side elevational view being identical thereto.
A lid is shown in broken lines in FIGS. 1-5 for illustrative purposes only and forms no part of the claimed design.

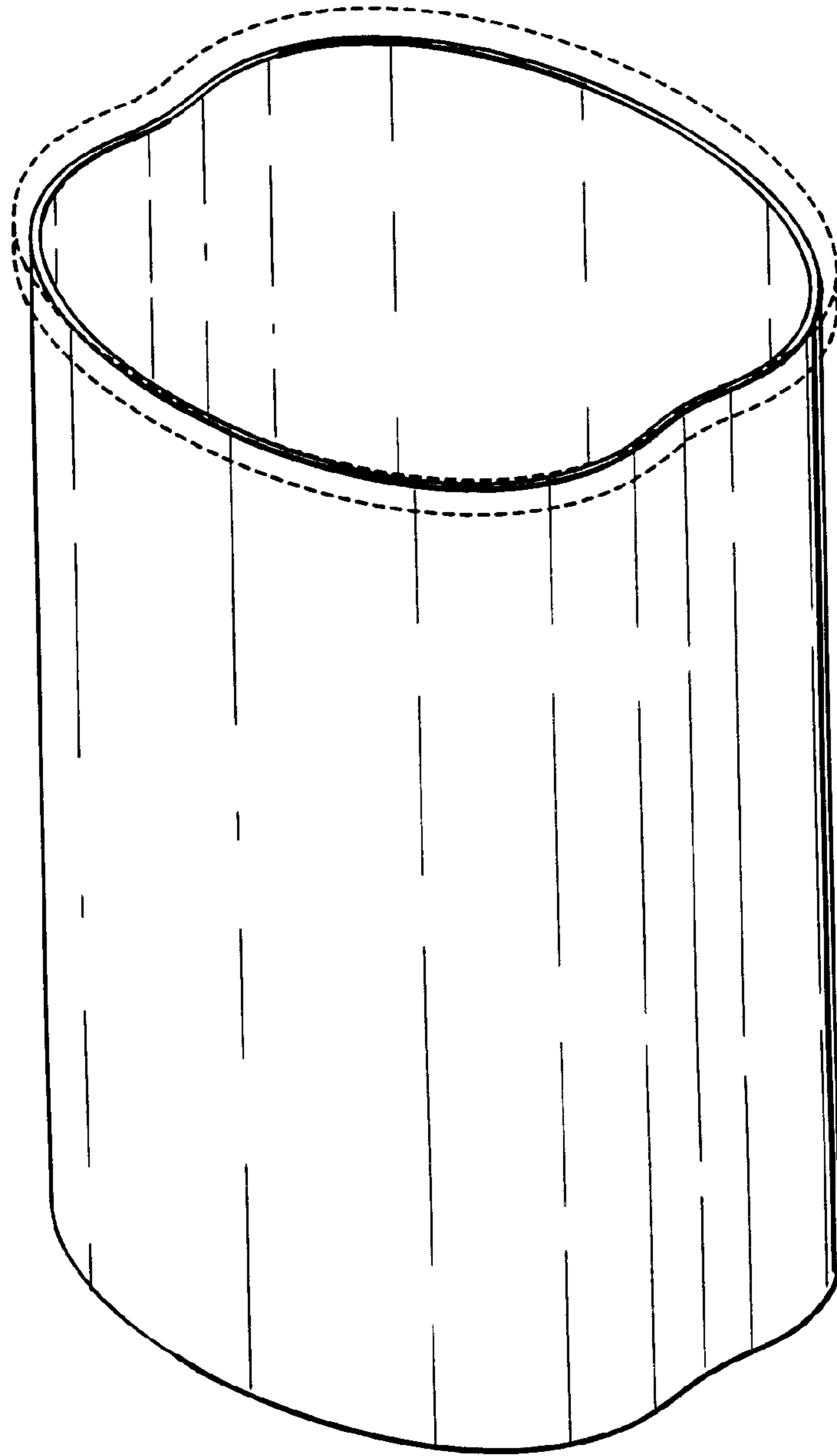

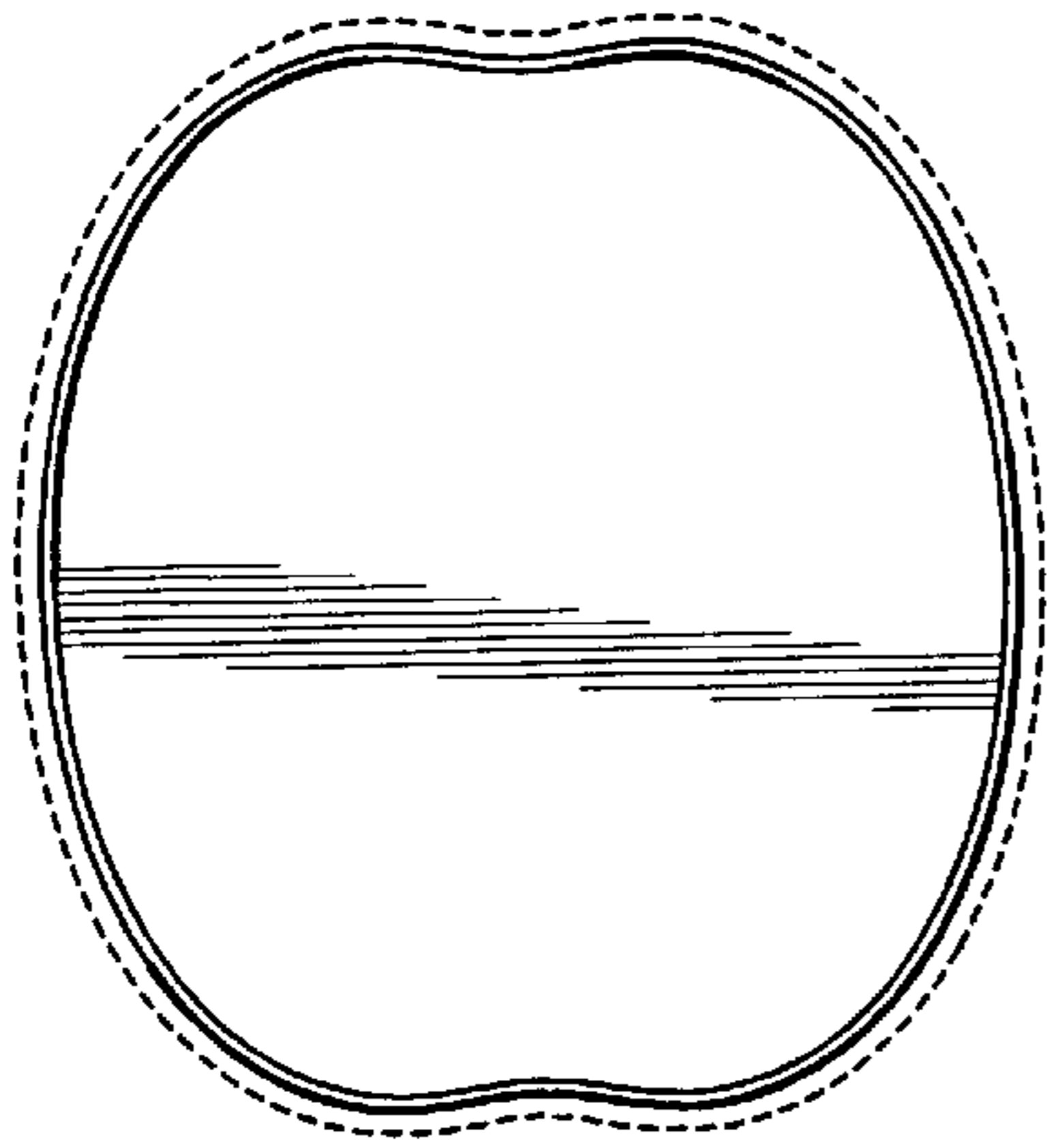

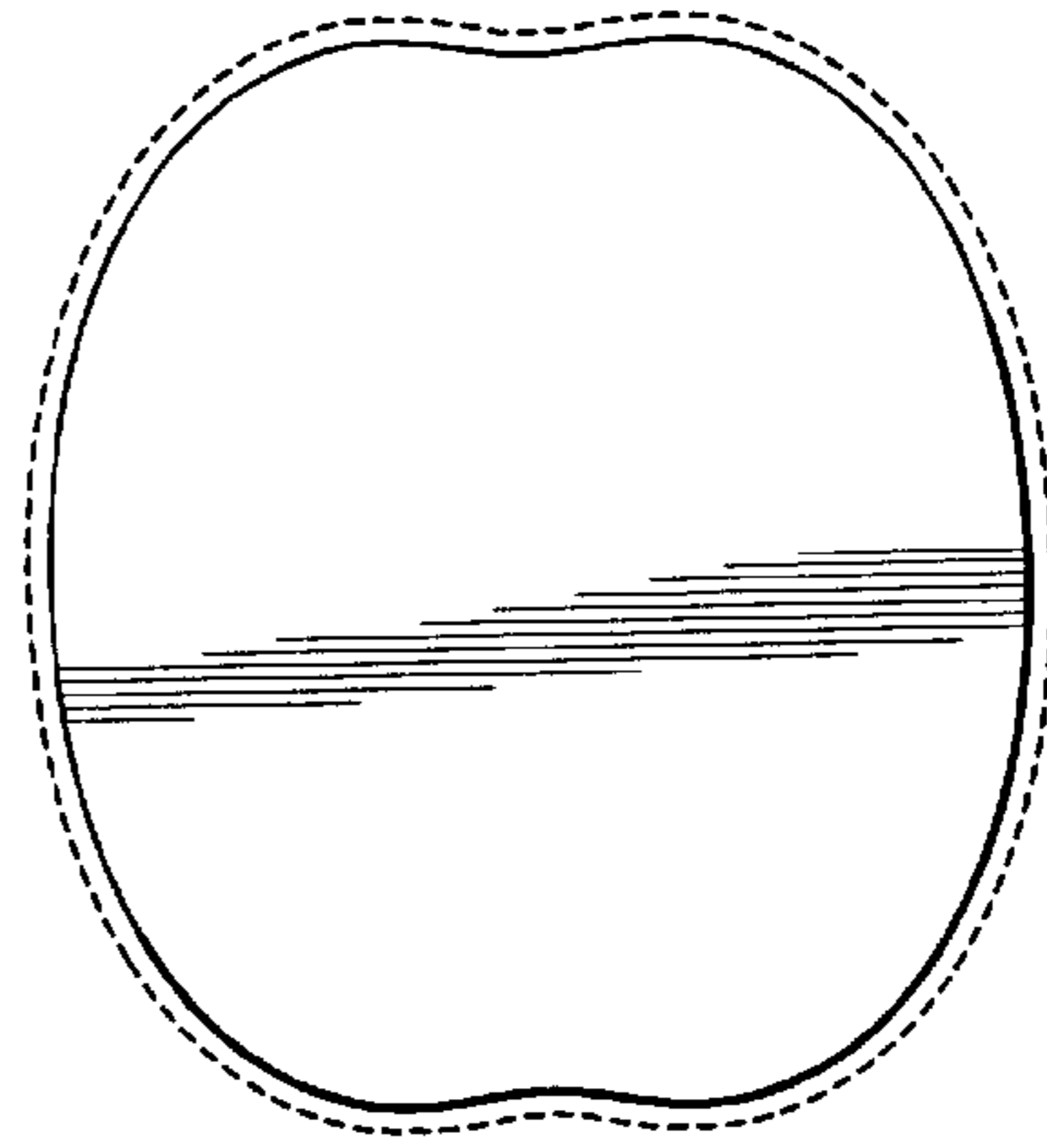

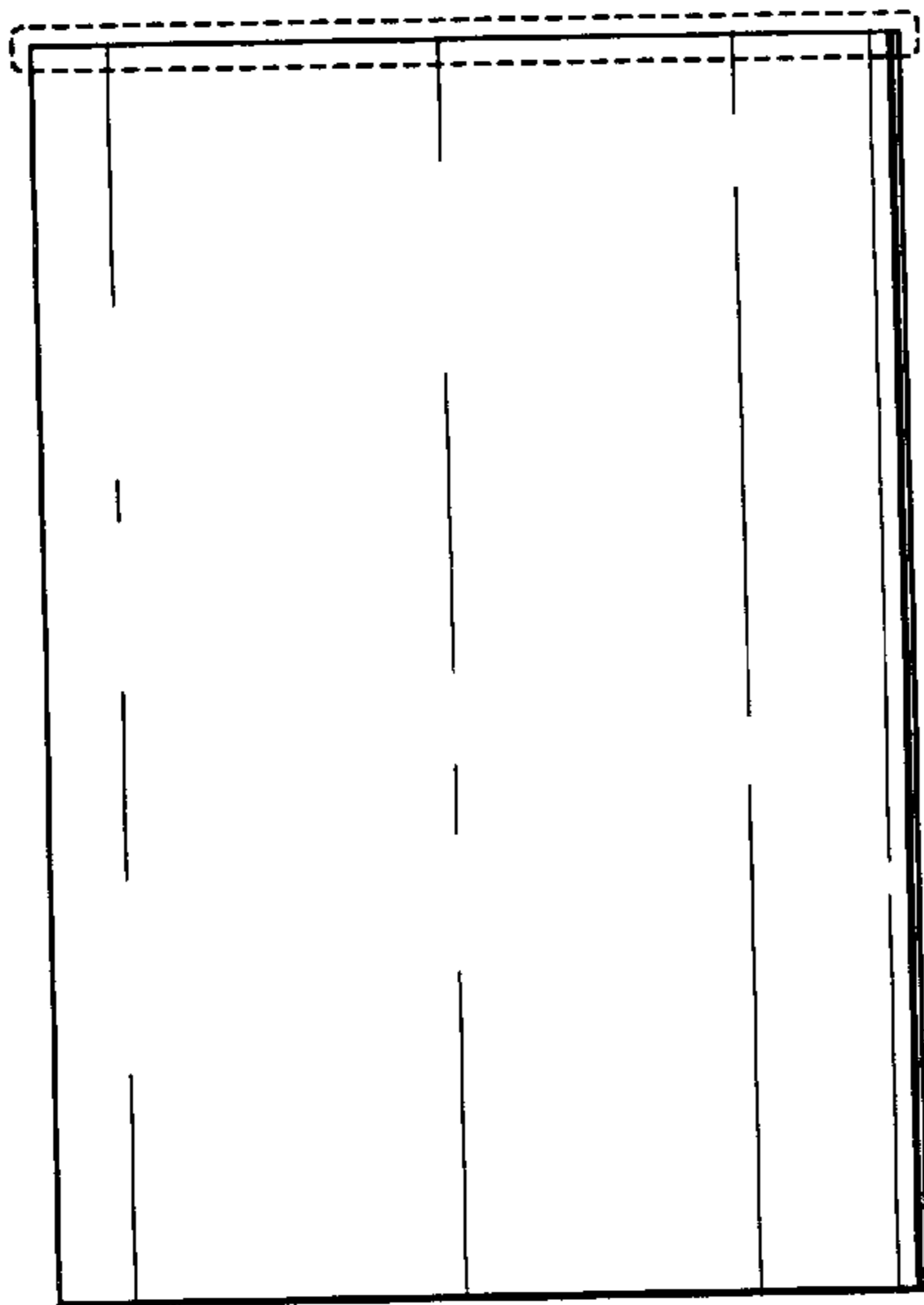
