(57) **CLAIM**

The ornamental design for a bottle with cap, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottle with cap of the present invention;

FIG. 2: a bottom figure of the bottle with cap flask illustrated in FIG. 1;

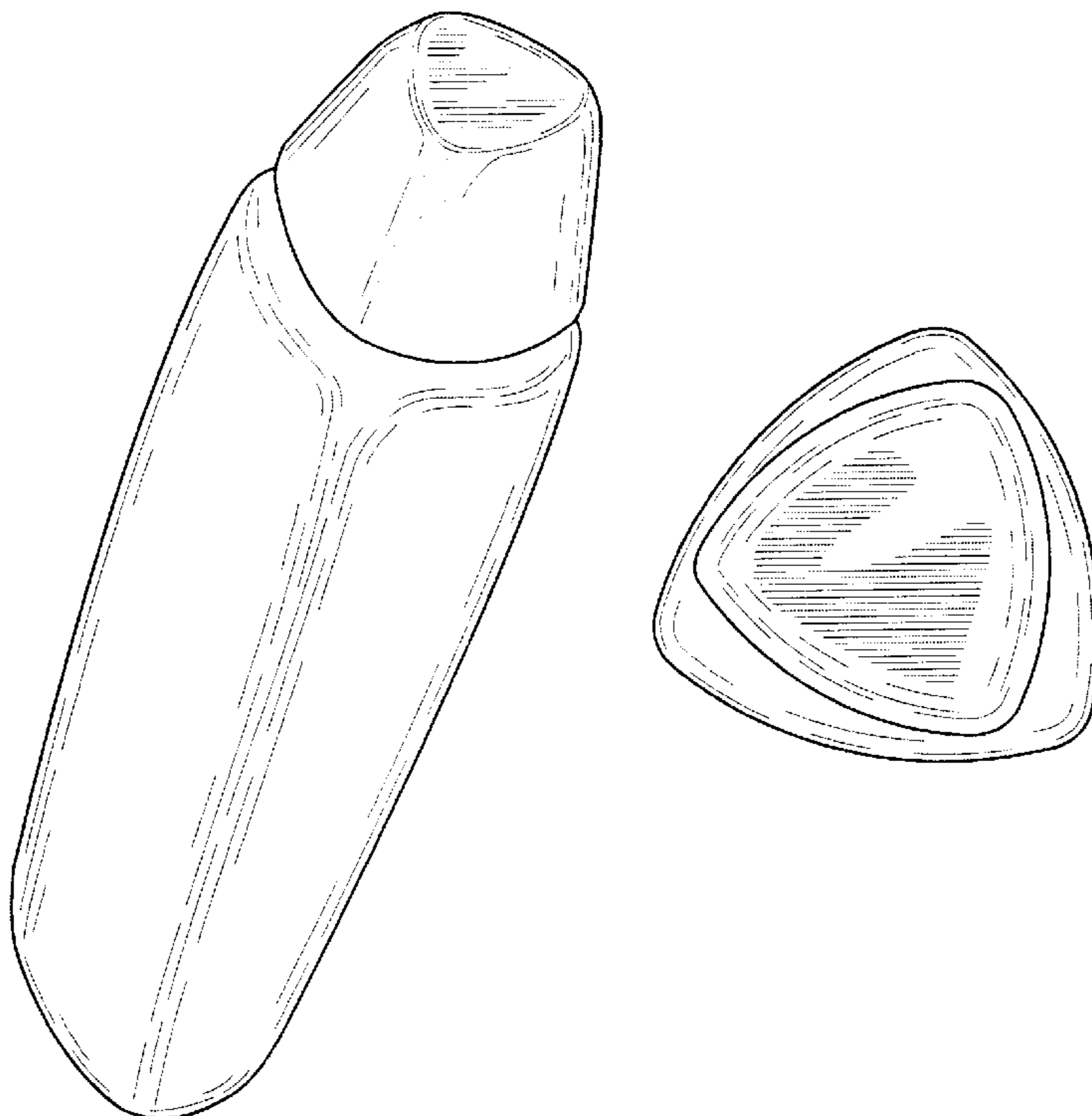
FIG. 3: a top view of the bottle with cap flask illustrated in FIGS. 1 and 2;

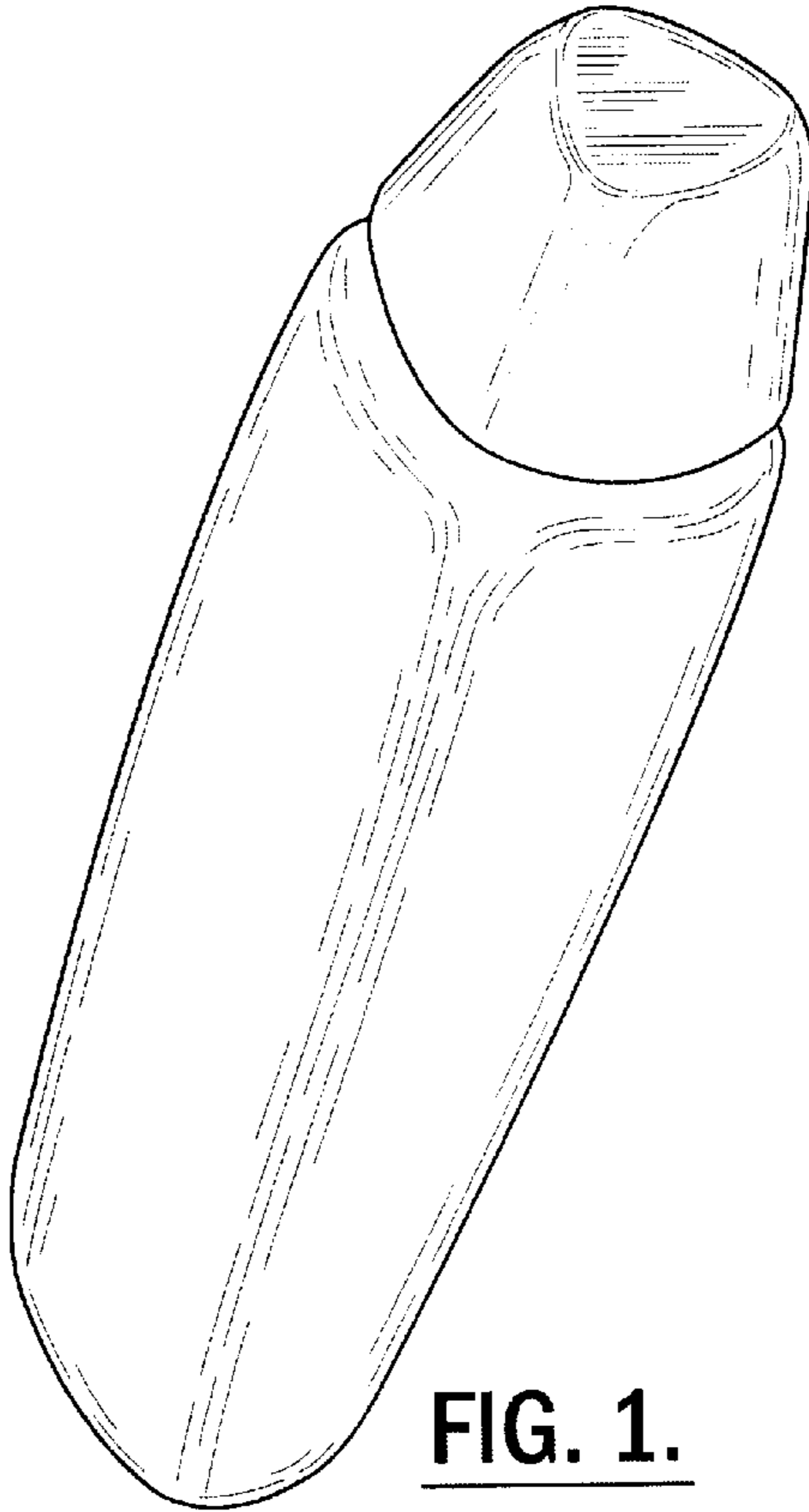

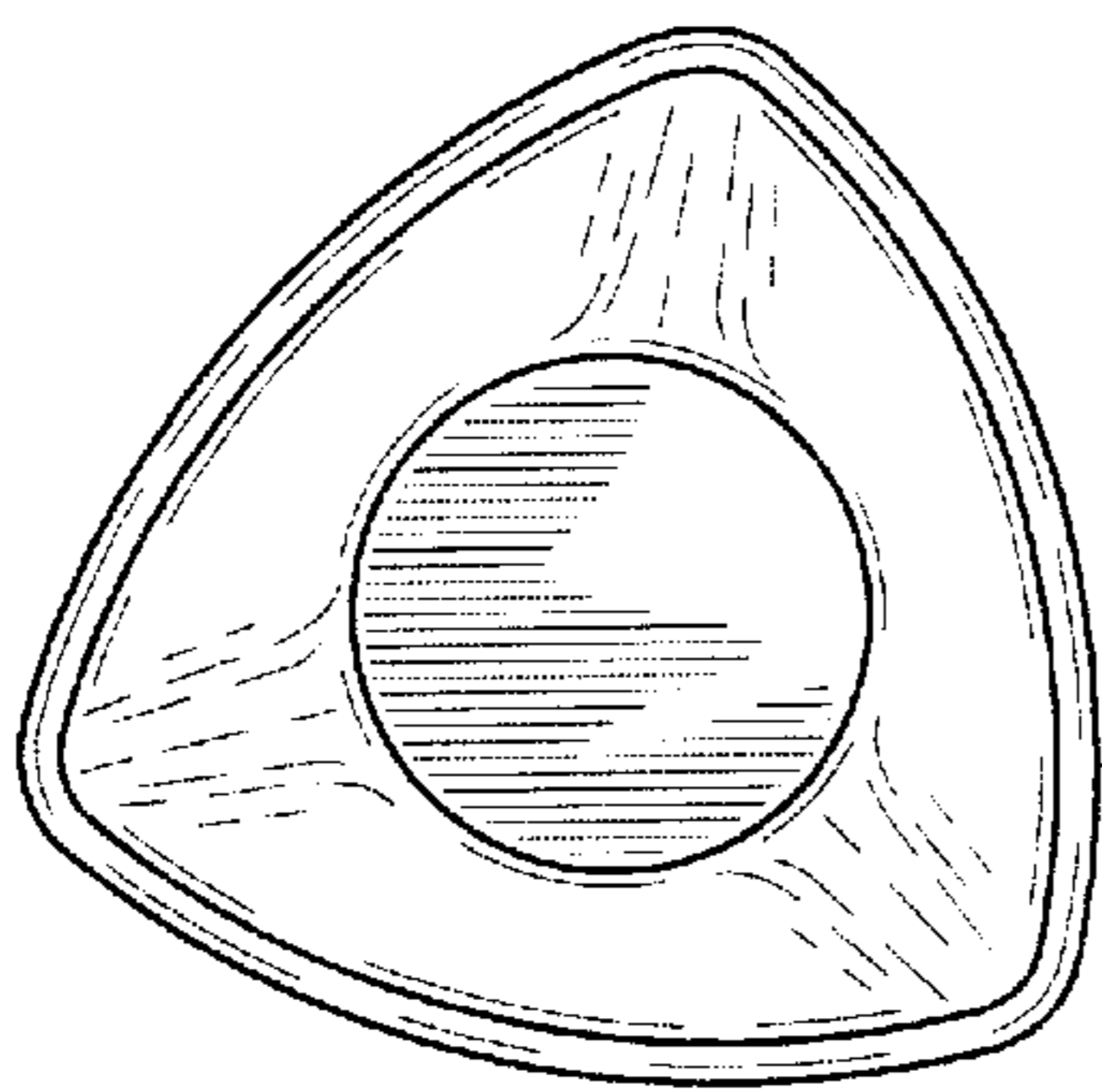

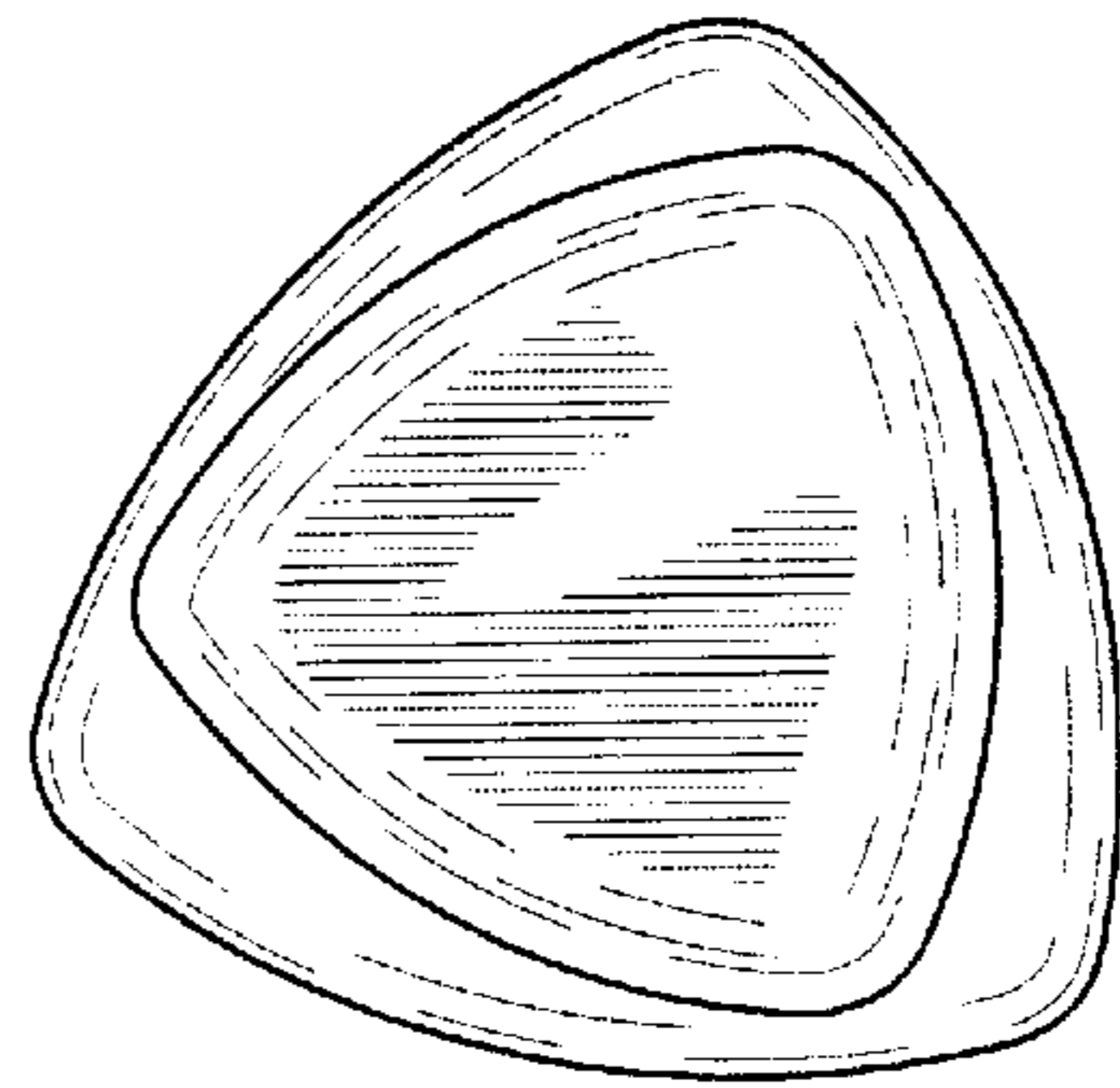

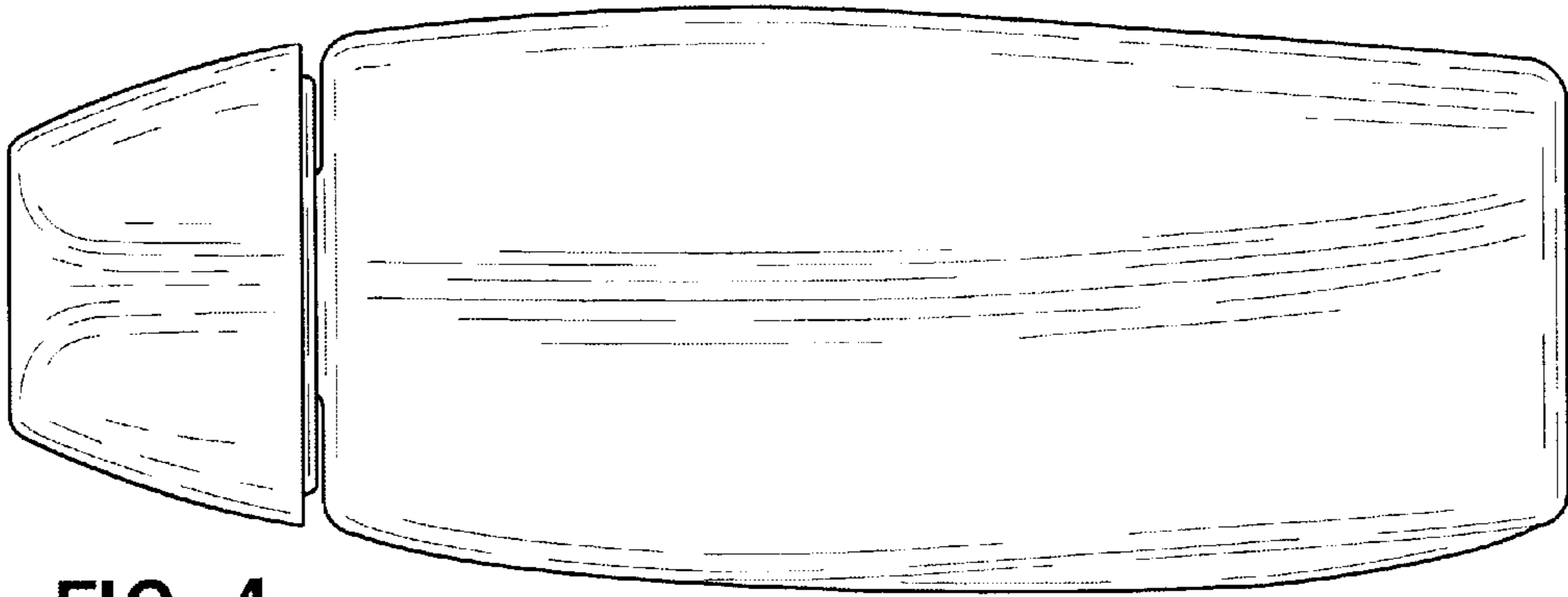

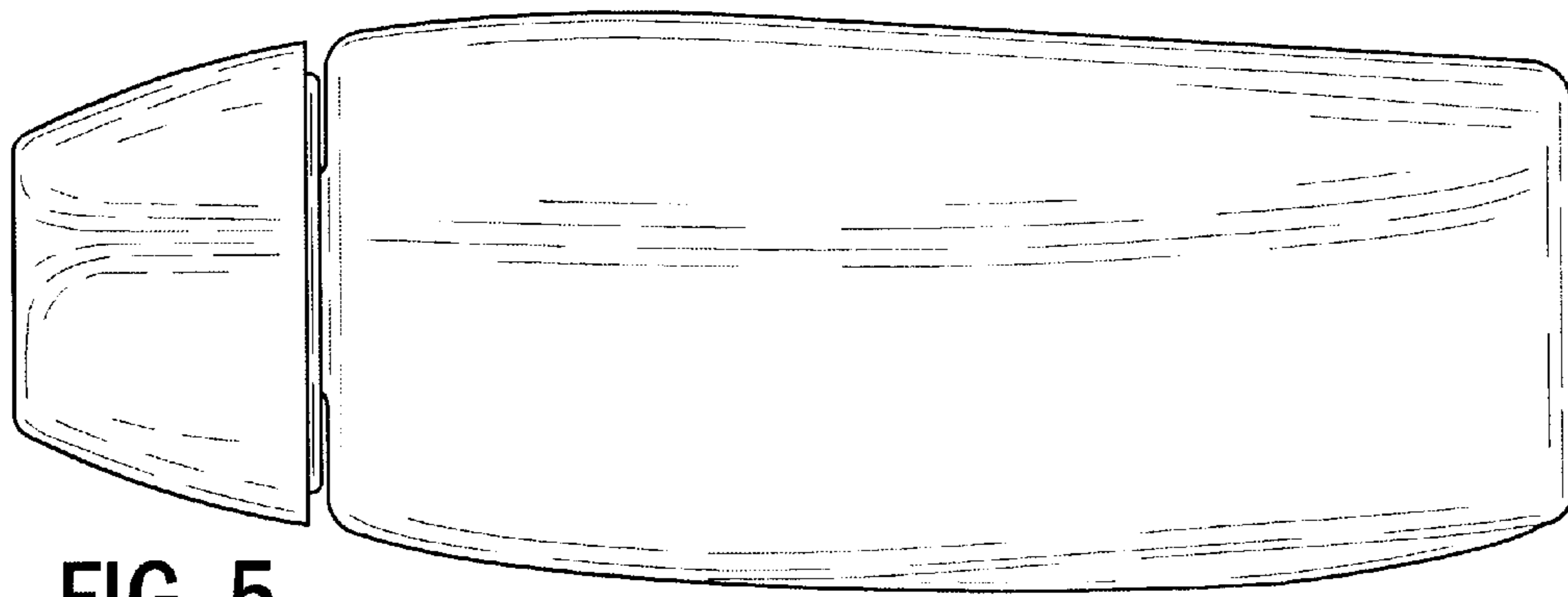

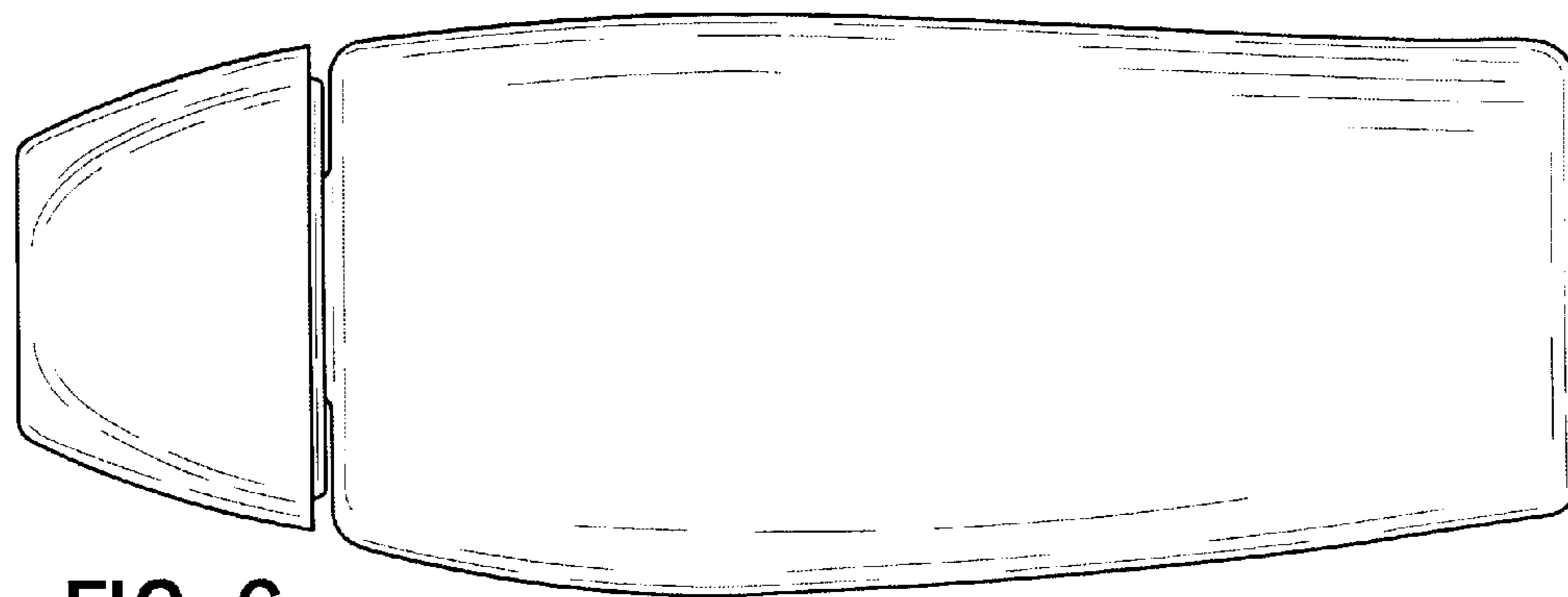
