FIG. 2 is a front elevational view thereof, the rear elevational view being identical;

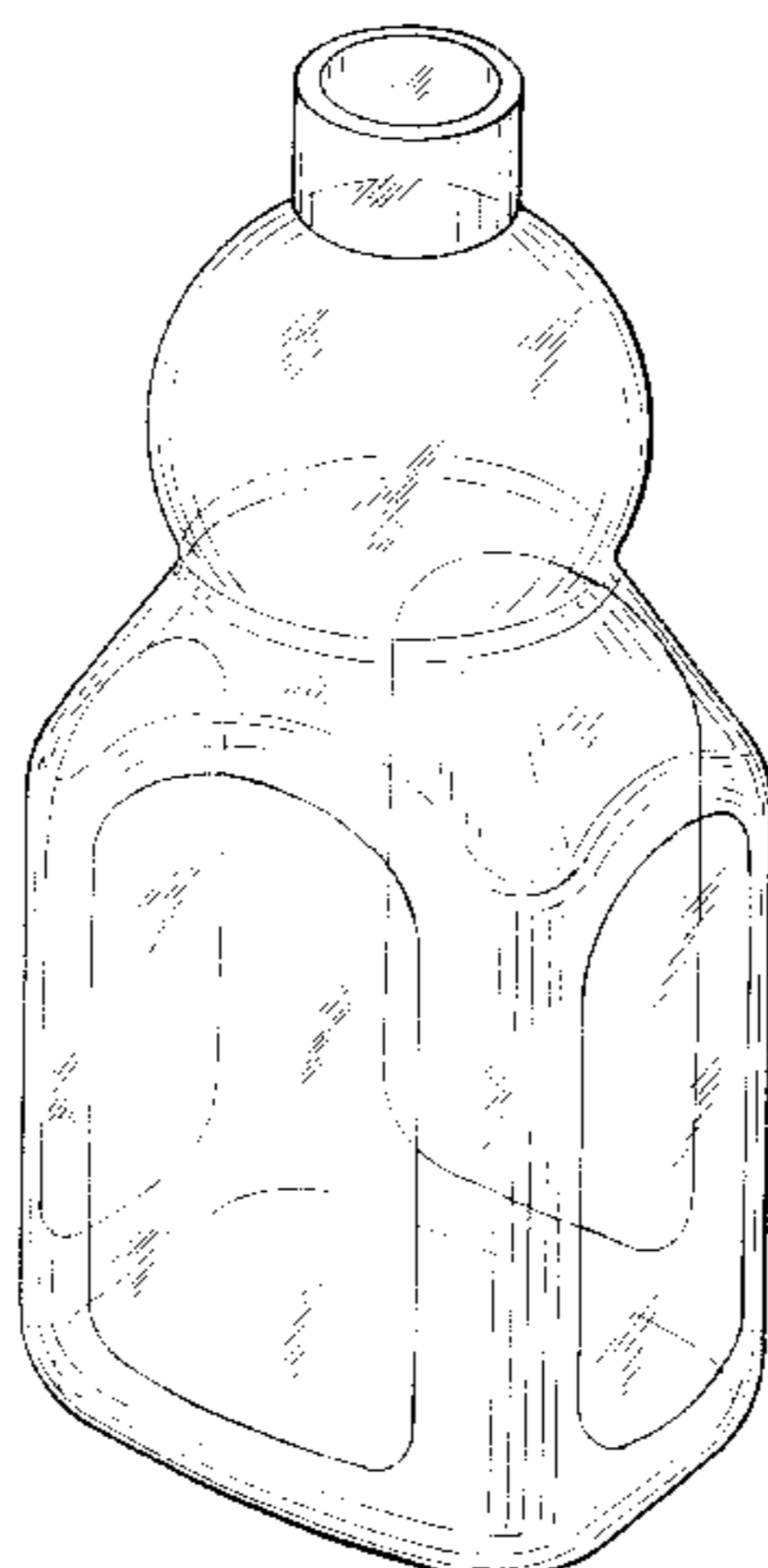
FIG. 3 is a right side elevational view thereof, the left side elevational view being identical;

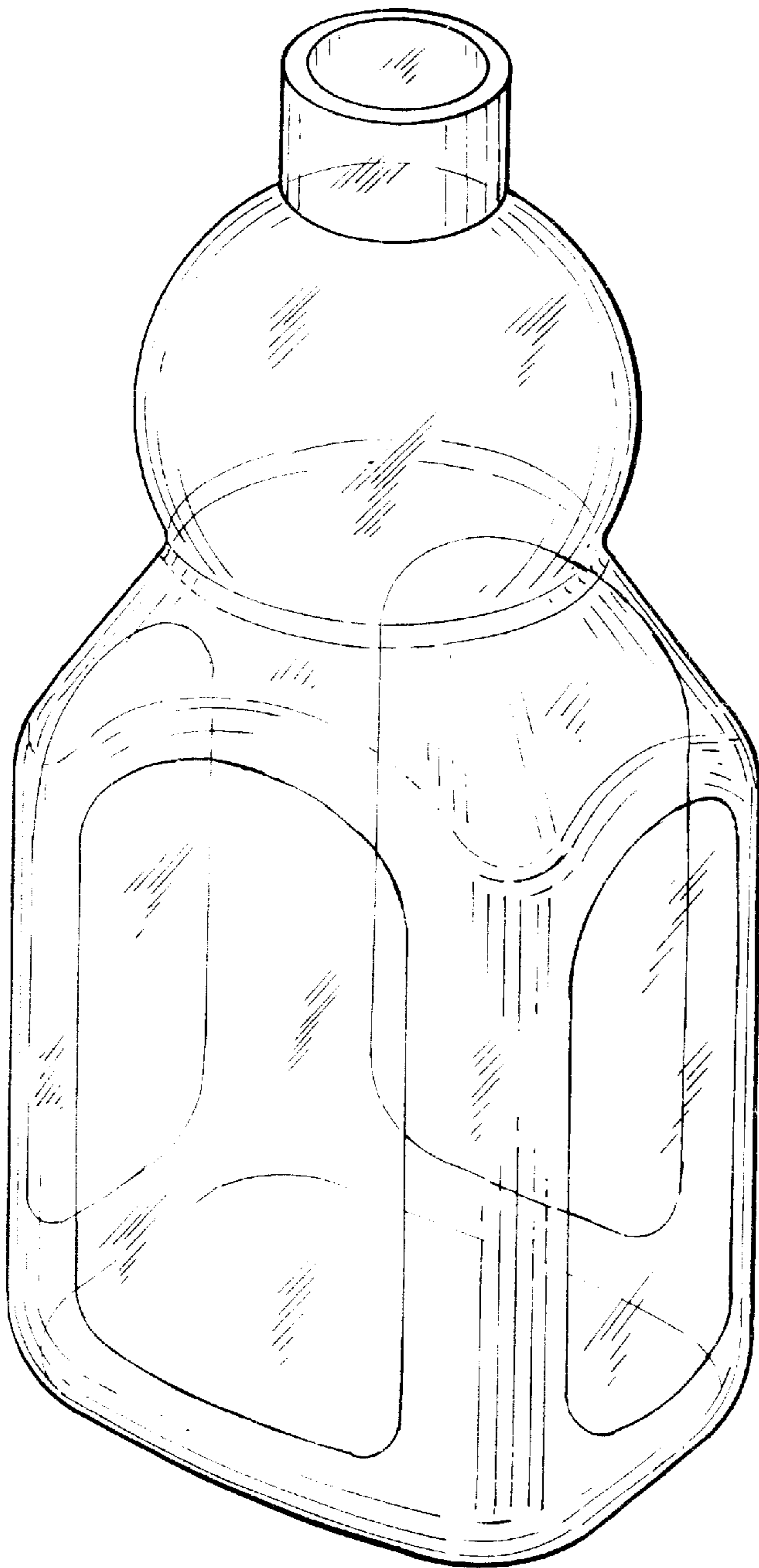

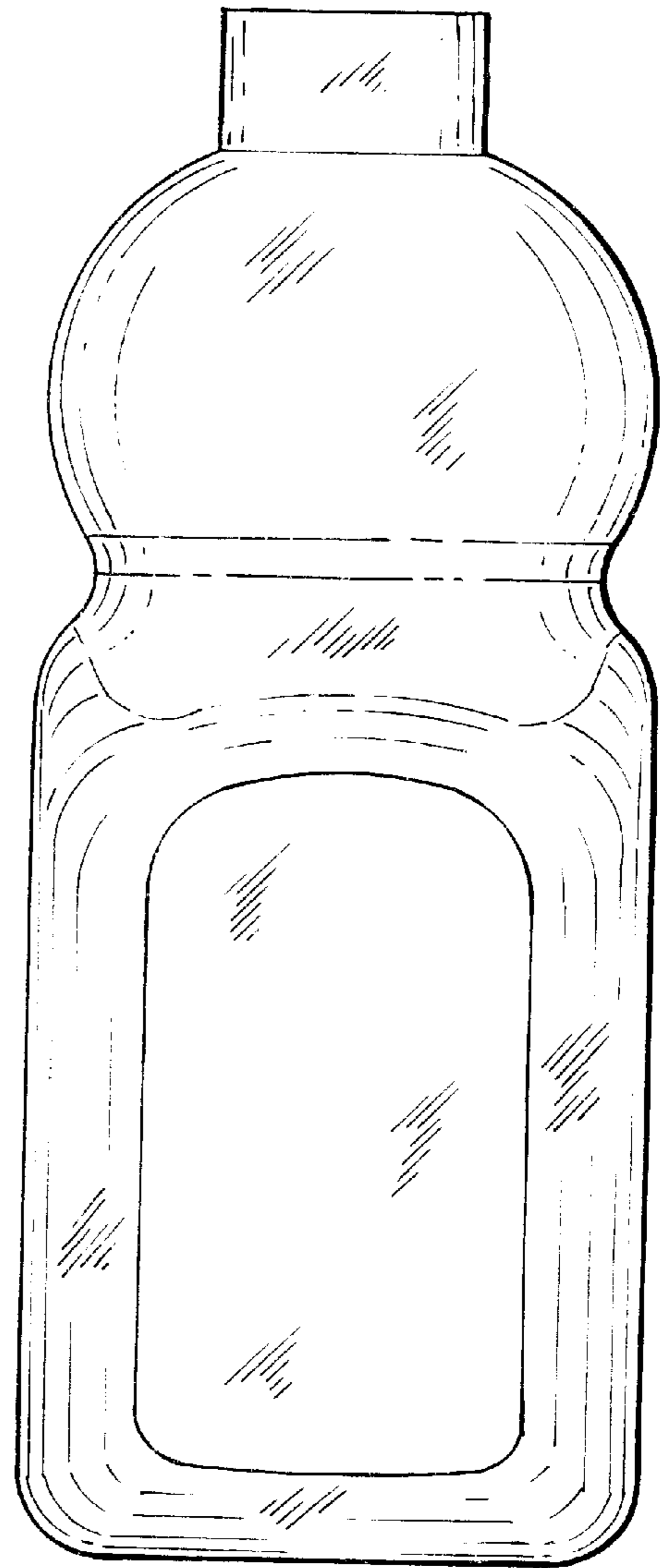

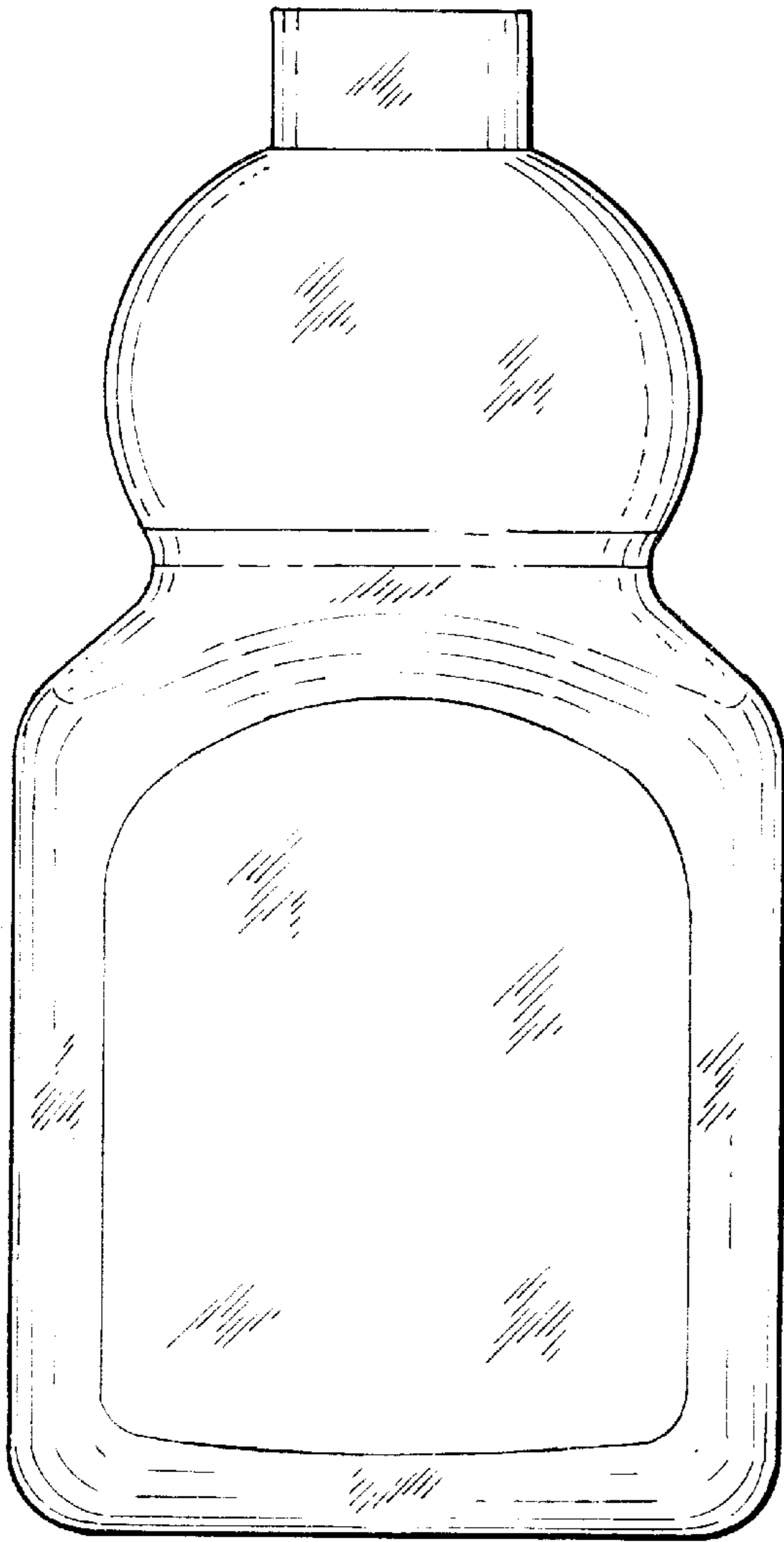

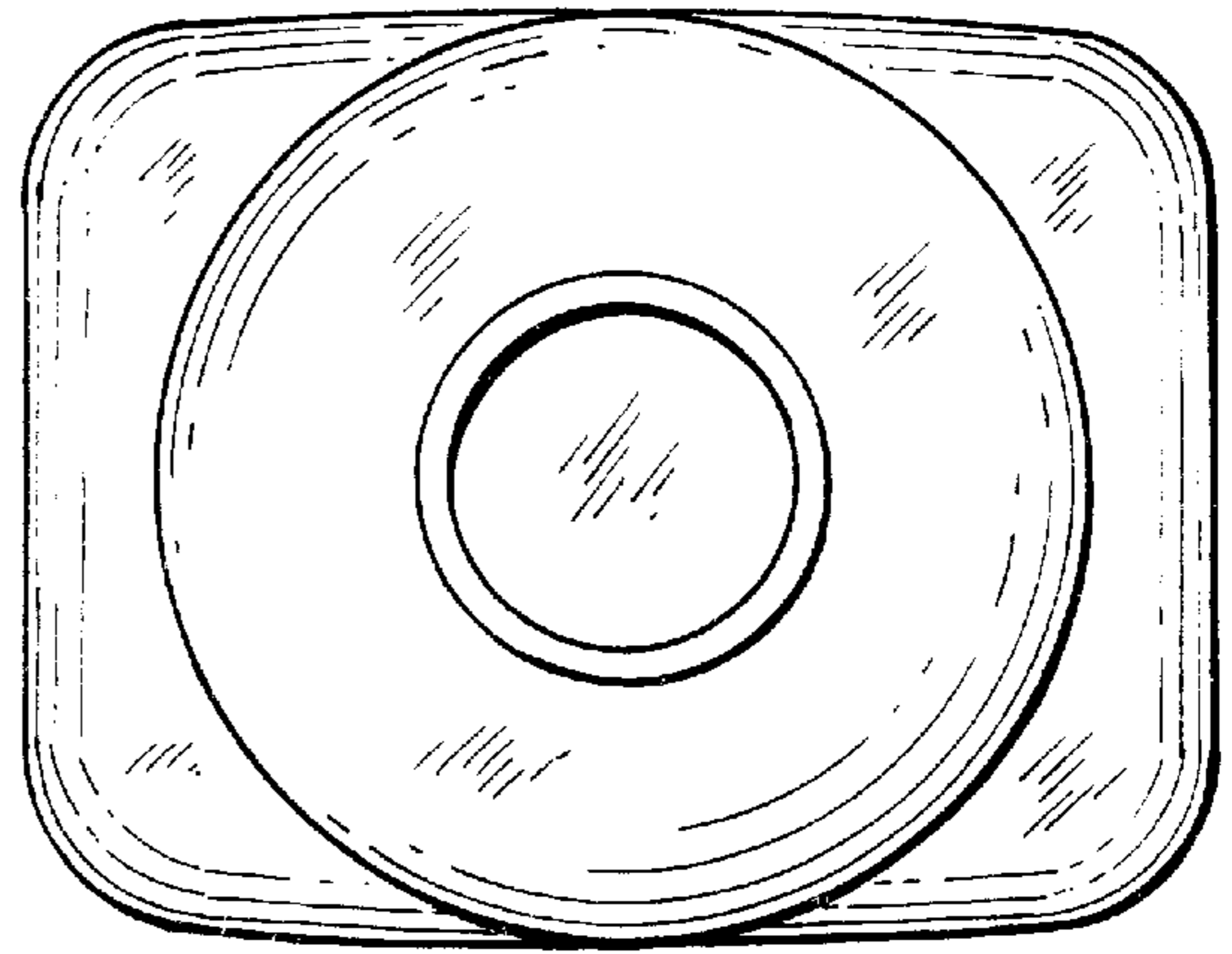
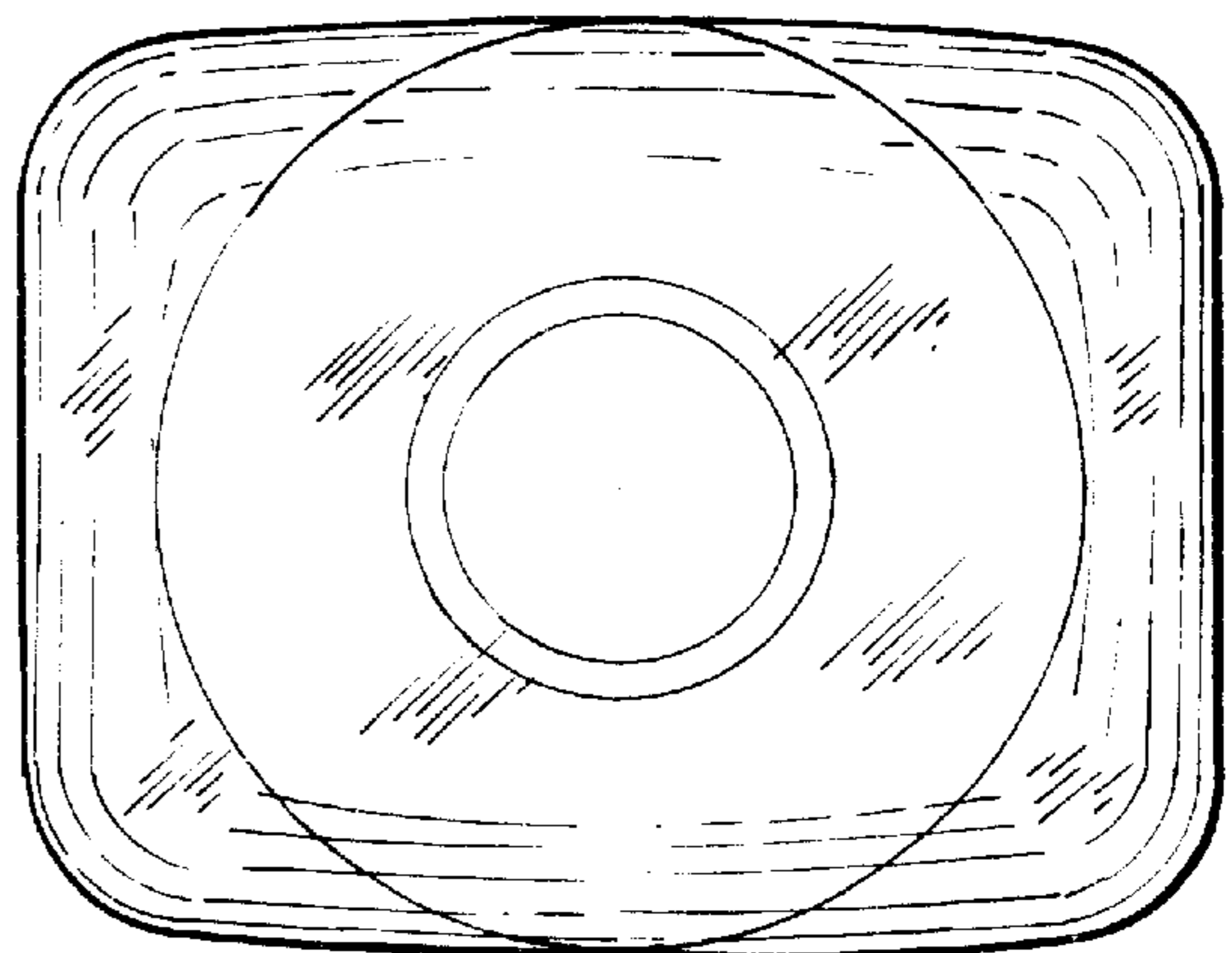
