The ornamental design for a decorative braid, as shown.

DESCRIPTION

FIG. 1 is a front view of the decorative braid of the subject matter;

FIG. 2 is a rear view of the decorative braid;

FIG. 3 is a plan view of the decorative braid;

FIG. 4 is a bottom view of the decorative braid;

FIG. 5 is a left side view of the decorative braid;

FIG. 6 is a right side view of the decorative braid;

FIG. 7 is a front, left, upper perspective view of the decorative braid;

FIG. 8 is a partially enlarged view of a front portion of FIG. 7;

FIG. 9 is a front view of the decorative braid of which a left portion is screened;

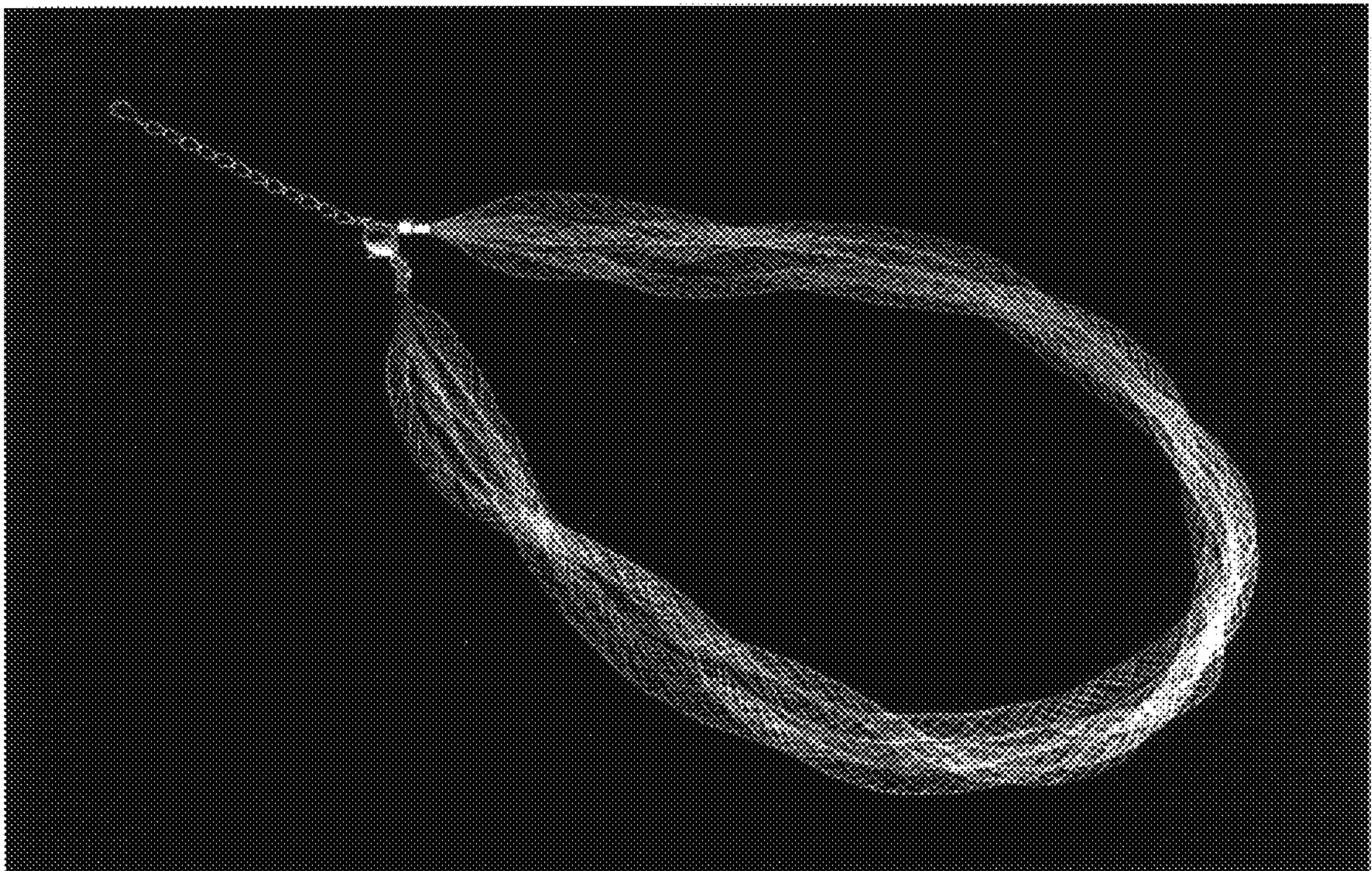
FIG. 10 is a partial enlarged rear view of a front portion of FIG. 9;

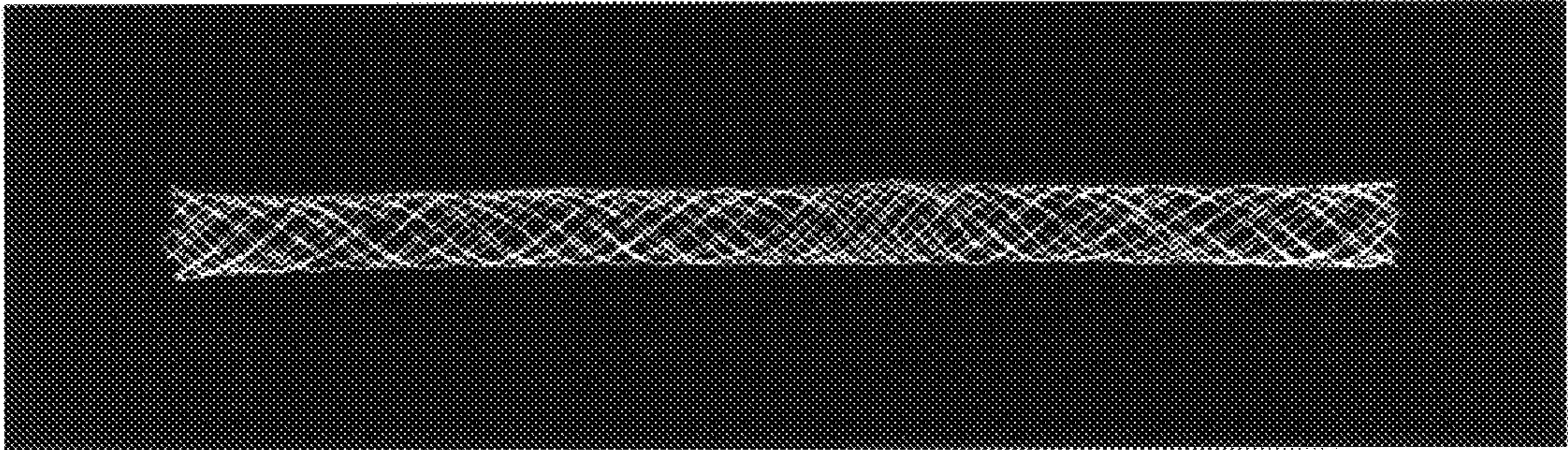

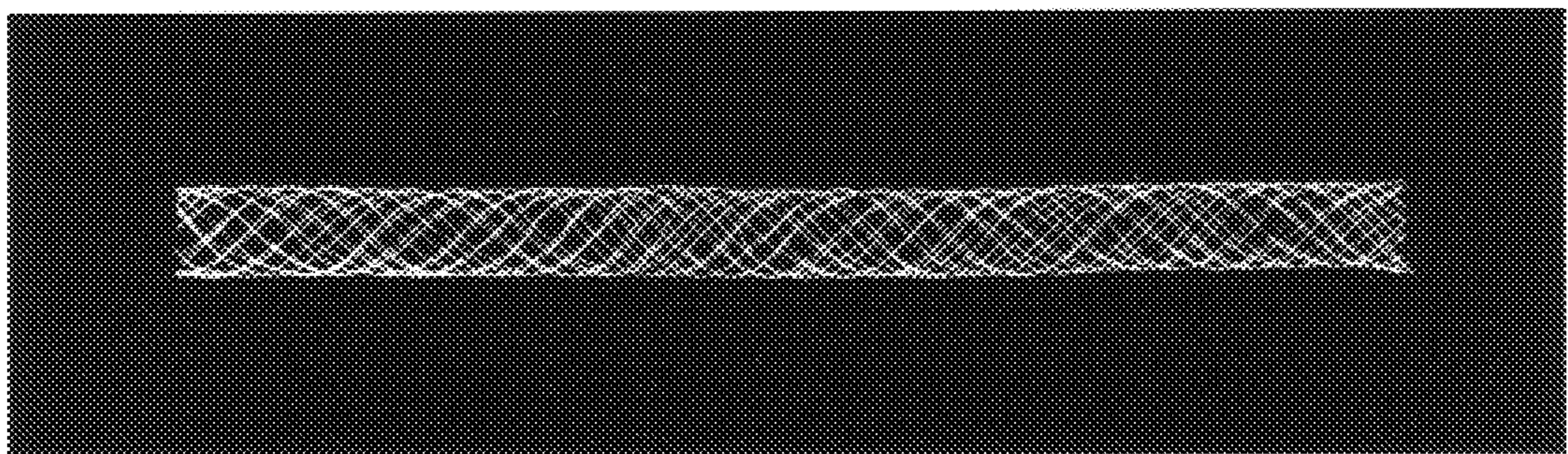

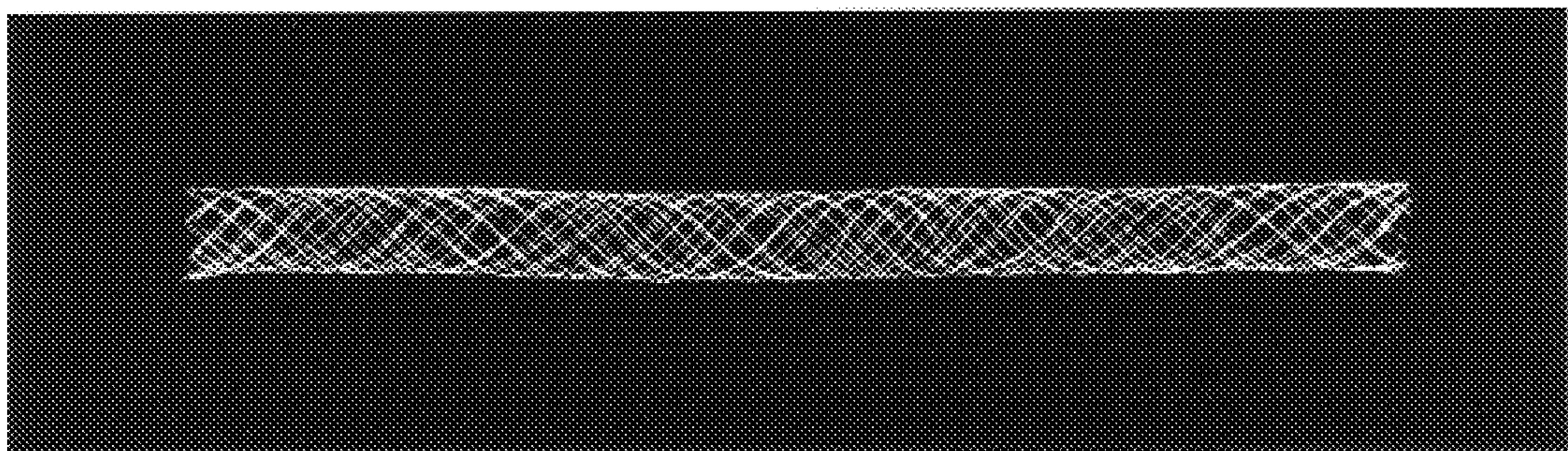

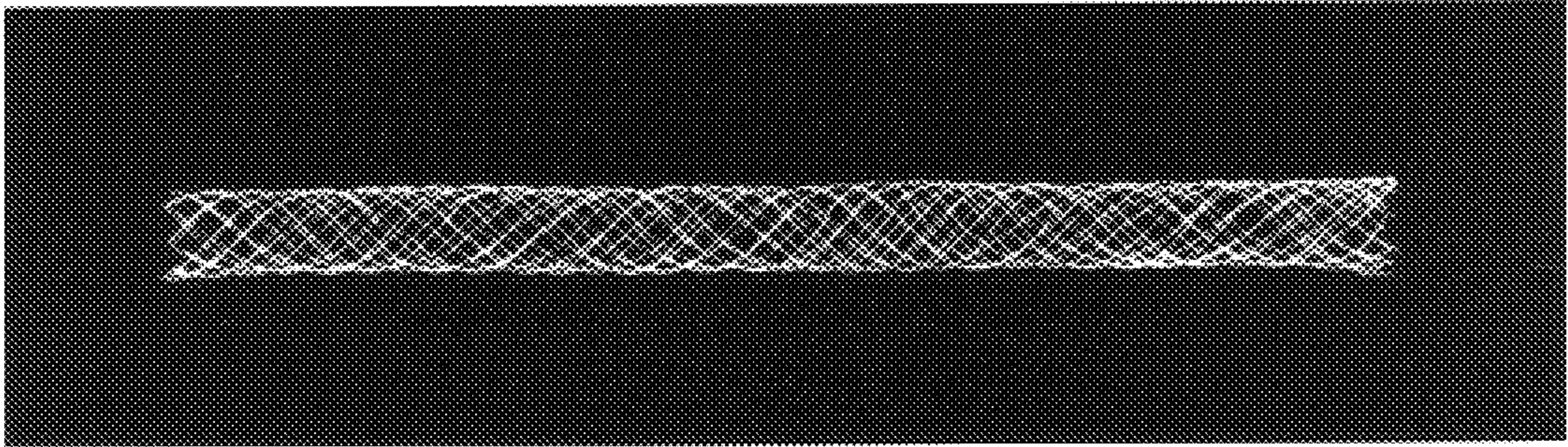

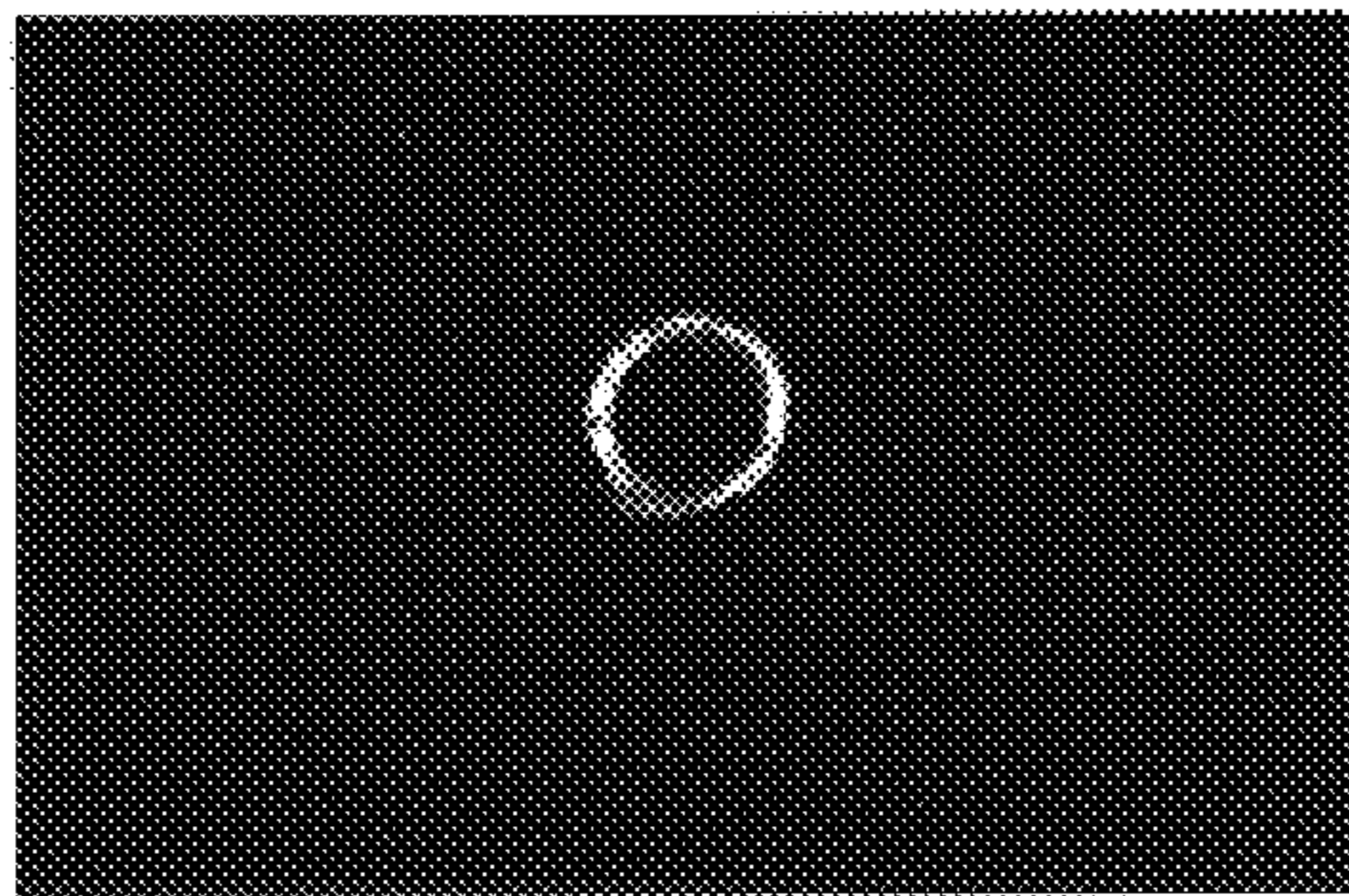

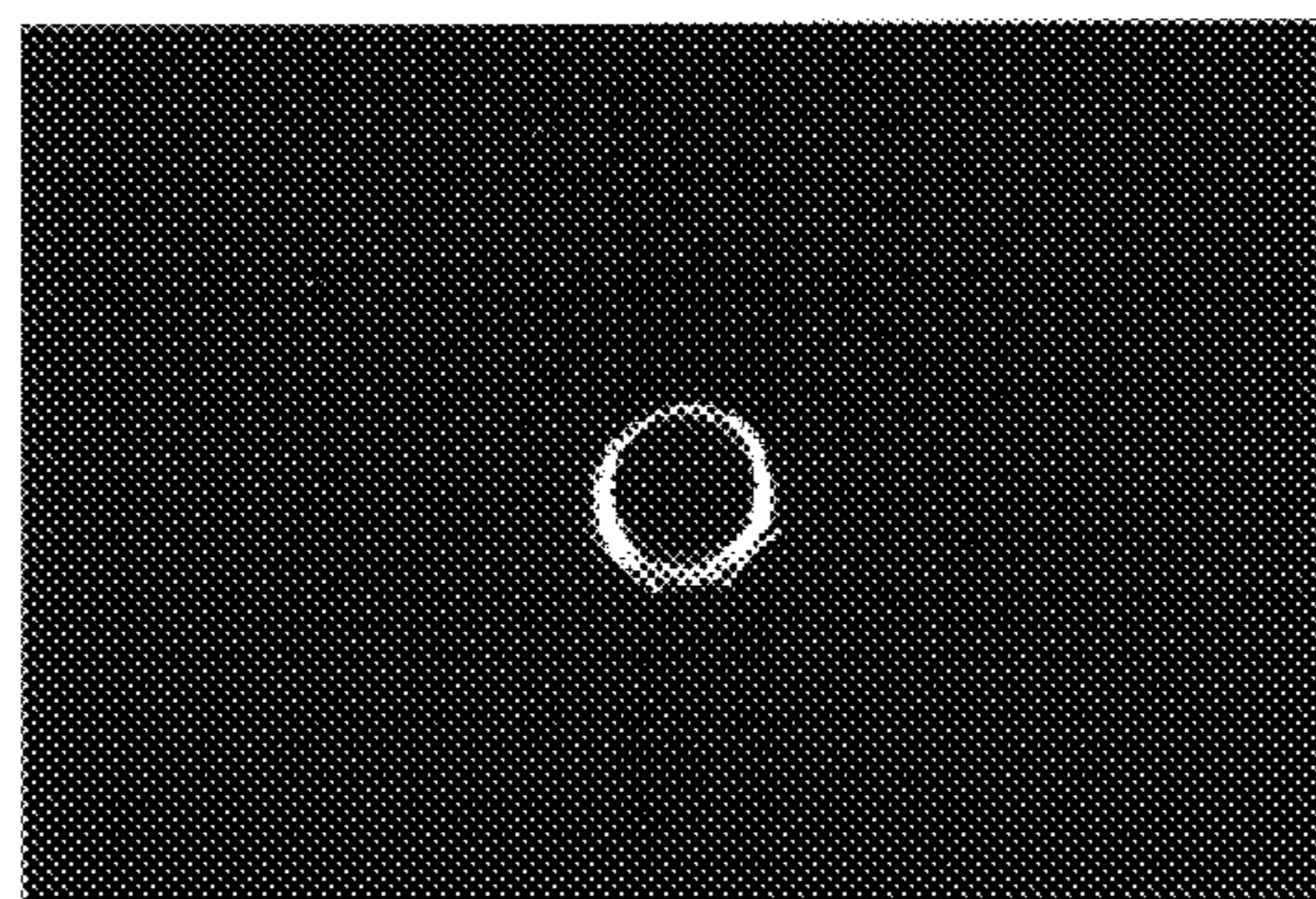

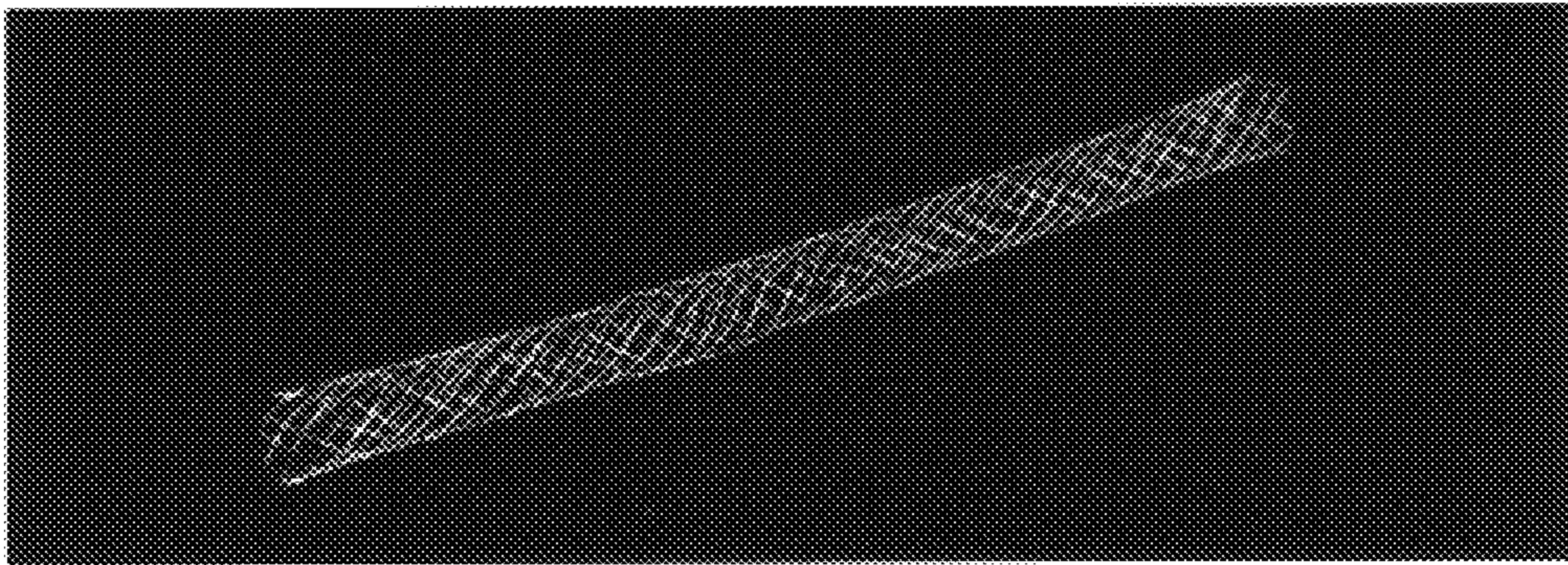

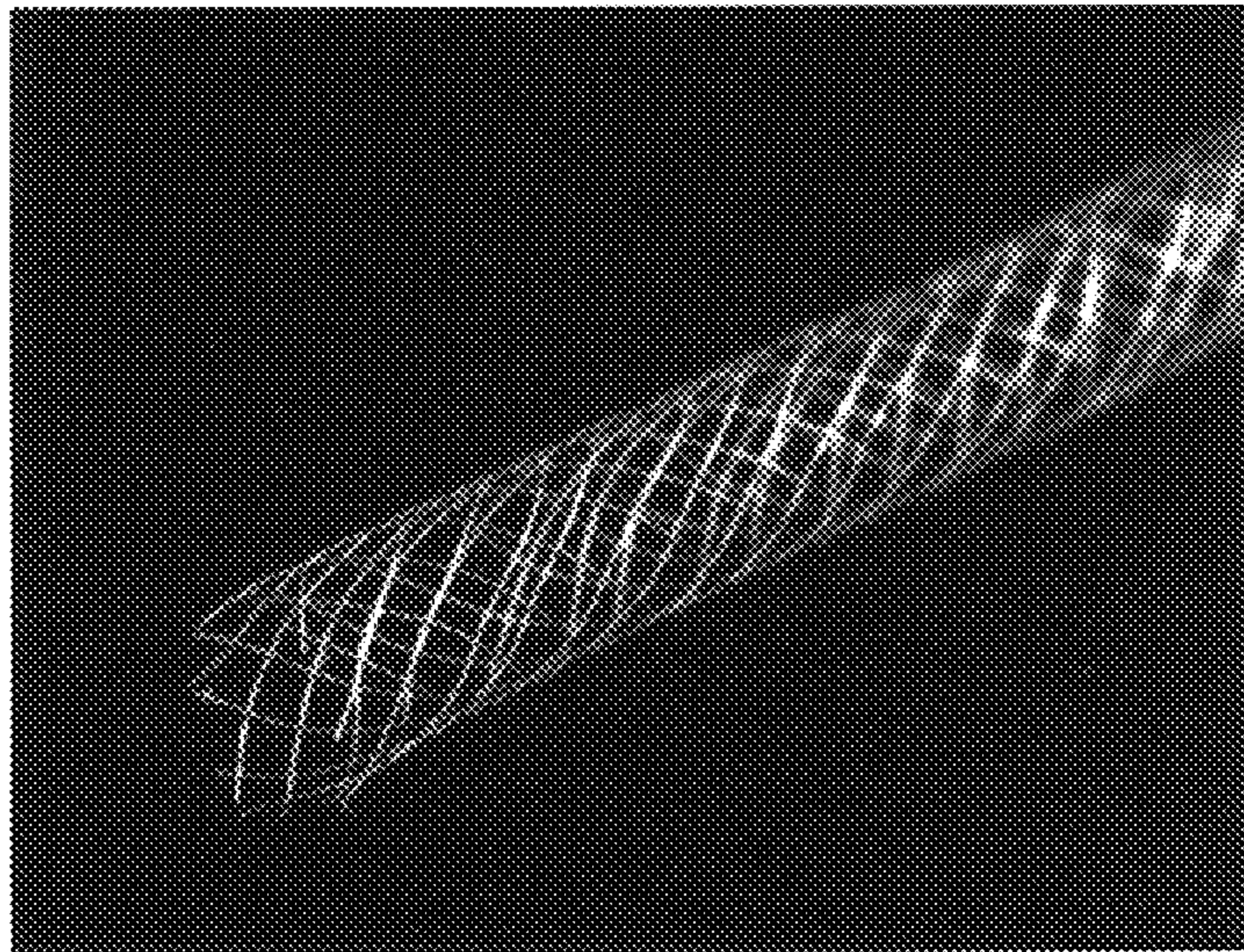

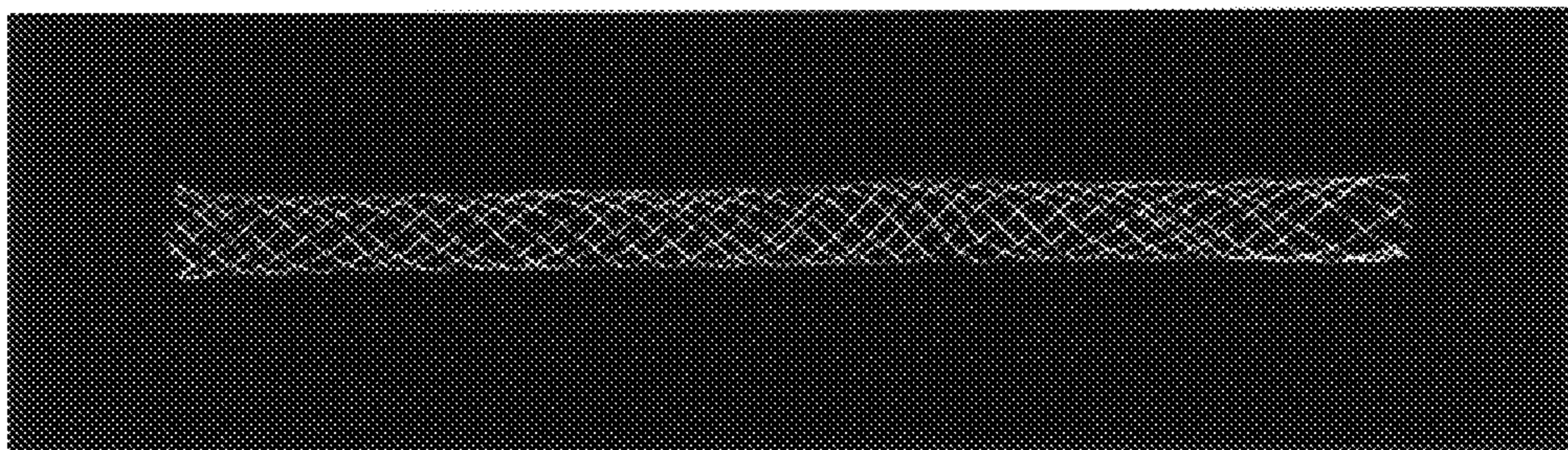

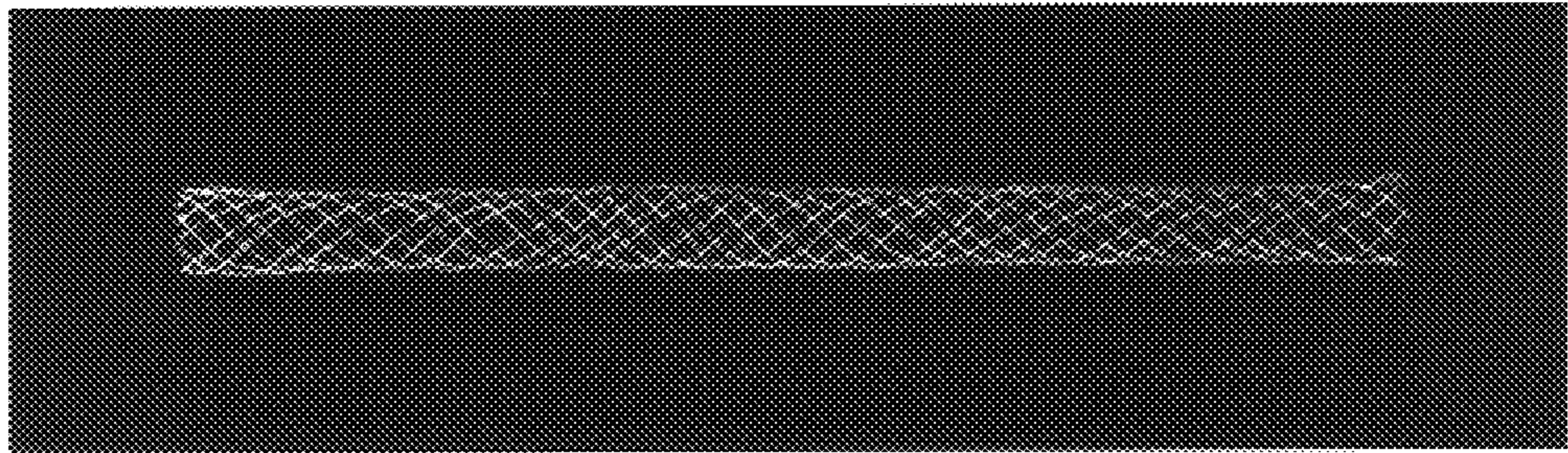

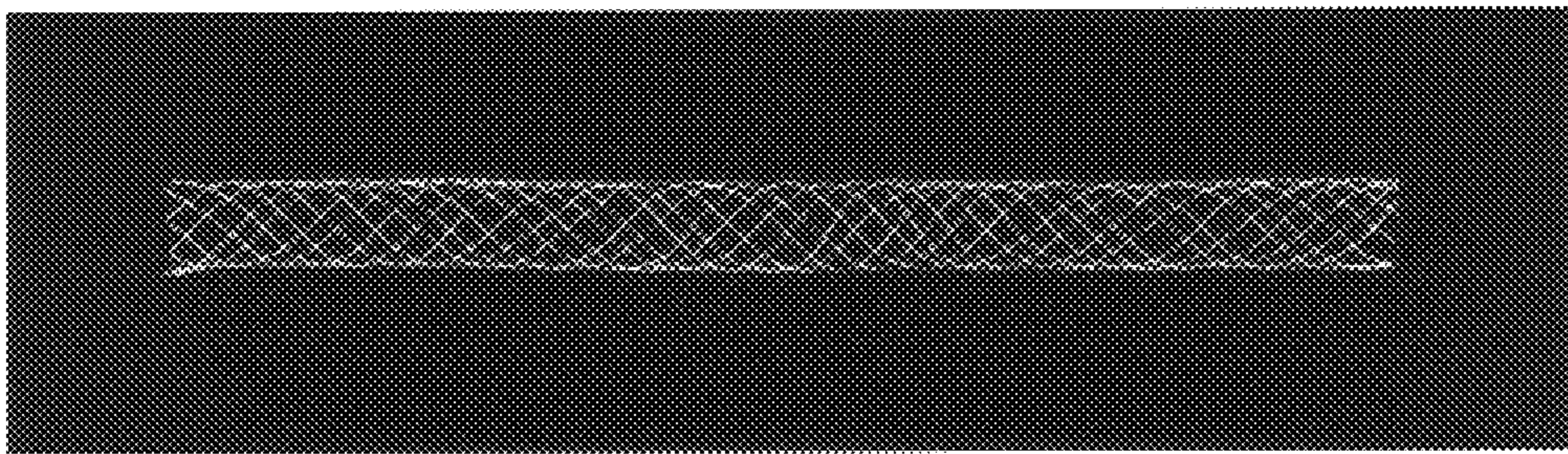

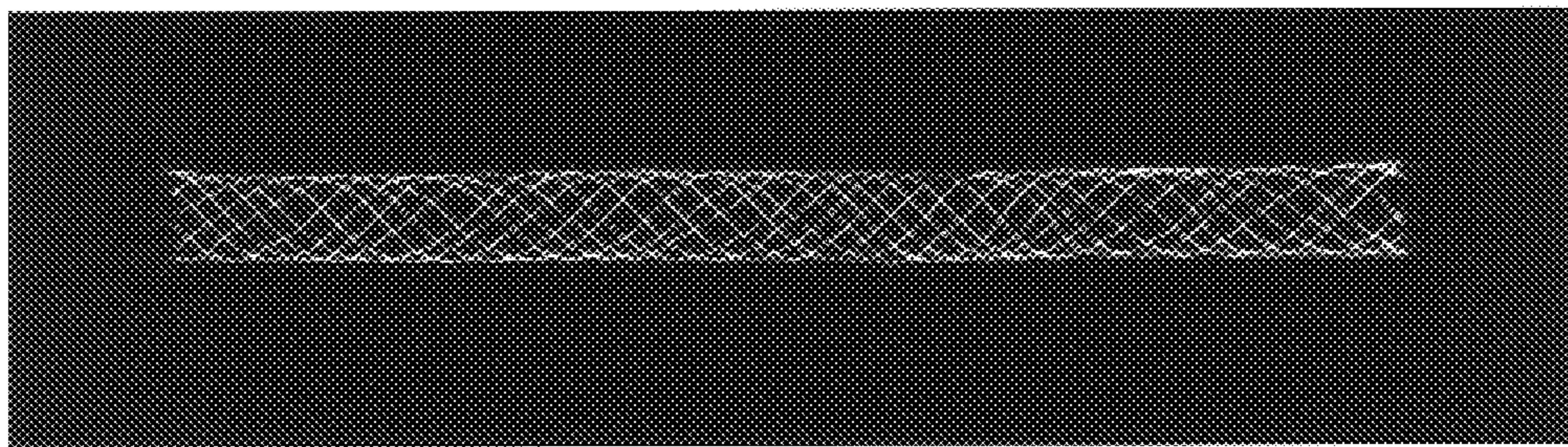
