**DESCRIPTION**

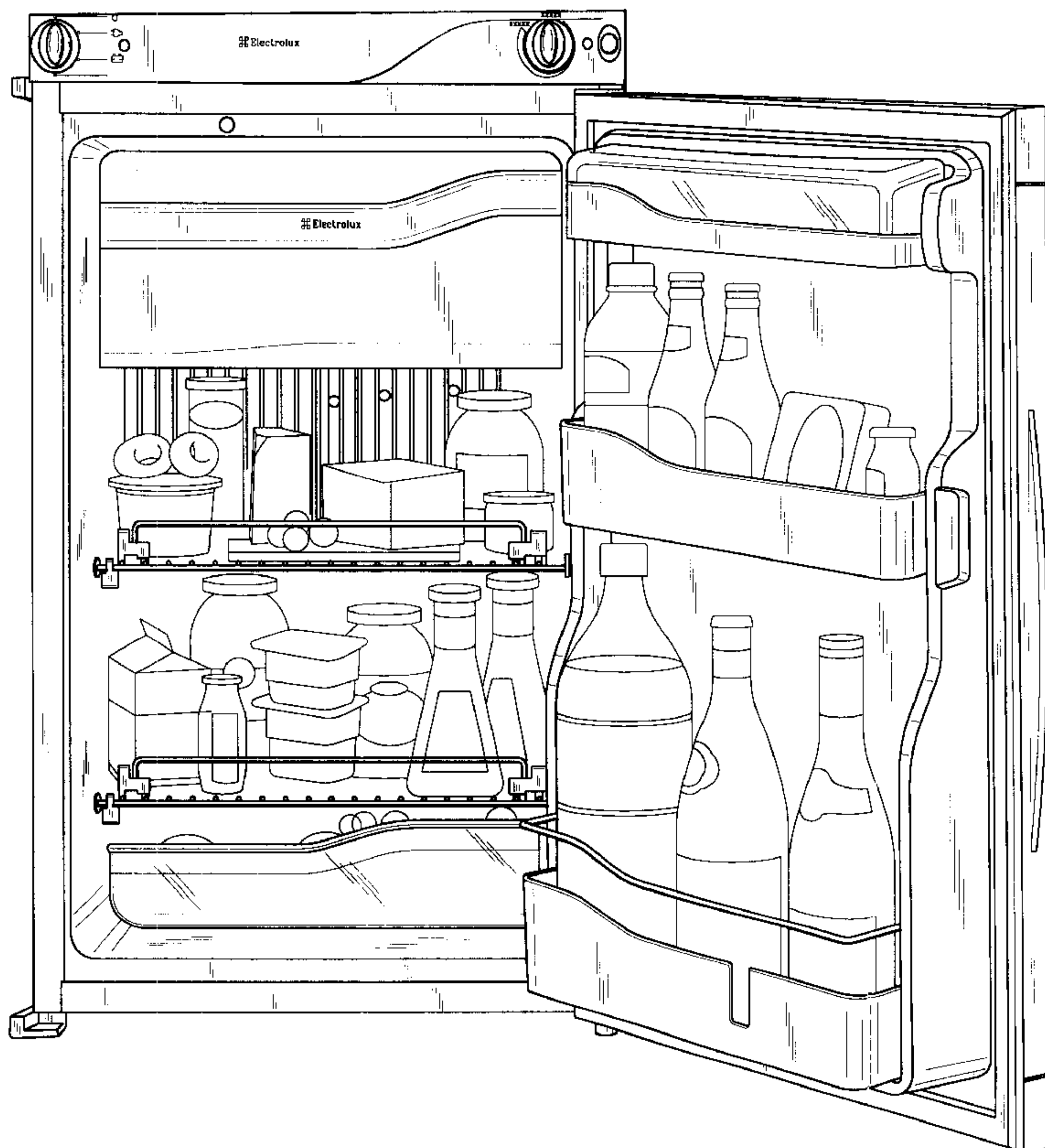
FIG. 1 is a front elevation view of an inside compartment according to a first aspect of the invention;

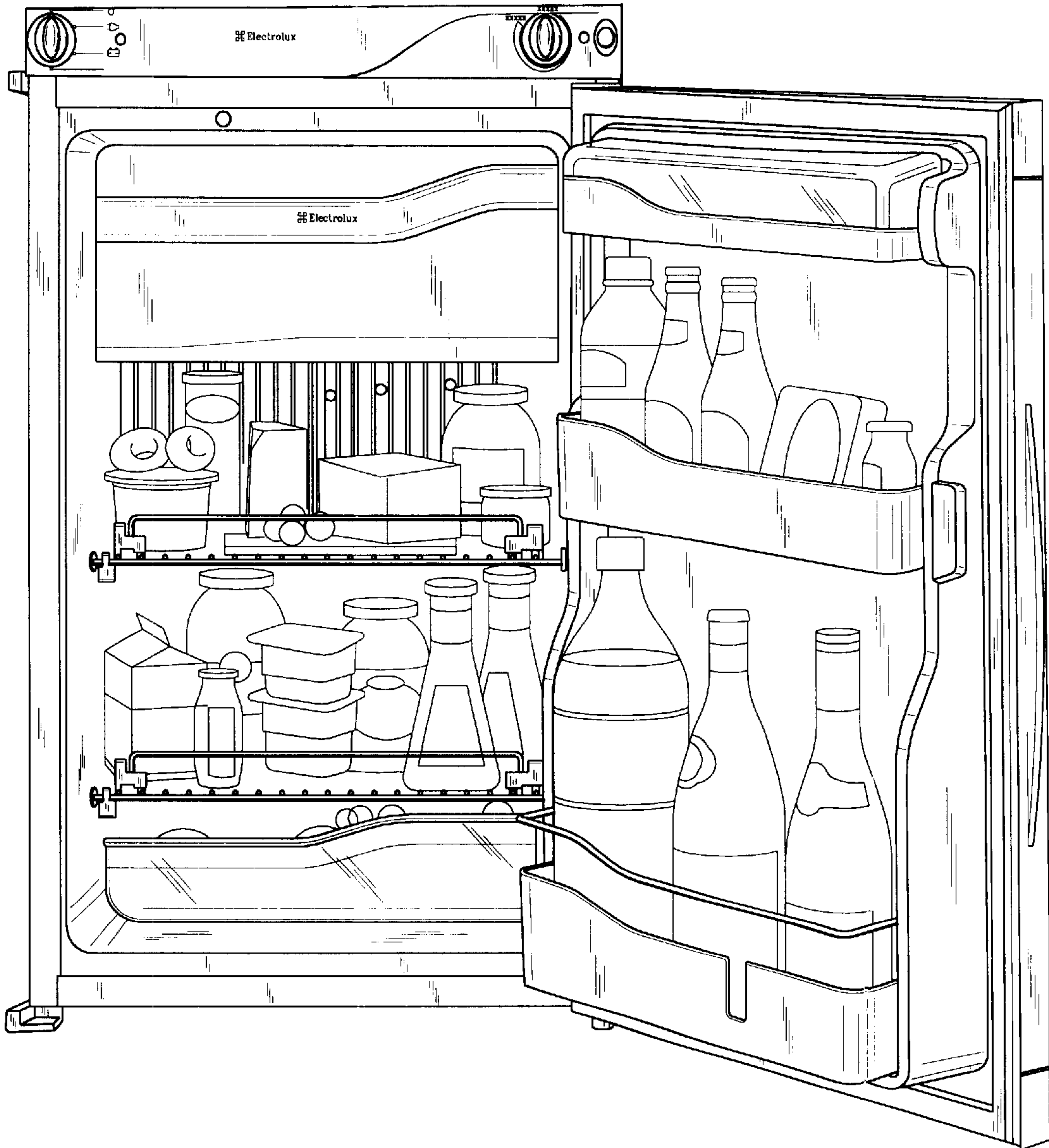

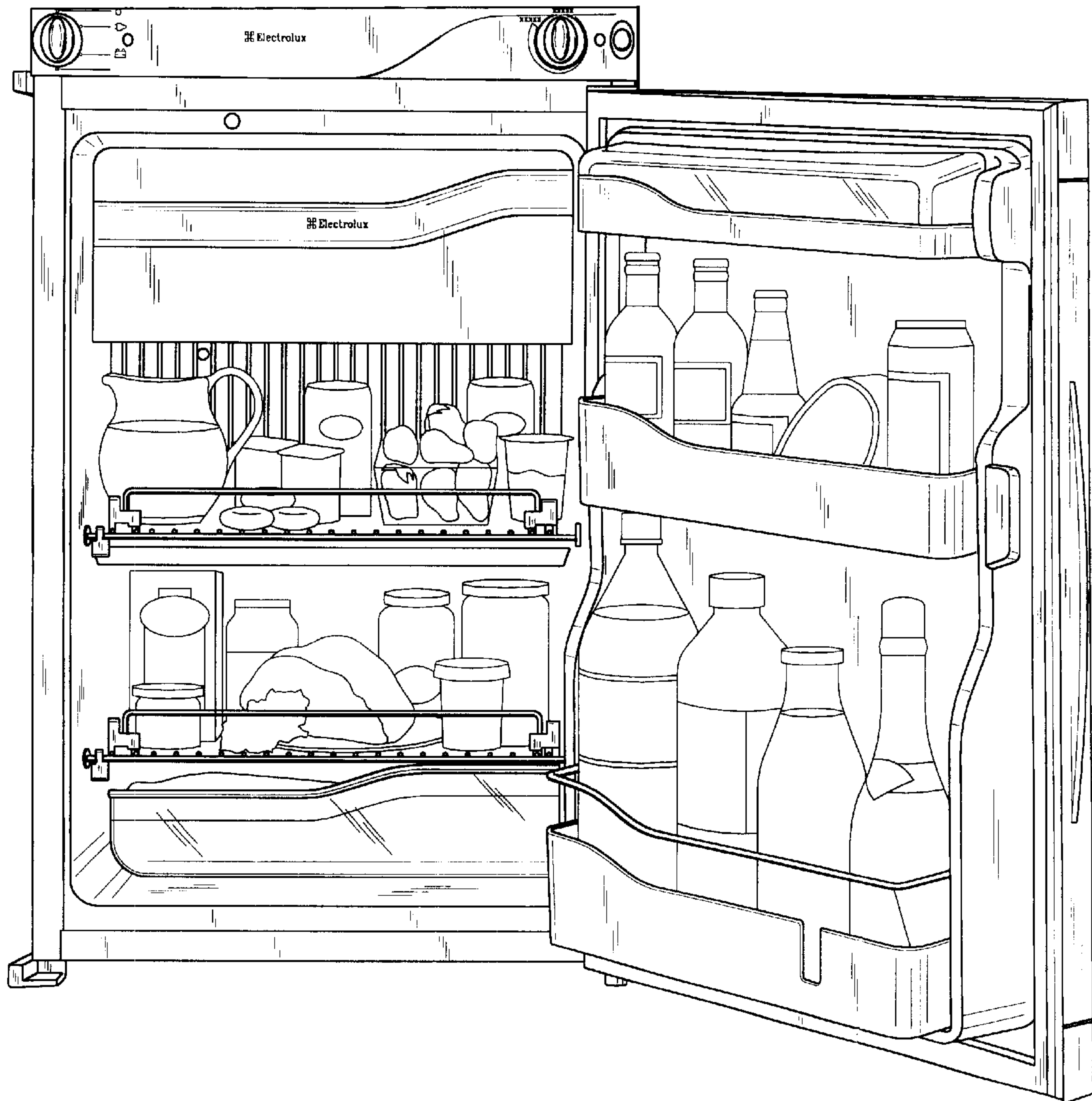

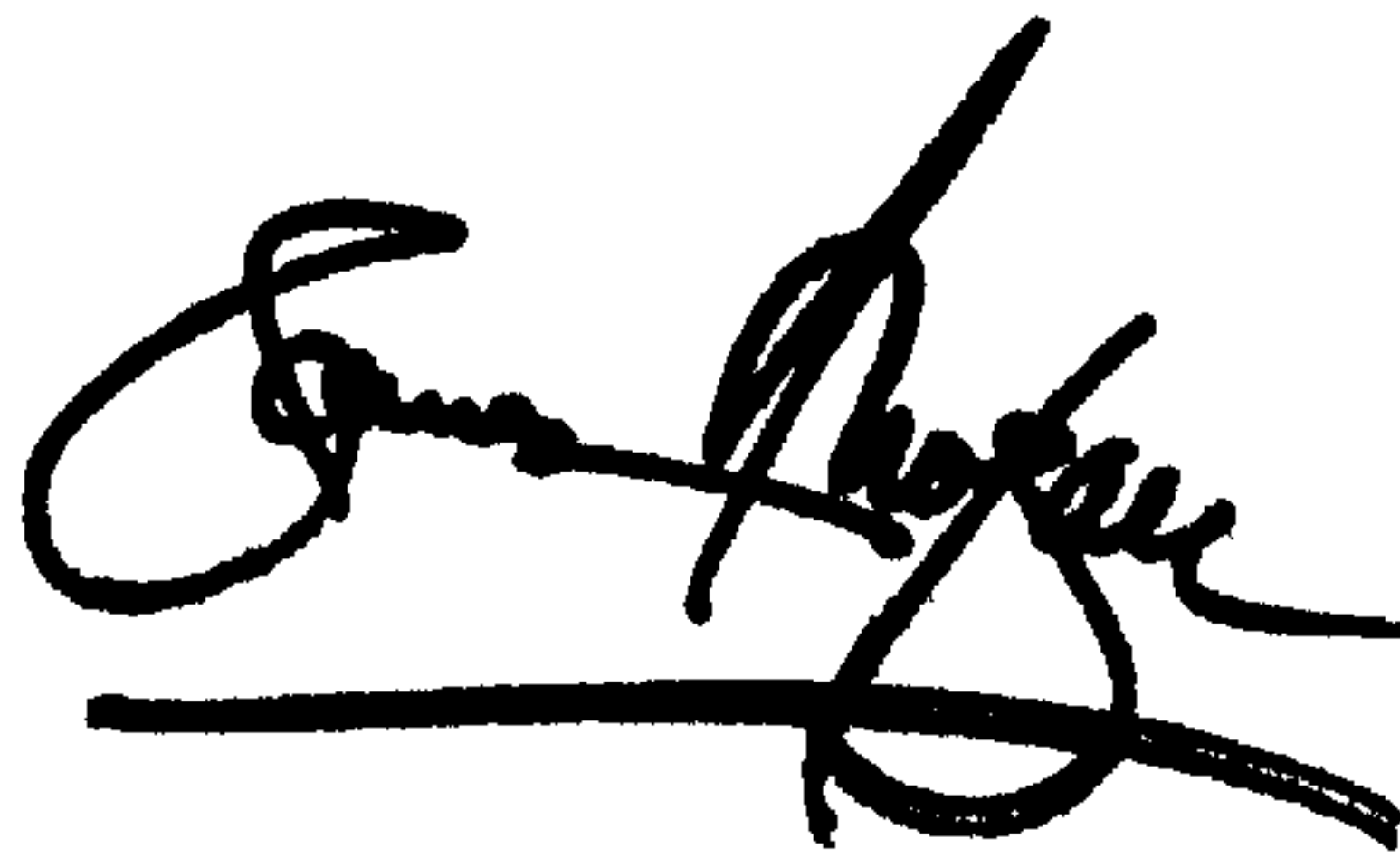
