The ornamental design for a shower escutcheon, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shower escutcheon showing my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left plan view thereof;

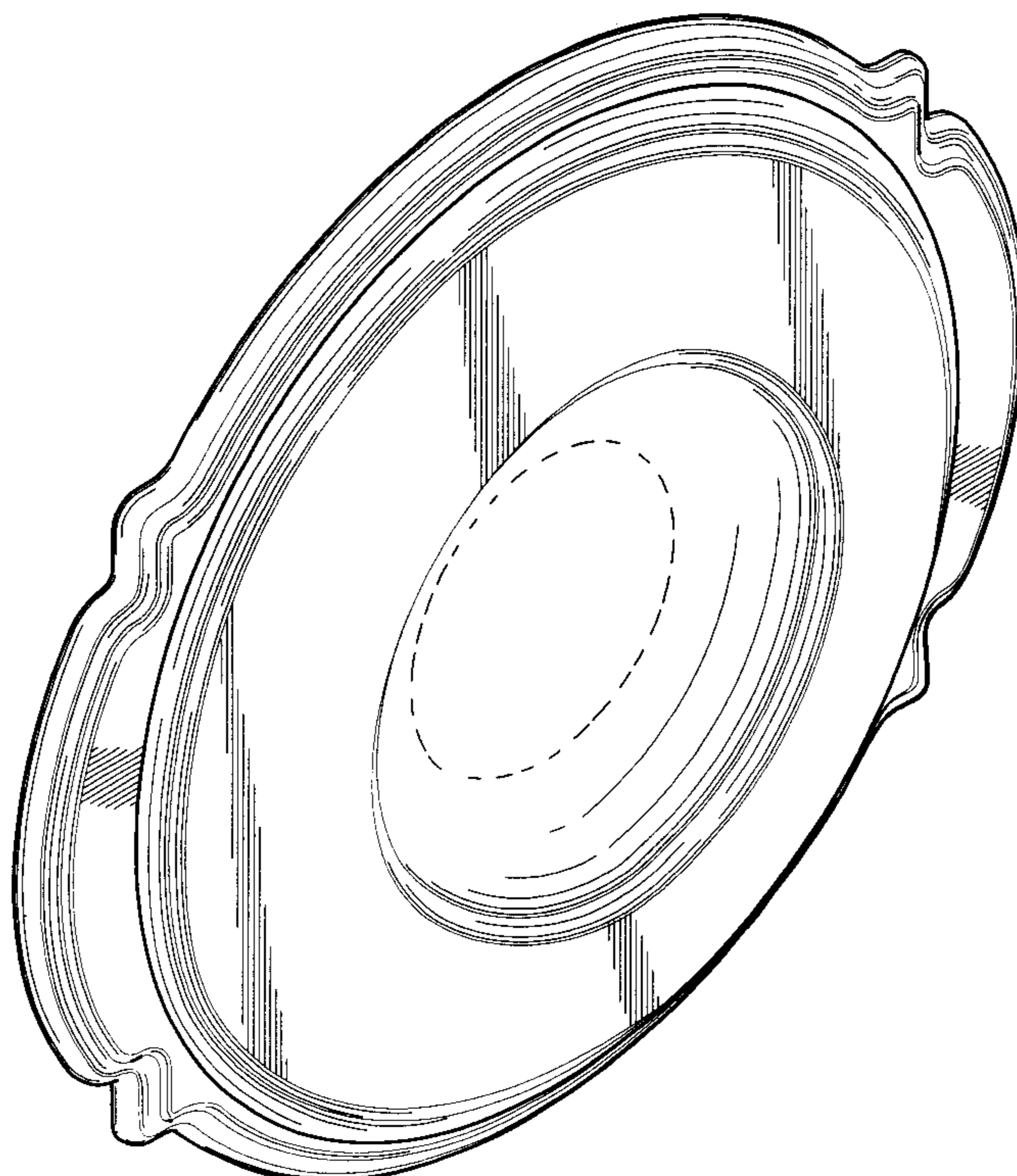
FIG. 5 is a bottom plan view thereof;

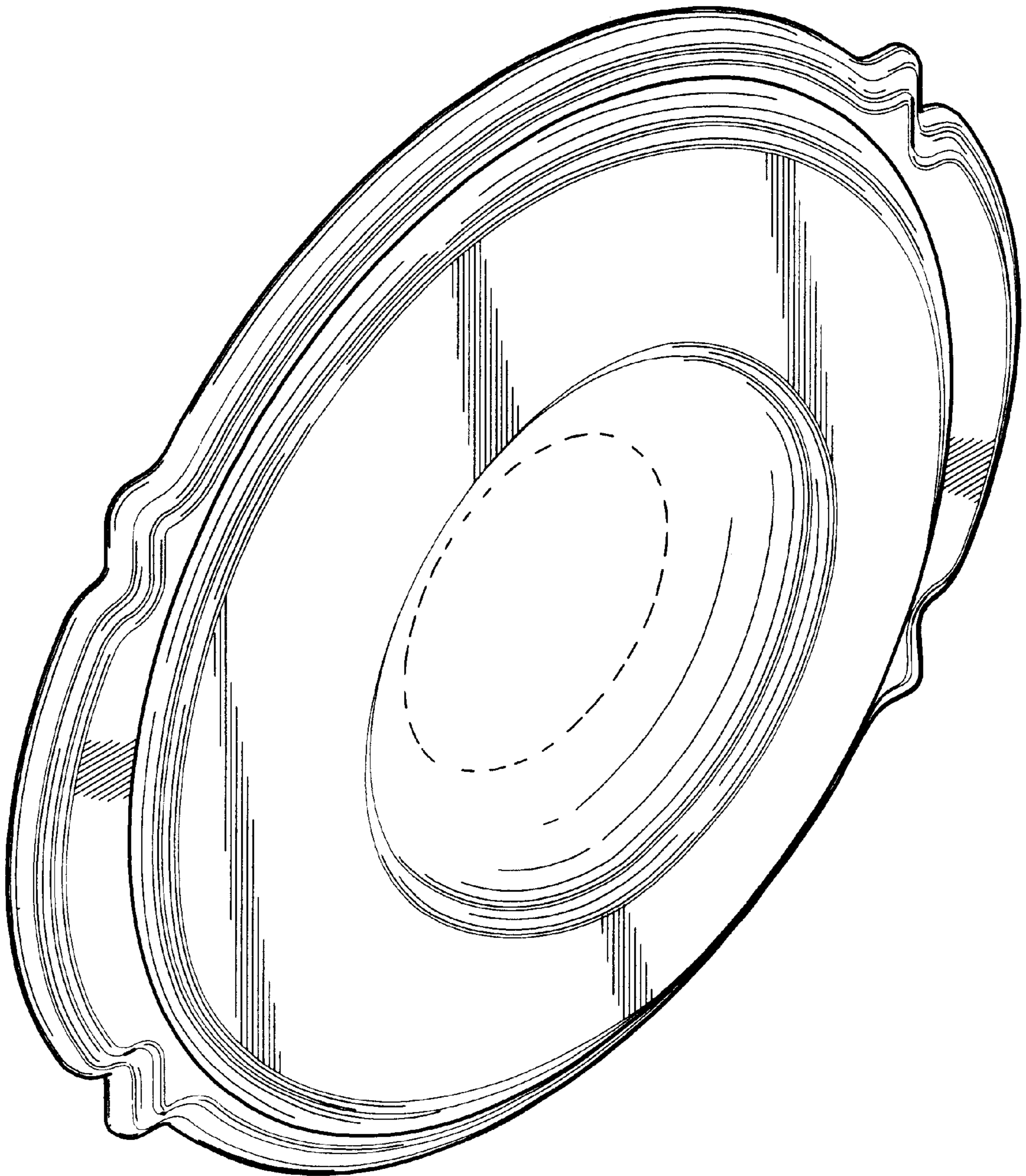

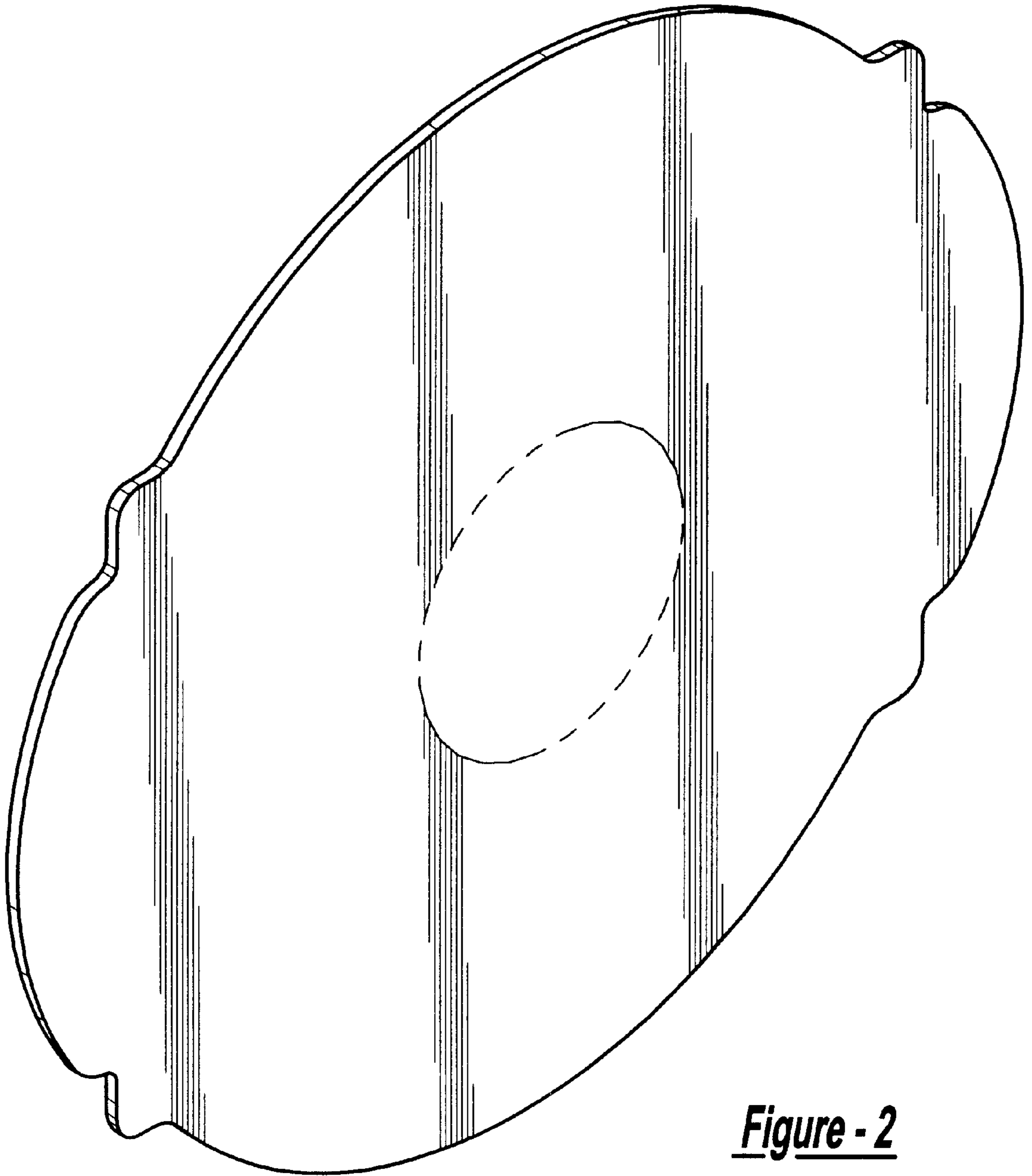

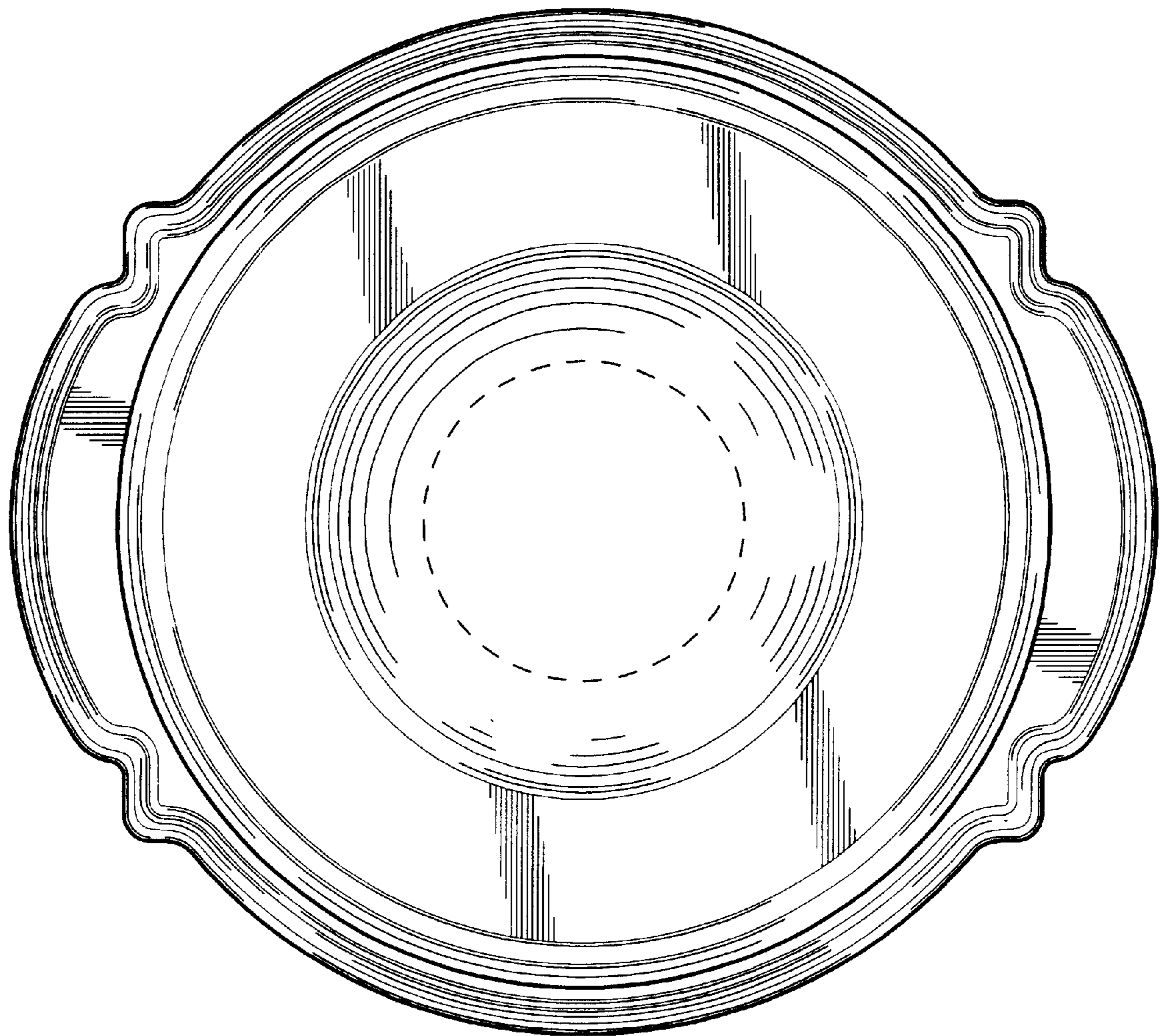

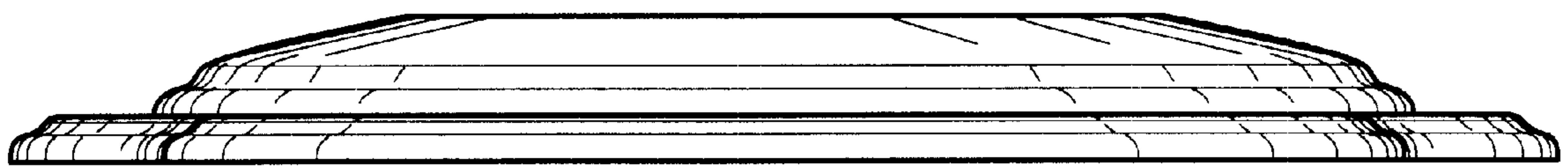

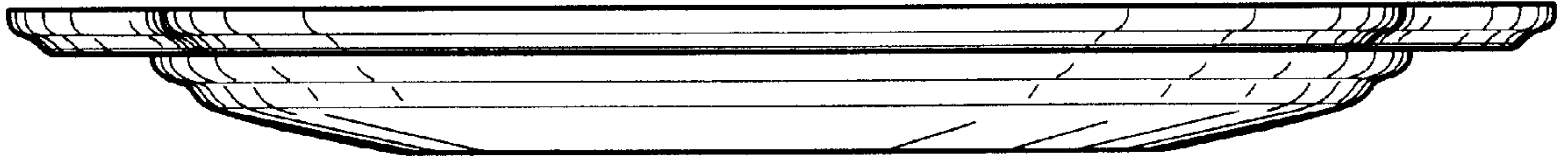

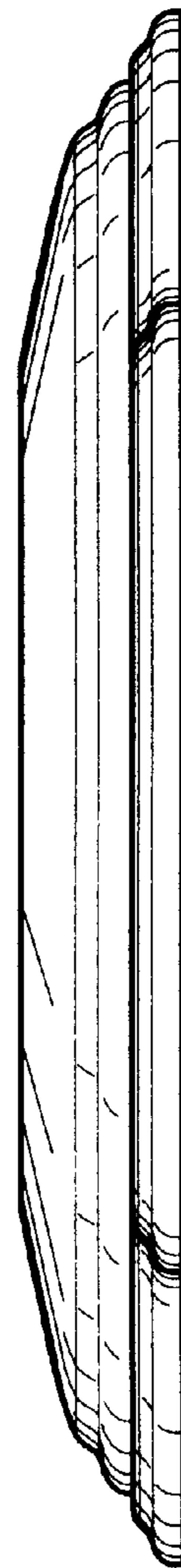
