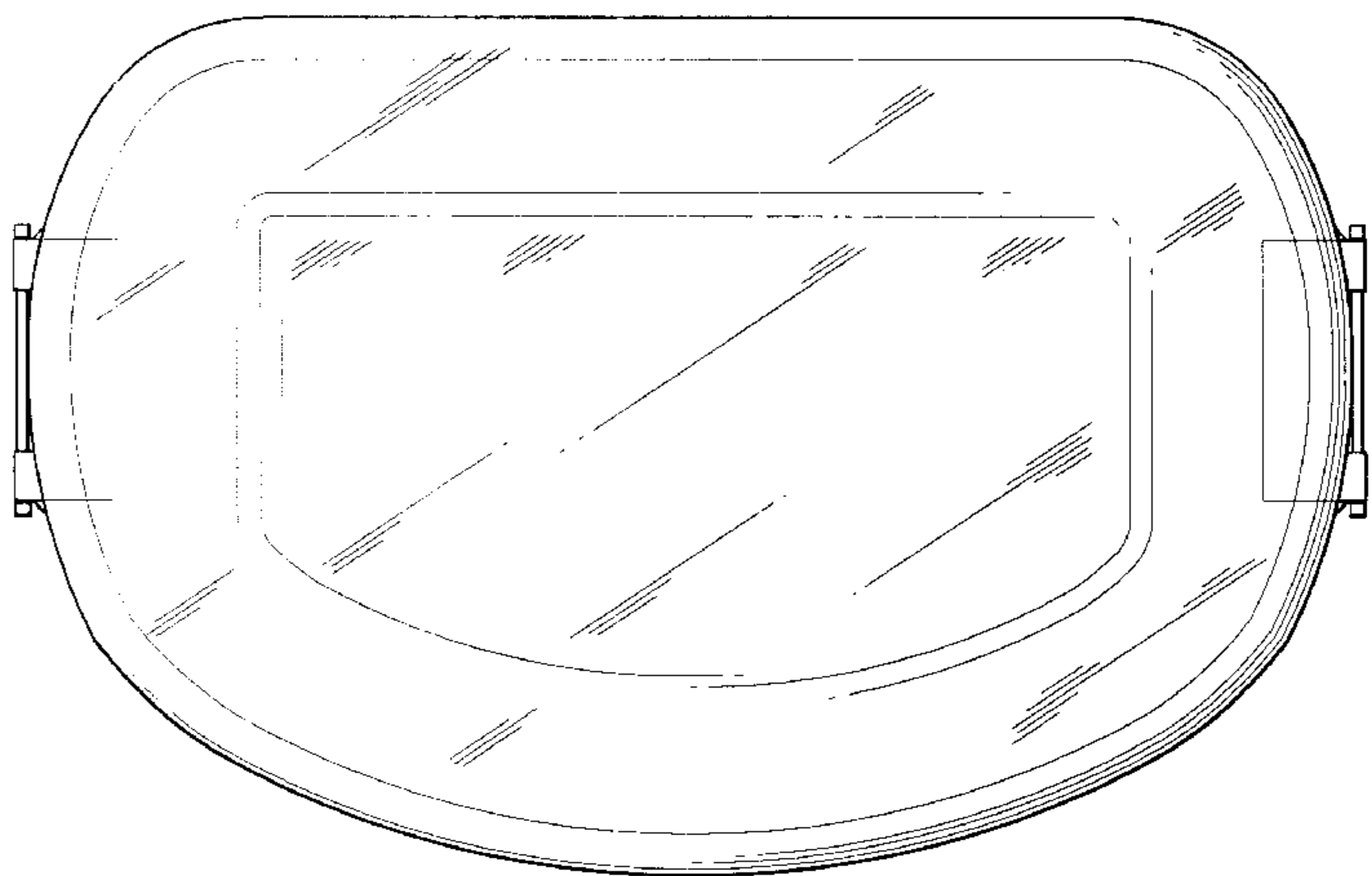
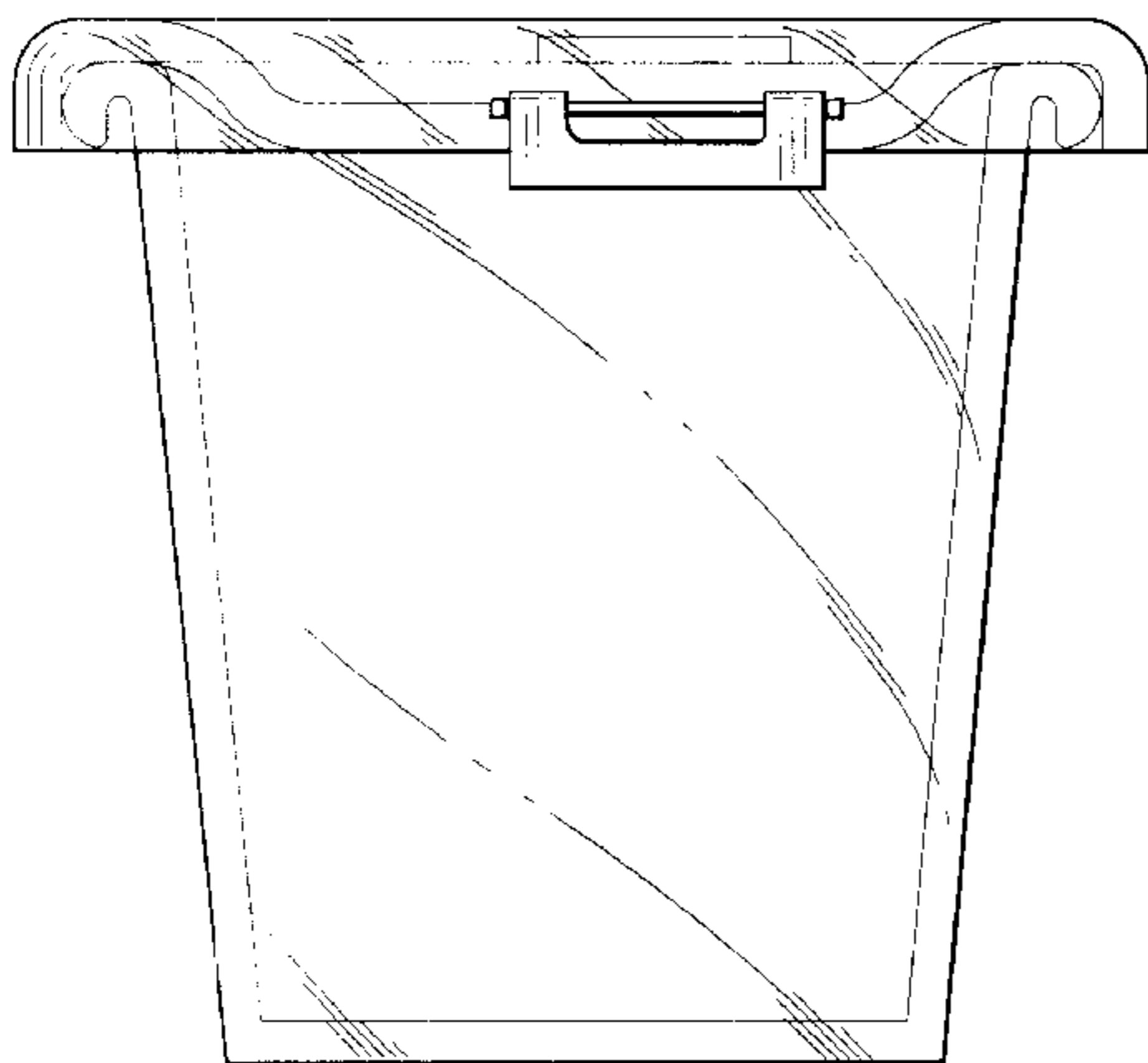
FIG. 1 is a front view of the organ cassette without a lid; FIG. 2 is a left side view of the organ cassette of FIG. 1, the opposite side view being a mirror image; FIG. 3 is a rear view of the organ cassette of FIG. 1, the arrangement of the holes shown in broken lines making up no part of the ornamentality of the claimed design; FIG. 4 is a top view of the organ cassette of FIG. 1; FIG. 5 is a bottom view of the organ cassette of FIG. 1; FIG. 6 is a left side view of the organ cassette with a lid, the opposite side view being a mirror image; FIG. 7 is a front view of the lid; FIG. 8 is a rear view of the lid of FIG. 7; FIG. 9 is a left side view of the lid of FIG. 7, the opposite side view being a mirror image; and, FIG. 10 is a top view of the lid of FIG. 7. The undersurface of the lid contains no ornamentality that is part of the claimed design.

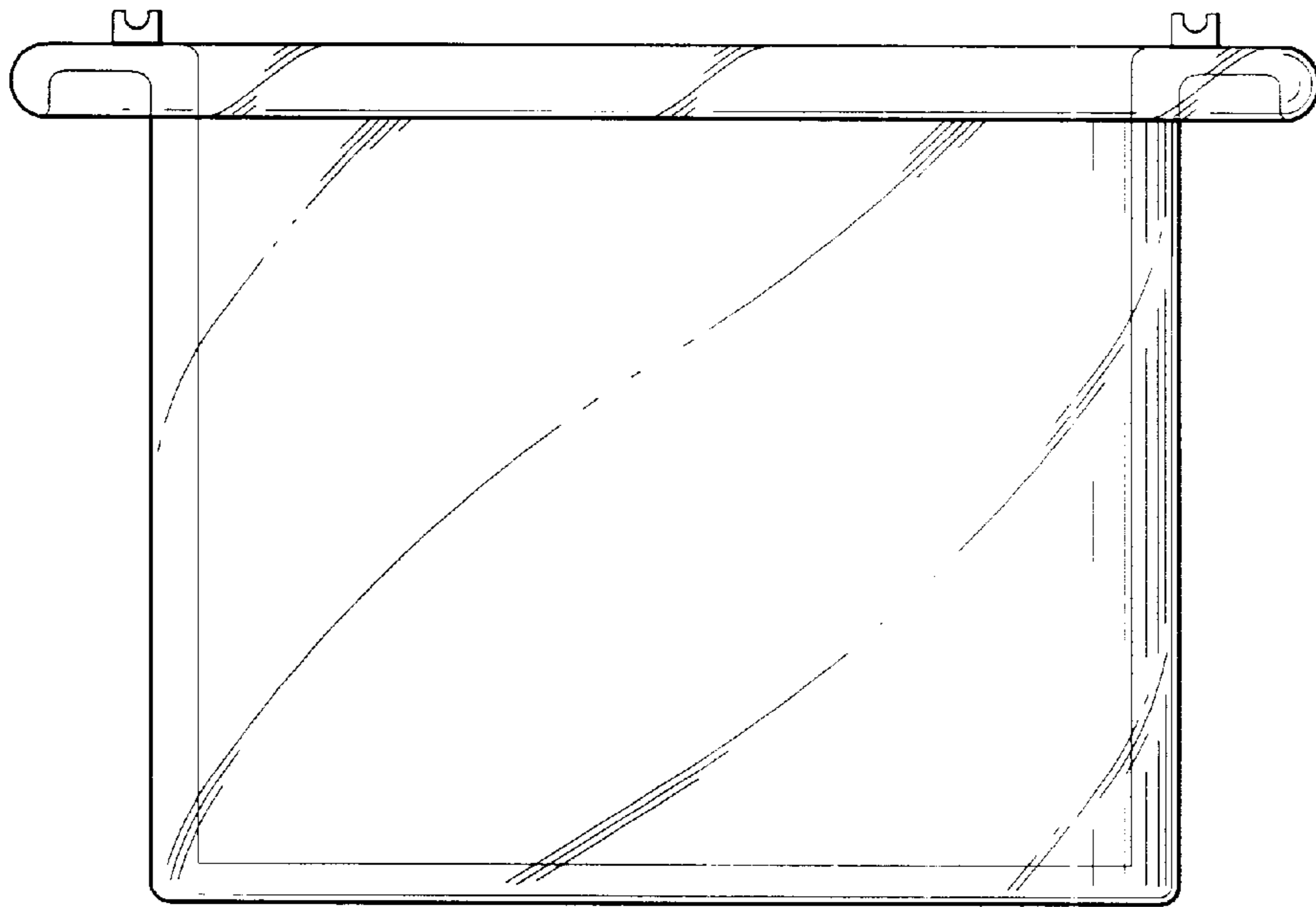

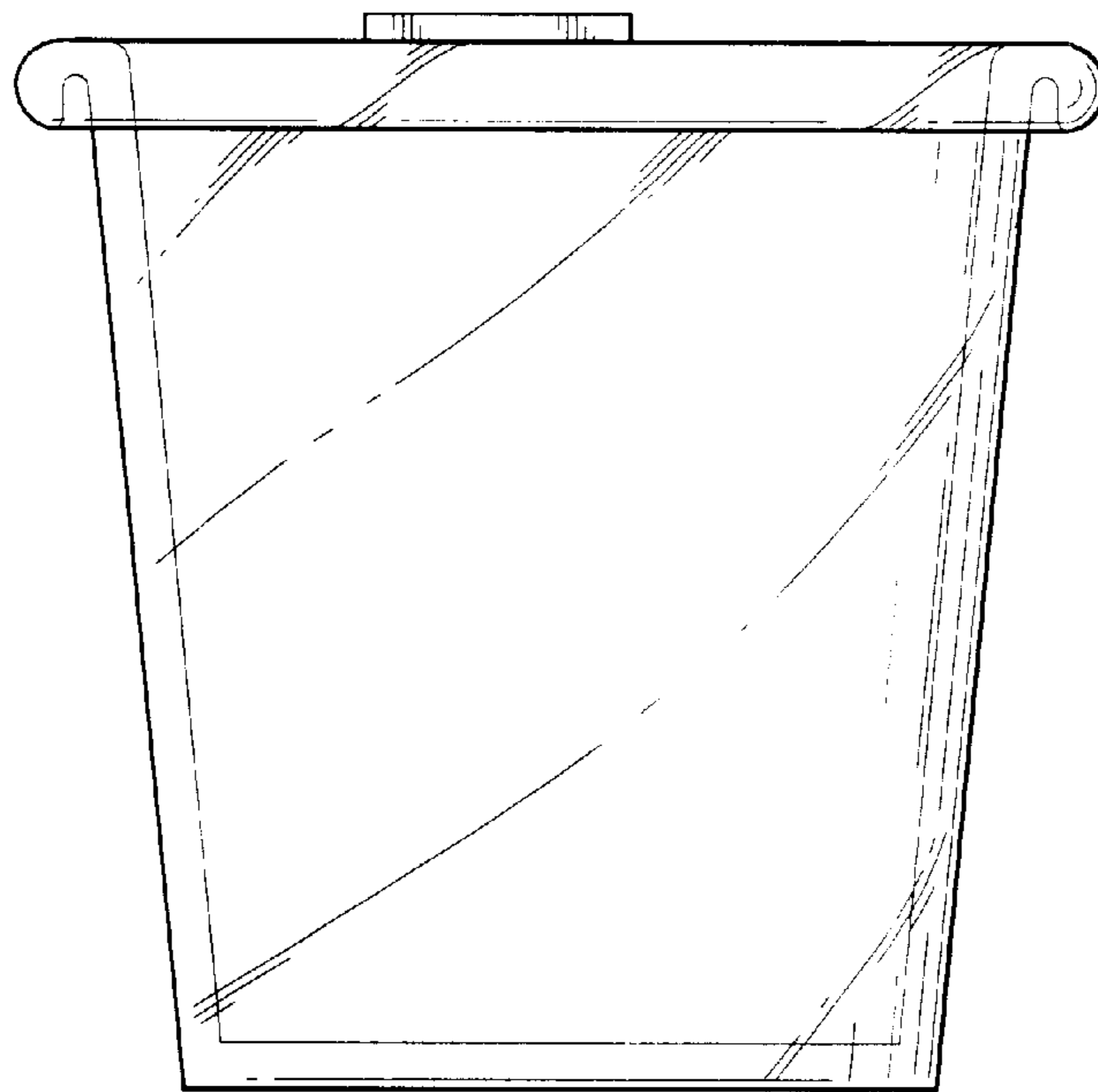

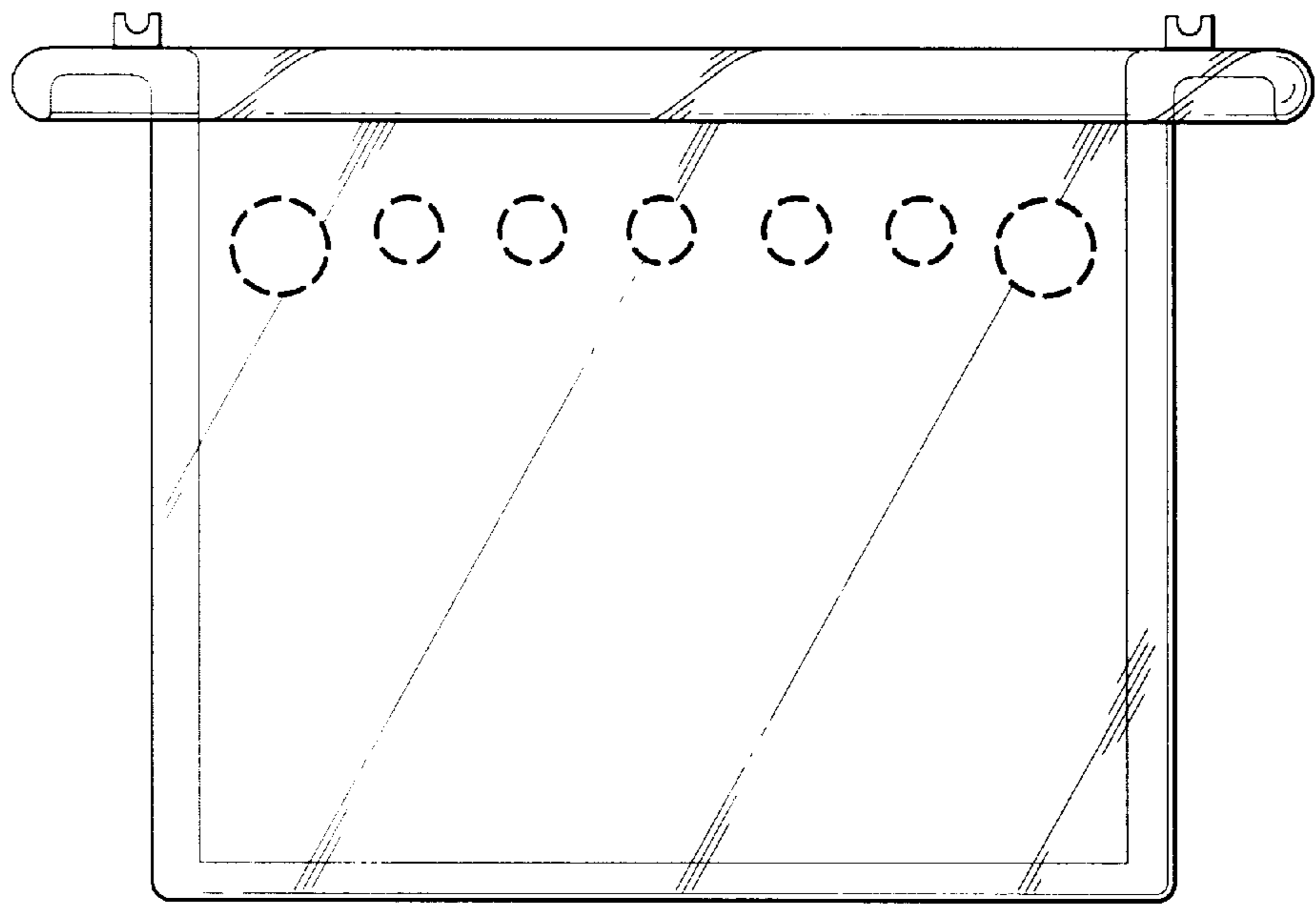

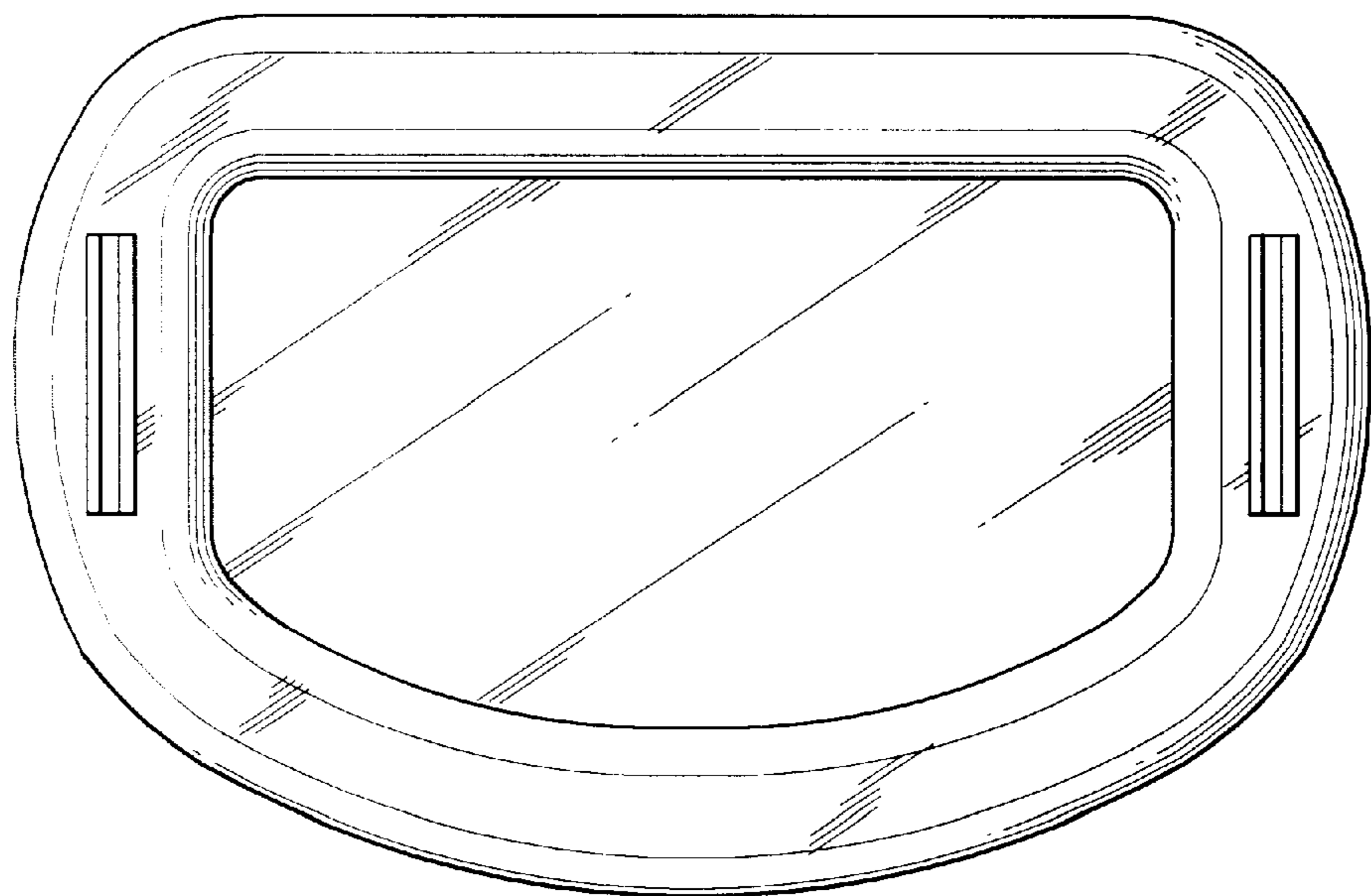

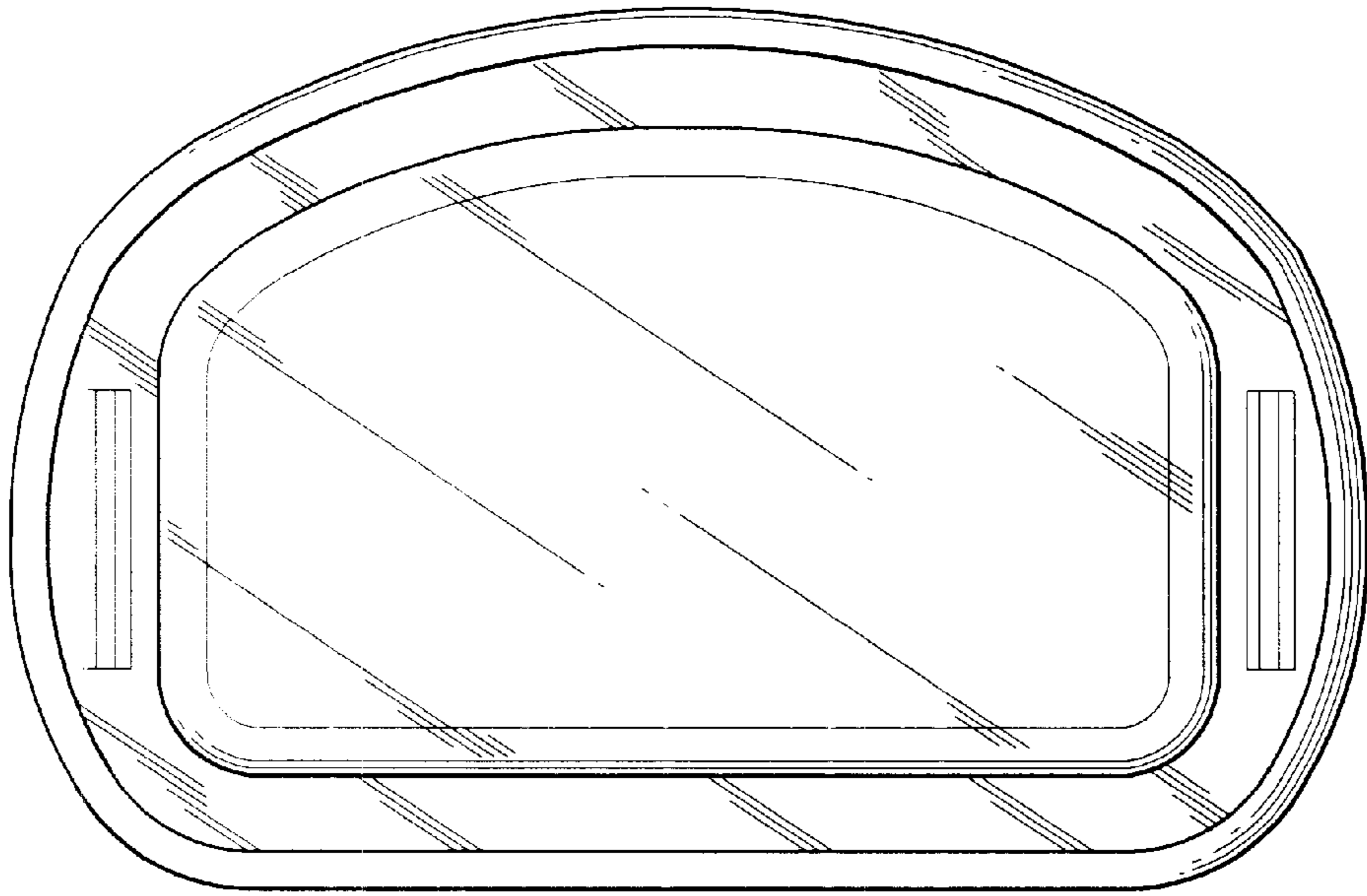

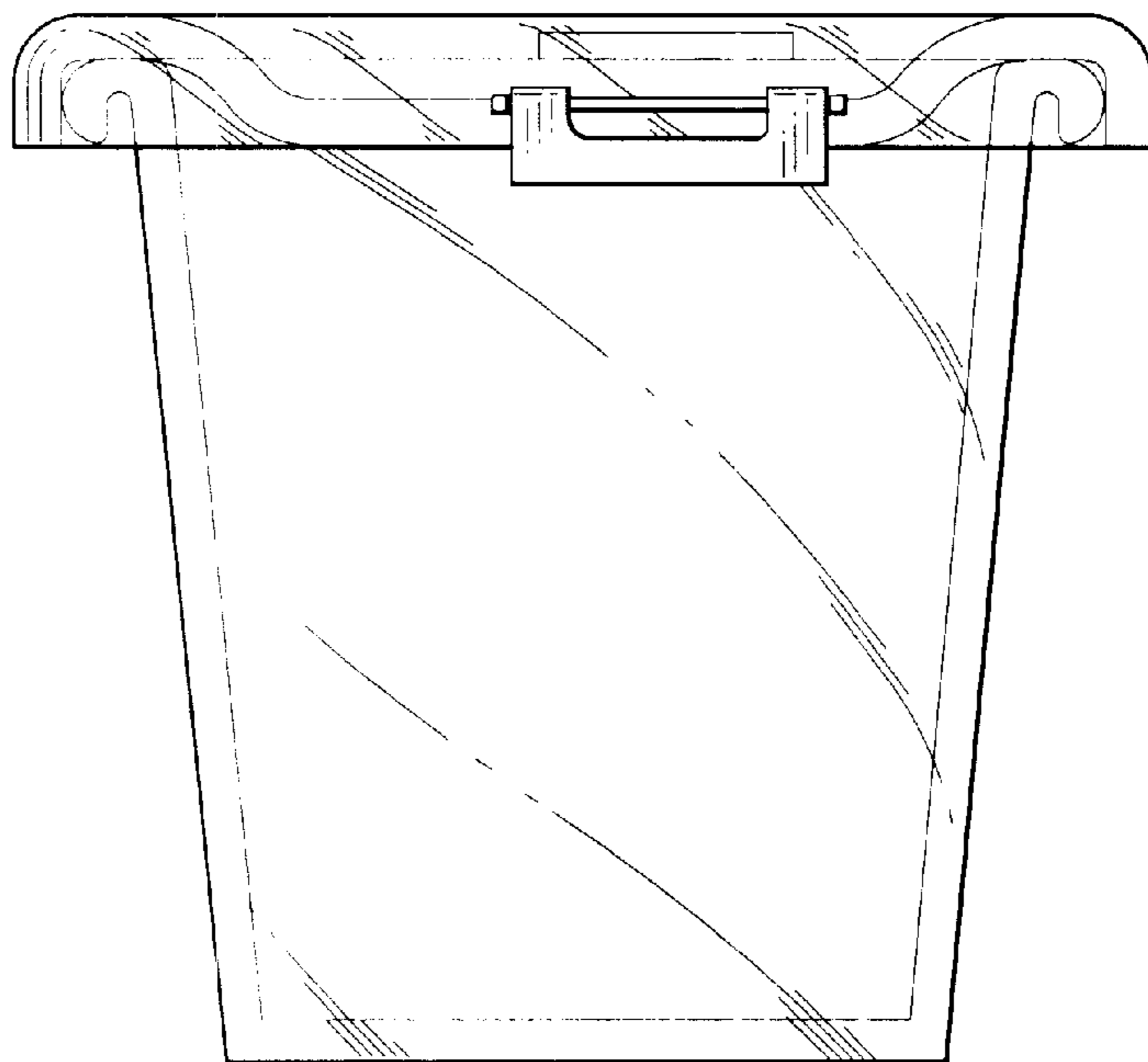

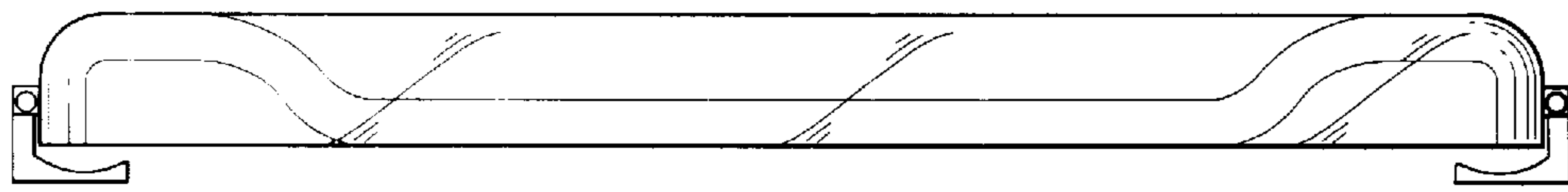

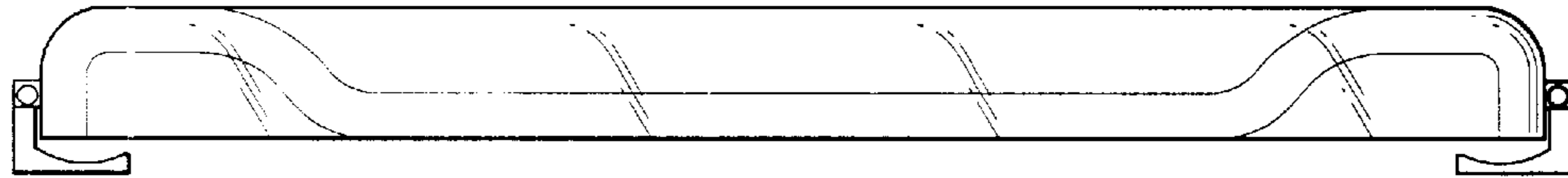

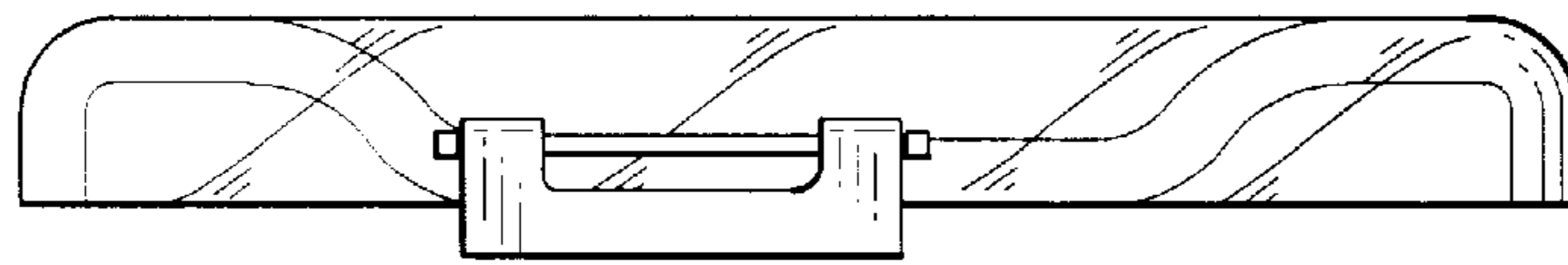

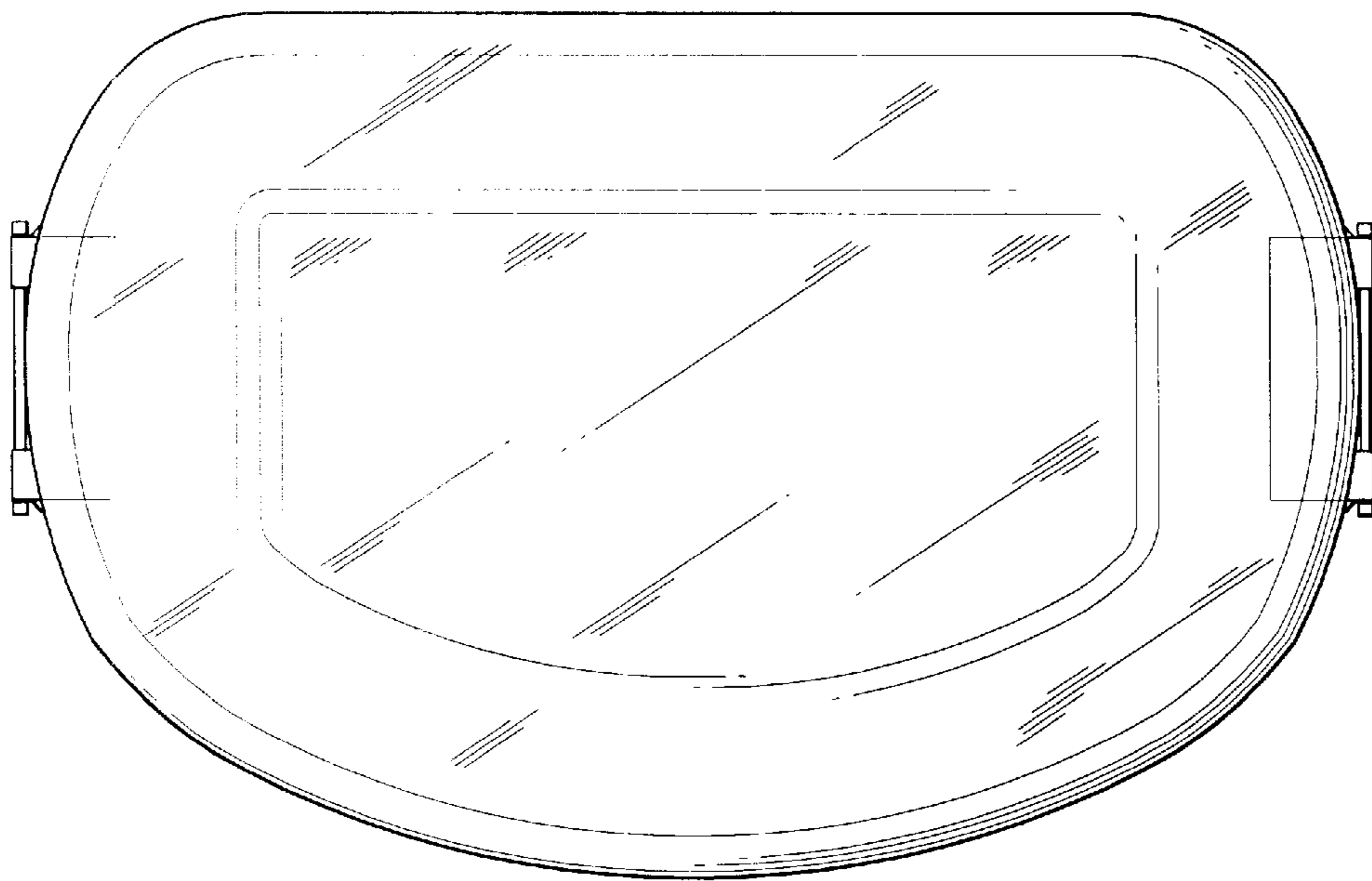
