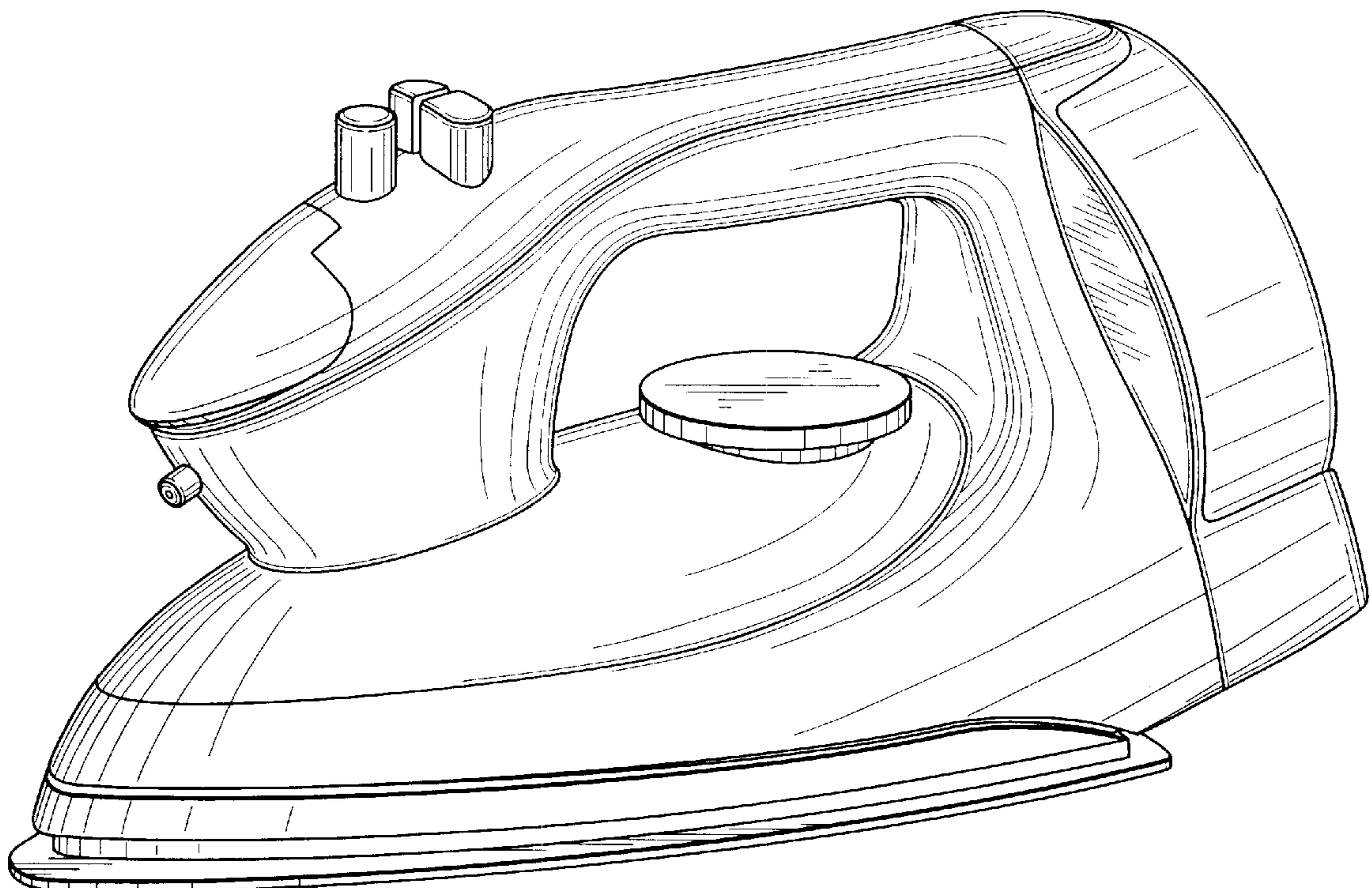

The ornamental design for an electric iron, as shown and described.

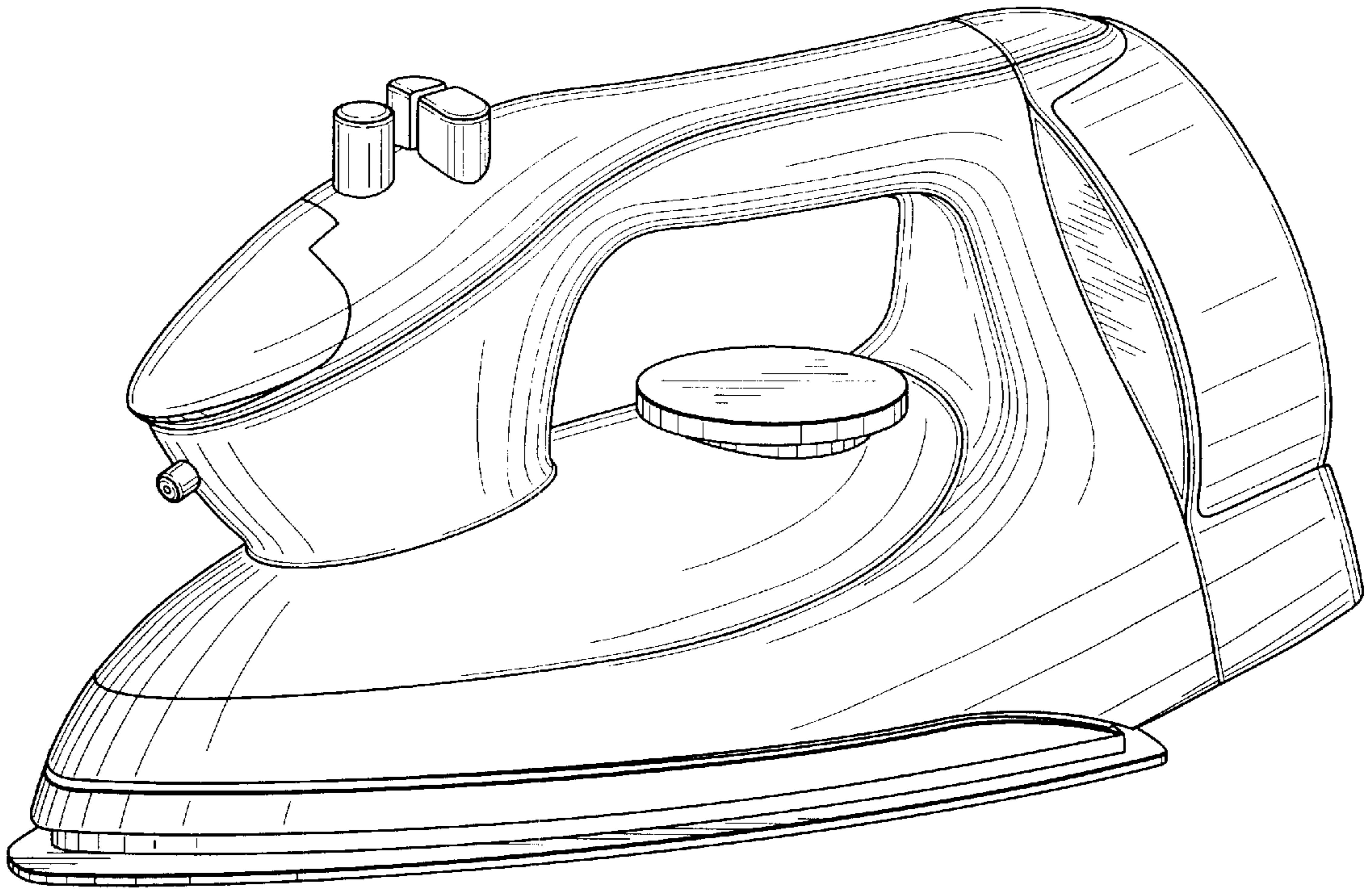
**DESCRIPTION**

 FIG. 7 is a left side view thereof.

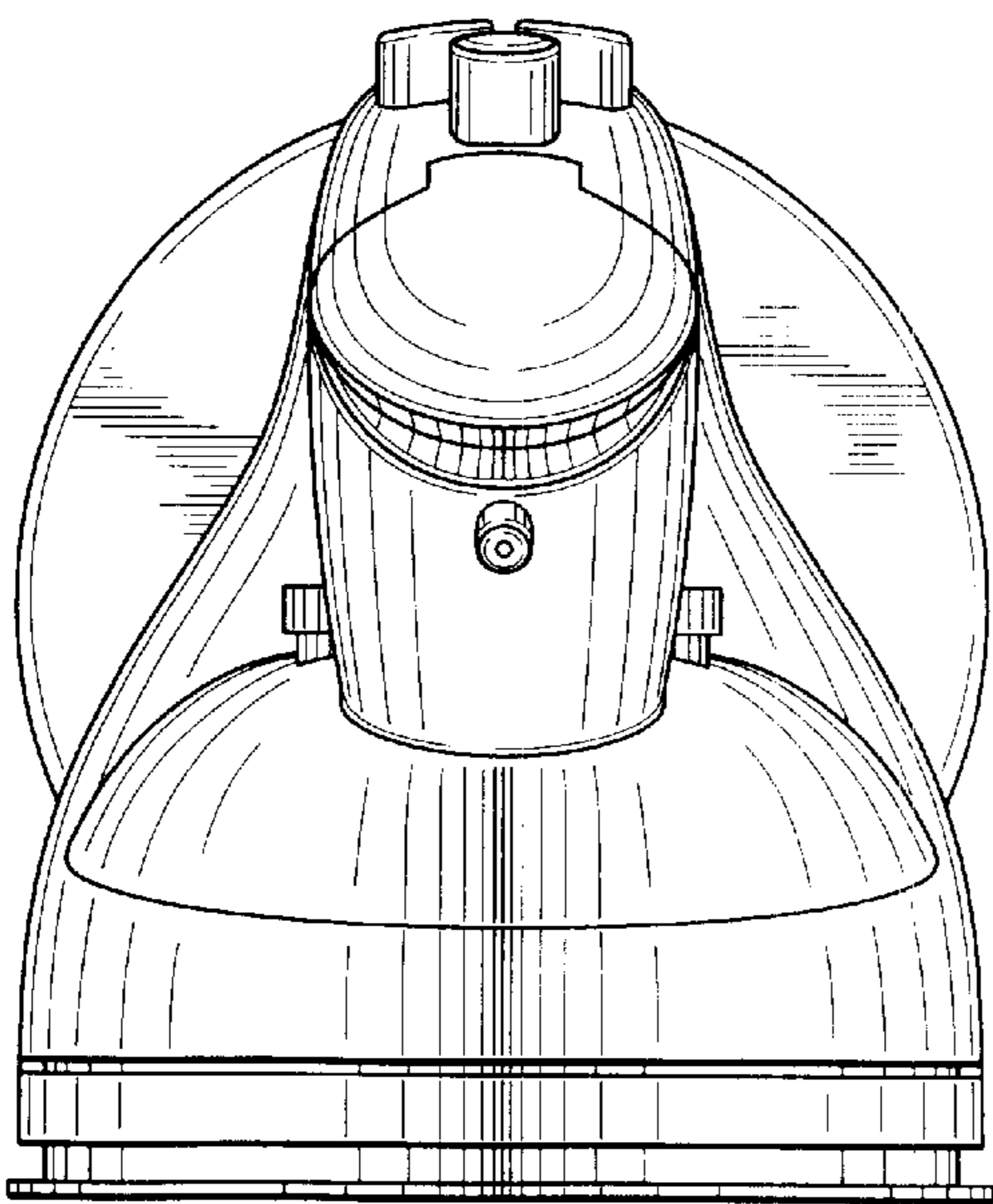

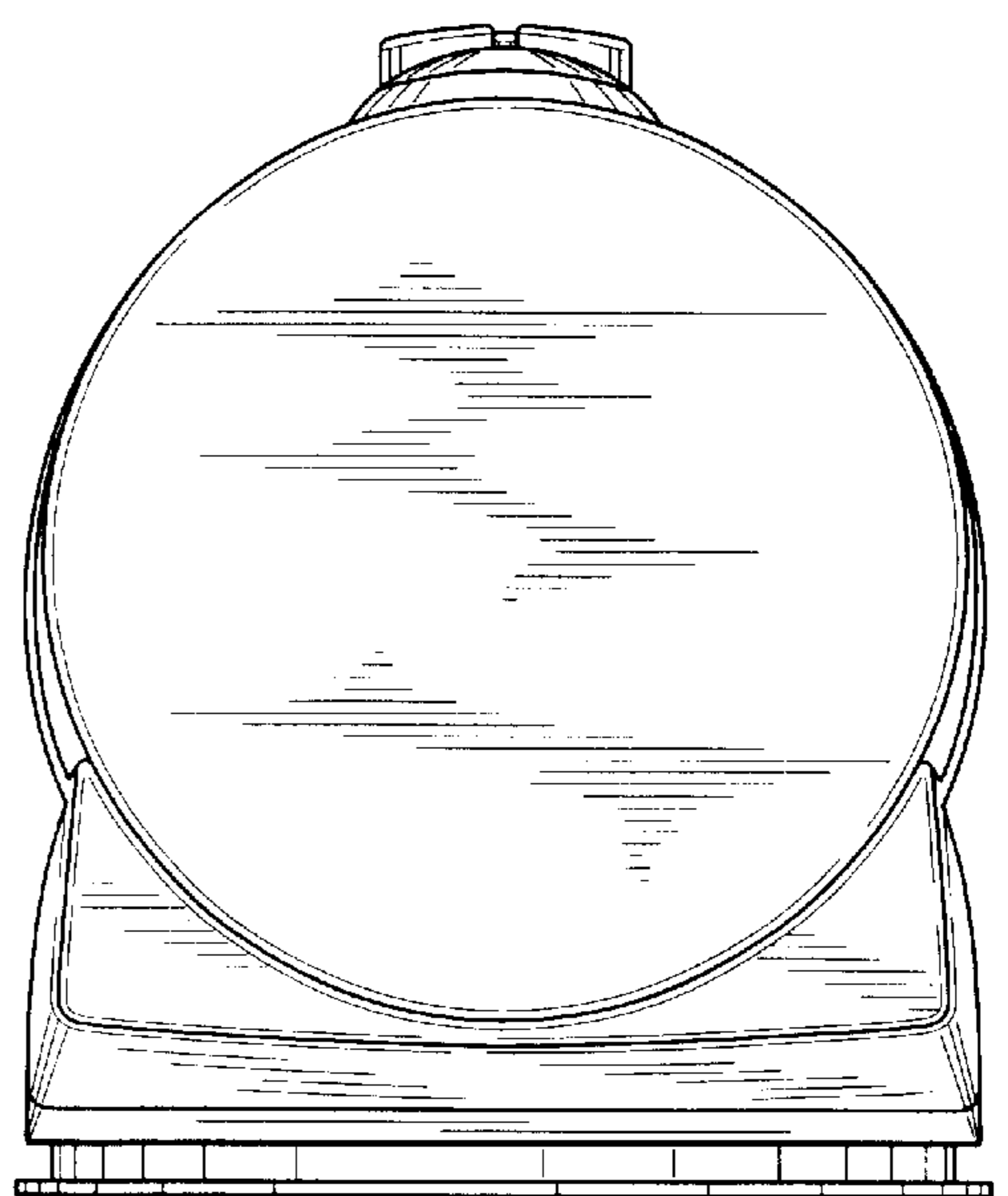

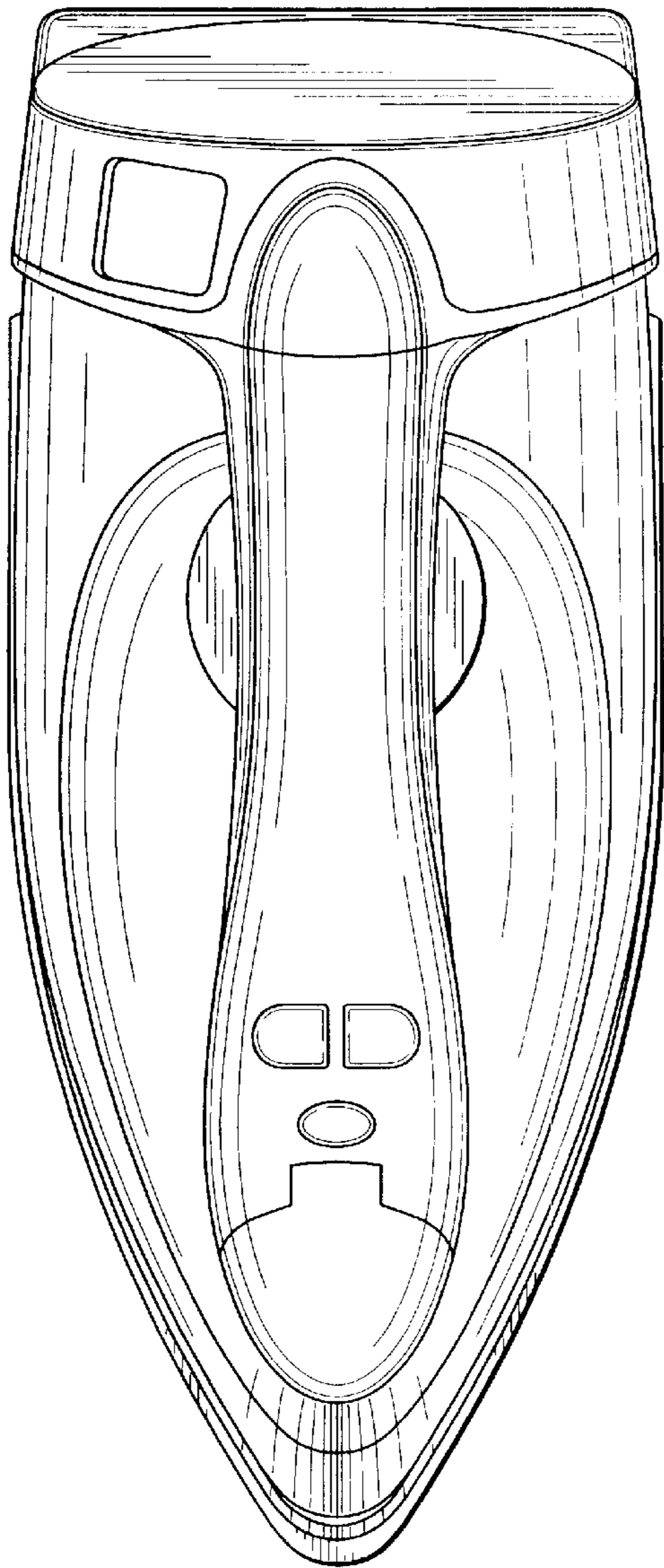

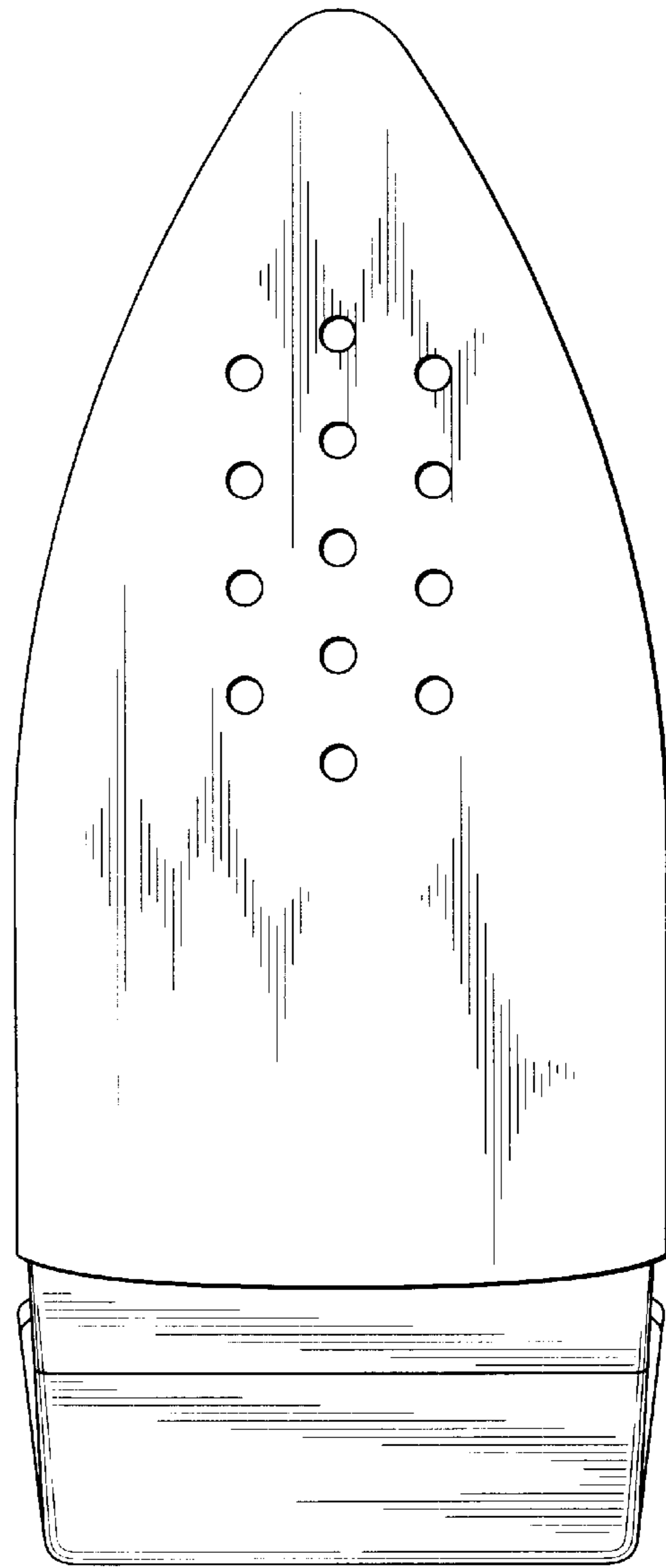

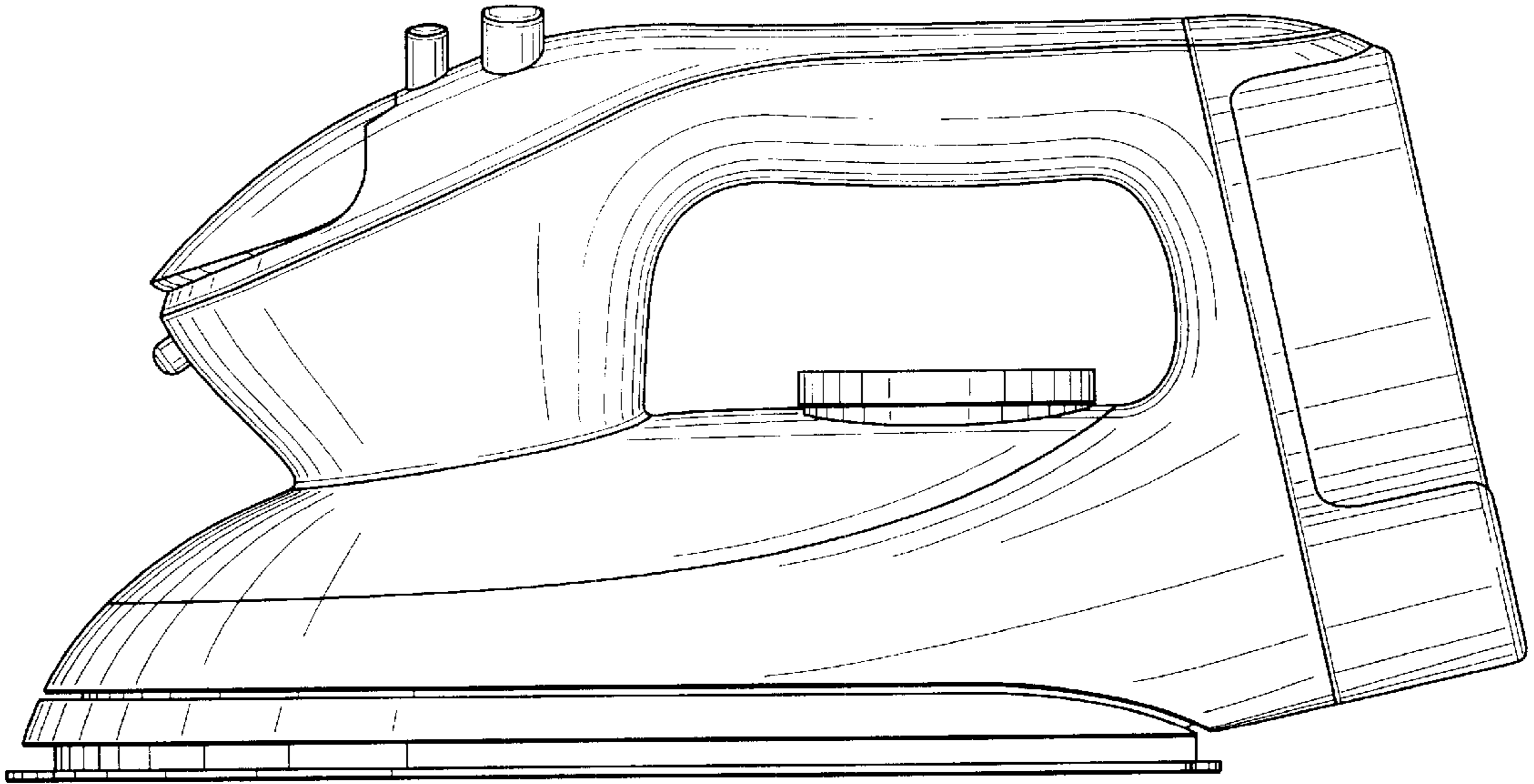
