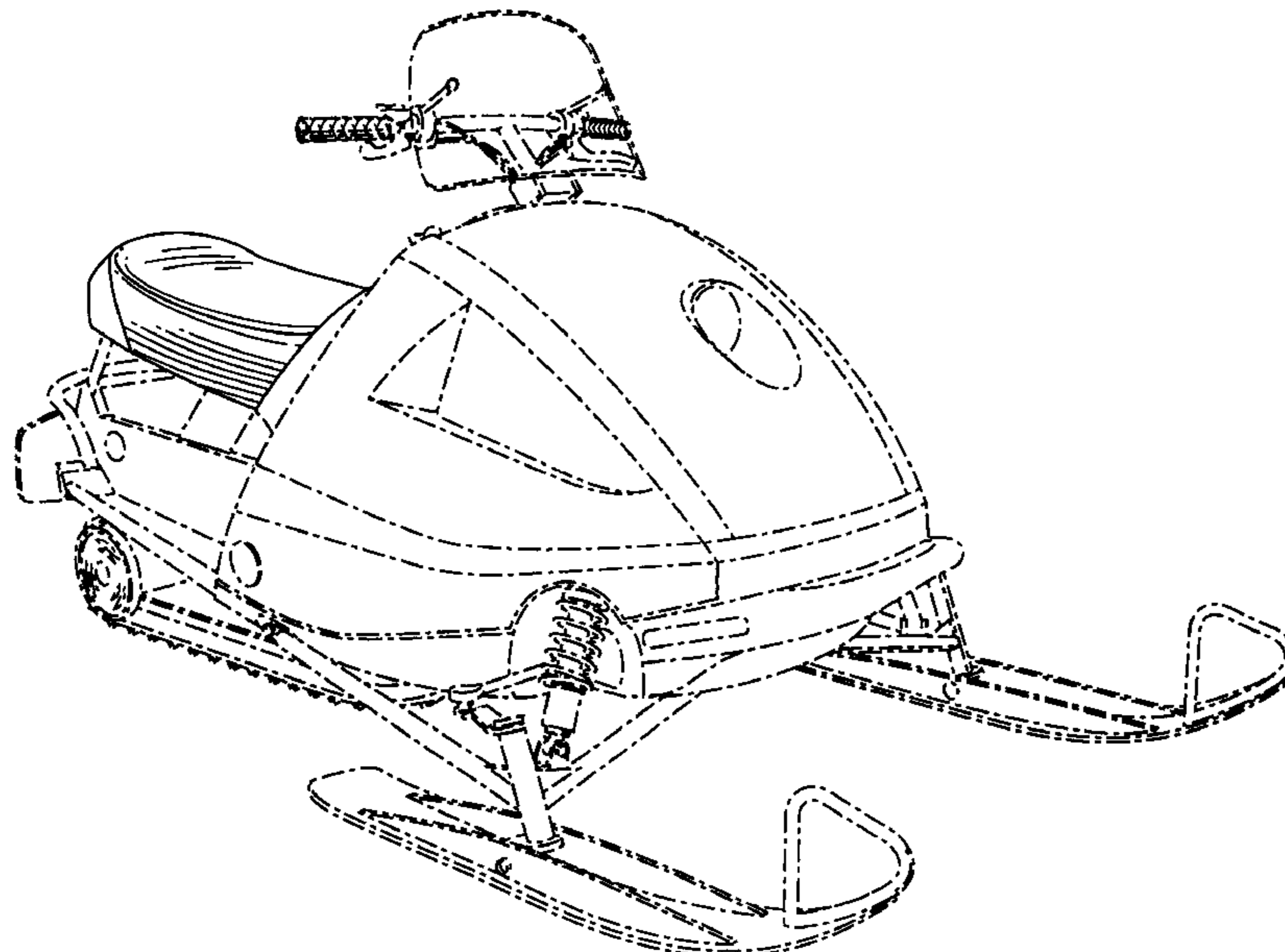
(57) **CLAIM**

The ornamental design for a snowmobile seat, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a snowmobile seat according to the present design;
FIG. 2 is a right side view of the snowmobile seat of FIG. 1;
FIG. 3 is a front elevation view of the snowmobile seat of FIG. 1;
FIG. 4 is a rear elevation view of the snowmobile seat of FIG. 1;
FIG. 5 is a top plan view of the snowmobile seat of FIG. 1; and,
FIG. 6 is a left side view of the snowmobile seat of FIG. 1. Where included, broken lines showing structure are for illustrative purposes only and form no part of the claimed design.

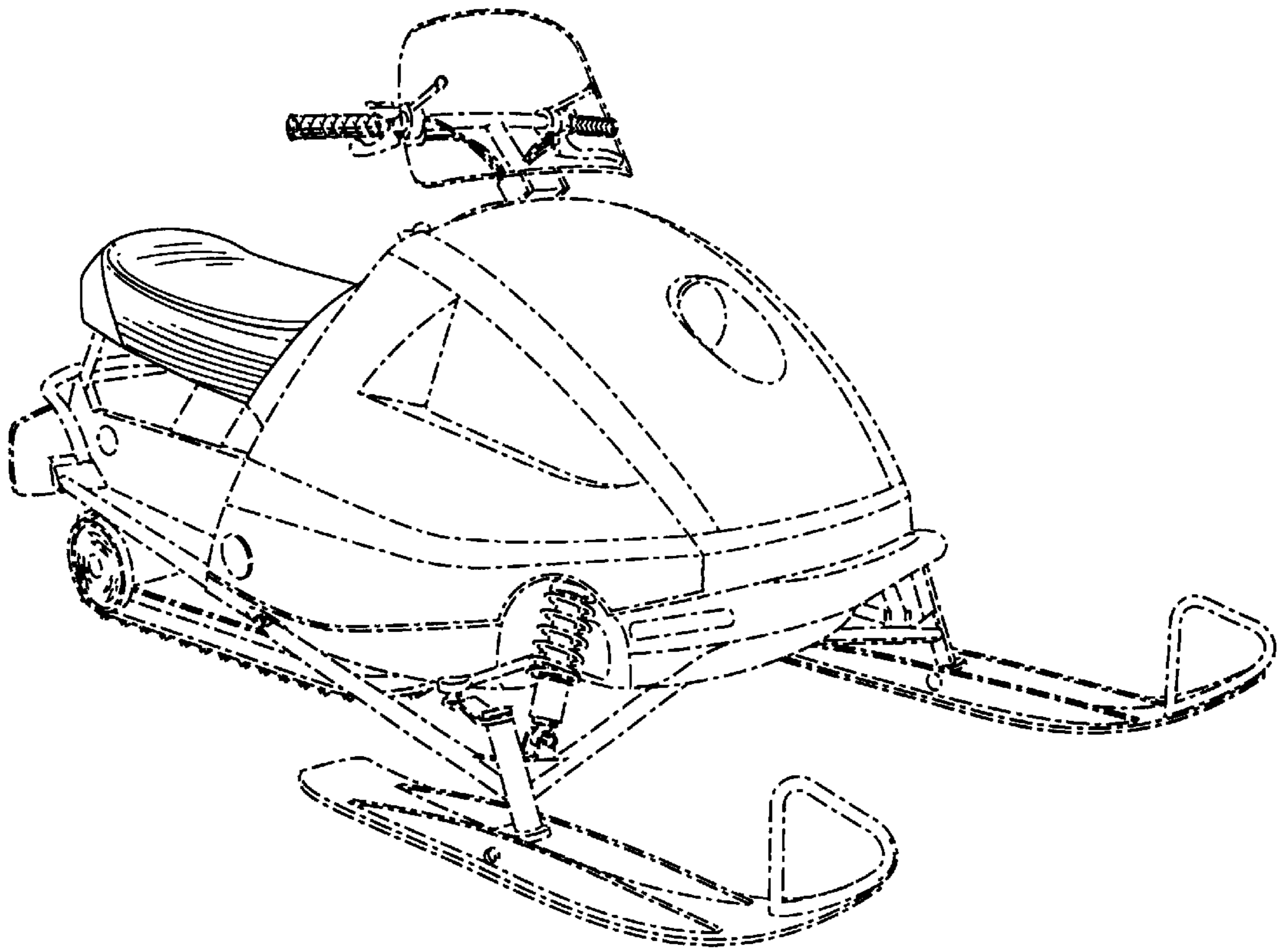

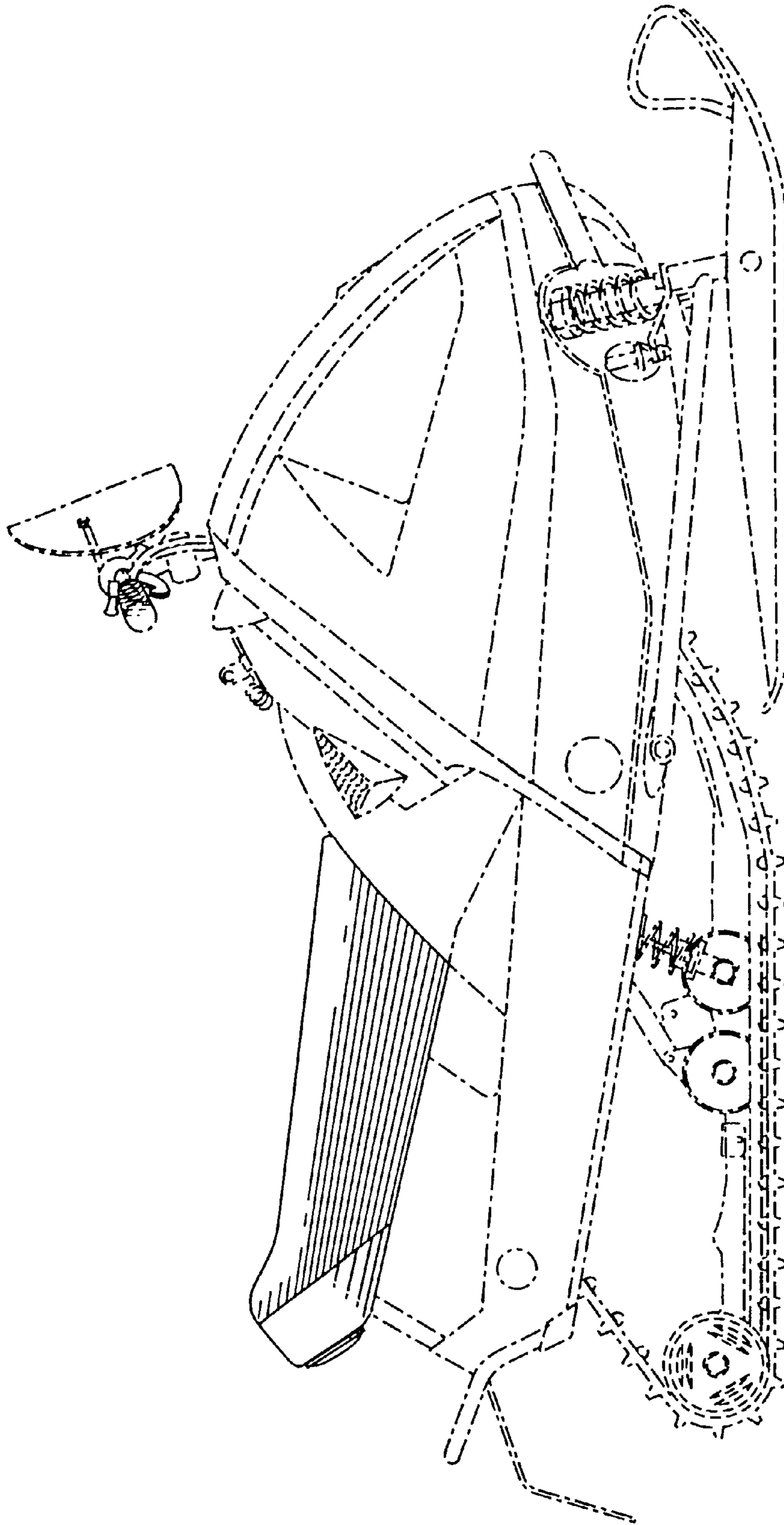

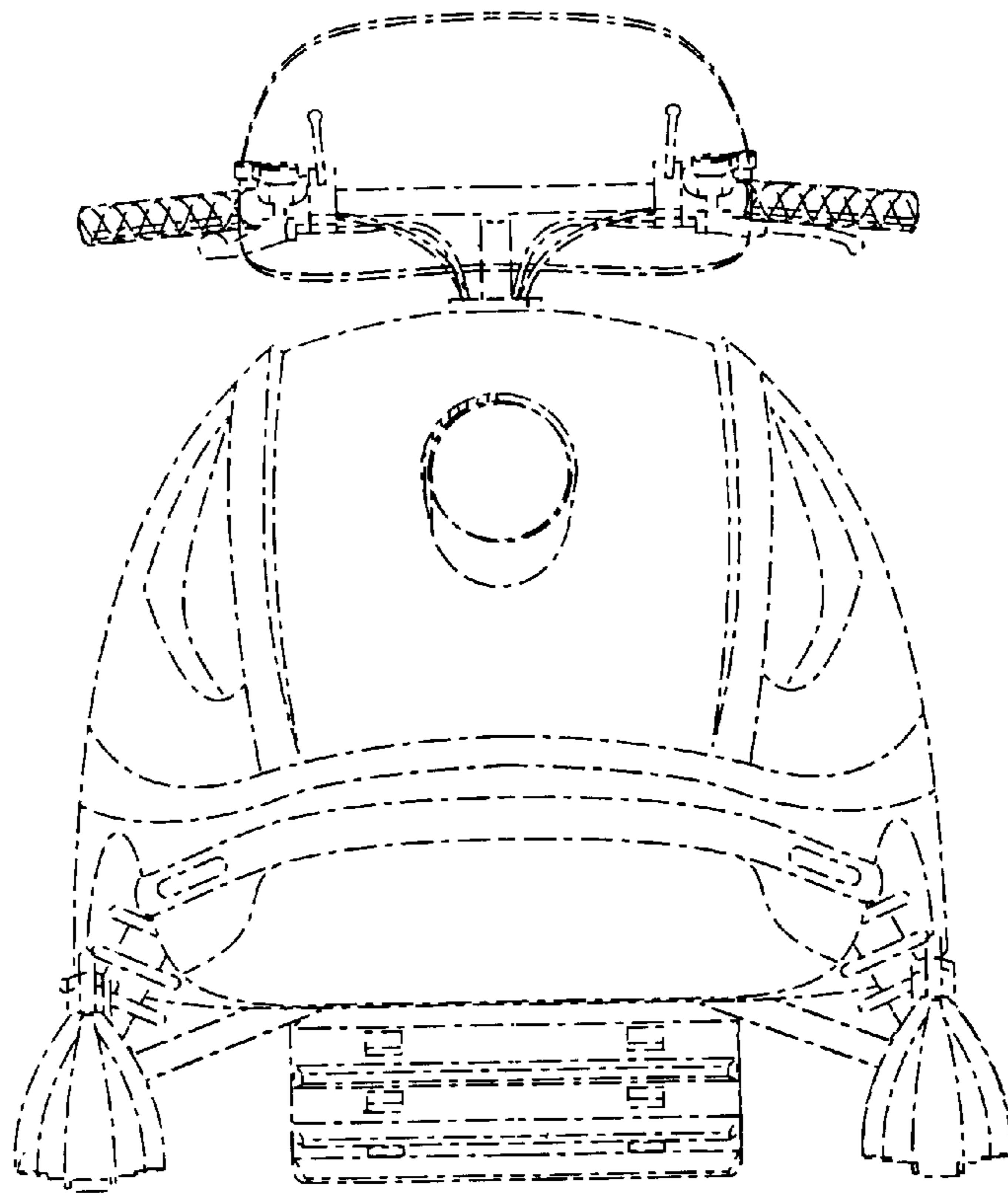

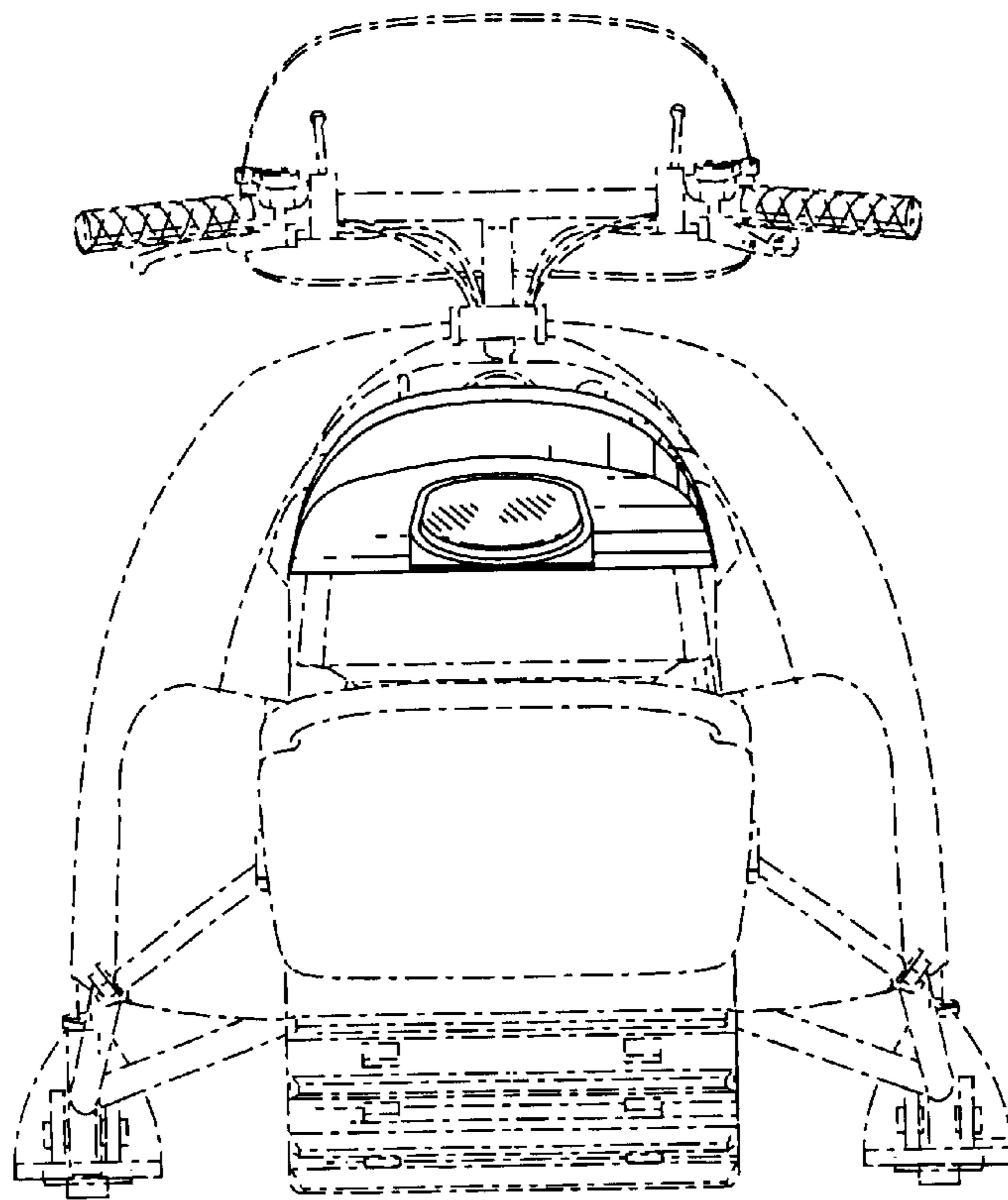

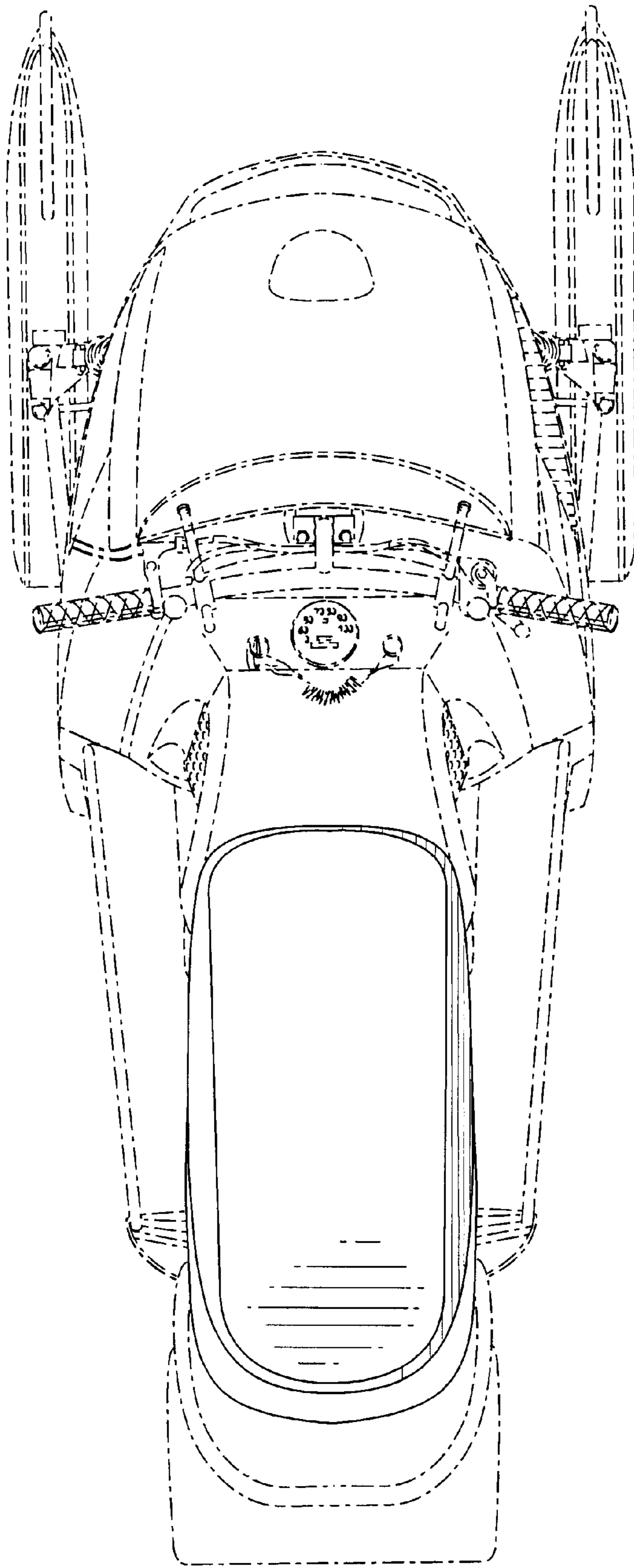

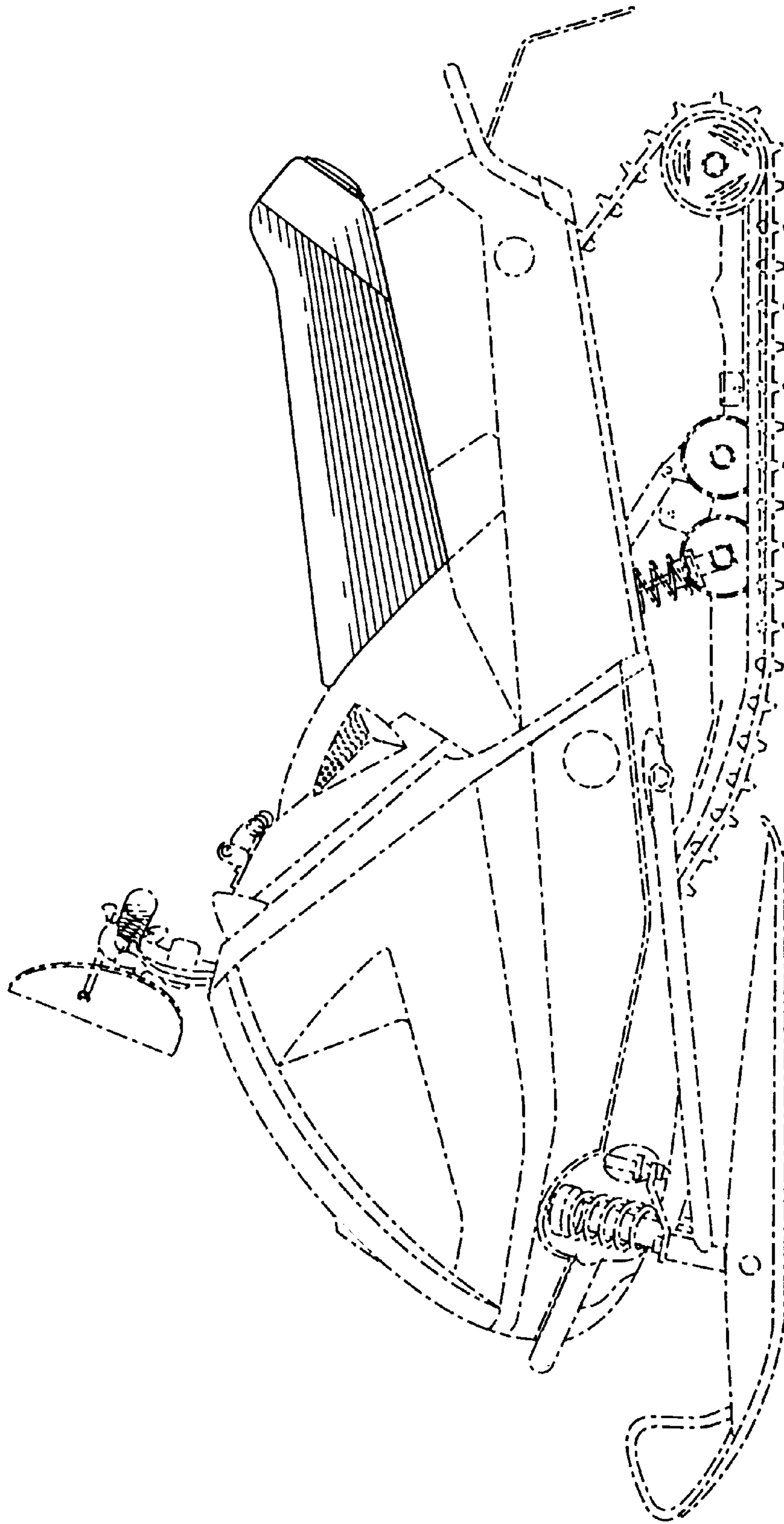
