**DESCRIPTION**

FIG. 1 is a perspective view from the front and one side of the plant holder;

FIG. 2 is a front elevation view of the plant holder of FIG. 1;

FIG. 3 is a rear elevation view of the plant holder of FIG. 1;

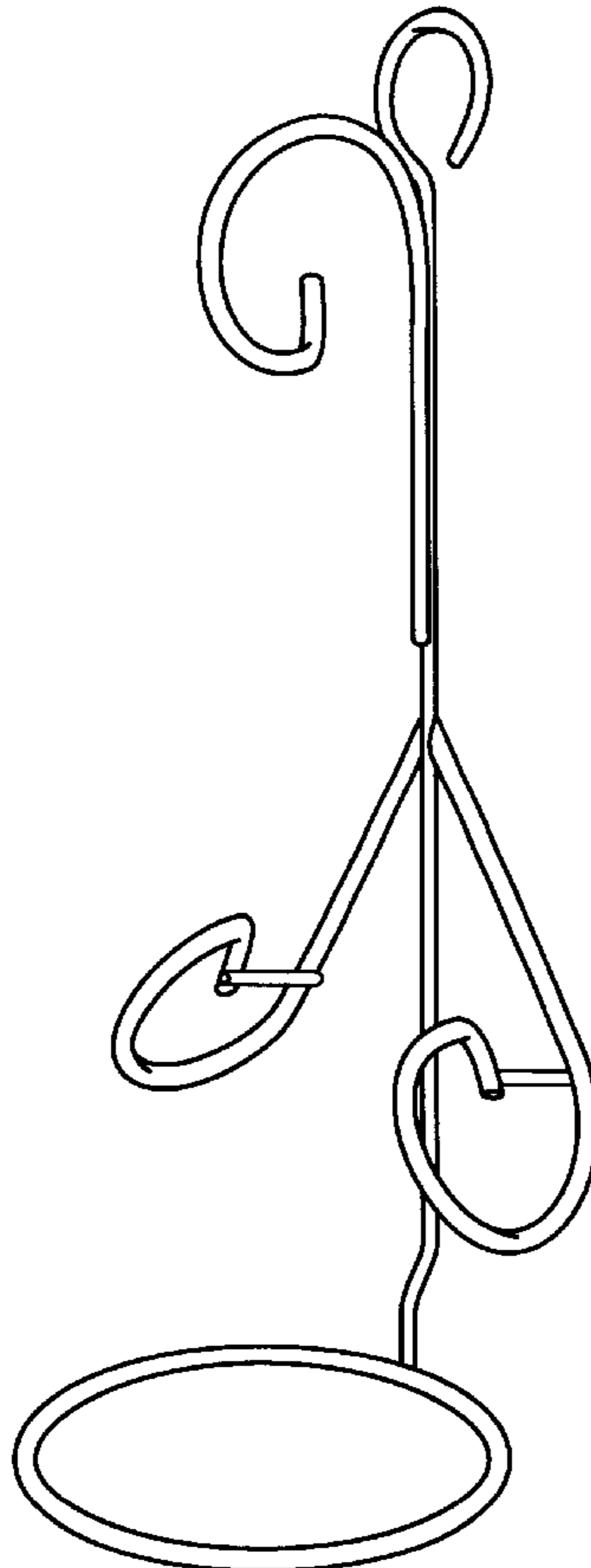
FIG. 4 is a side elevation view of the plant holder of FIG. 1;

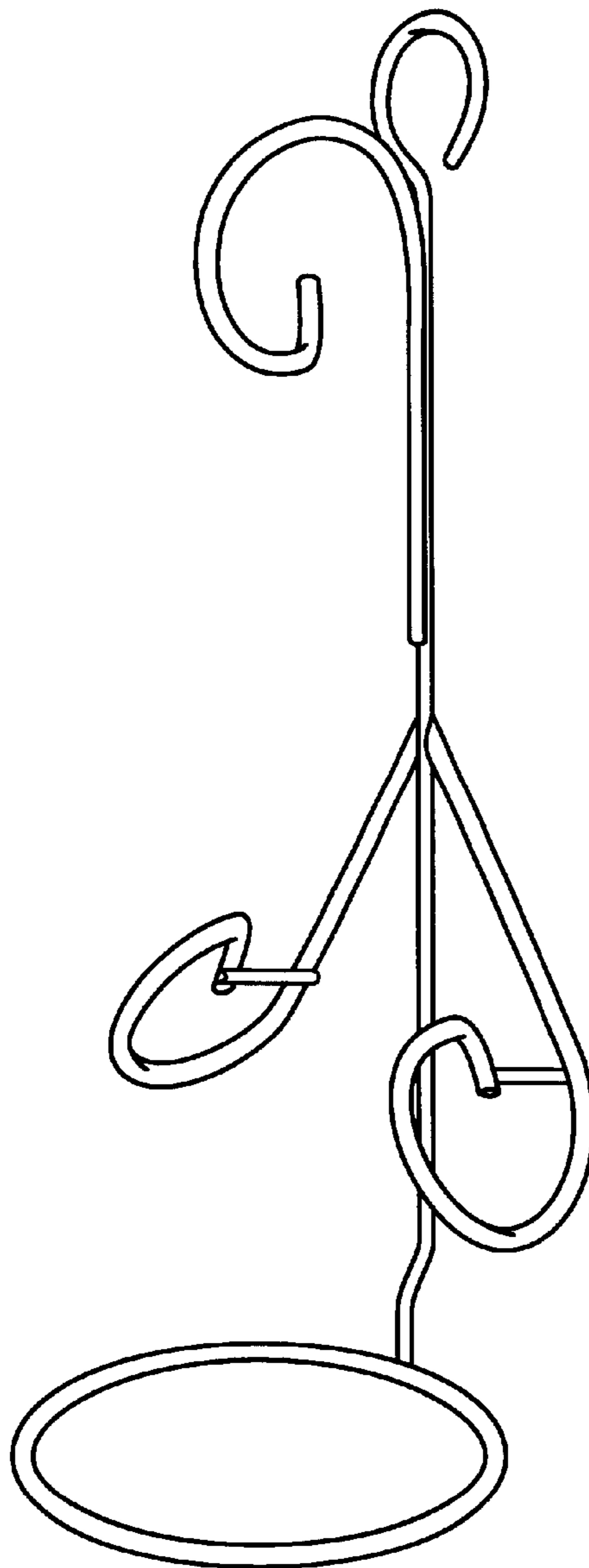

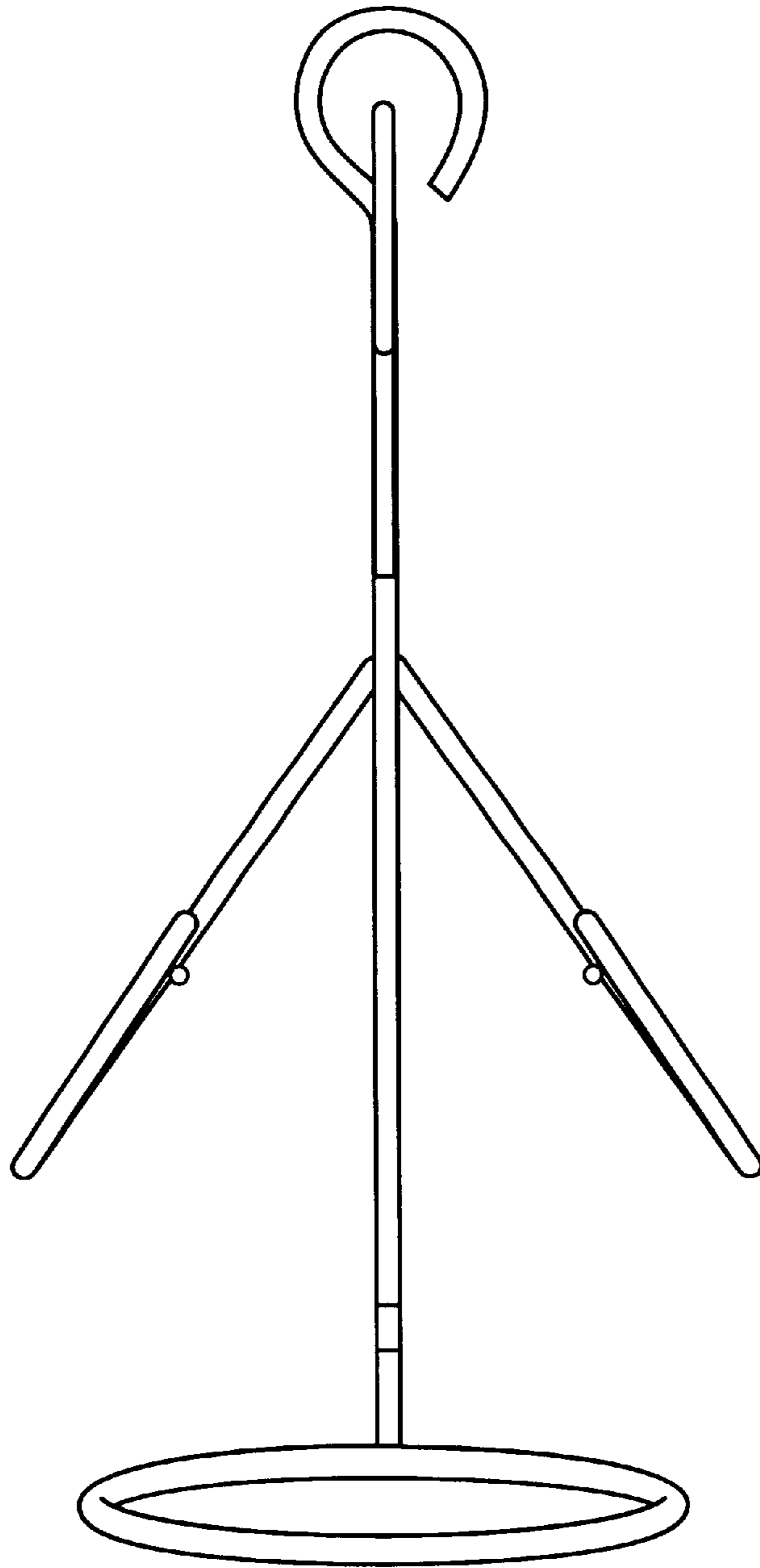

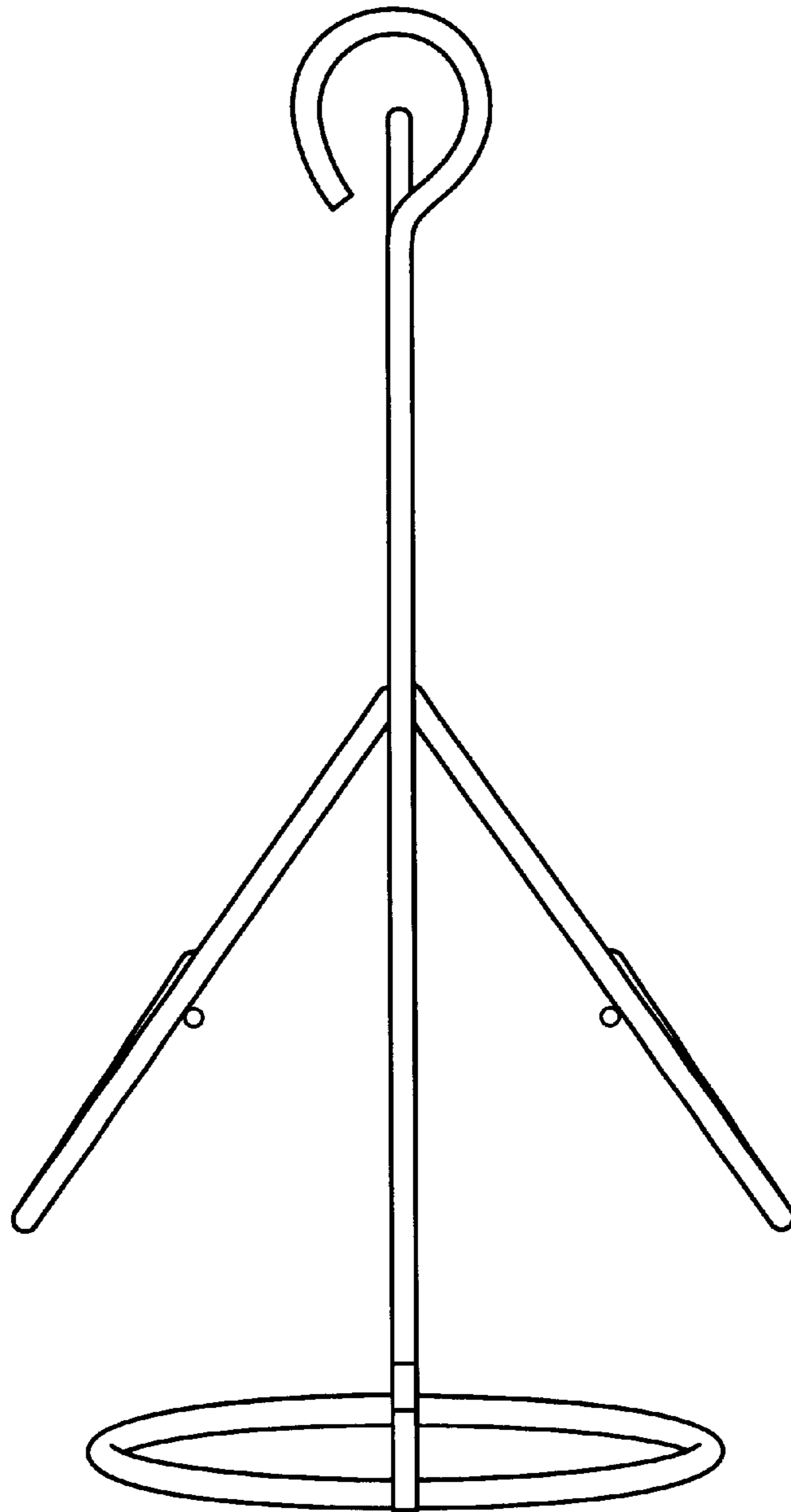

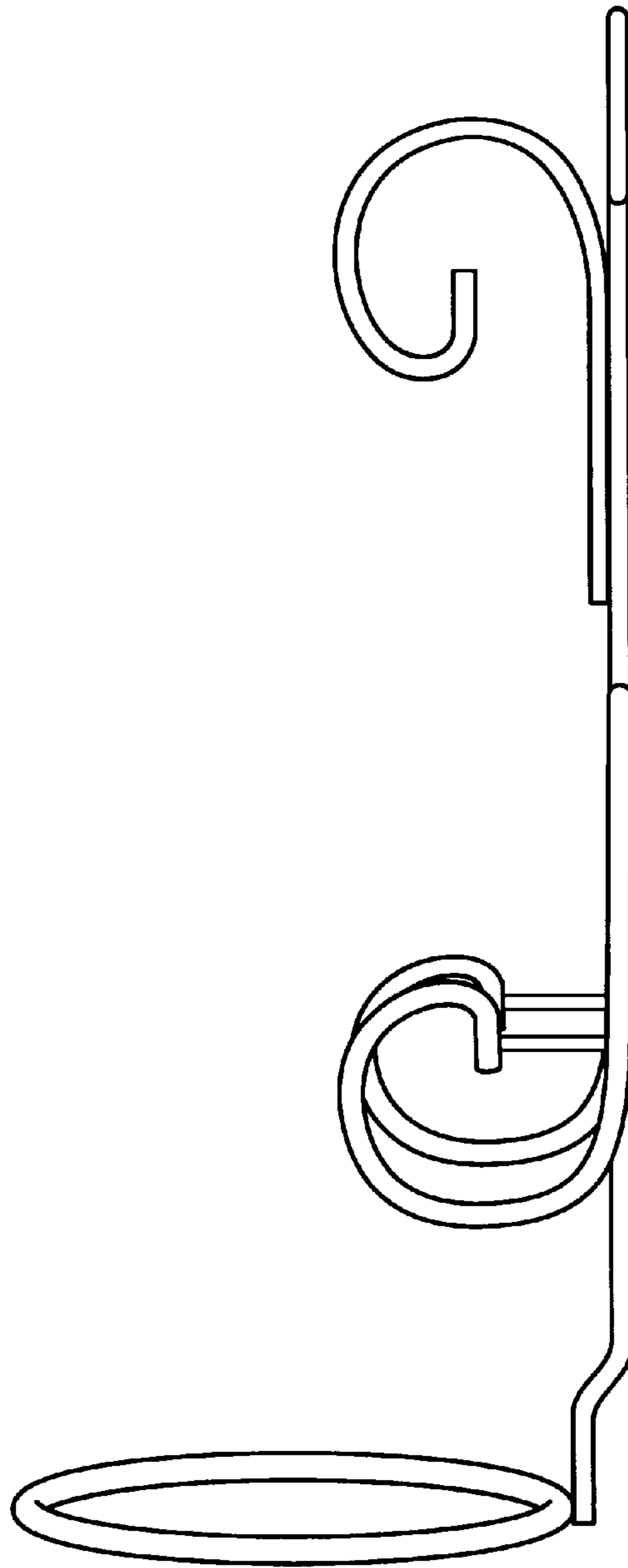

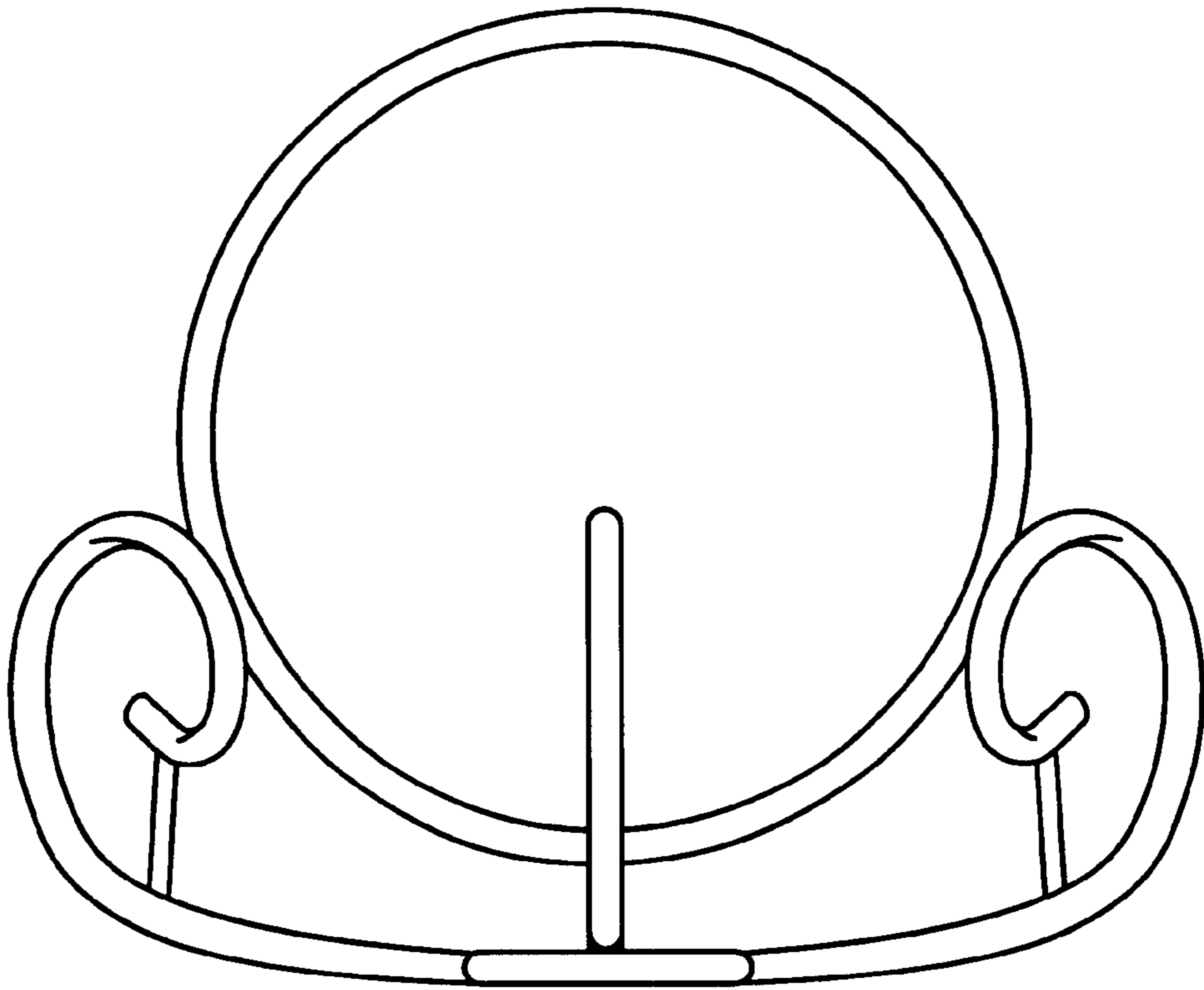

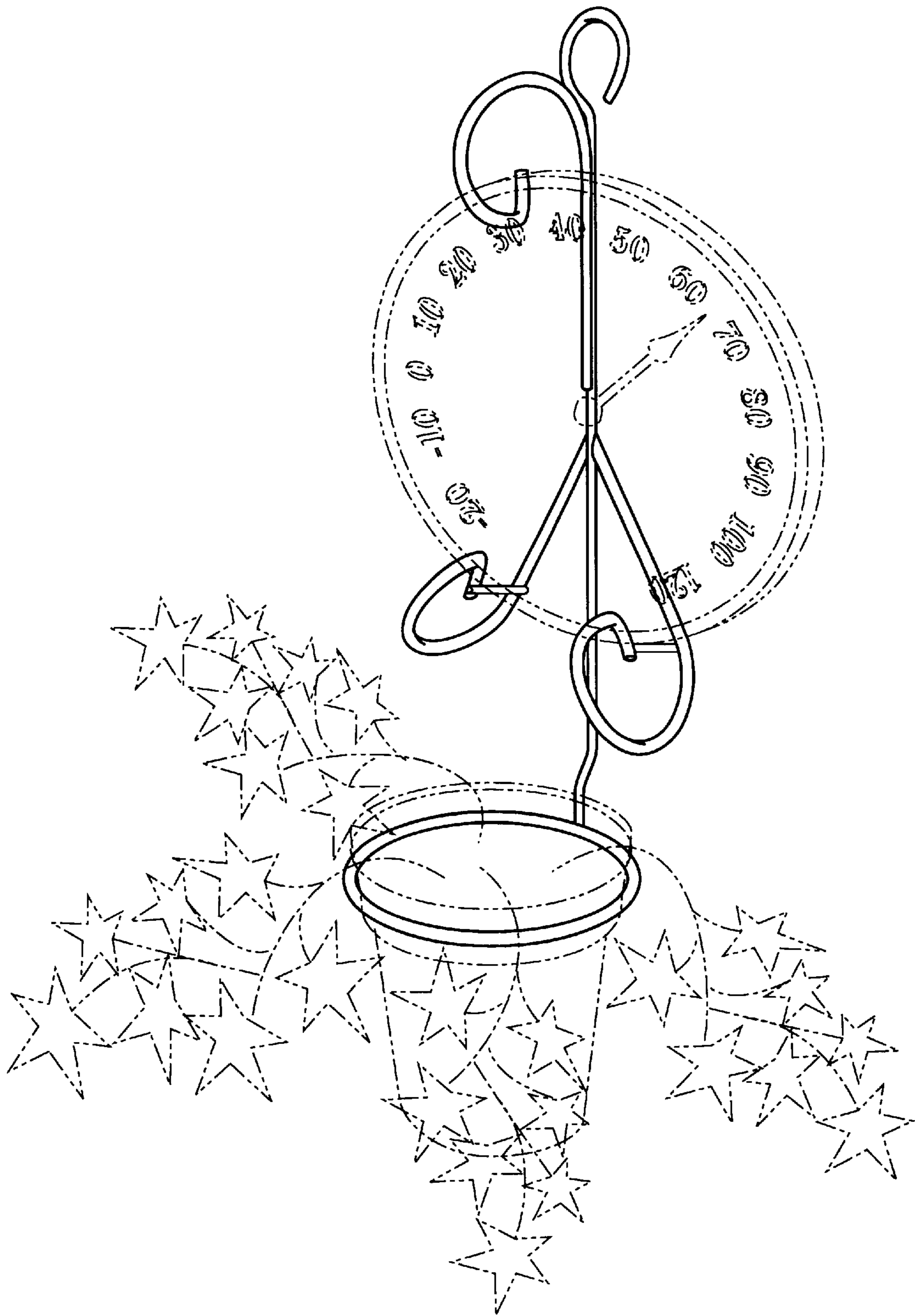
