FIG. 3 is a left elevation view of the mixer of FIG. 1;

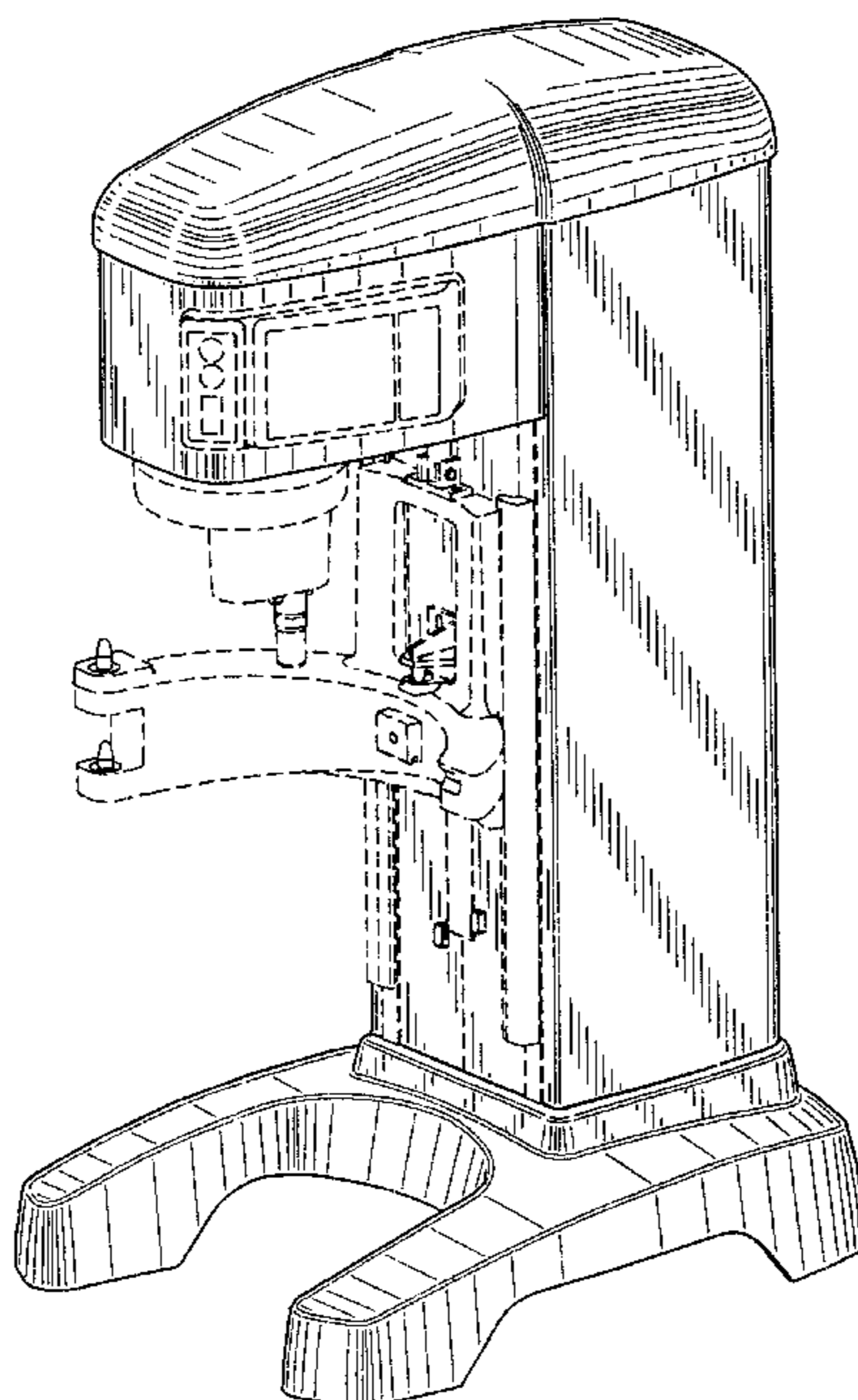
FIG. 4 is a rear elevation view of the mixer of FIG. 1;

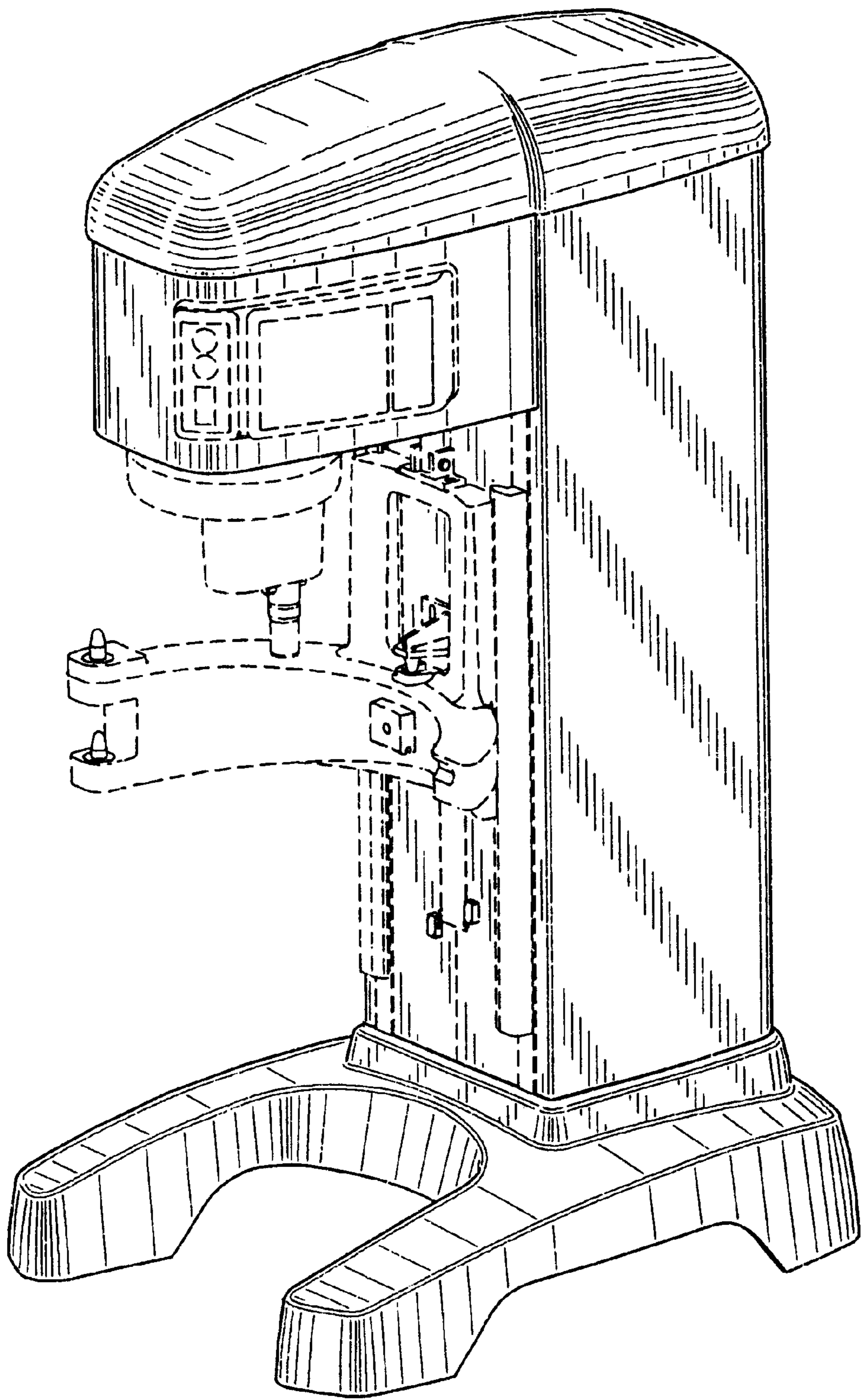

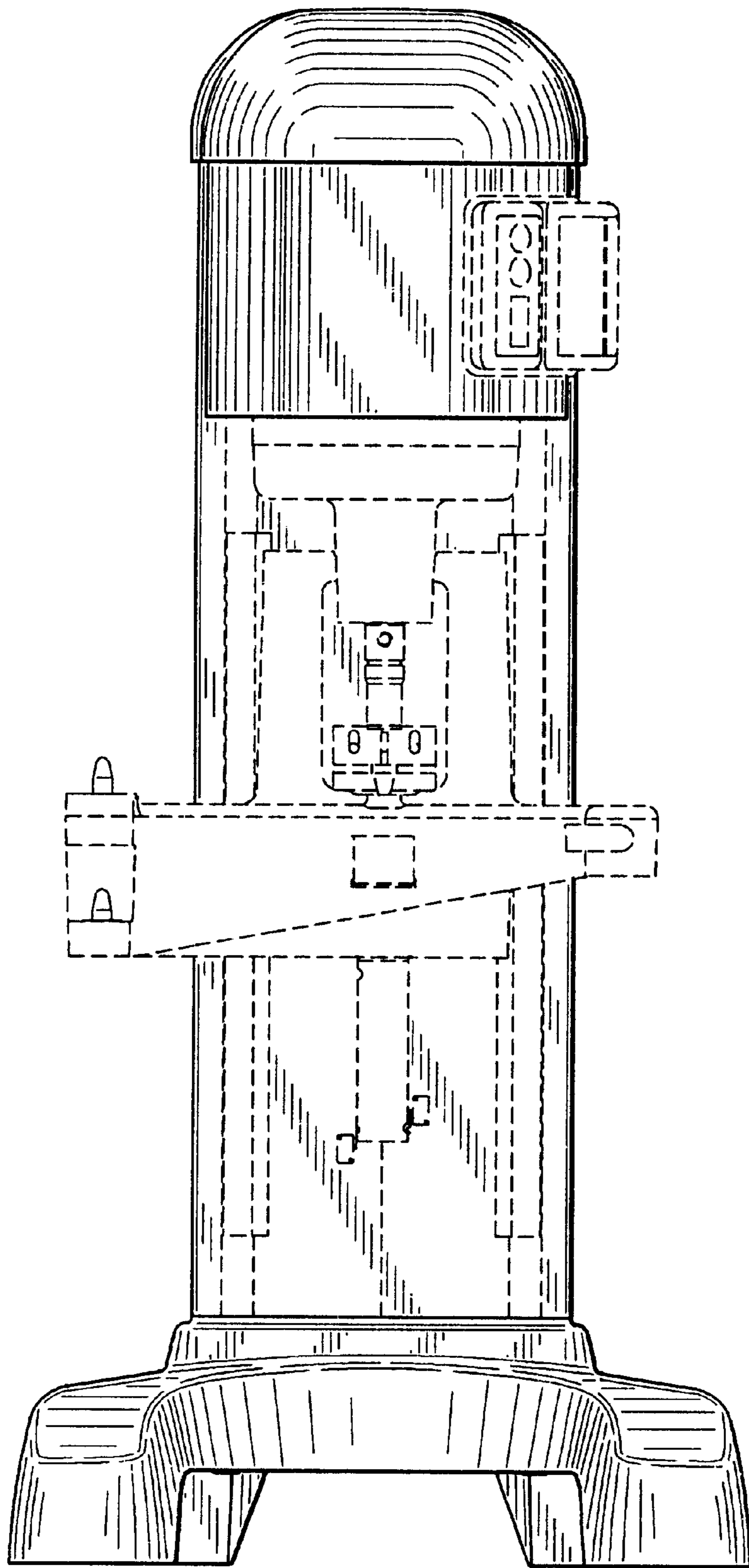

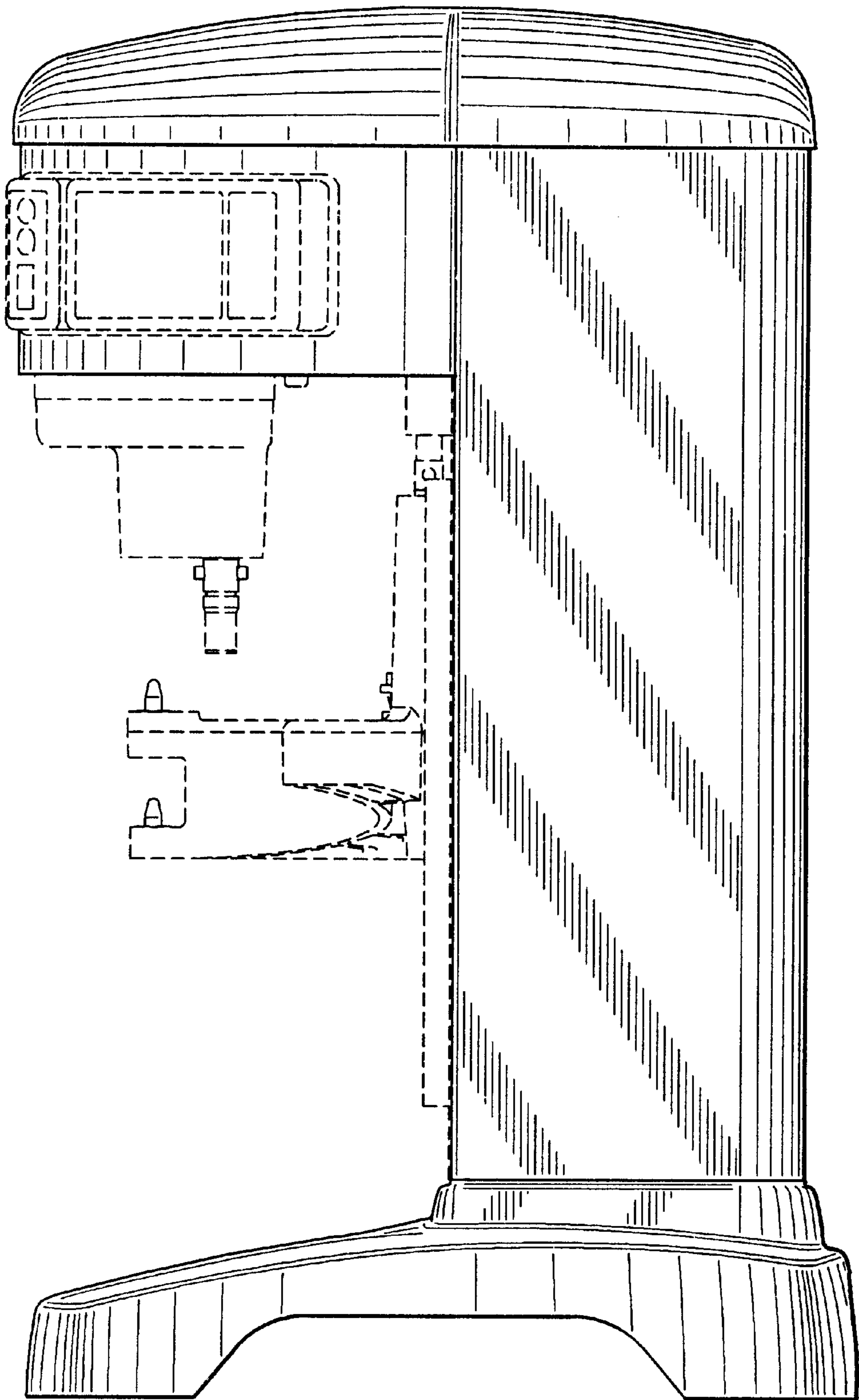

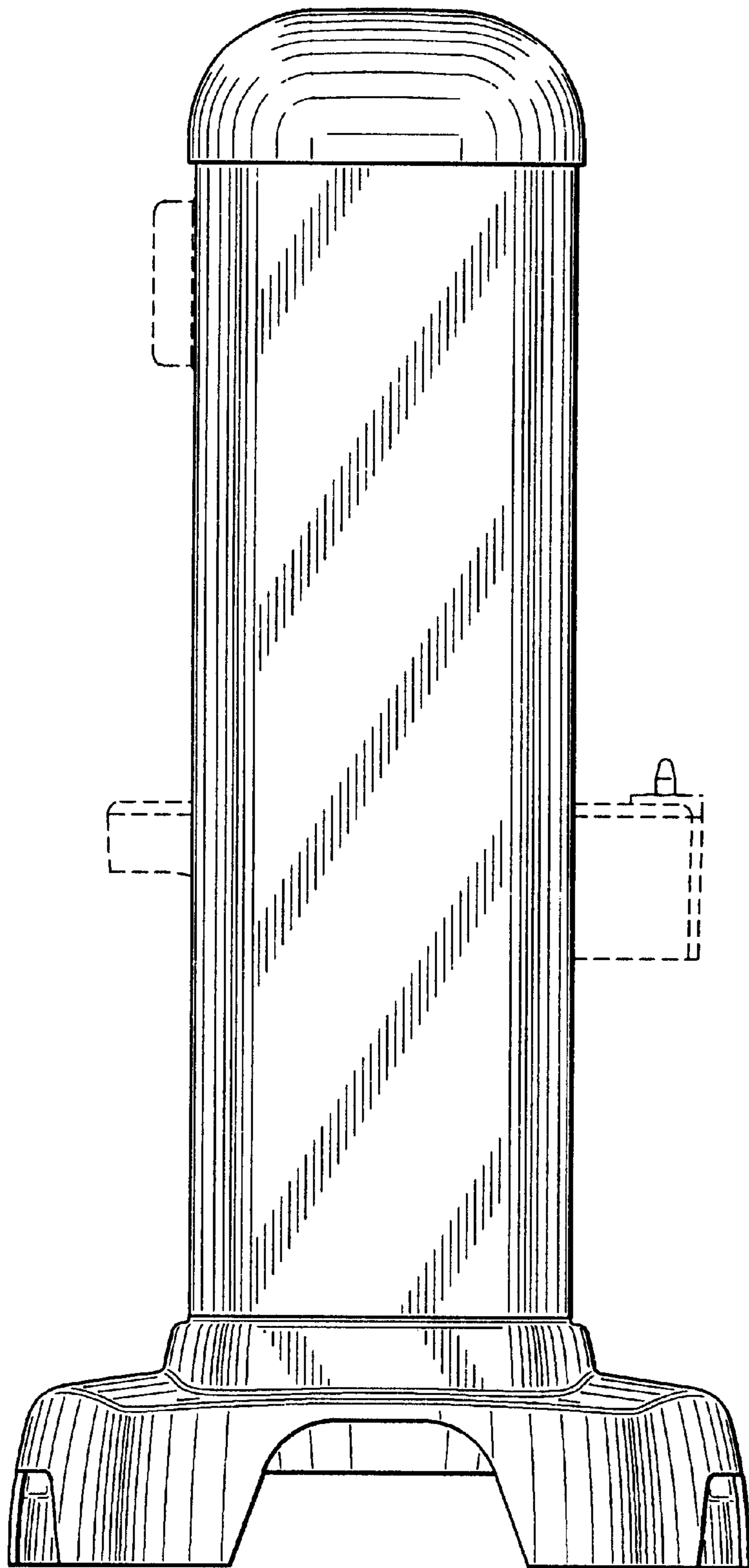

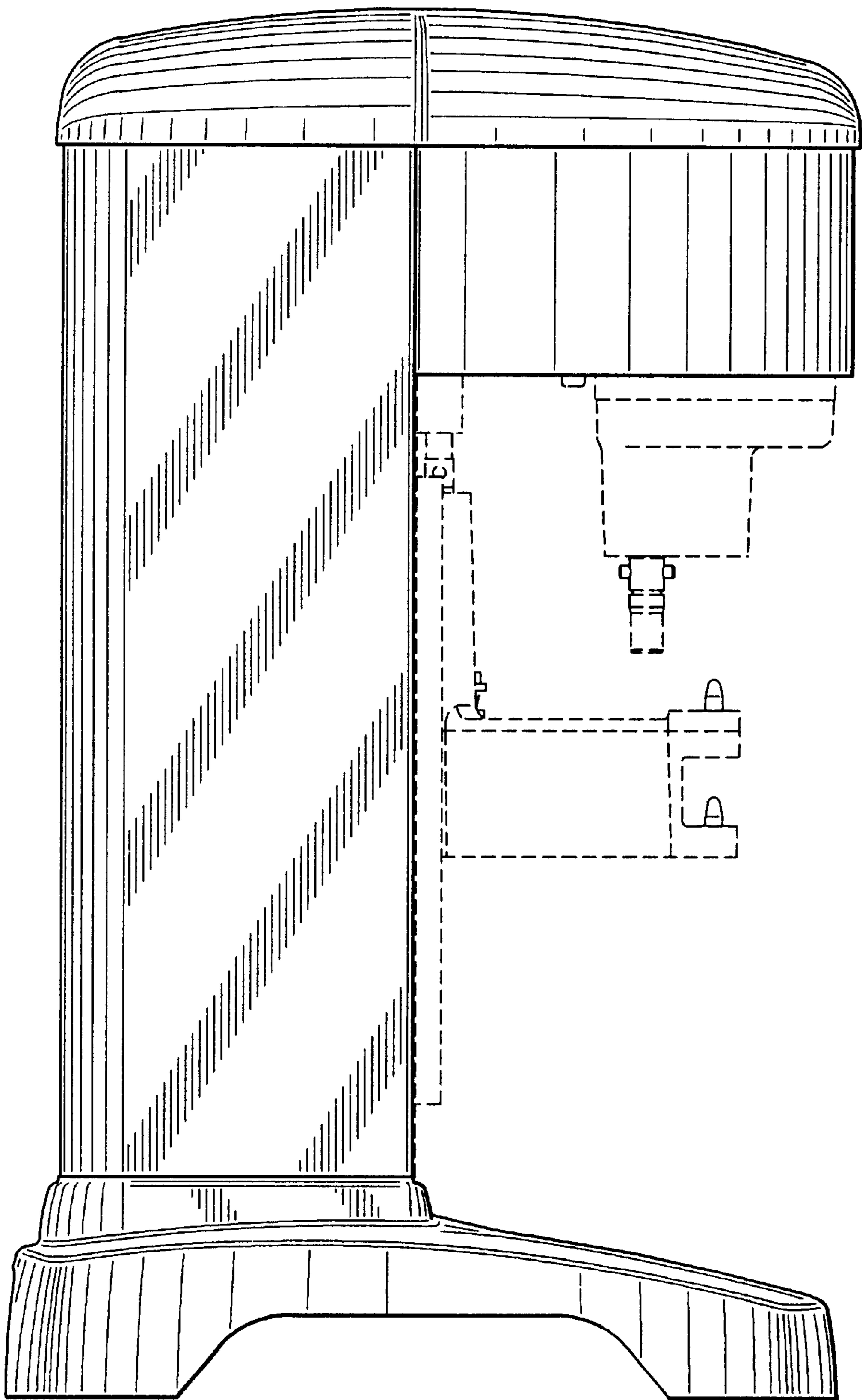

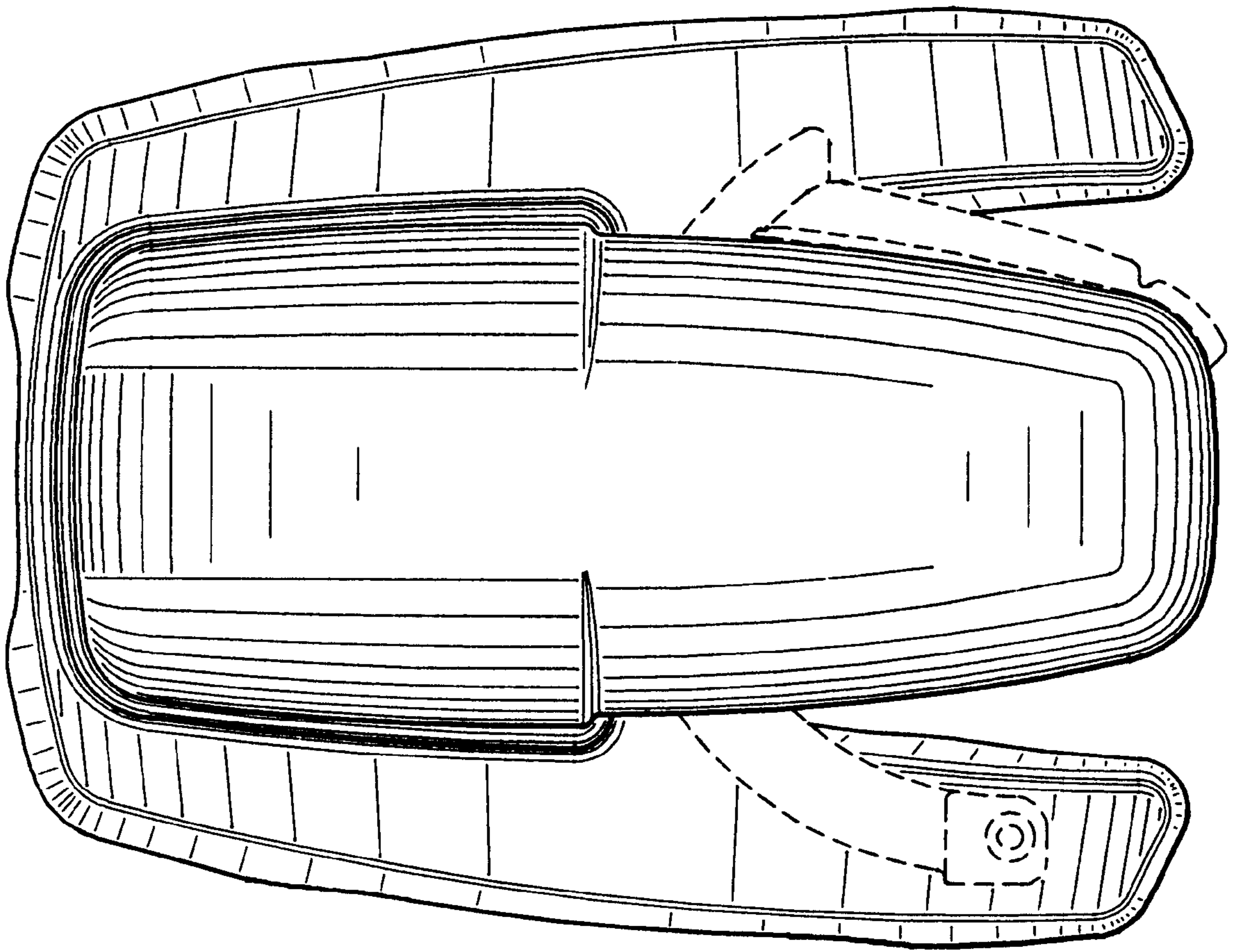
