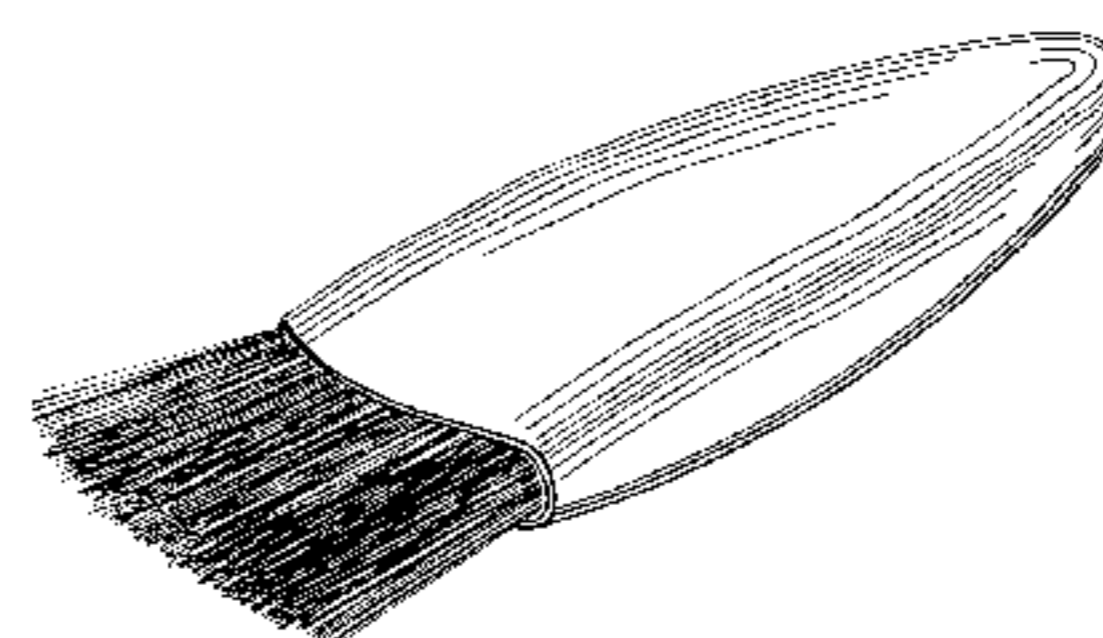
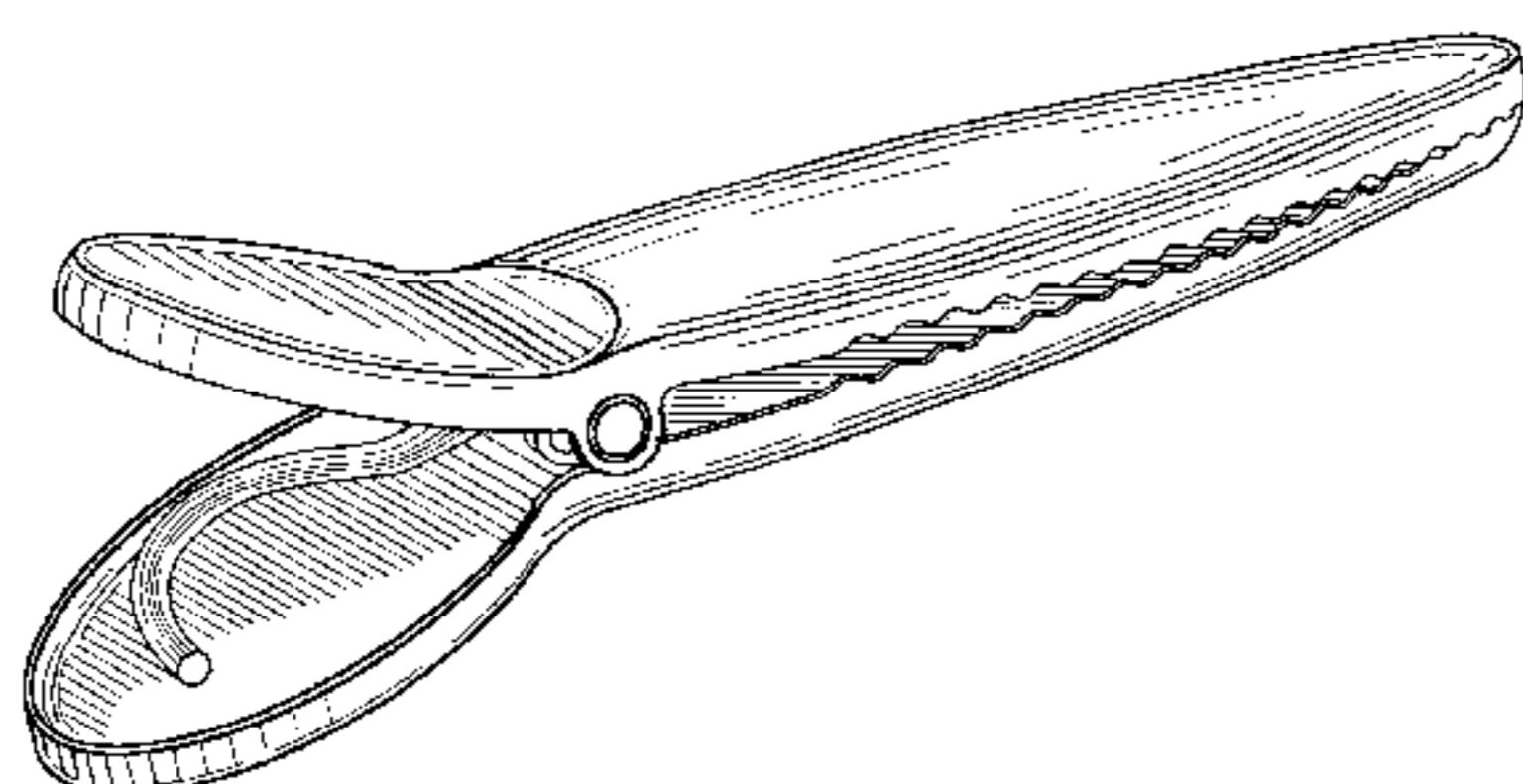
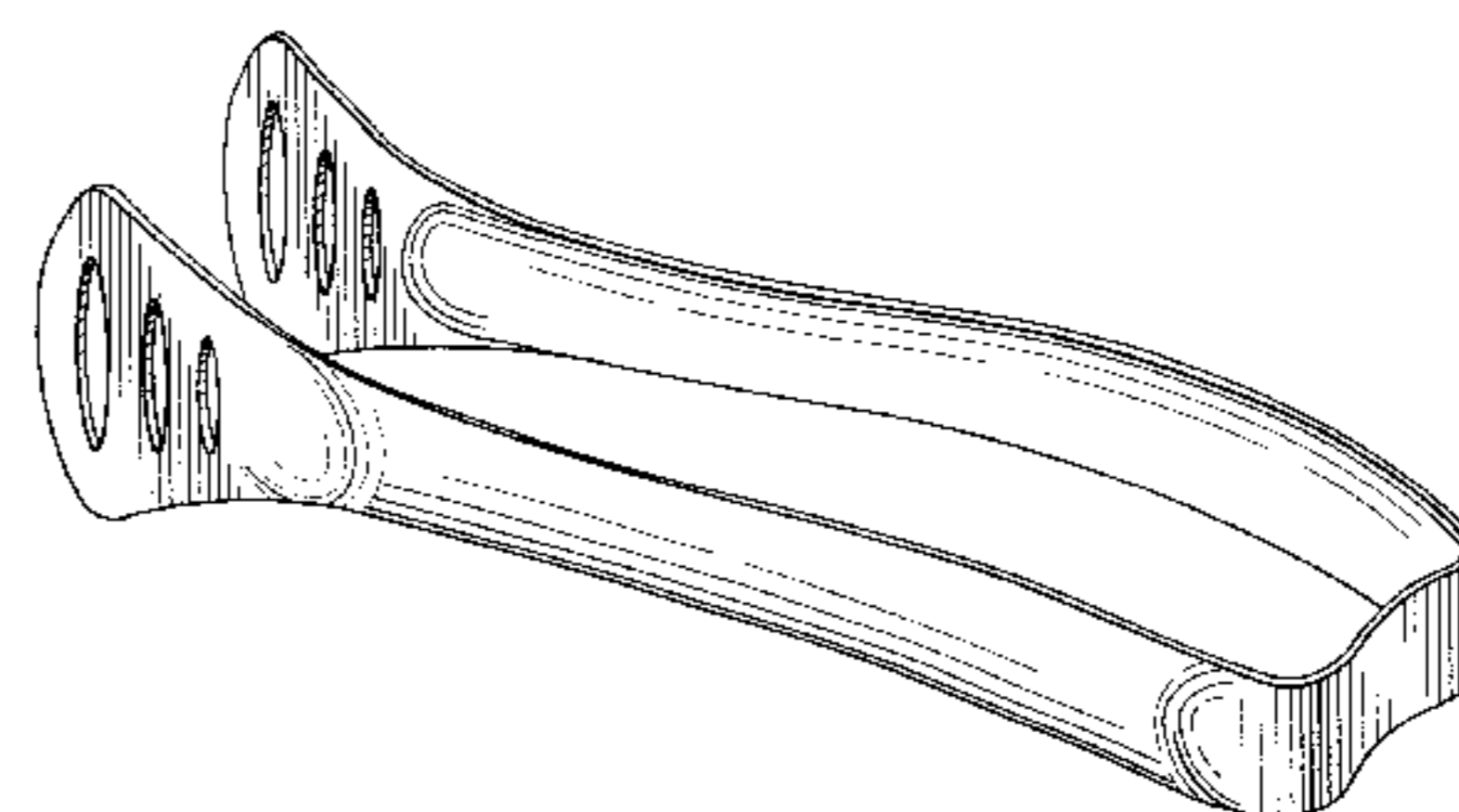
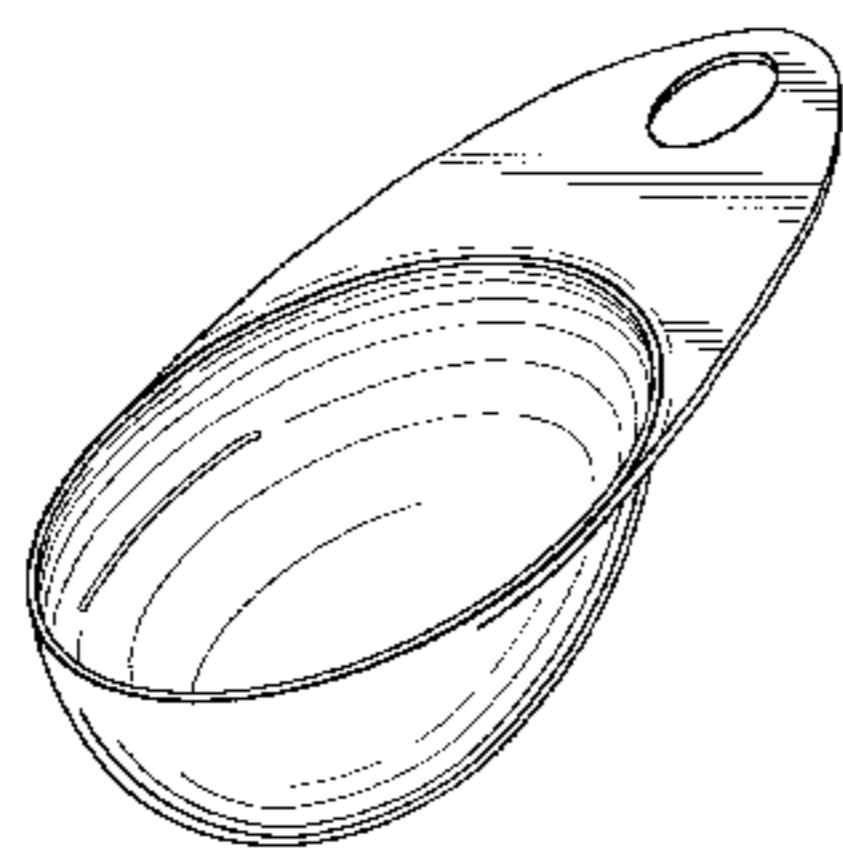
The ornamental design for the coffee preparation set, as shown and described.

**DESCRIPTION**

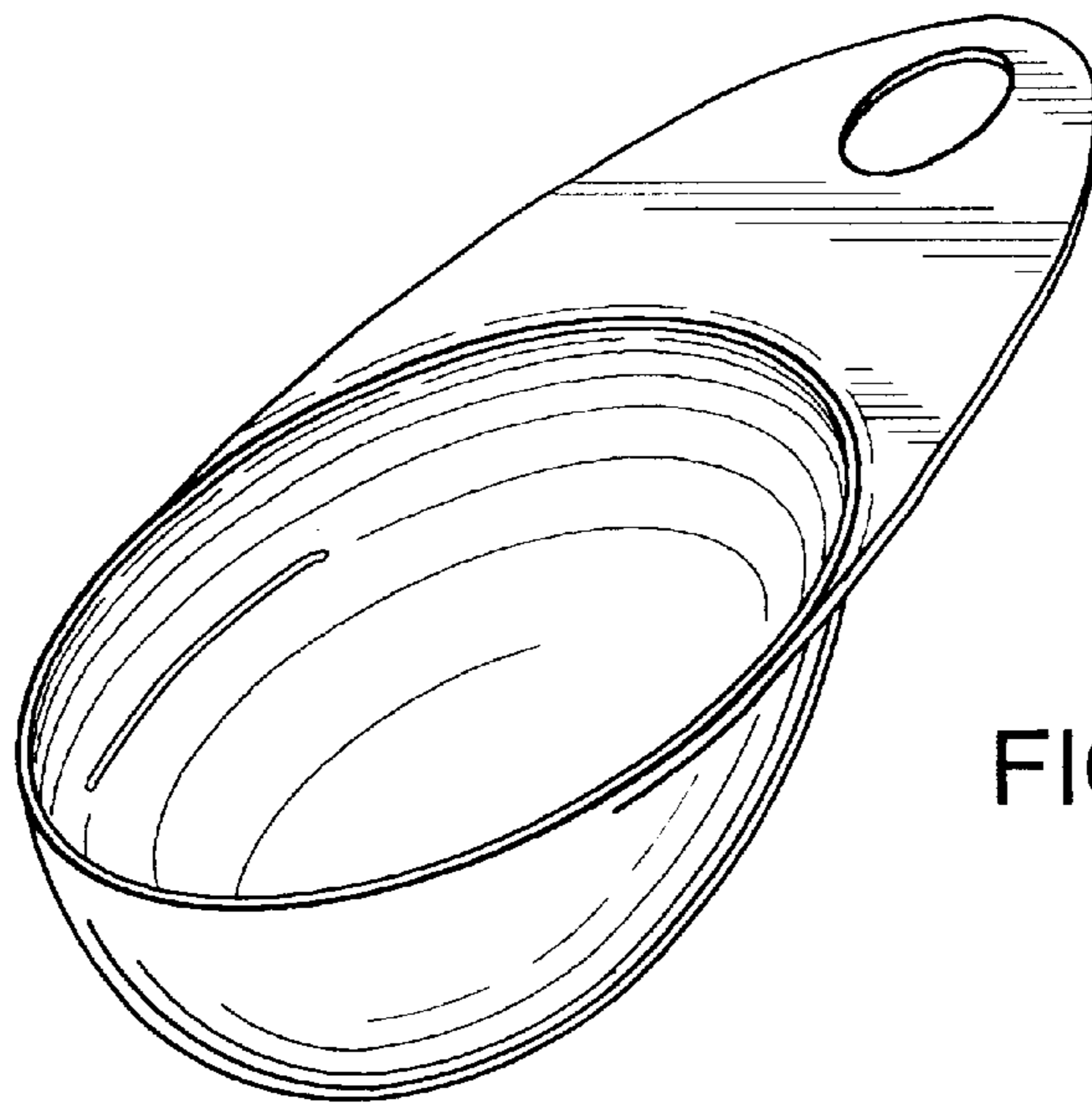

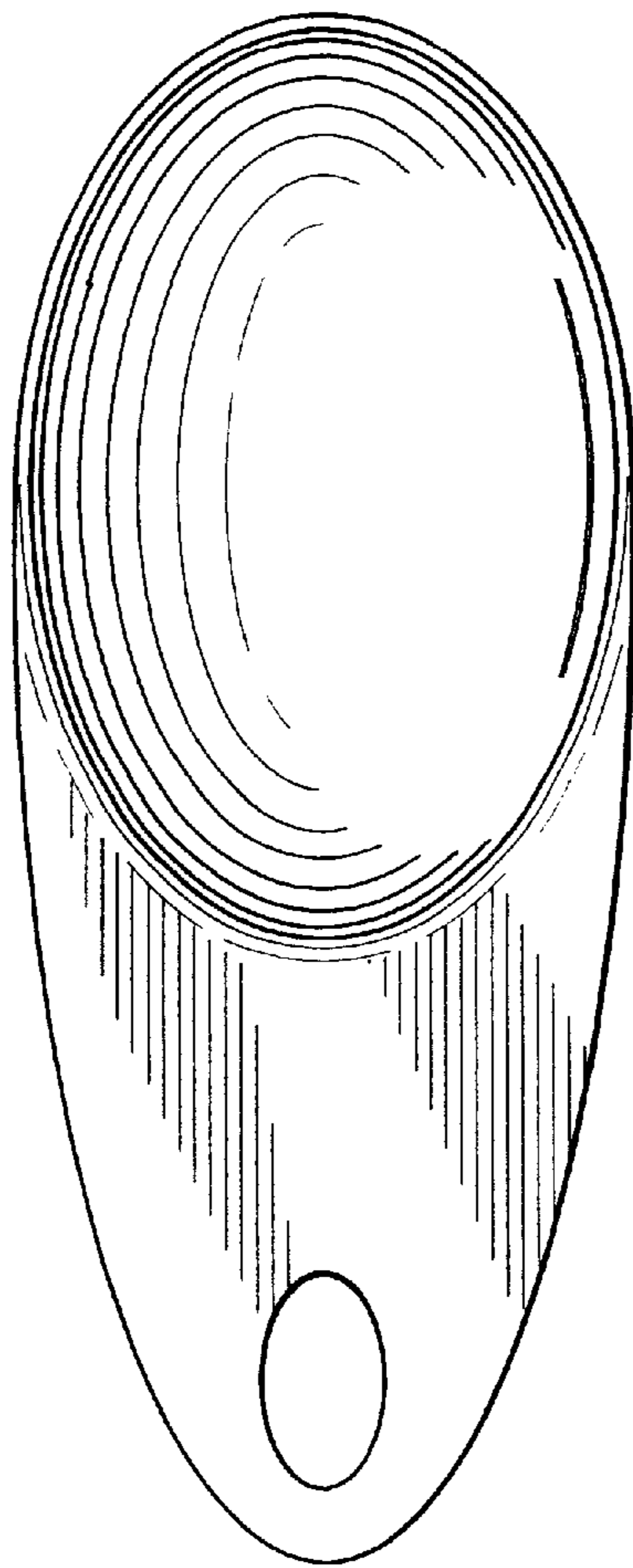

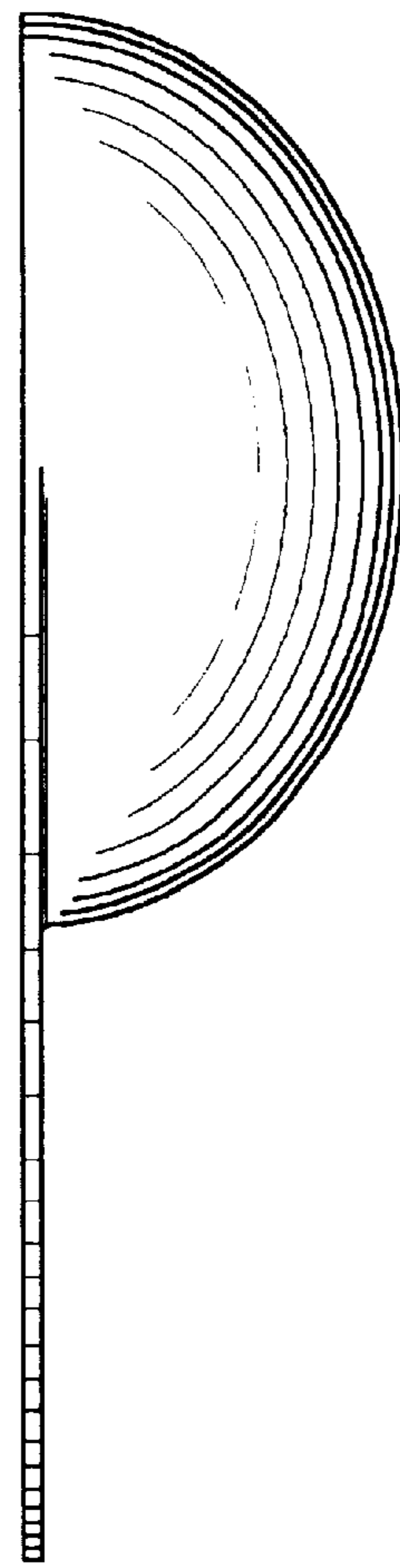

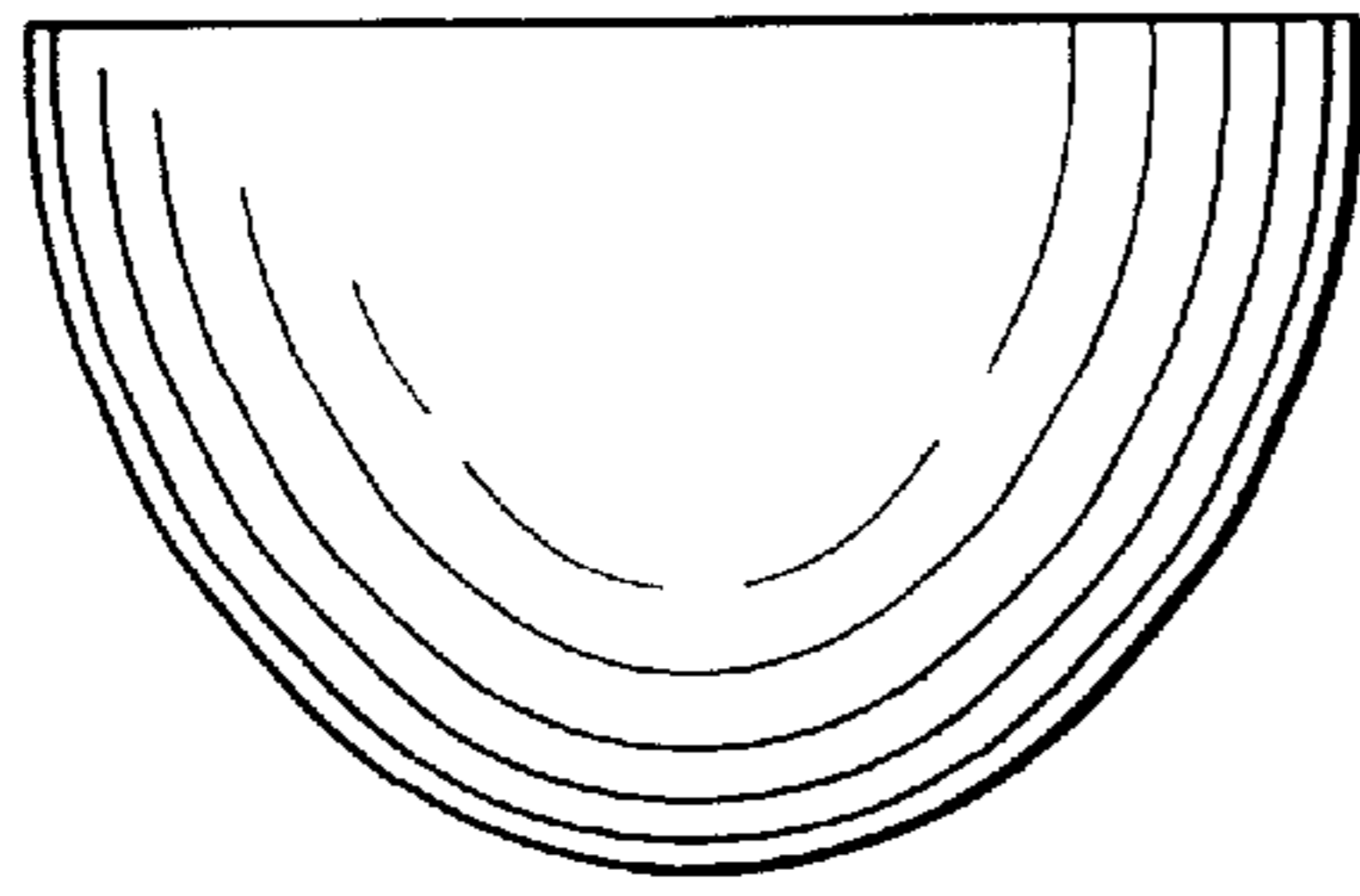

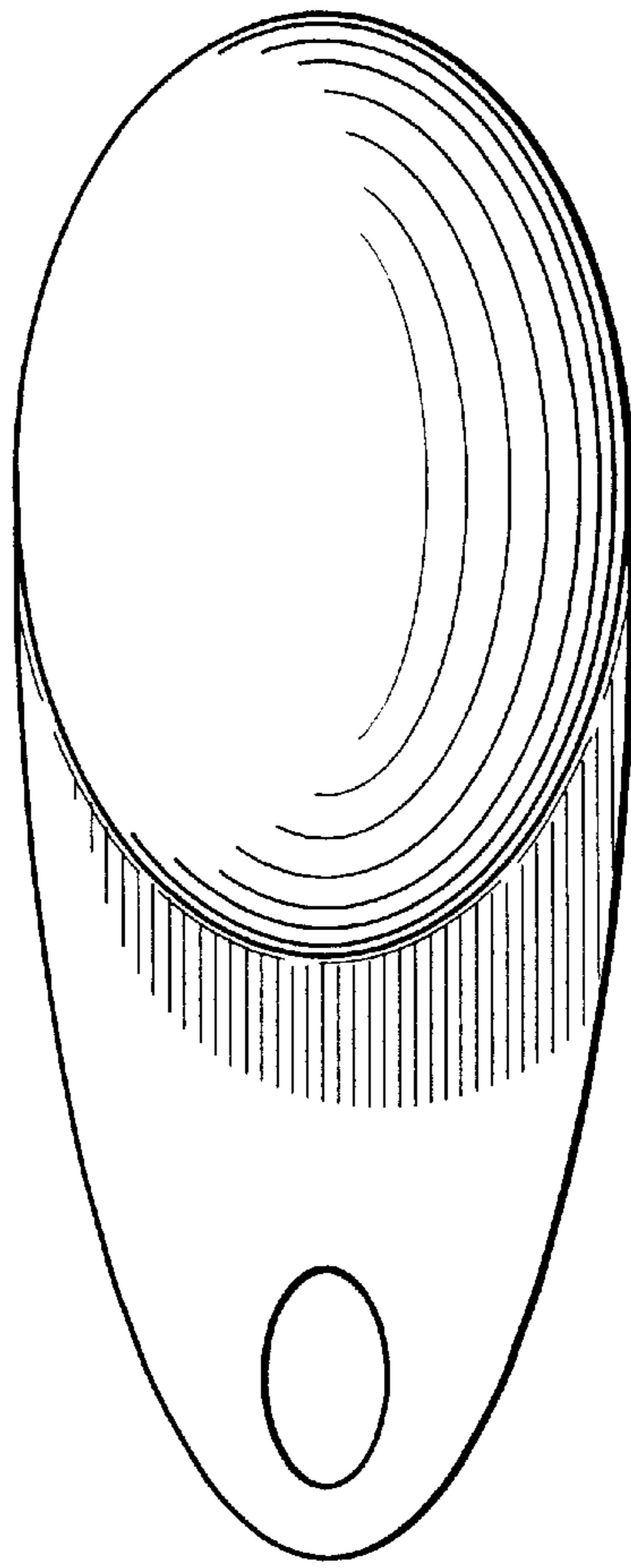

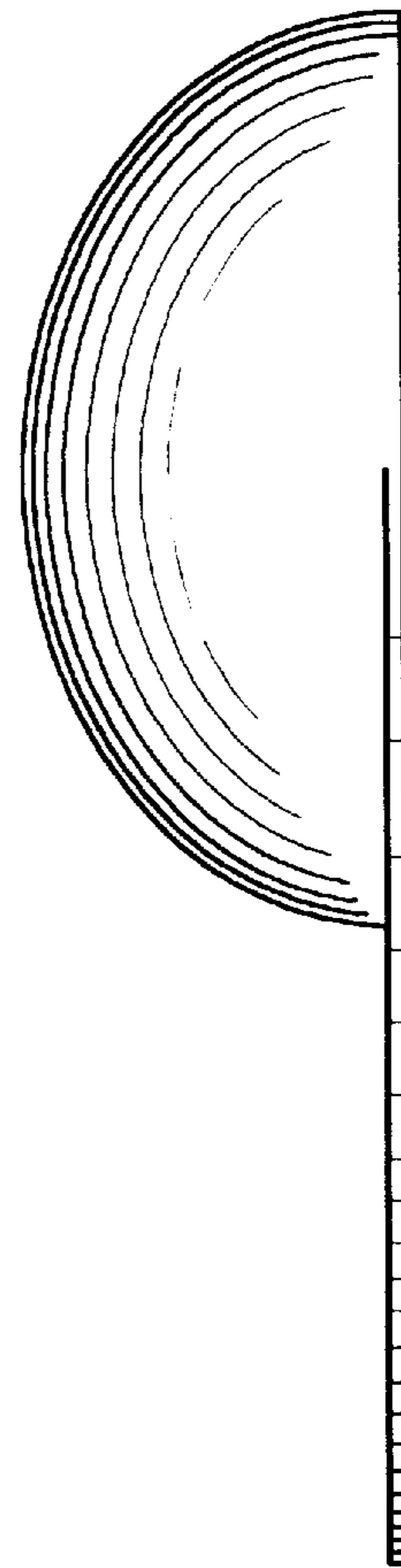

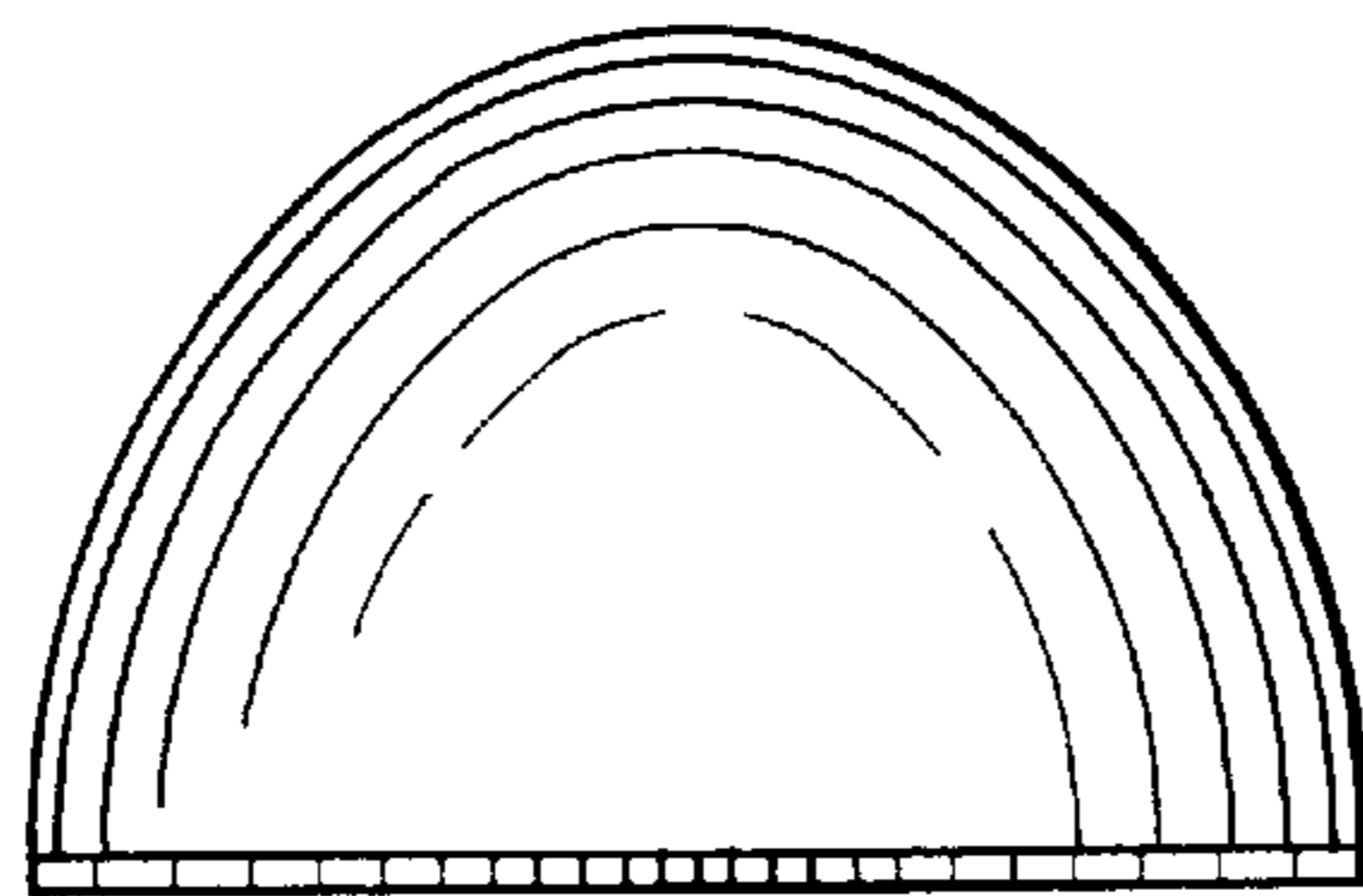

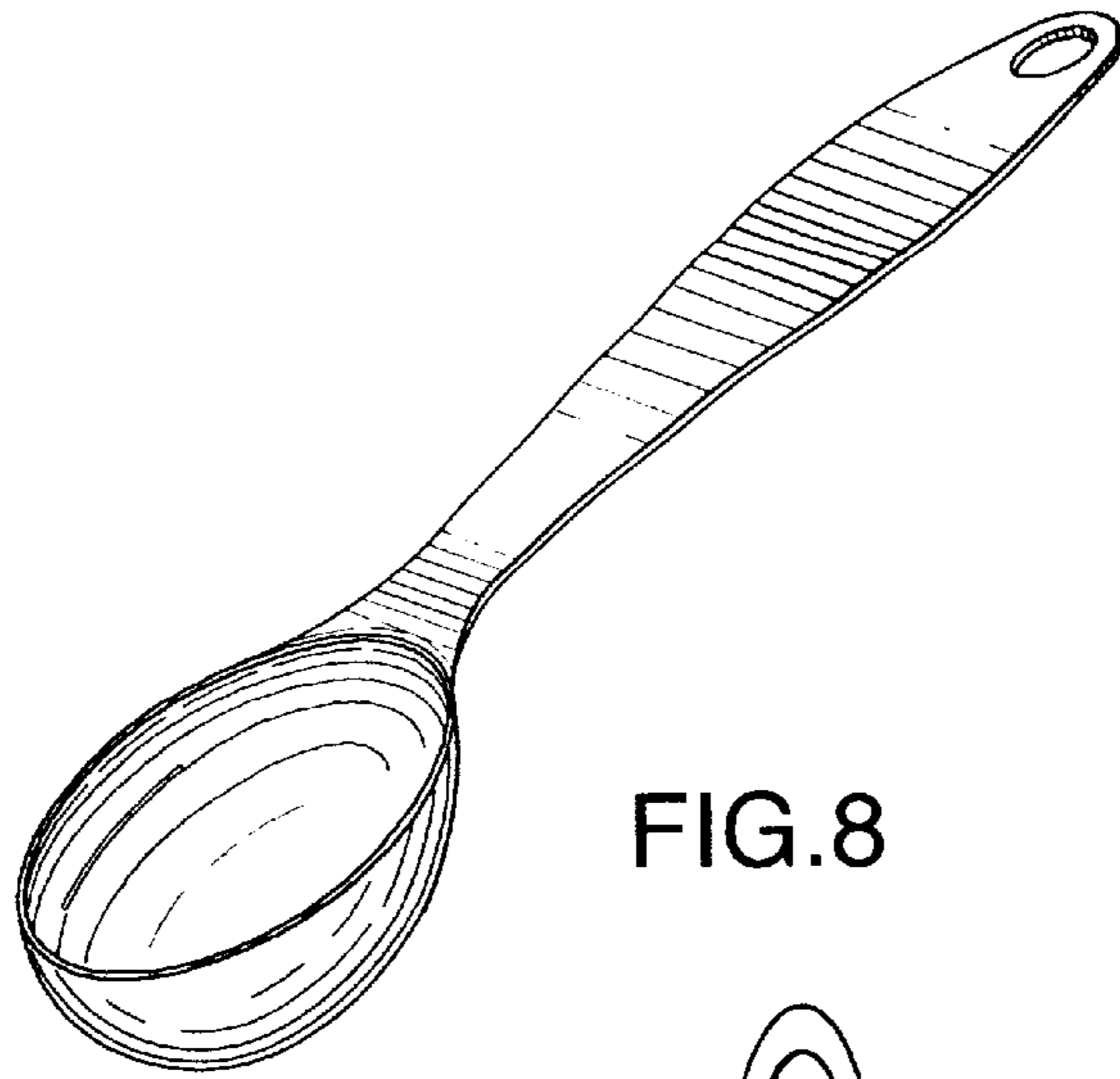

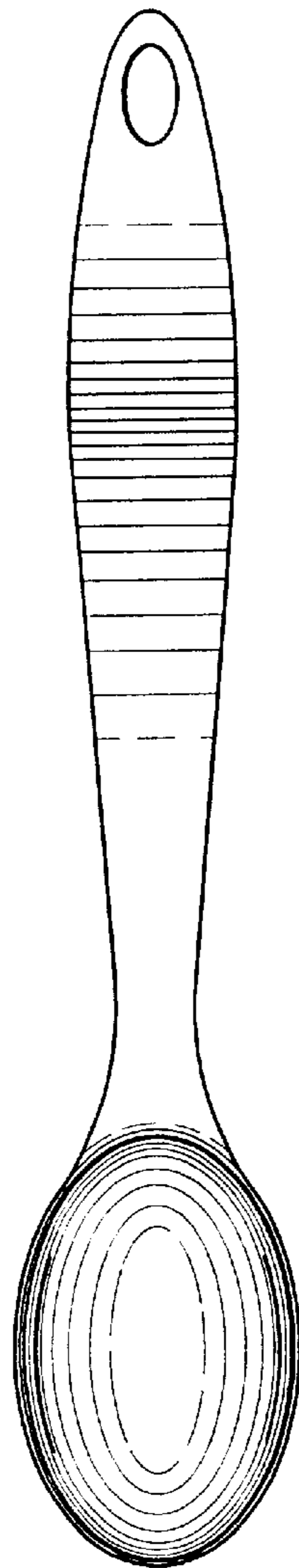

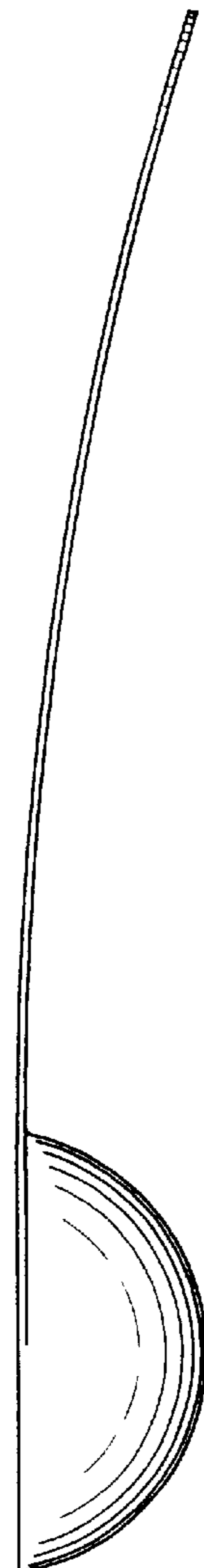

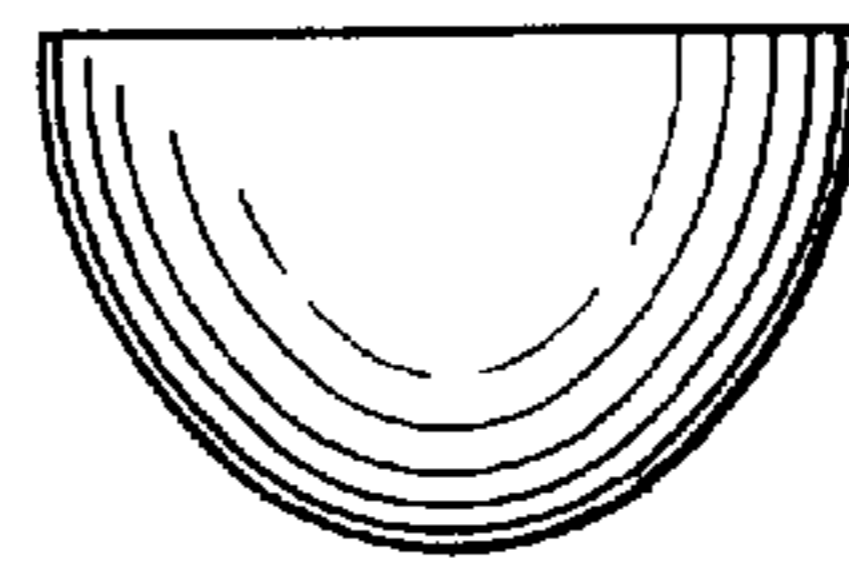

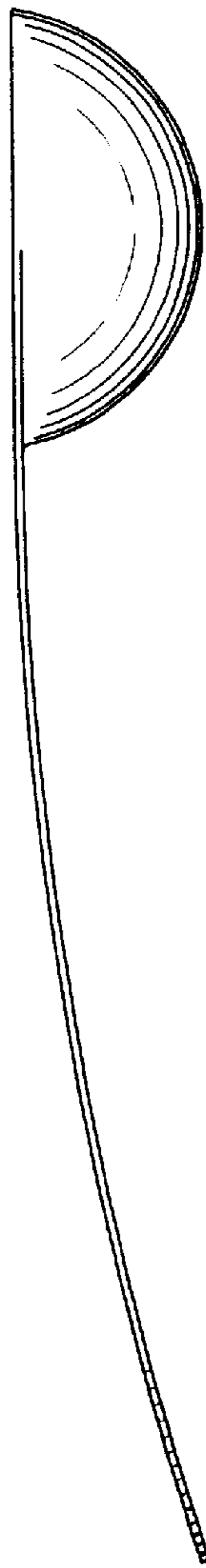

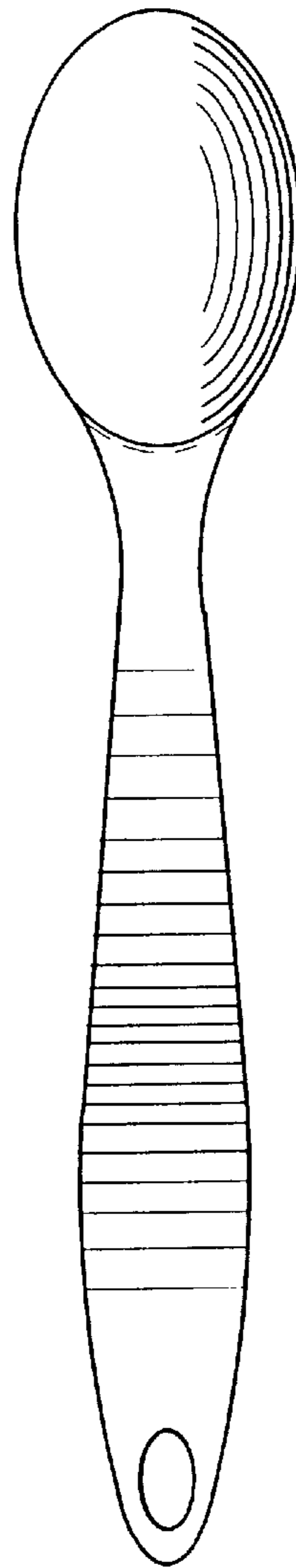

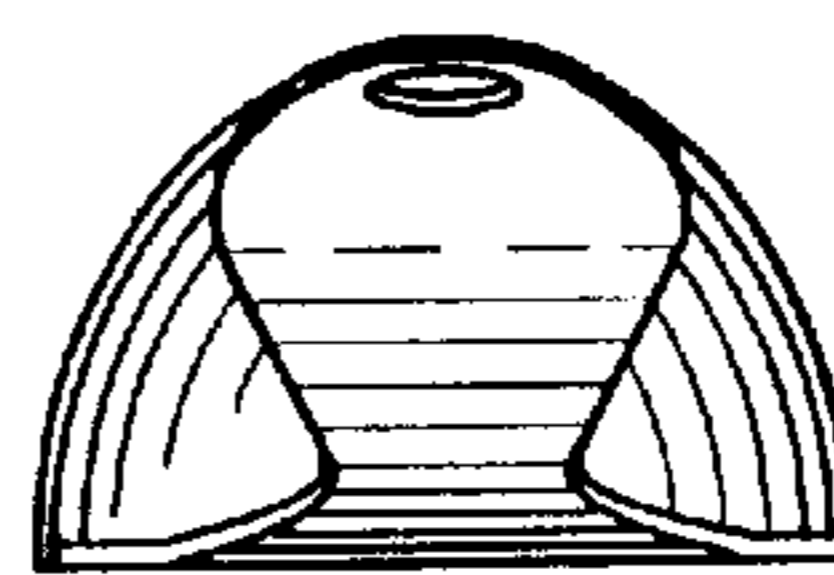

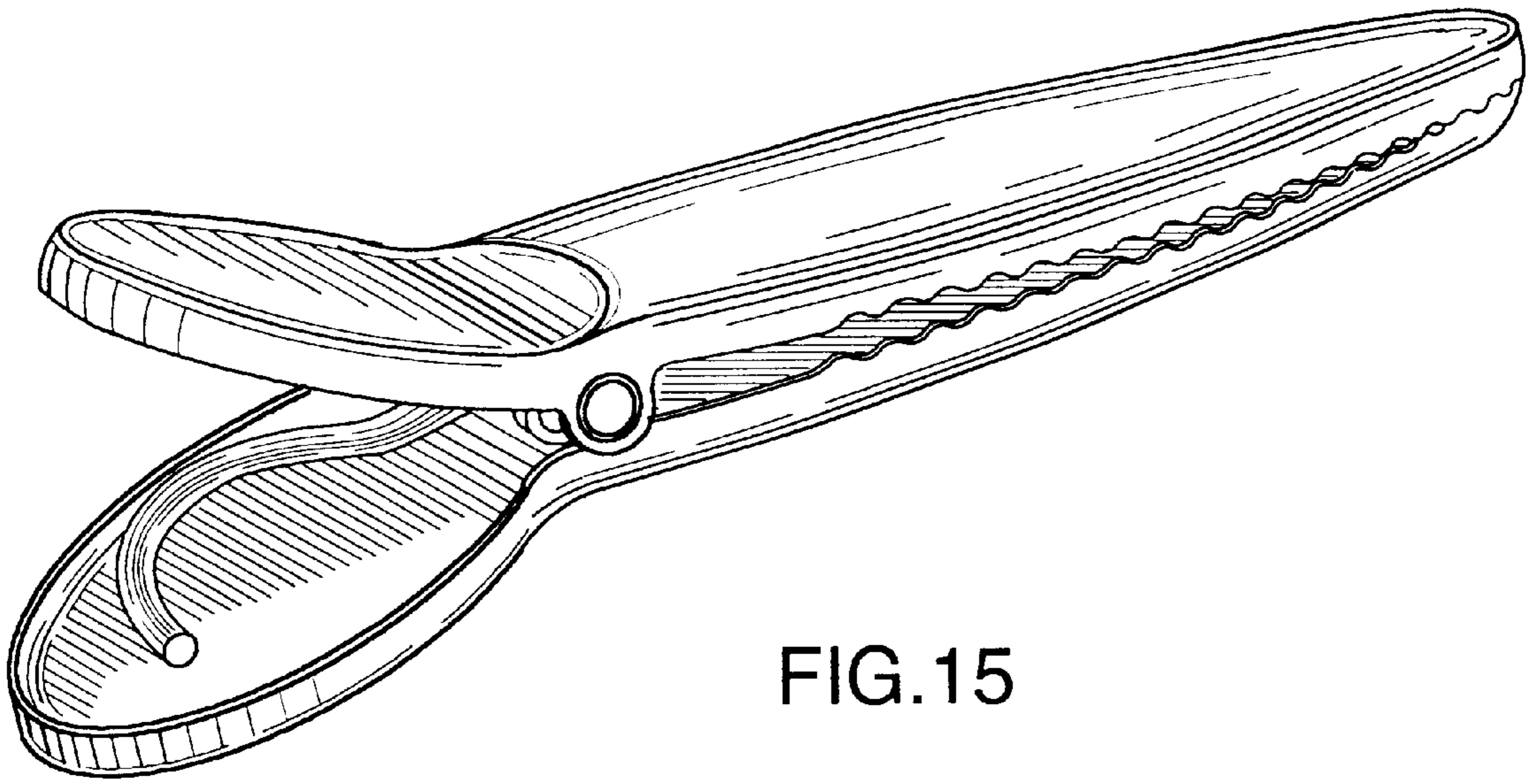

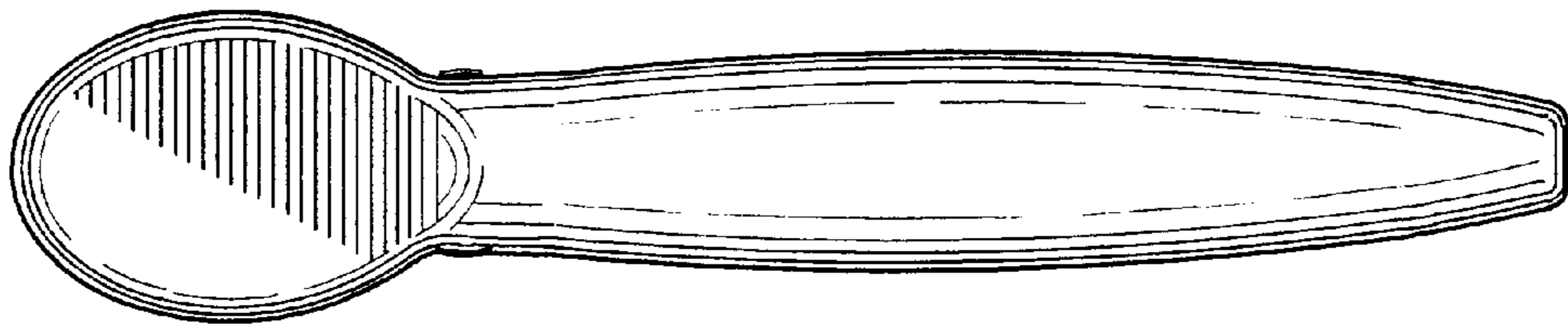

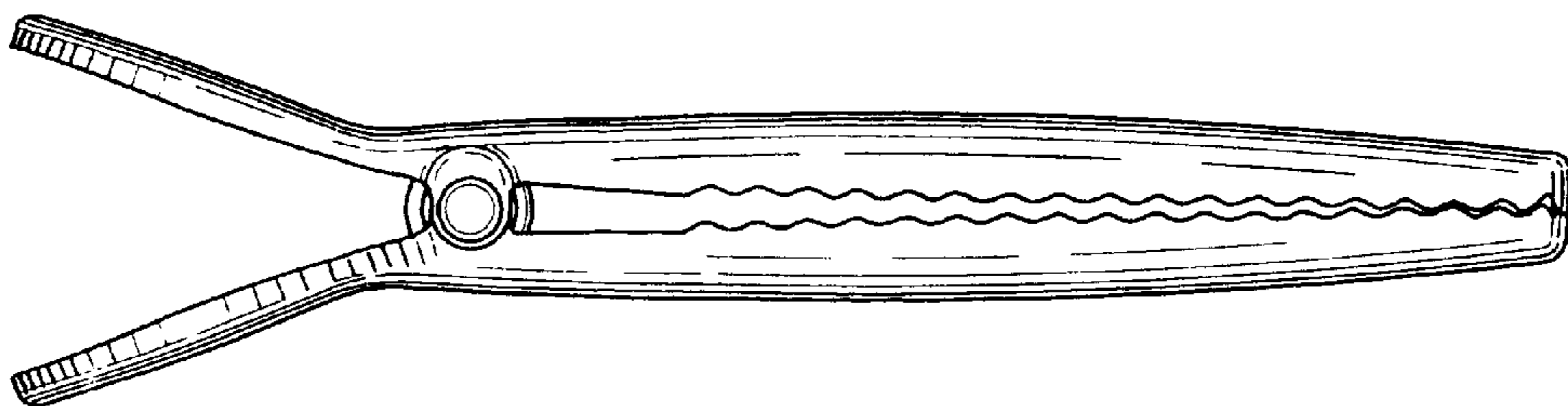

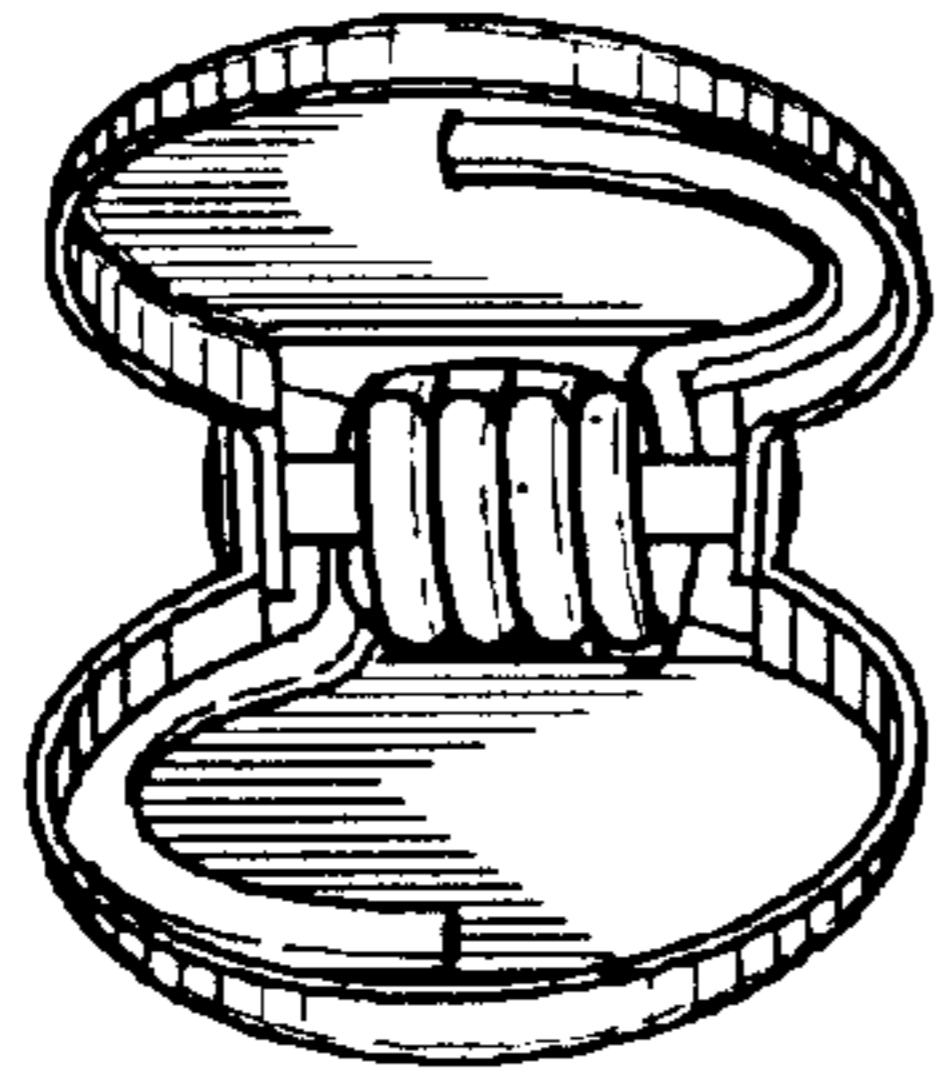

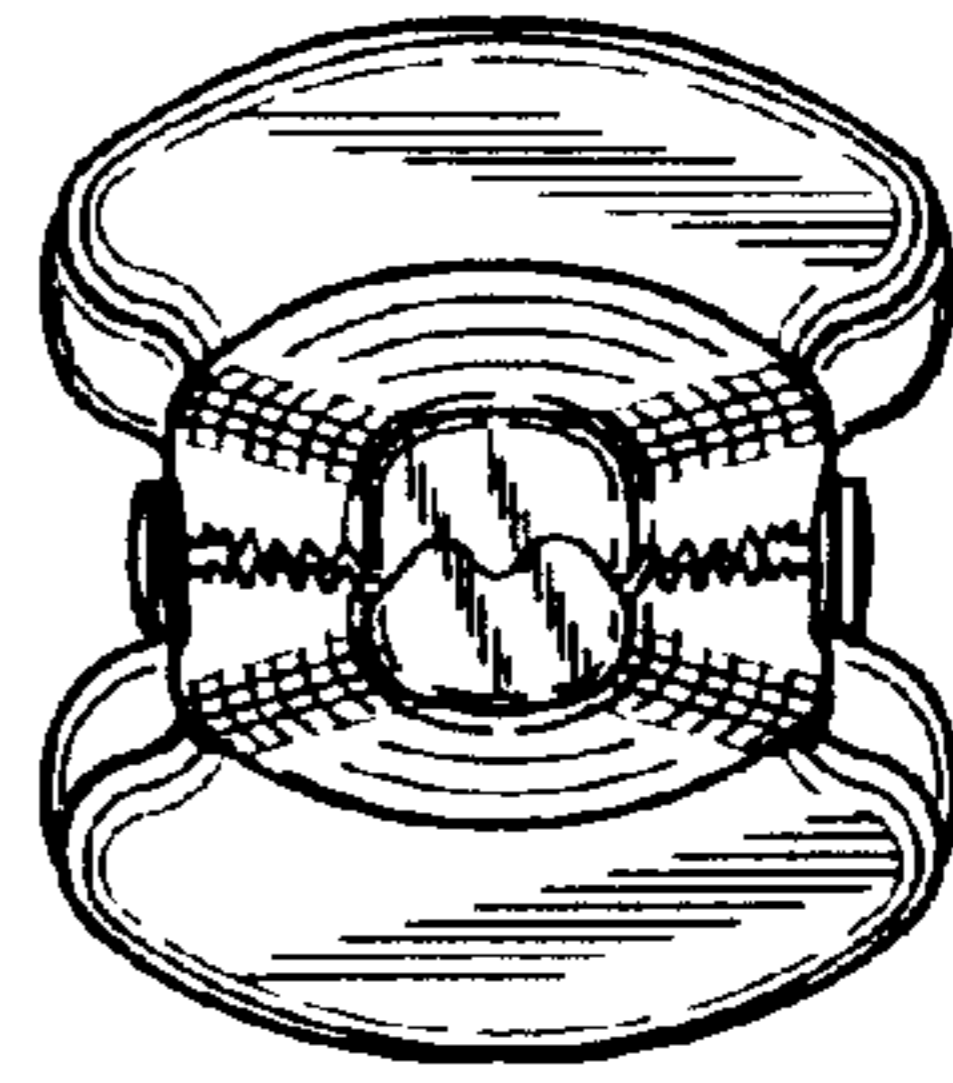

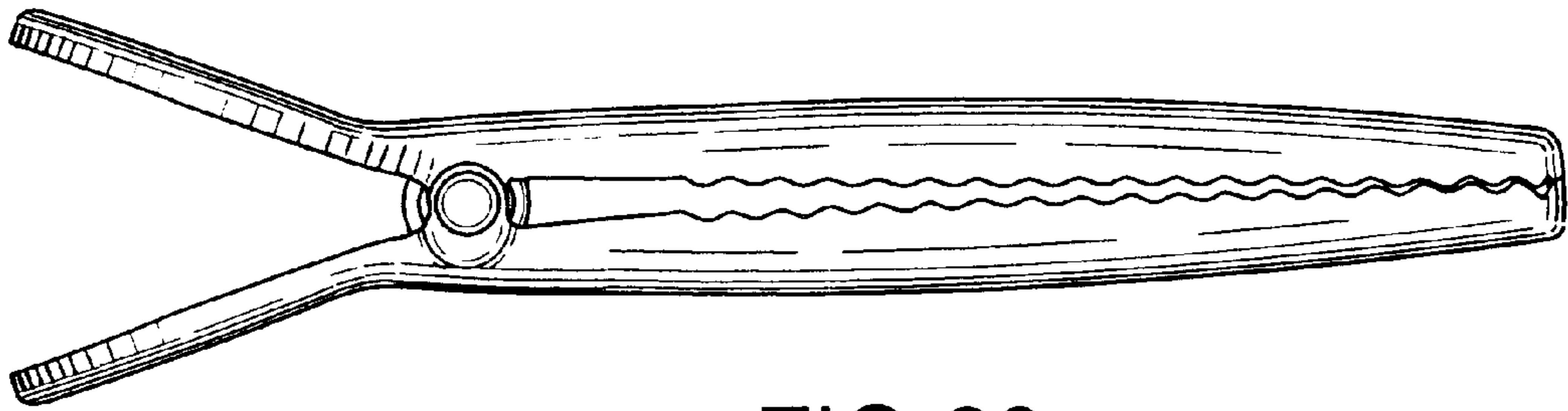

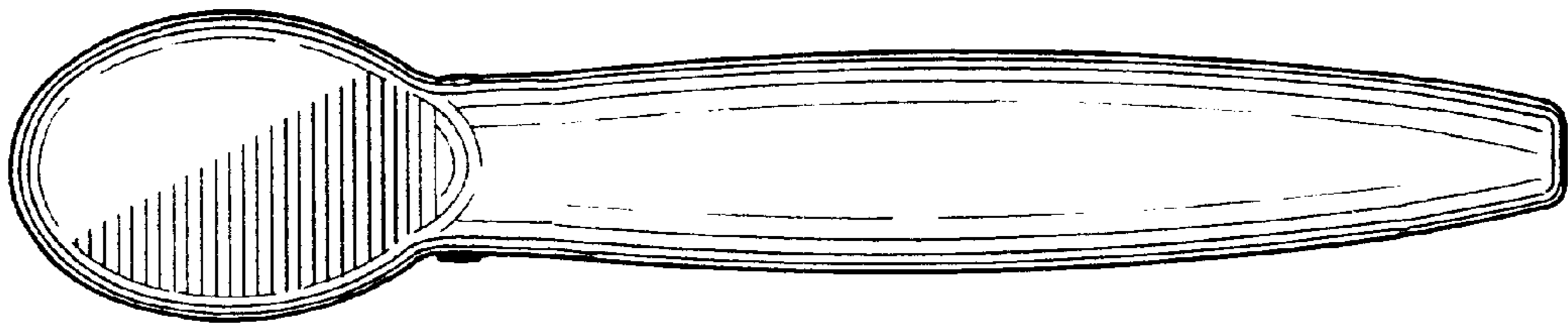

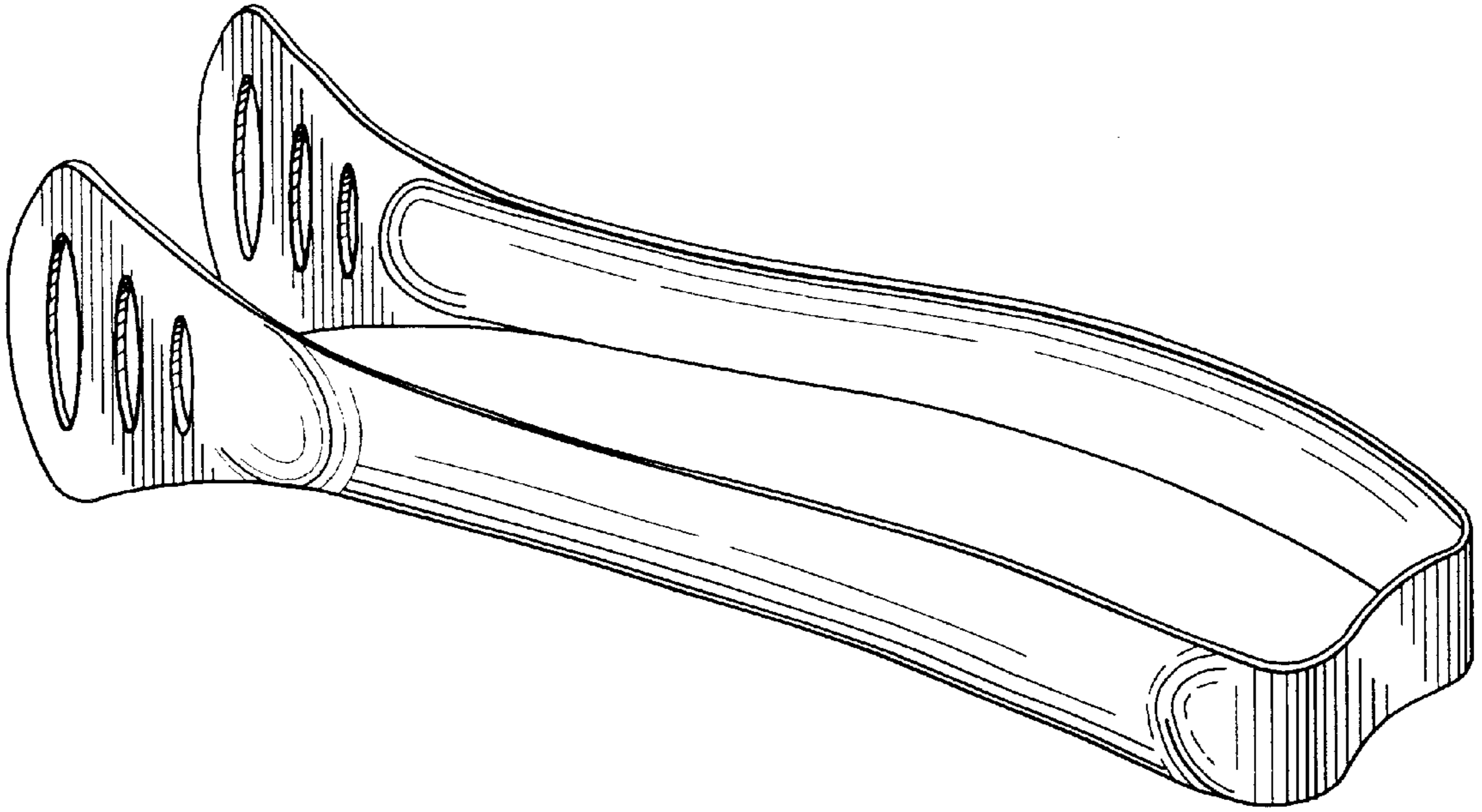

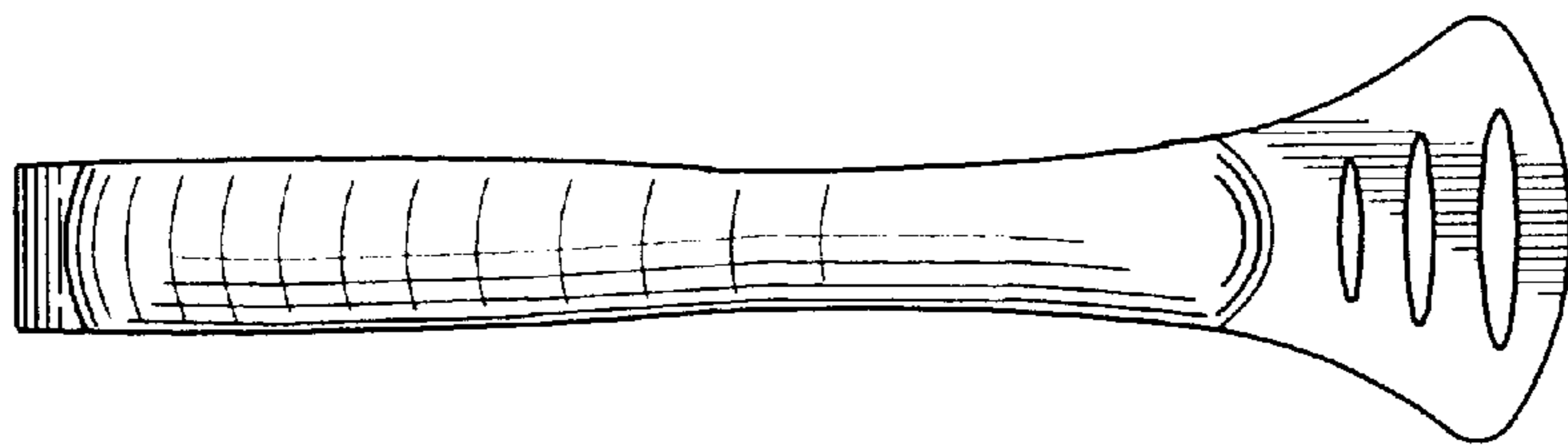

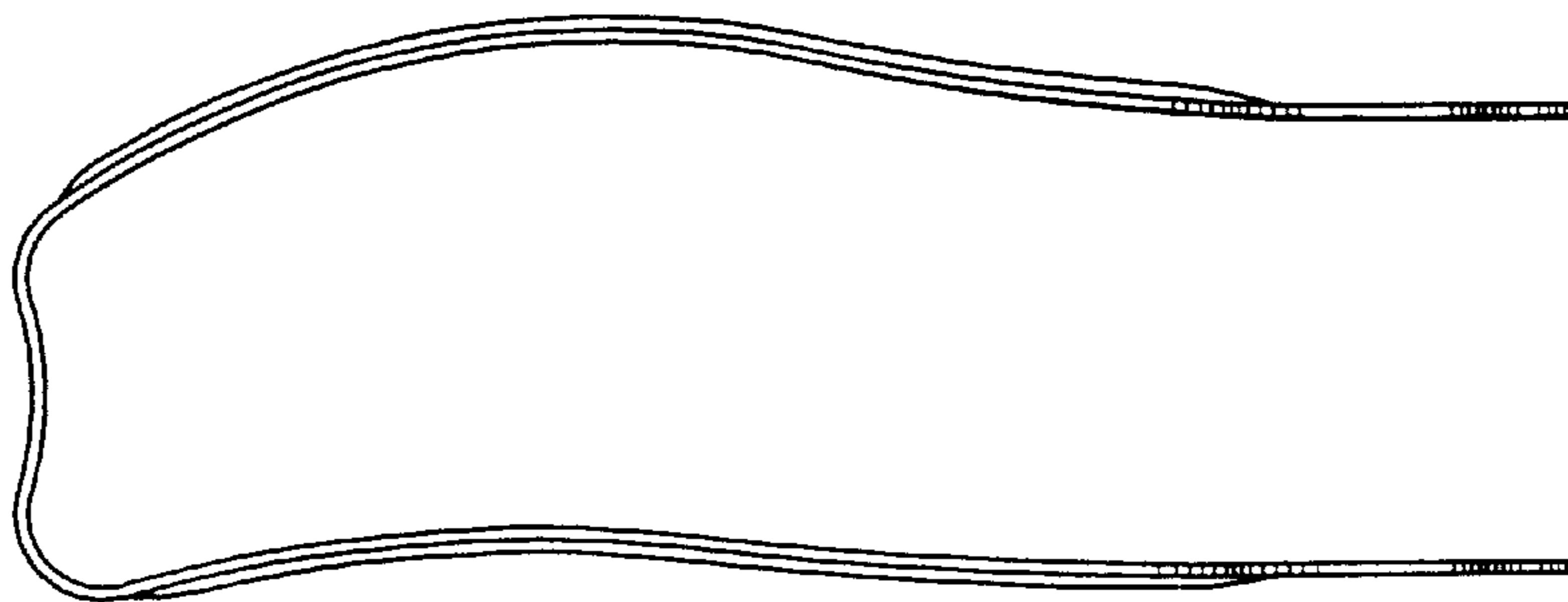

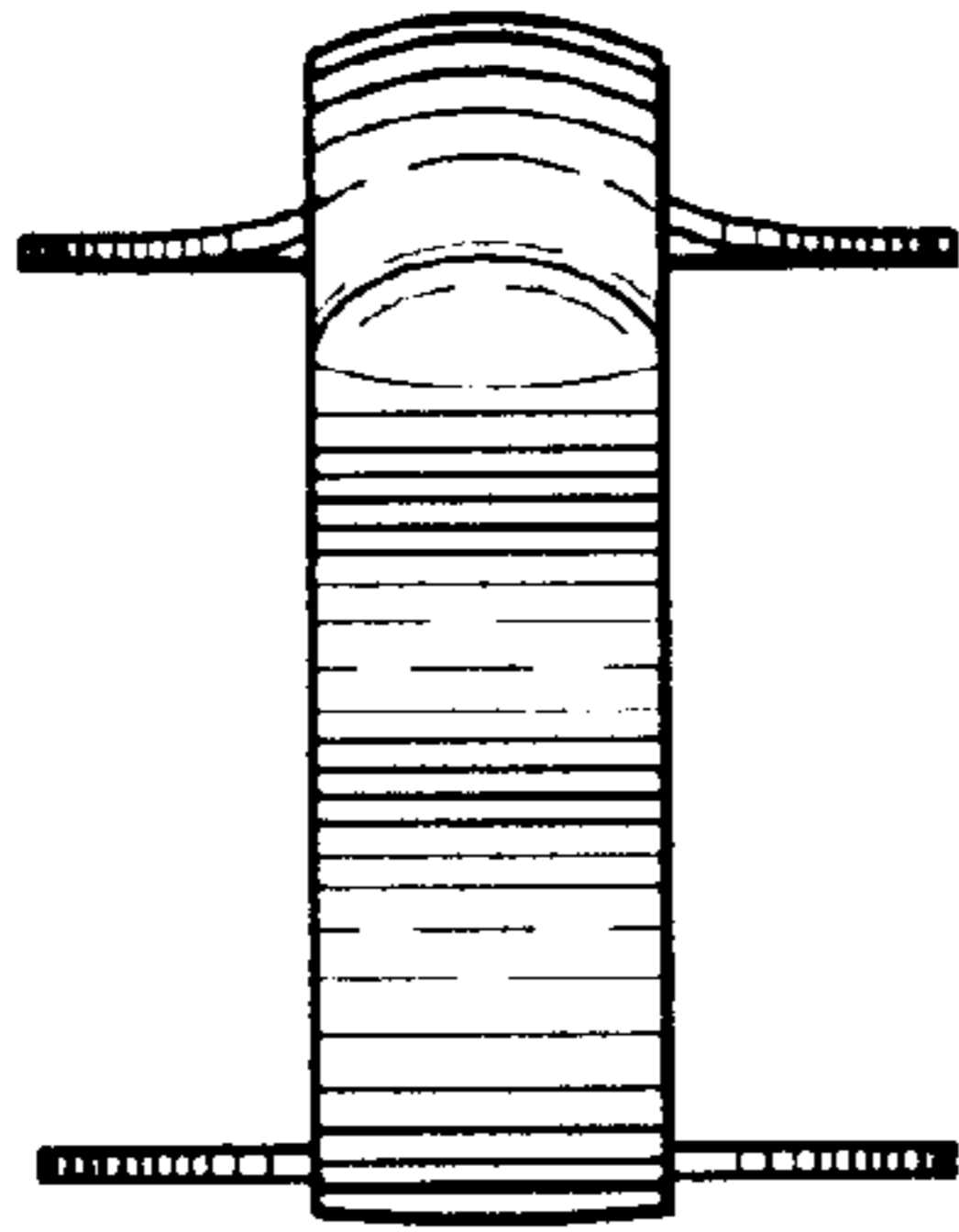

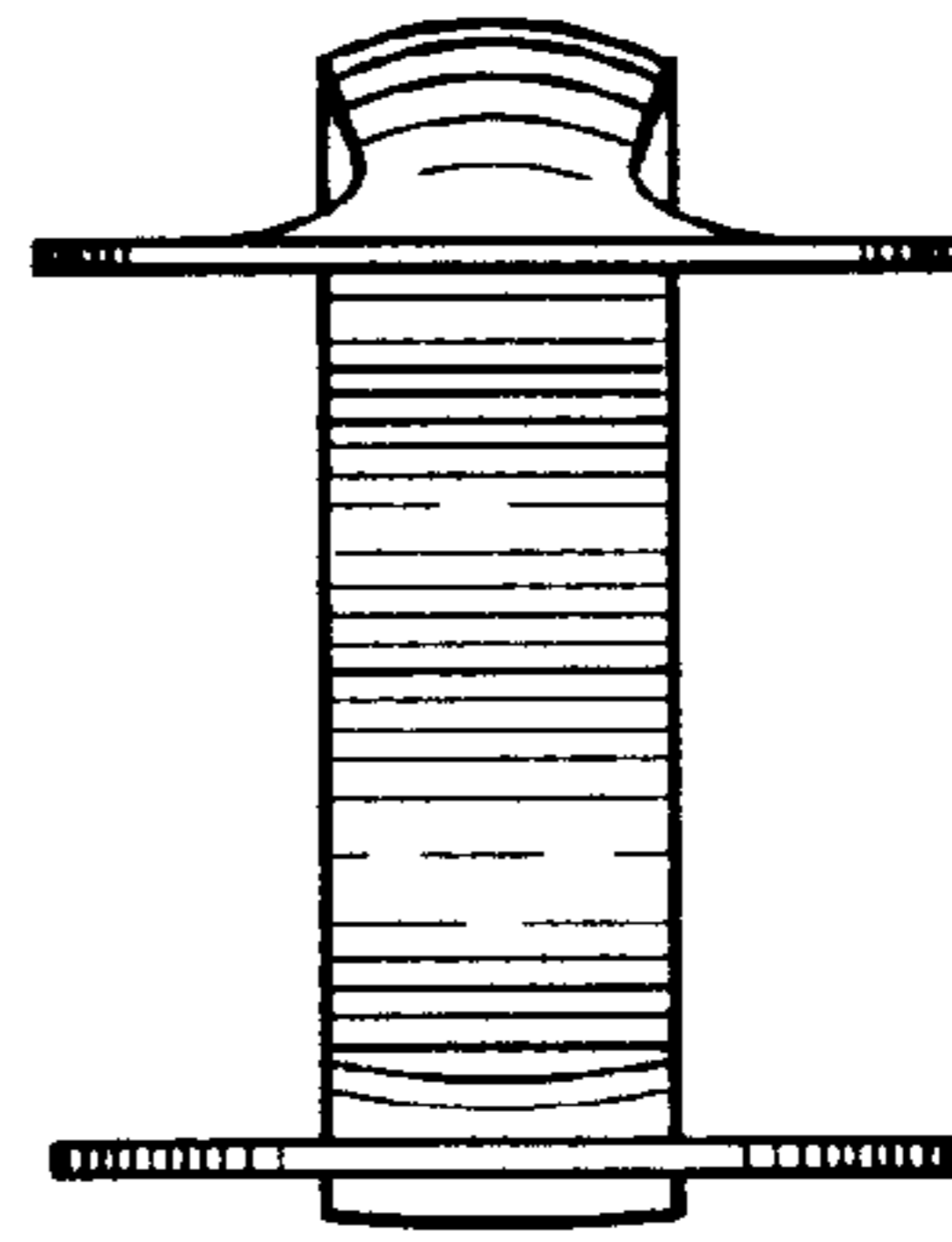

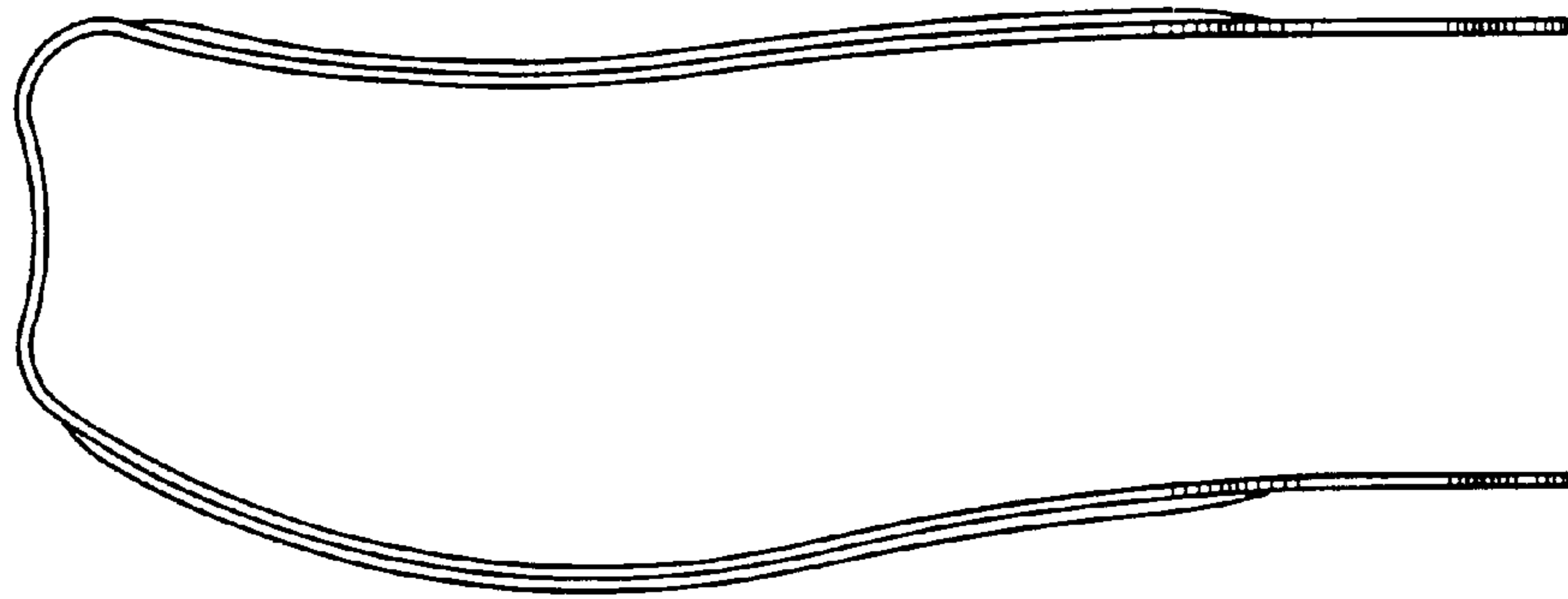

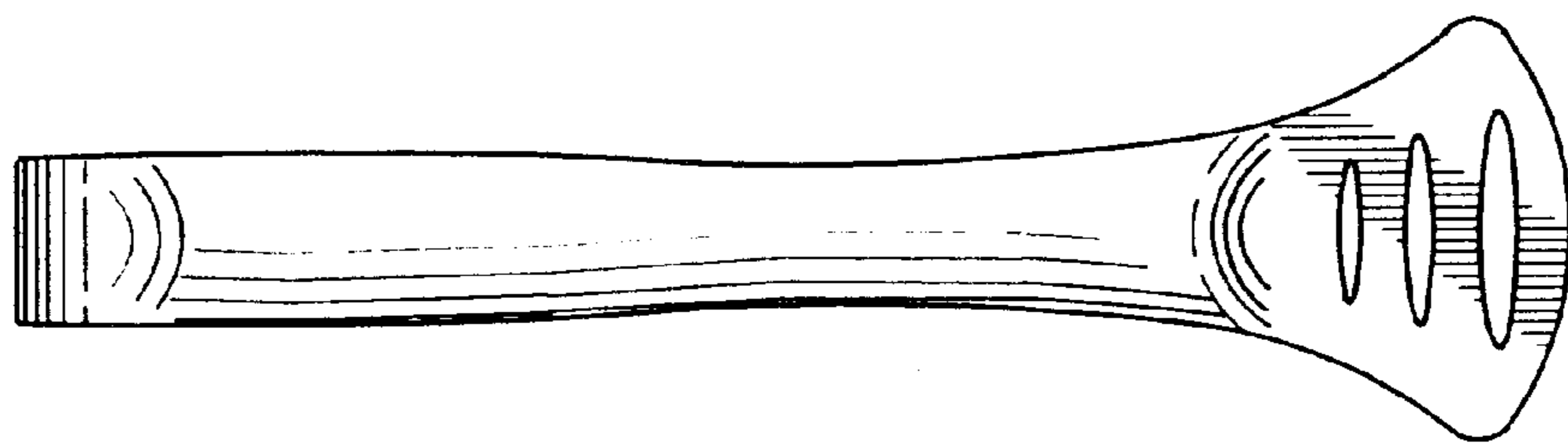

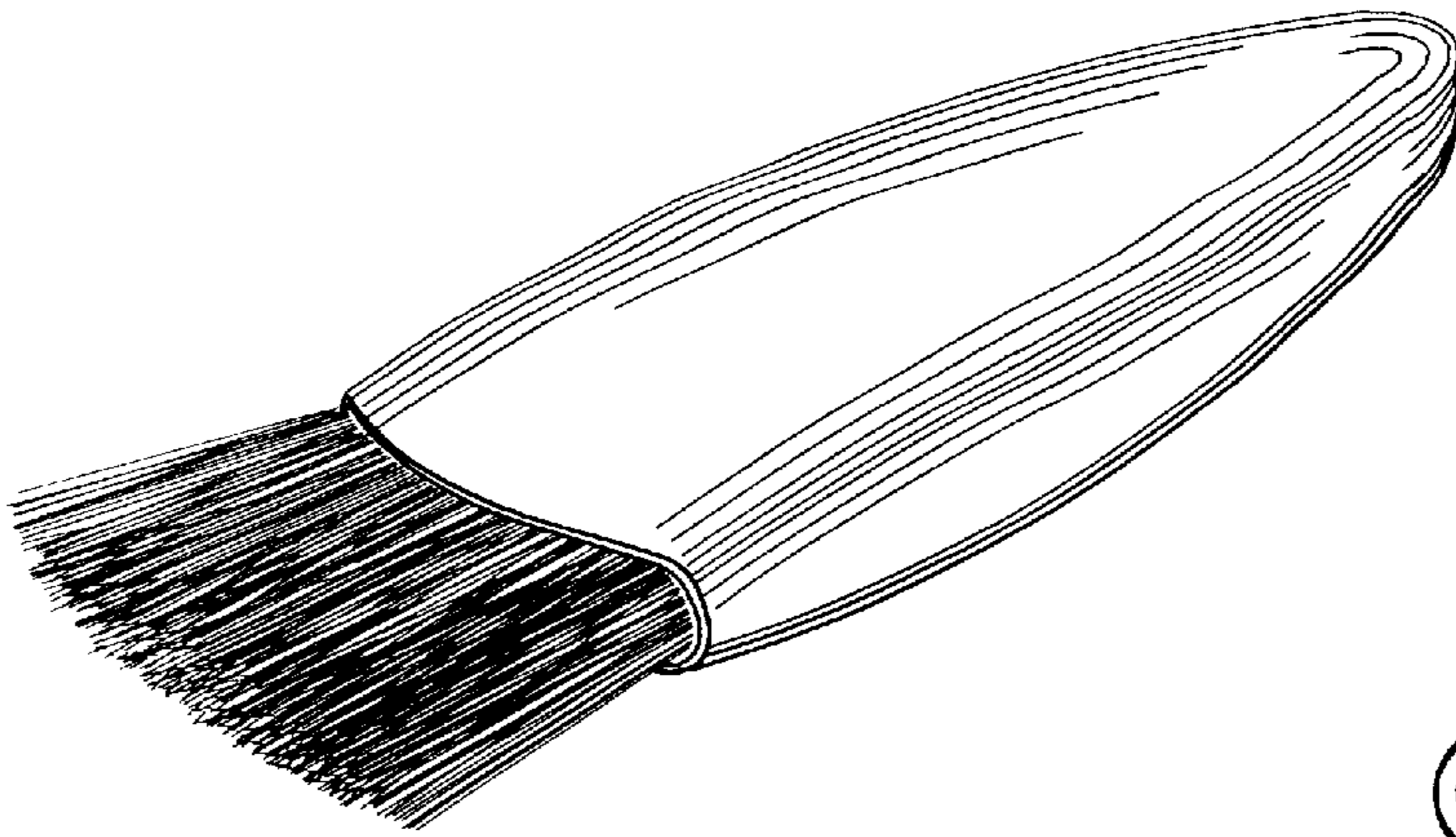

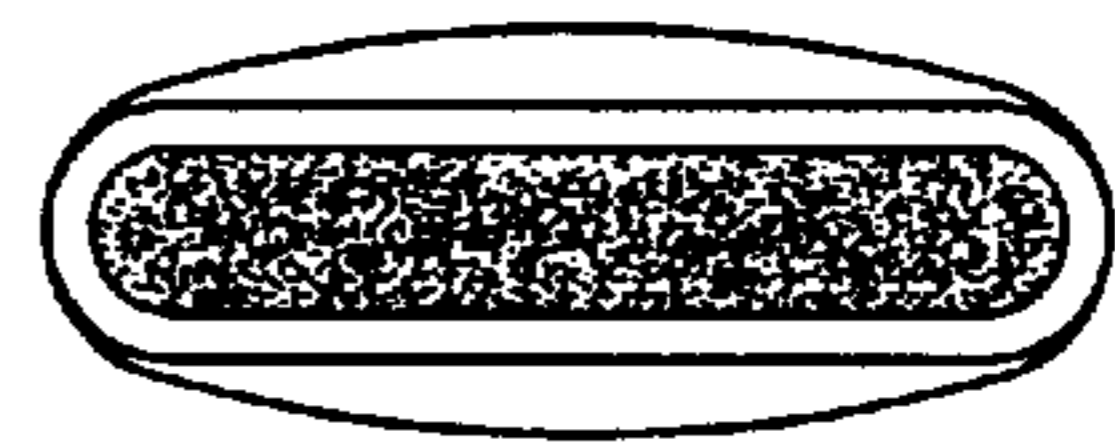

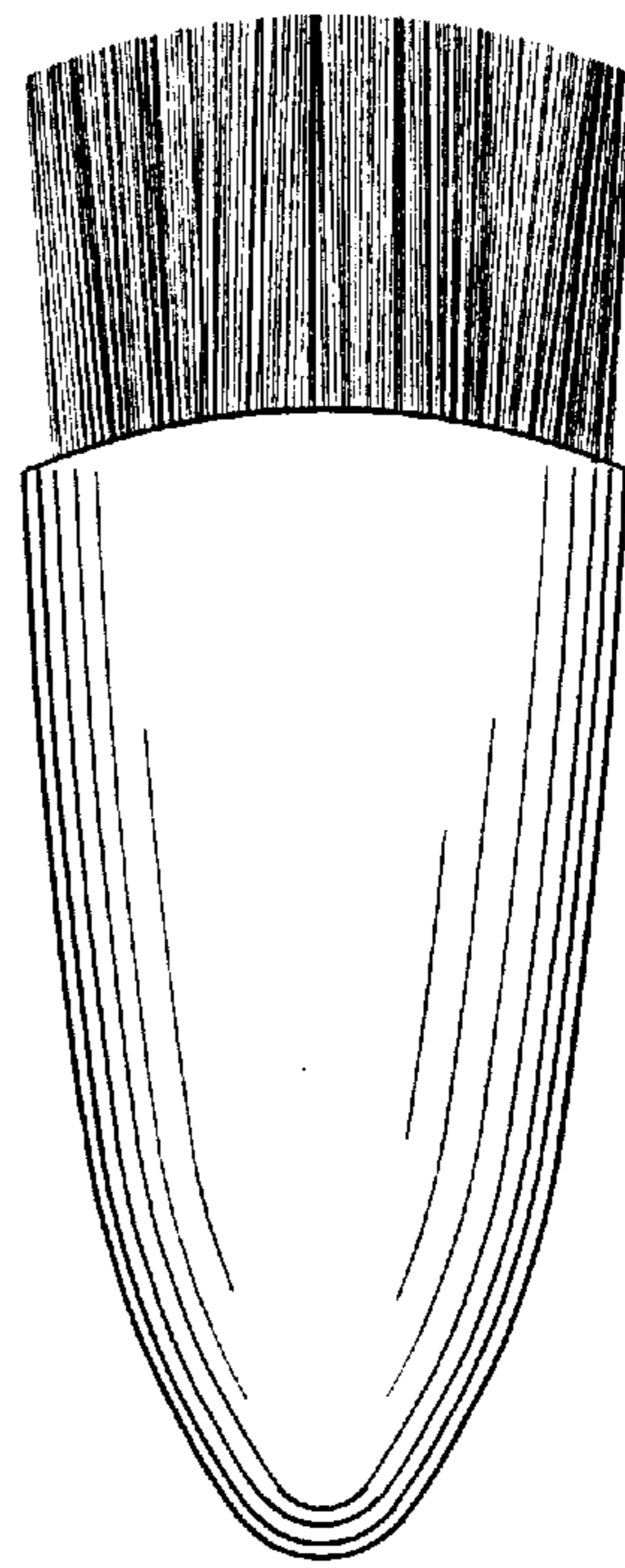

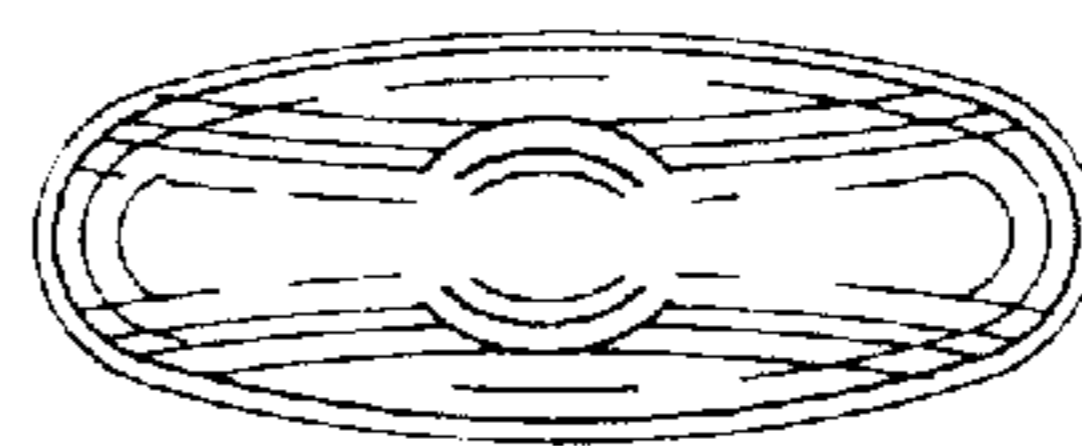

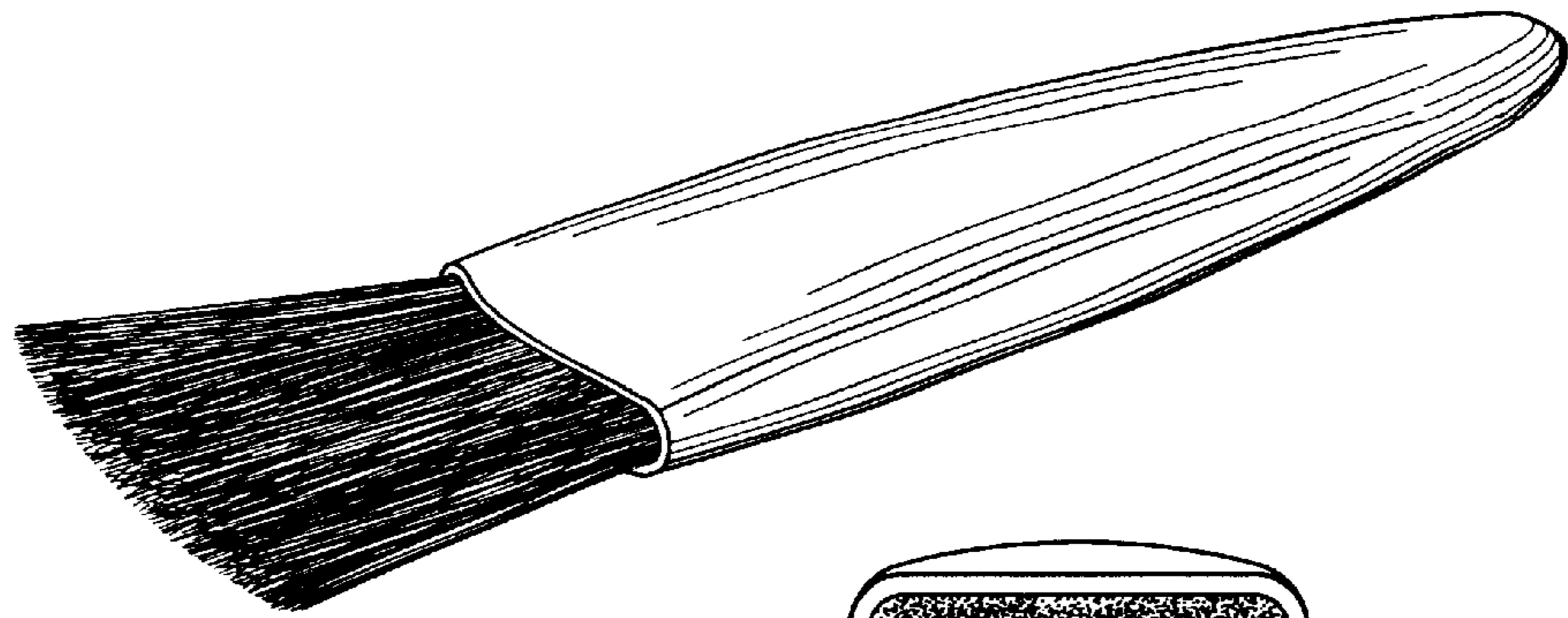

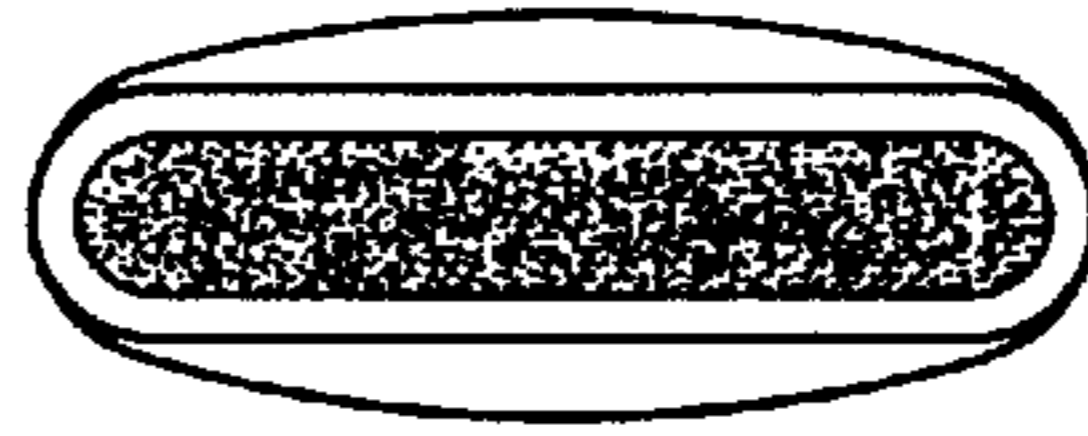

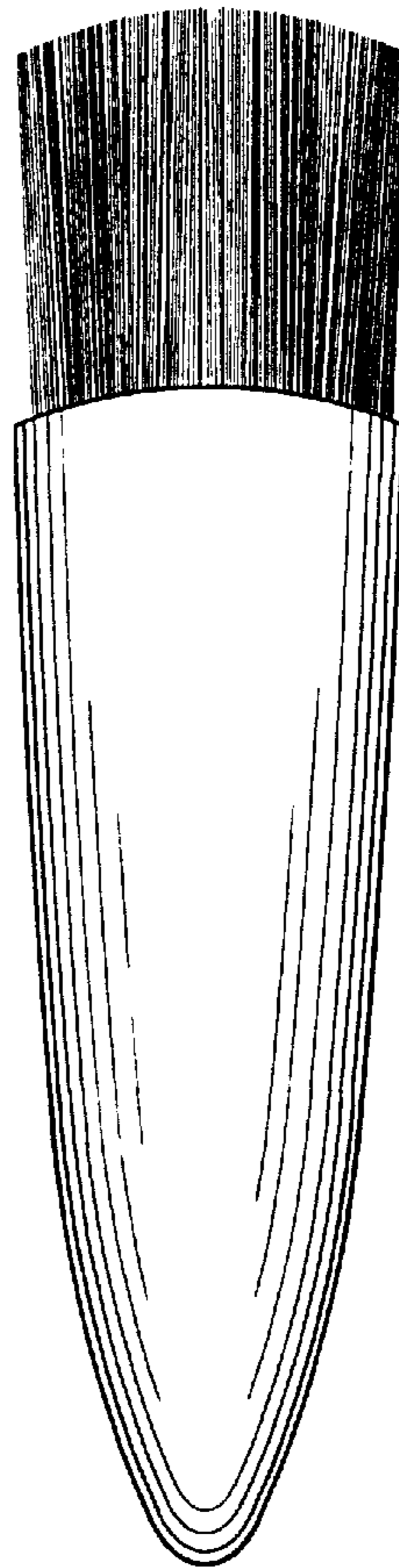

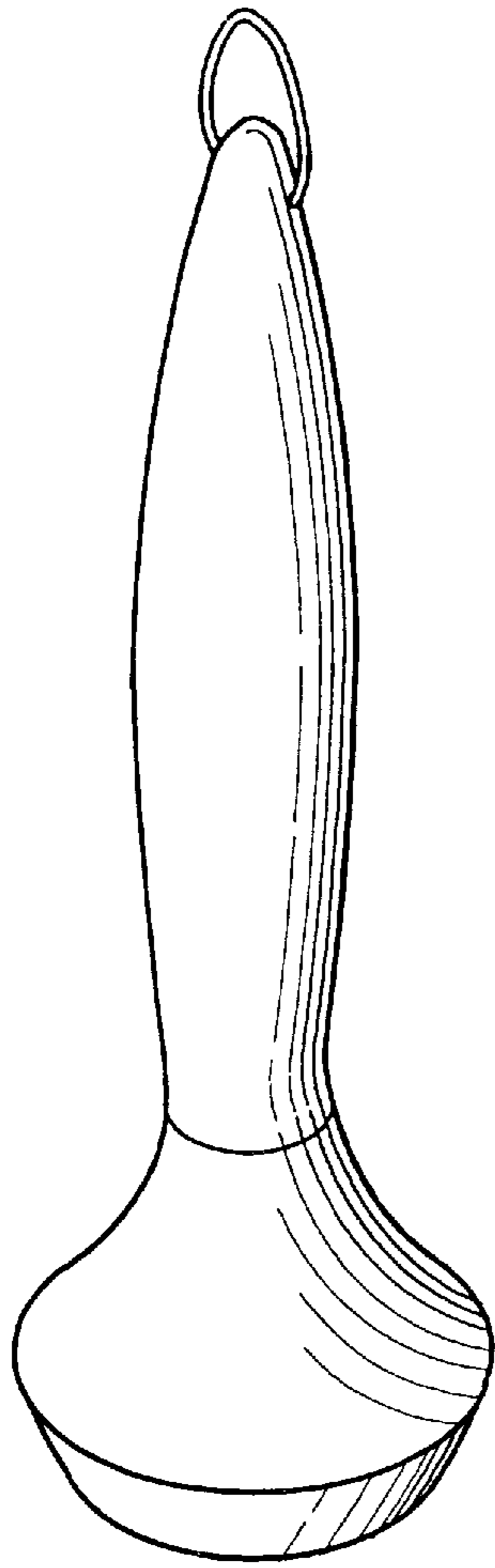

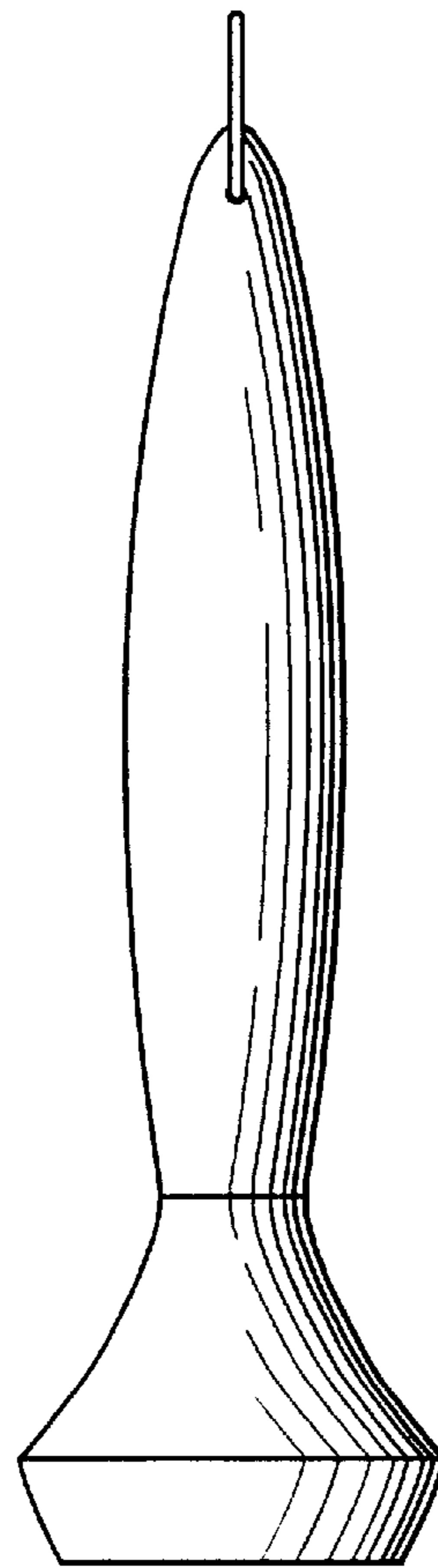

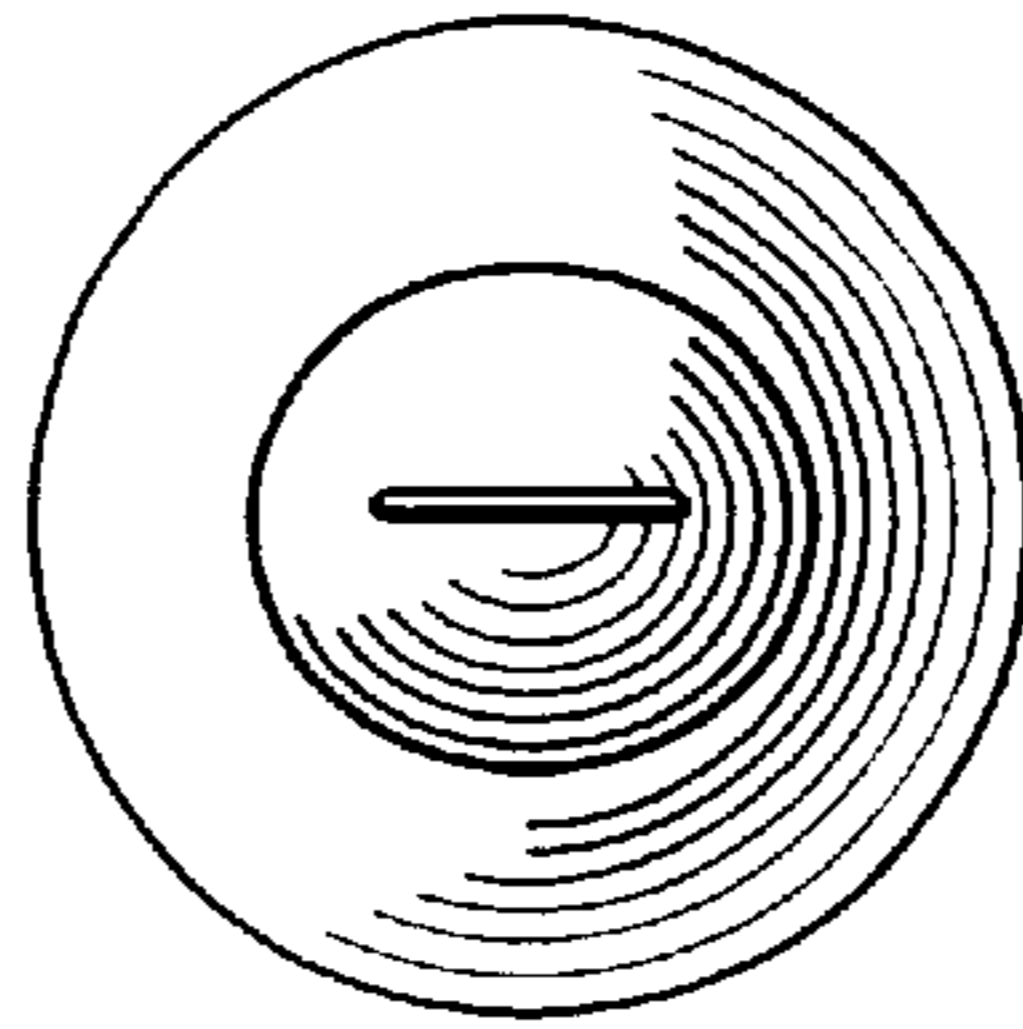

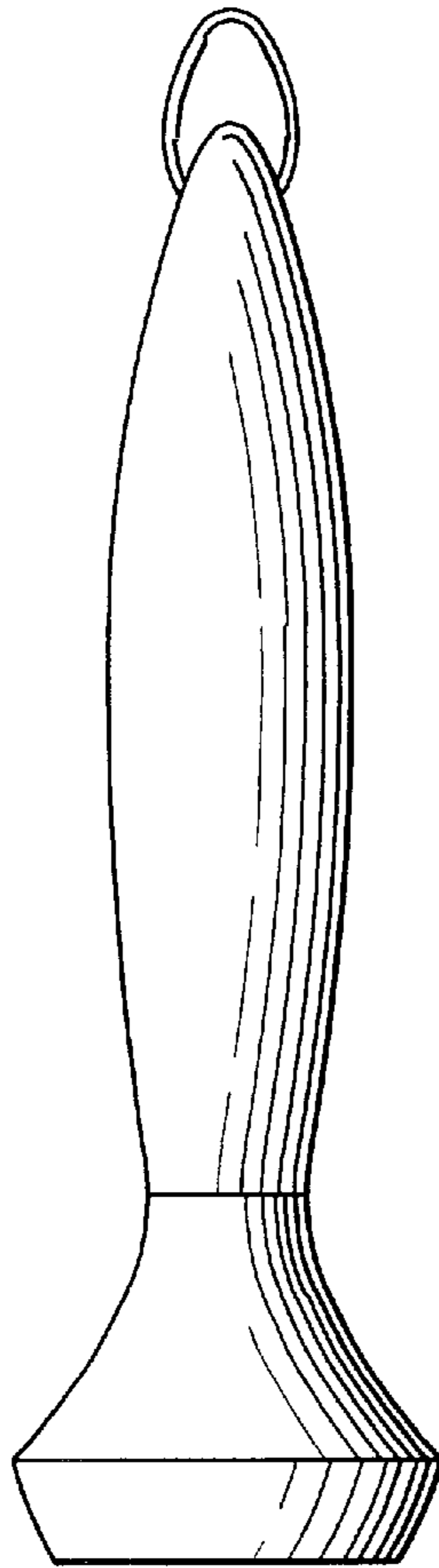

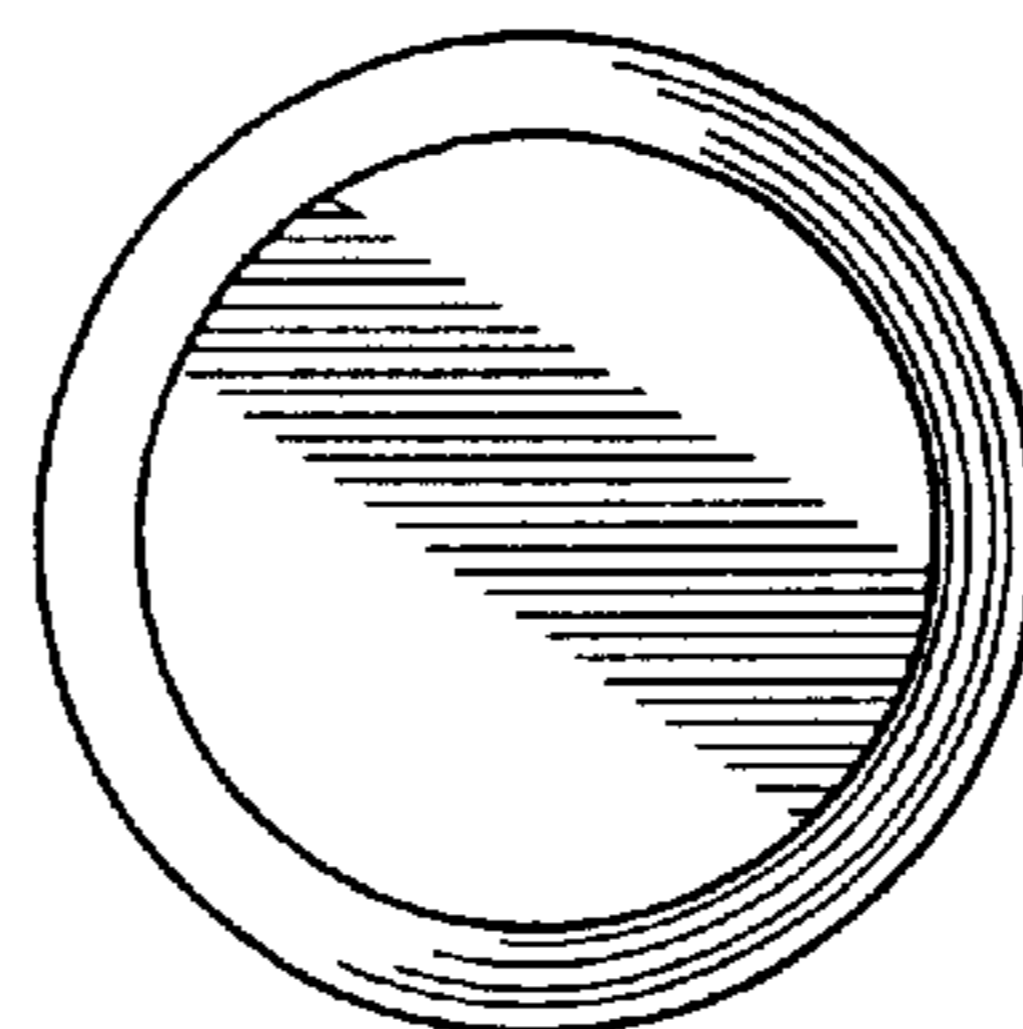
