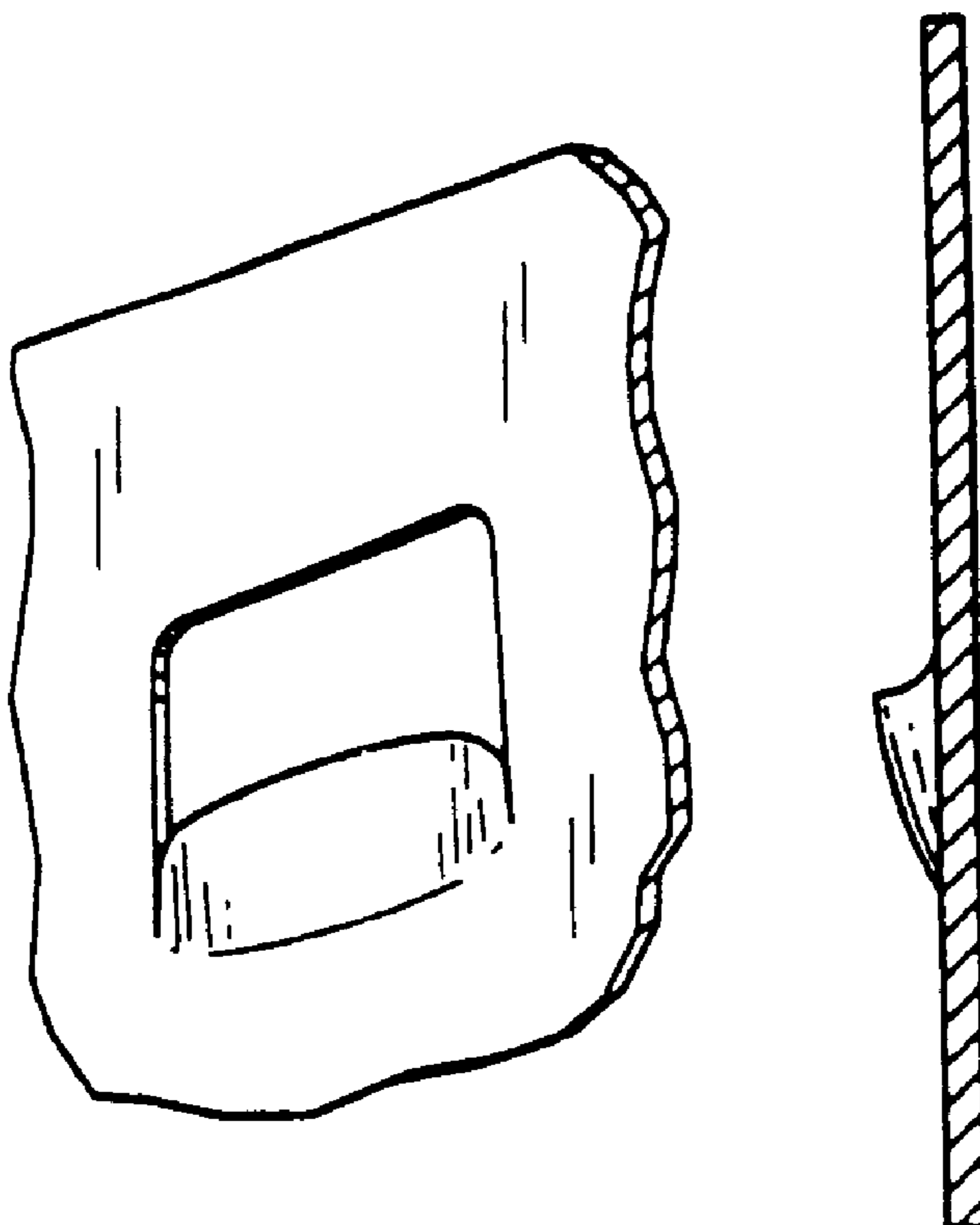
(57) **CLAIM**

The ornamental design for a portion of a grater, as shown and described.

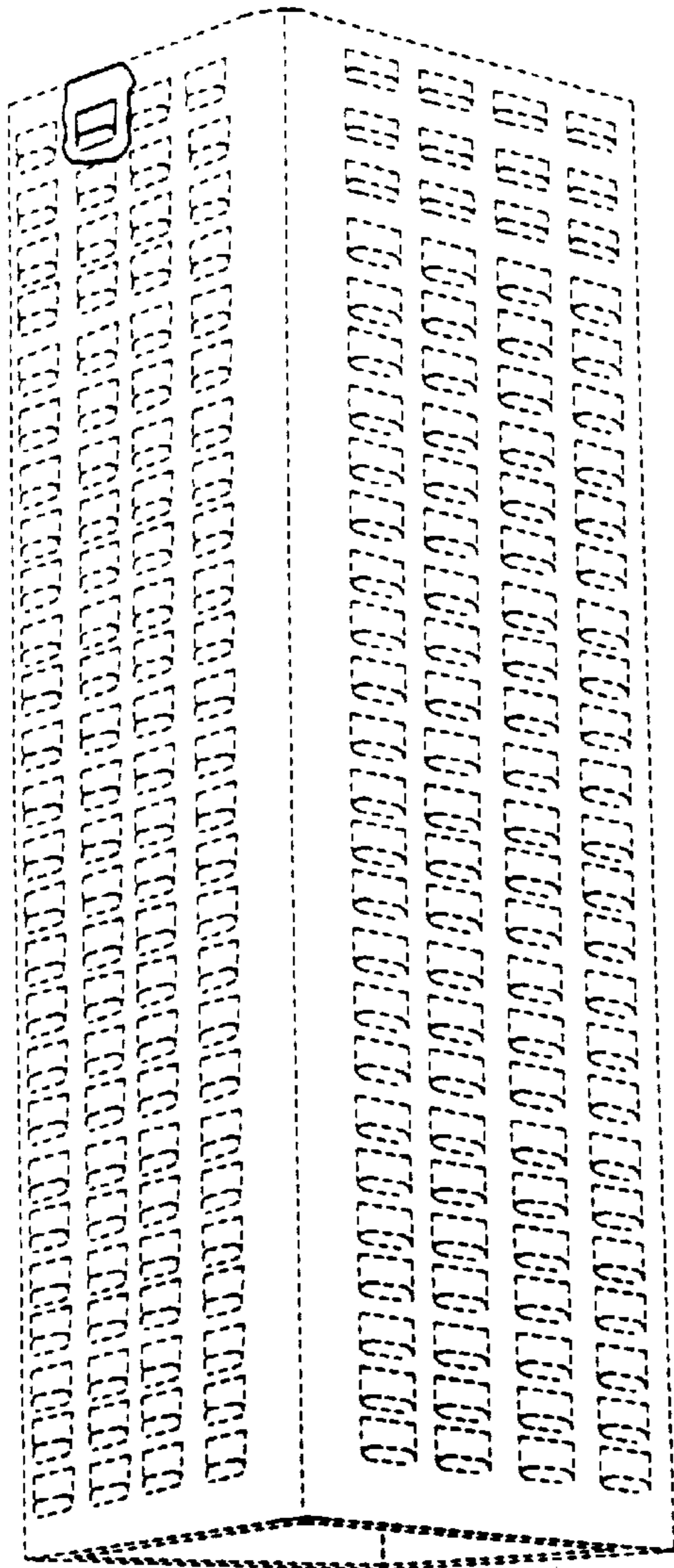
**DESCRIPTION**

FIG. 1 is a perspective view of the portion of a grater showing my new design, the broken lines are for illustrative purposes only and form no part of the claimed design; FIG. 2 is an enlarged perspective view thereof; FIG. 3 is a top plan view of FIG. 2; FIG. 4 is a front elevation view of FIG. 2; FIG. 5 is a bottom plan view of FIG. 2; FIG. 6 is a rear elevation view of FIG. 2; FIG. 7 is a left side elevation view of FIG. 2, the right side being a mirror image; FIG. 8 is a perspective view of an alternate embodiment of FIG. 1; FIG. 9 is a top plan view of FIG. 8; FIG. 10 is a front elevation of FIG. 8; FIG. 11 is a bottom plan view of FIG. 8; FIG. 12 is a rear elevation of FIG. 8; and, FIG. 13 is a left side elevation of FIG. 8, the right side being a mirror image.

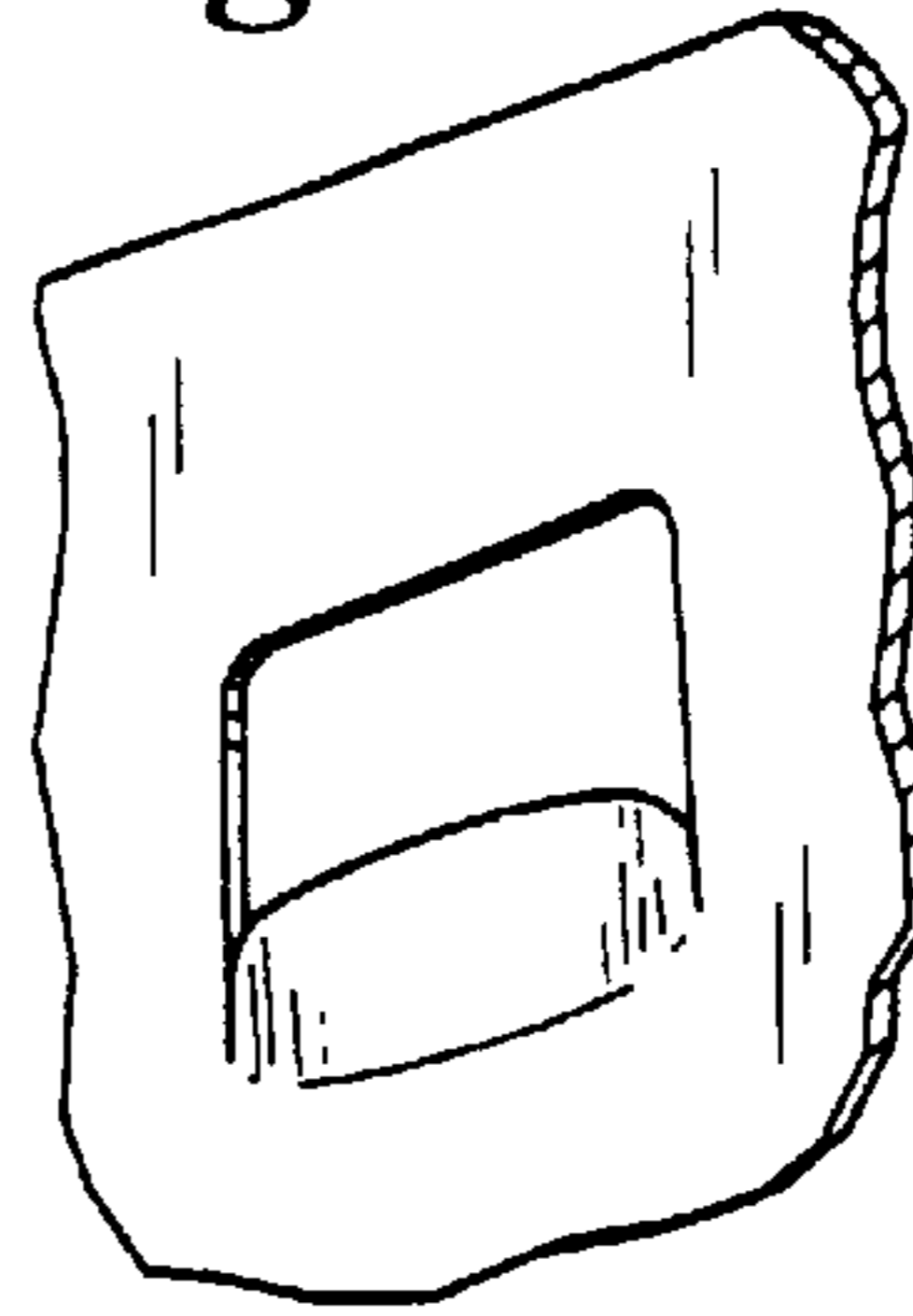

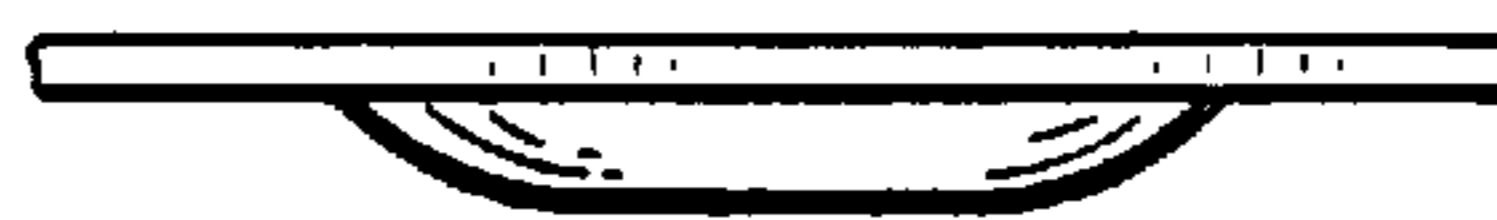

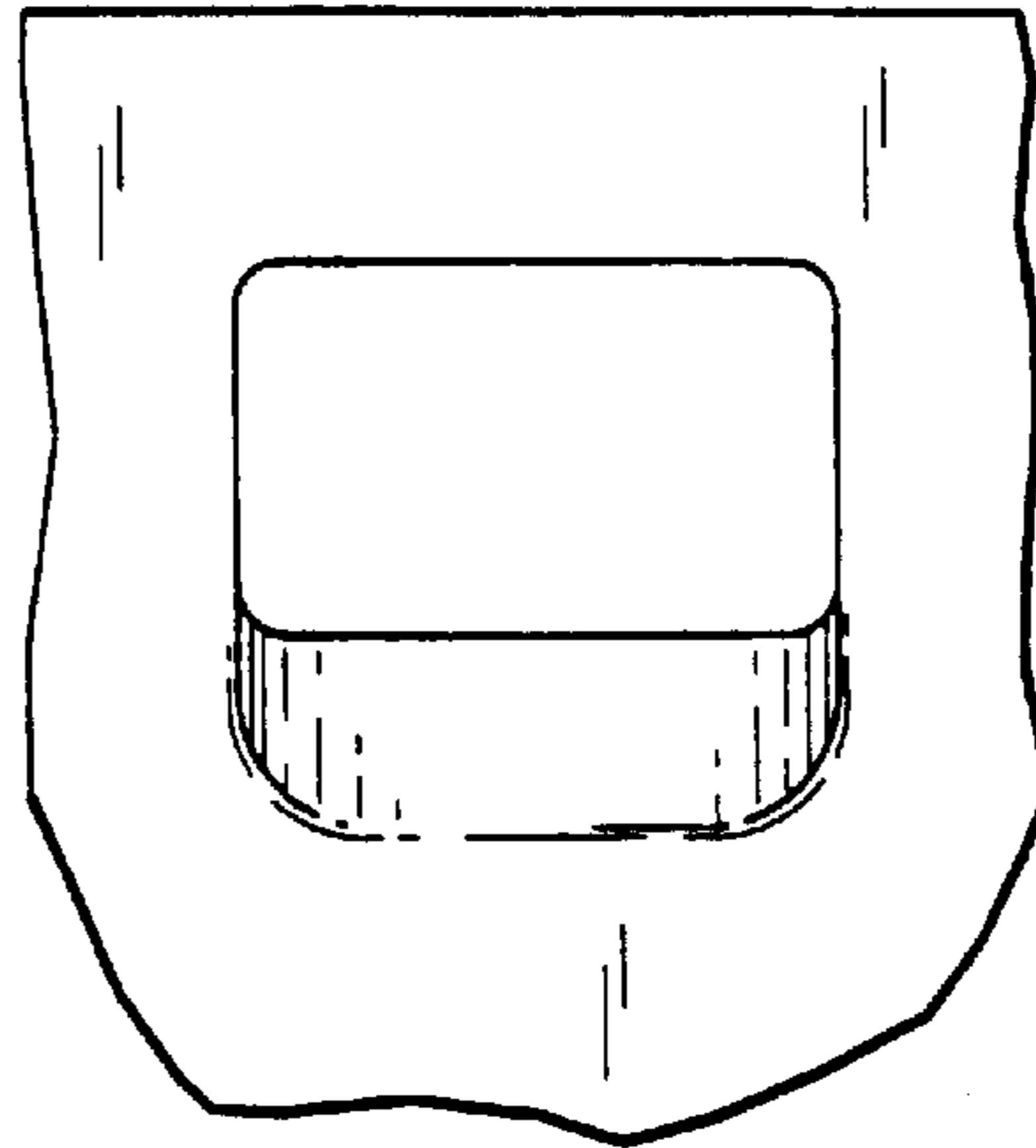

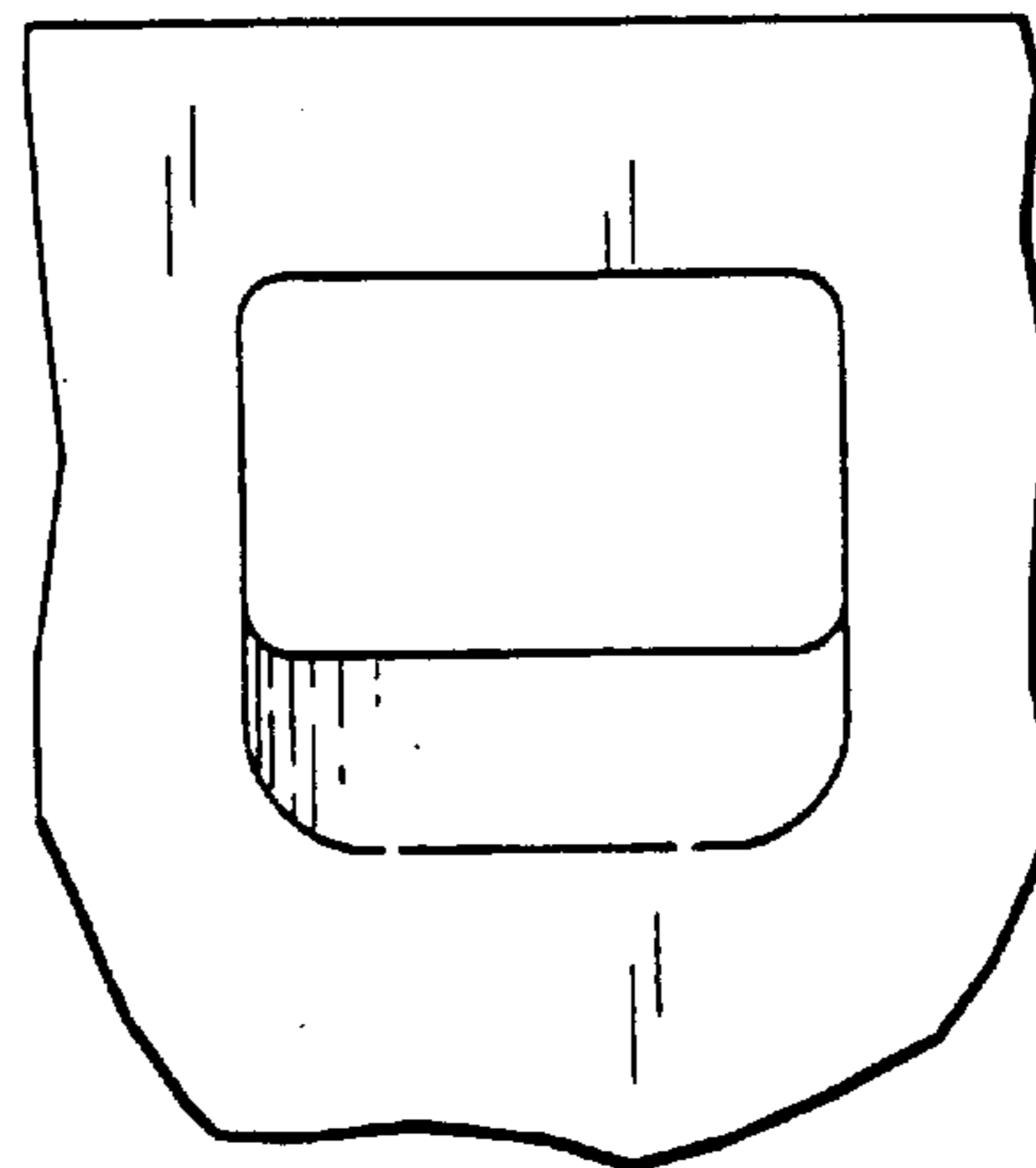

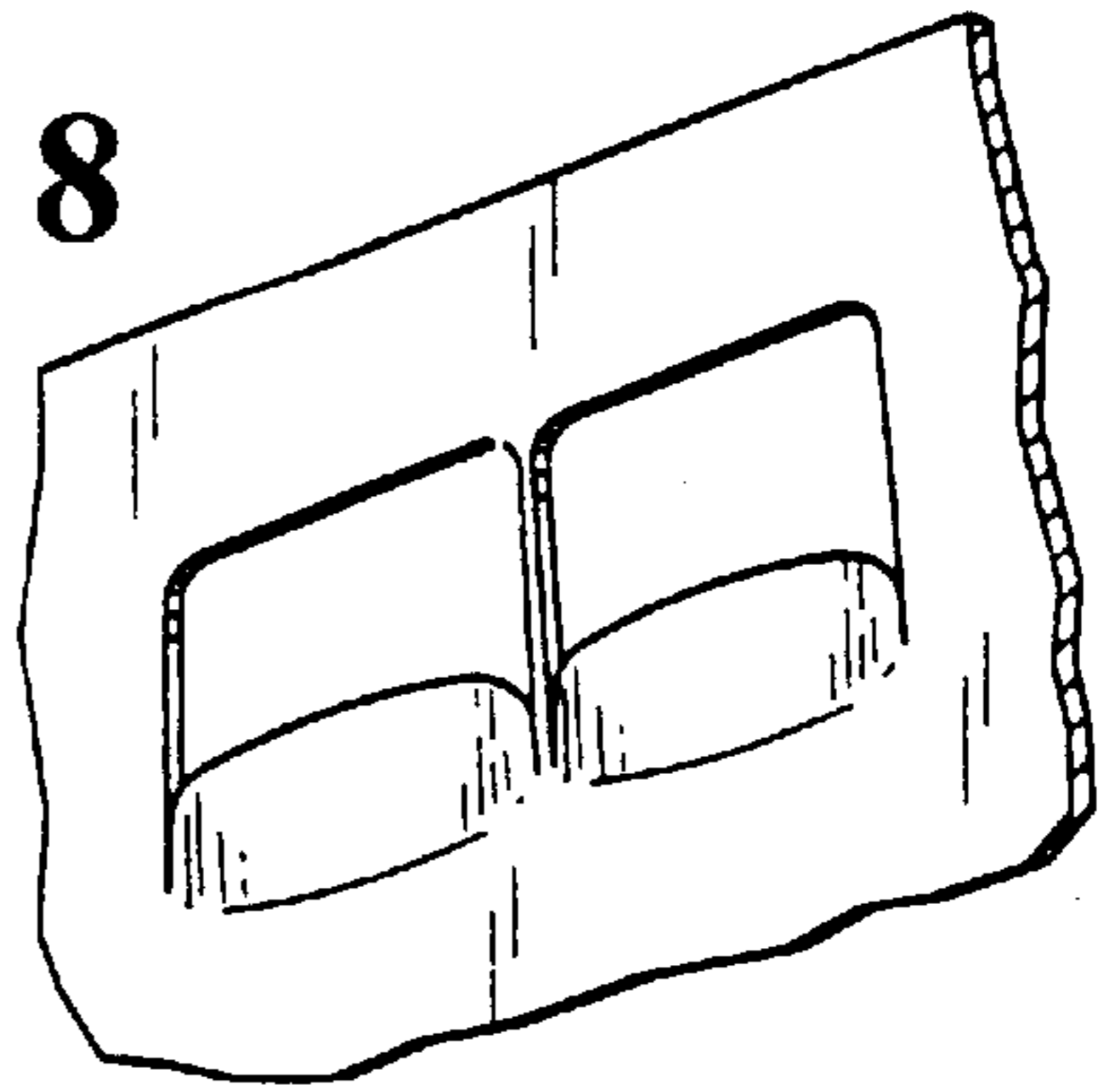

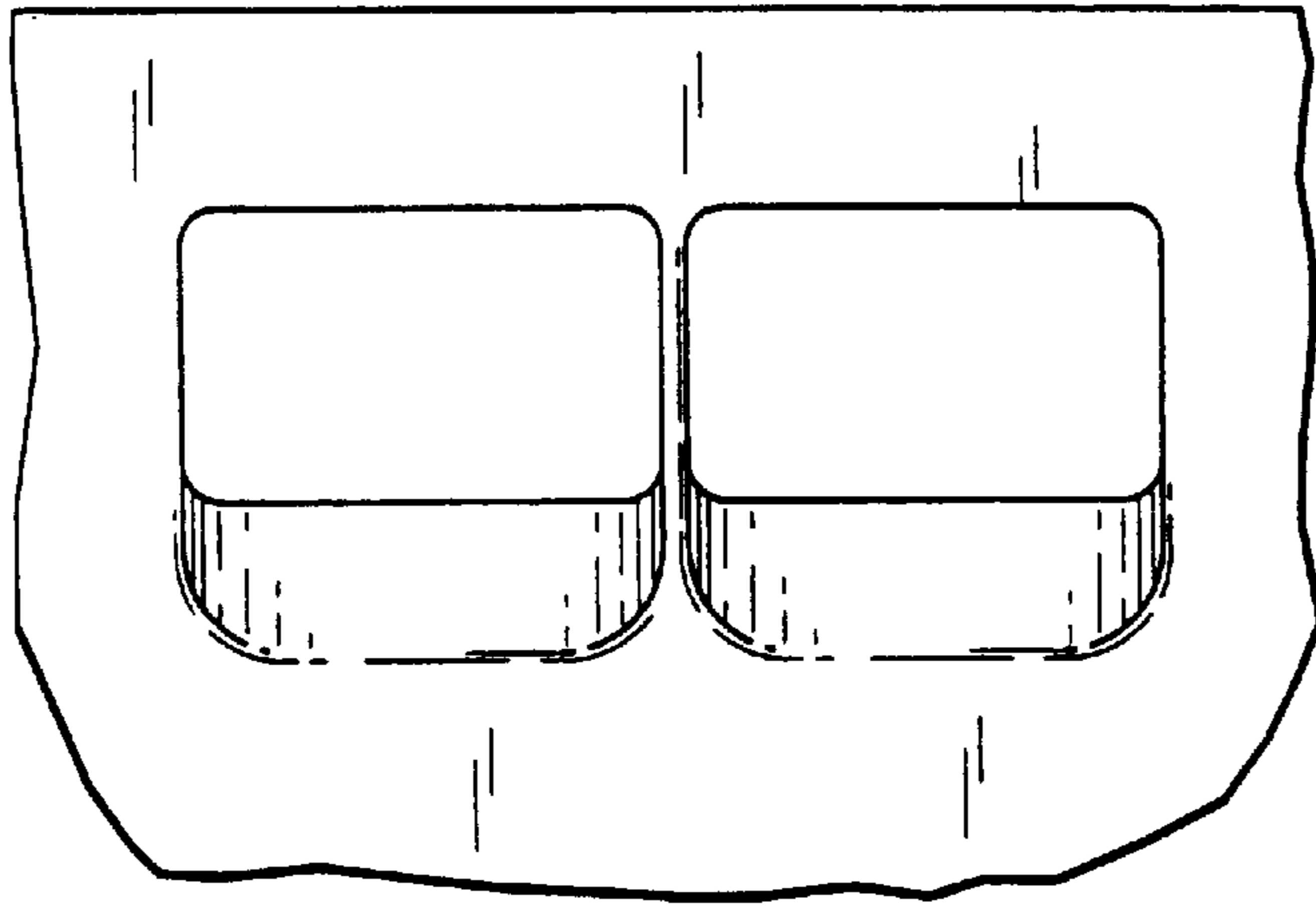

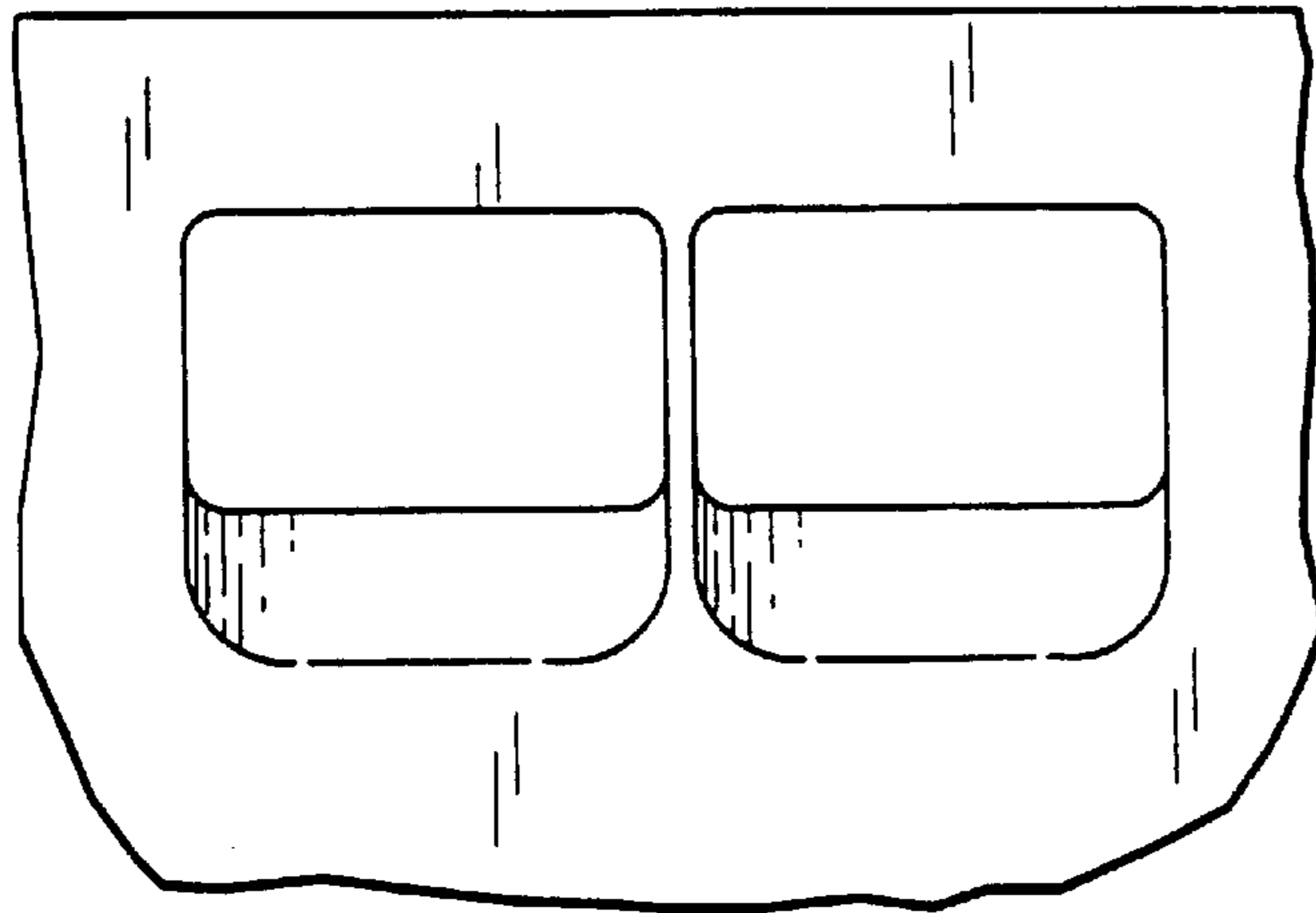
